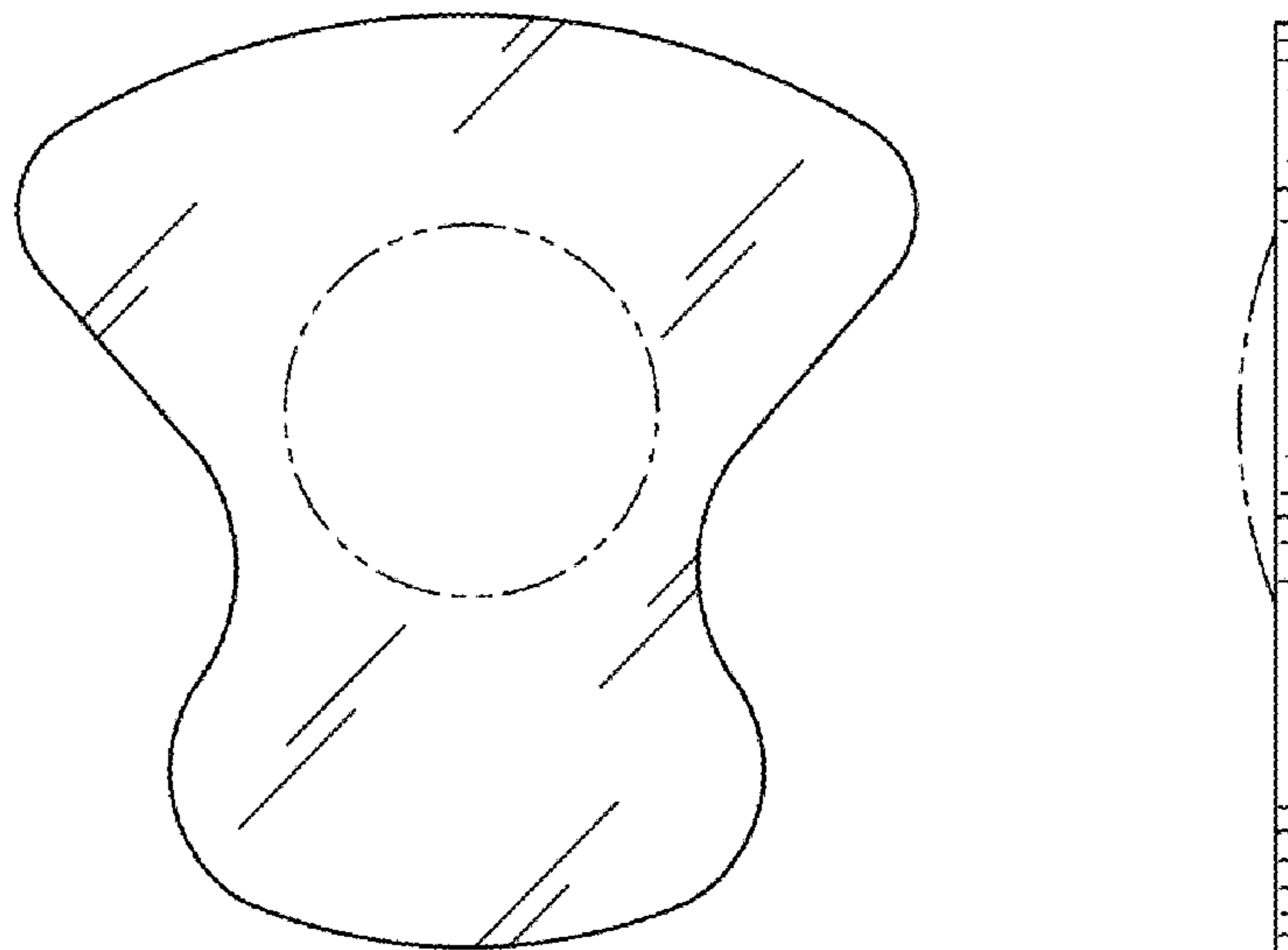
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top view of the nasal applique showing my new design;

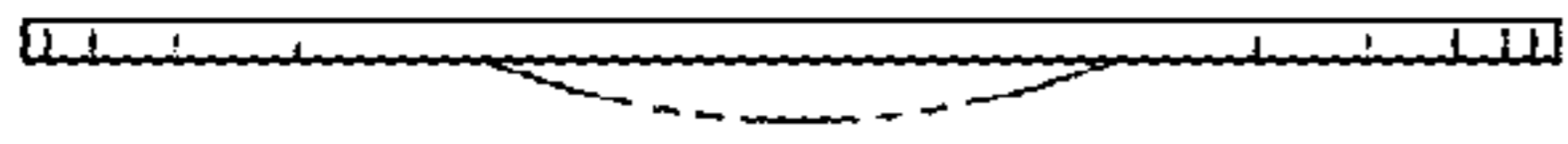

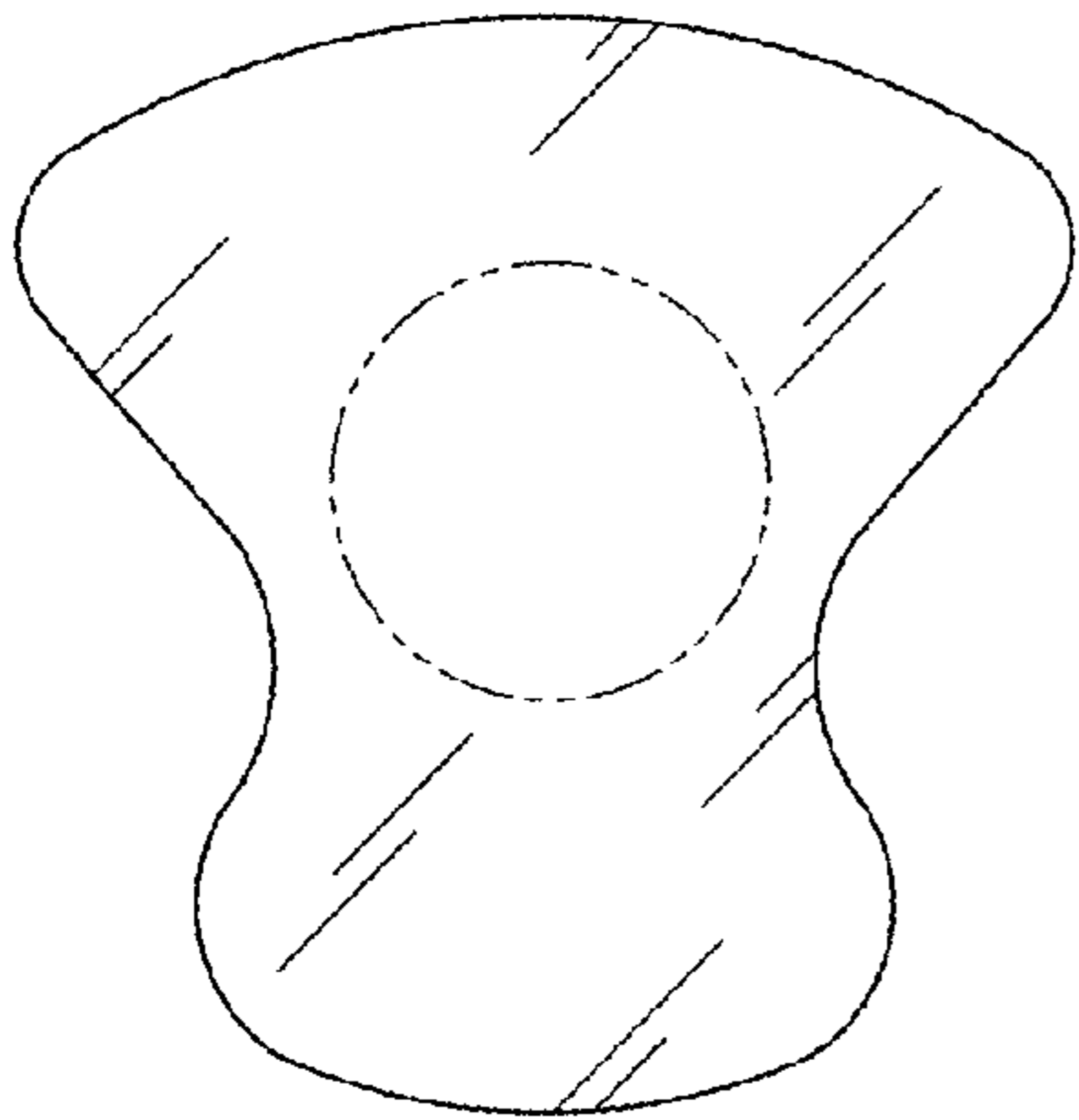

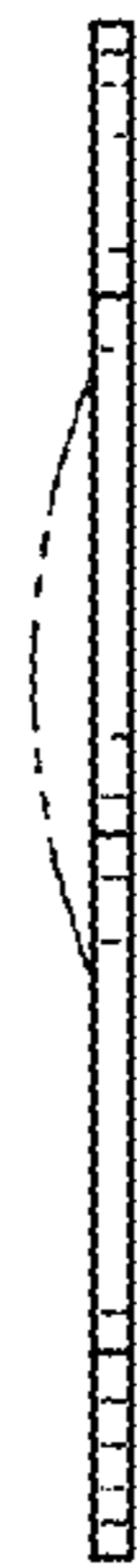

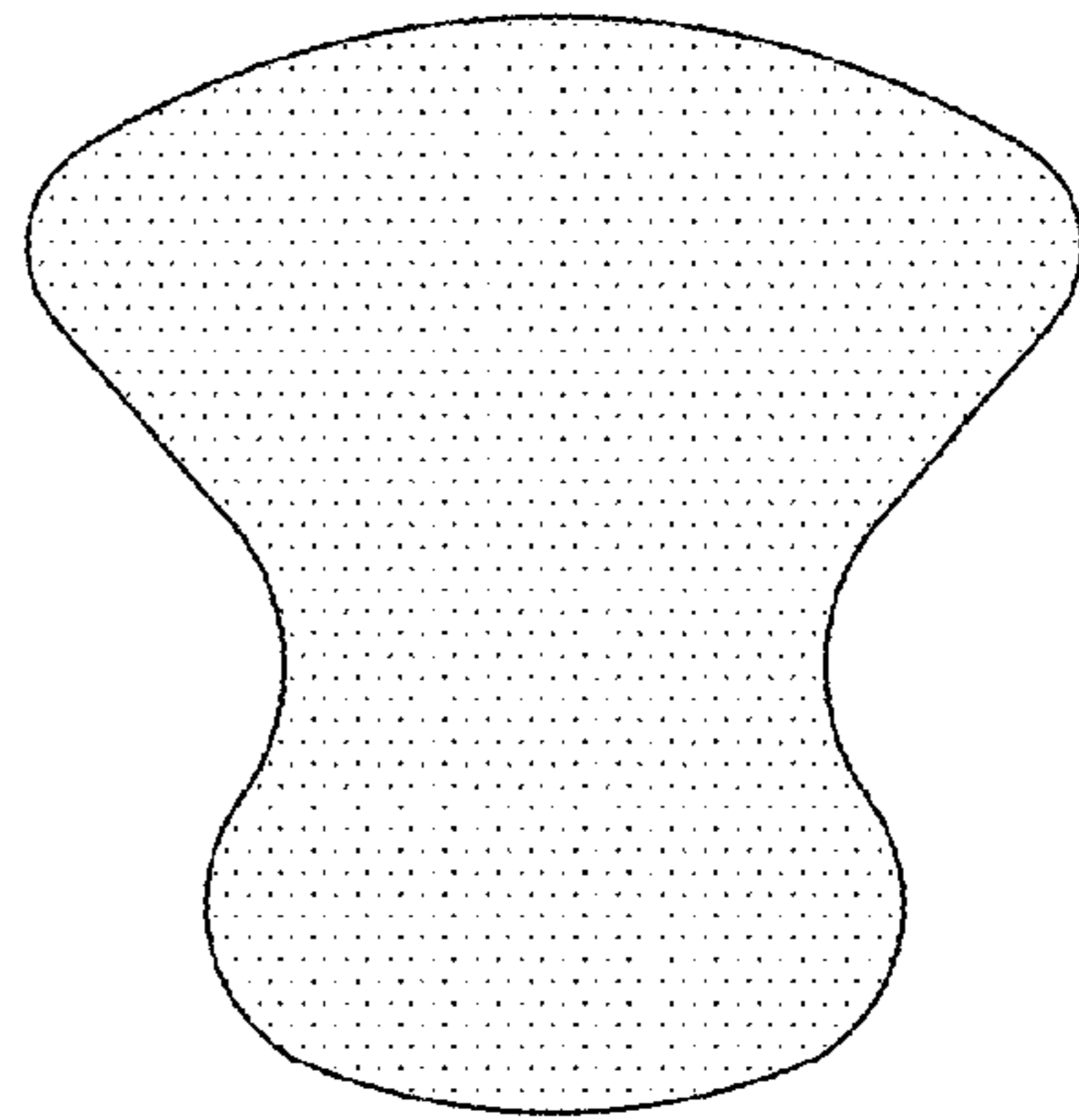

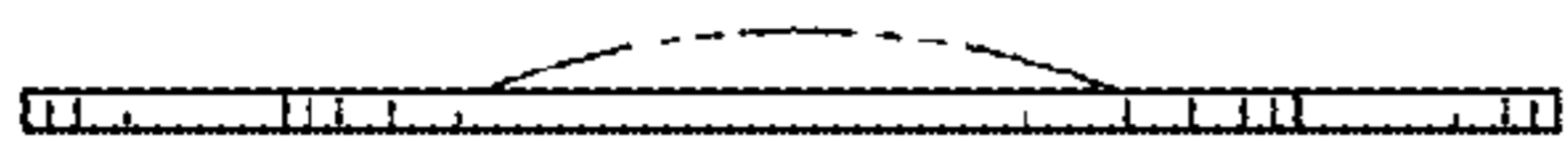

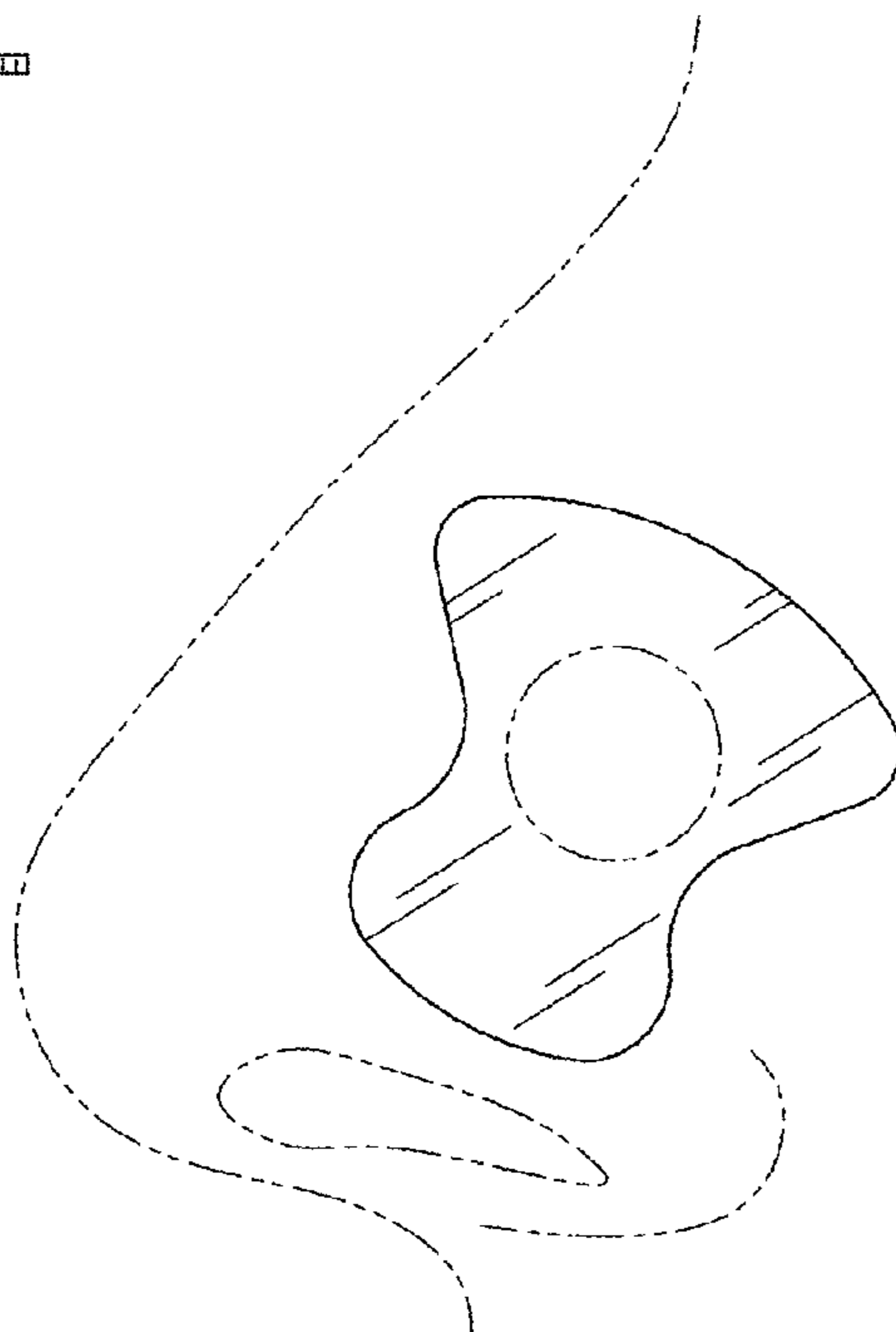
