(57) **CLAIM**

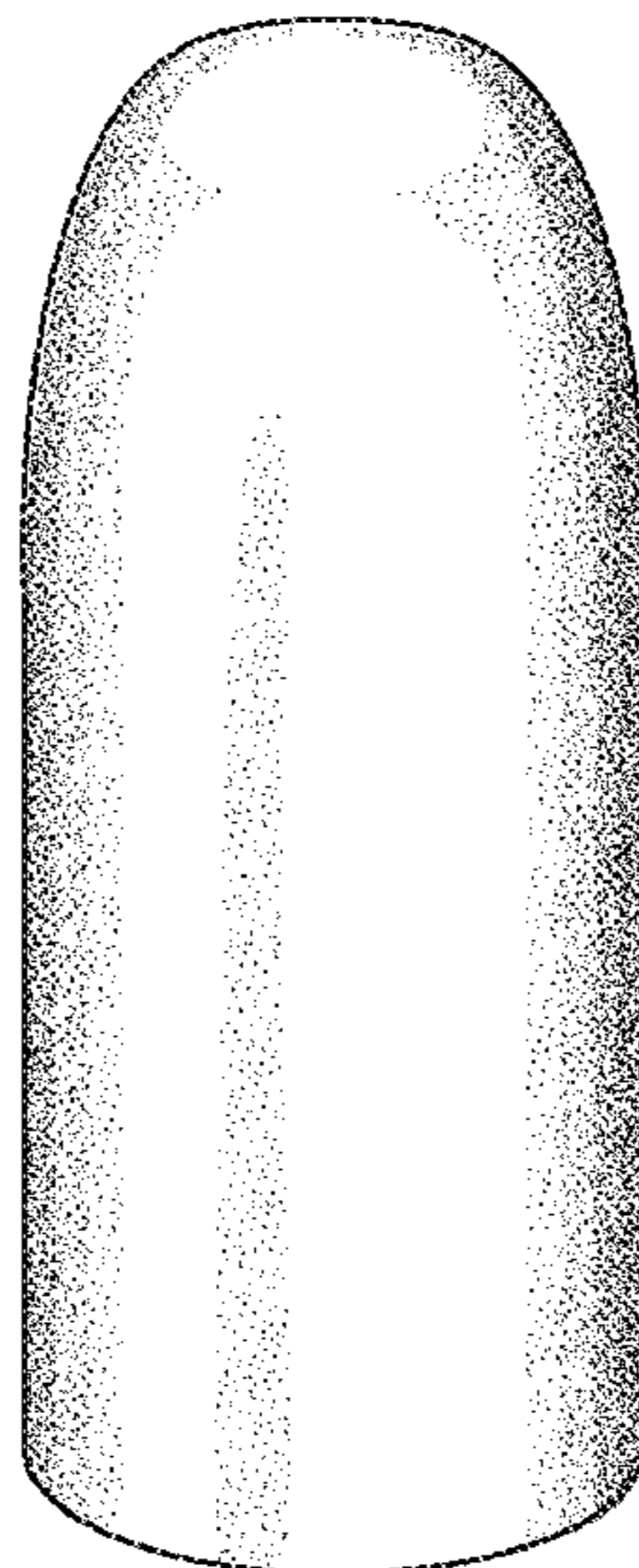
The ornamental design for a surgical table peg pad, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new surgical table peg pad;
FIG. 2 is a side view thereof, the image being identical from all side views;
FIG. 3 is a top view thereof; and,
FIG. 4 is a bottom view thereof.
The broken line showing of elements on the surgical table peg pad illustrate portions of the article and form no part of the claimed design.

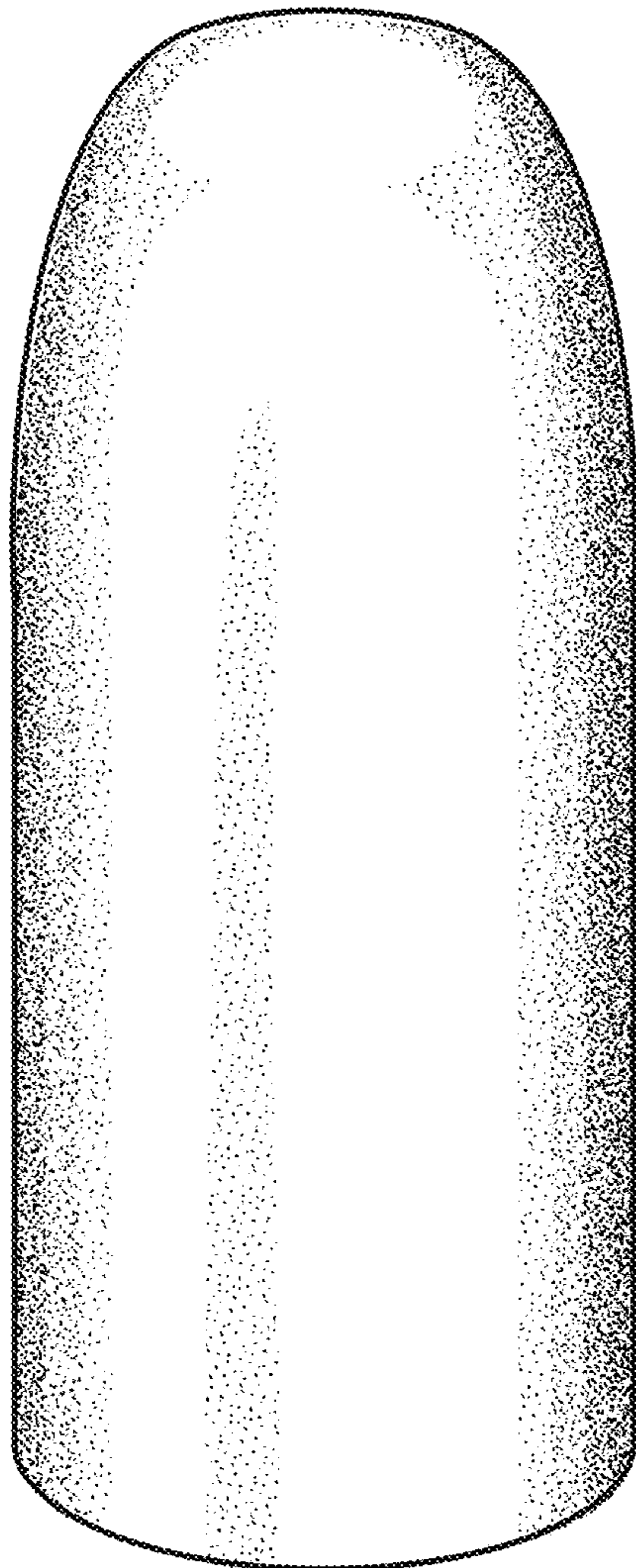

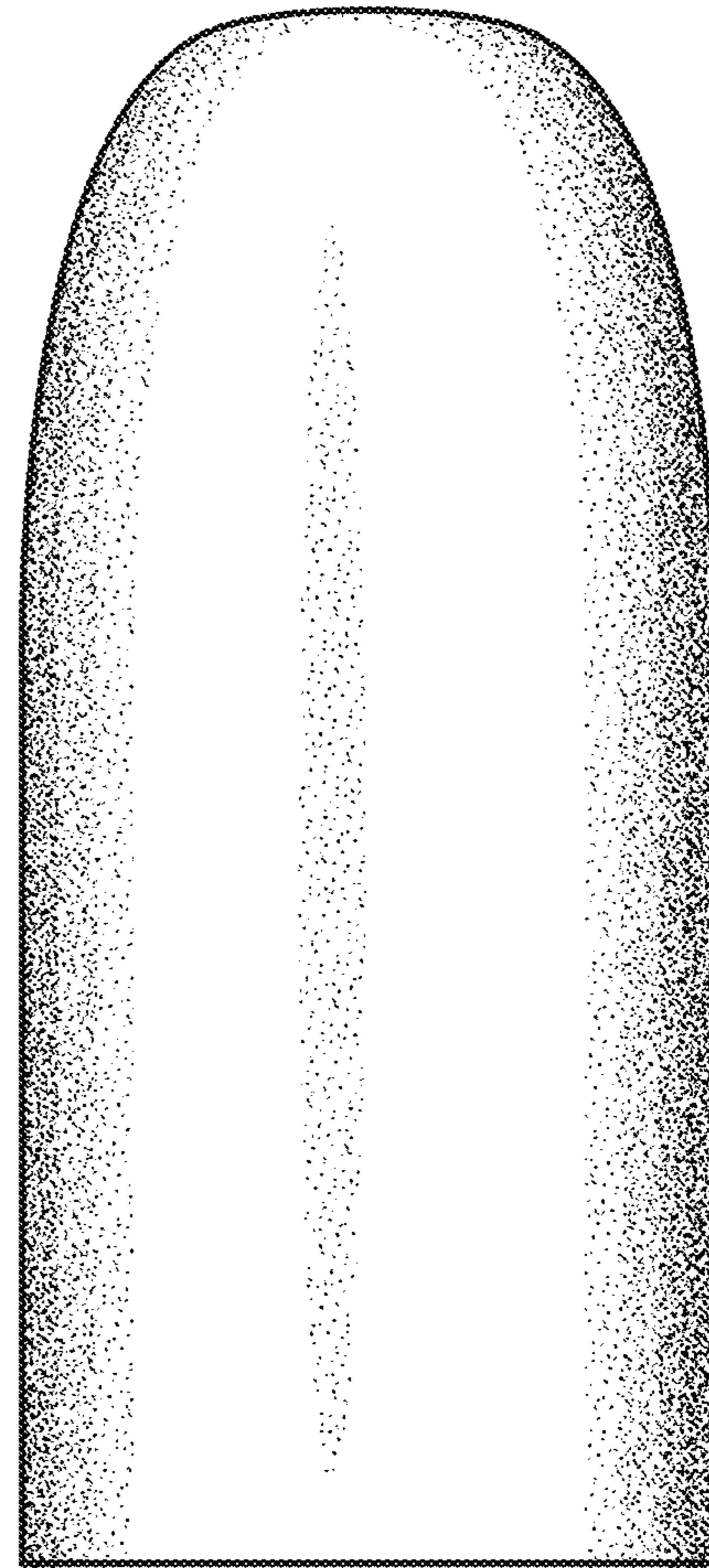

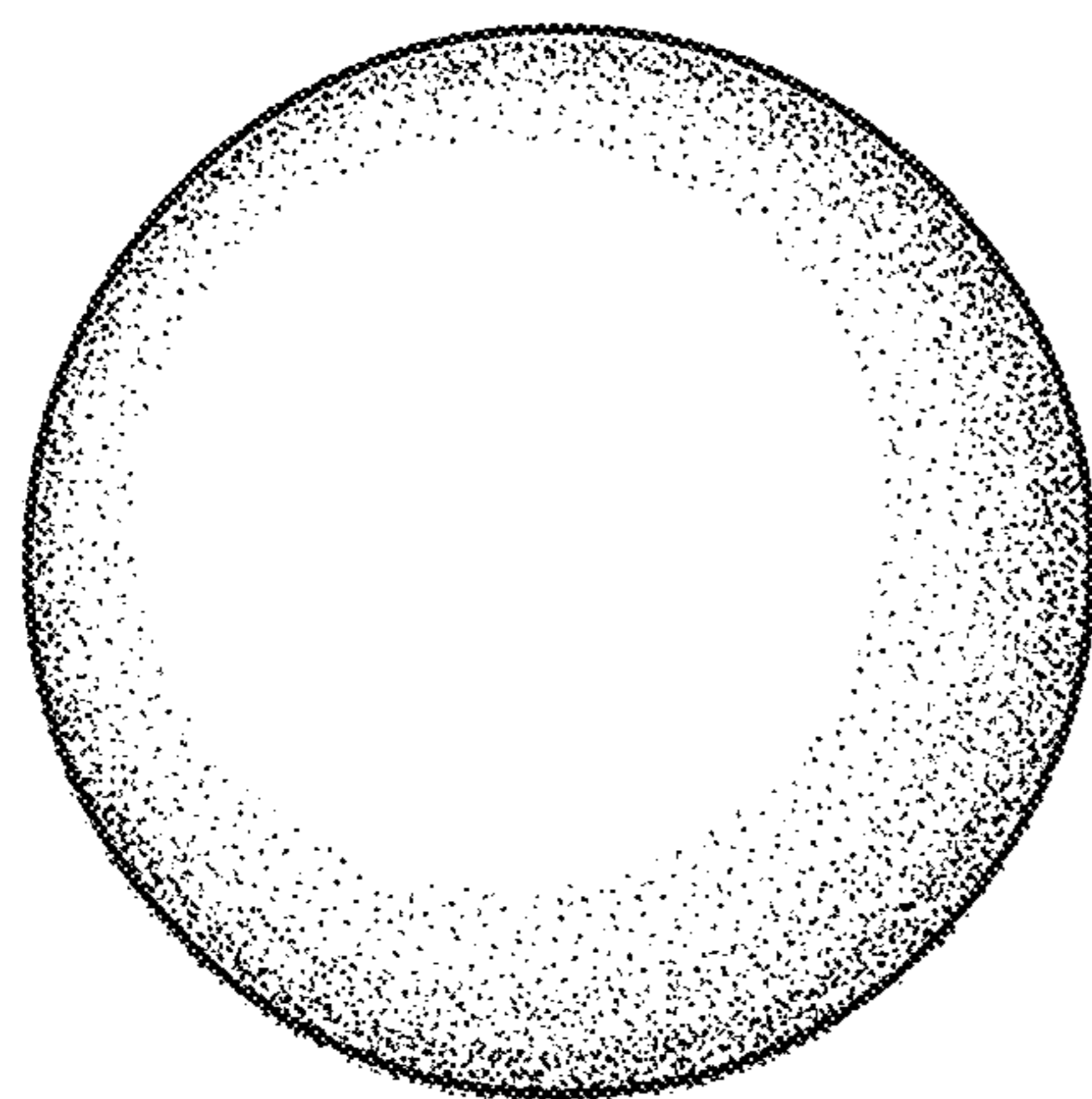

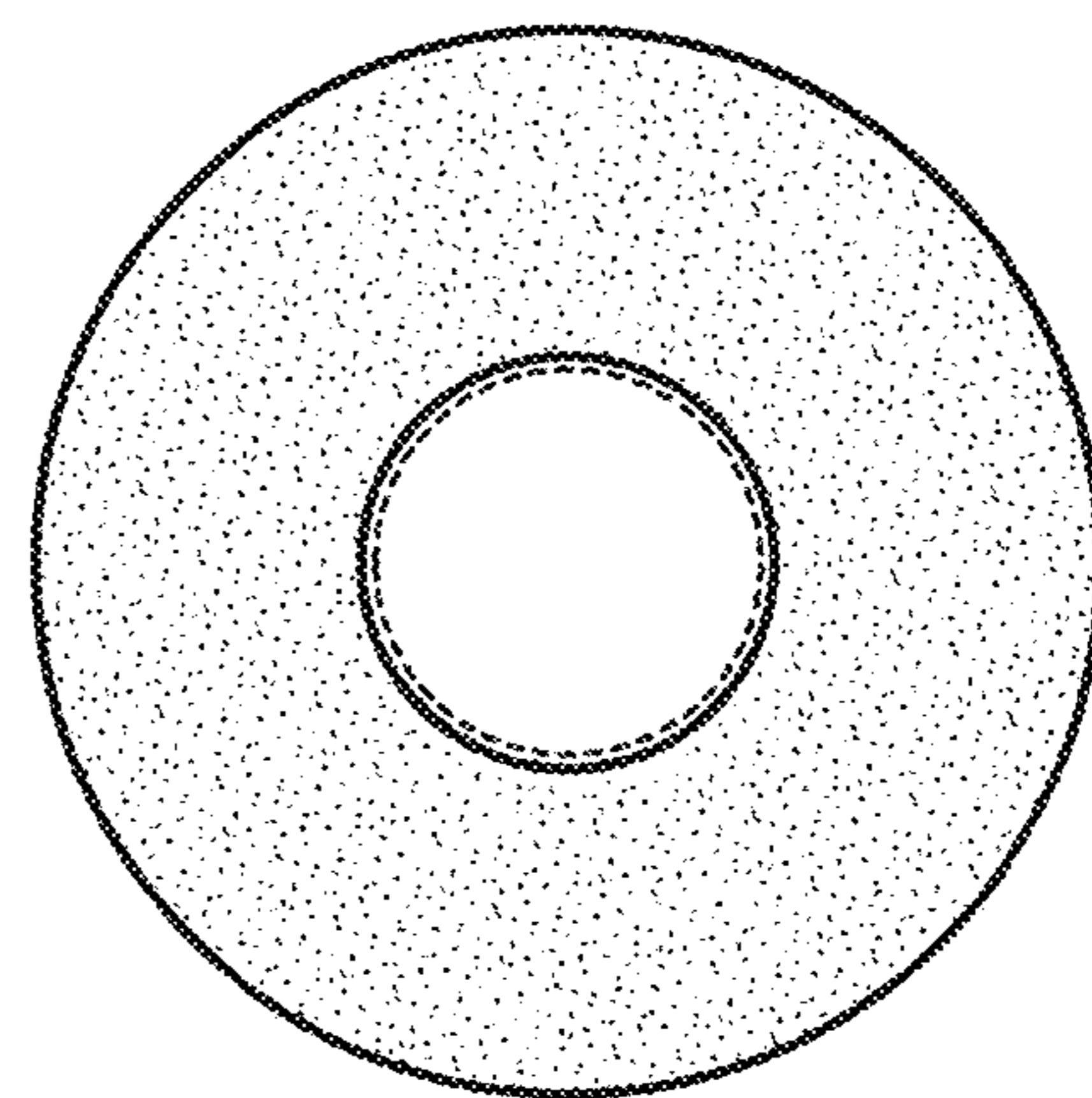
