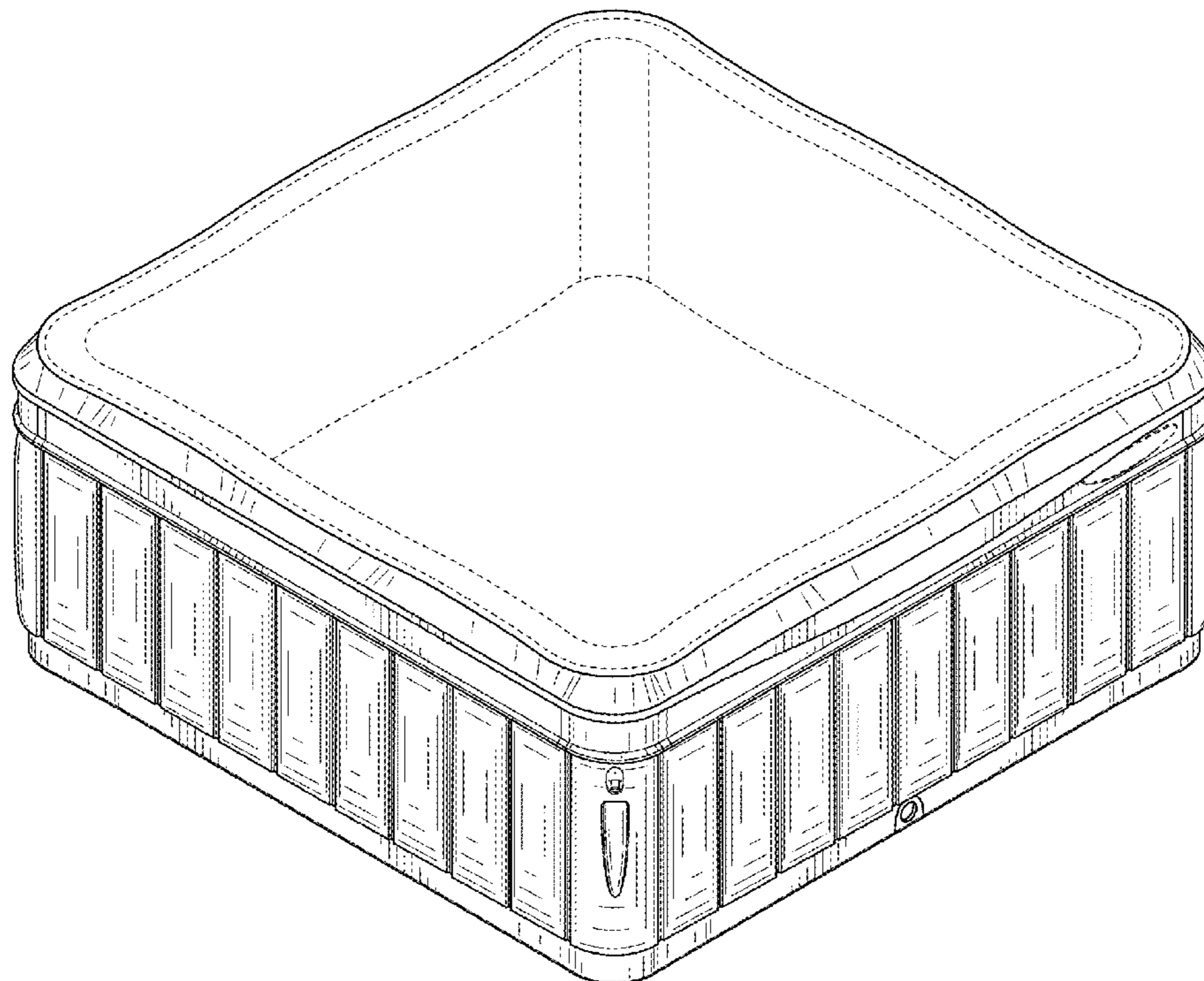

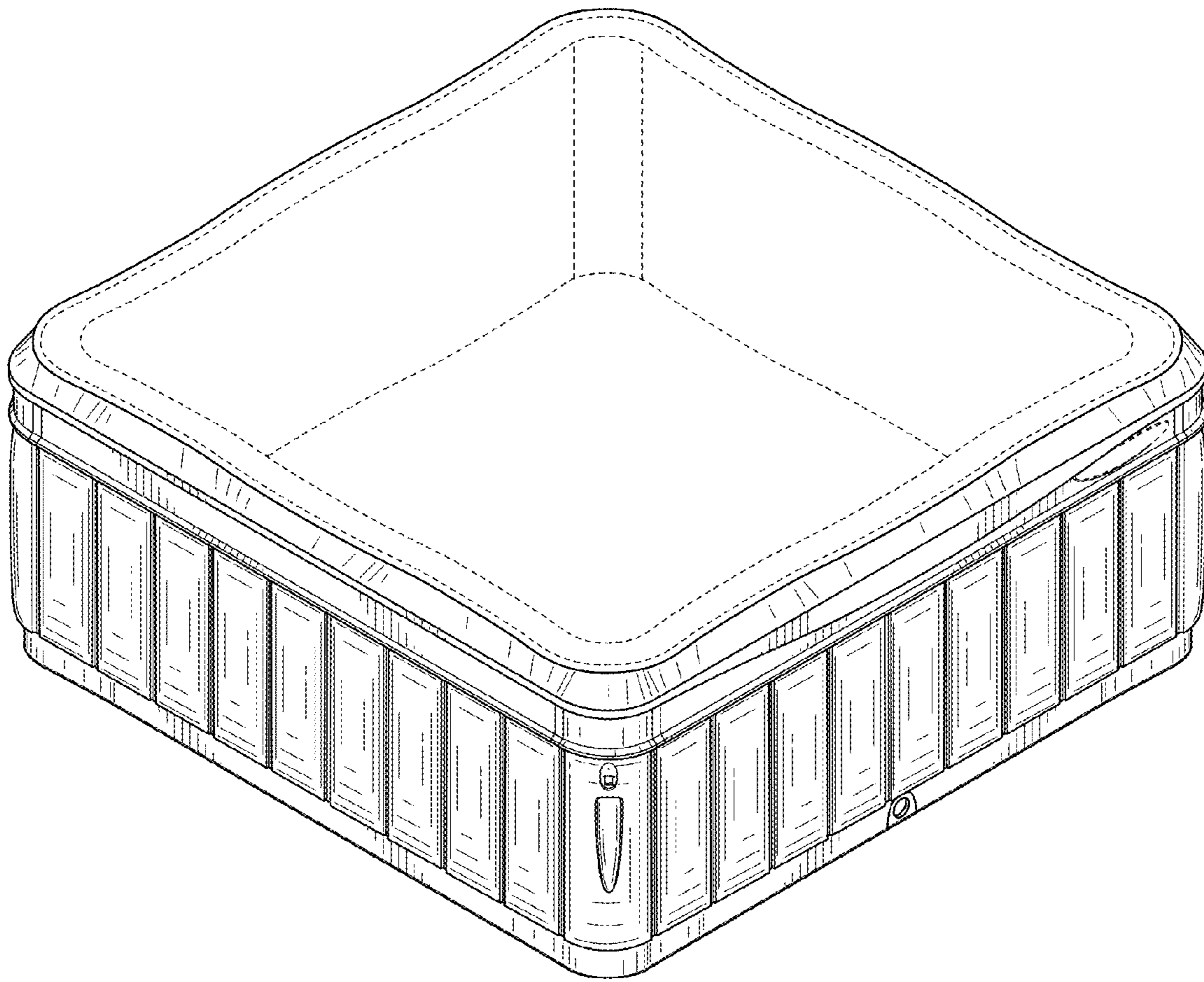
The ornamental design for a spa exterior, as shown and described.

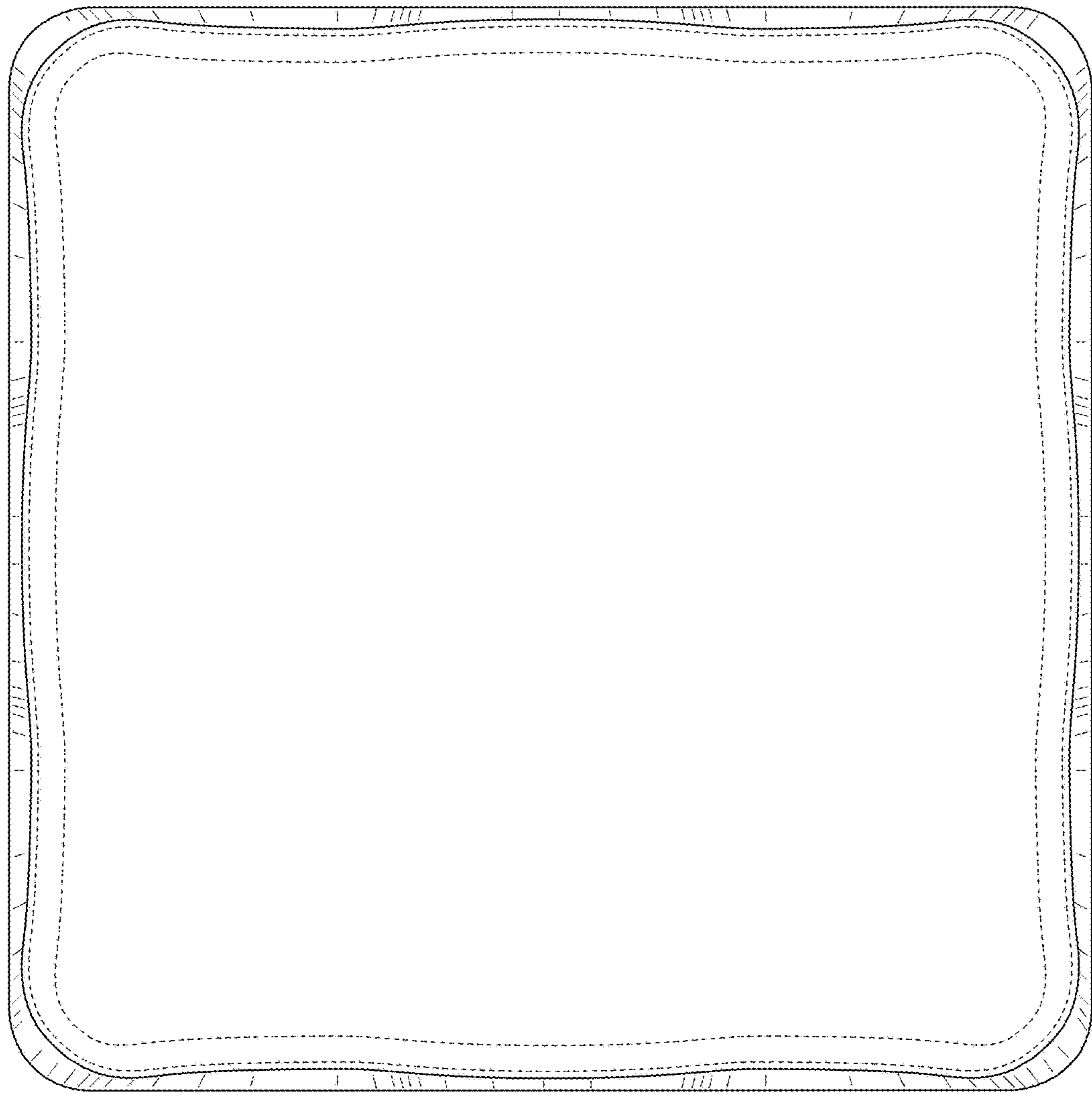

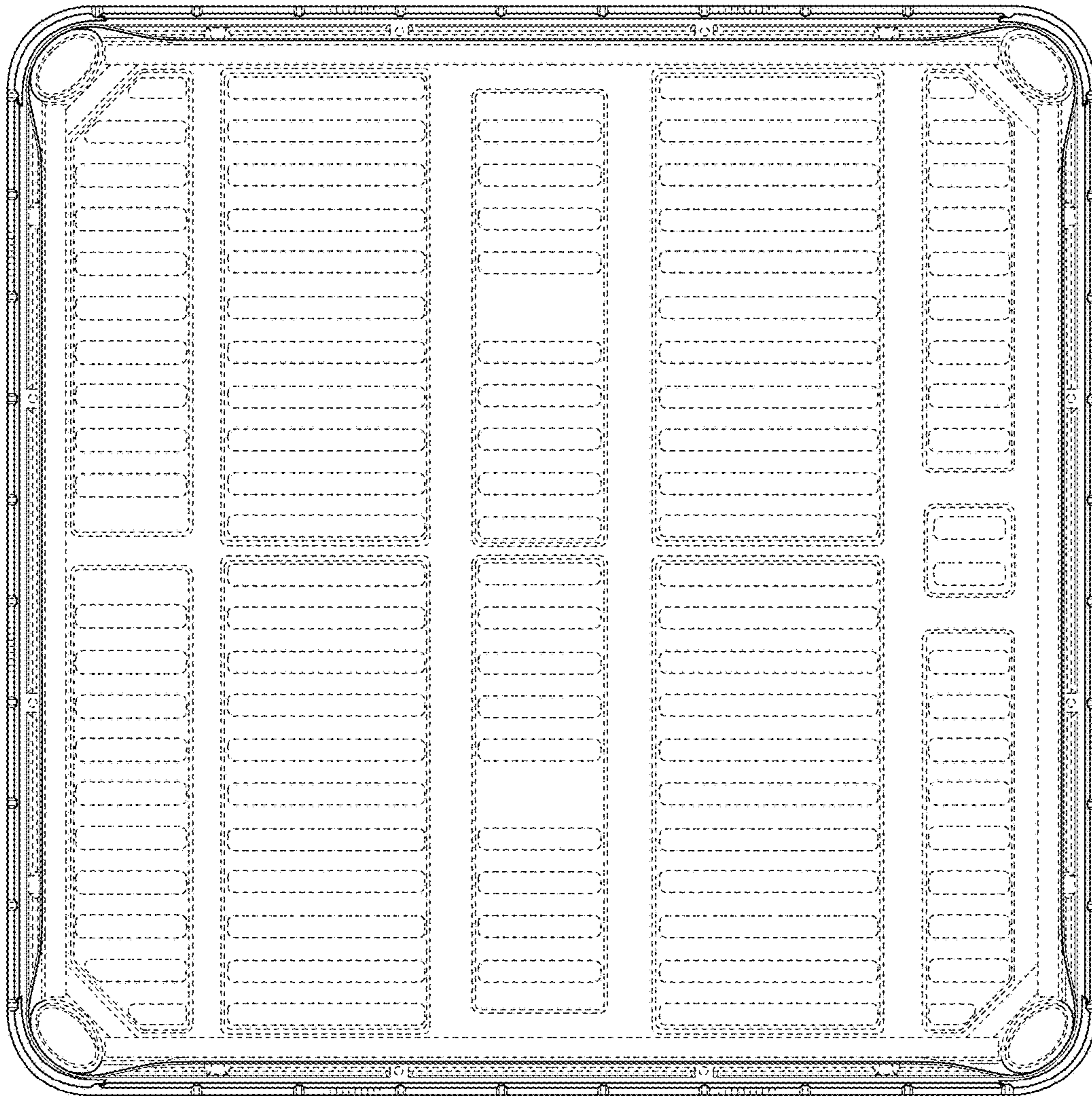

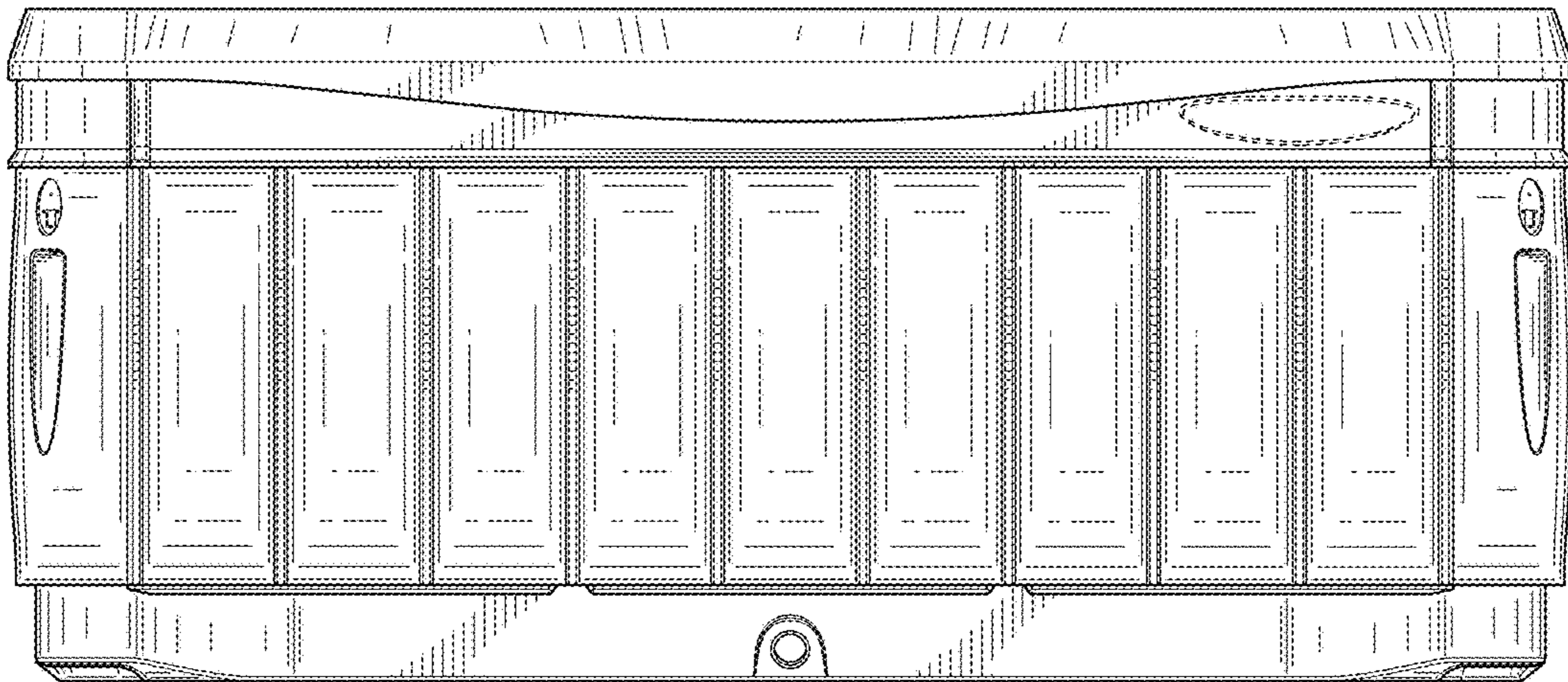
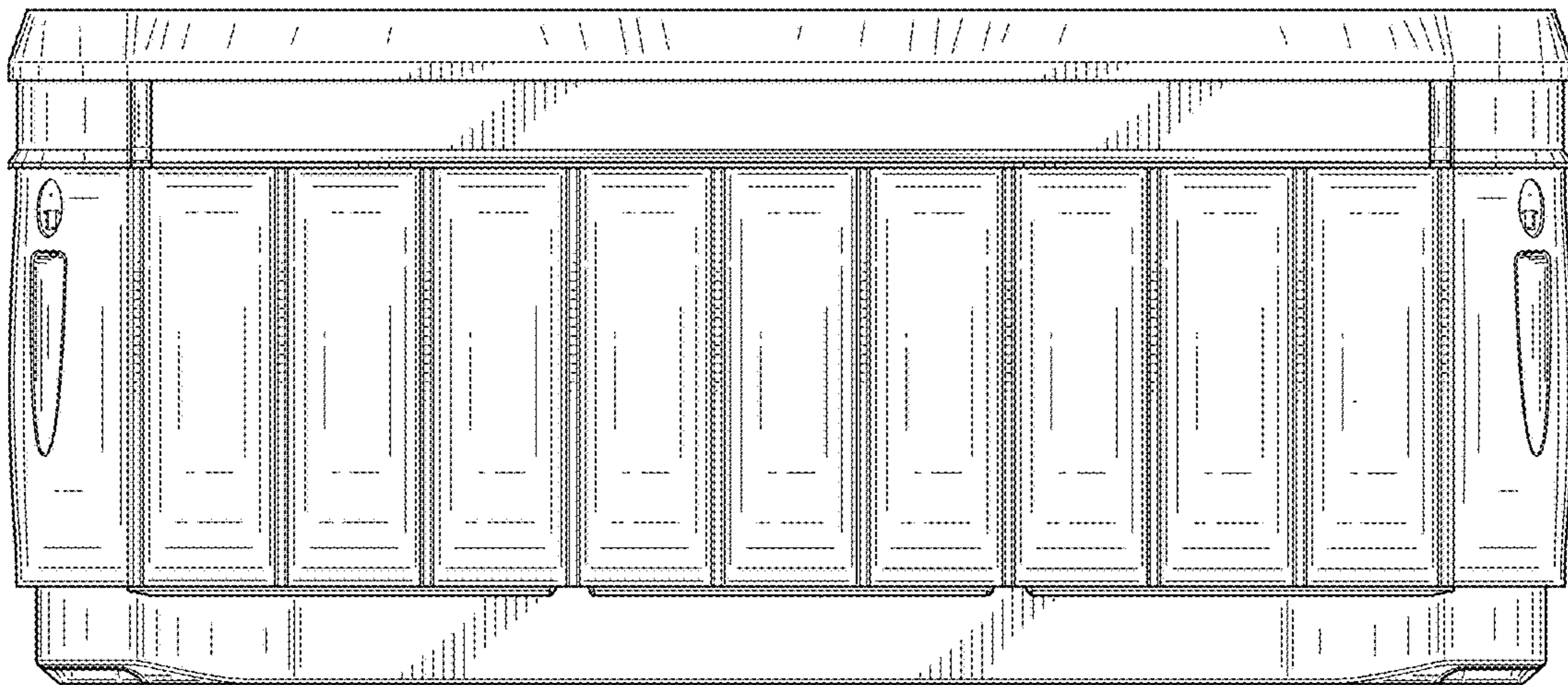

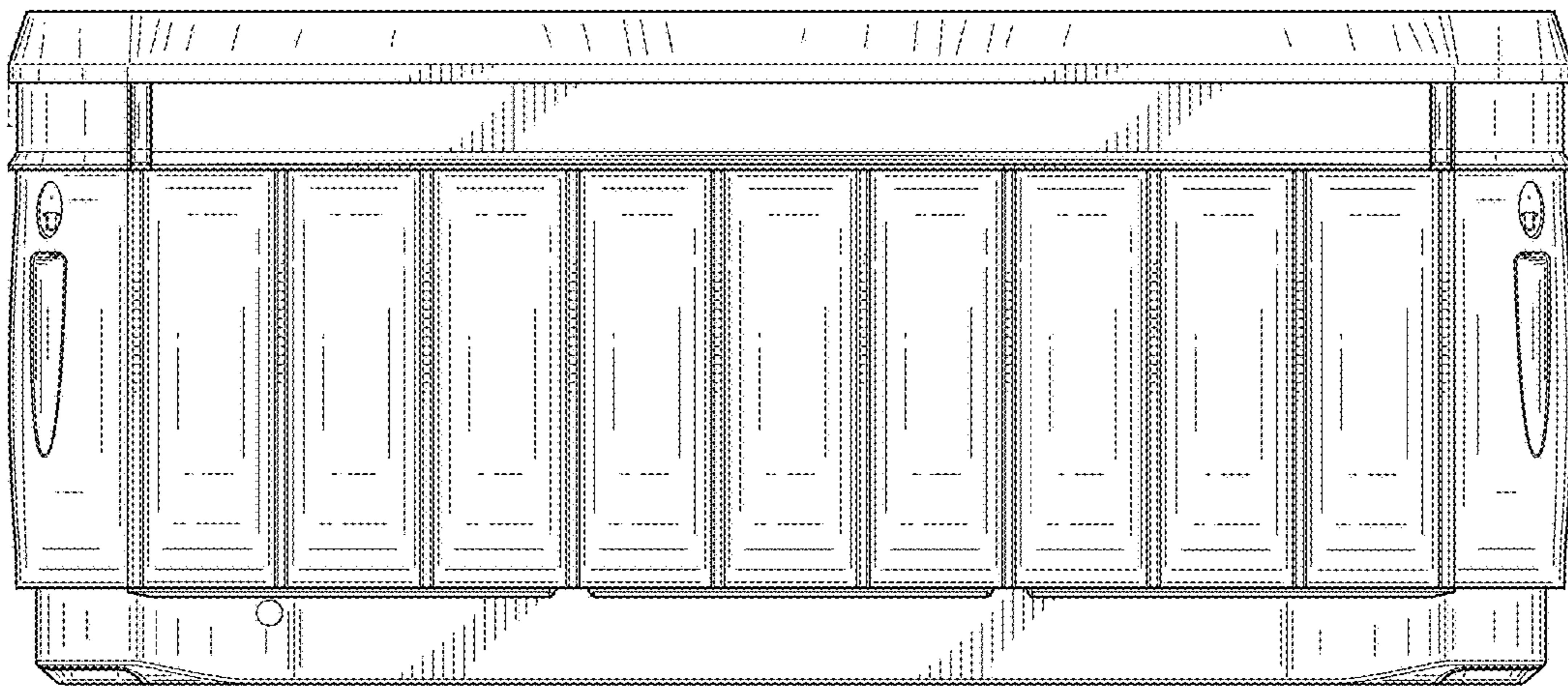
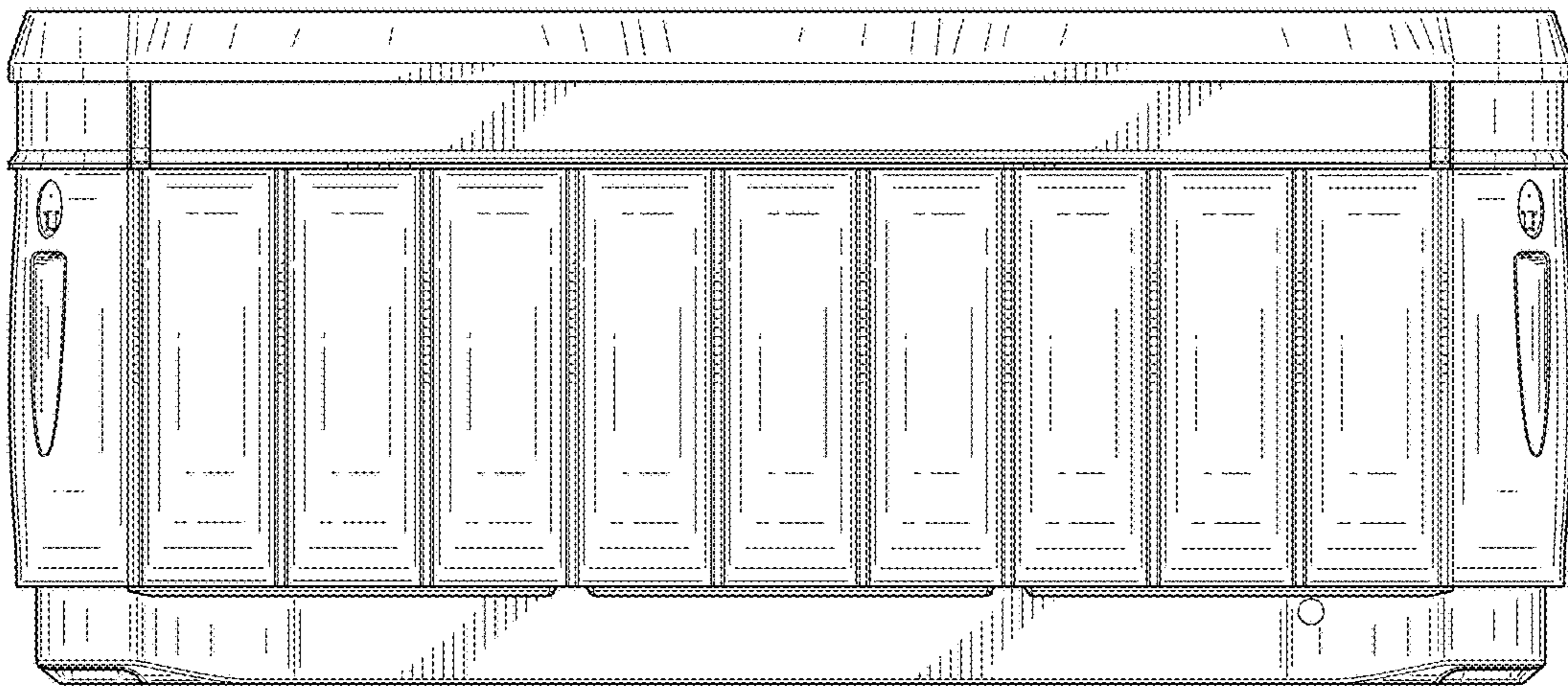
