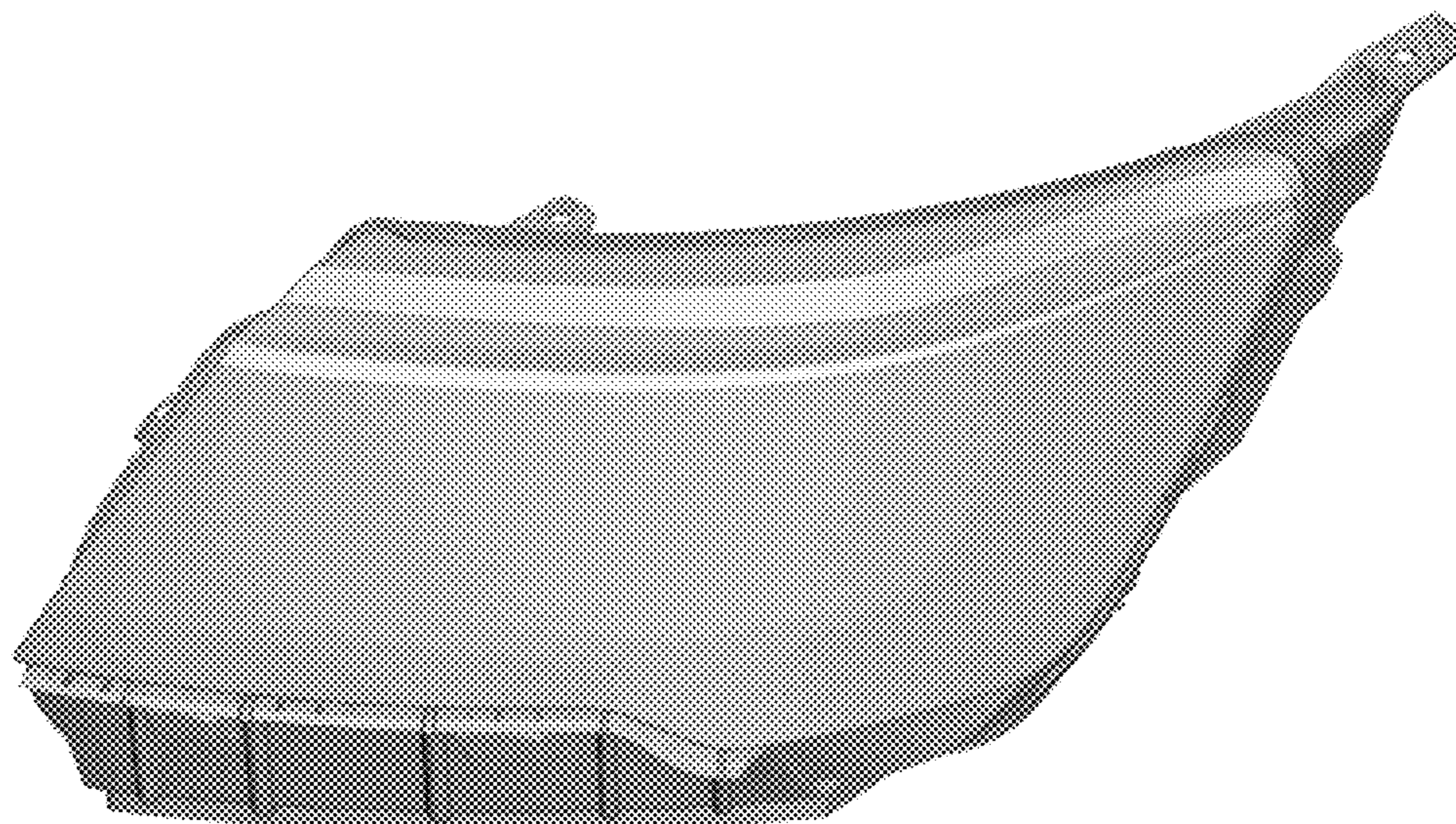
(57) **CLAIM**

The ornamental design for a vehicle headlight, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of the left vehicle headlight (the right headlight being a mirror image and is not shown);
FIG. 2 is a bottom front perspective view thereof;
FIG. 3 is a top rear perspective view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is rear elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a right side elevational view thereof;
FIG. 8 is a top plan view thereof; and,
FIG. 9 is a bottom plan view thereof.

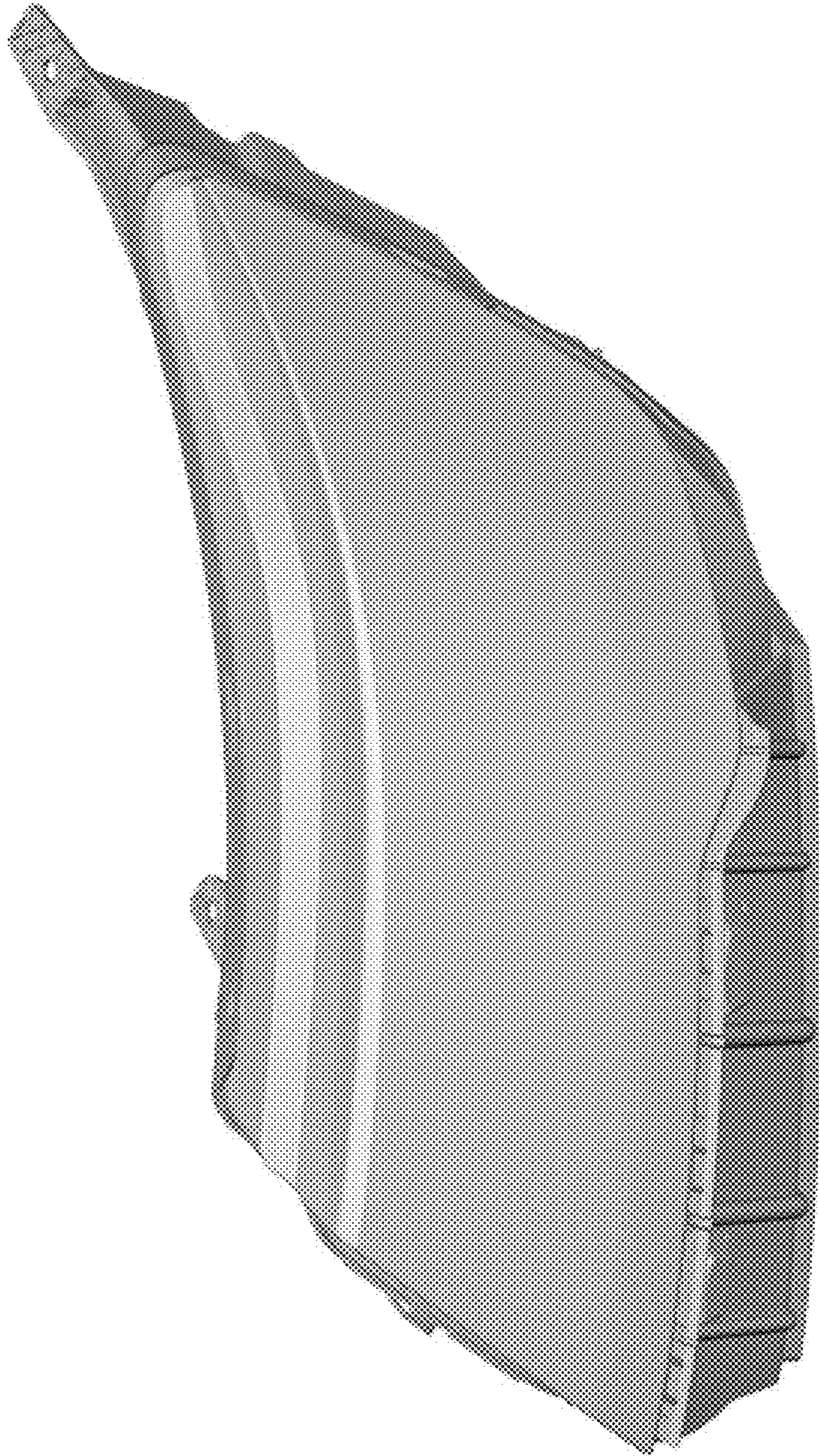

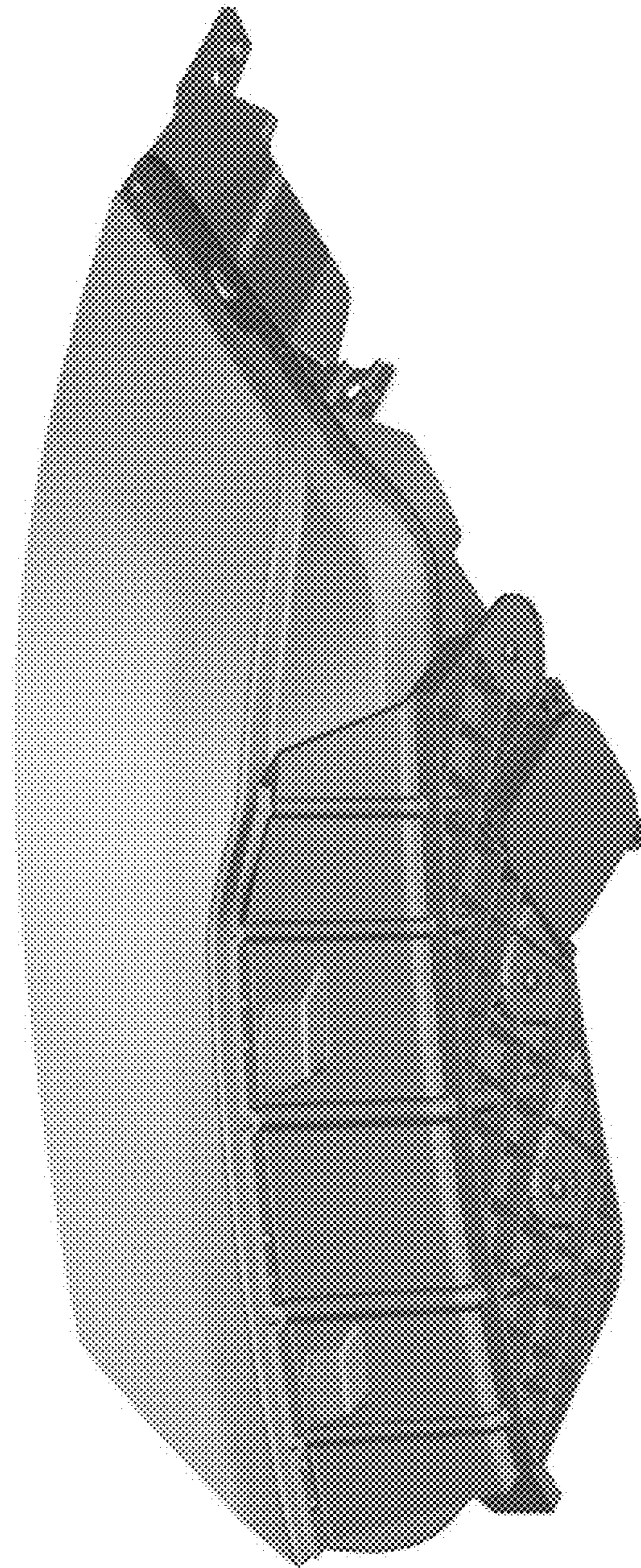

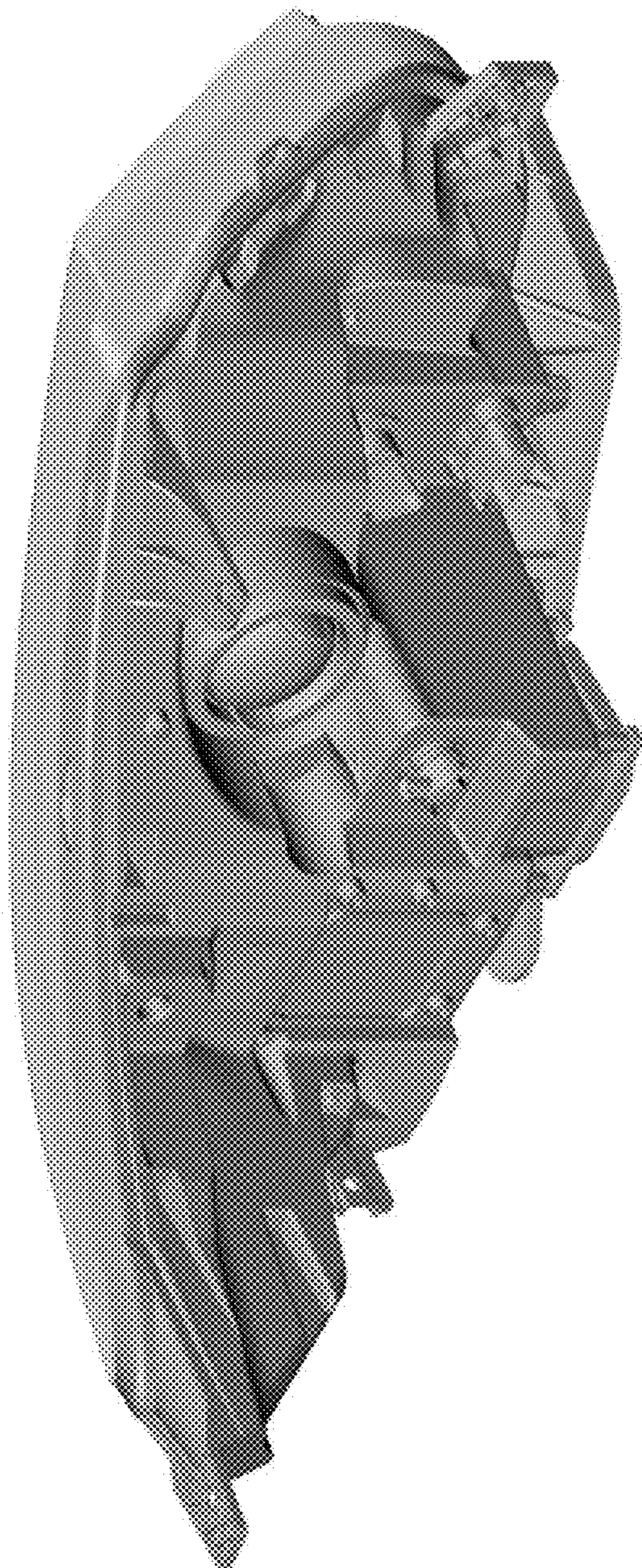

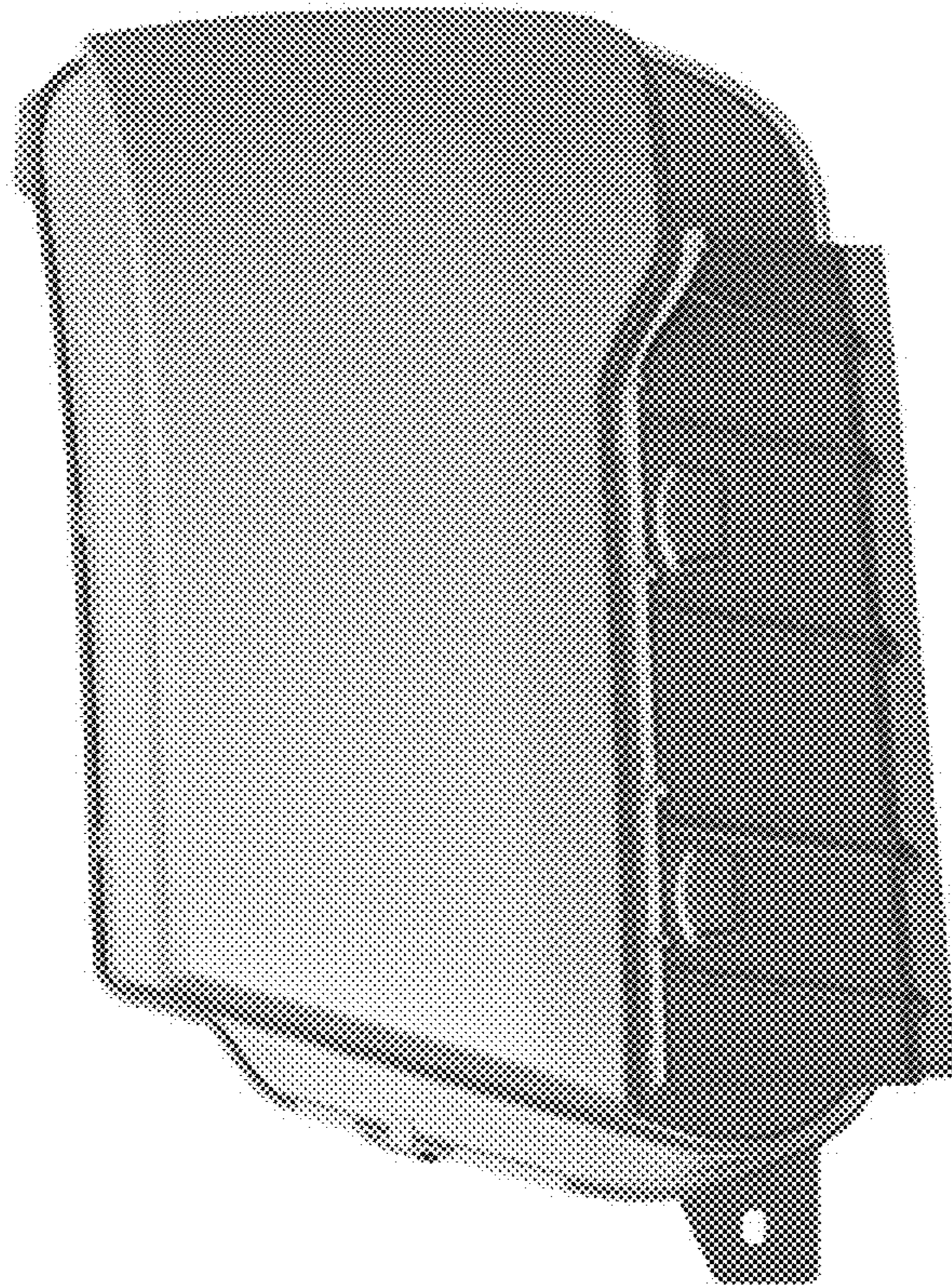

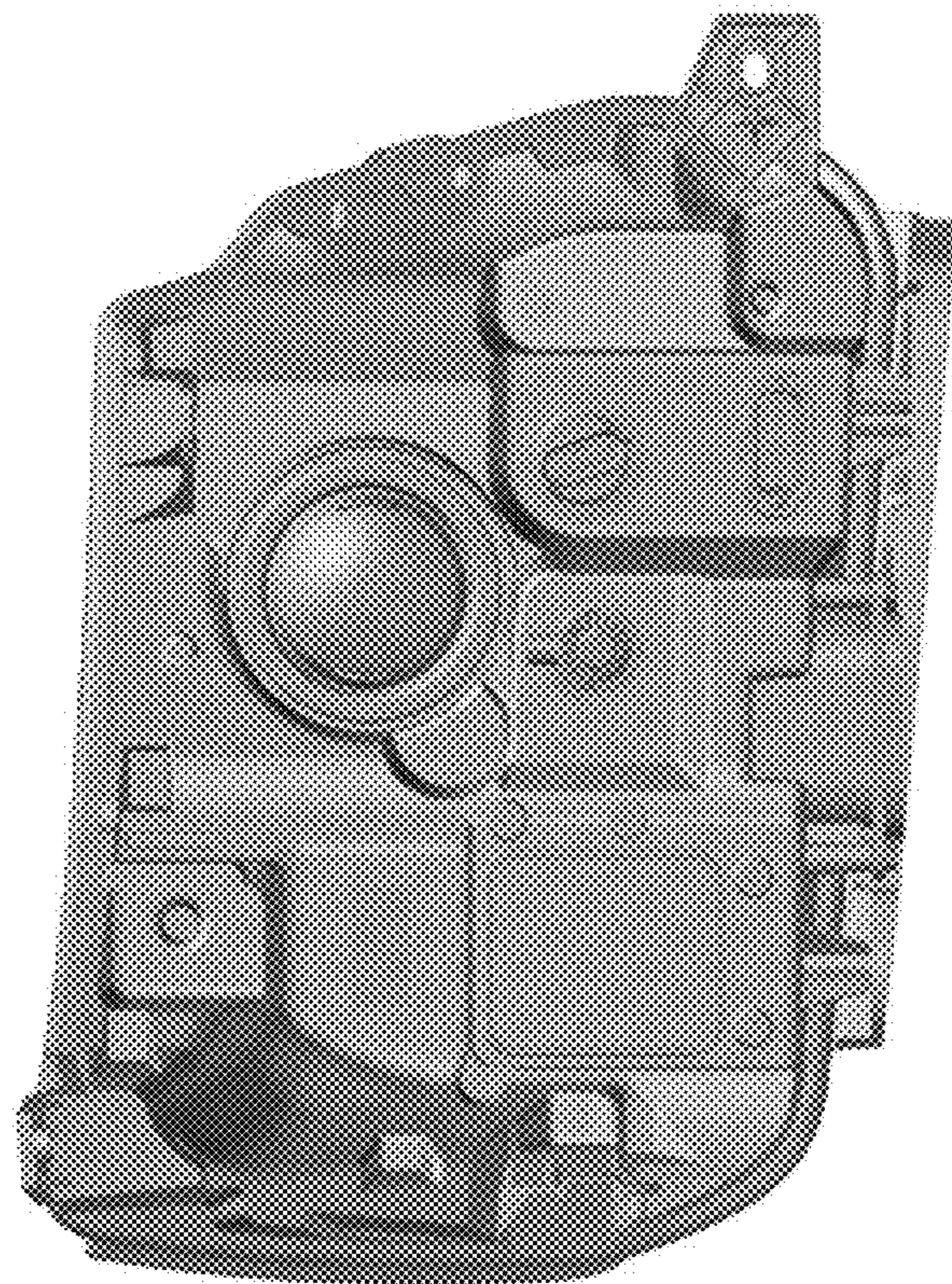

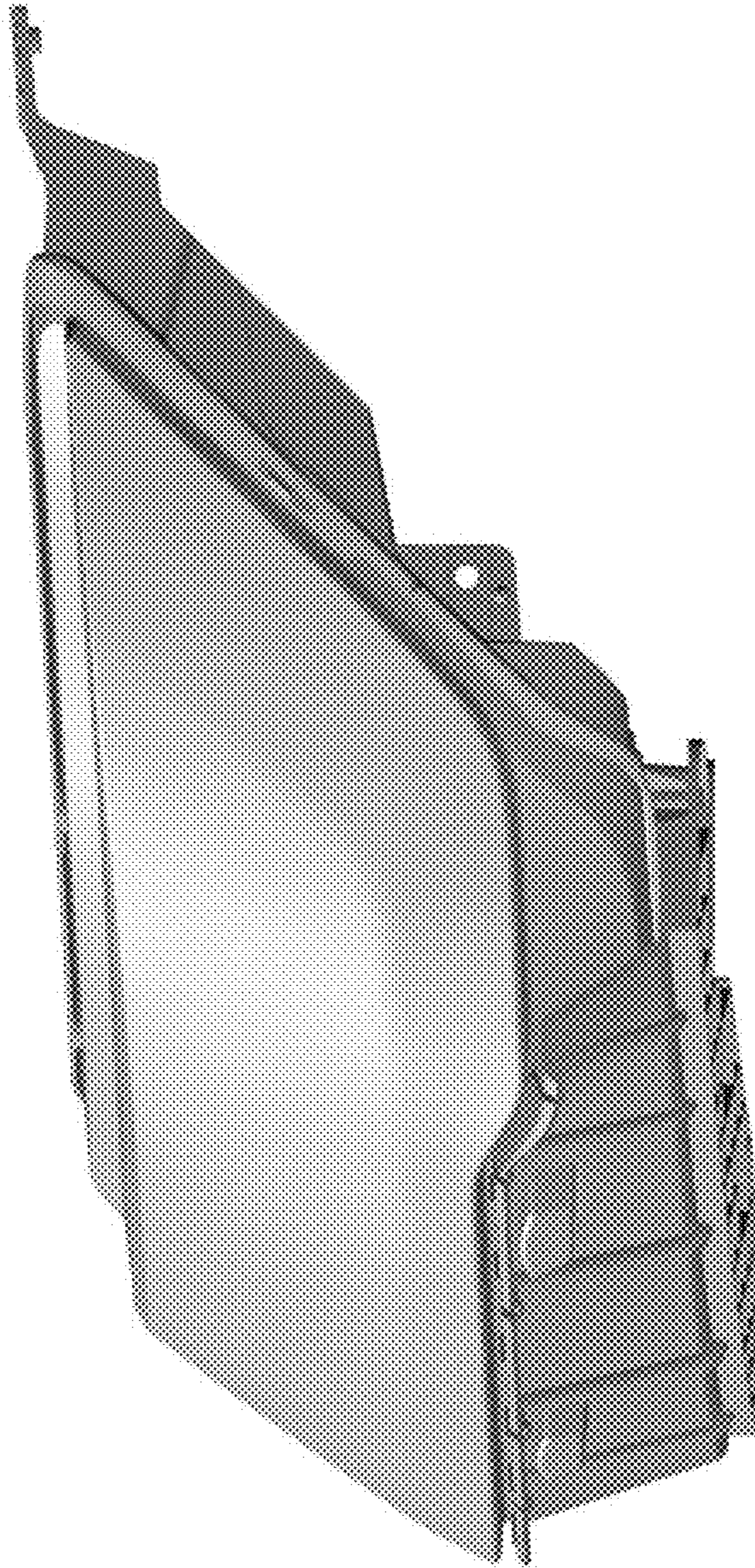

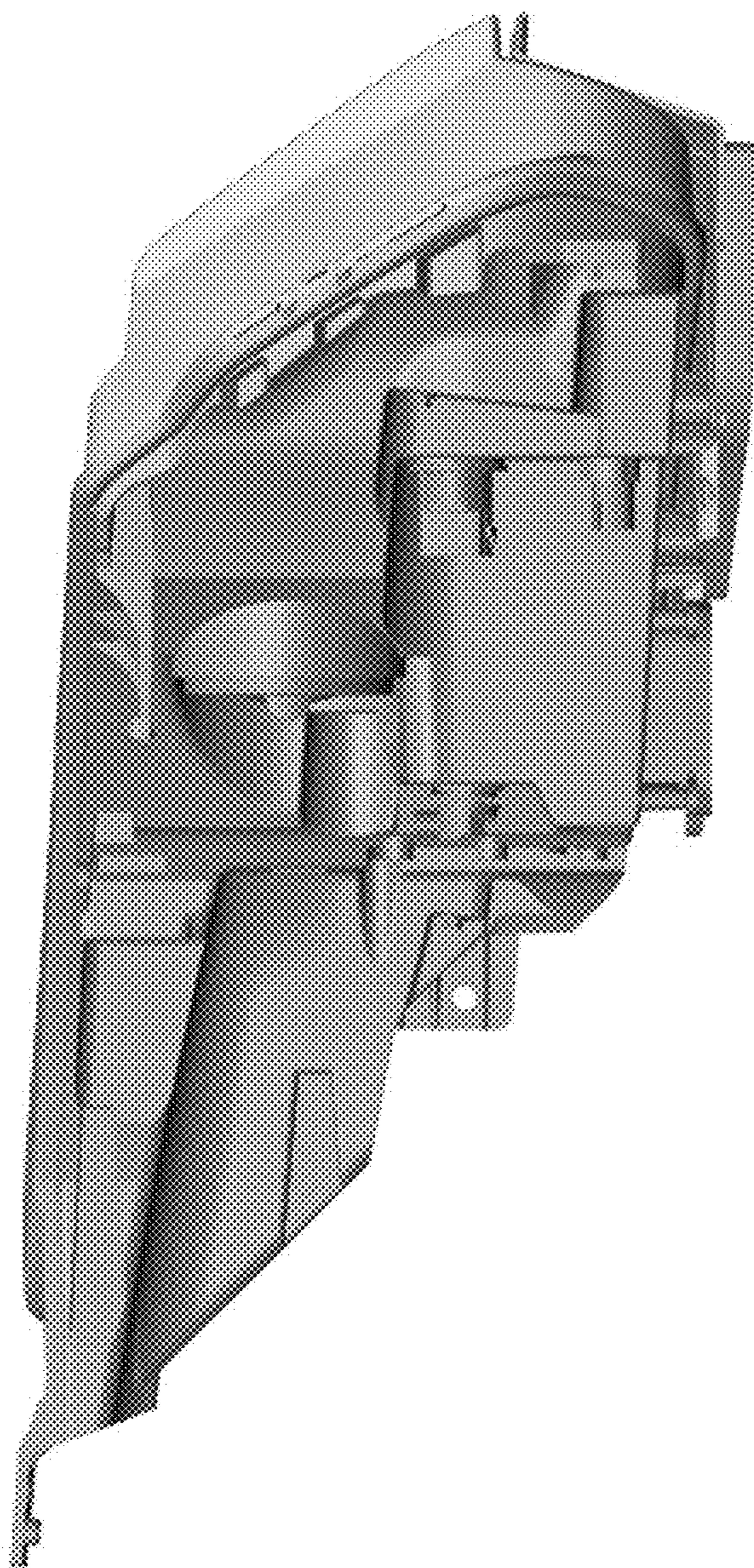

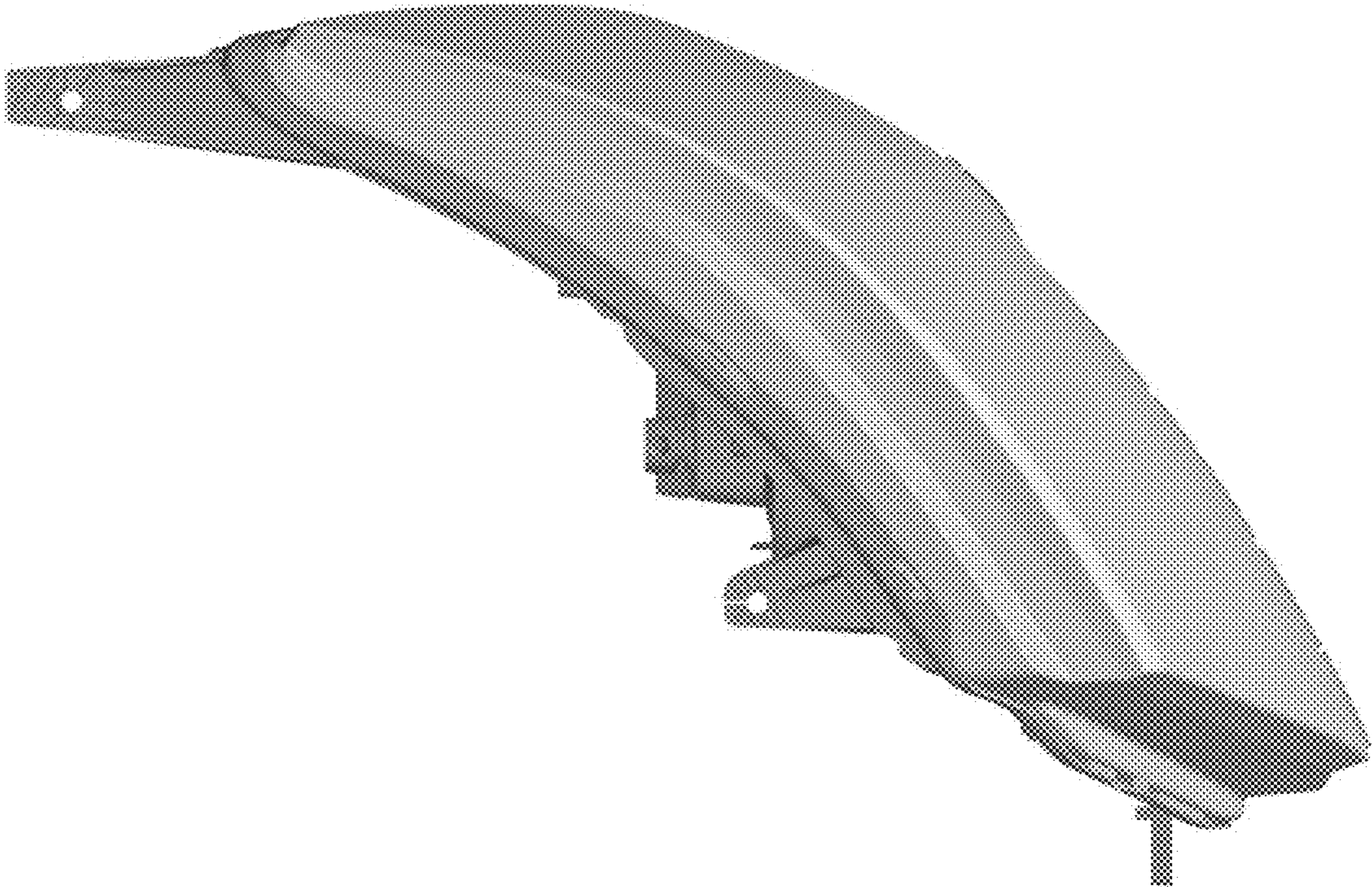
