The ornamental design for a floor lamp, as shown and described.

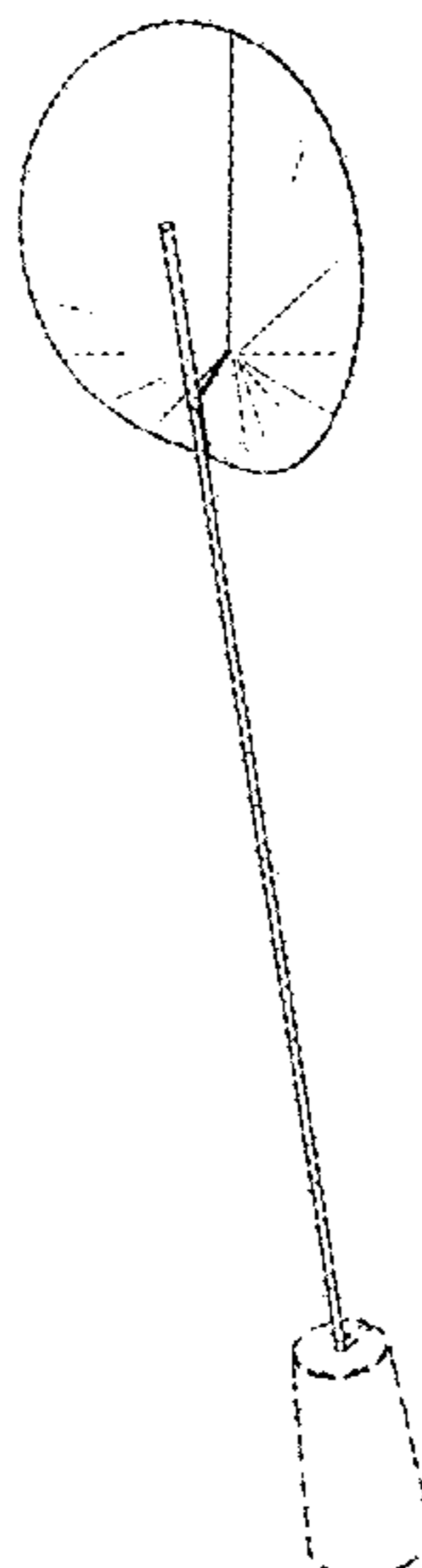
DESCRIPTION

FIG. 1.8 is a bottom plan view.

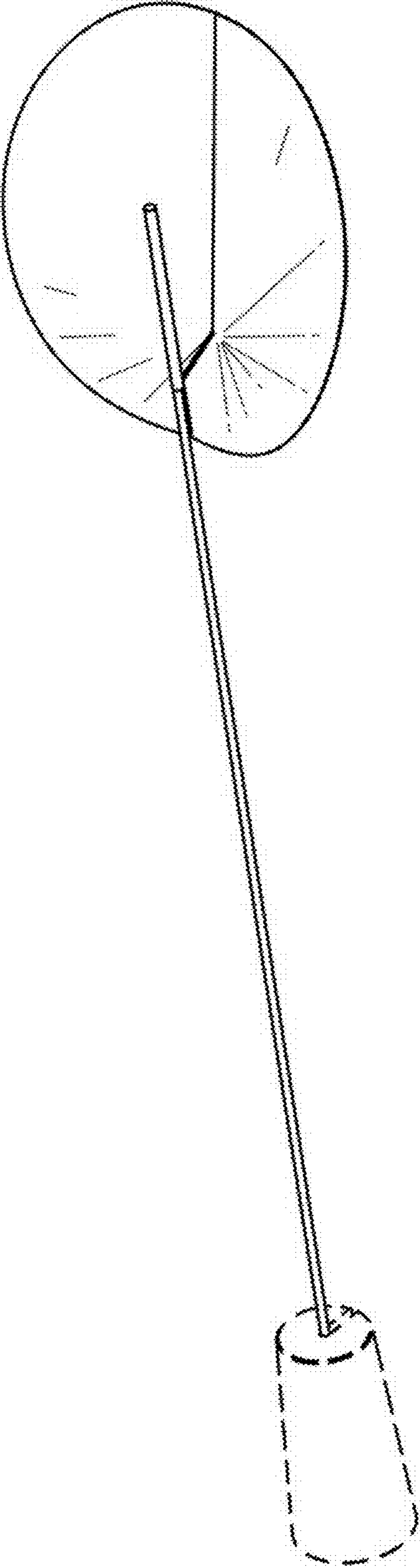
The broken lines in the drawing are for illustrative purposes only and form no part of the claimed design.

The model is a table lamp with a base having a rectangular shape and a shade having a spherical shape.

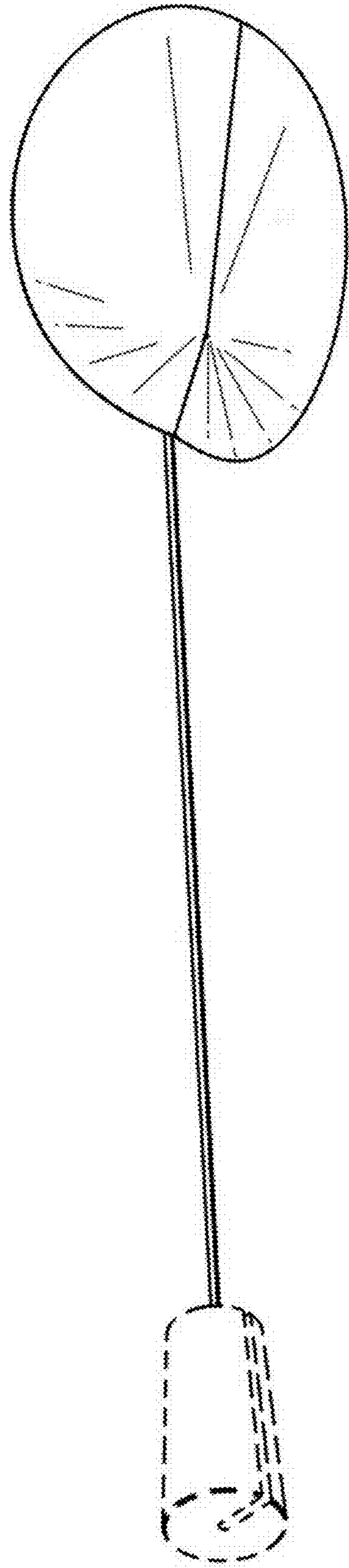

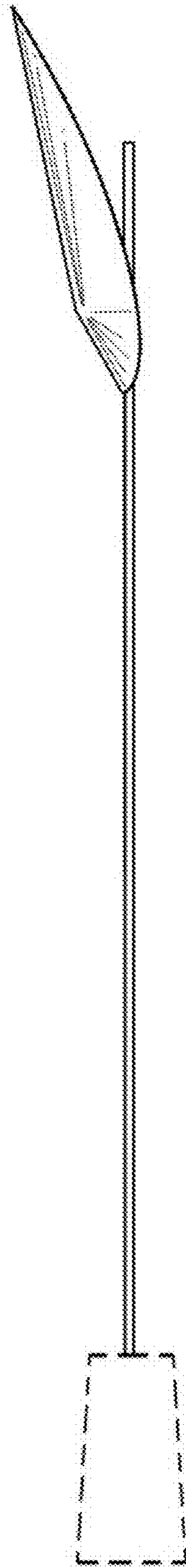

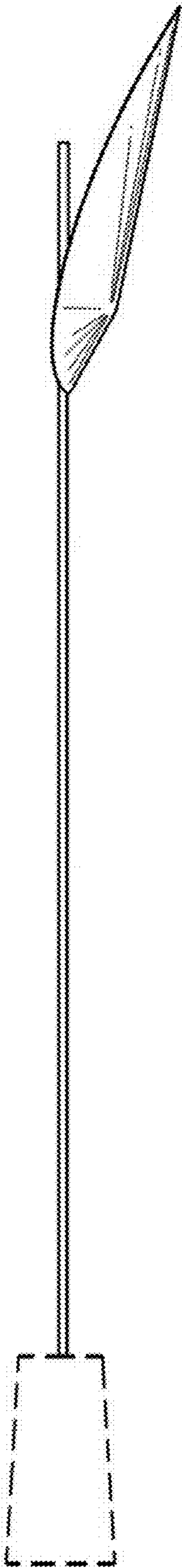

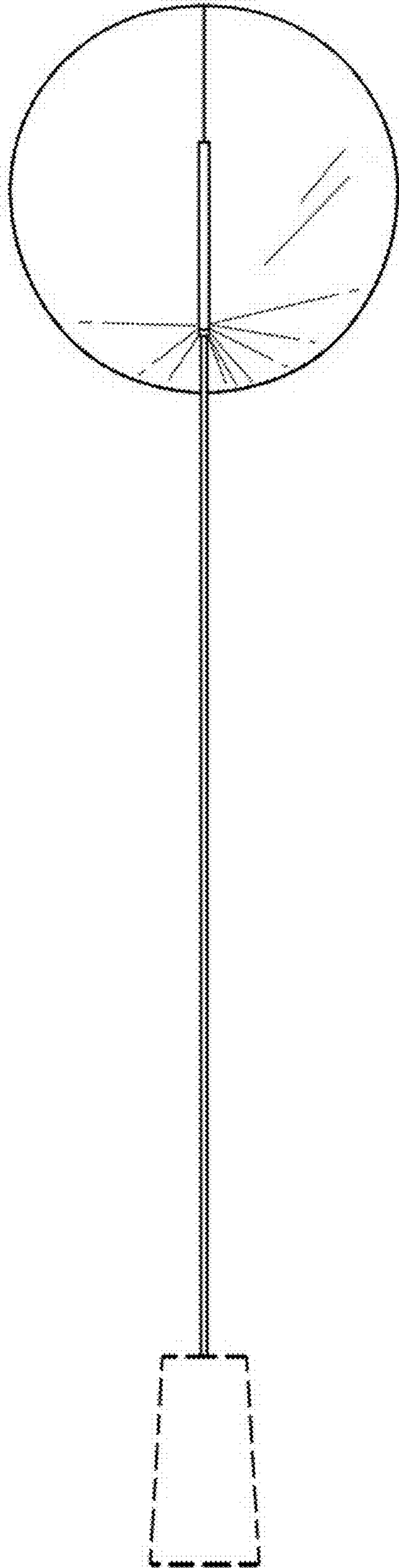

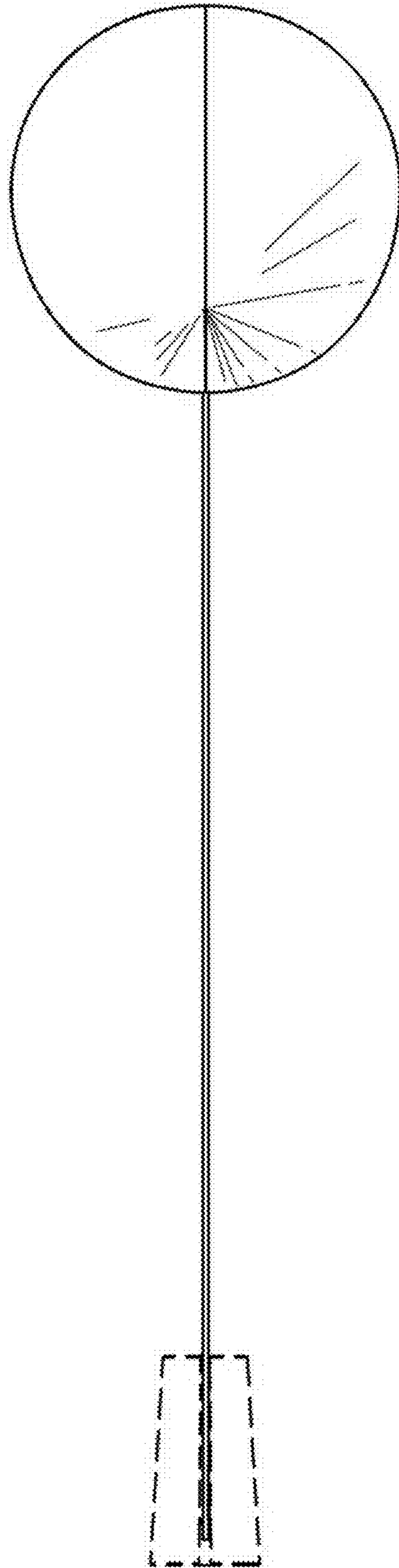

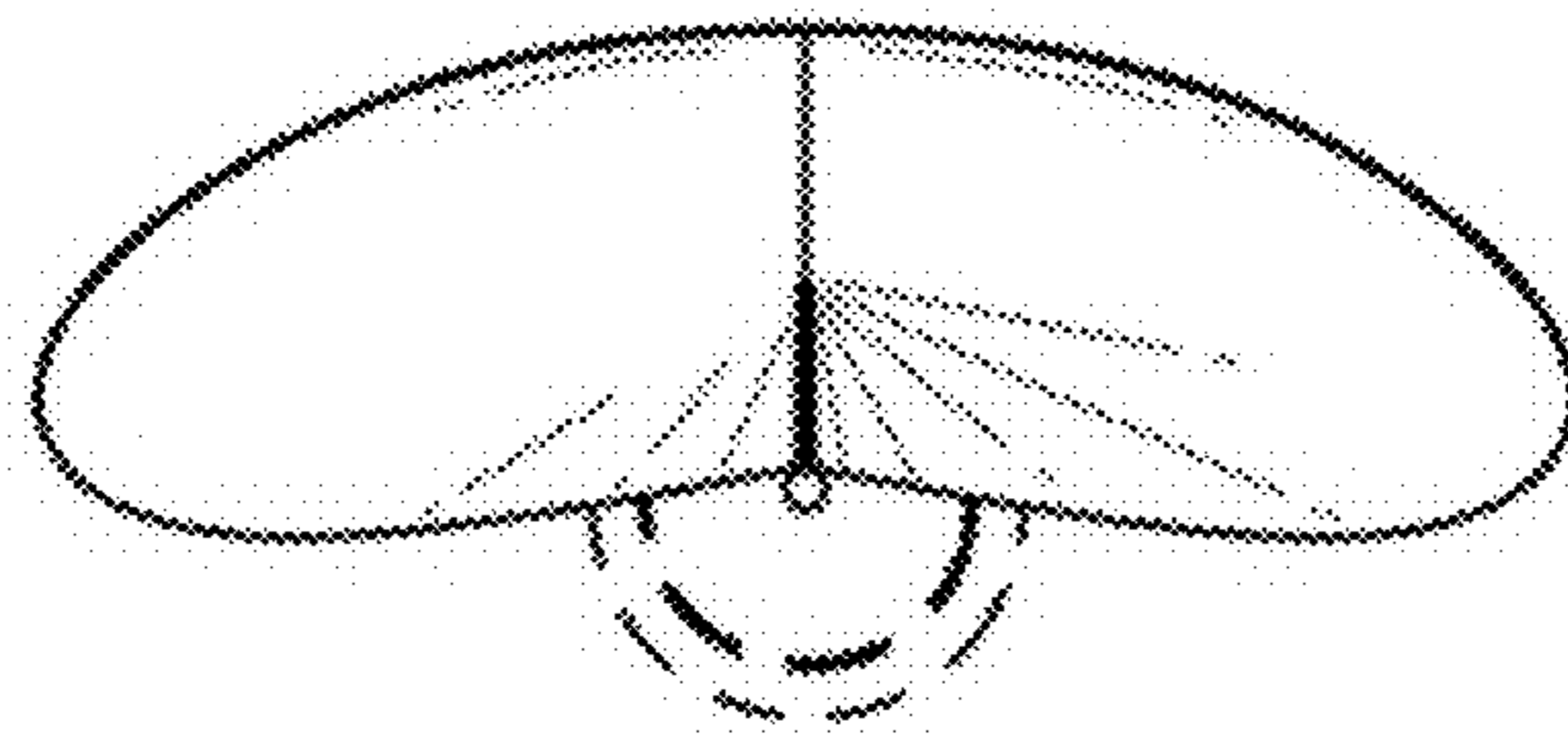
