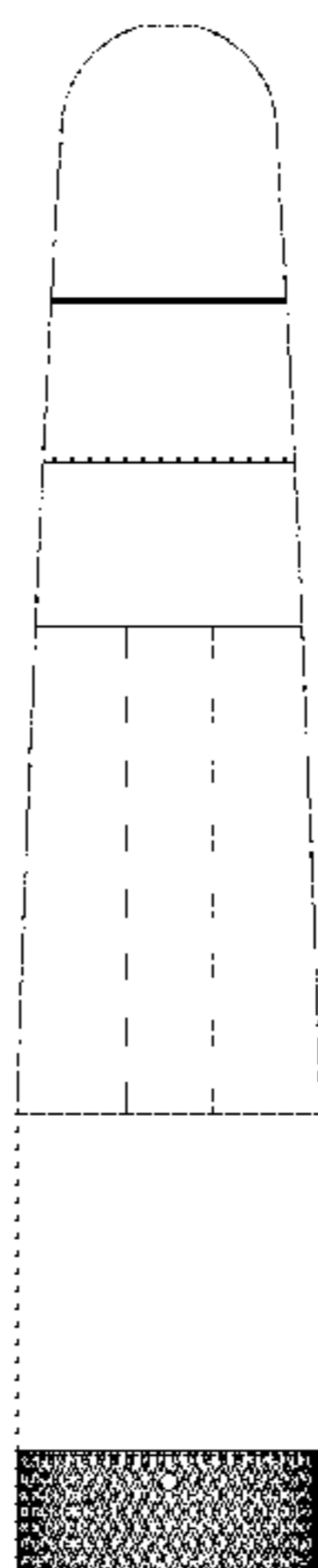


FIG. 17 is a rear view of the atomizer of electronic cigarette according to the third embodiment of the present application;

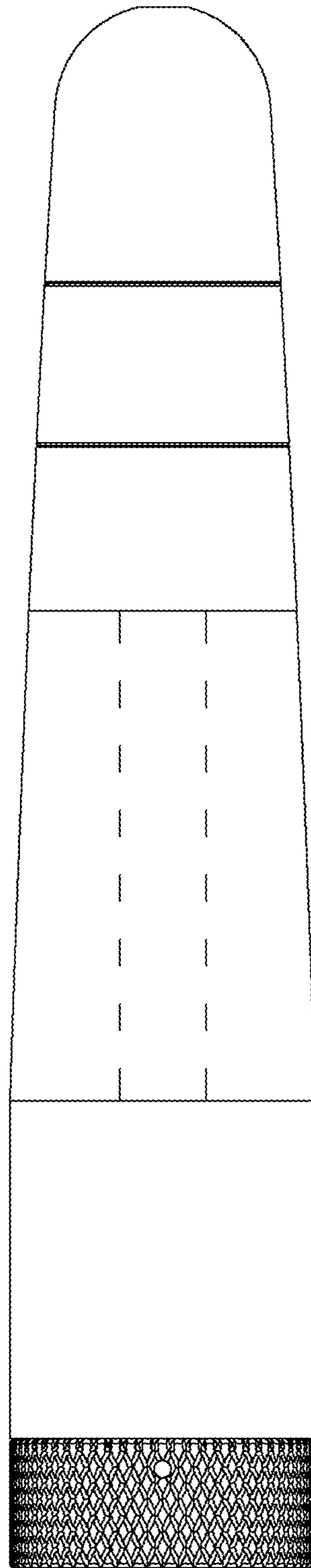

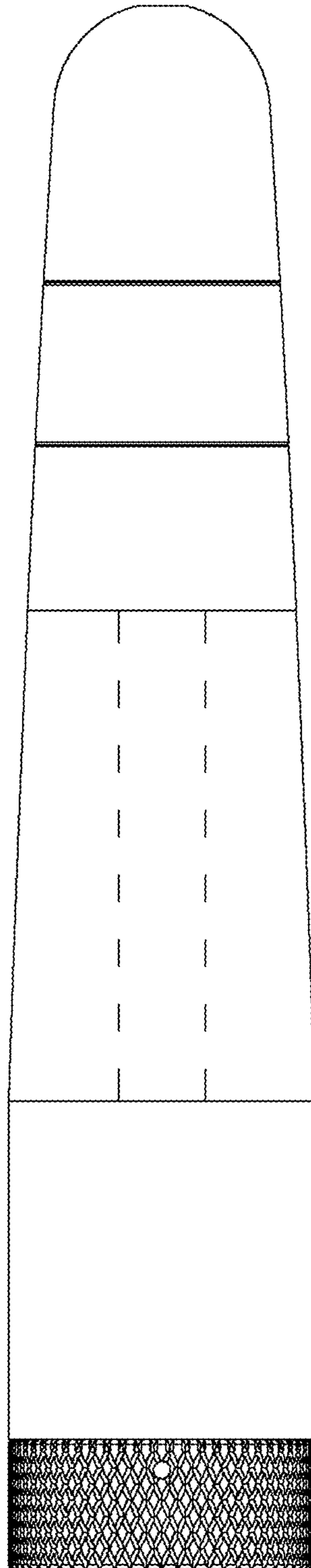

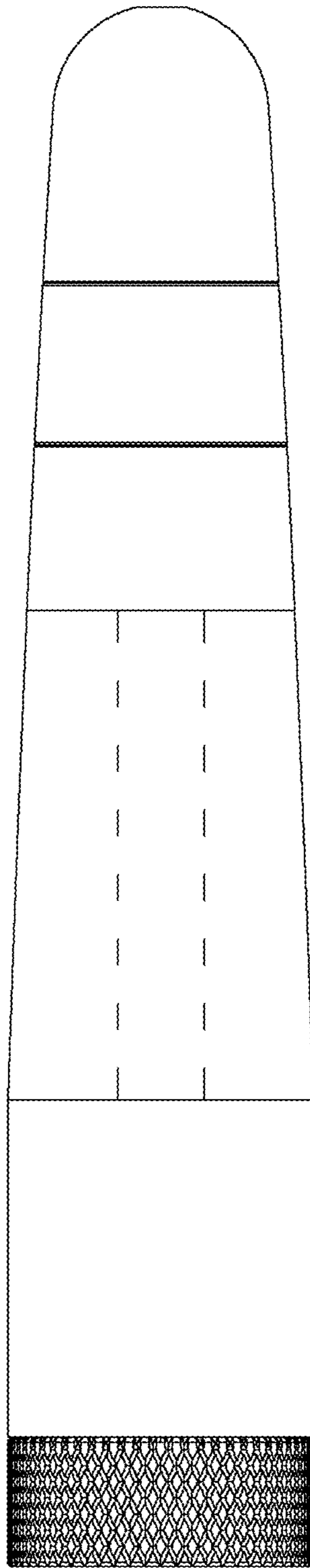

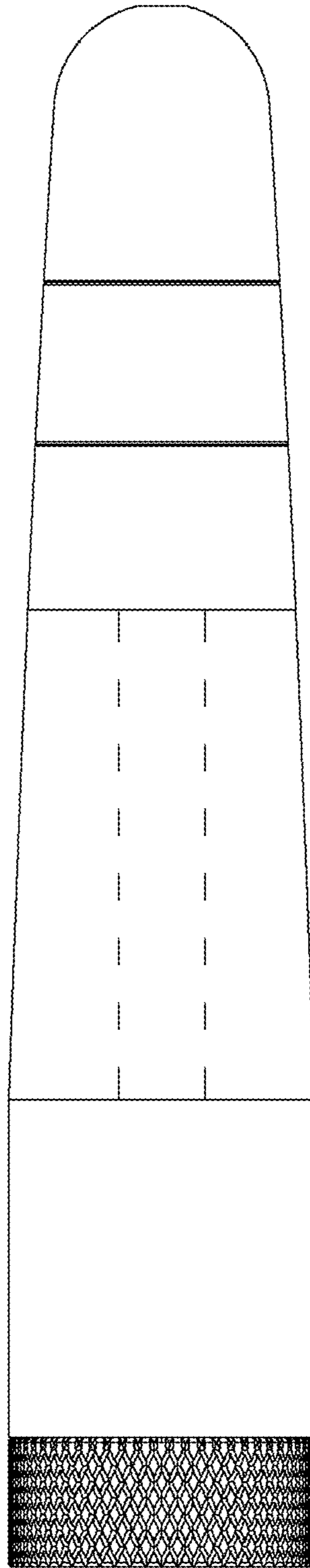

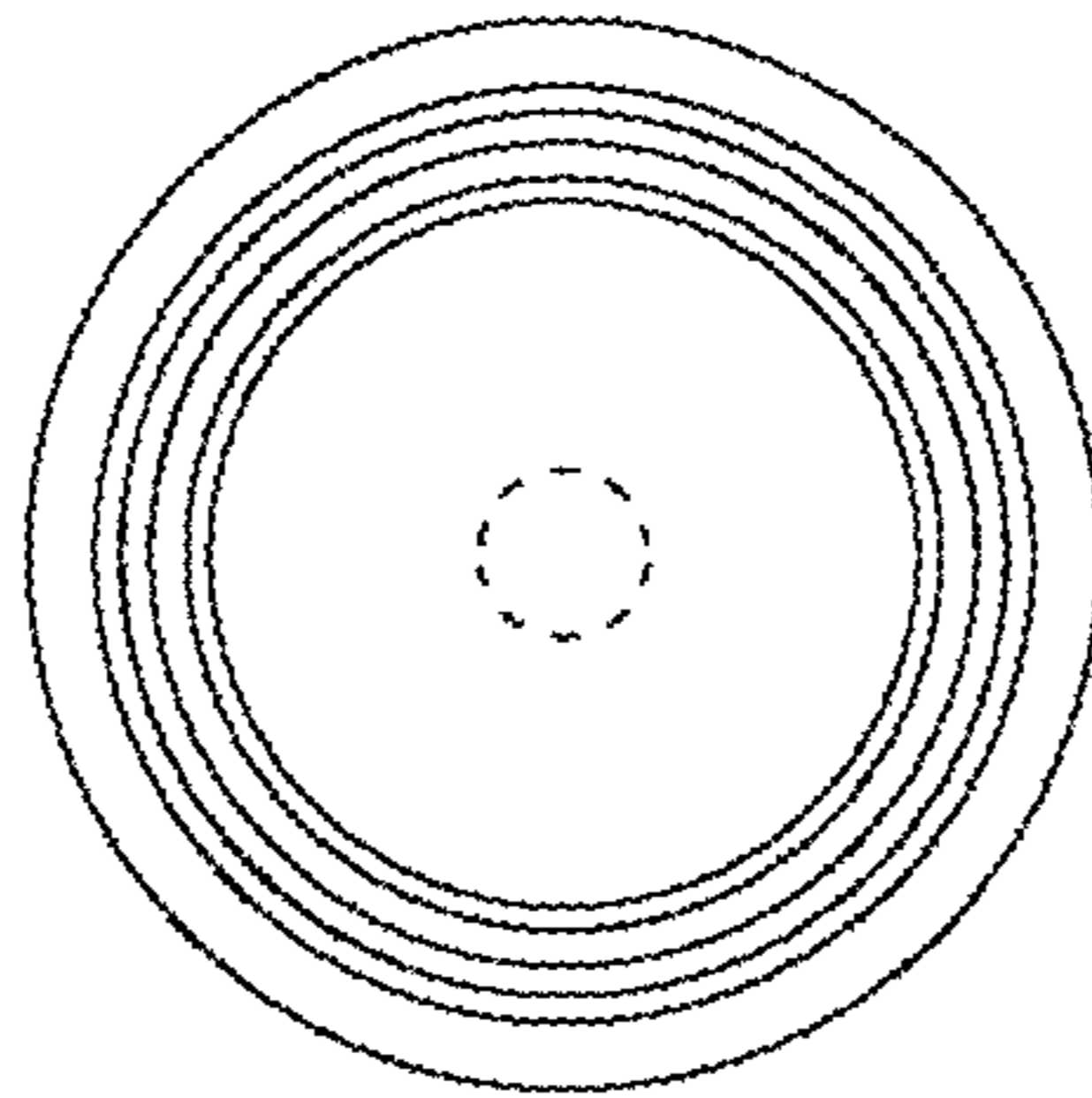

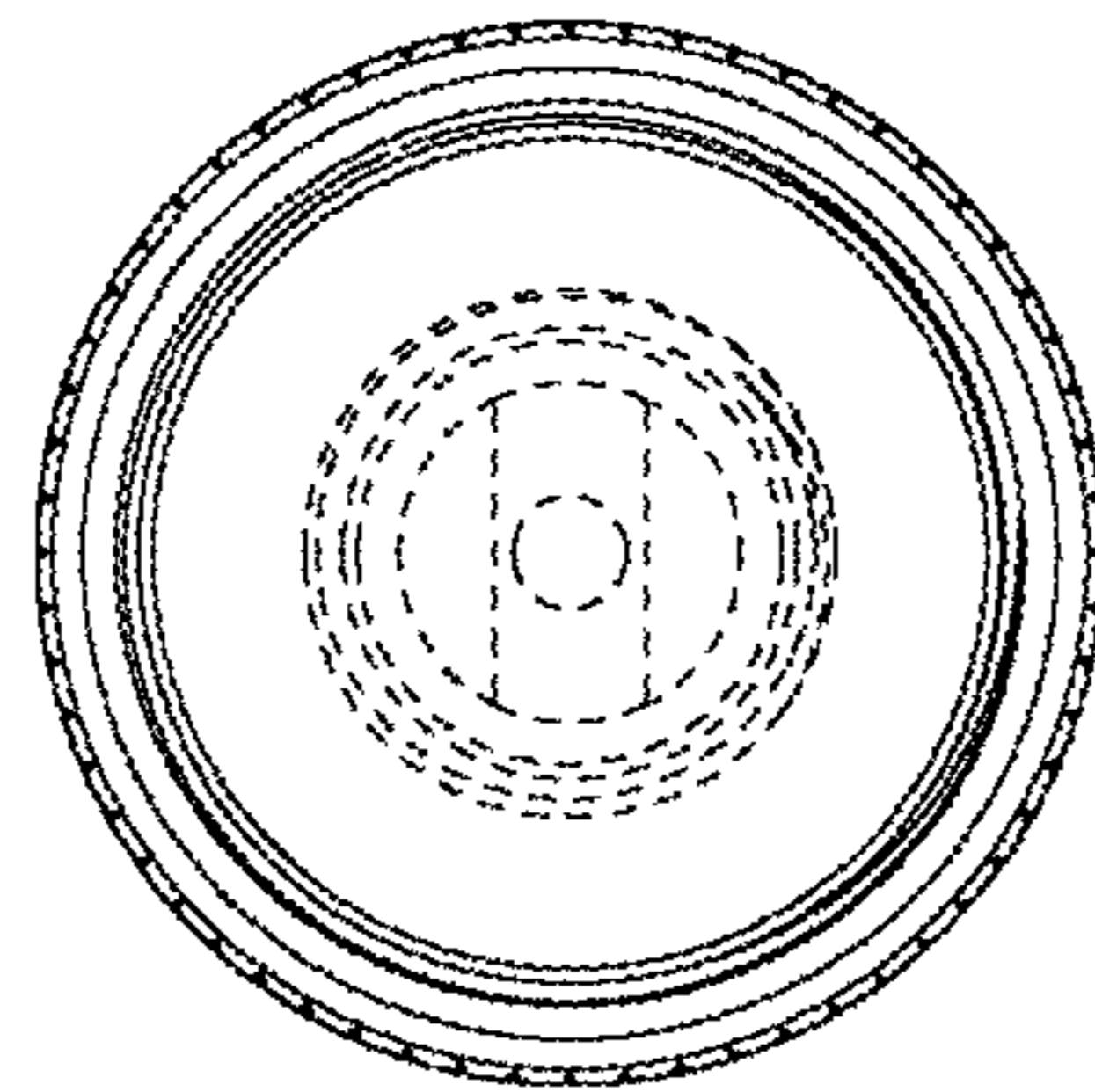

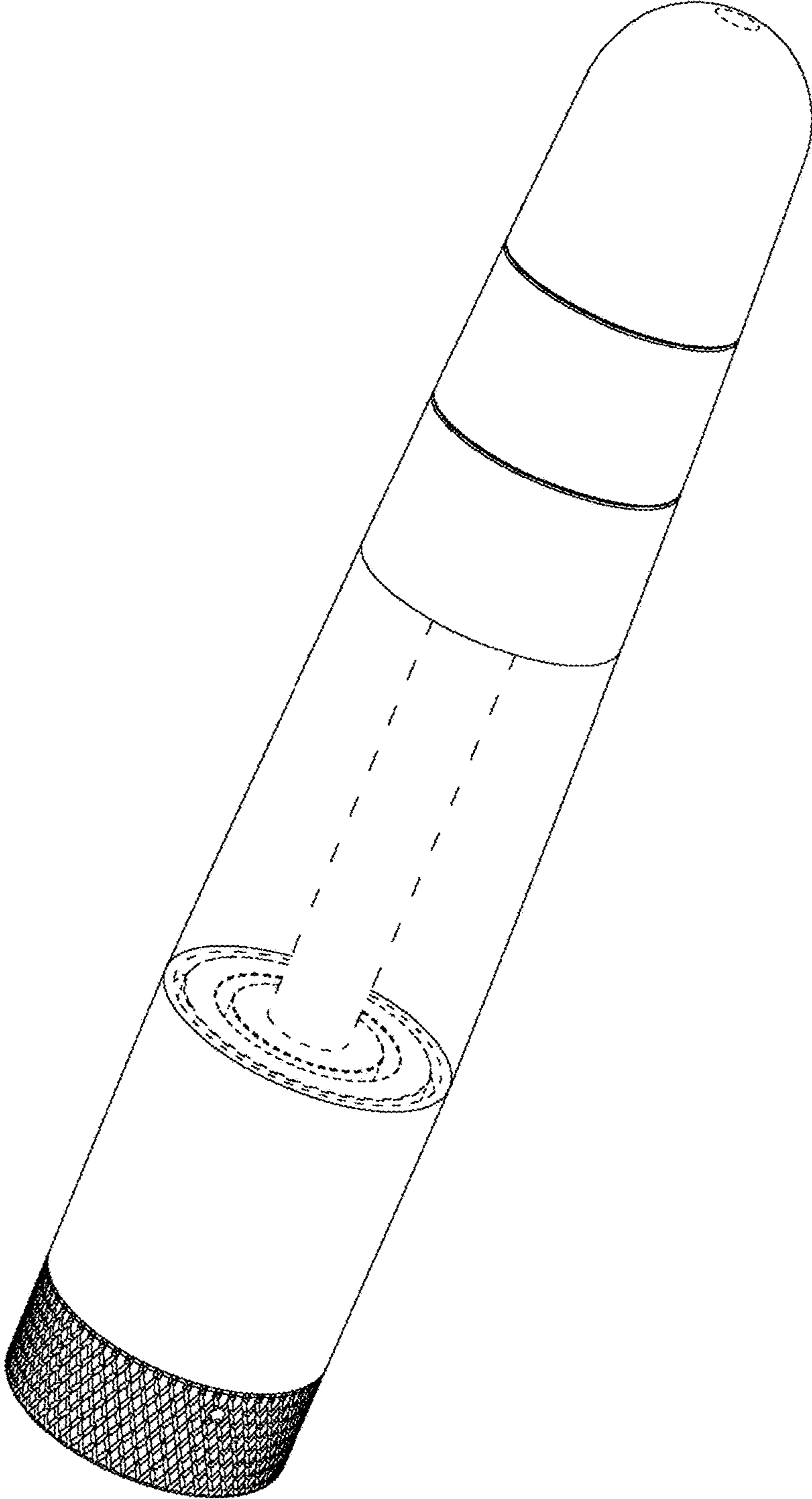

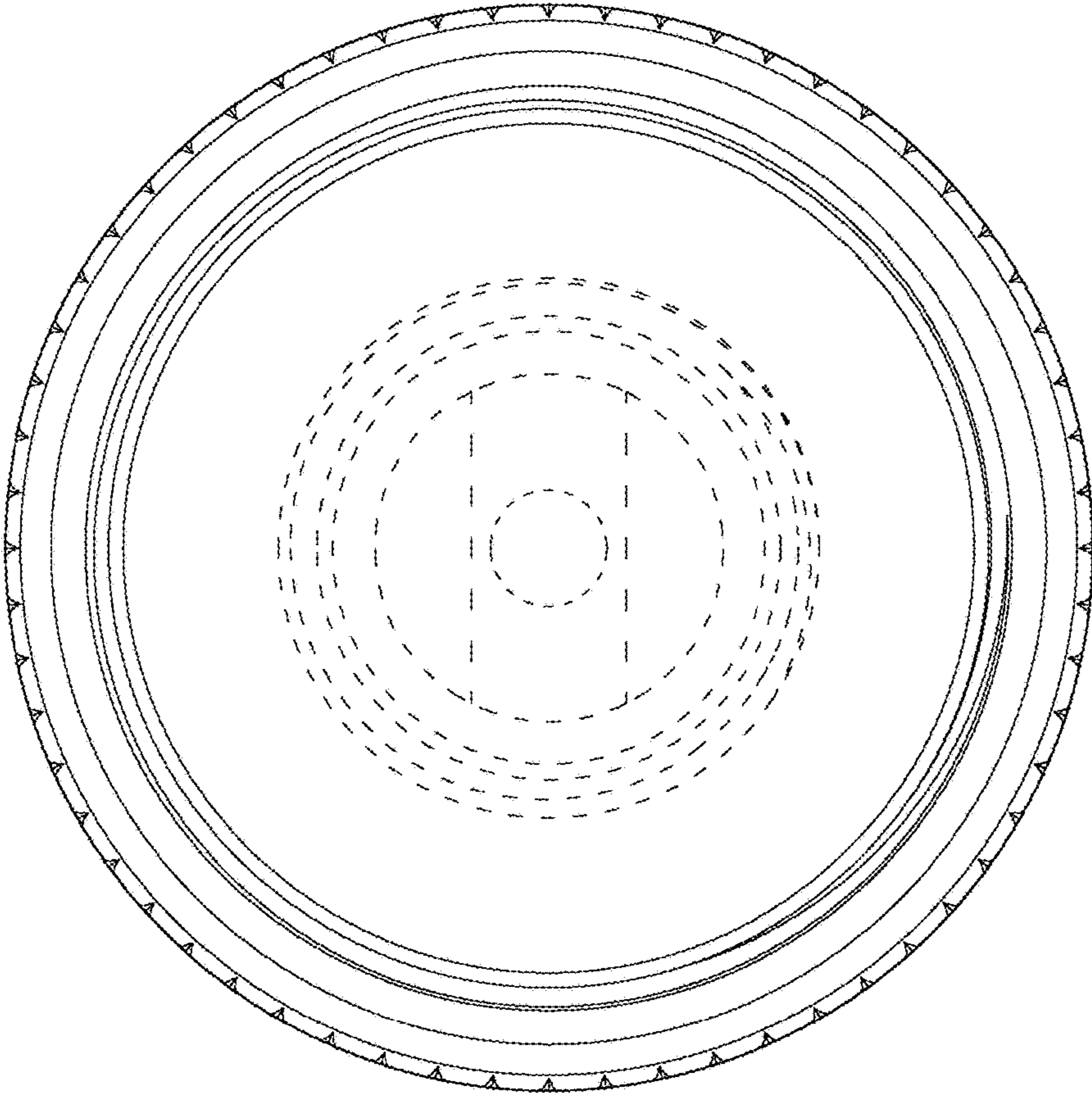

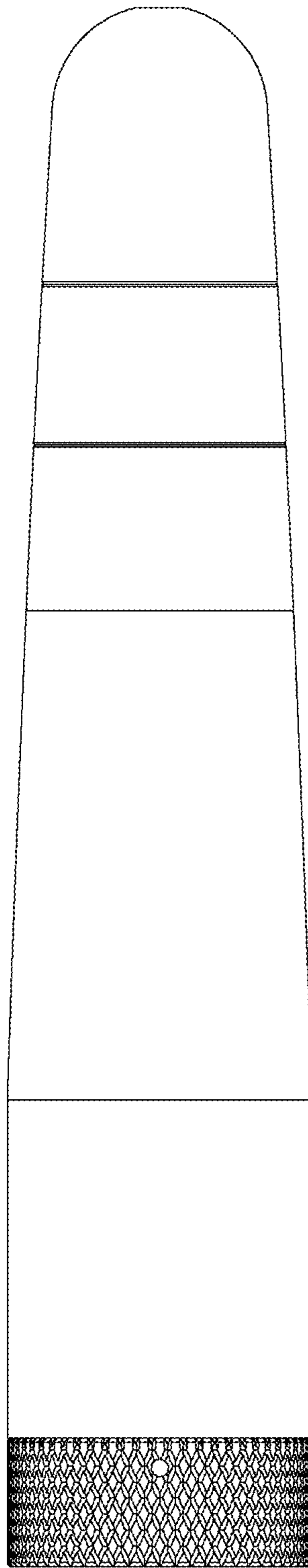

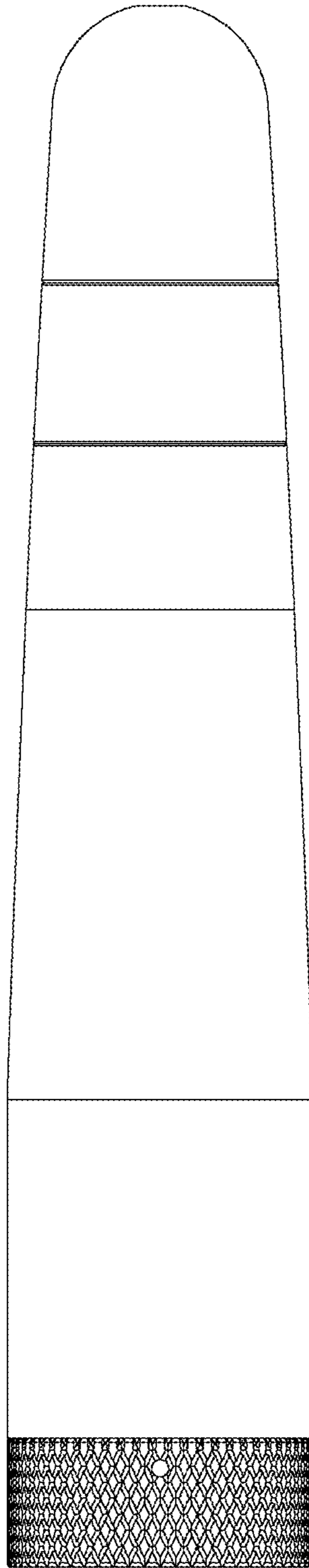

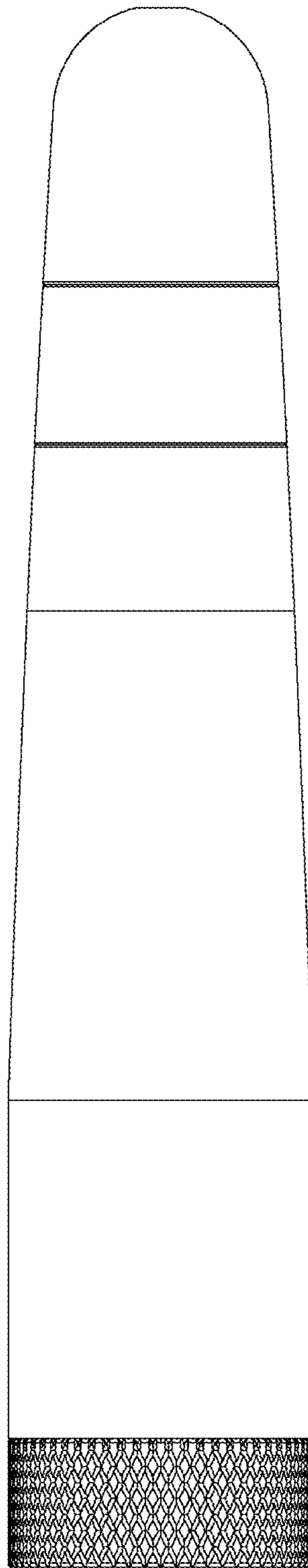

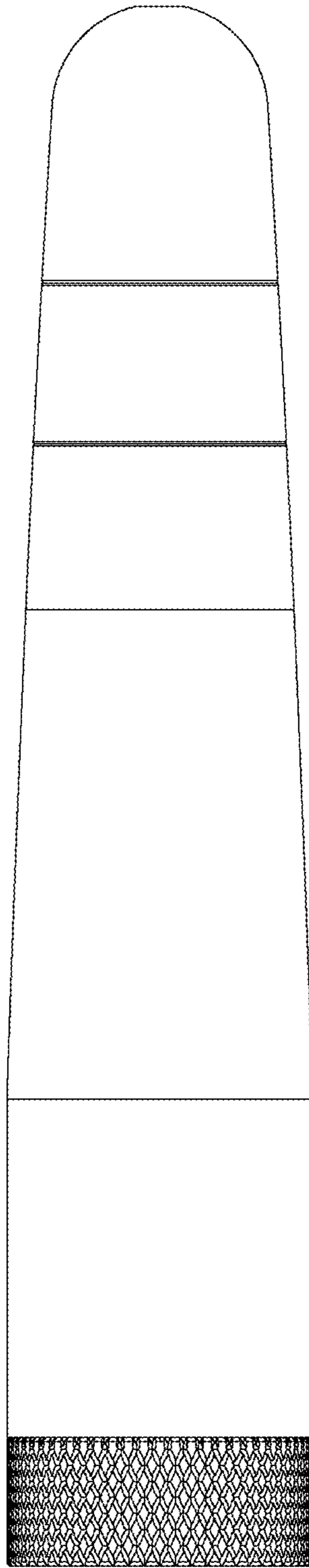

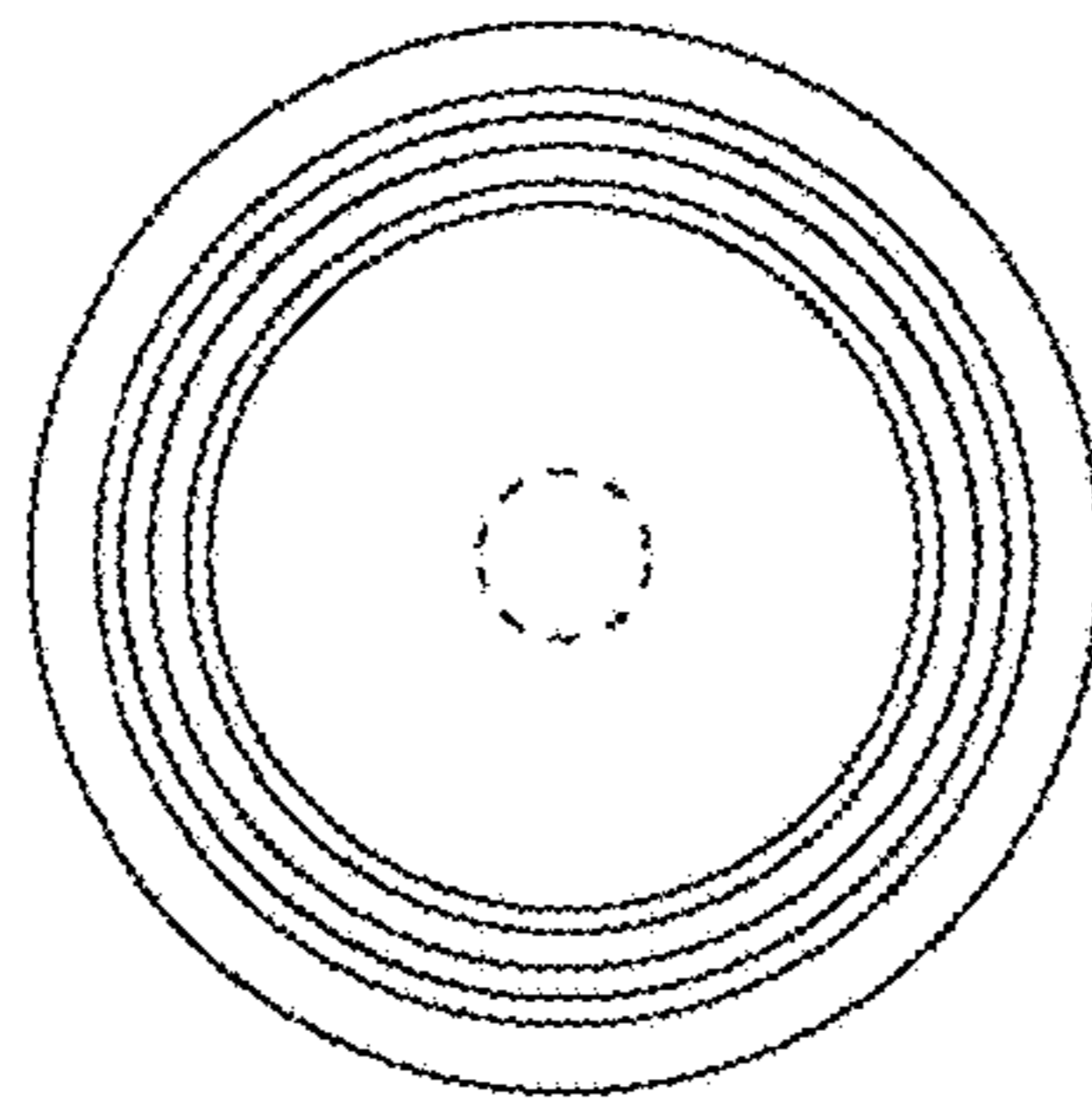

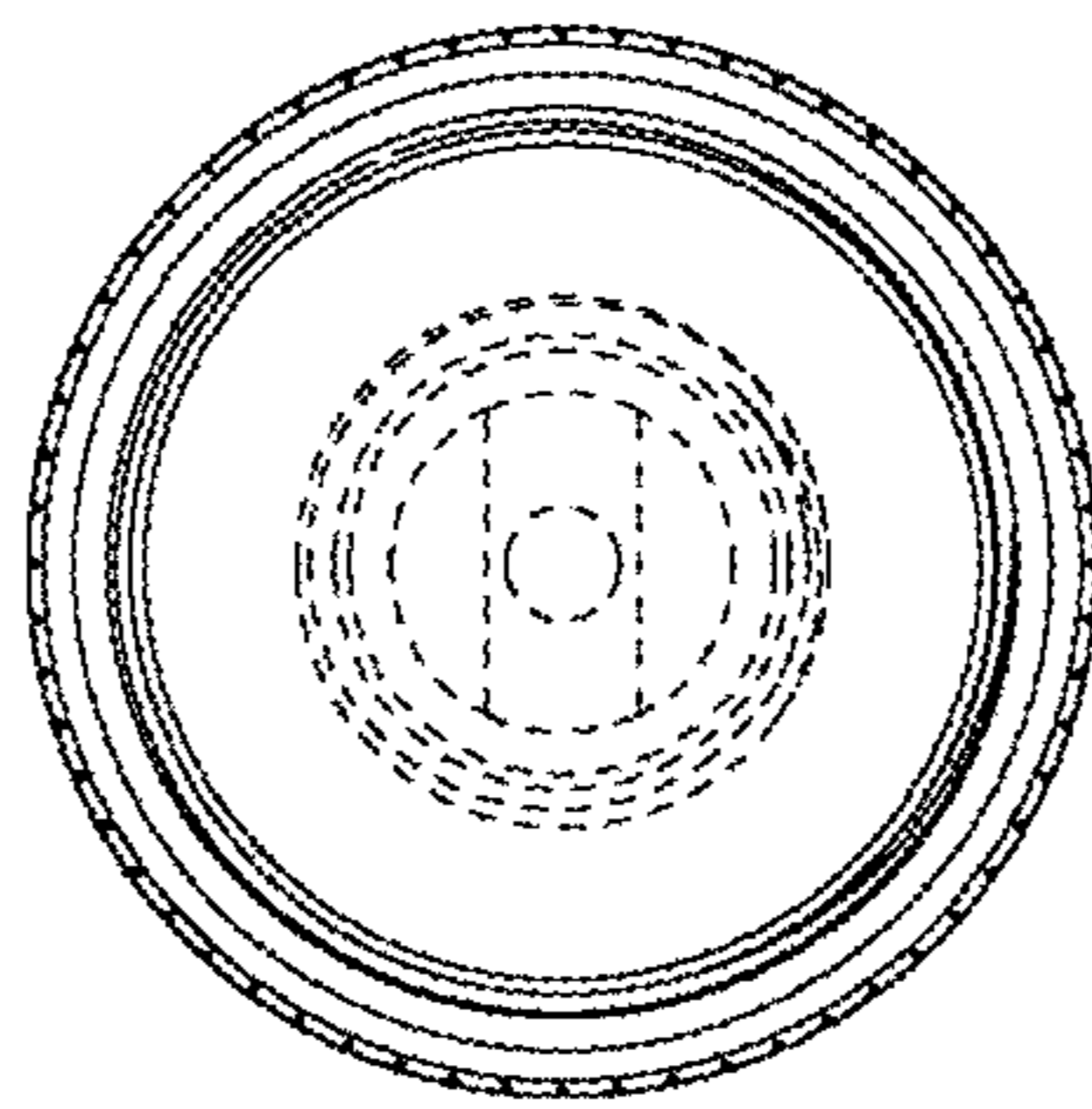

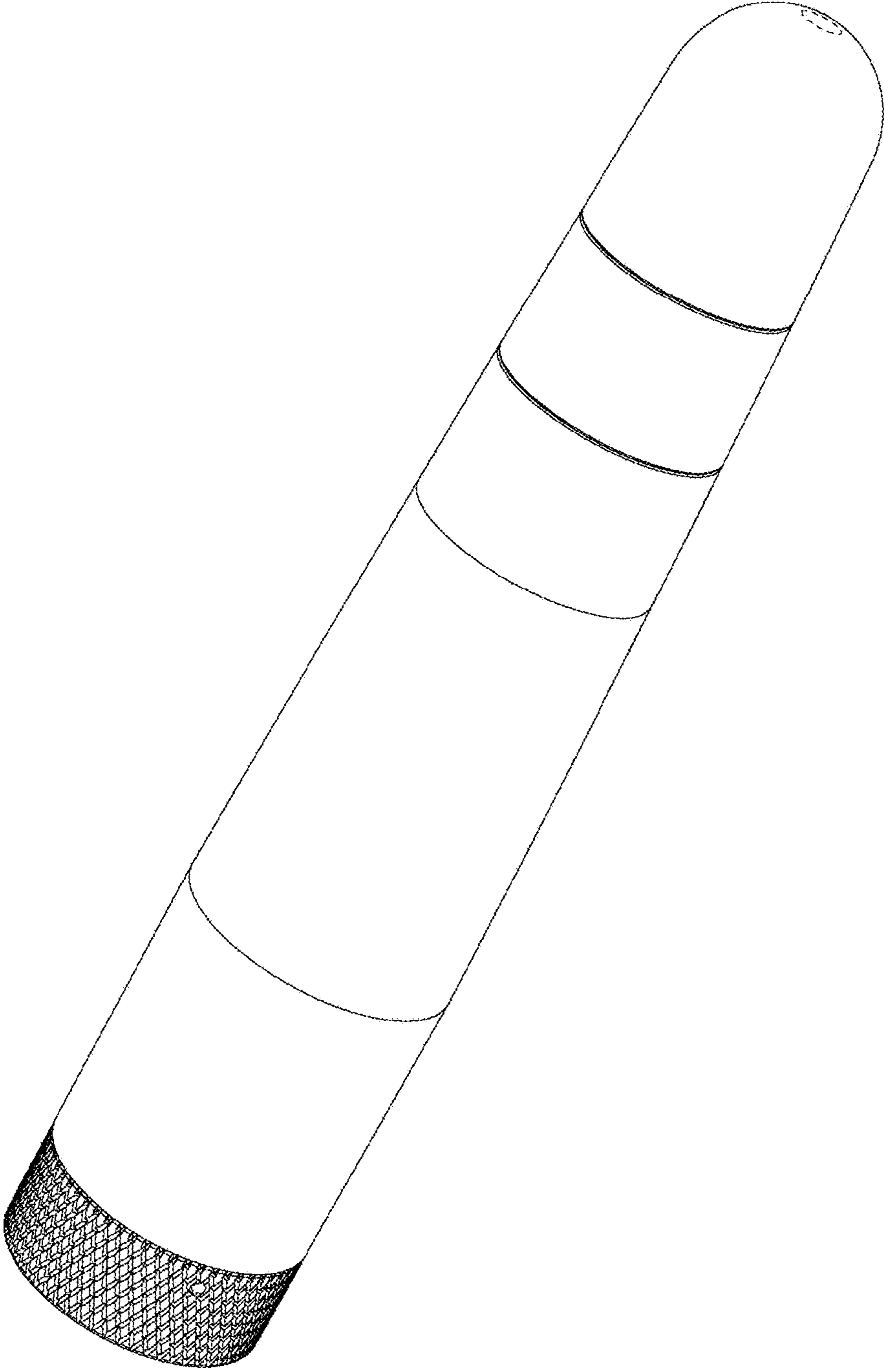

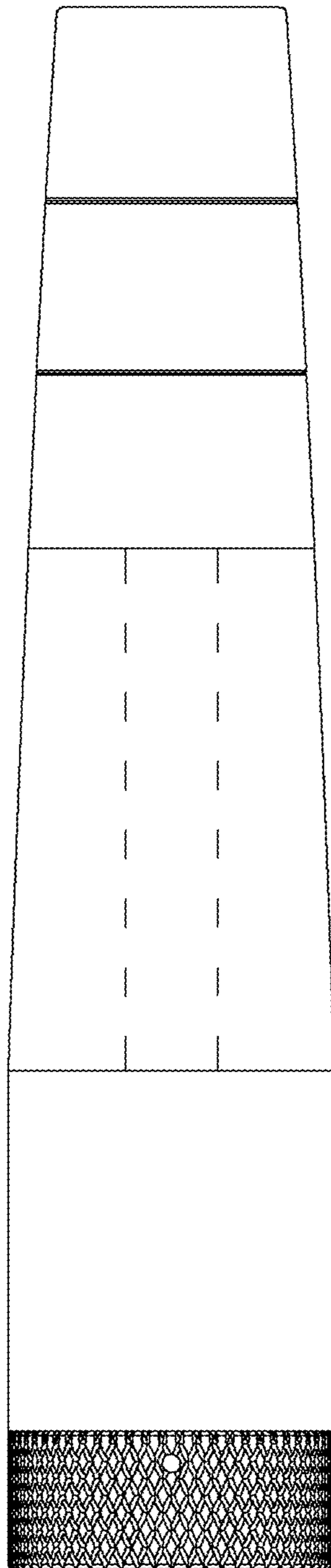

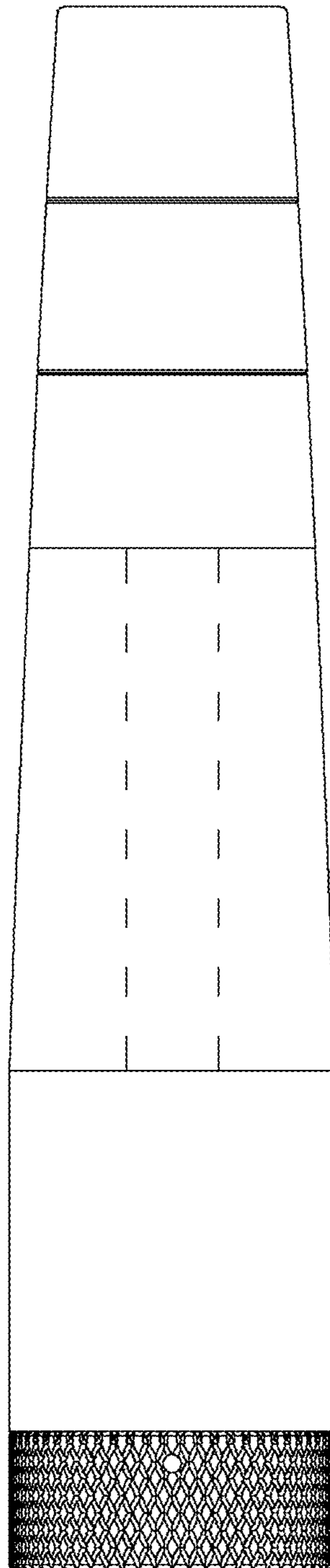

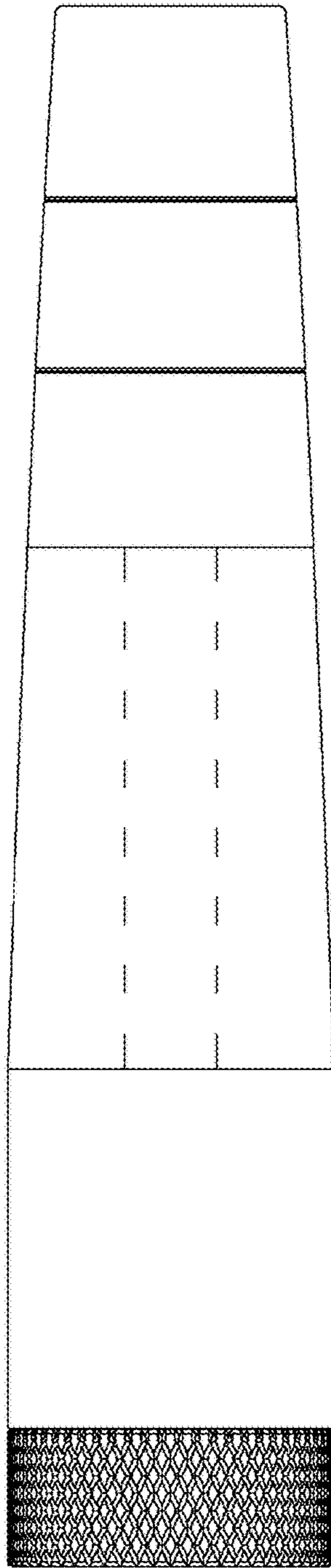

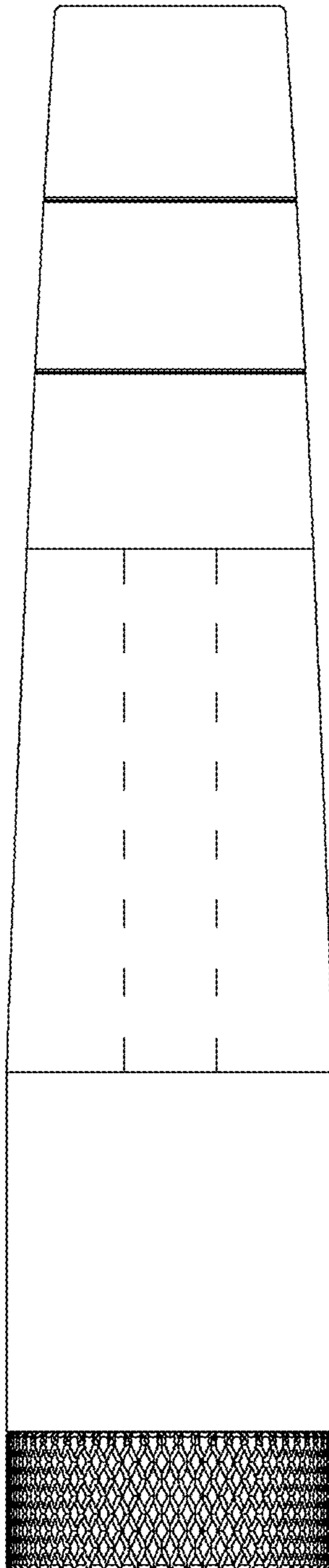

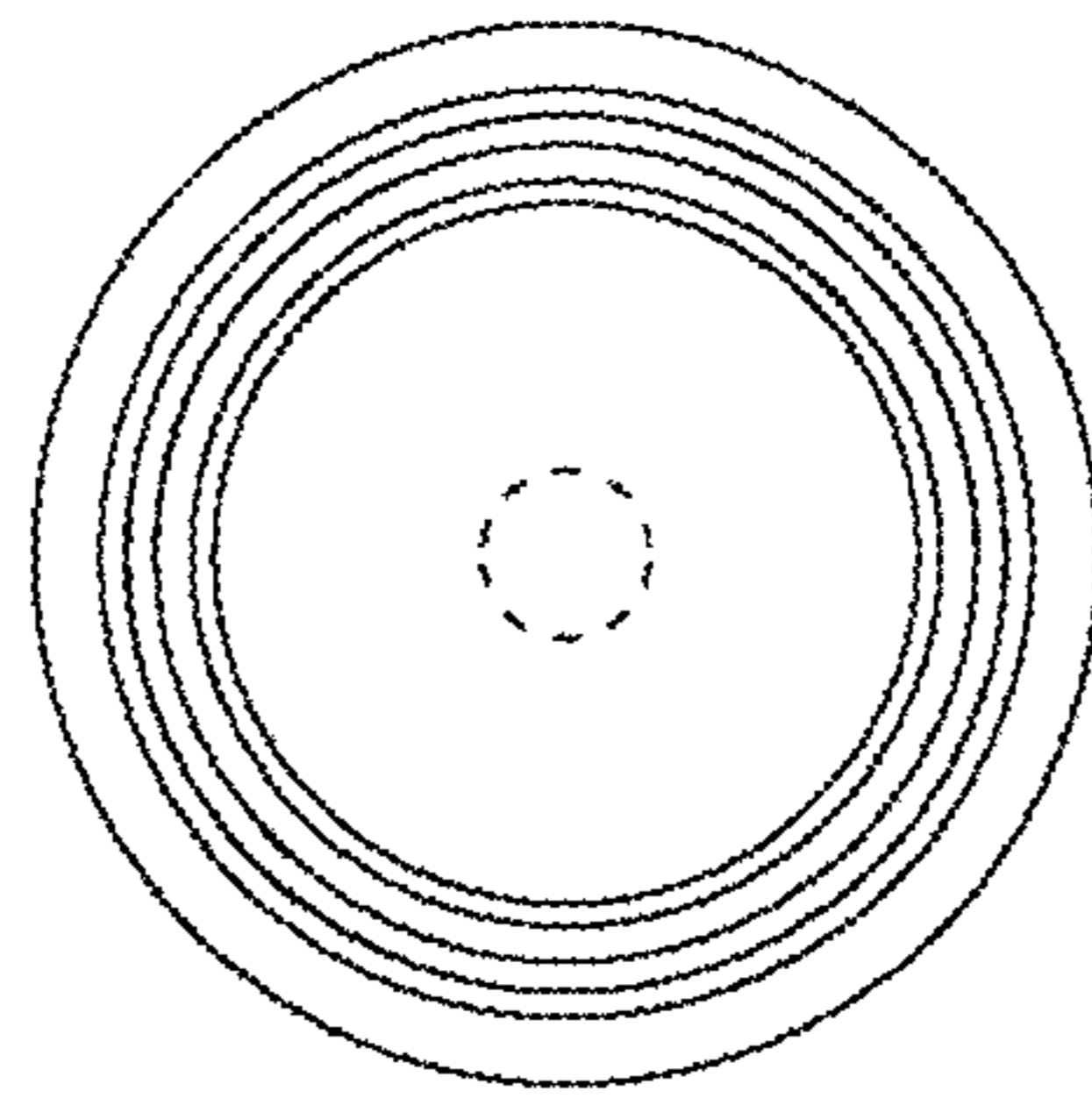

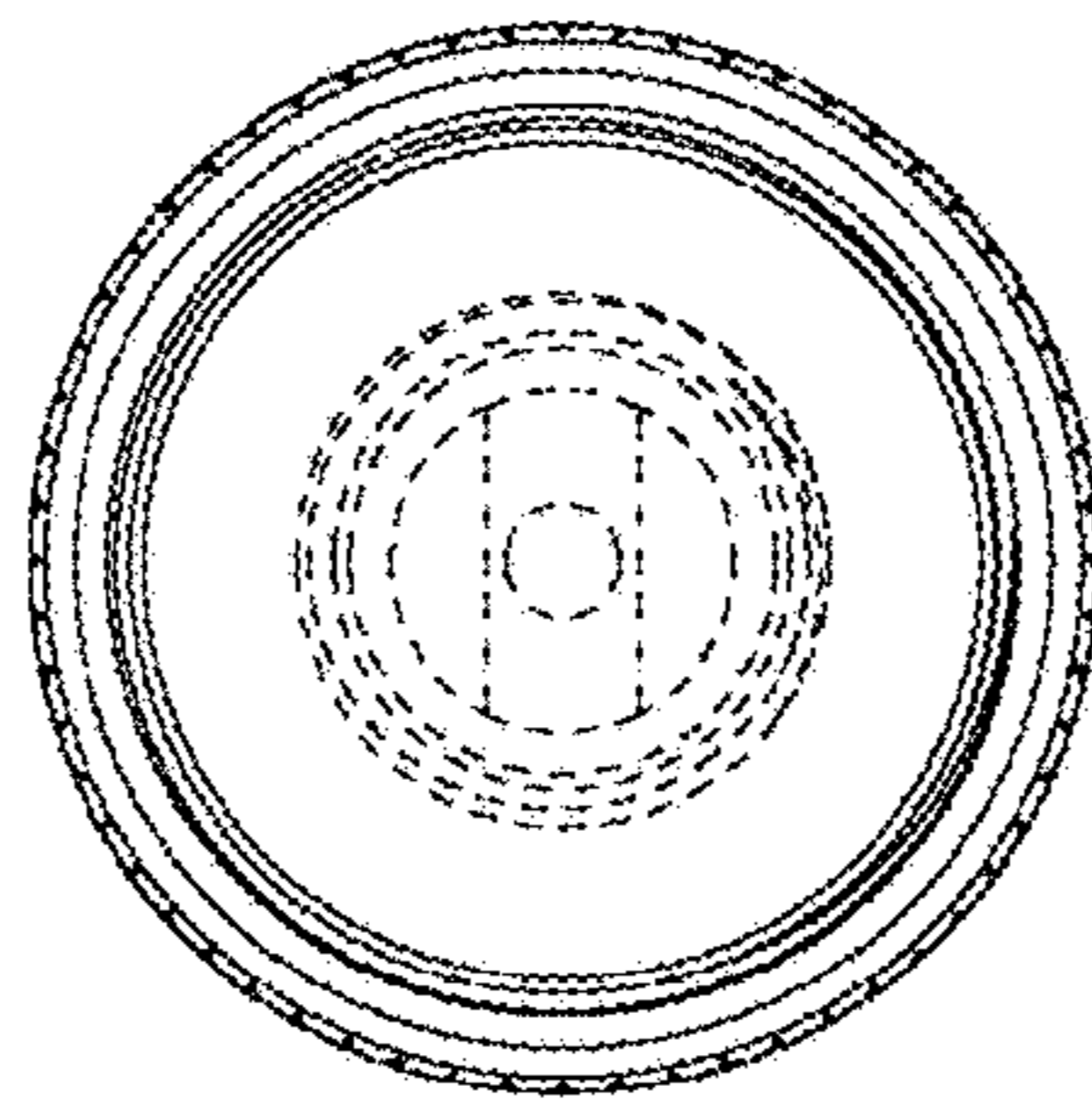

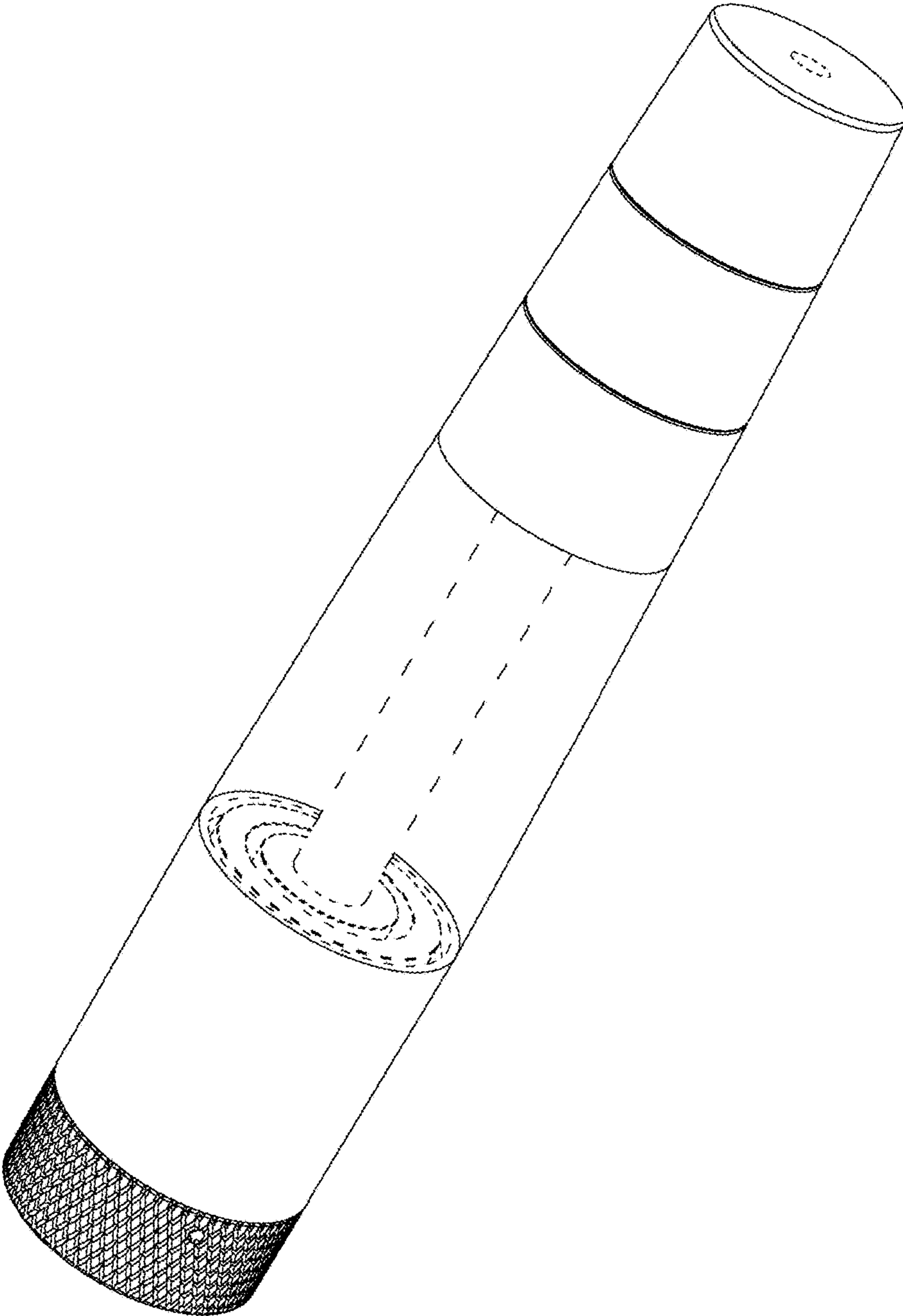

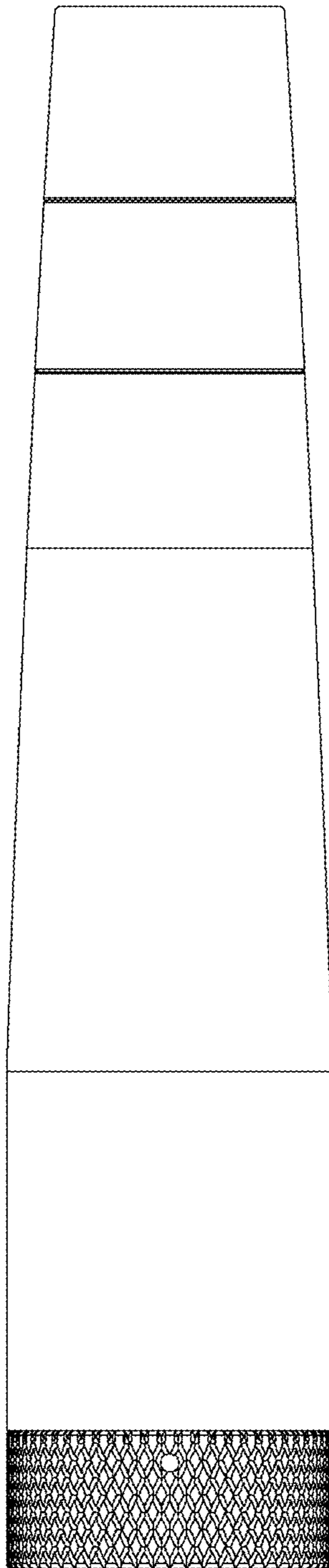

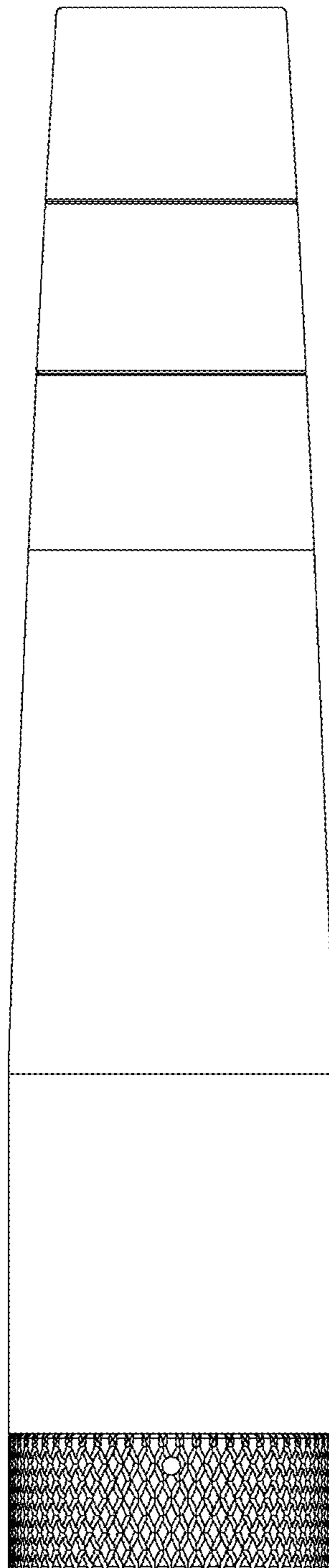

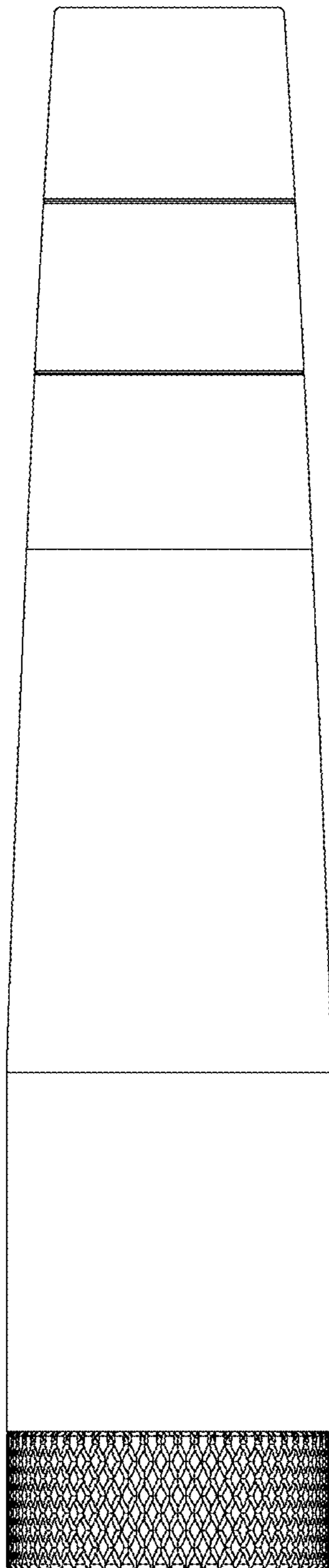

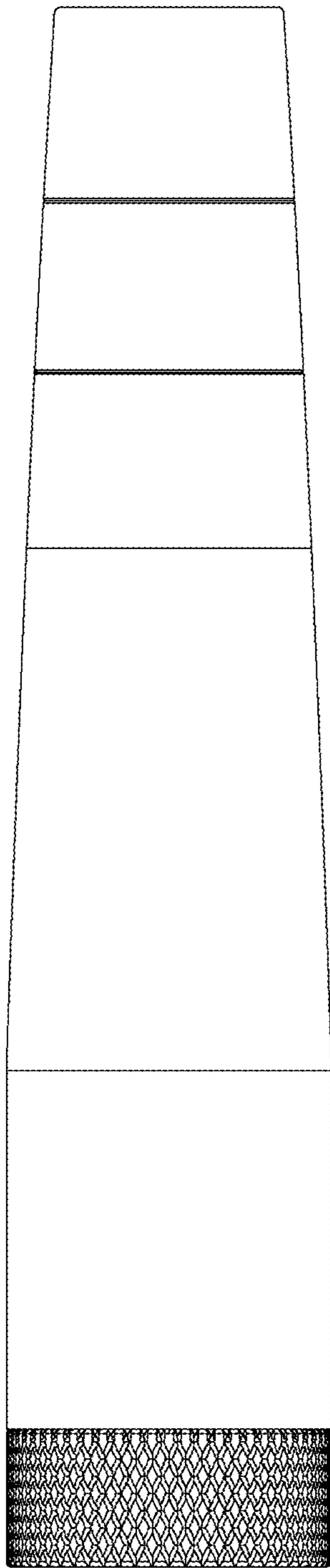

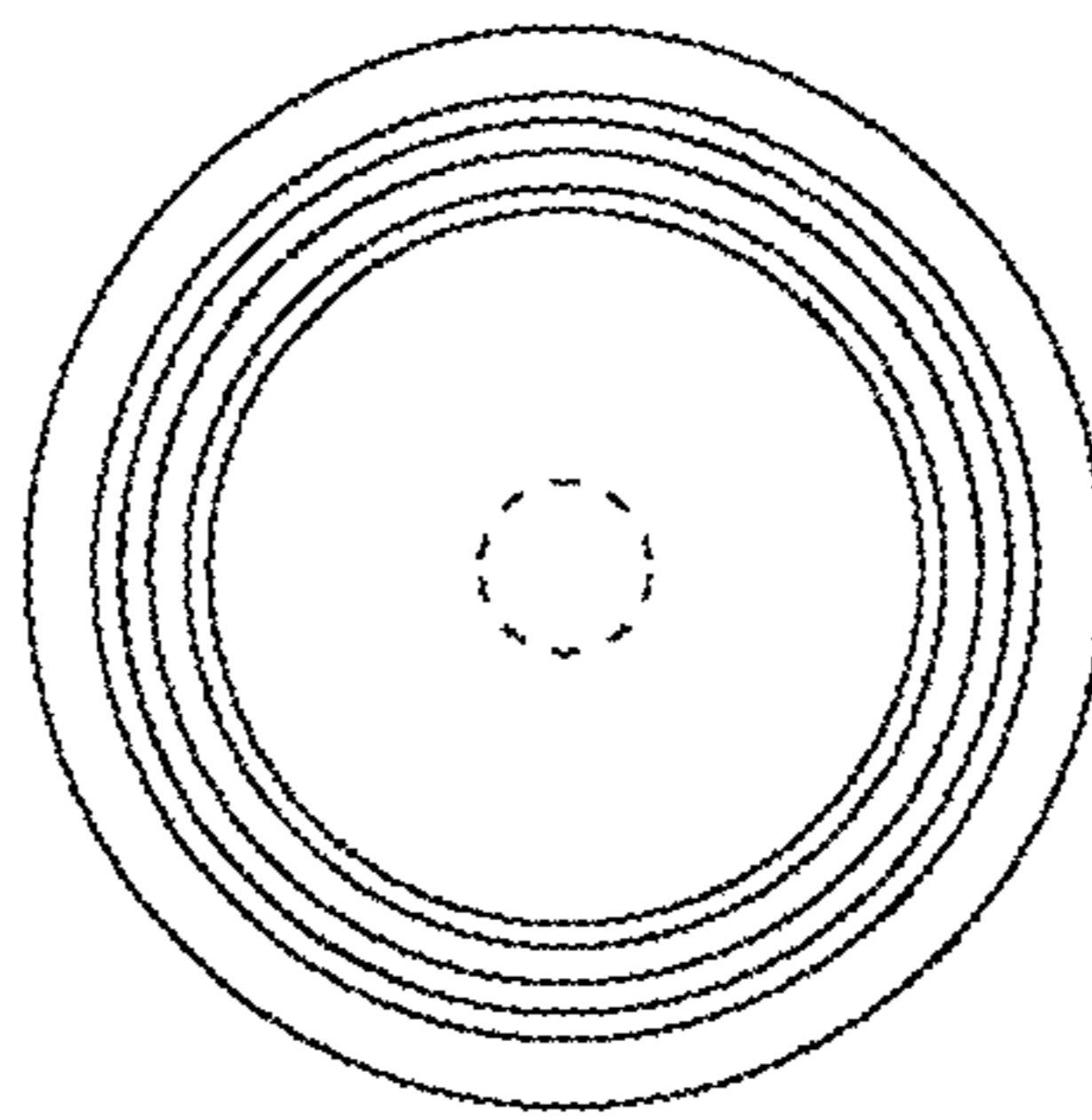

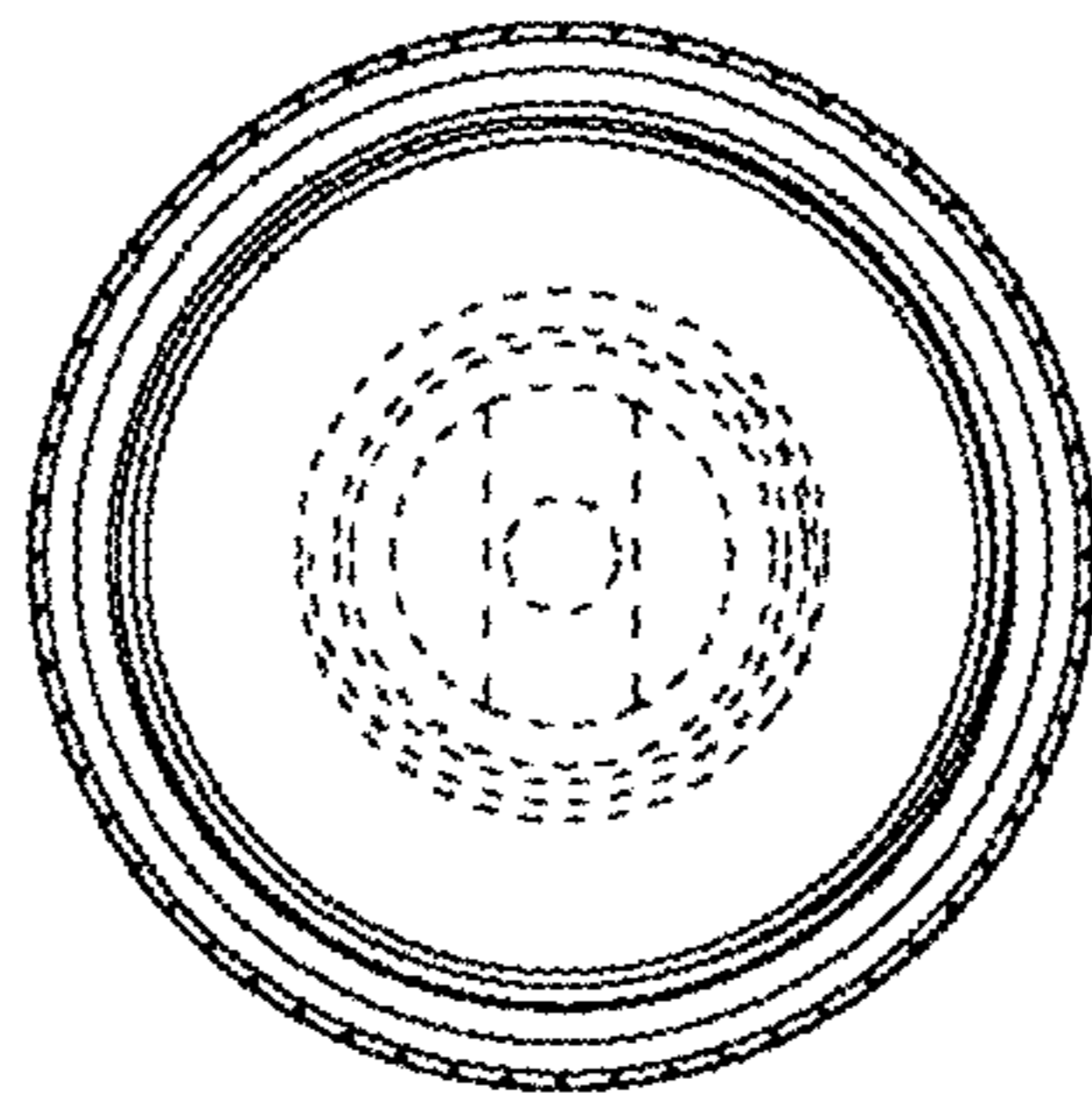

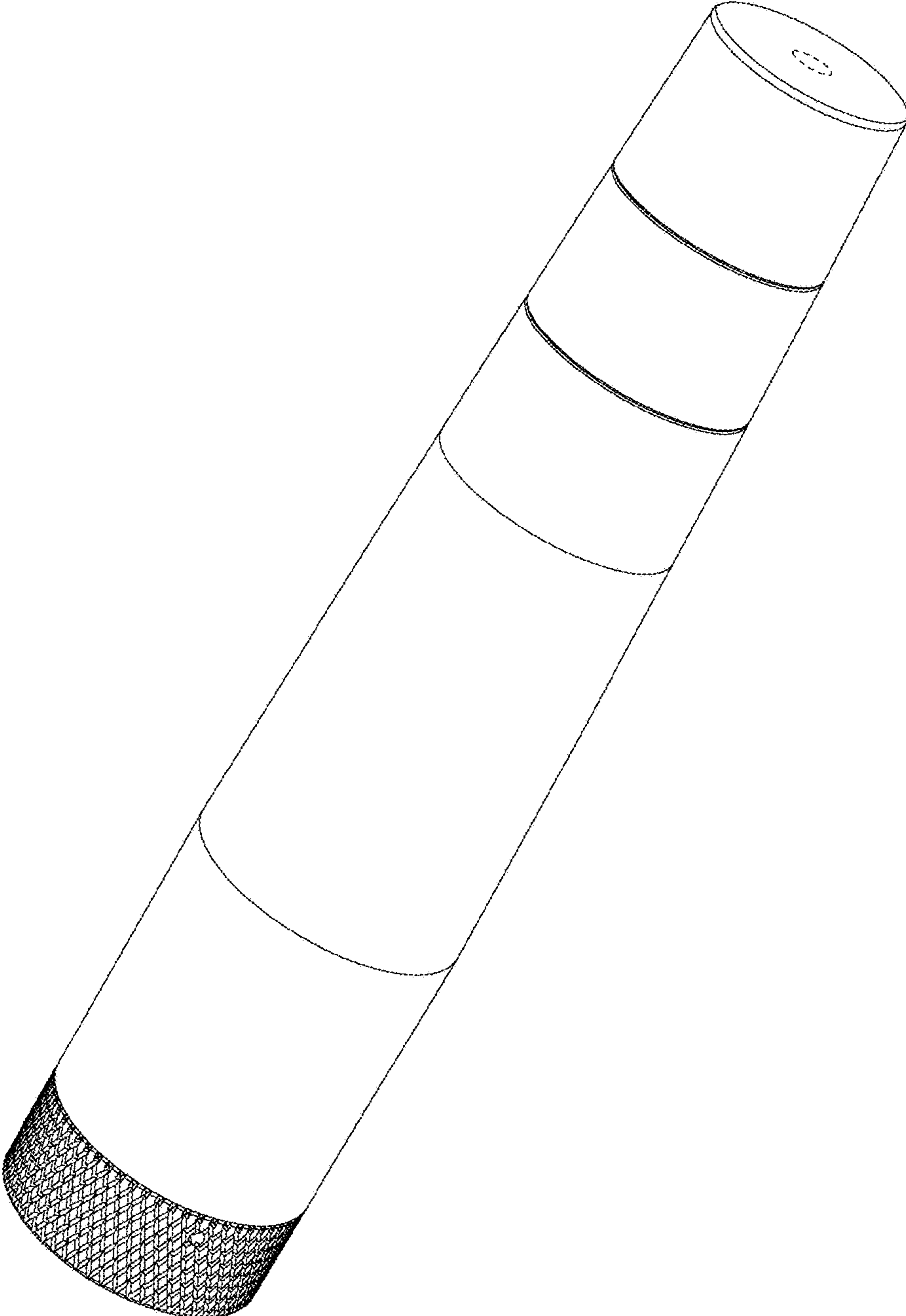
