**DESCRIPTION**

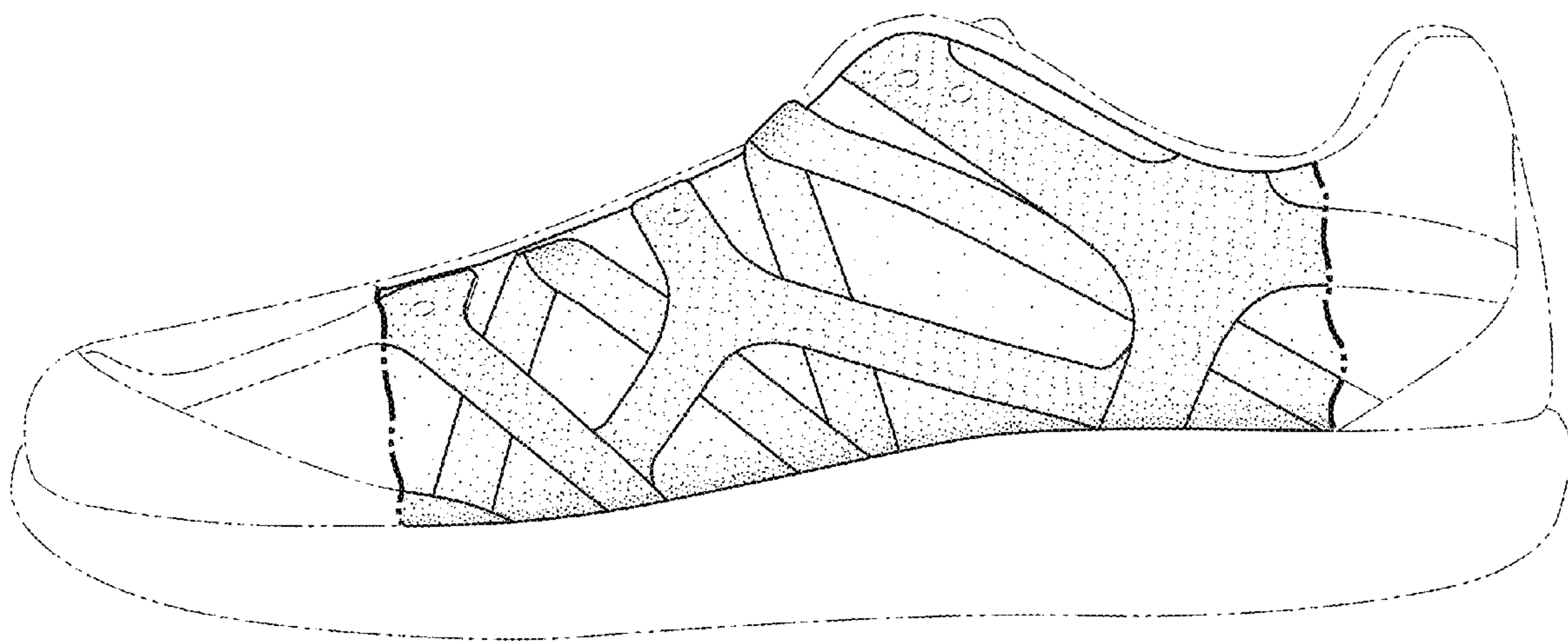
FIG. 1 is a front perspective view of footwear, showing my new design;

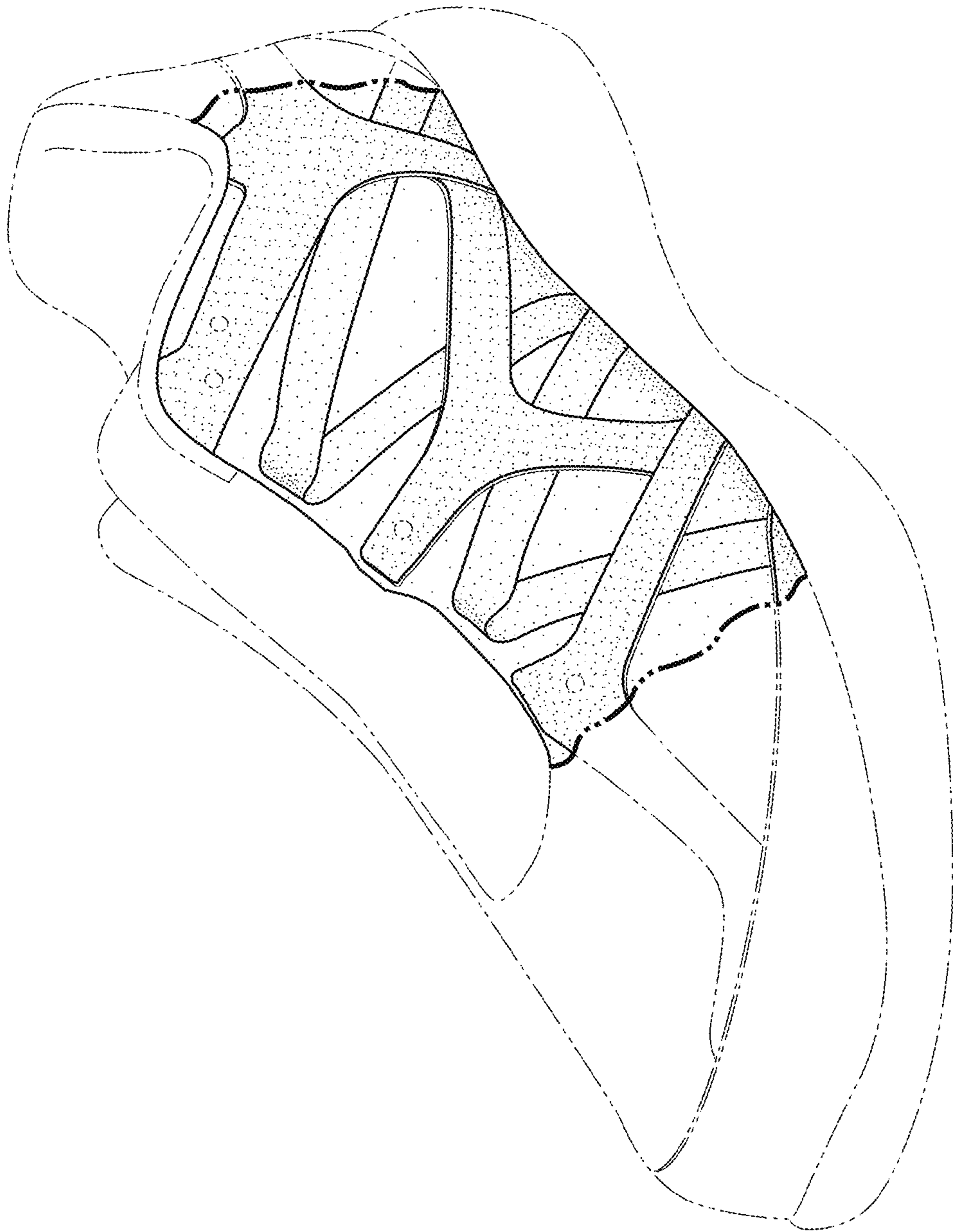
FIG. 2 is a right side view thereof; and,

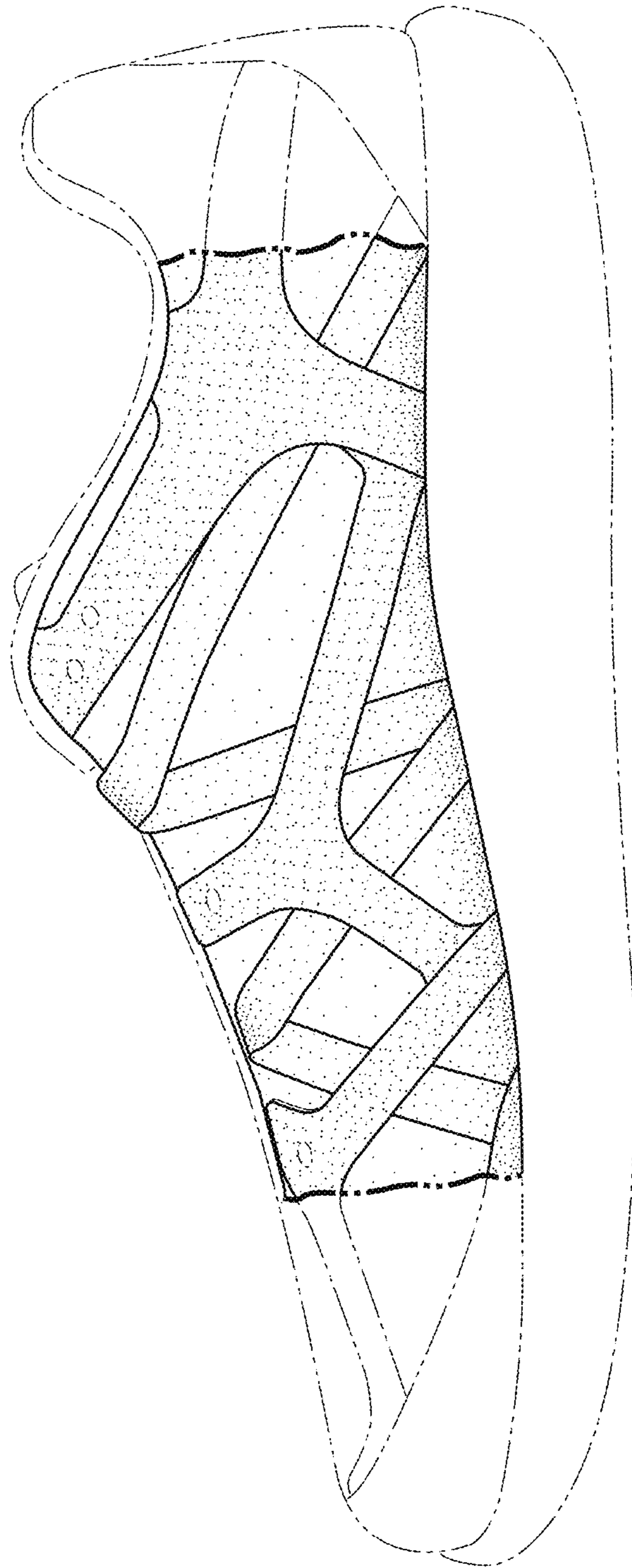

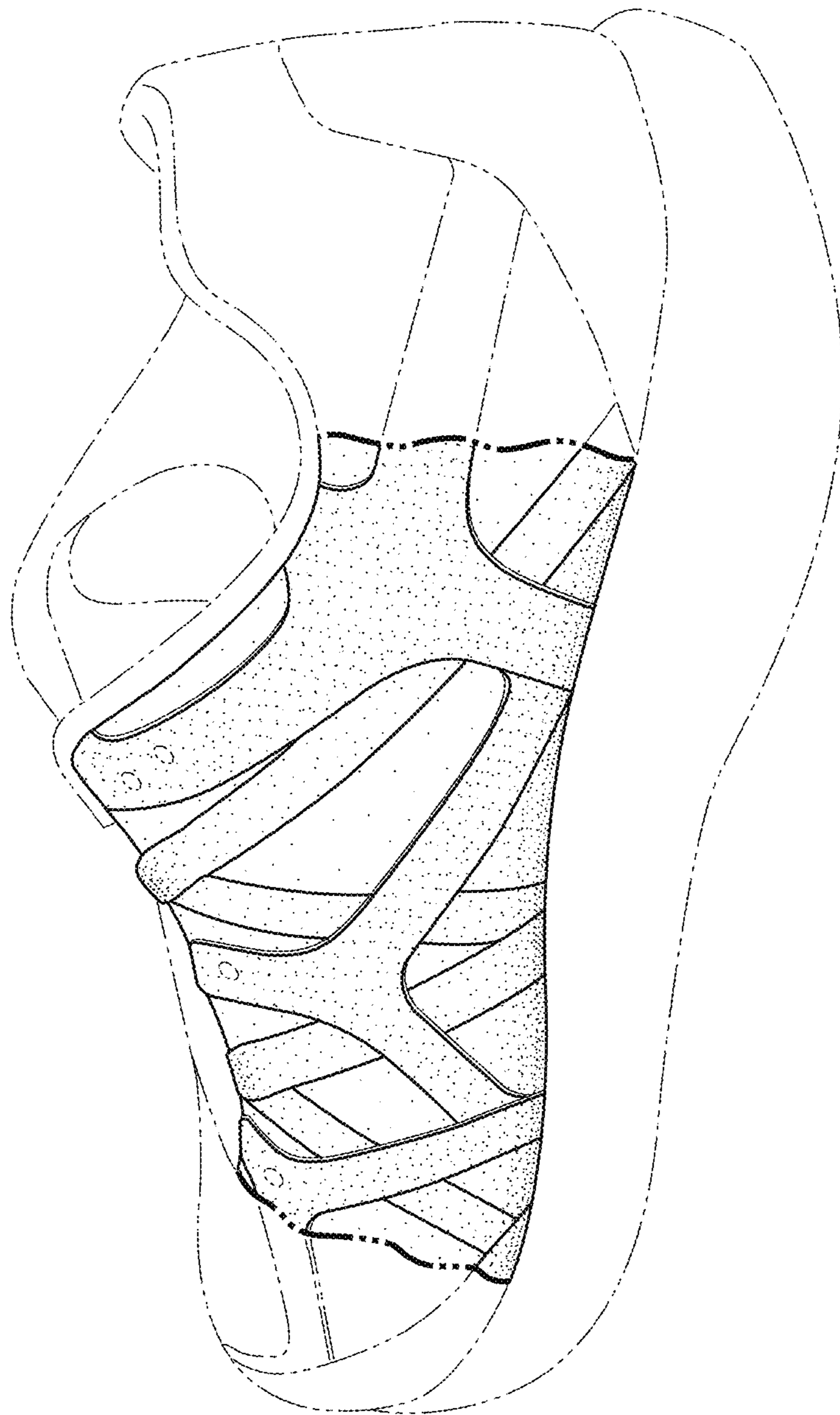
