**DESCRIPTION**

FIG. 15 is a side view thereof;

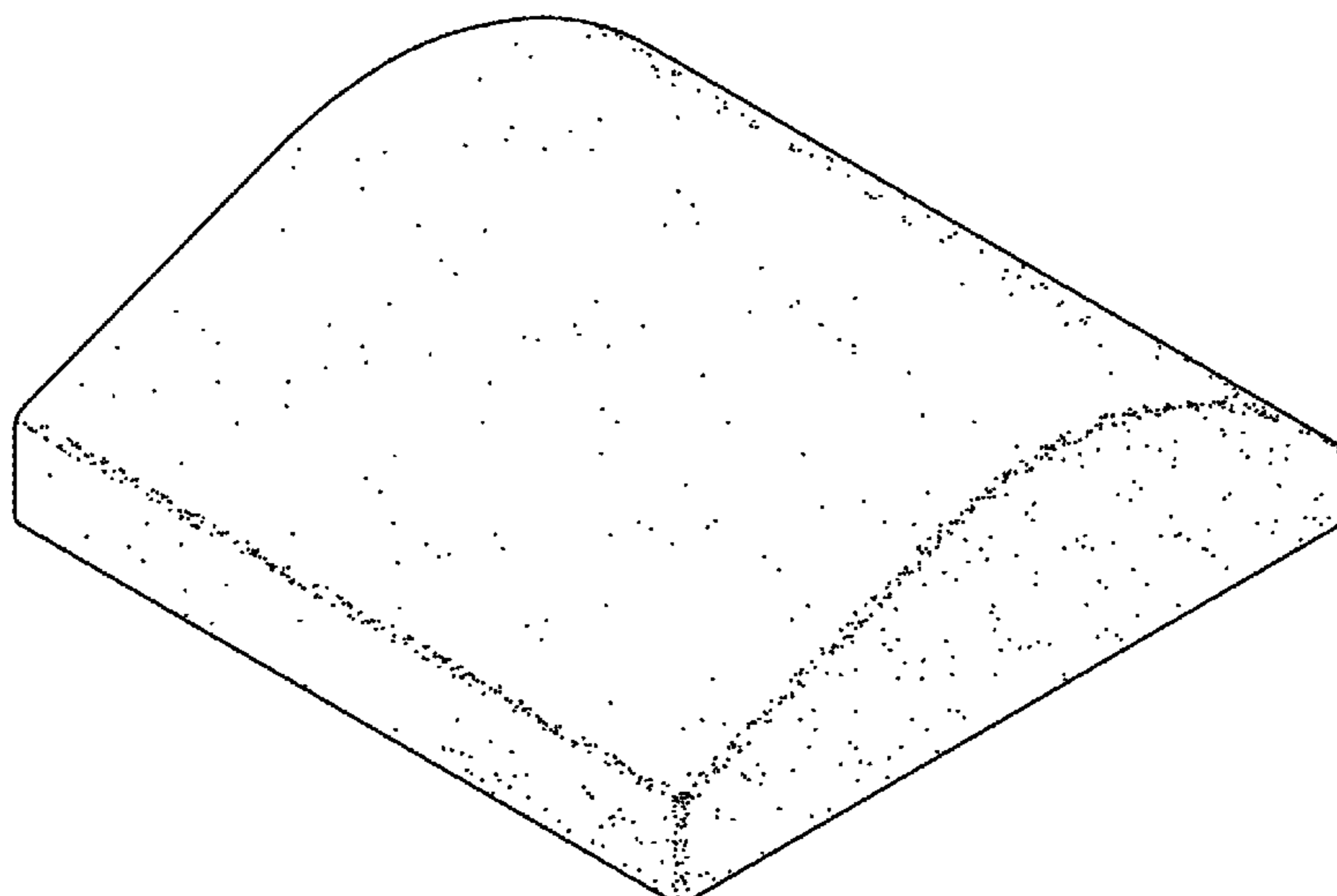
FIG. 16 is a back view thereof;

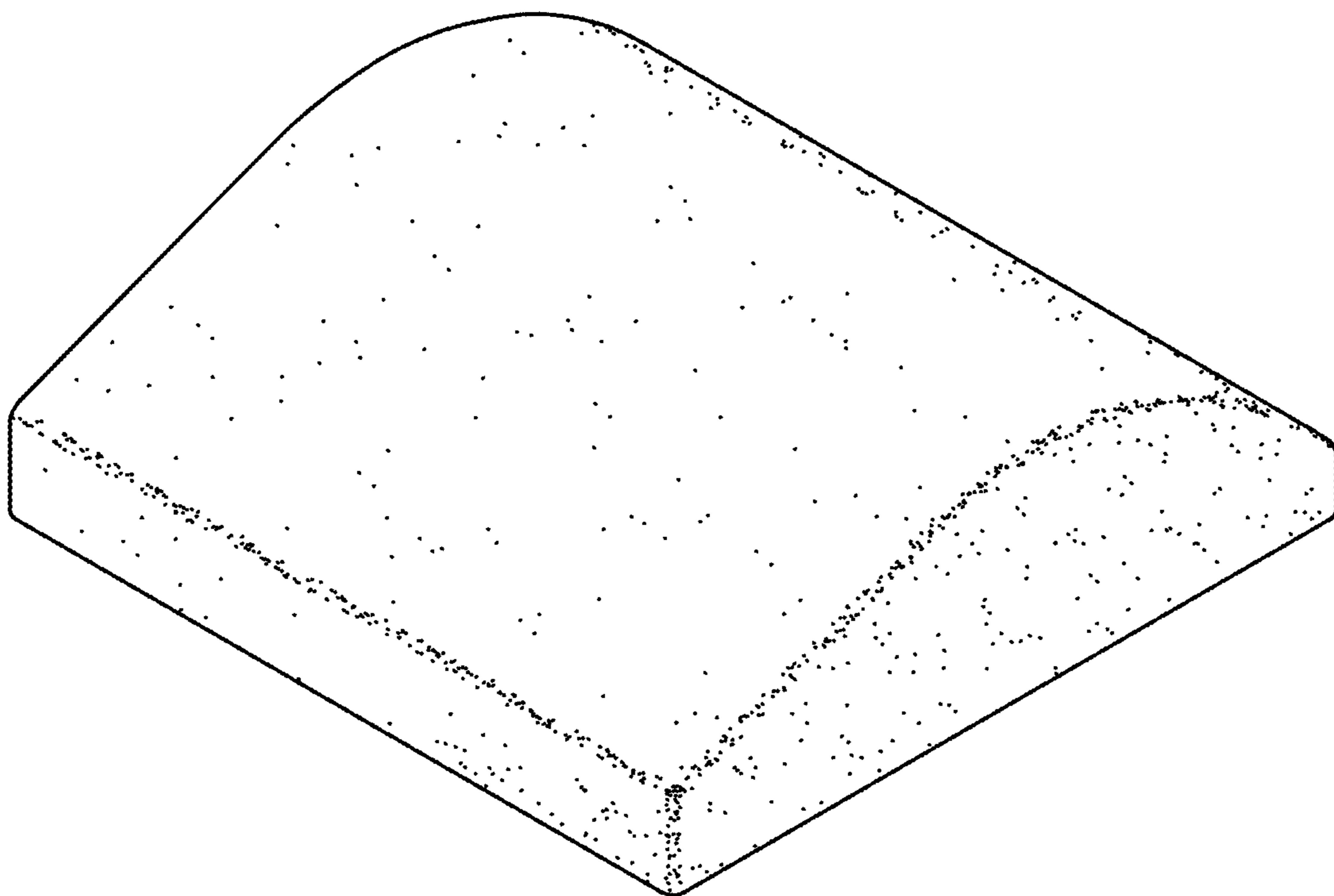

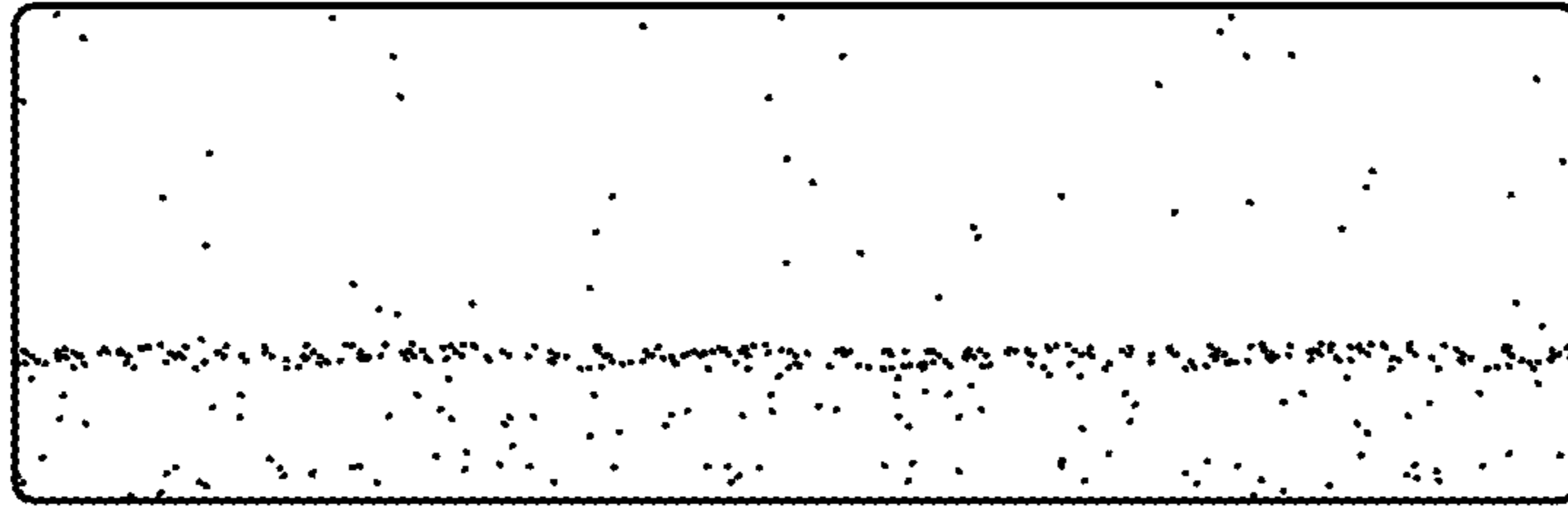

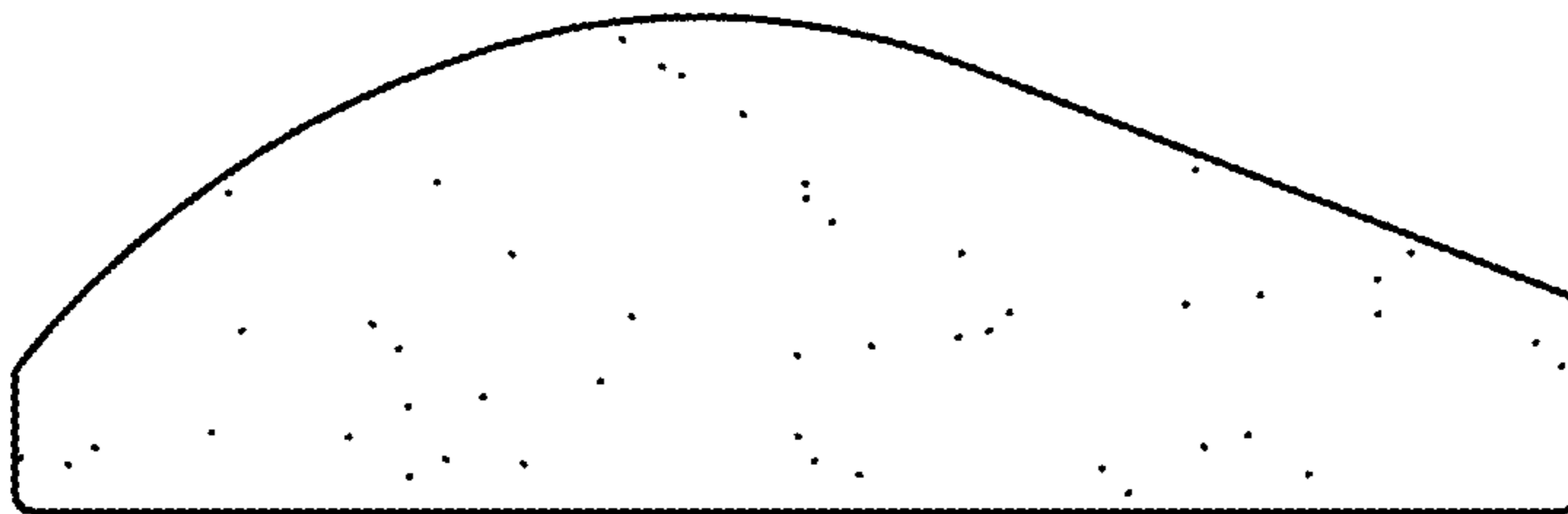

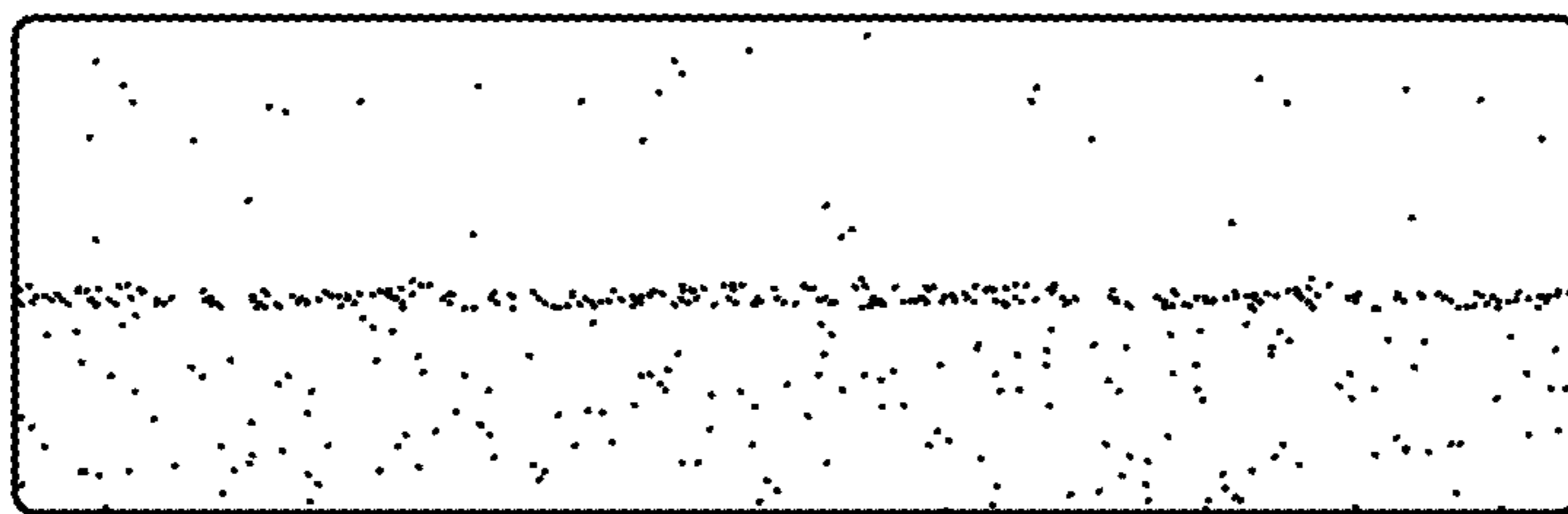

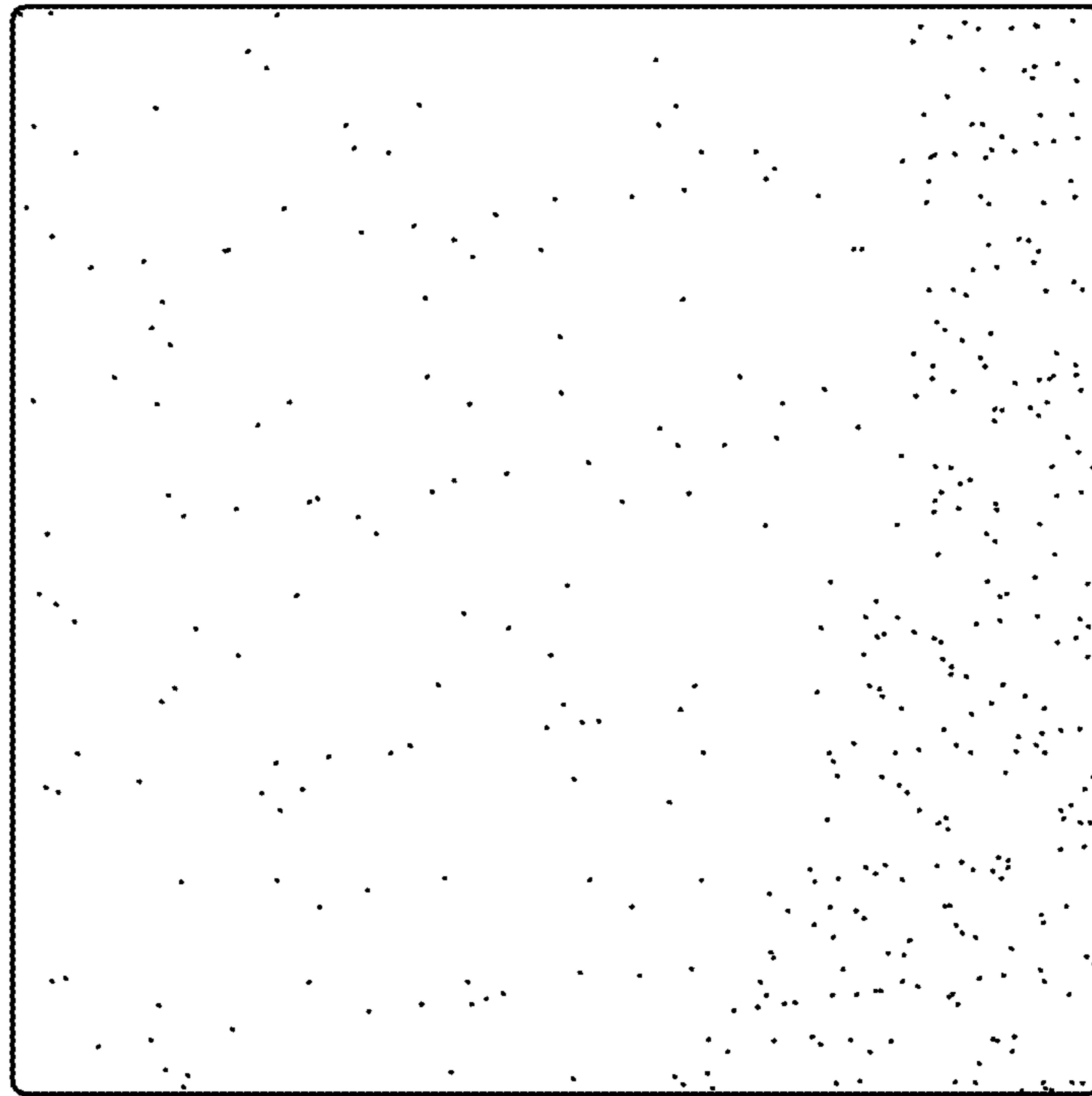

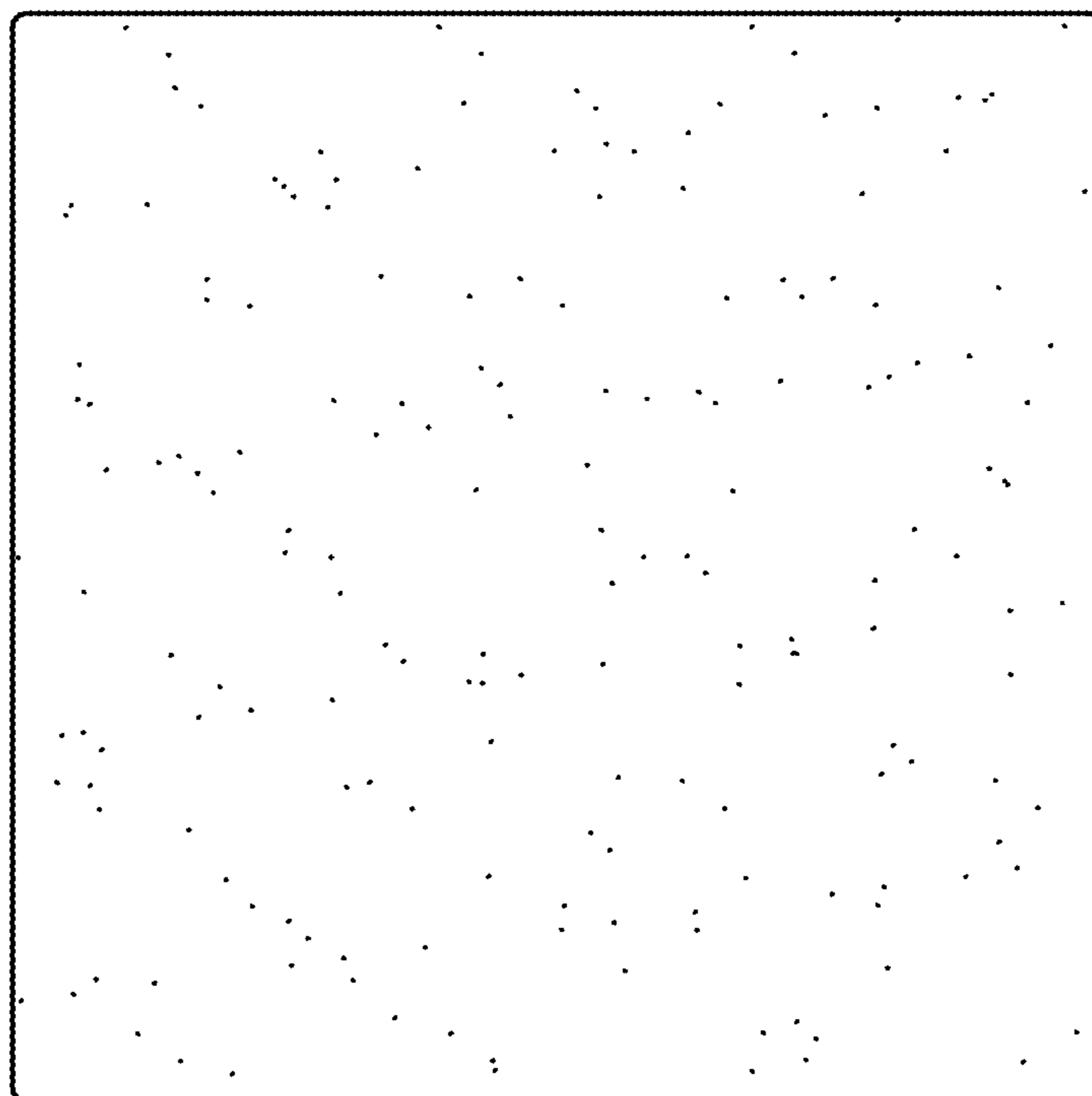

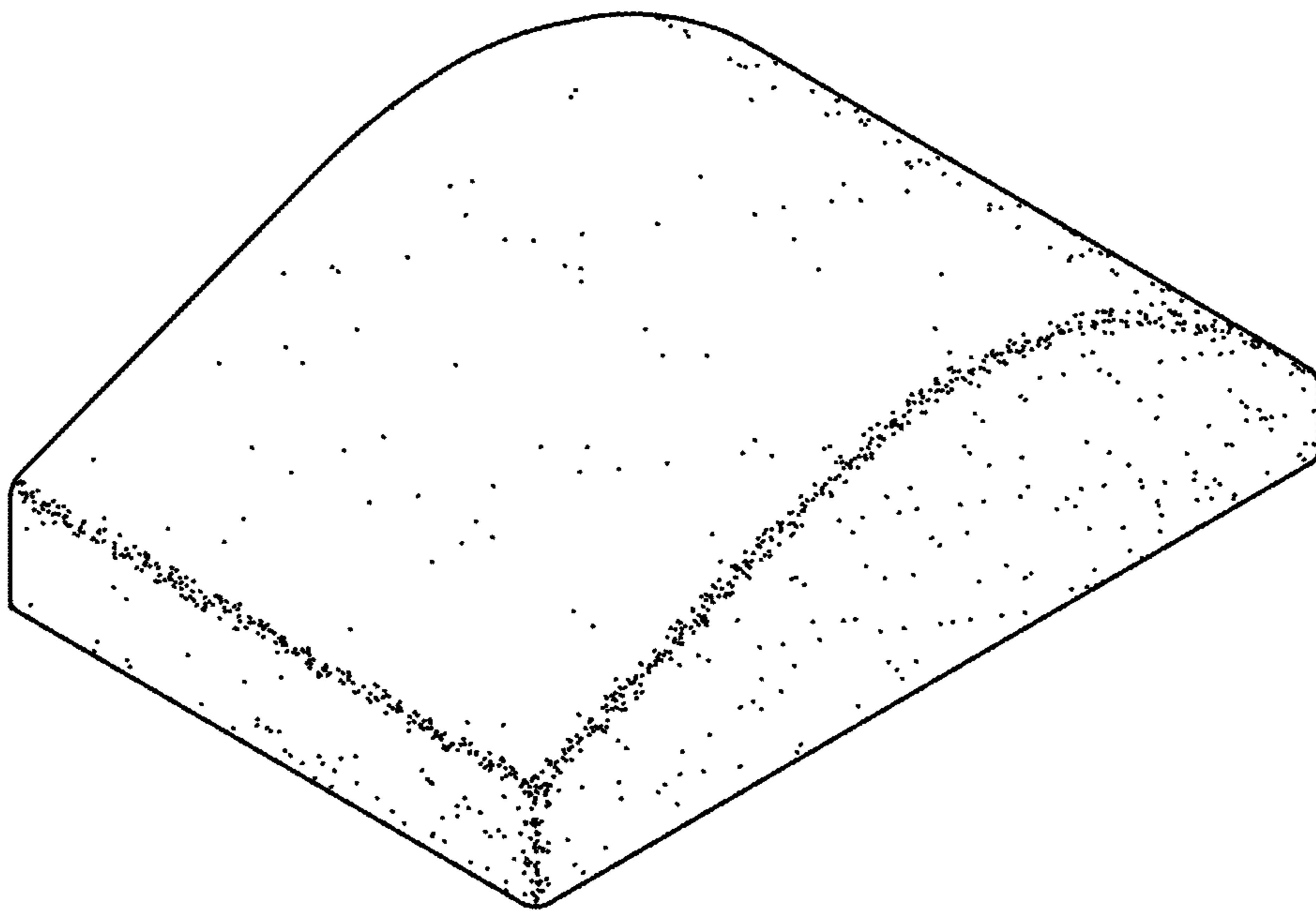

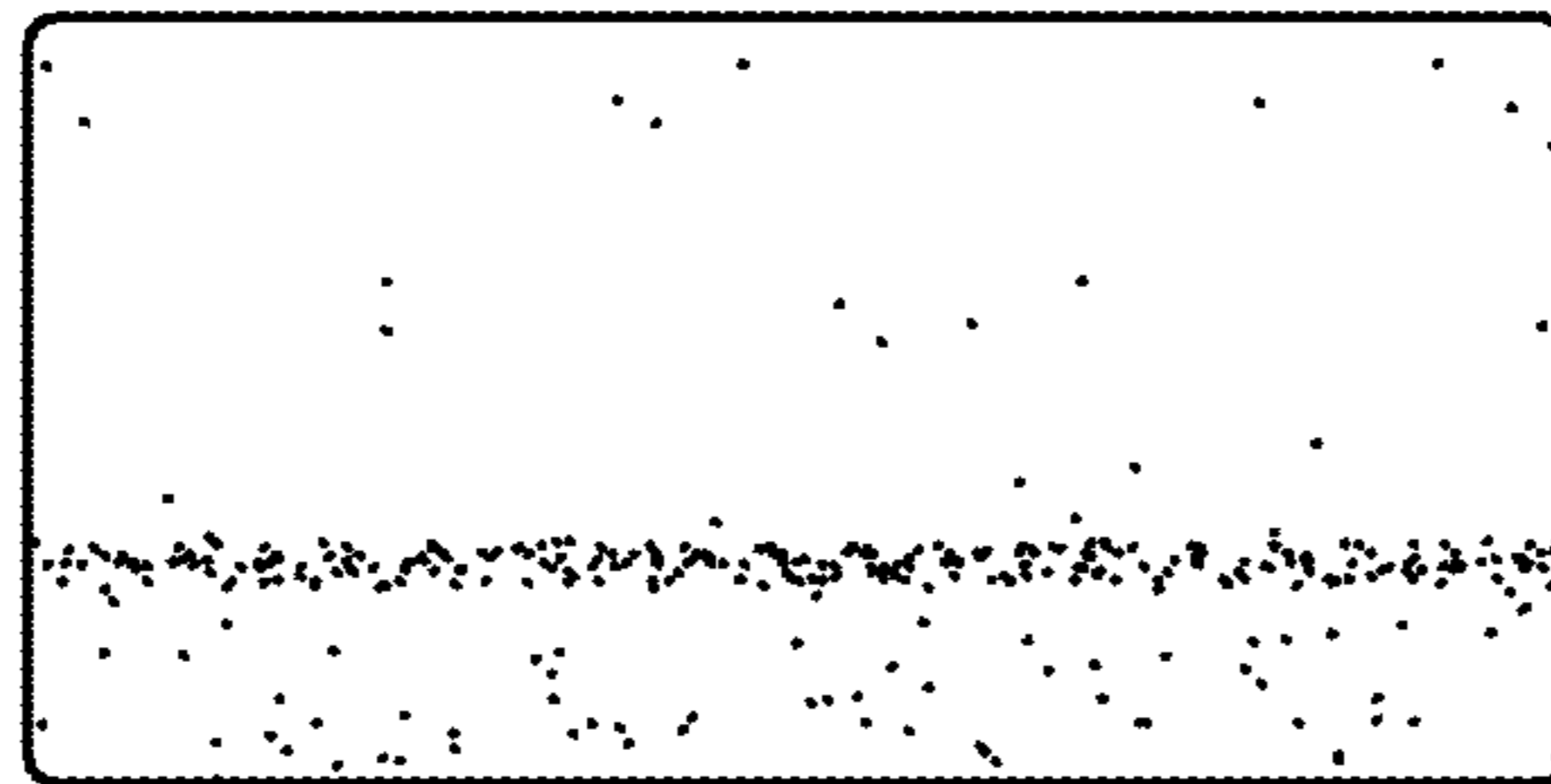

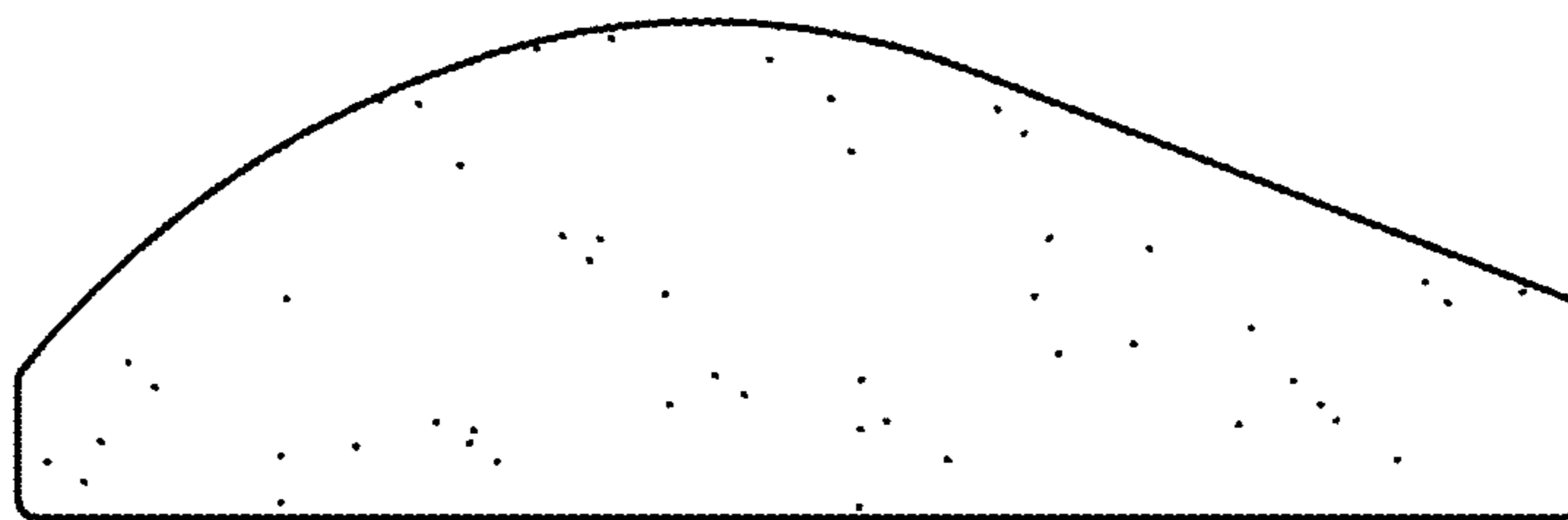

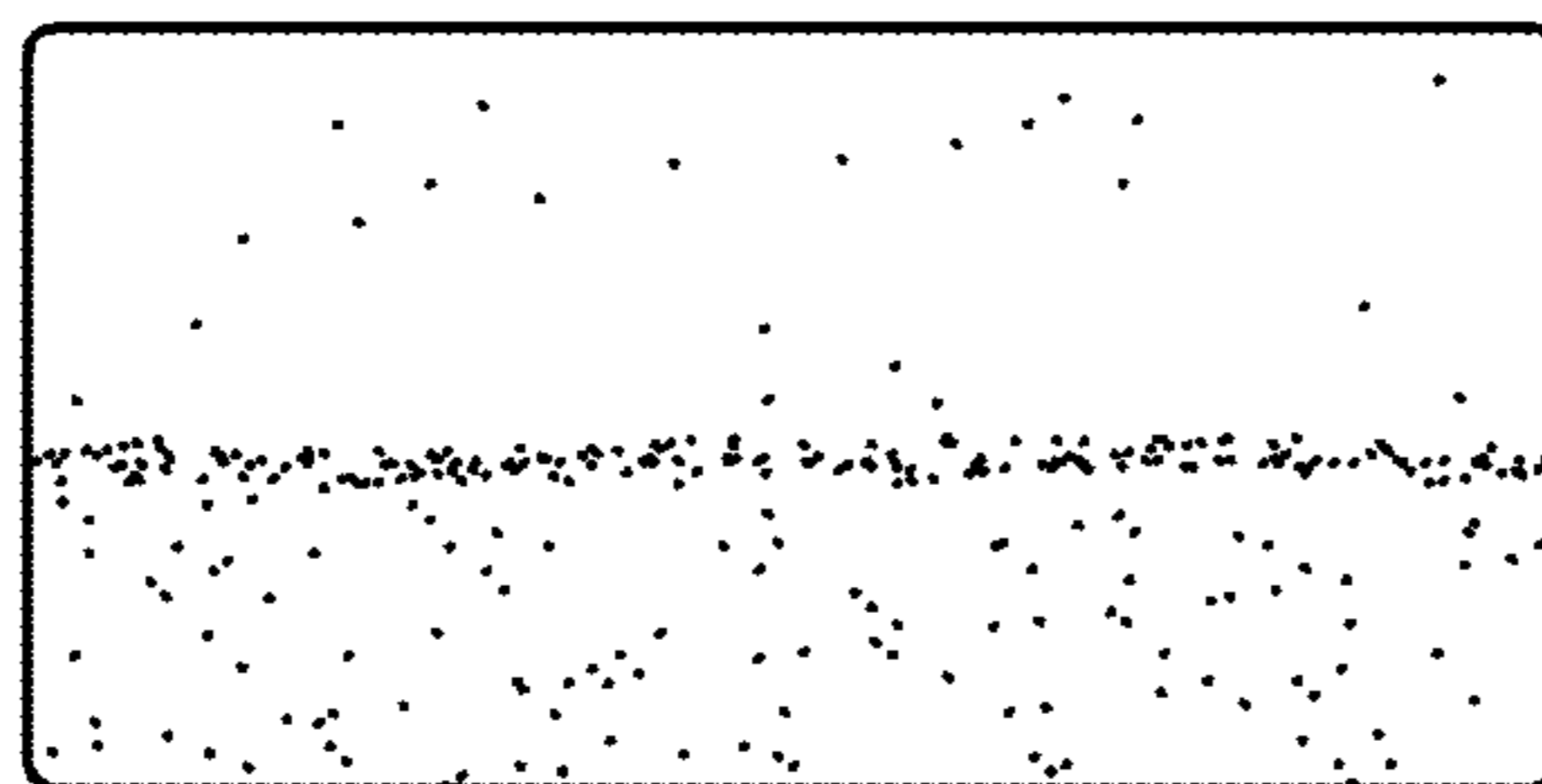

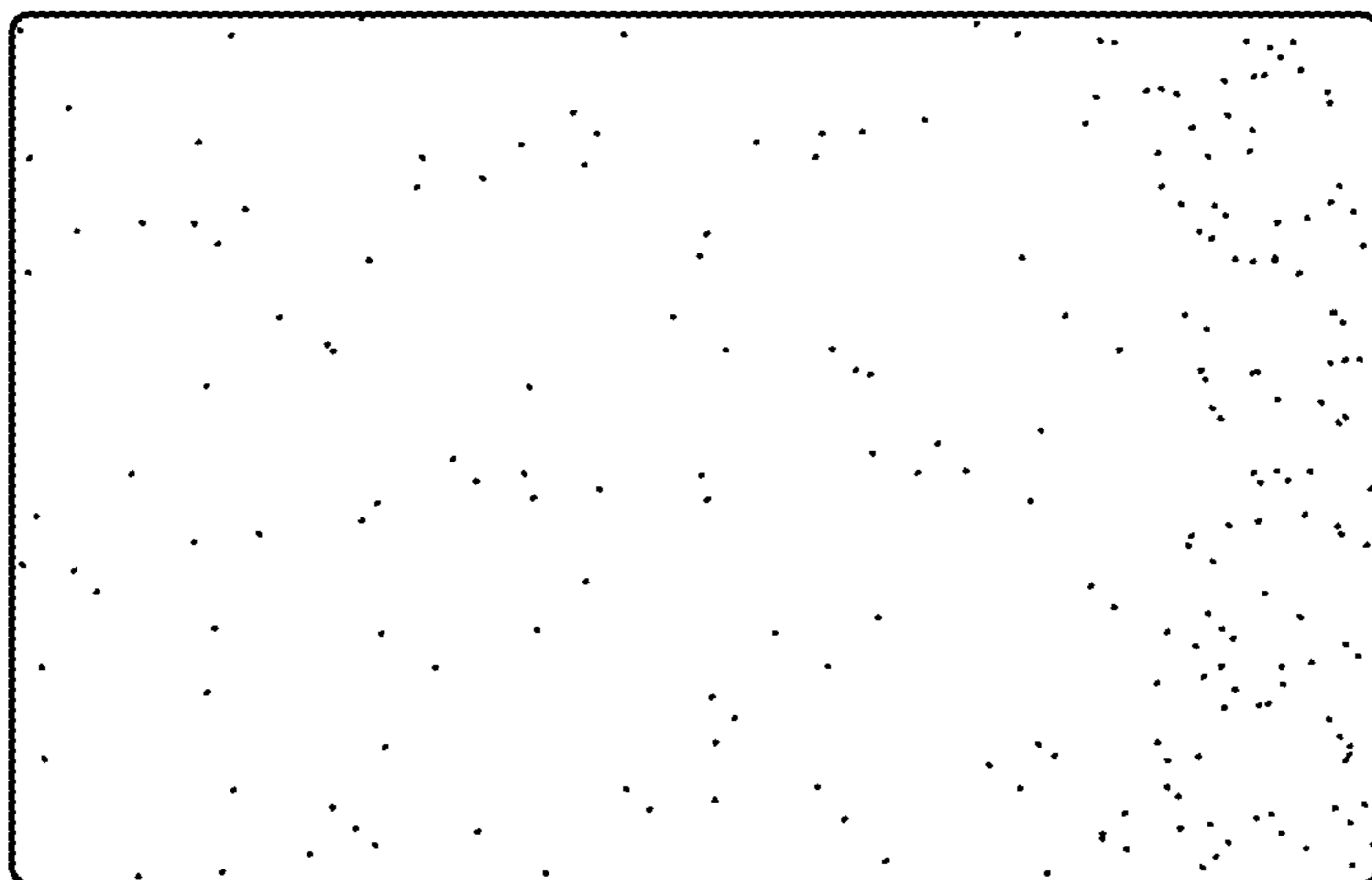

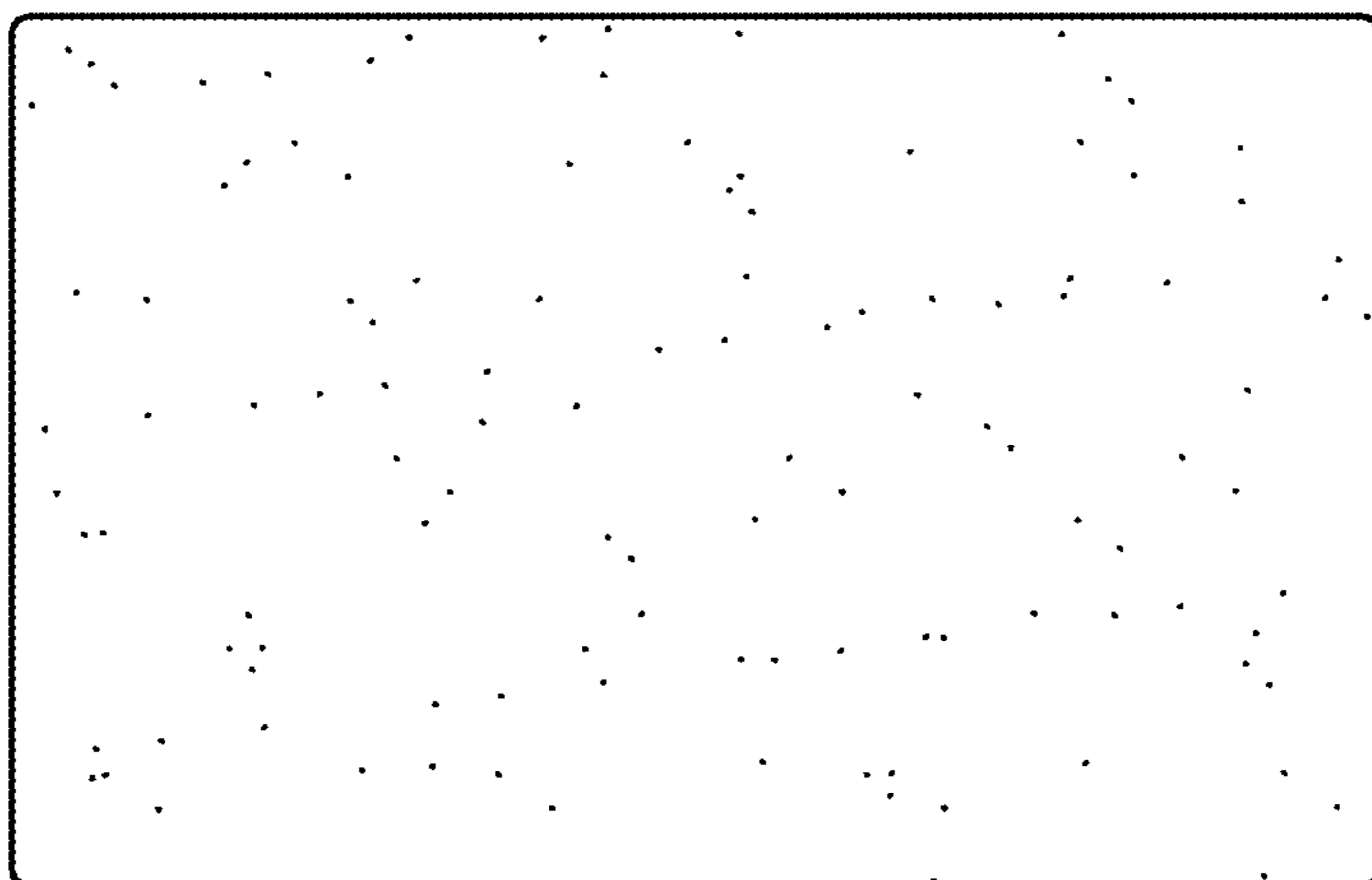

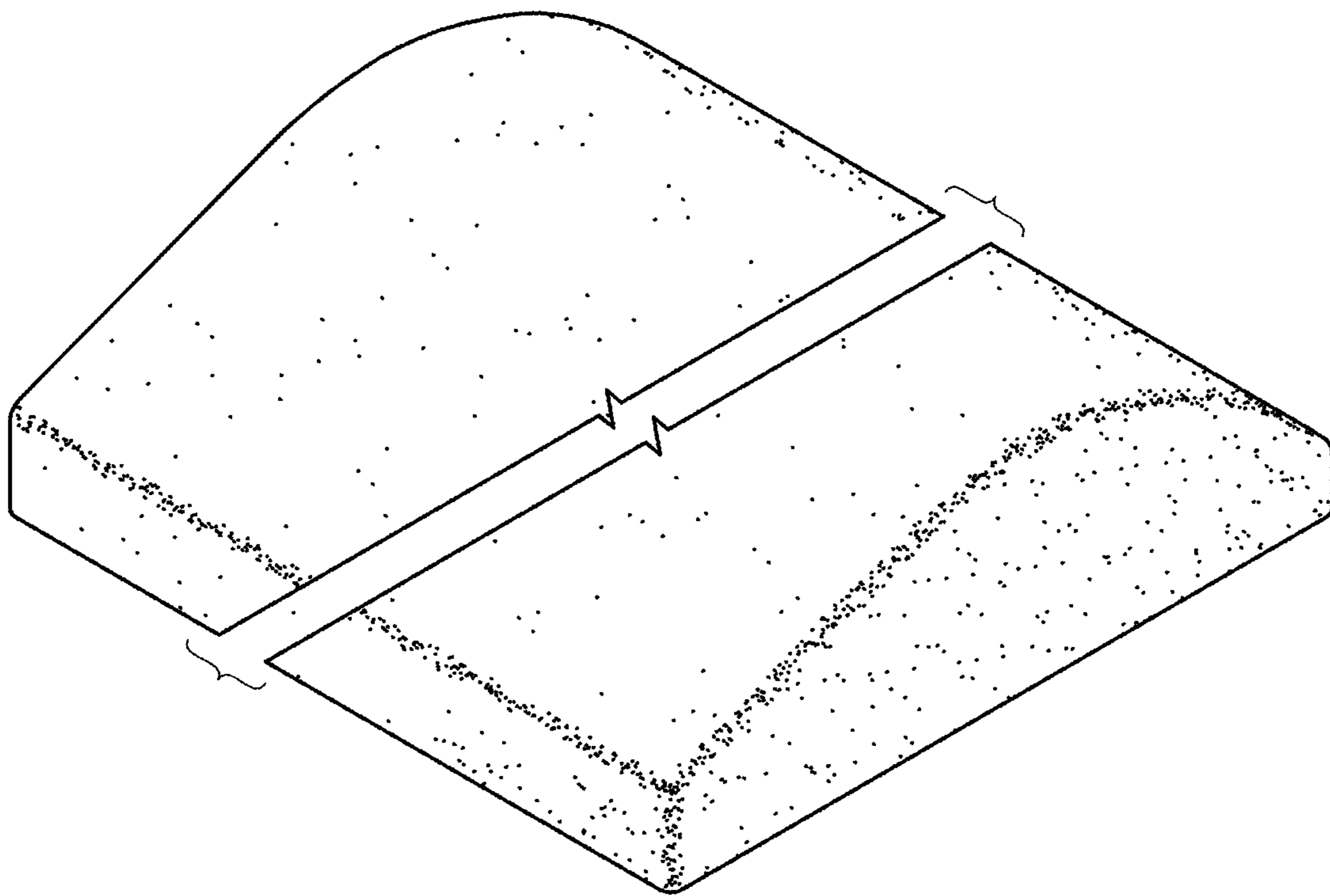

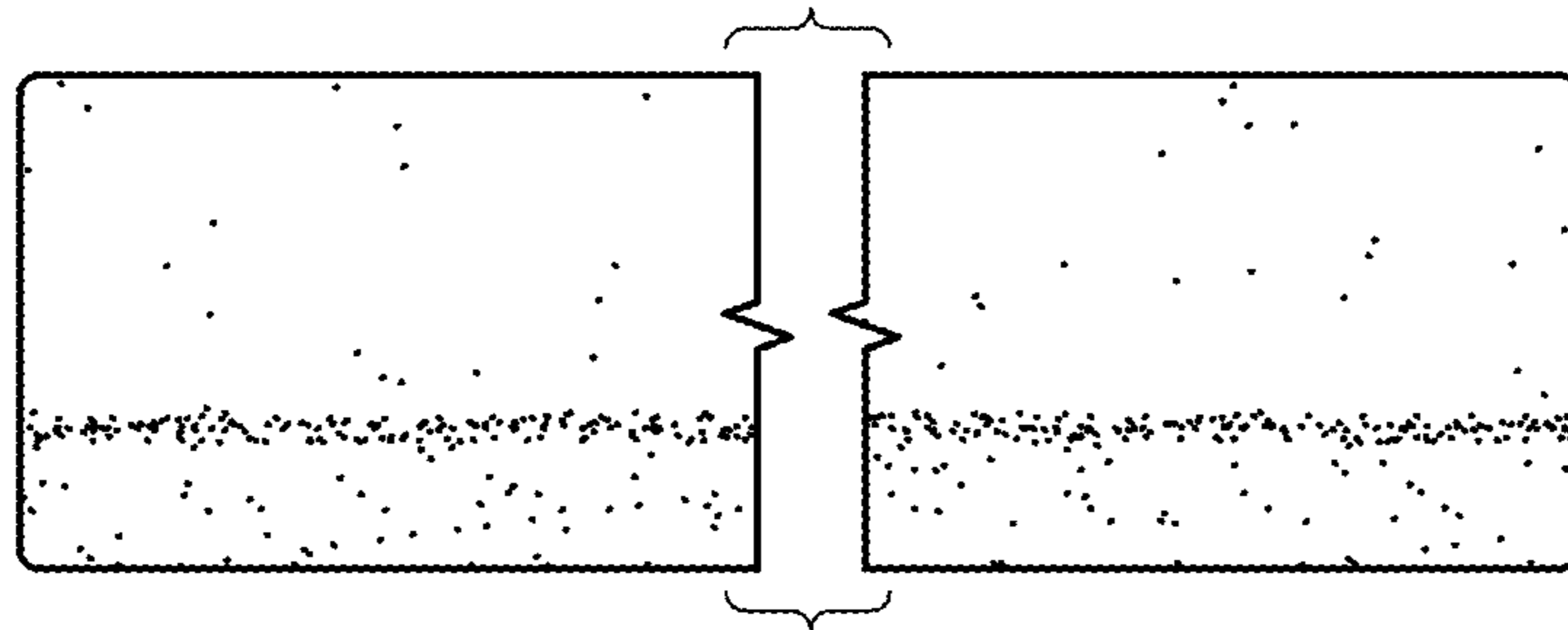

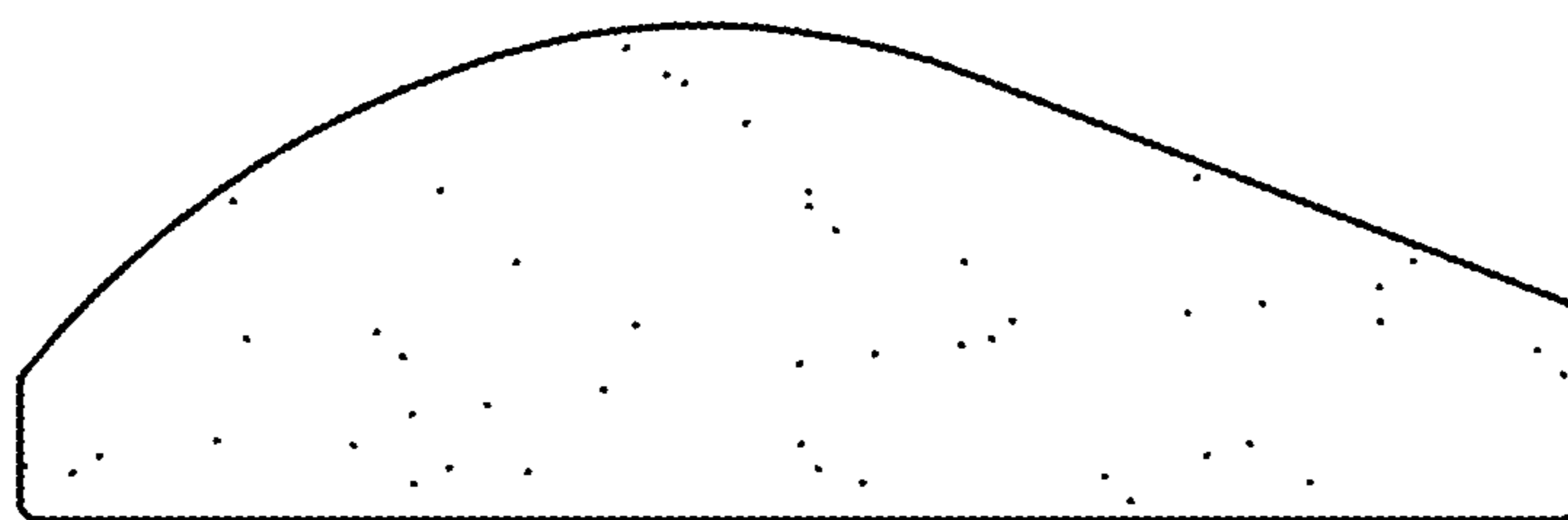




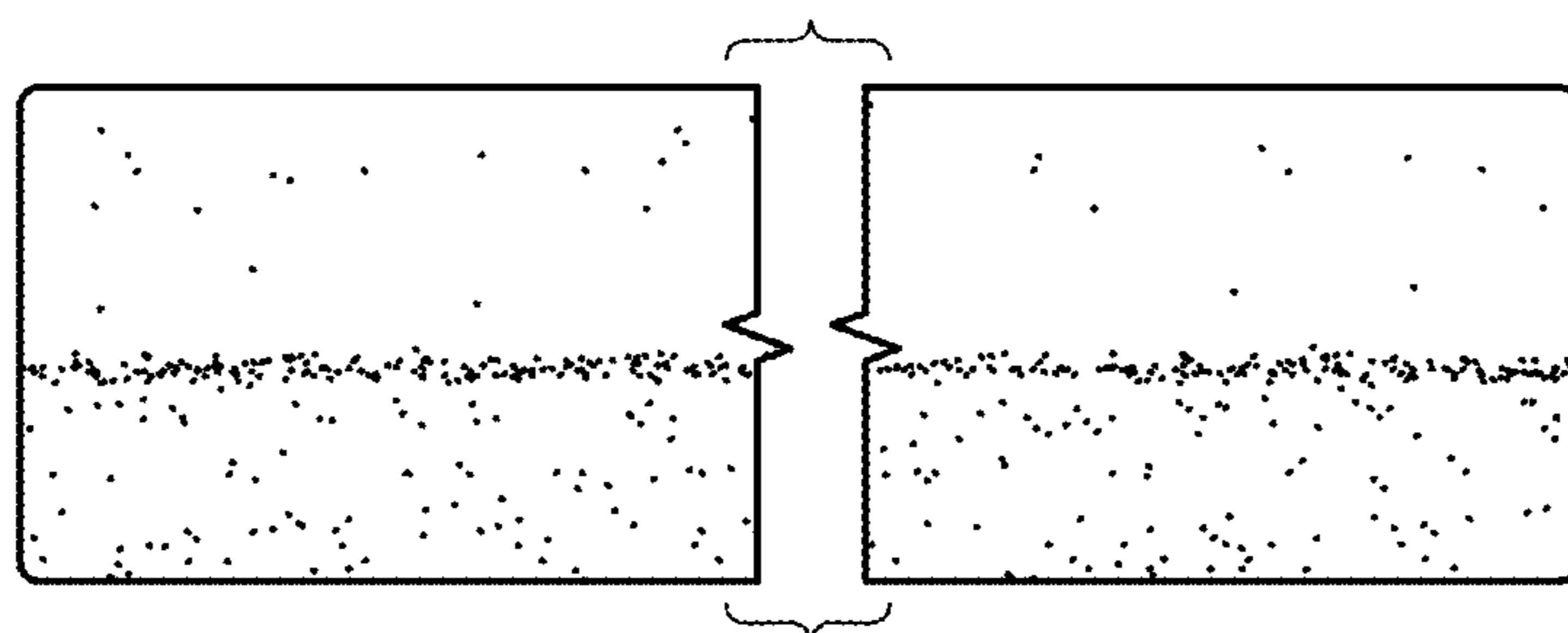

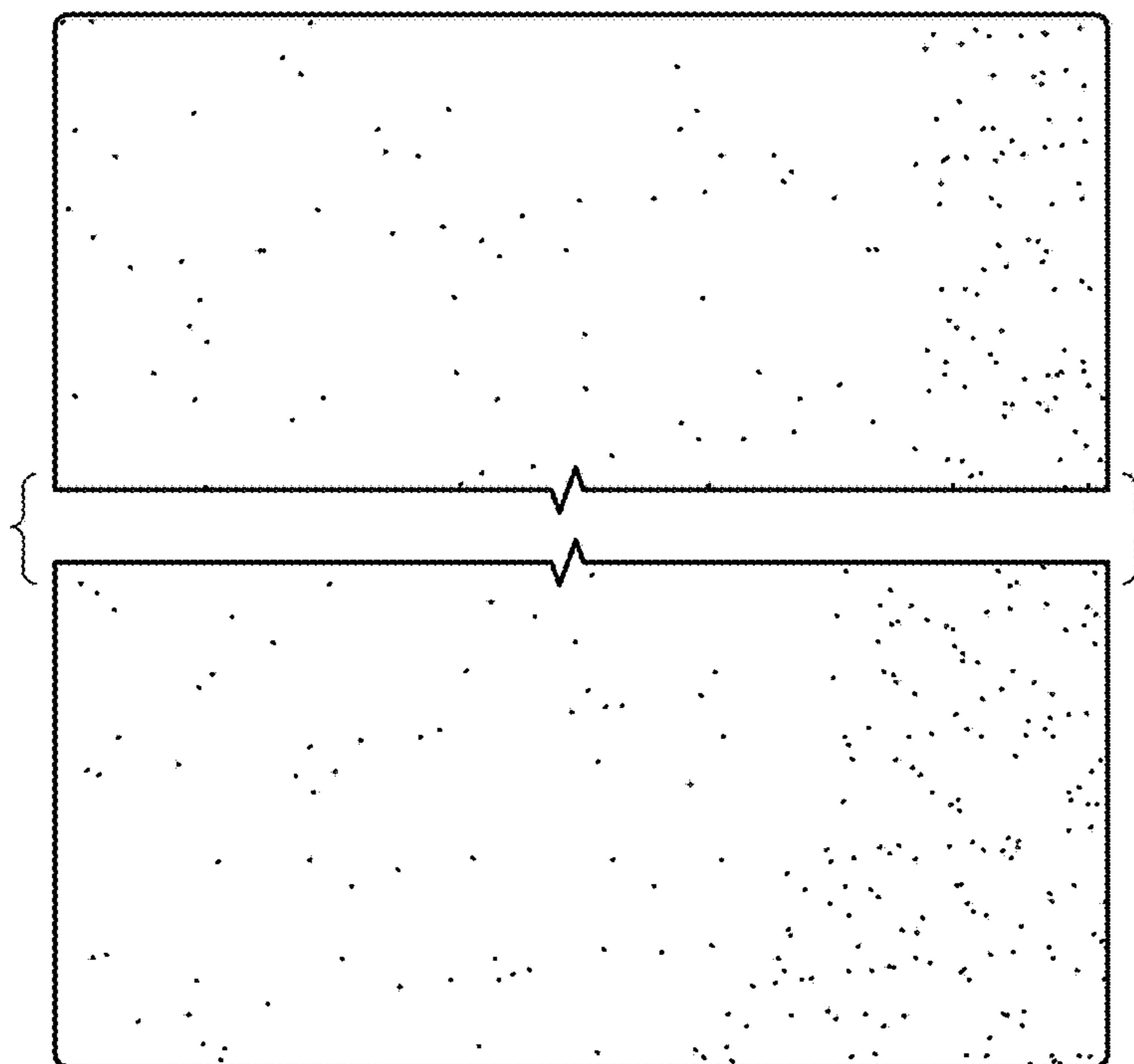

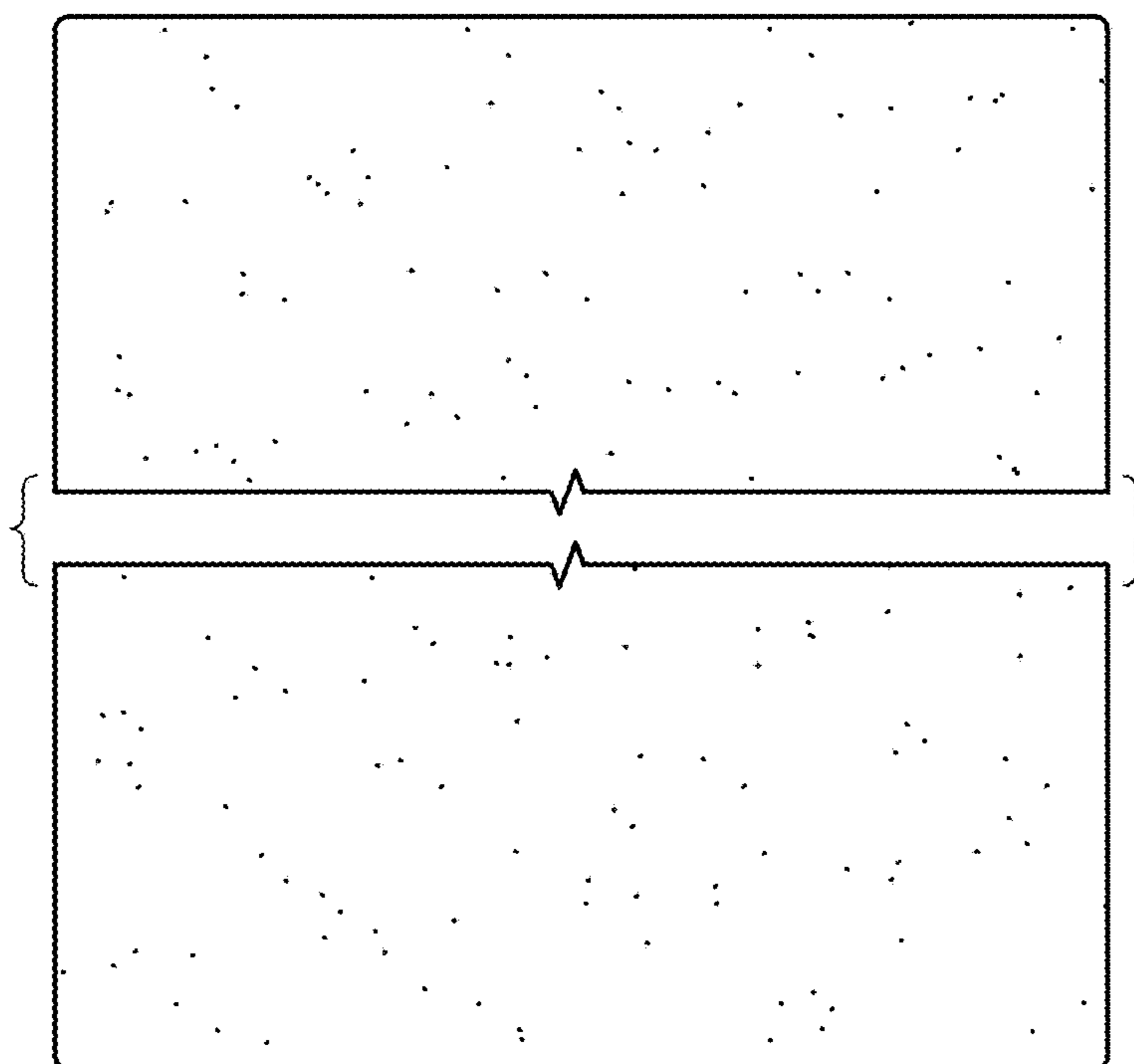
