FIG. 2 is a left side view of the furry pillow of FIG. 1, the right side view being a mirror image thereof.

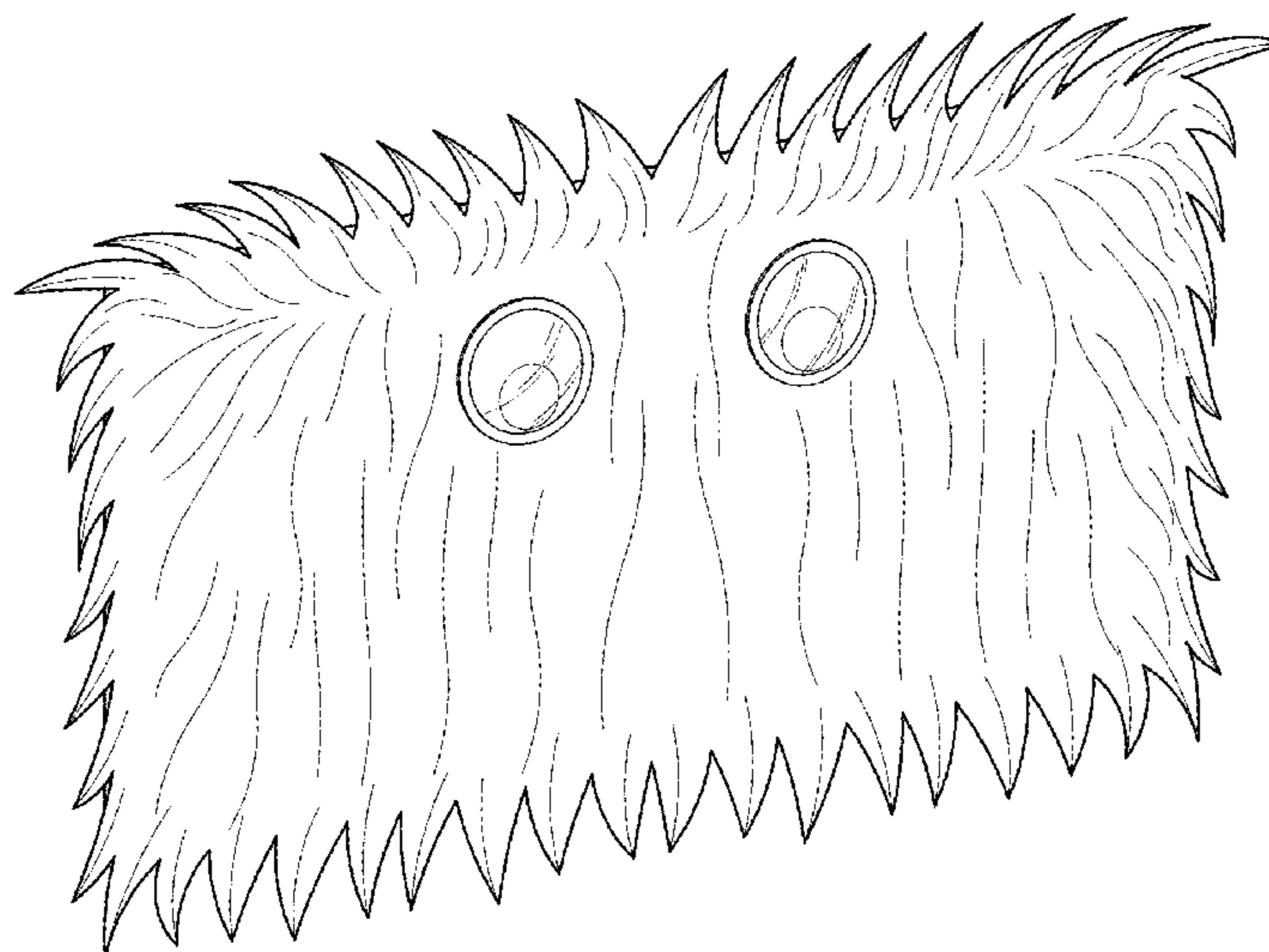
FIG. 3 is a front view of the furry pillow of FIG. 1.

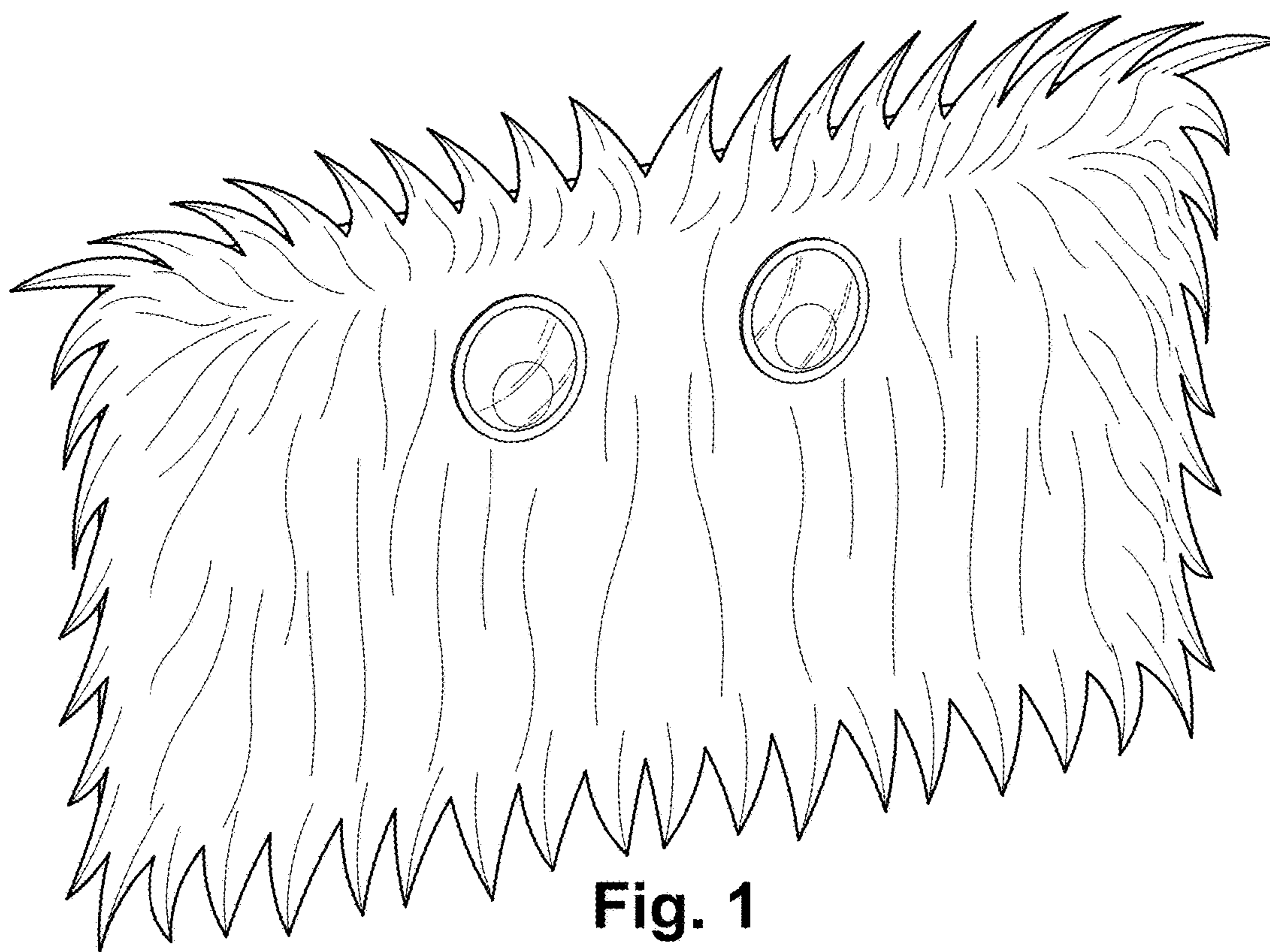

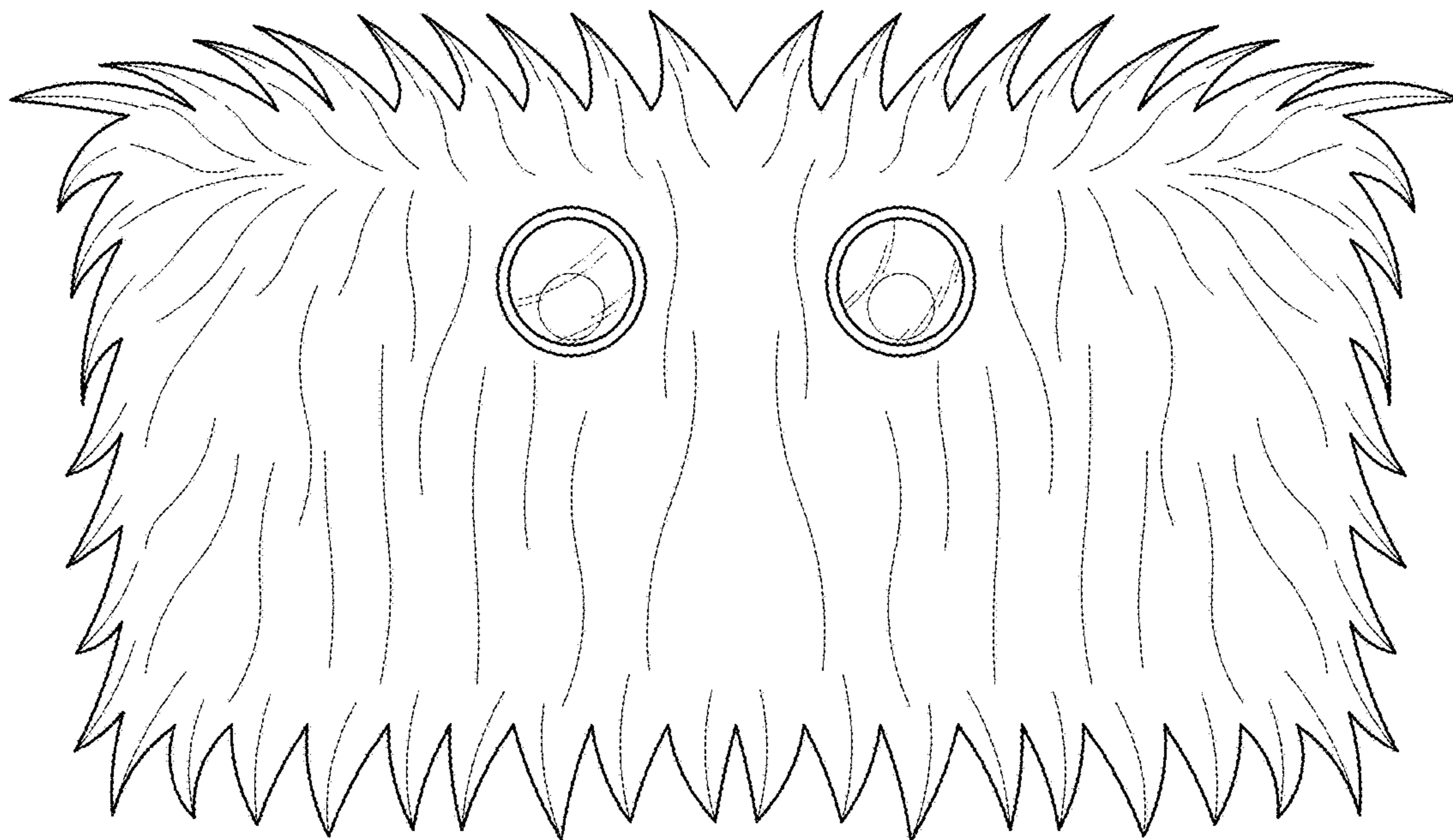

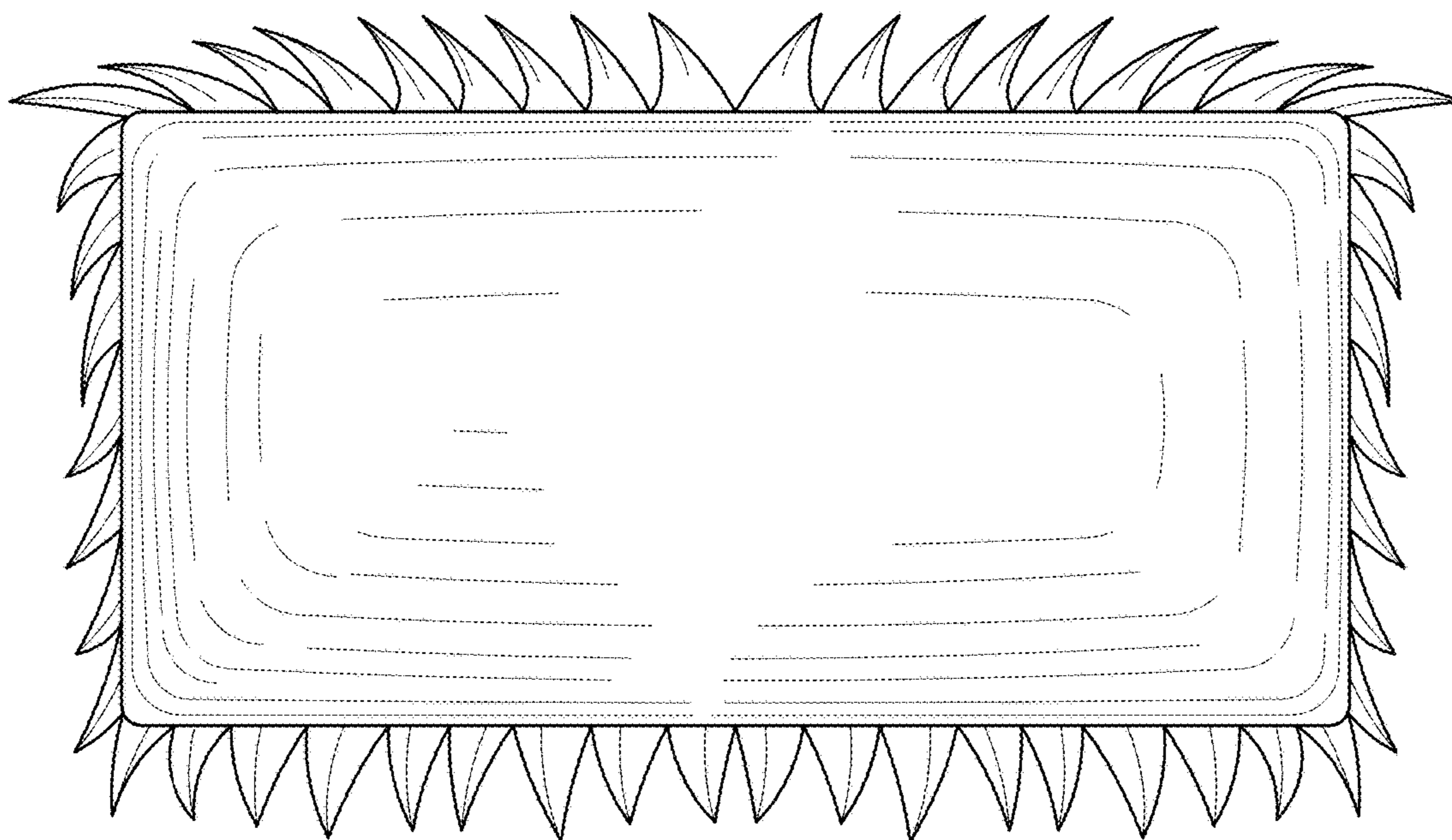

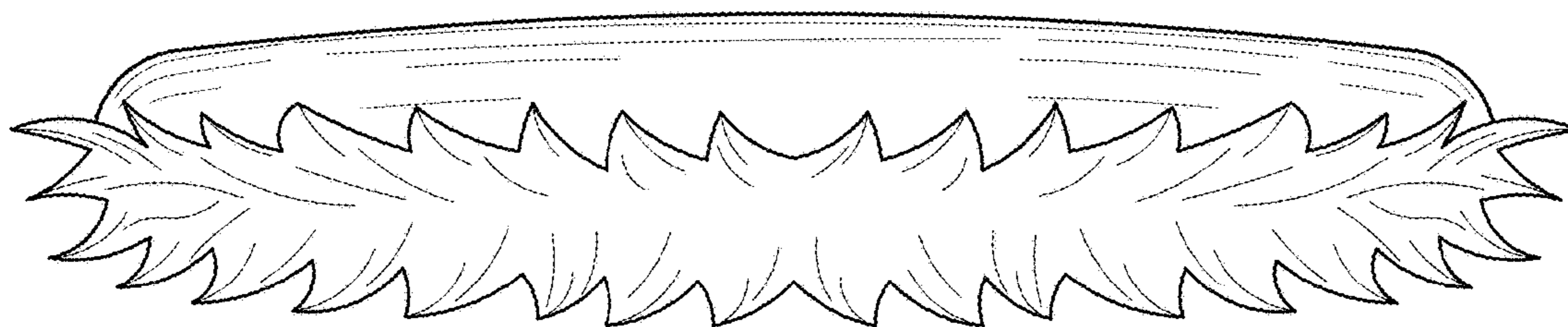

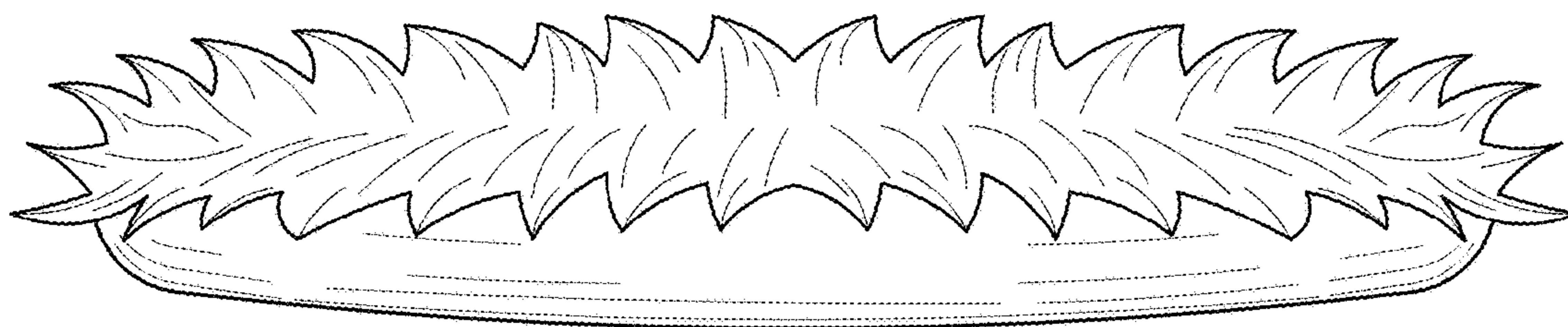
