We claim the ornamental design for a gas oven range, as shown and described.

**DESCRIPTION**

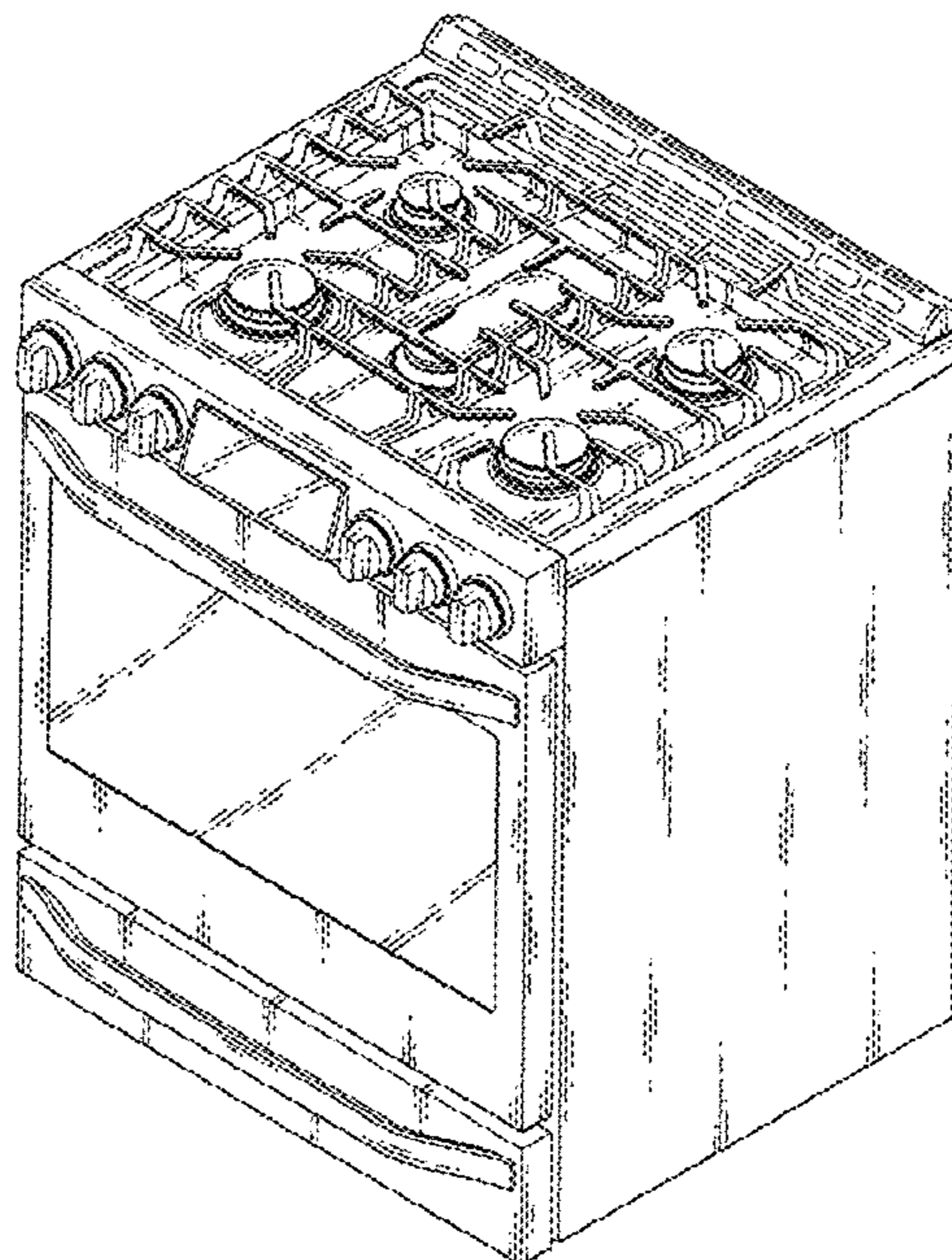

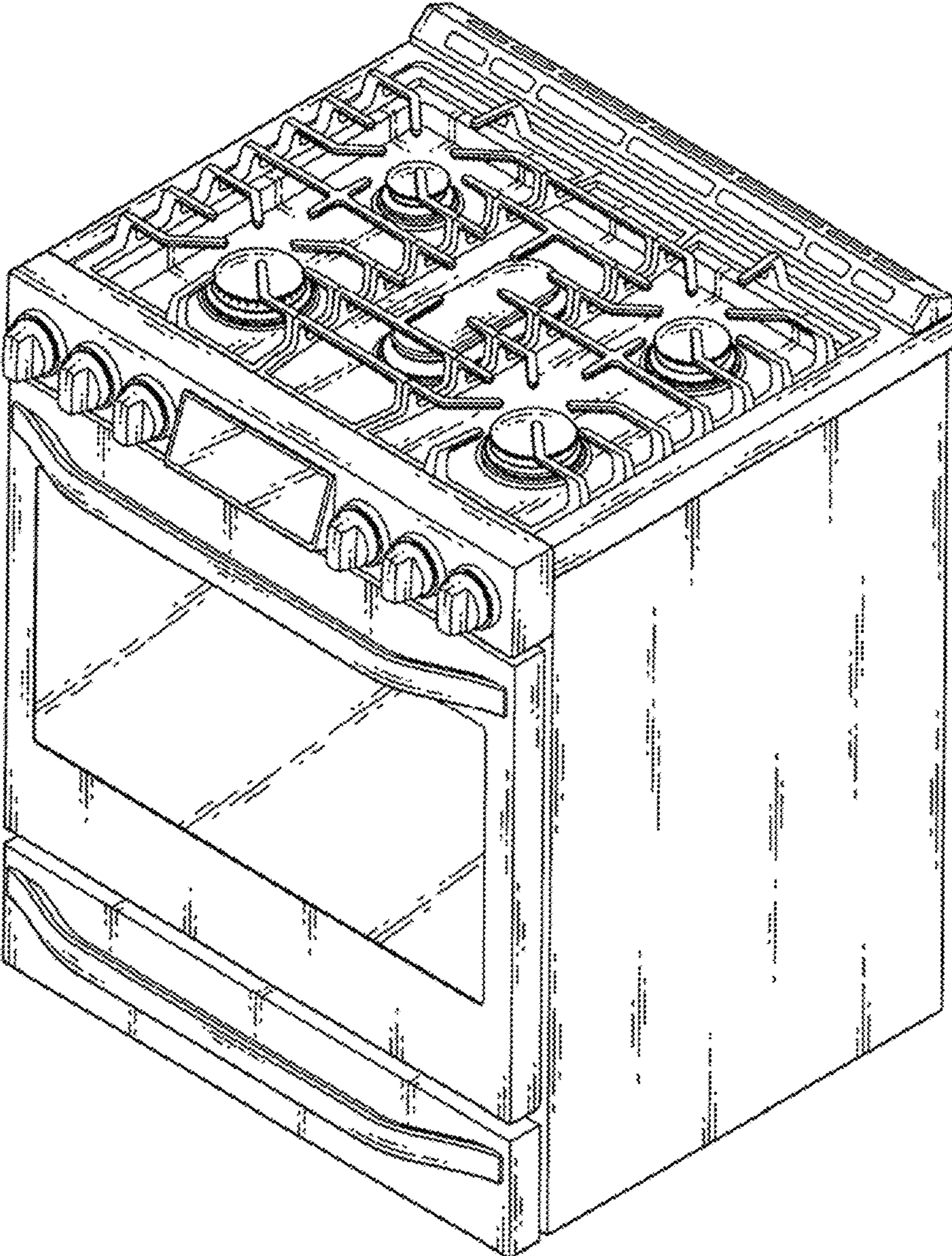

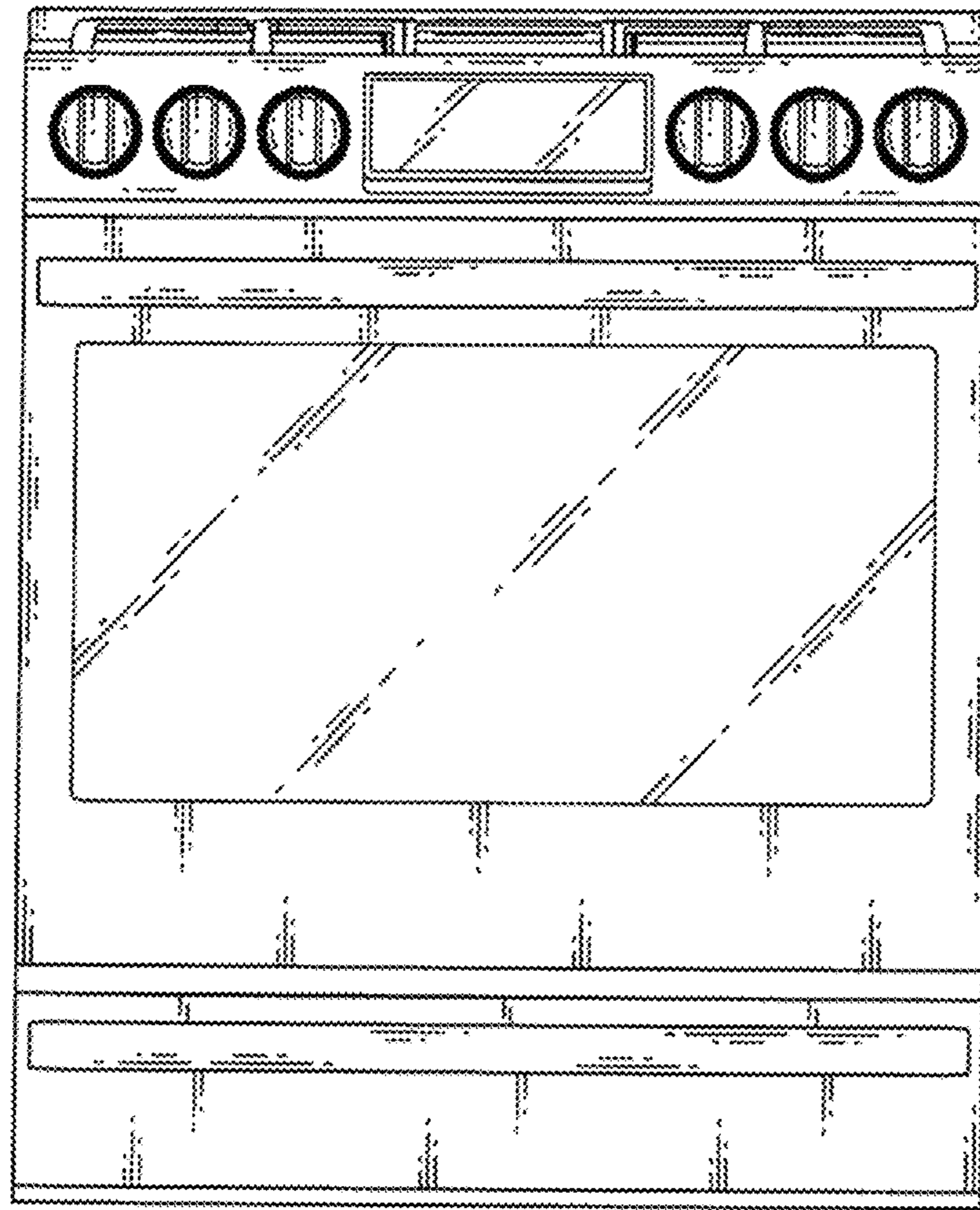

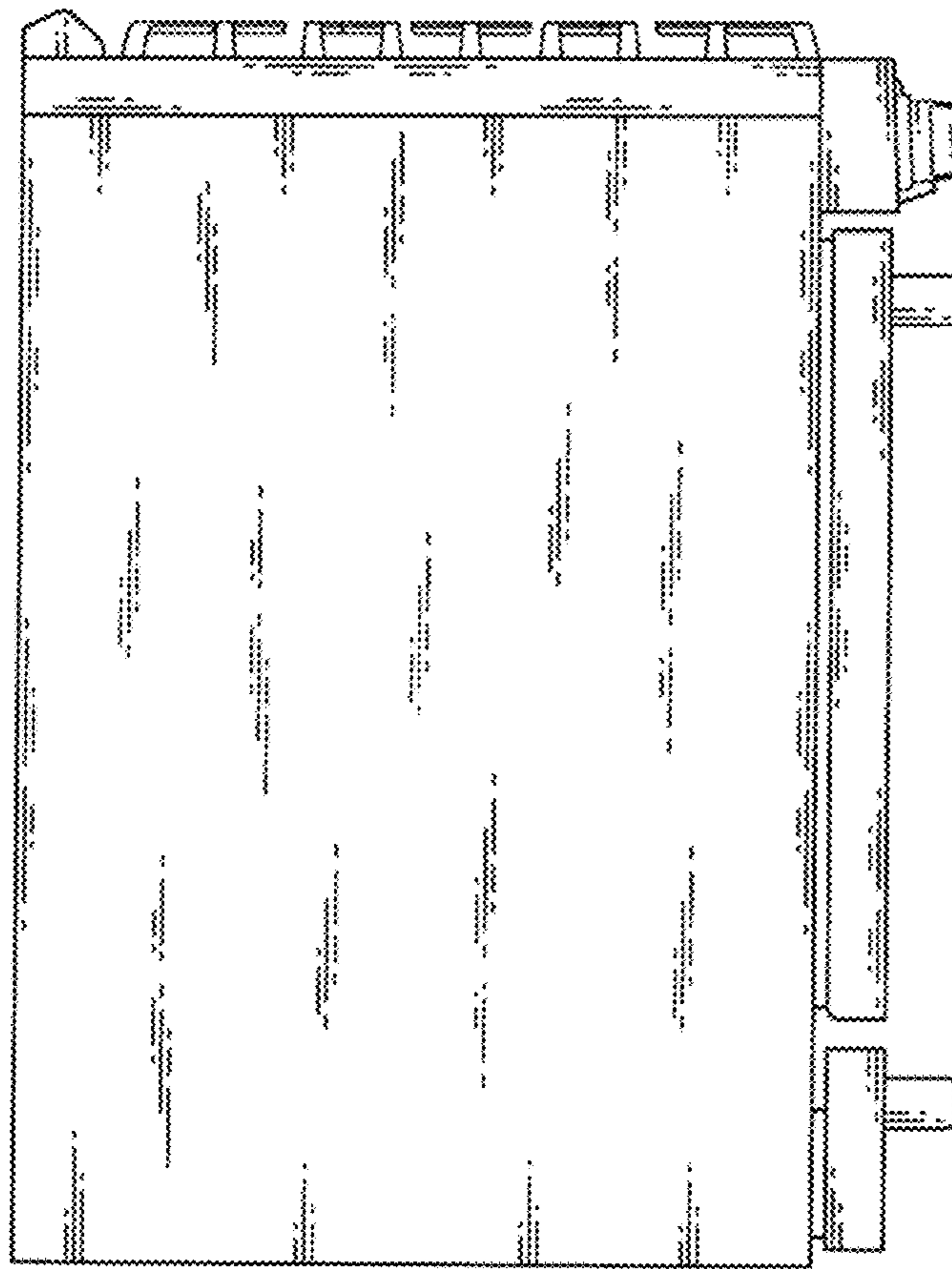

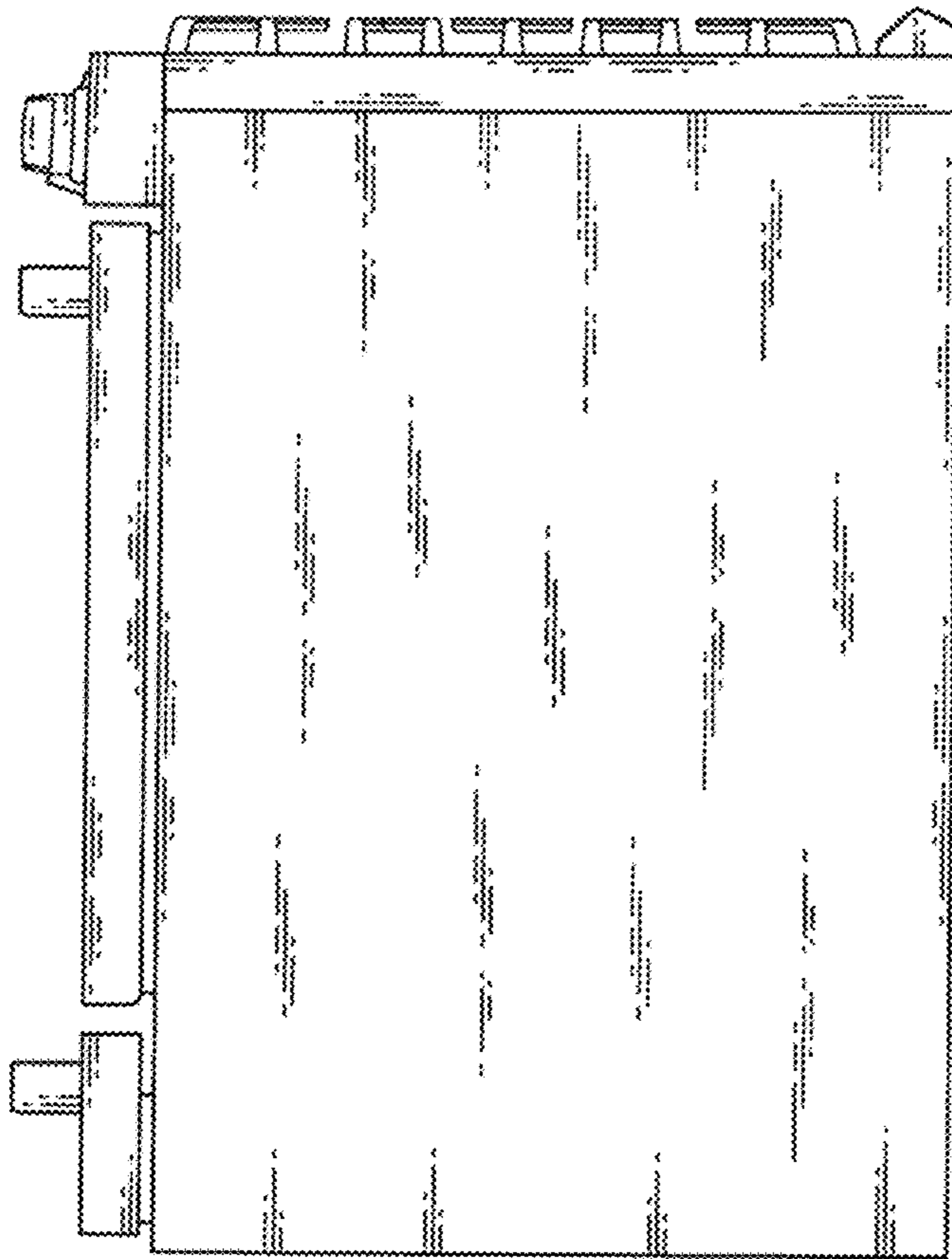

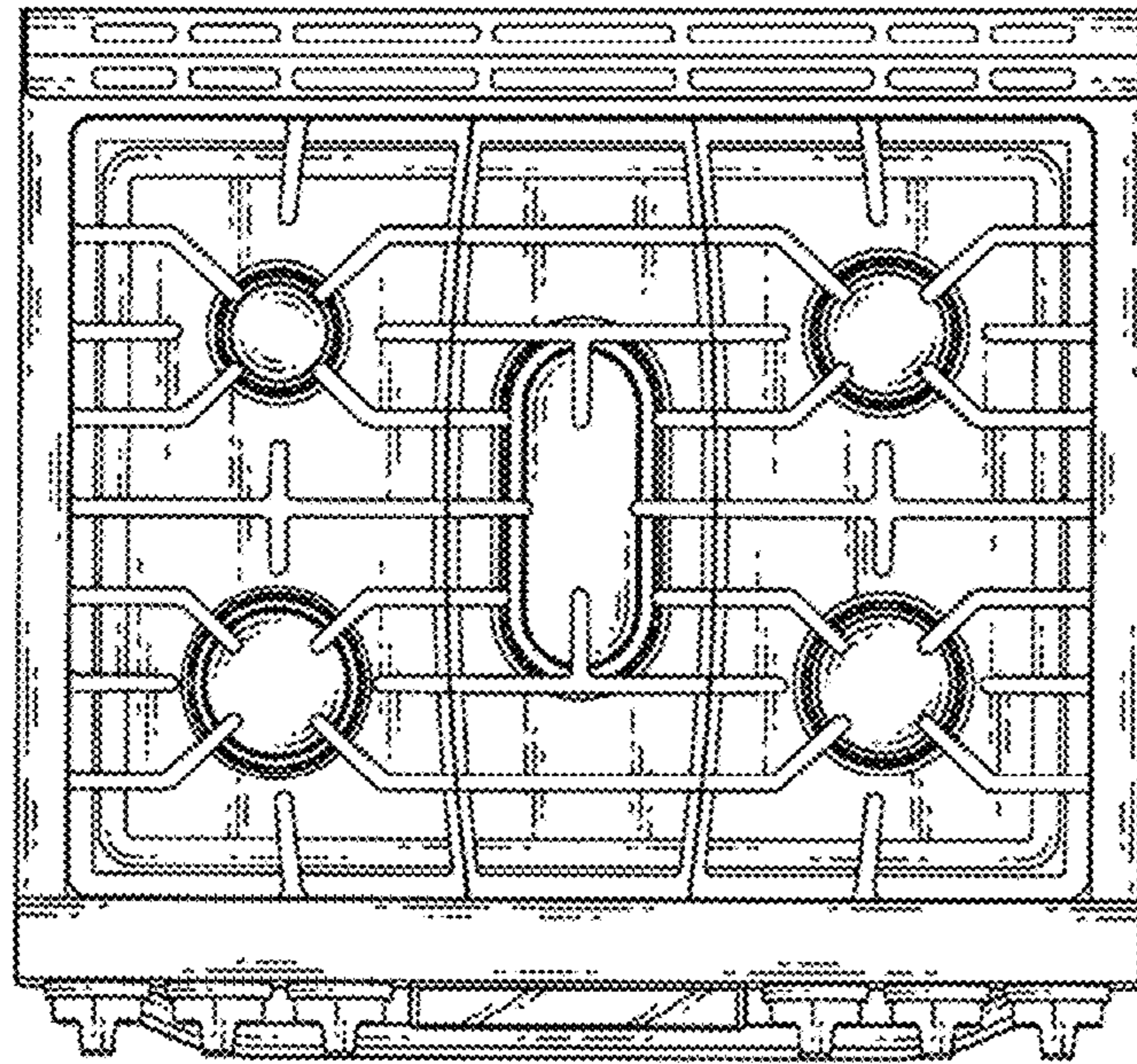
