(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a bottle in accordance with a first embodiment of the present invention;

FIG. 2 is a side elevation view thereof, the opposing side elevation view being identical with the exception of the unclaimed threaded pour spout;

FIG. 3 is a top plan view thereof, shown at an enlarged scale; FIG. 4 is a bottom plan view thereof, shown at an enlarged scale;

FIG. 5 is a bottom perspective view of a bottle in accordance with a second embodiment of the present invention;

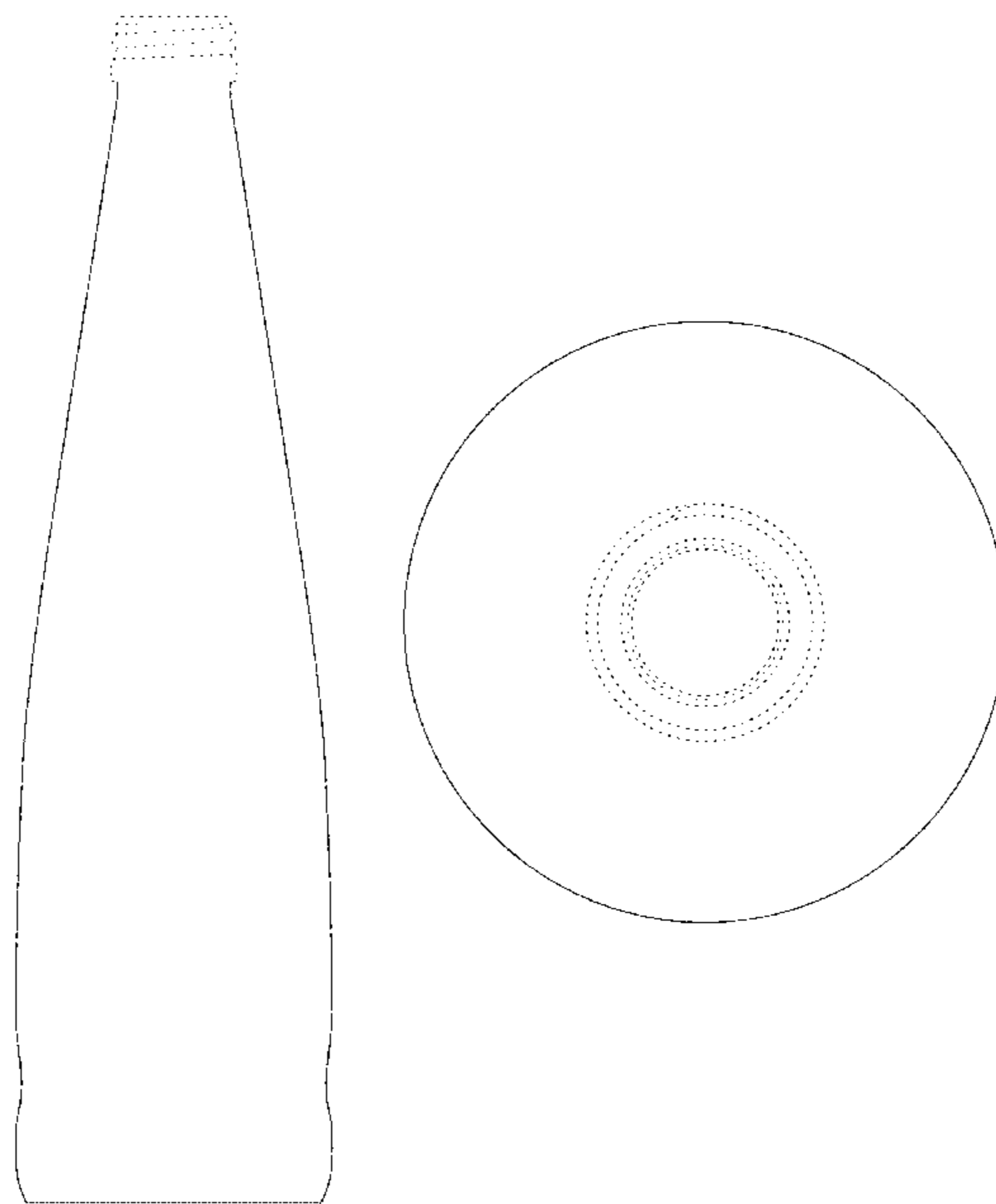
FIG. 6 is a side elevation view thereof, the opposing side elevation view being identical with the exception of the unclaimed threaded pour spout;

FIG. 7 is a top plan view thereof, shown at an enlarged scale; and,

FIG. 8 is a bottom plan view thereof, shown at an enlarged scale.

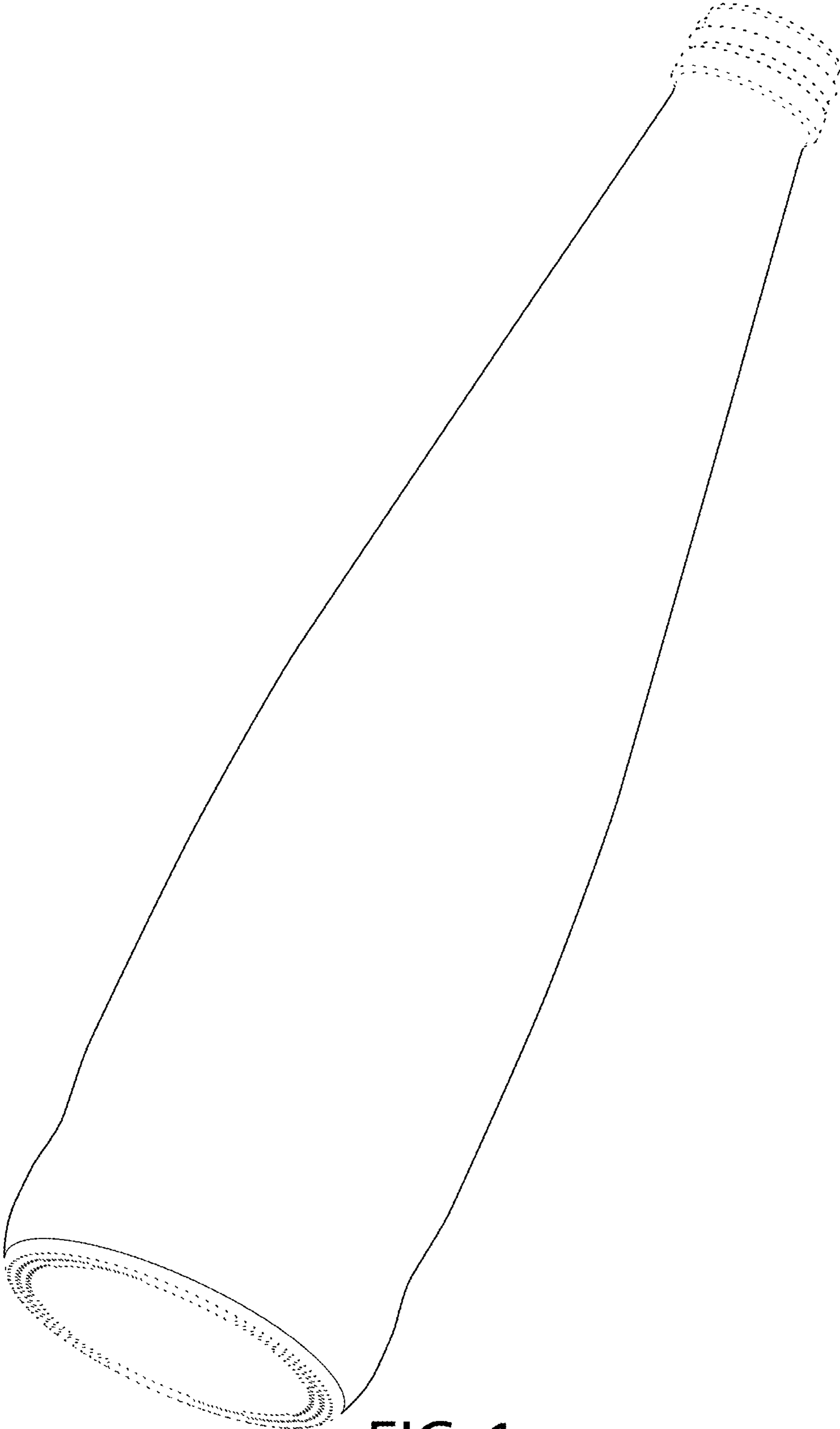

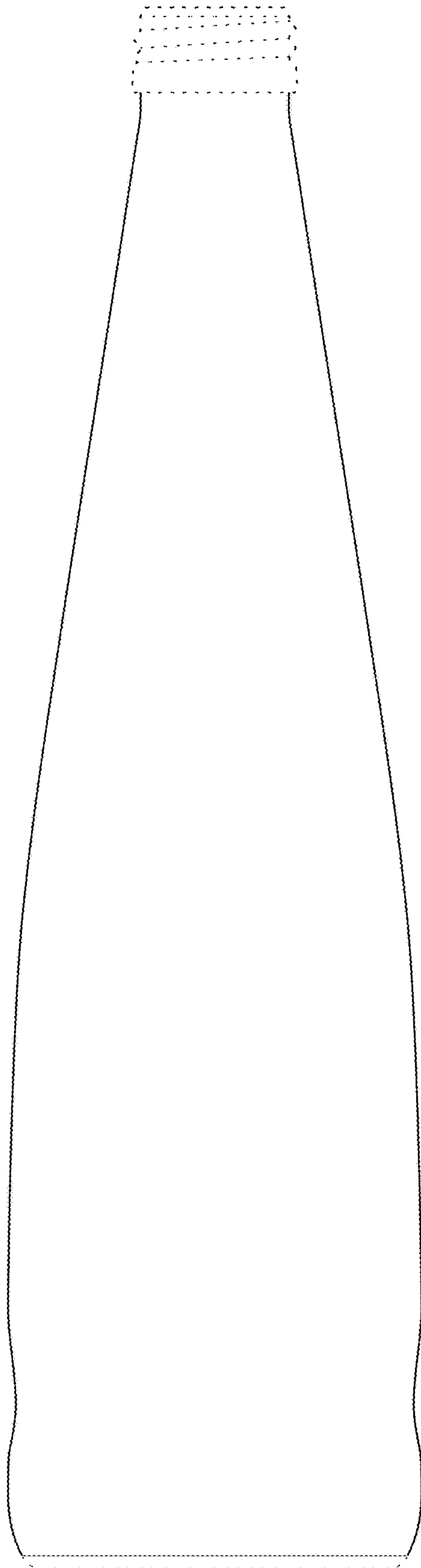

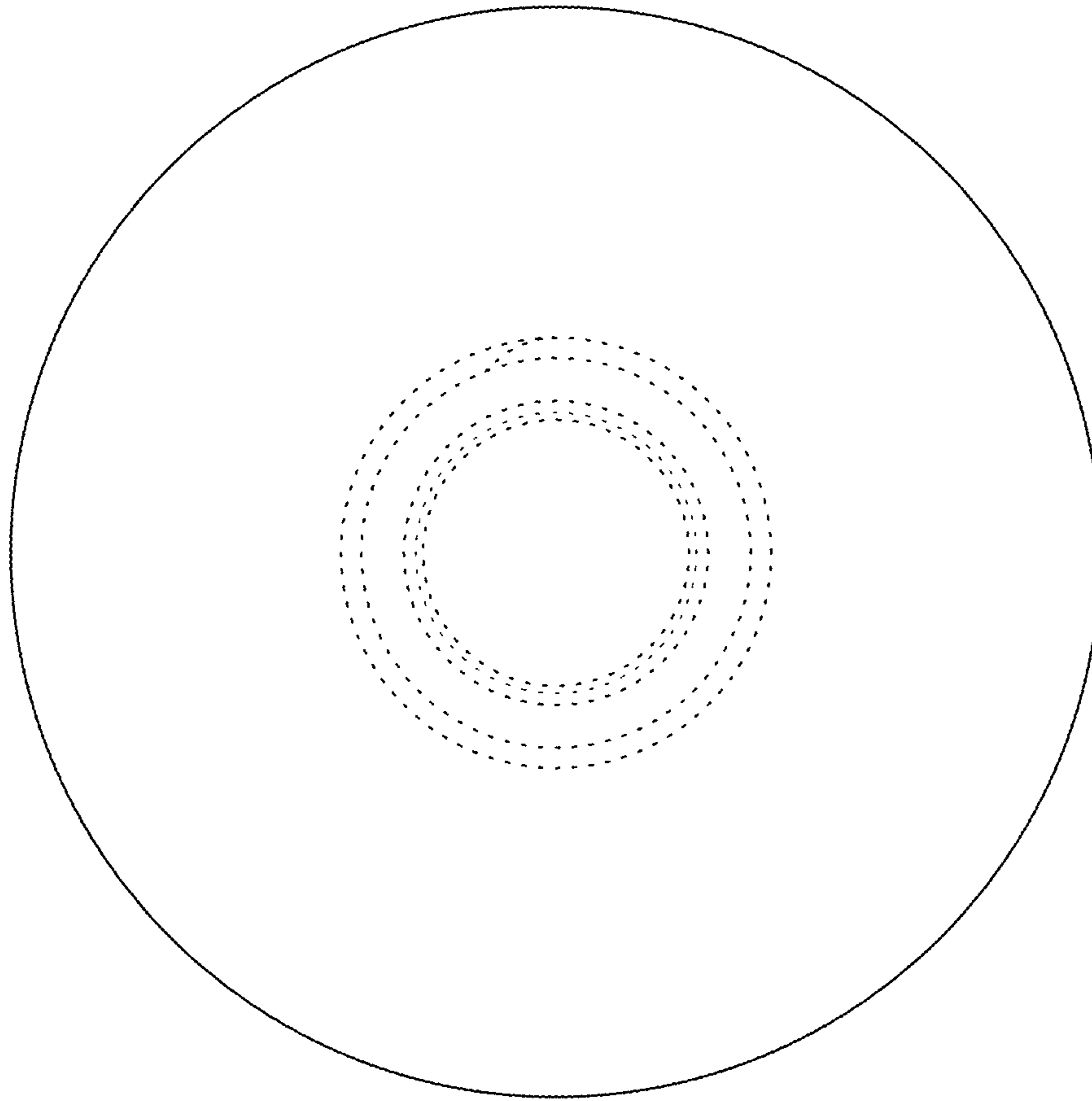

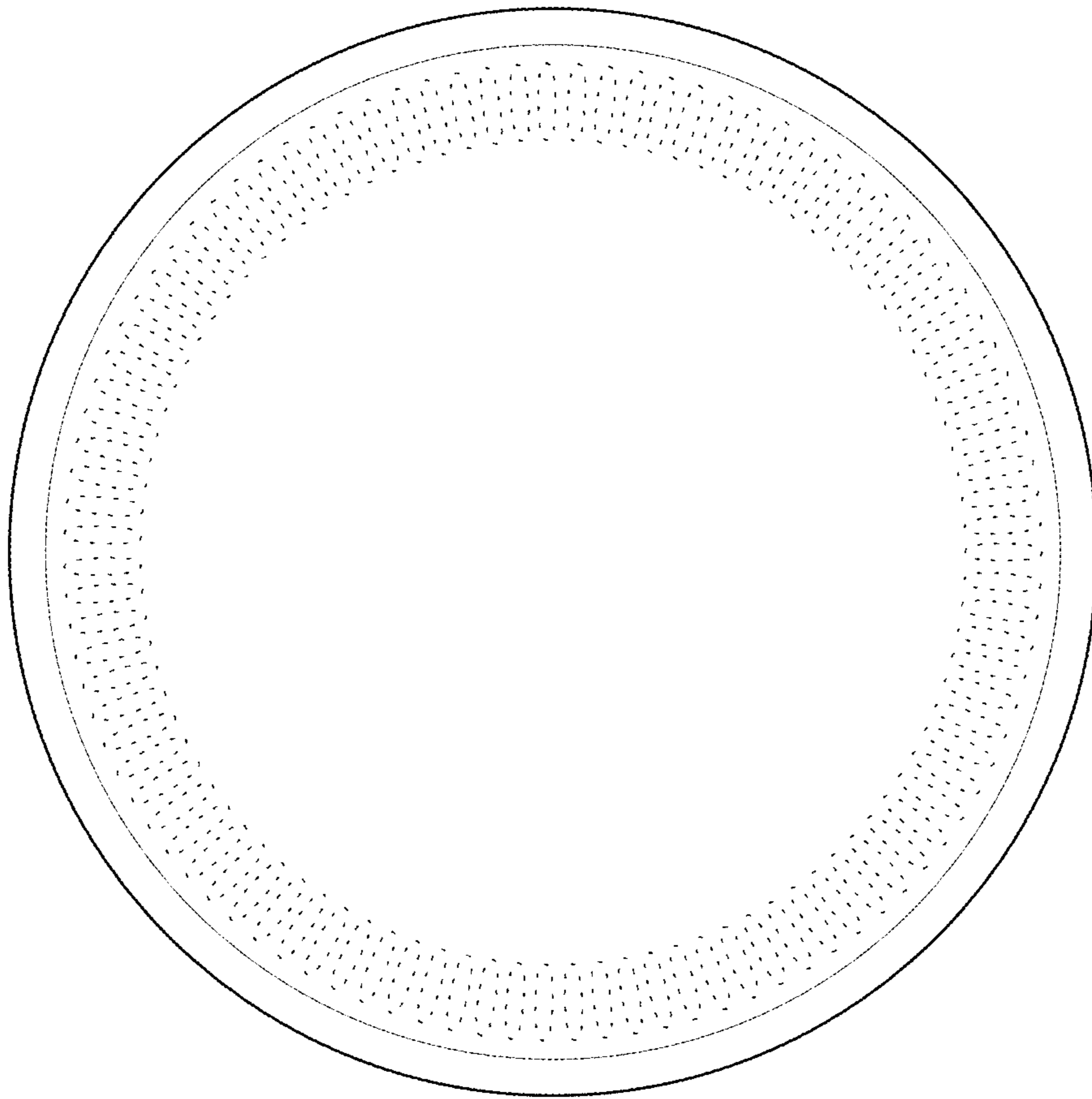

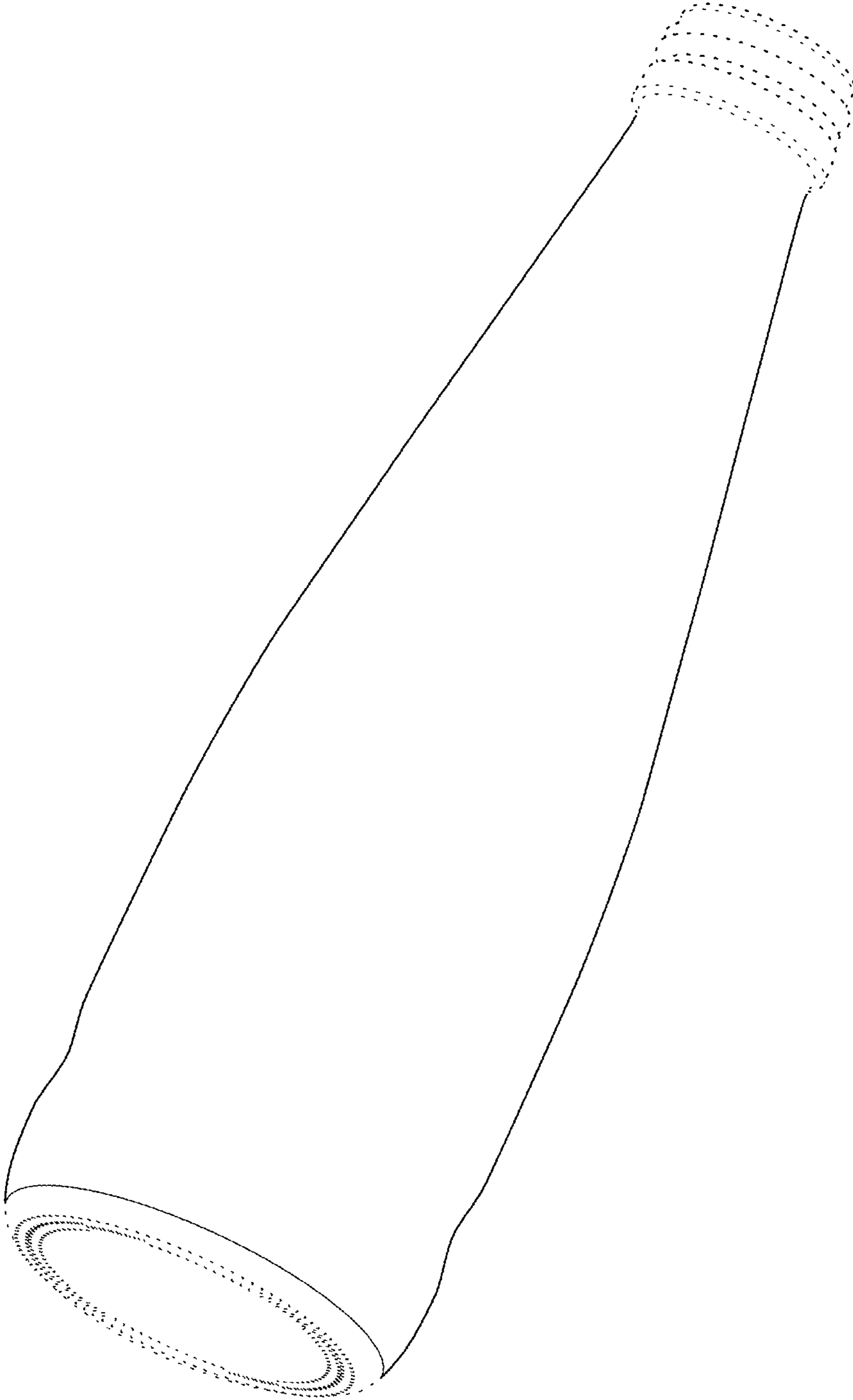

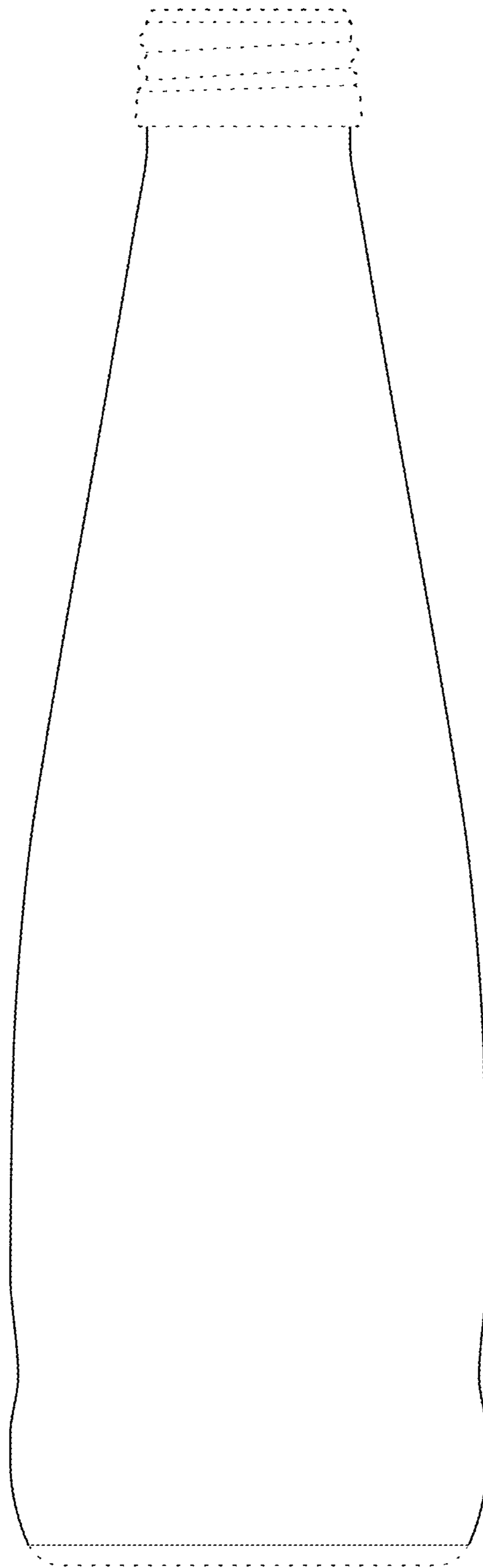

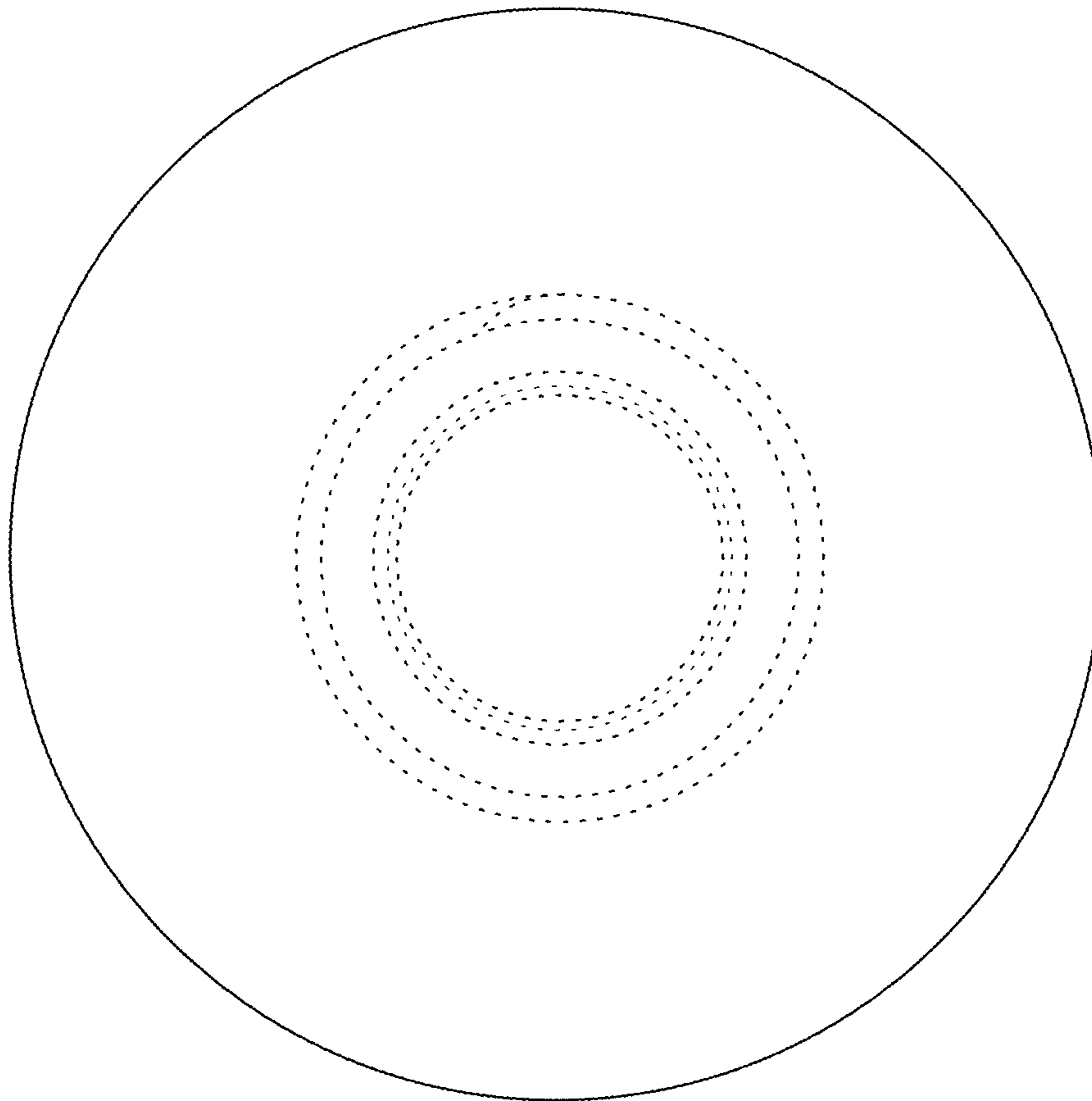

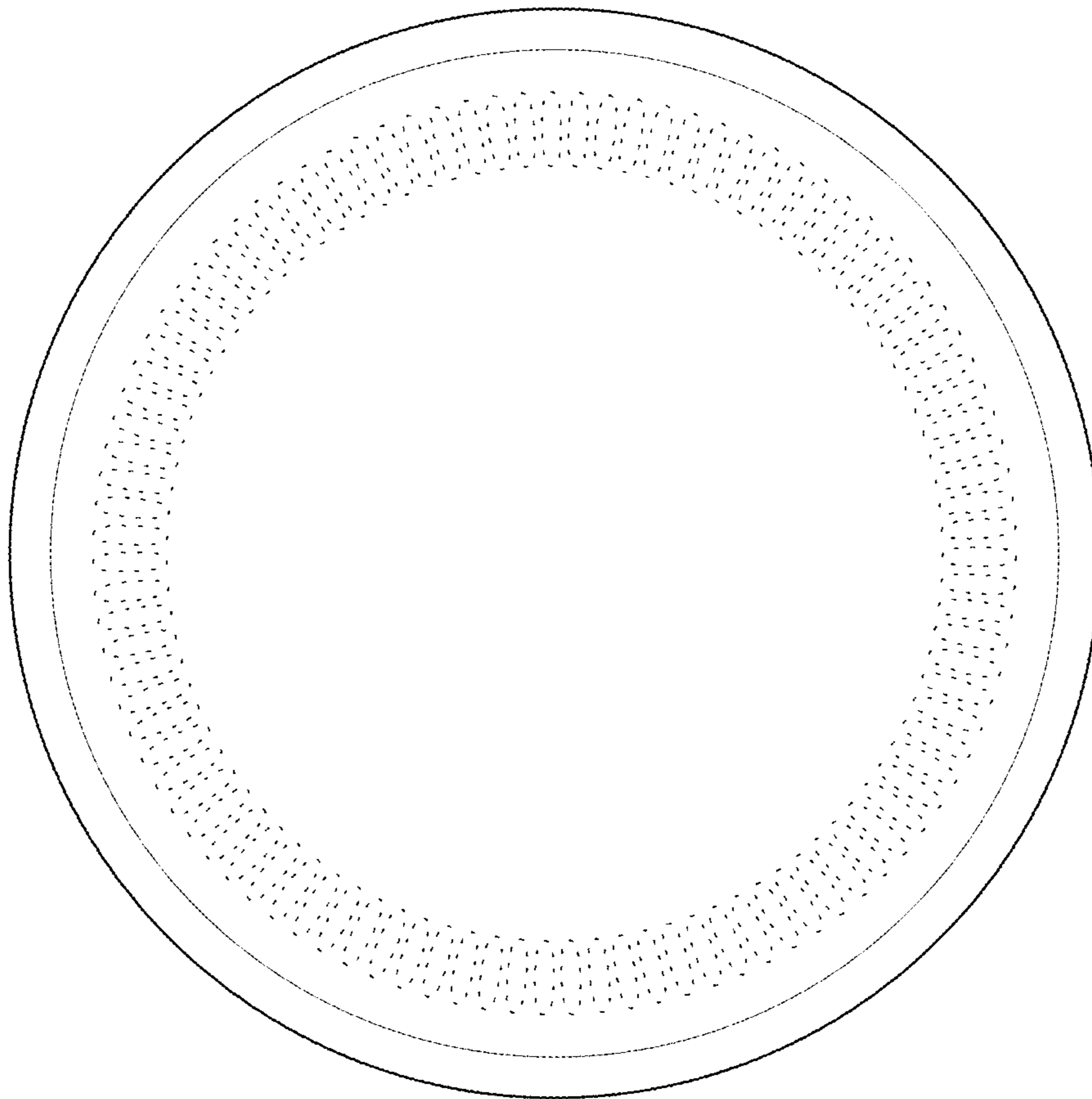
