DESCRIPTION

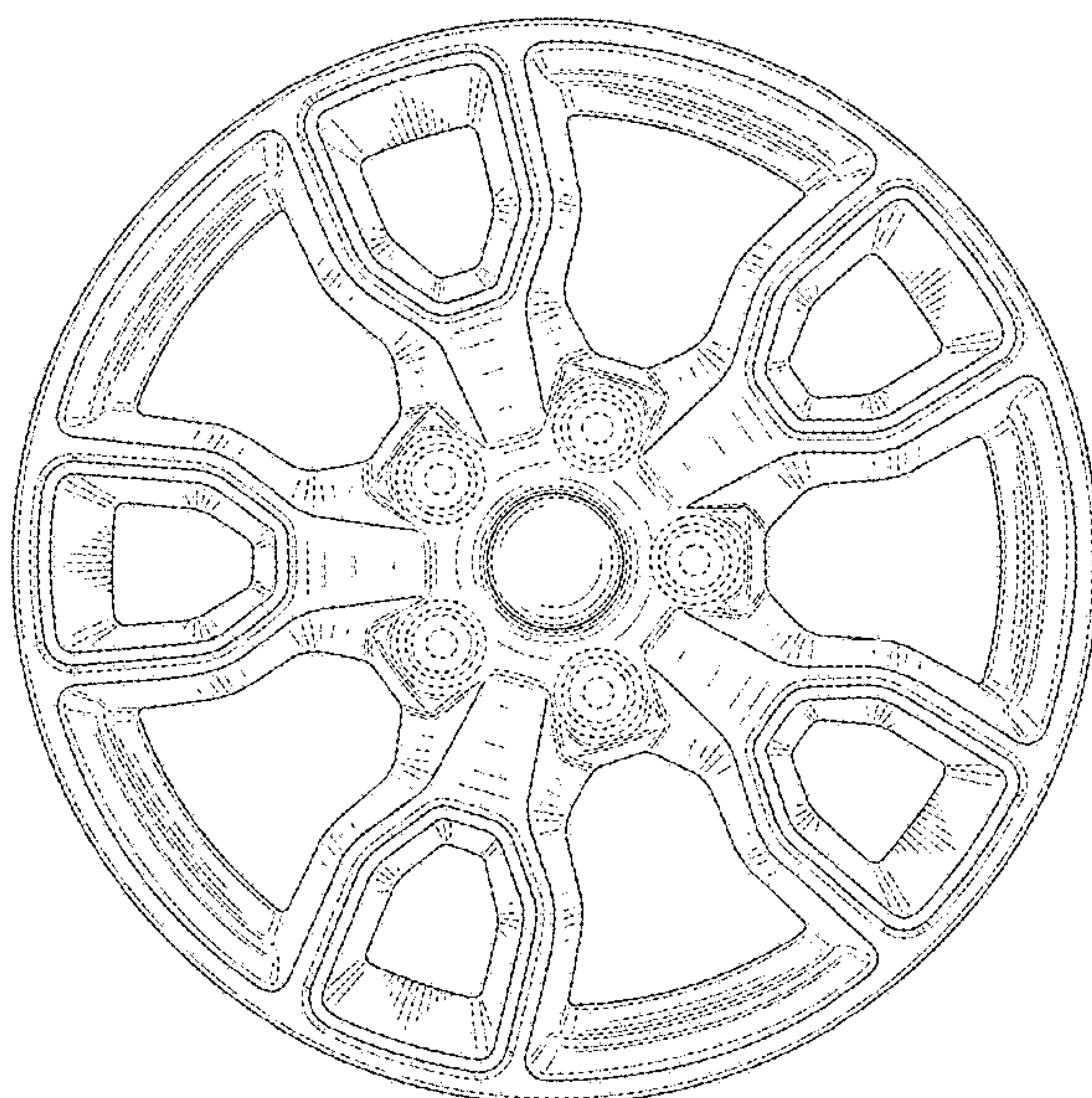
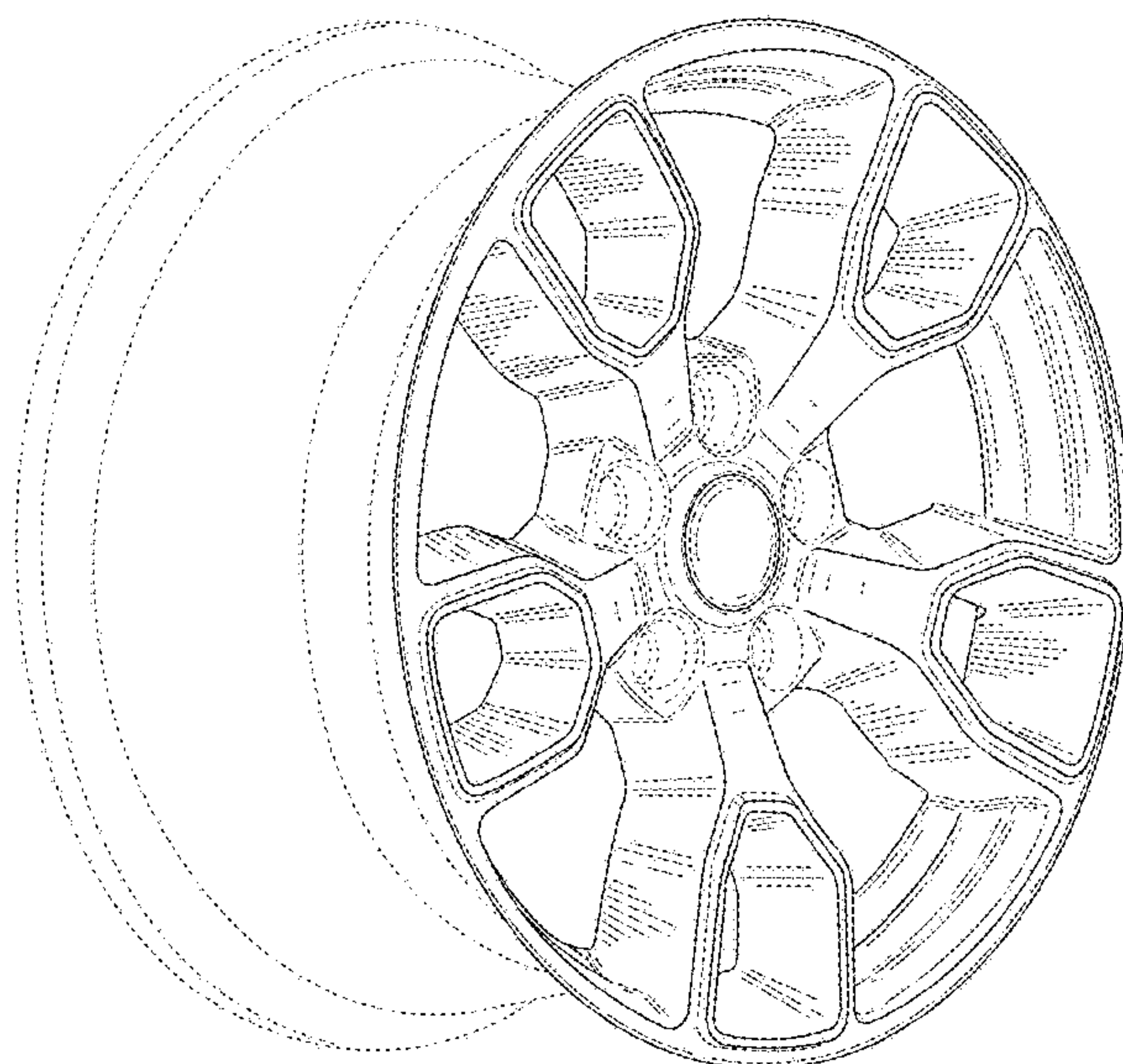
FIG. 1 is a right side perspective view of an automobile wheel showing our new design;

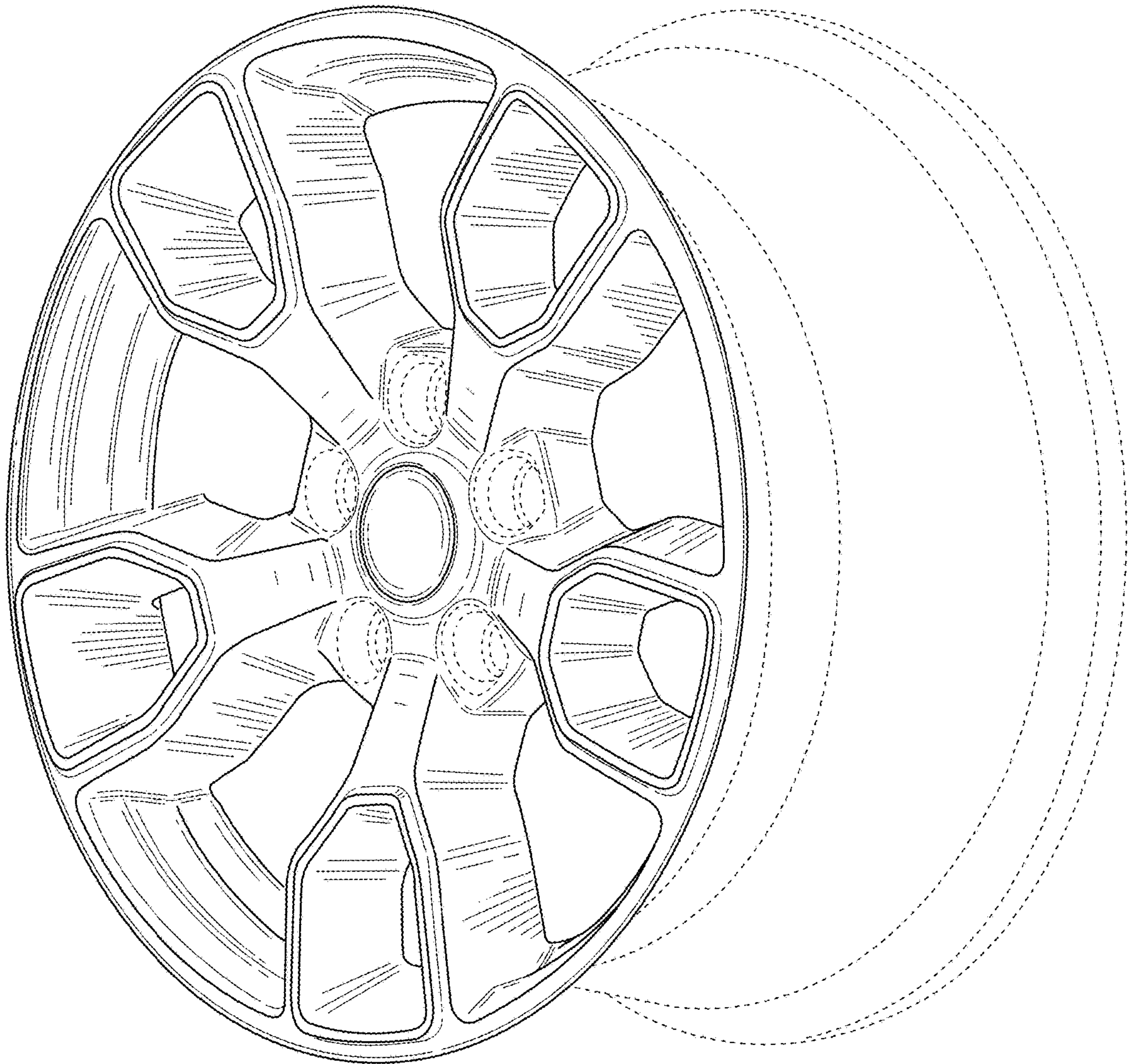

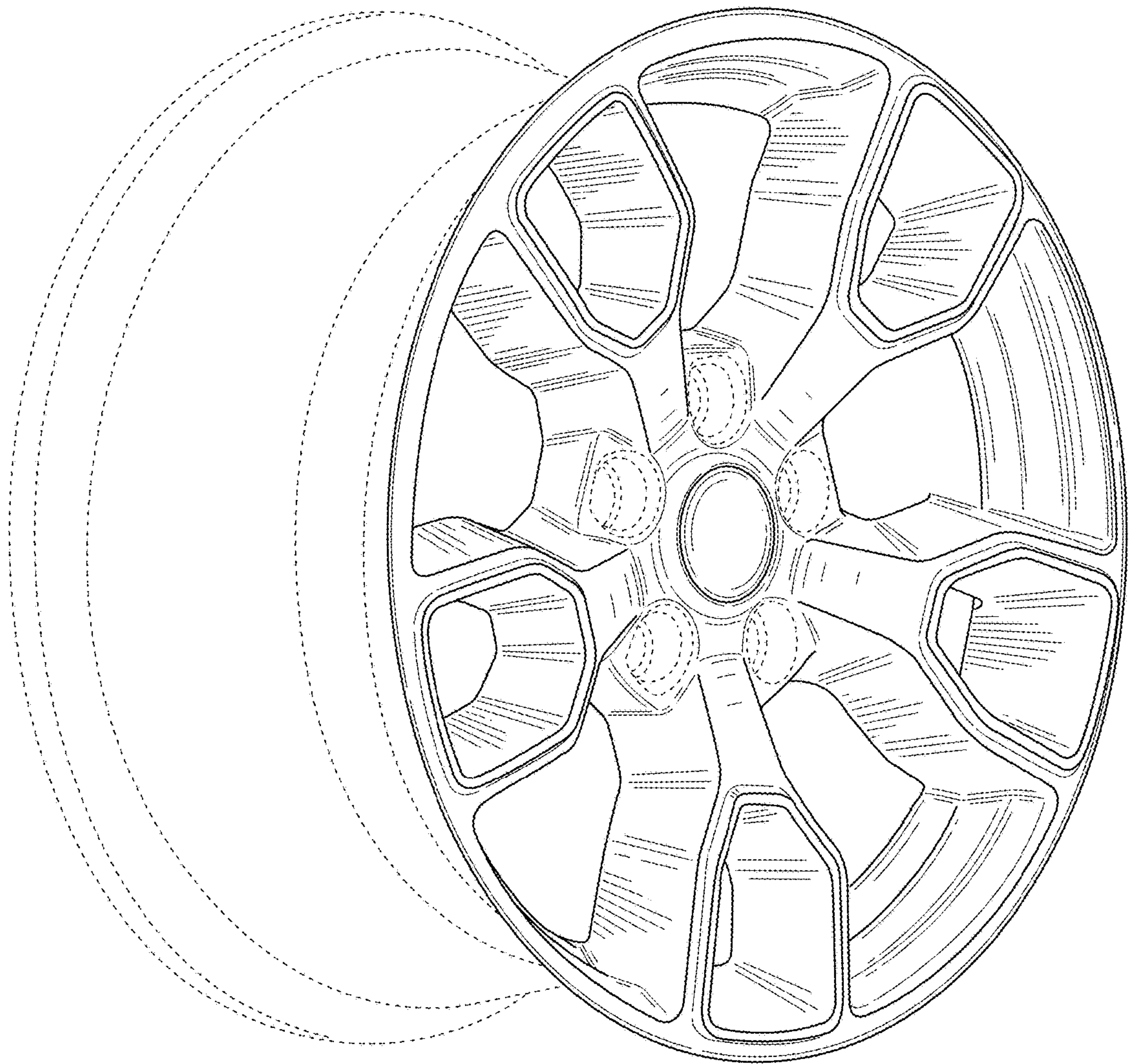

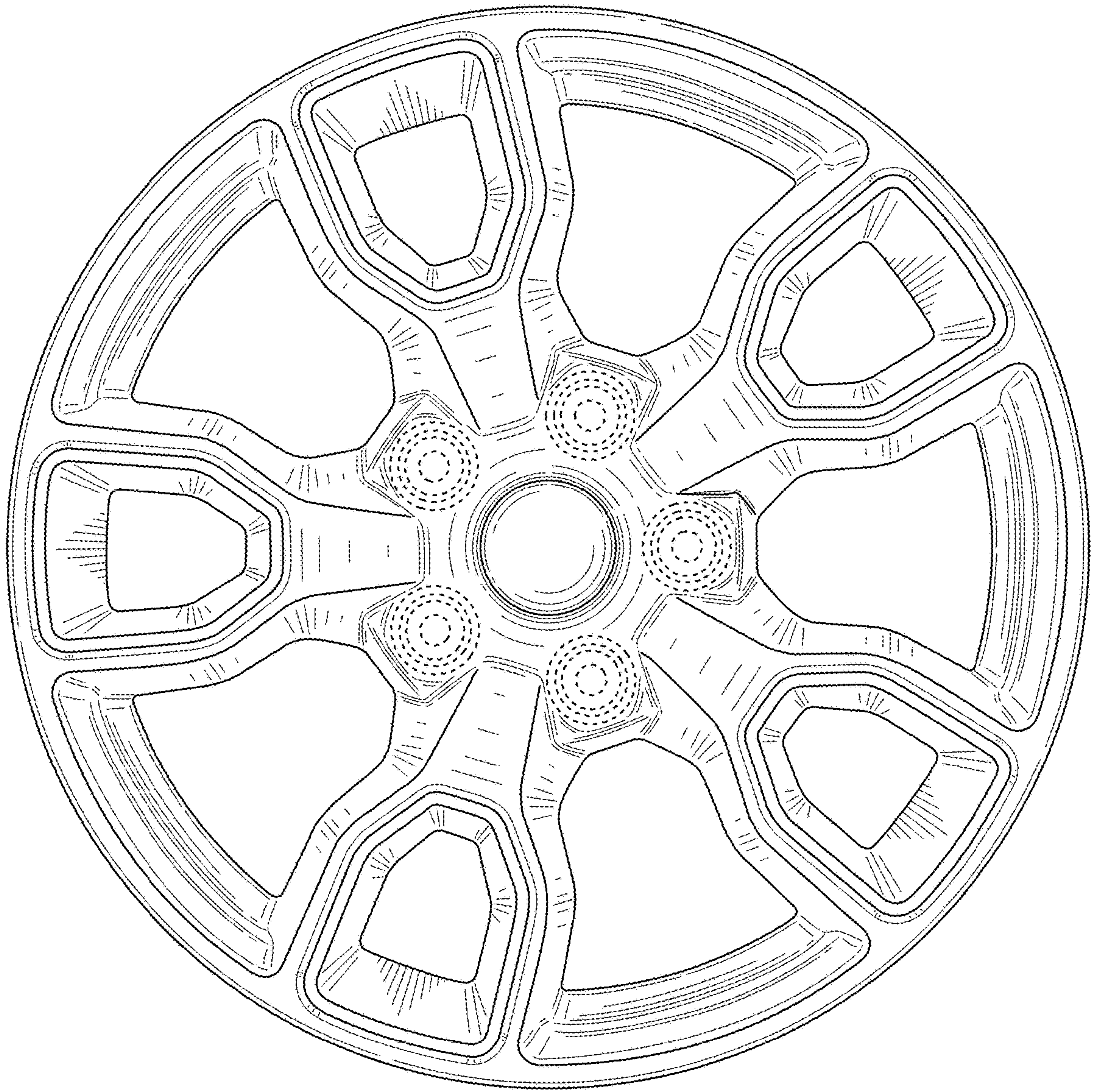
