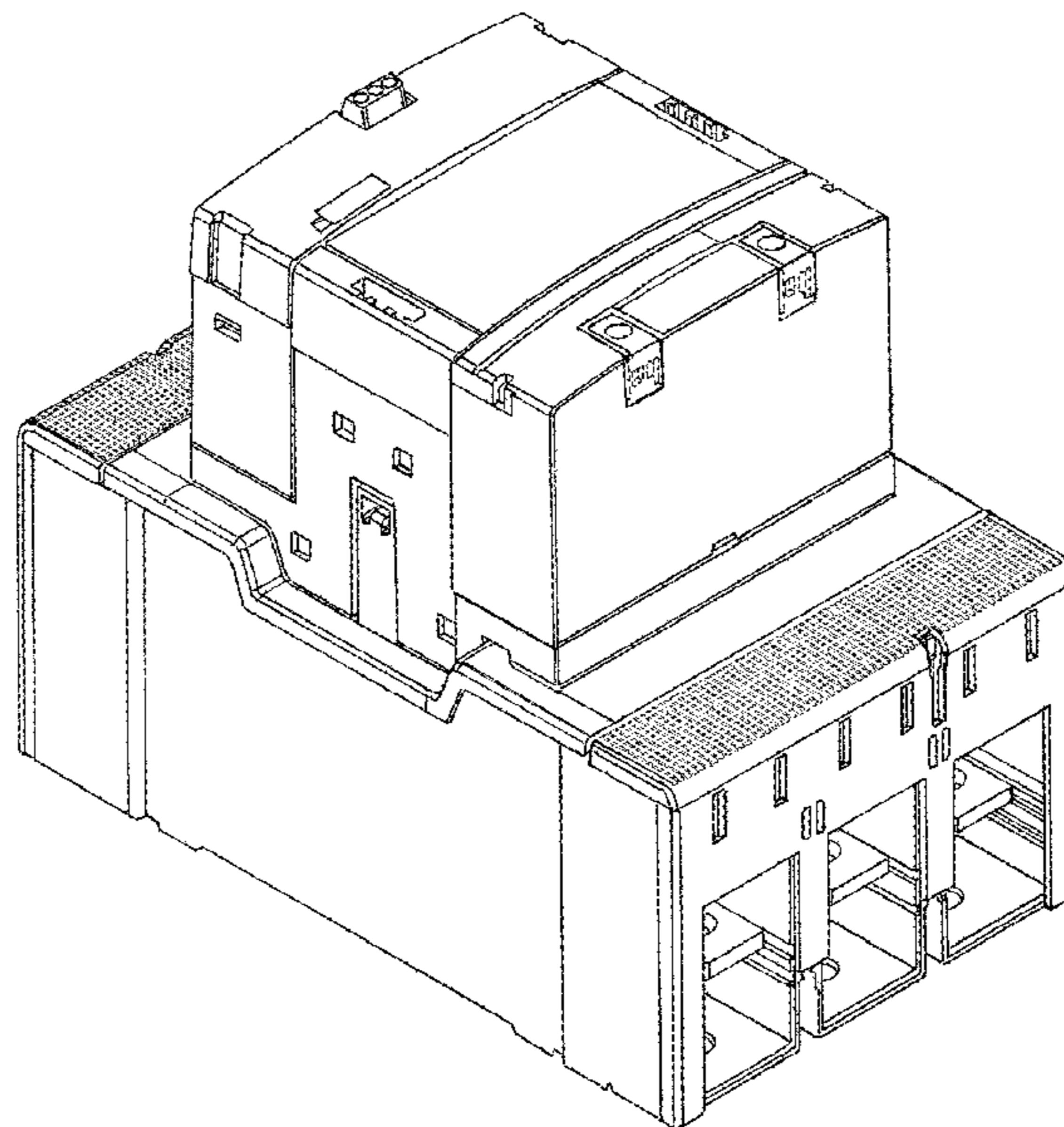

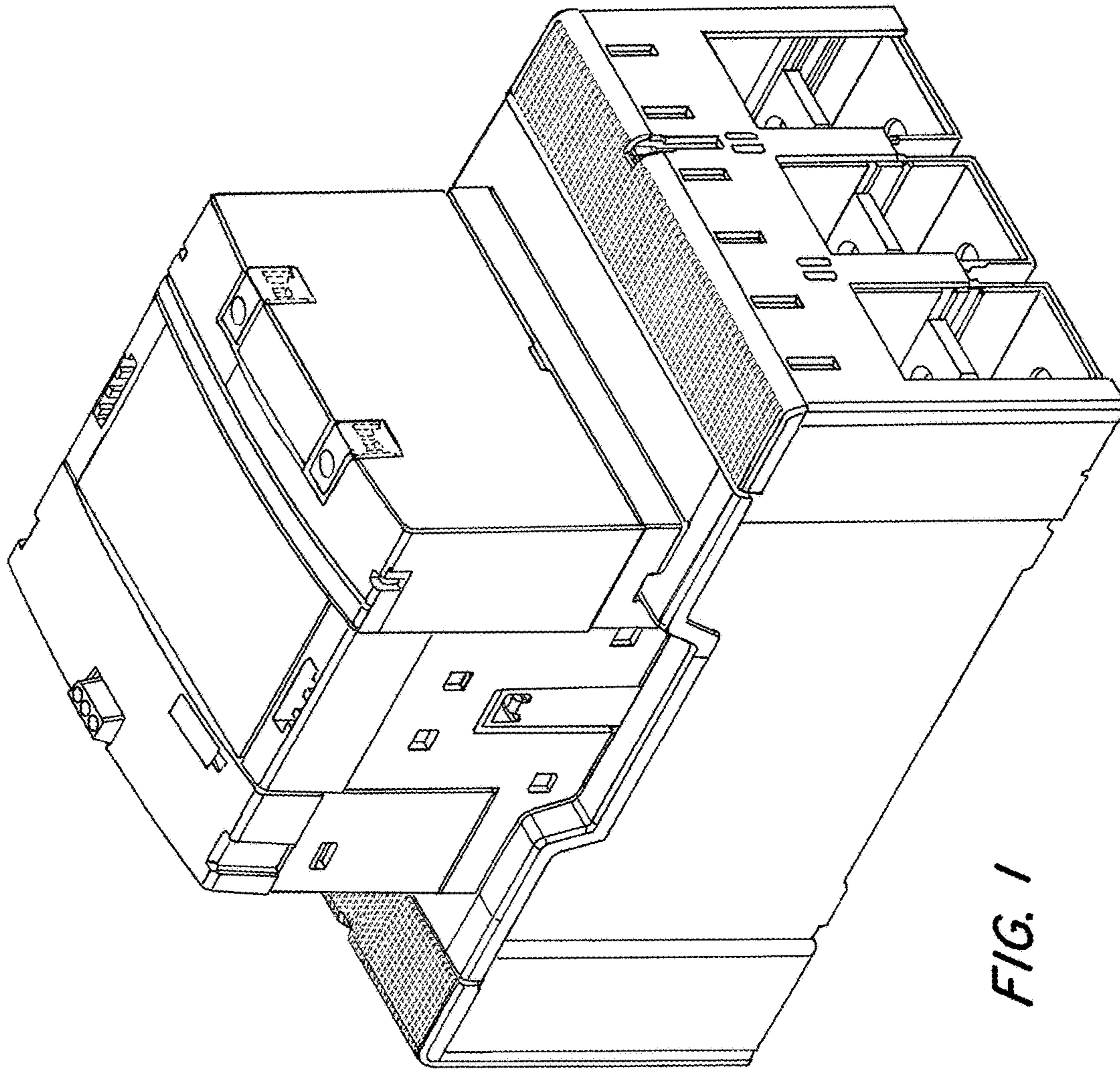

**DESCRIPTION**  
FIG. 1 is a front left side isometric view of a contactor in accordance with the new design;  
FIG. 2 is an enlarged front elevational view thereof;  
FIG. 3 is an enlarged top plan view thereof;  
FIG. 4 is an enlarged bottom plan view thereof;  
FIG. 5 is an enlarged right side elevational view thereof; and,

The broken line portion of the figure drawings is included to show portions of the article that form no part of the claimed design.

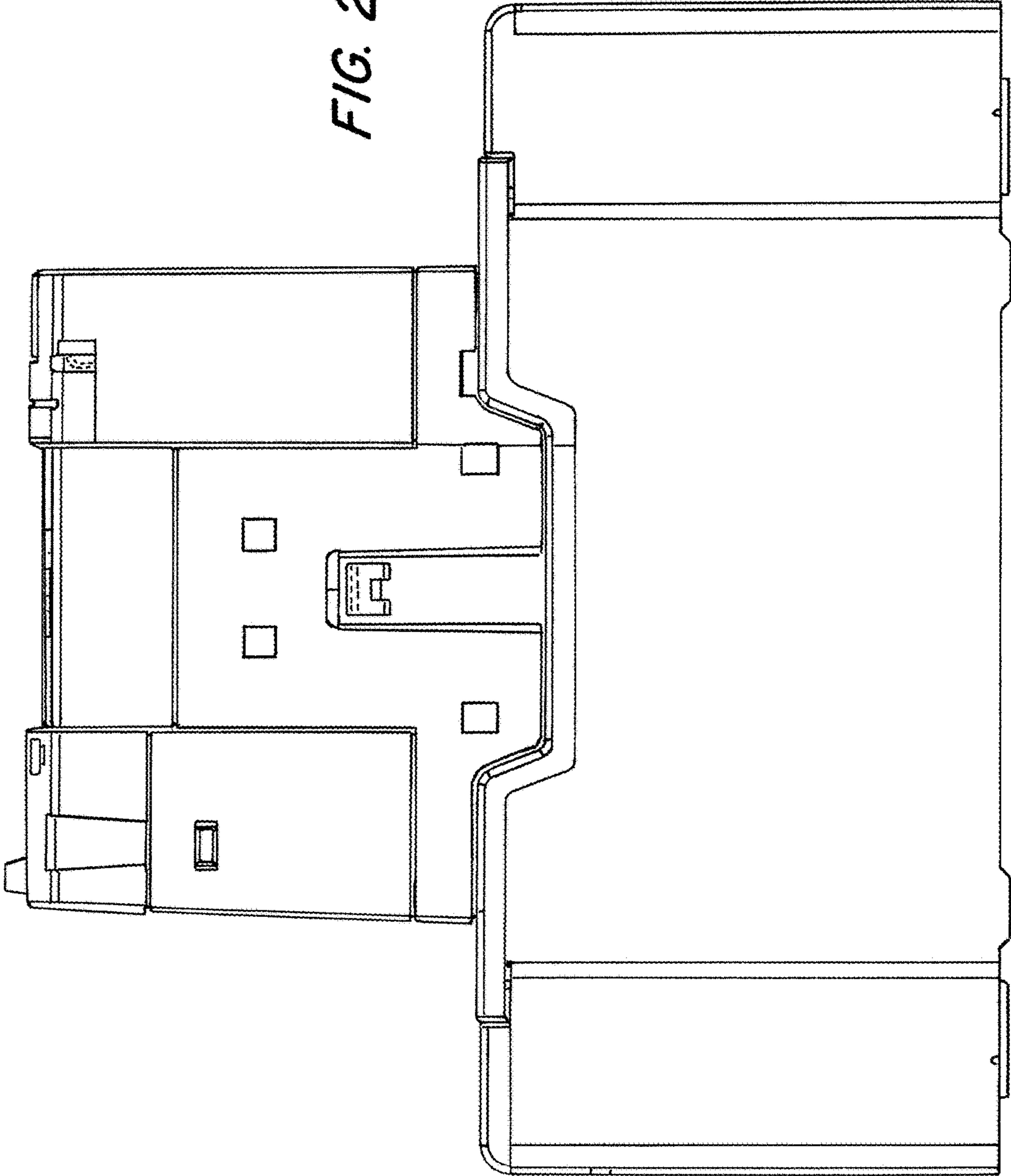

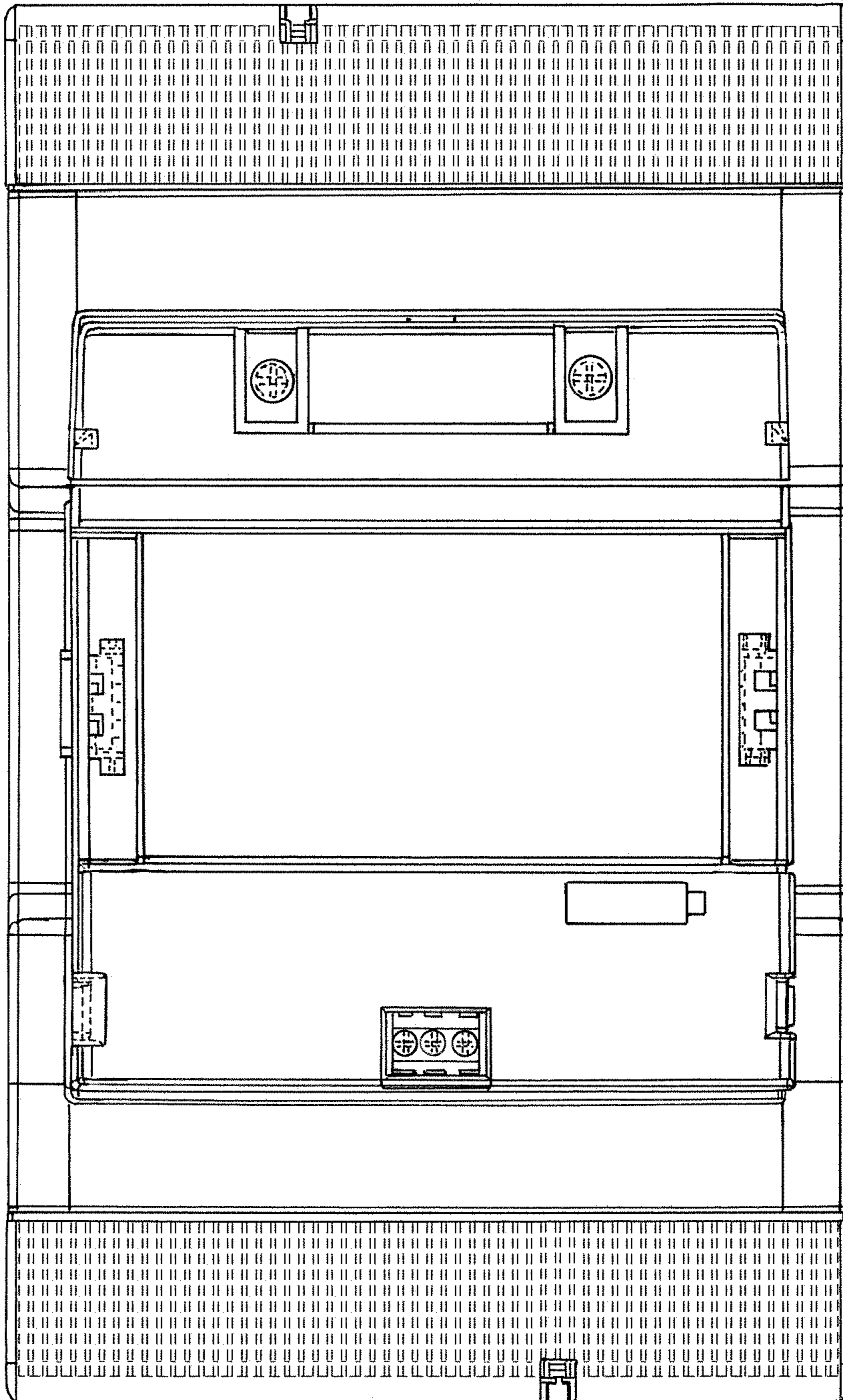

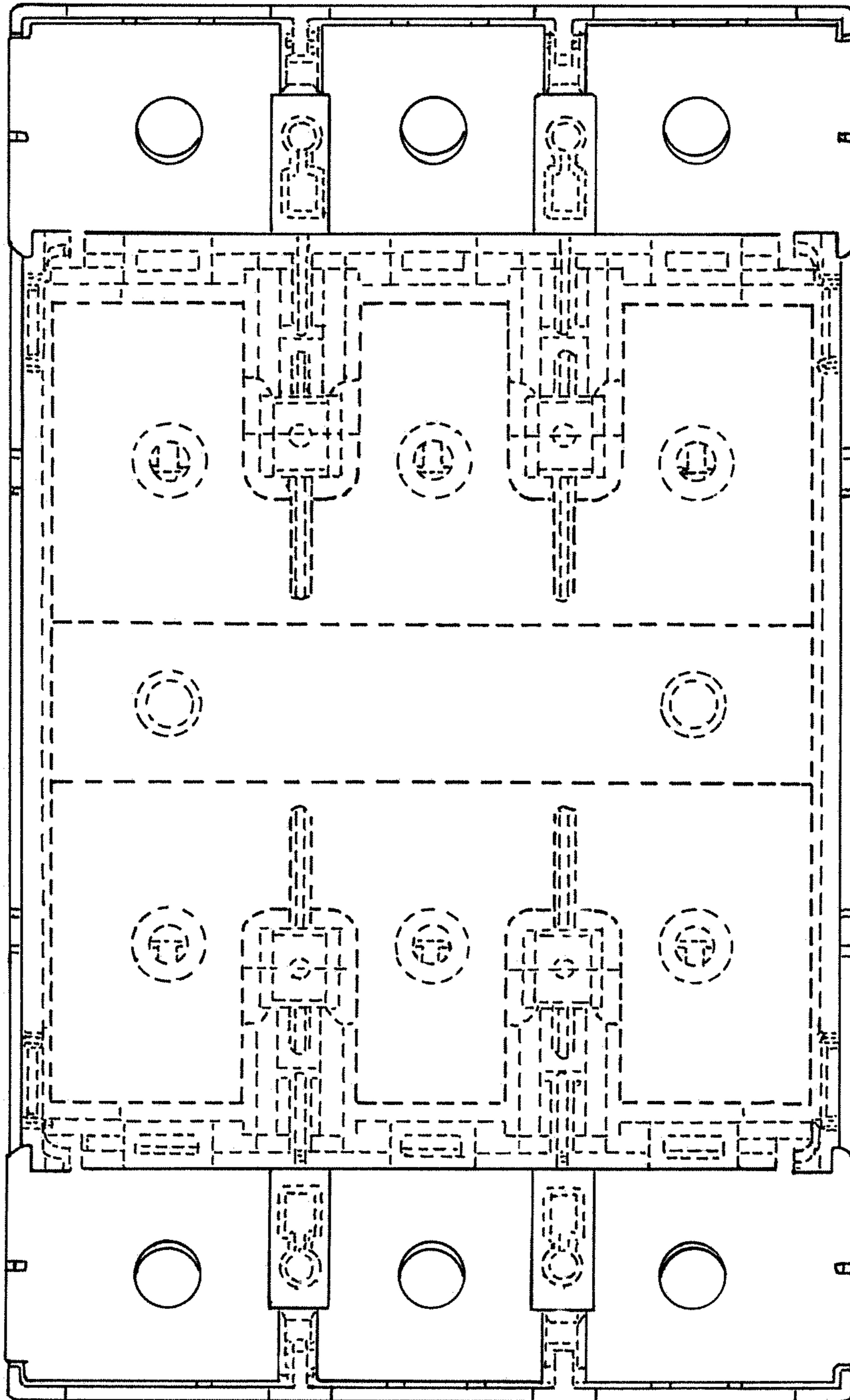
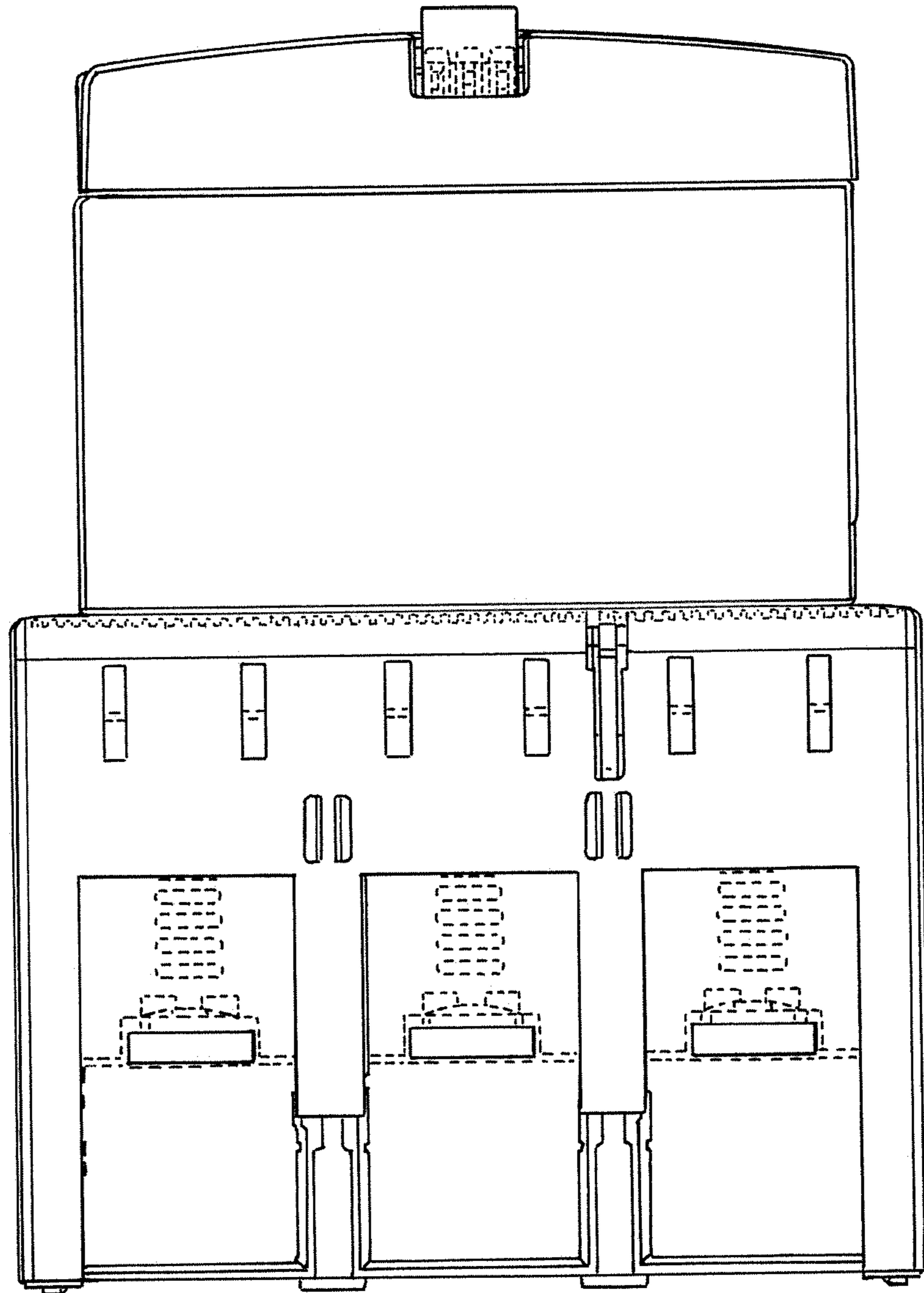
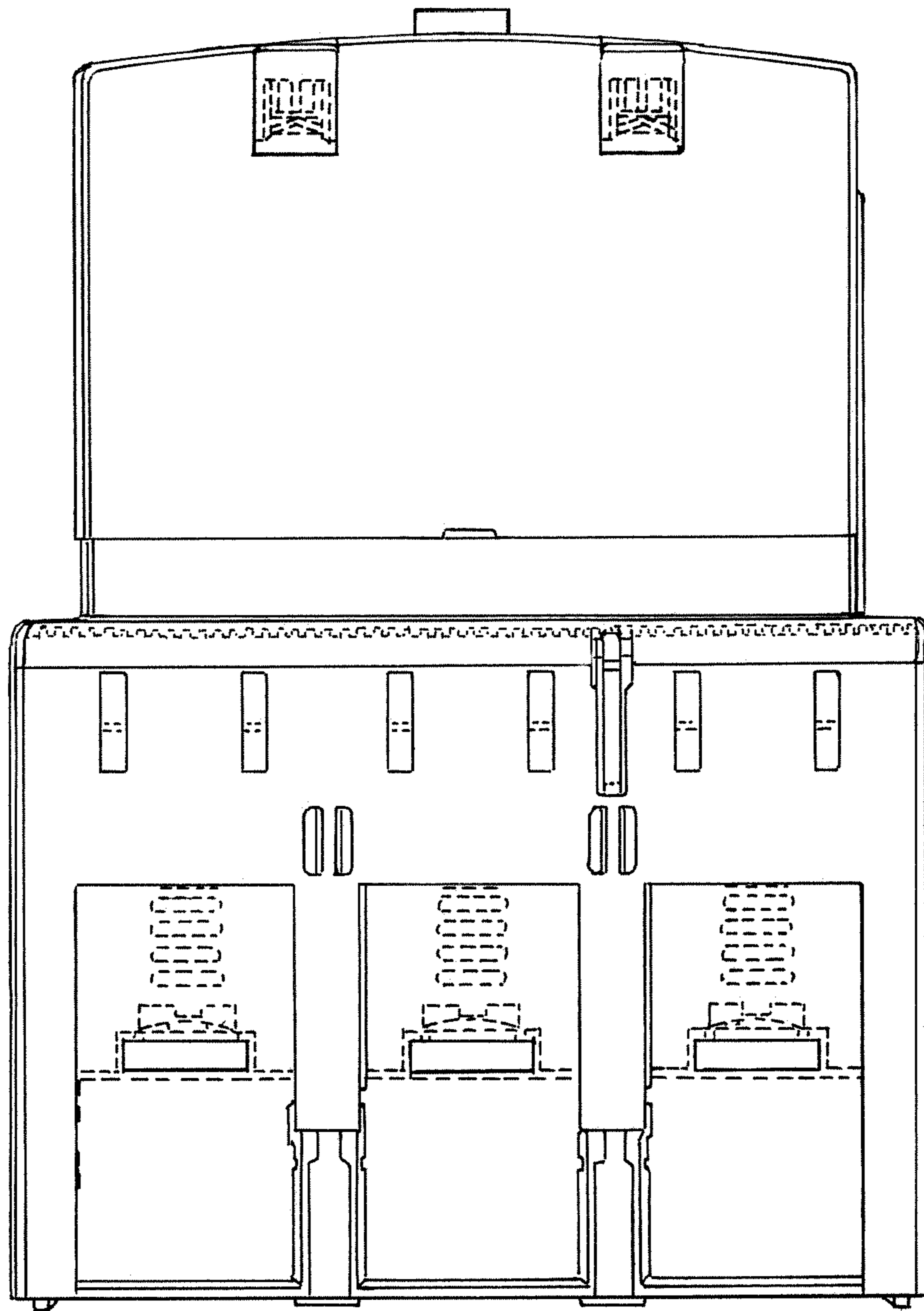
