DESCRIPTION

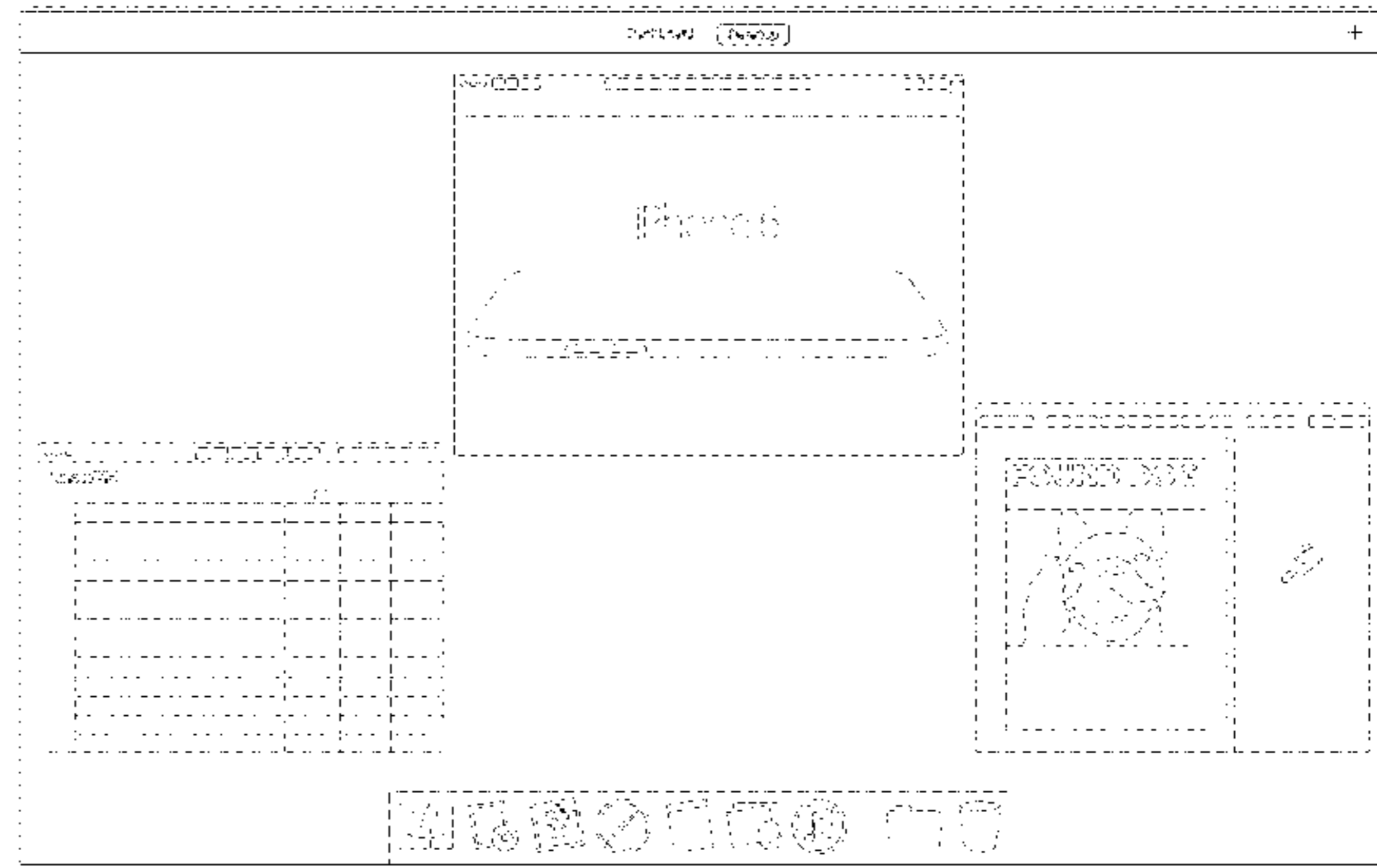
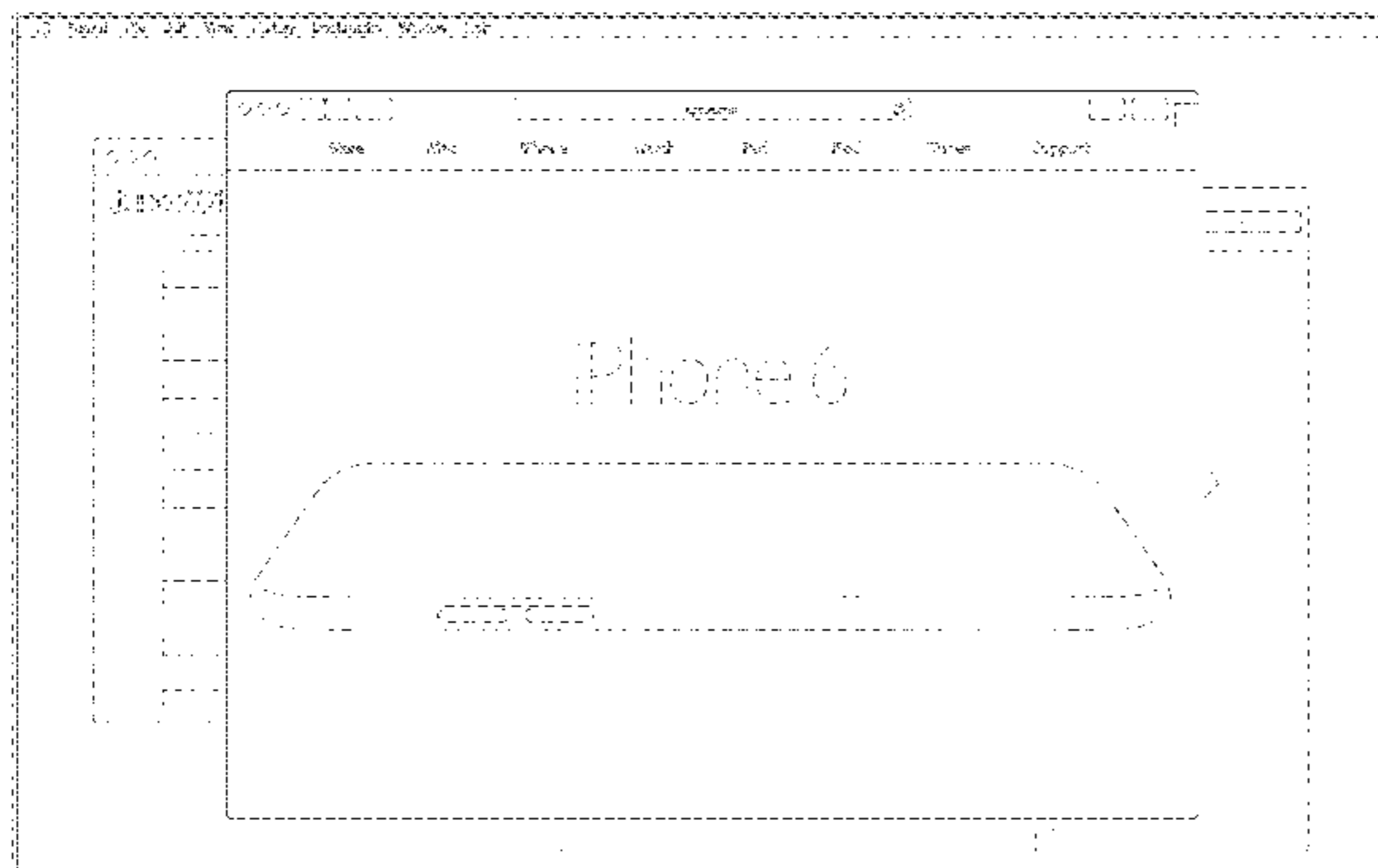
FIG. 1 shows a first image of a display screen or portion thereof with animated graphical user interface showing our new design;

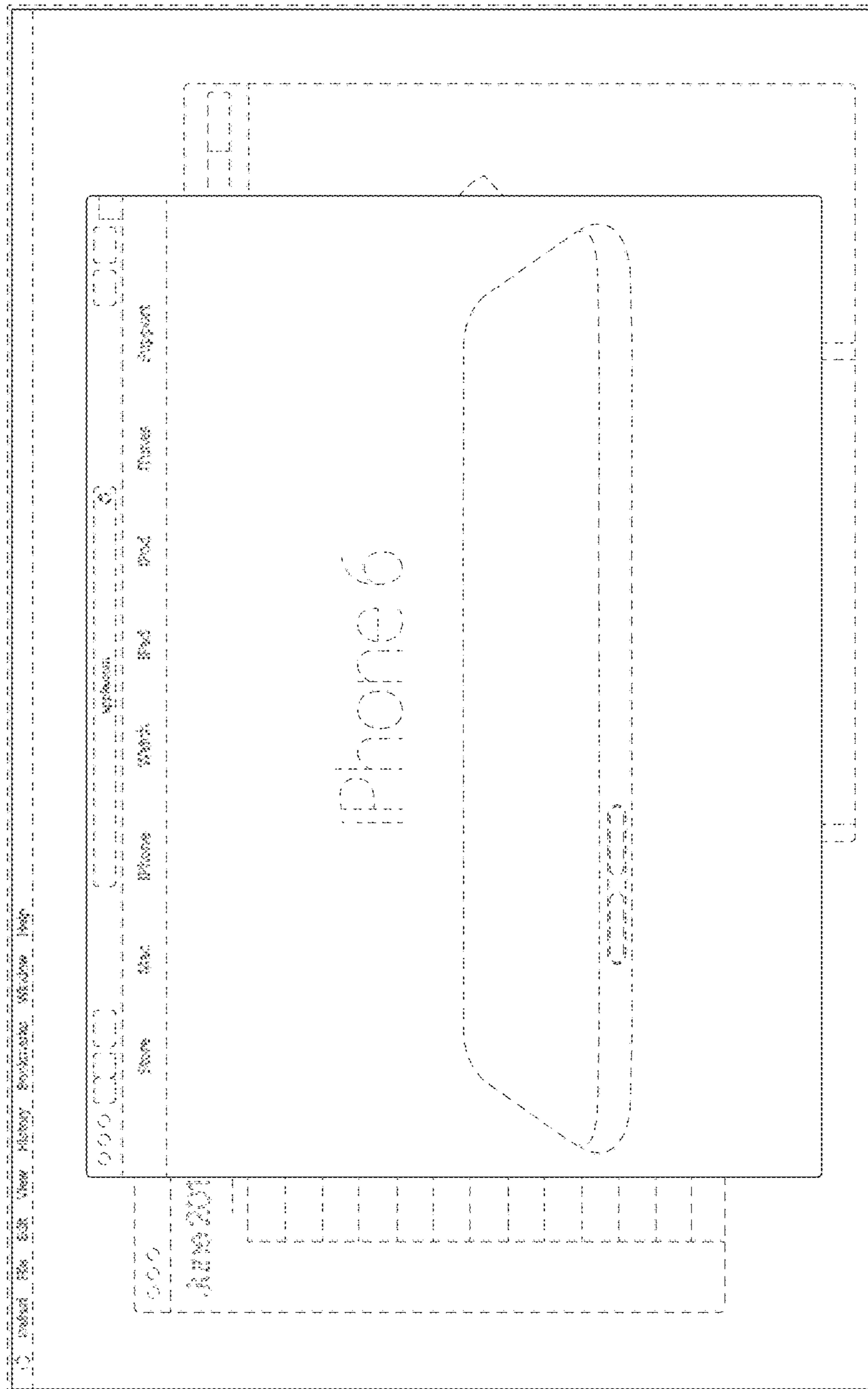

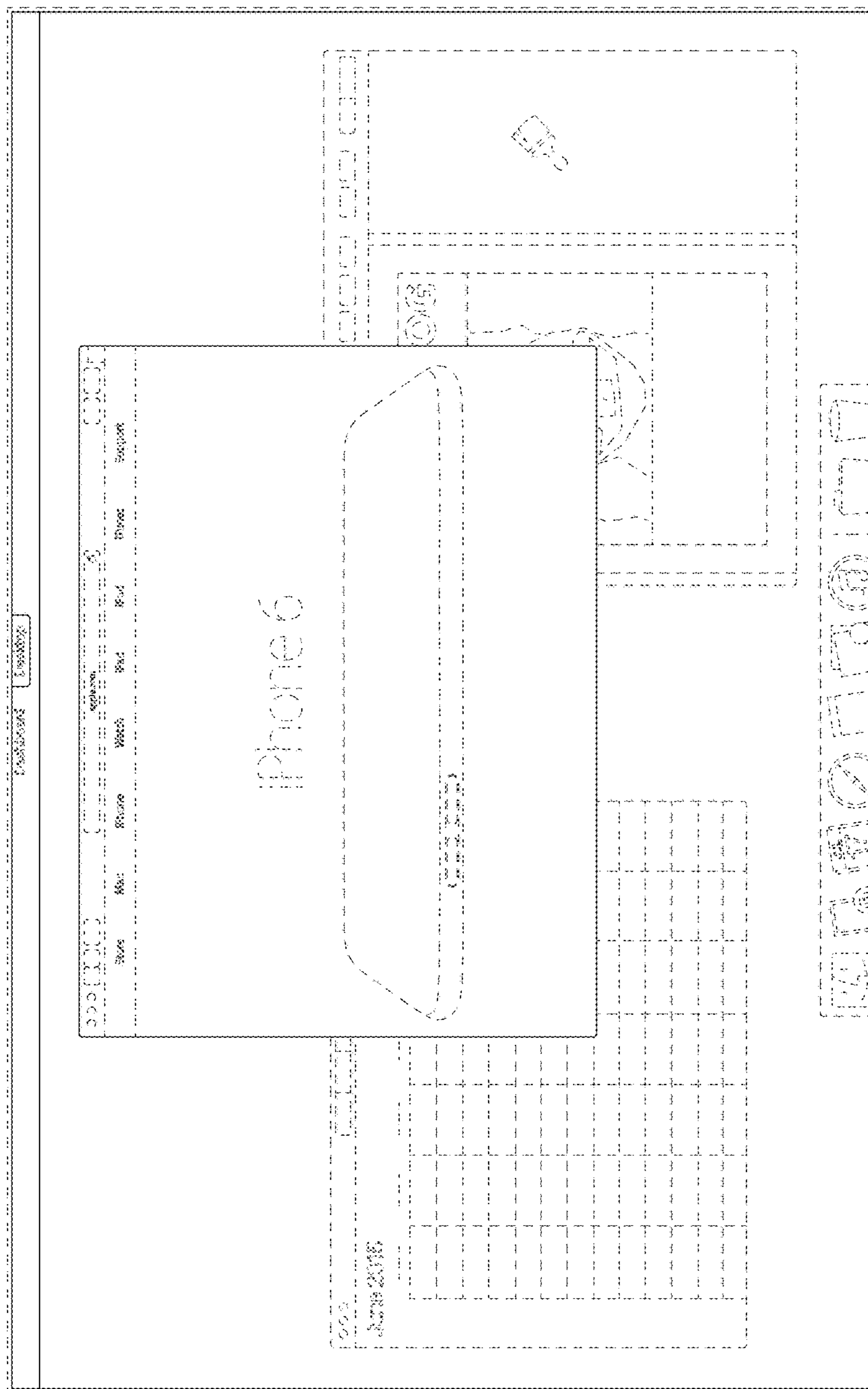

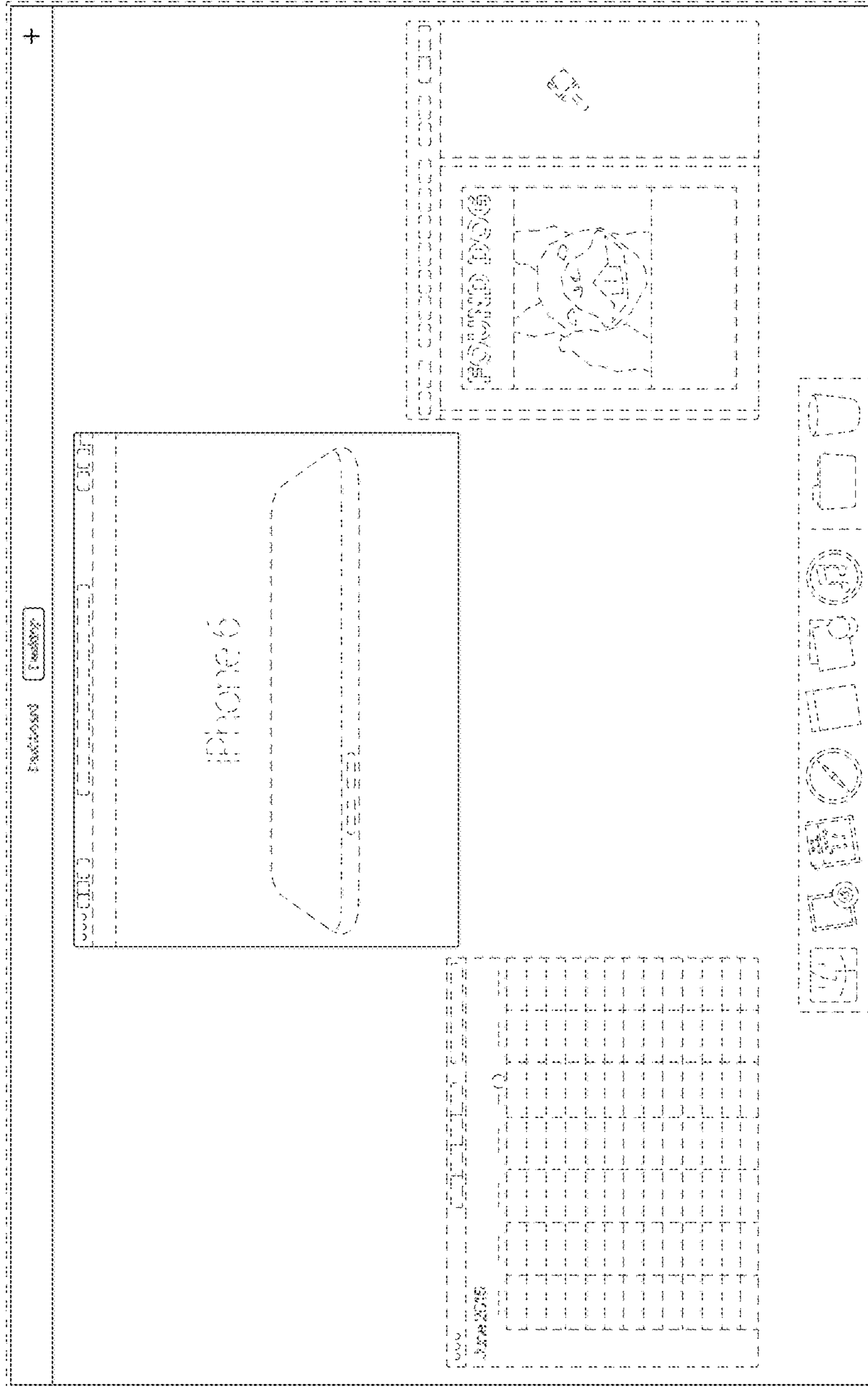

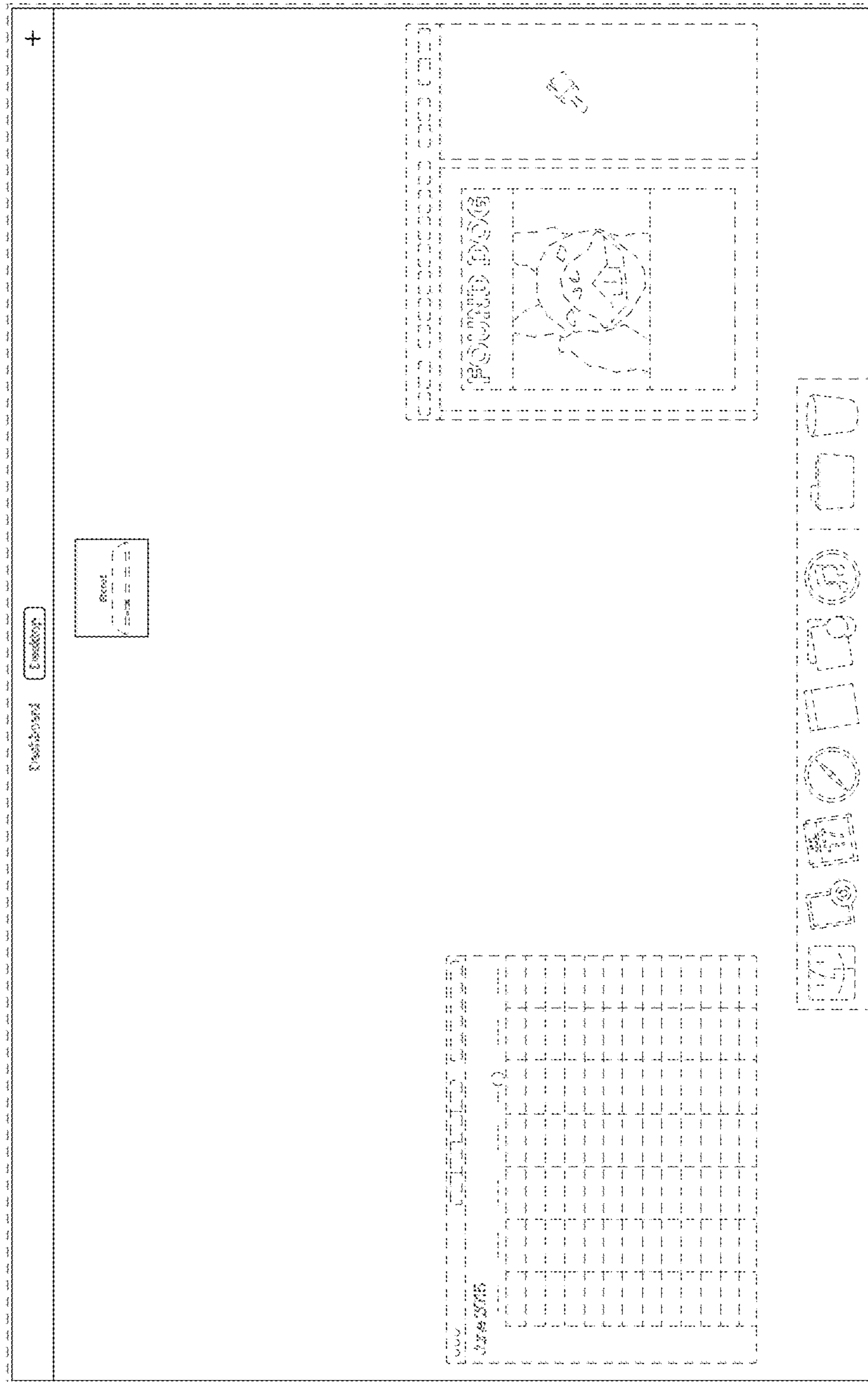

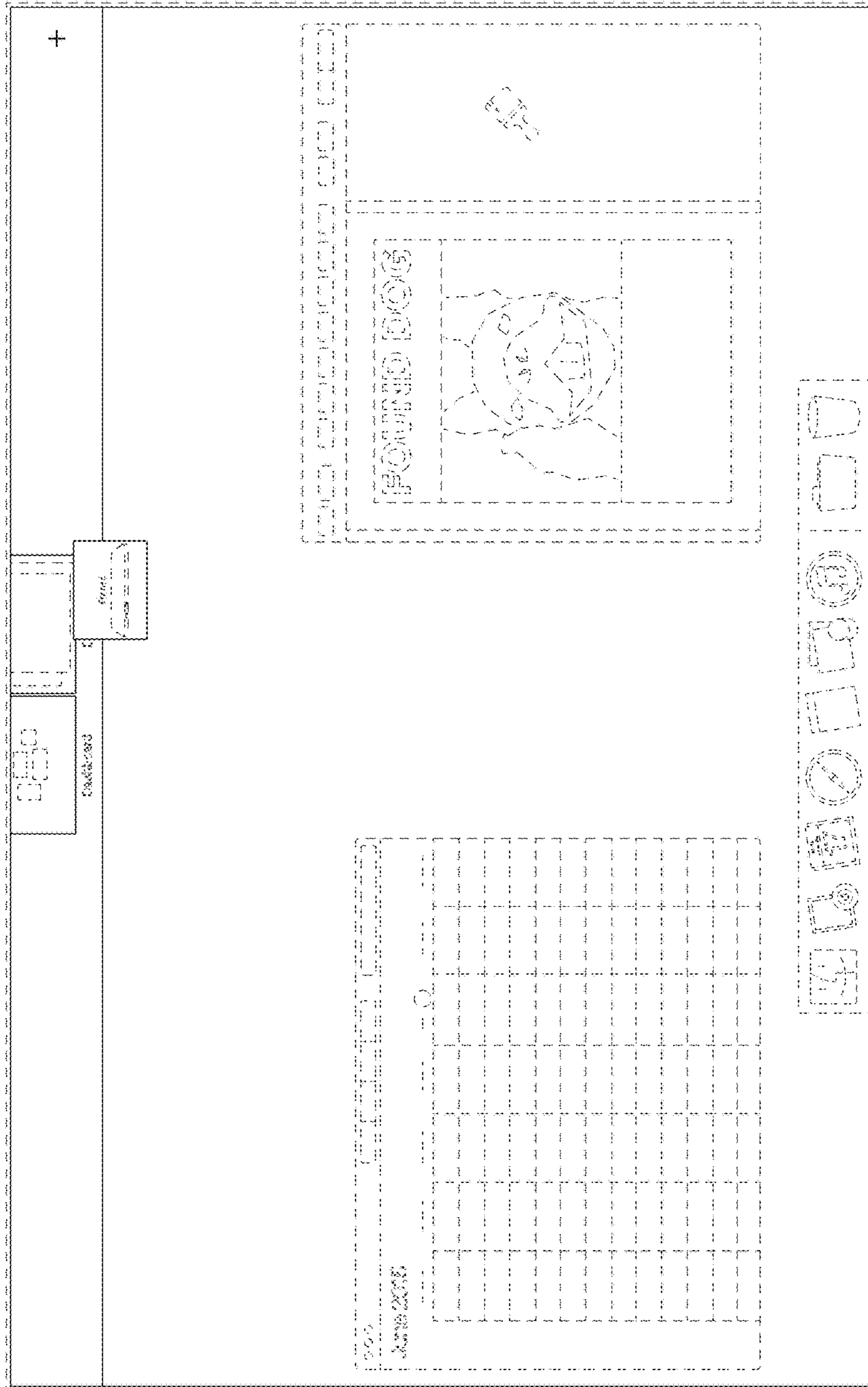
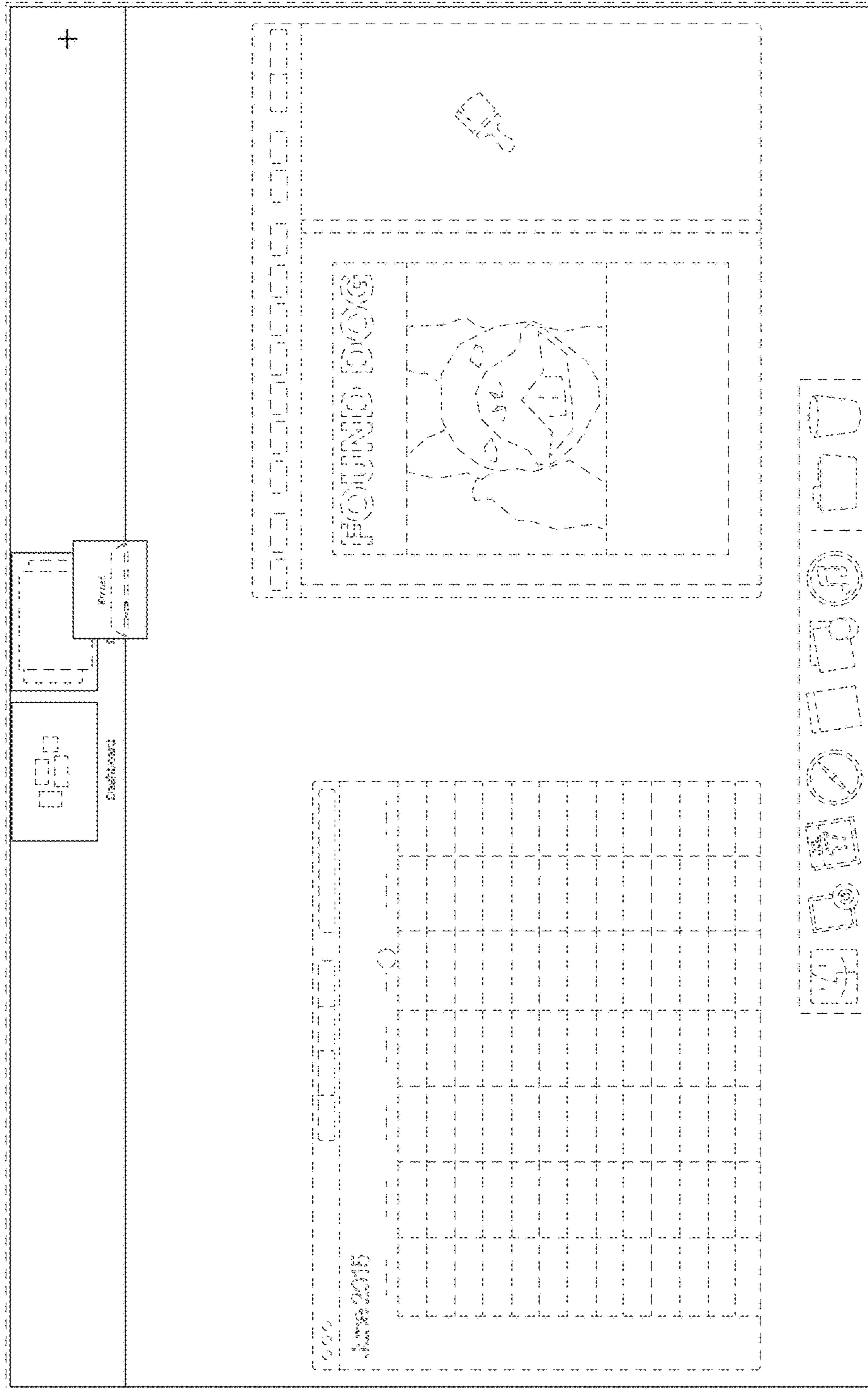

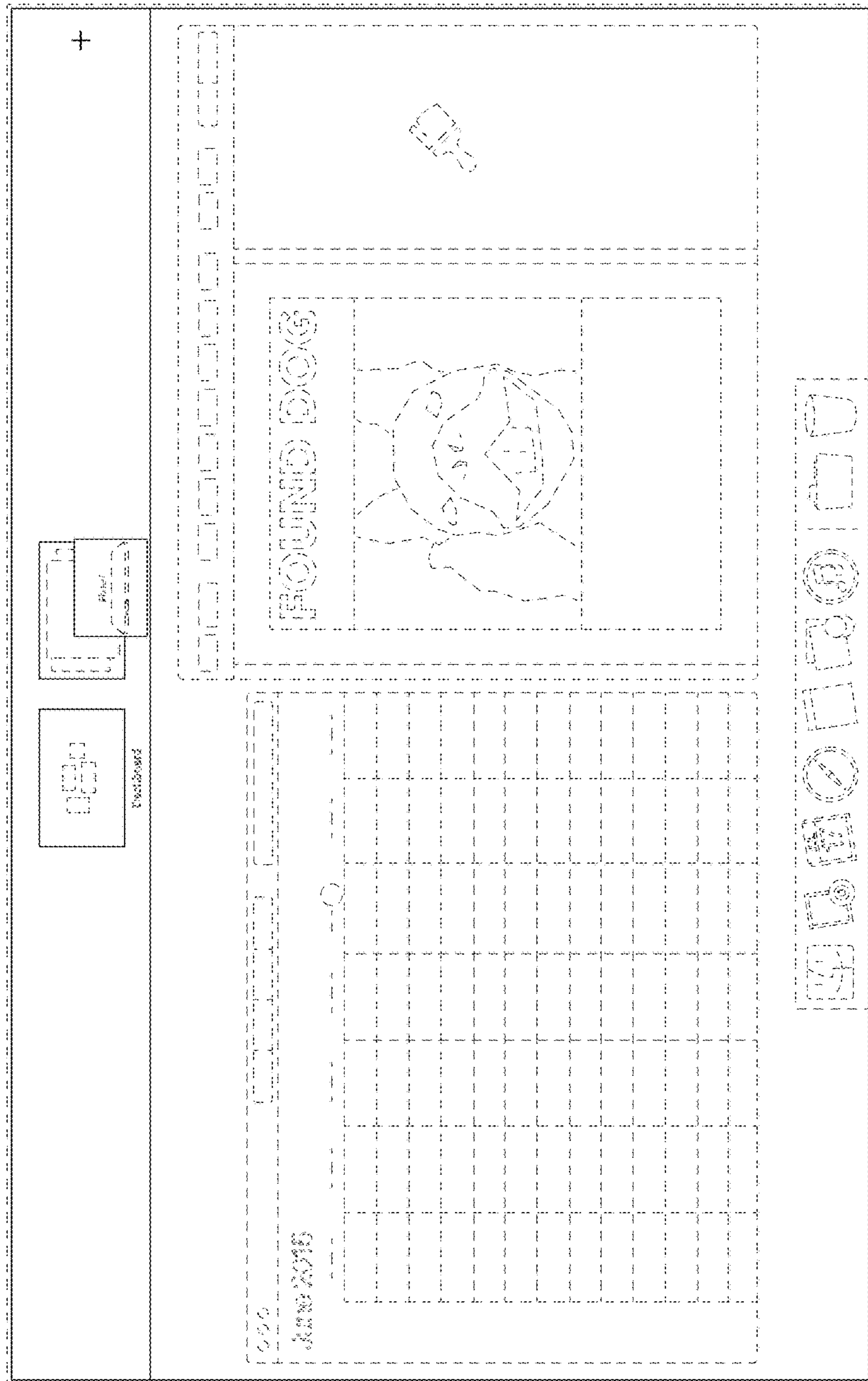
