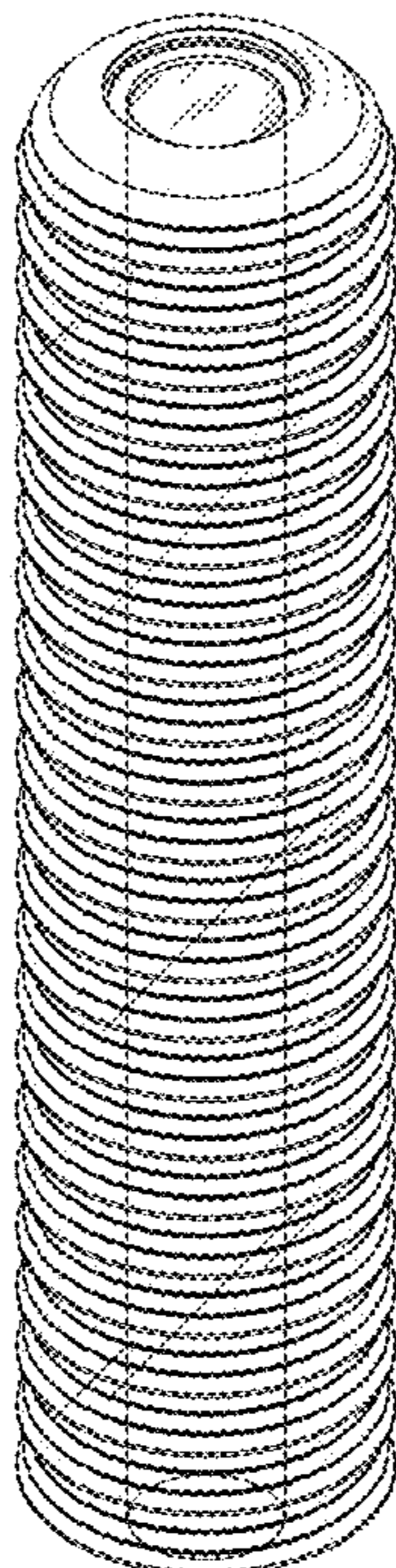
DESCRIPTION

1. Ceiling lamp

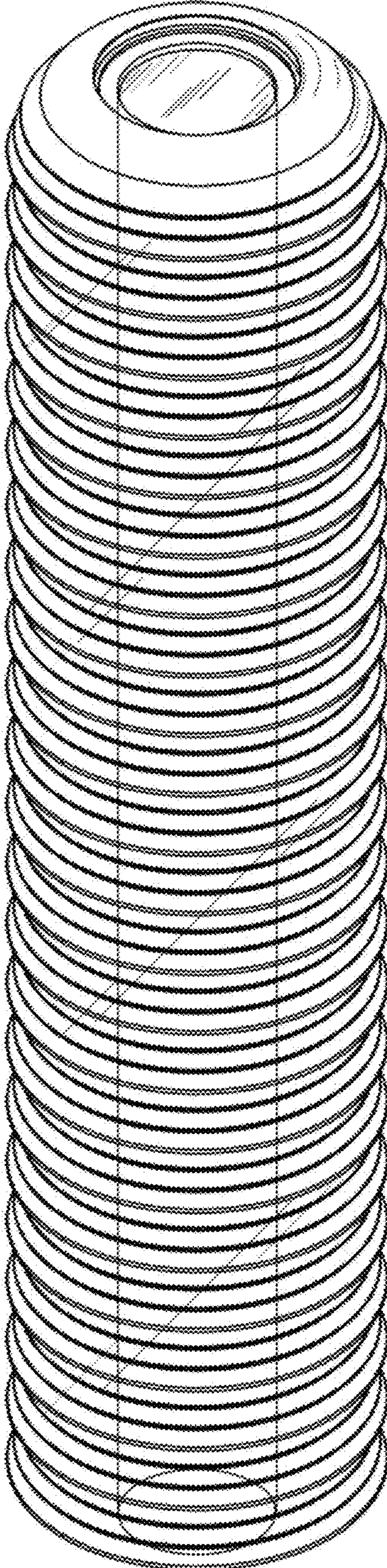
FIG. 1.1 is a perspective view;
FIG. 1.2 is a bottom perspective view;
FIG. 1.3 is a front elevation view;
FIG. 1.4 is a top plan view;
FIG. 1.5 is a bottom plan view.

The claimed design is a ceiling lamp to be hung; the lamp comprises an outer transparent diffuser and lighting cylindrical body located into the diffuser.

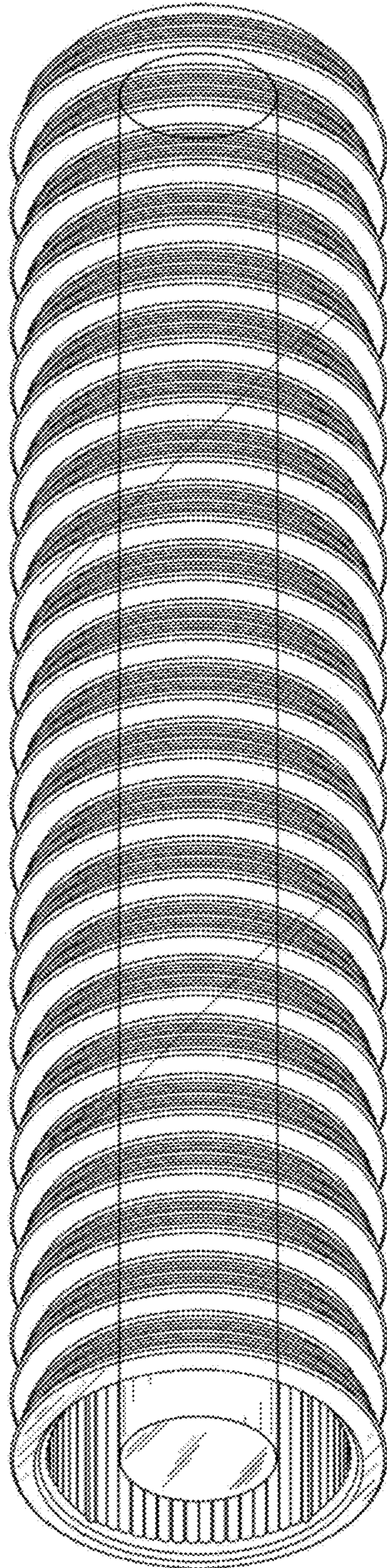

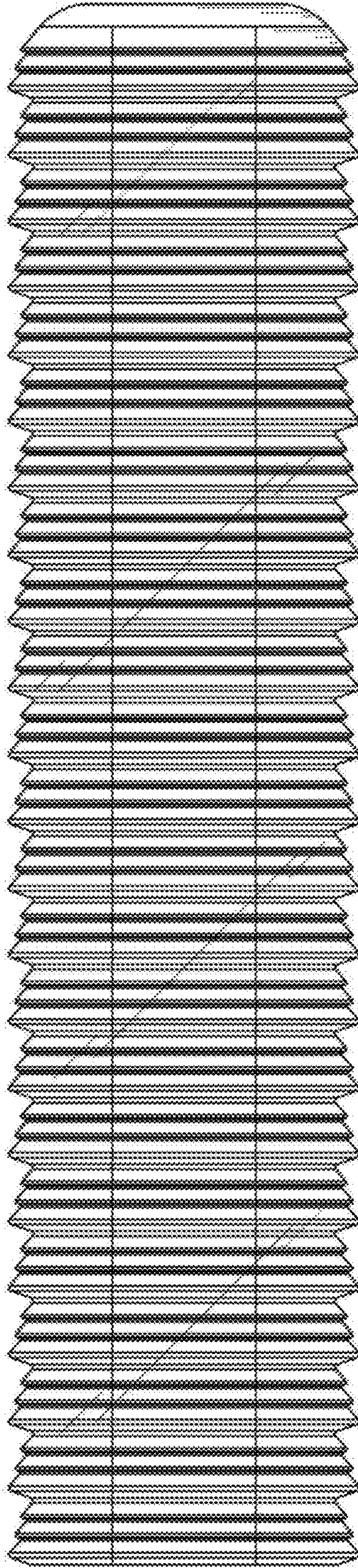

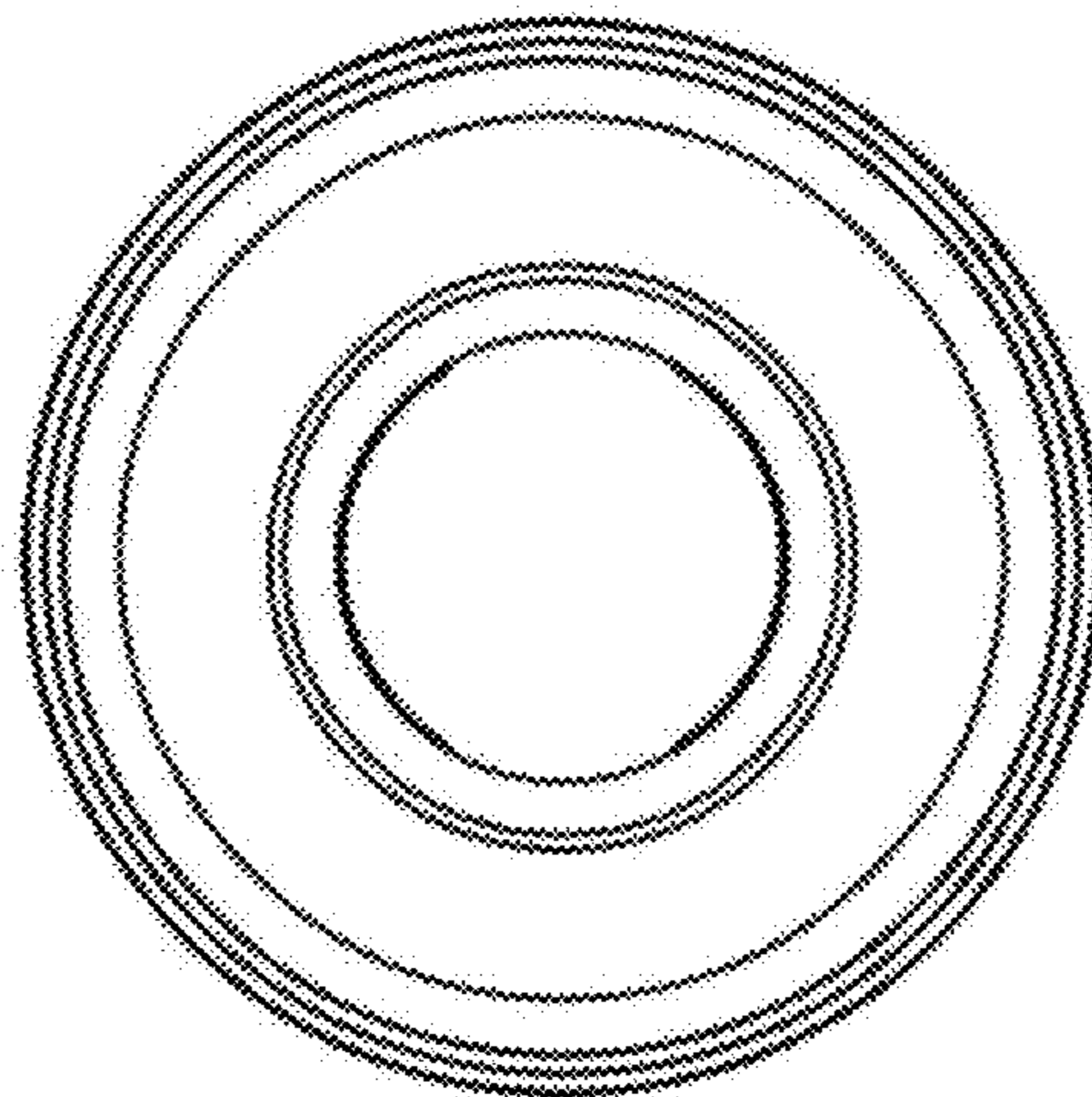
