DESCRIPTION

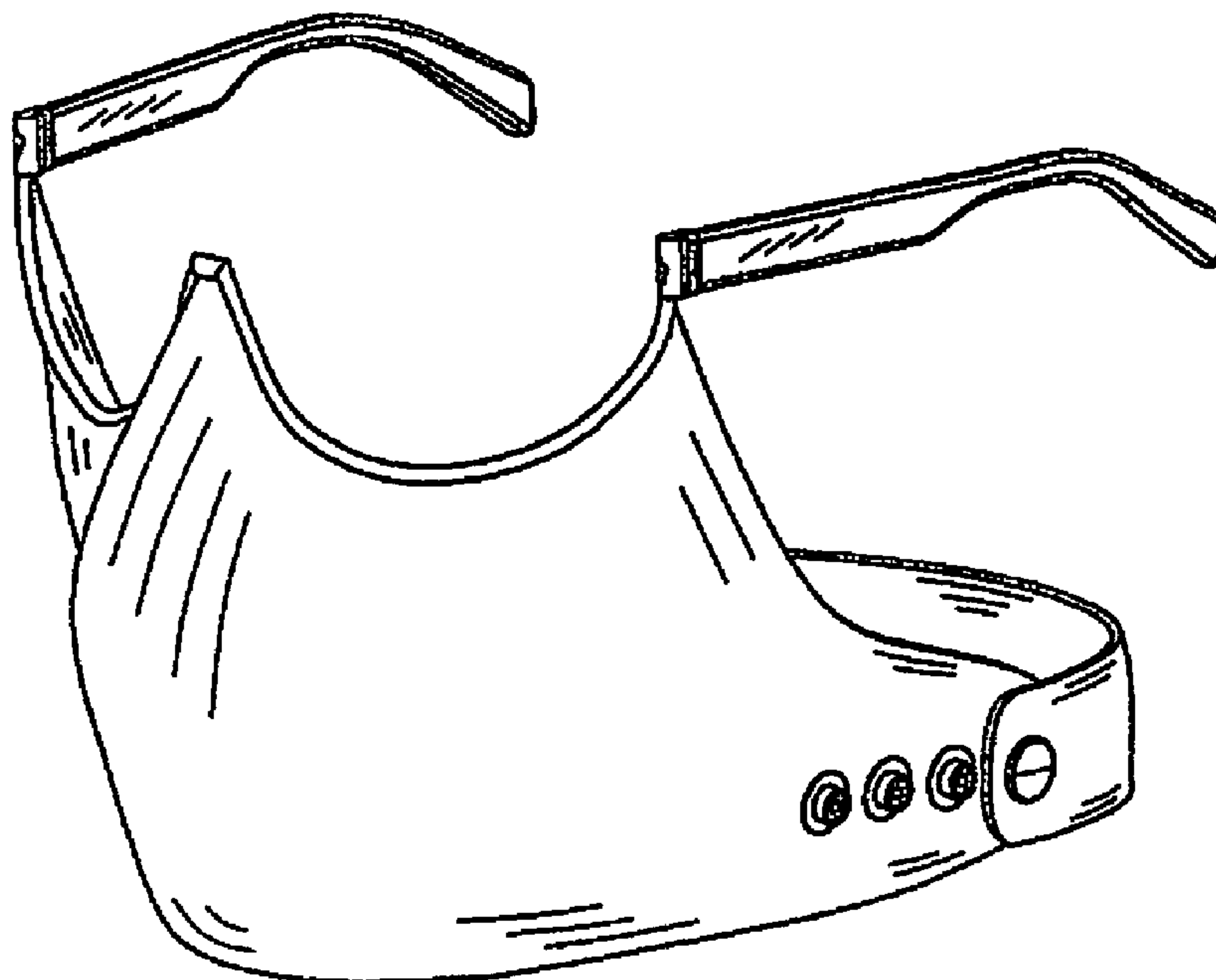
FIG. 1 is a perspective view of a stylized mask showing my new design;

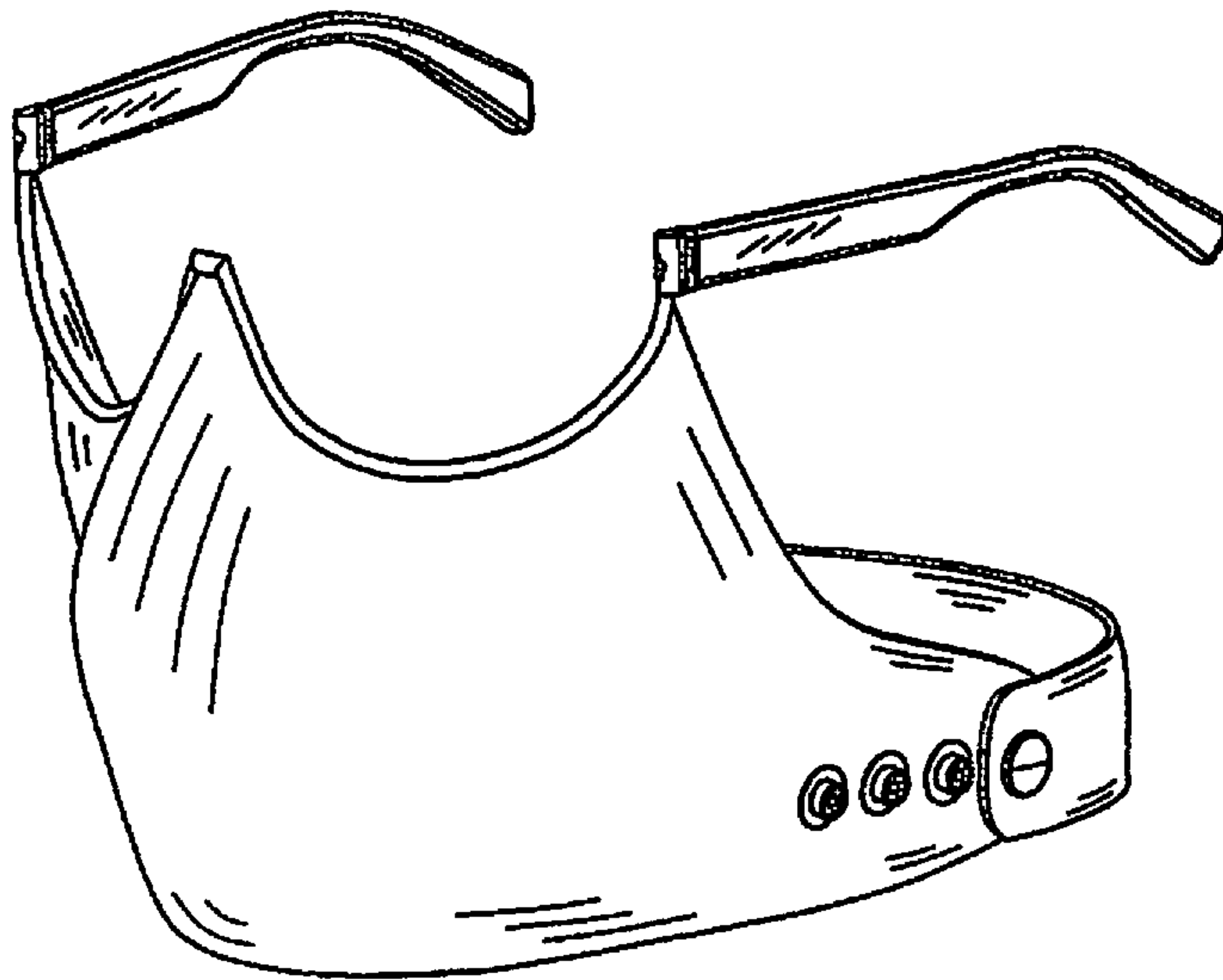

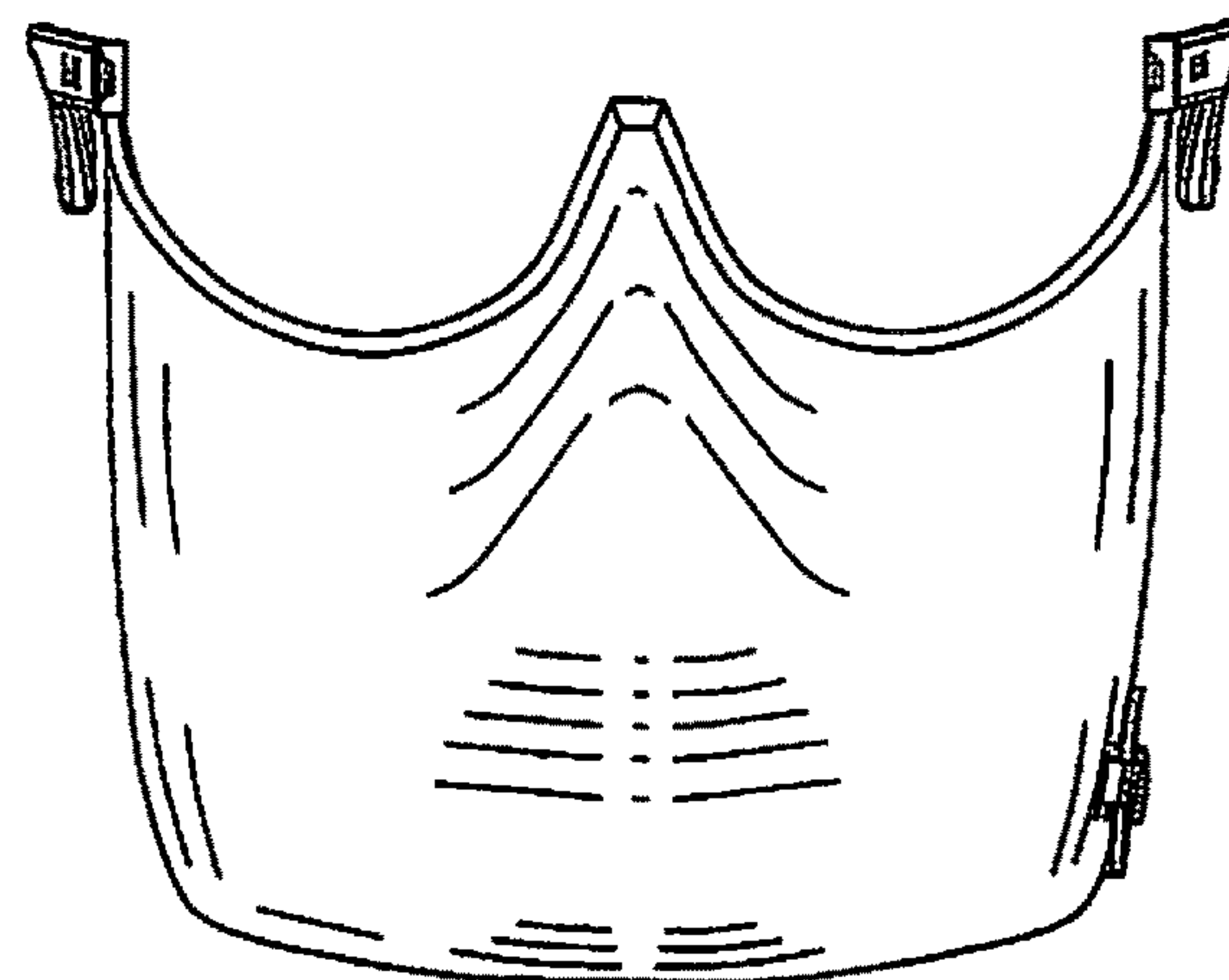
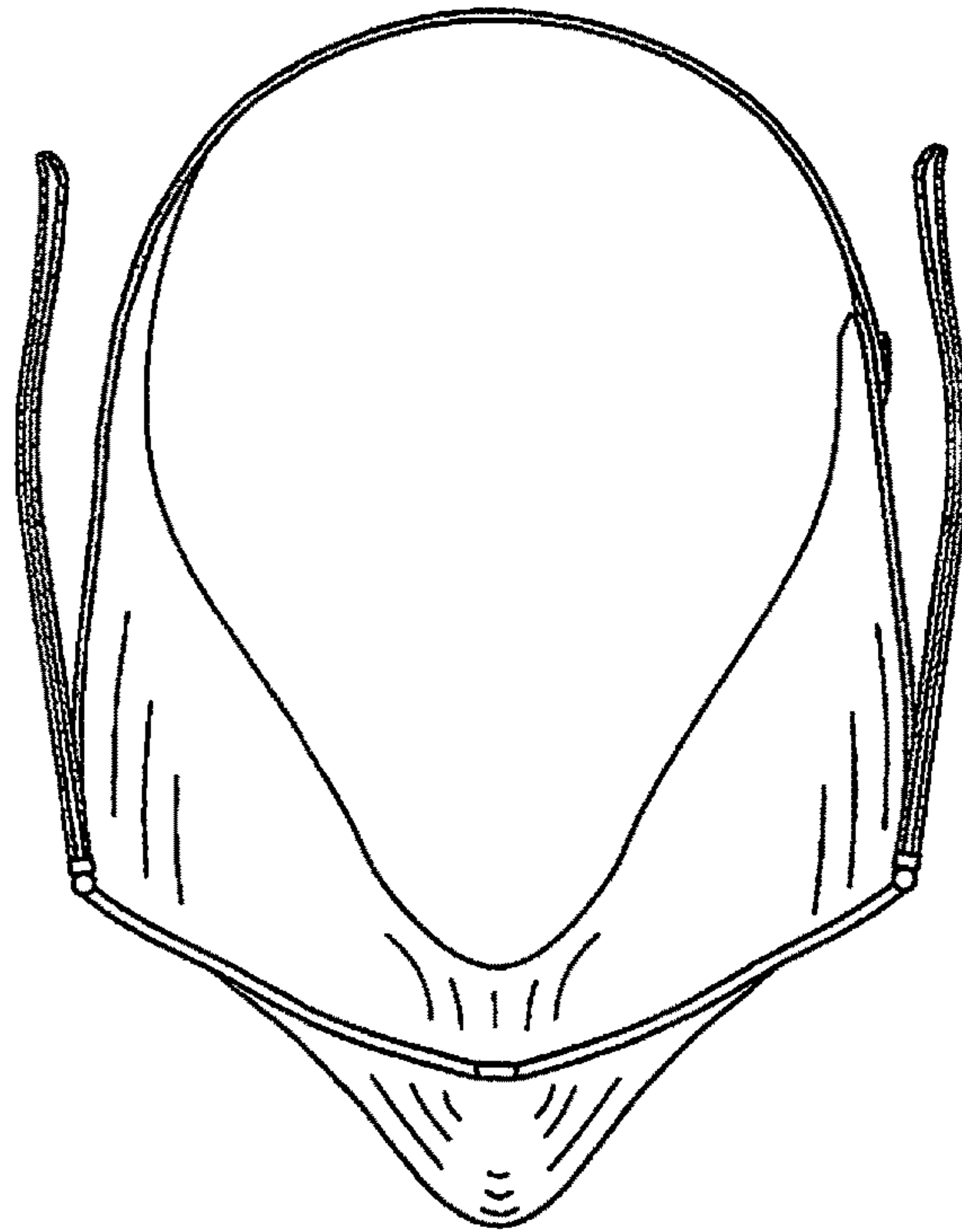

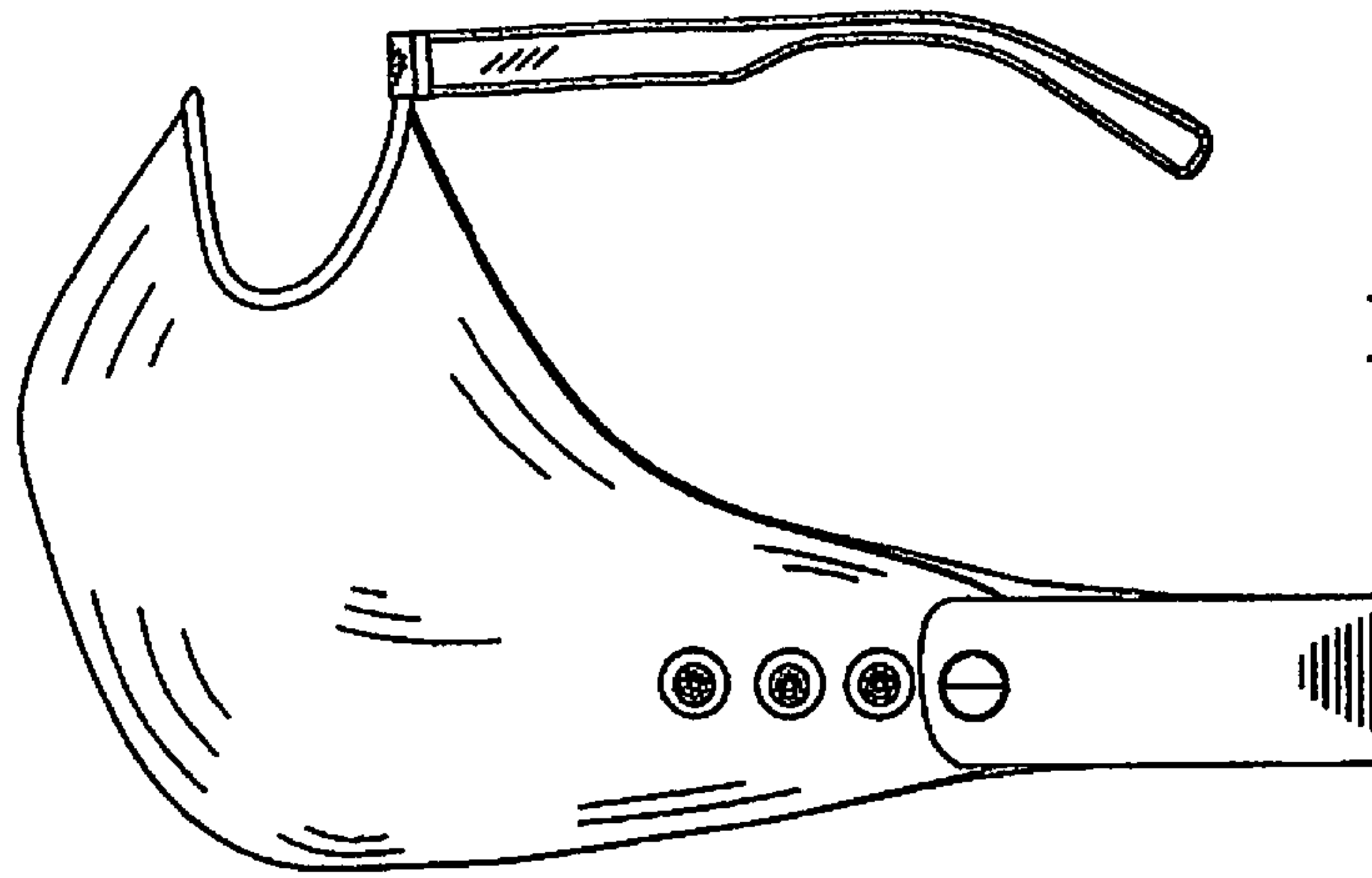

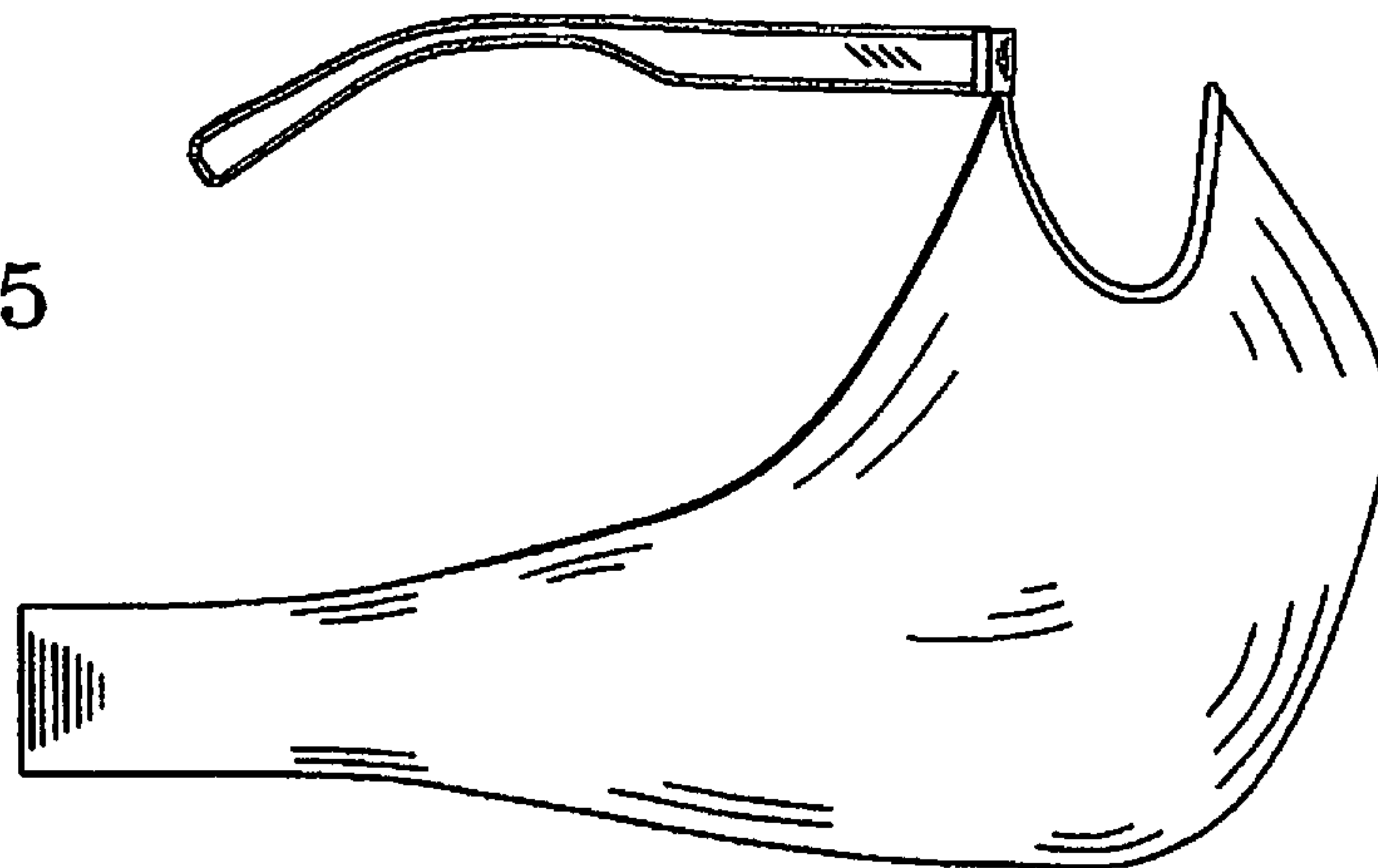

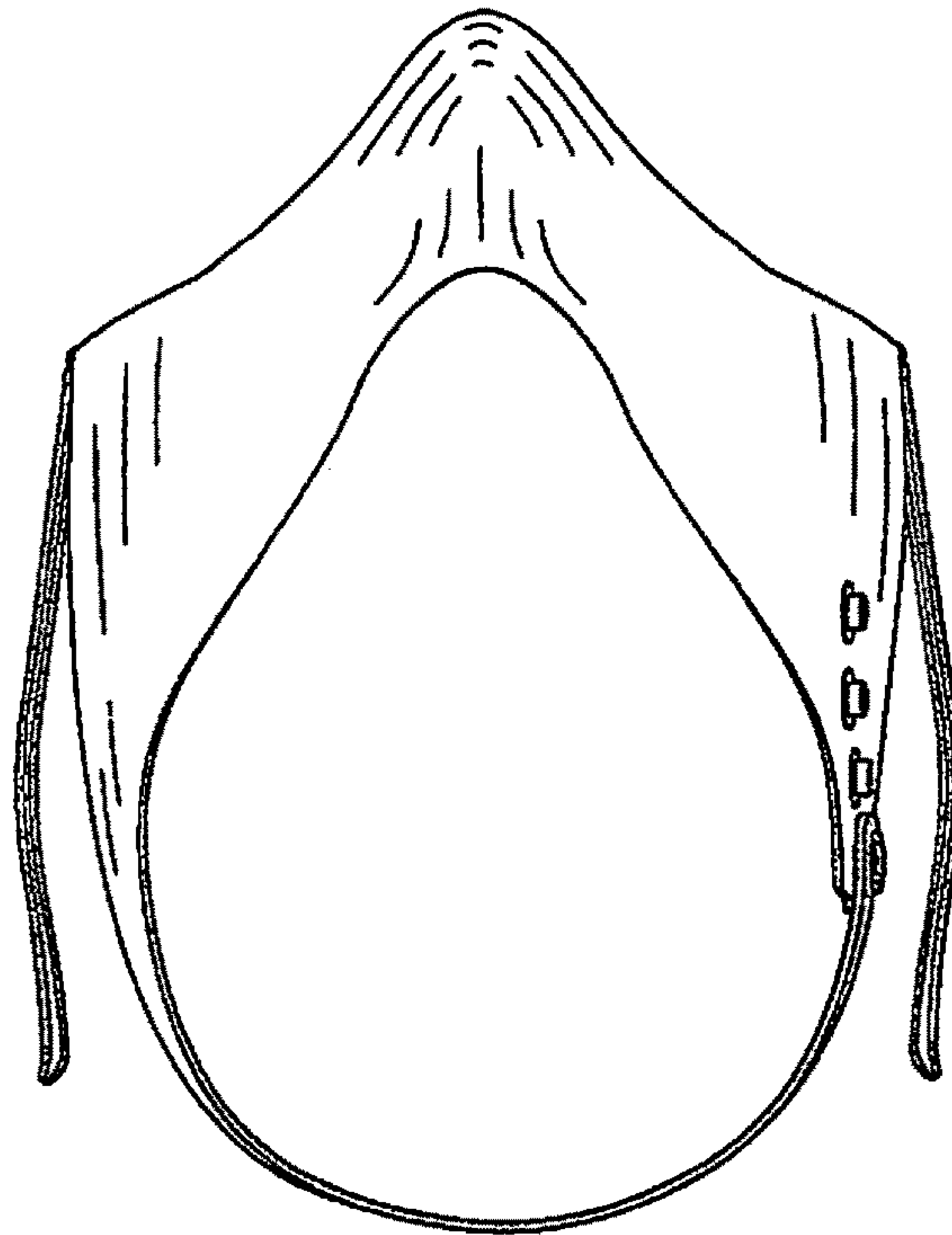
