**DESCRIPTION**

FIG. 1 is a perspective view of a sight glass of welding mask showing my new design;

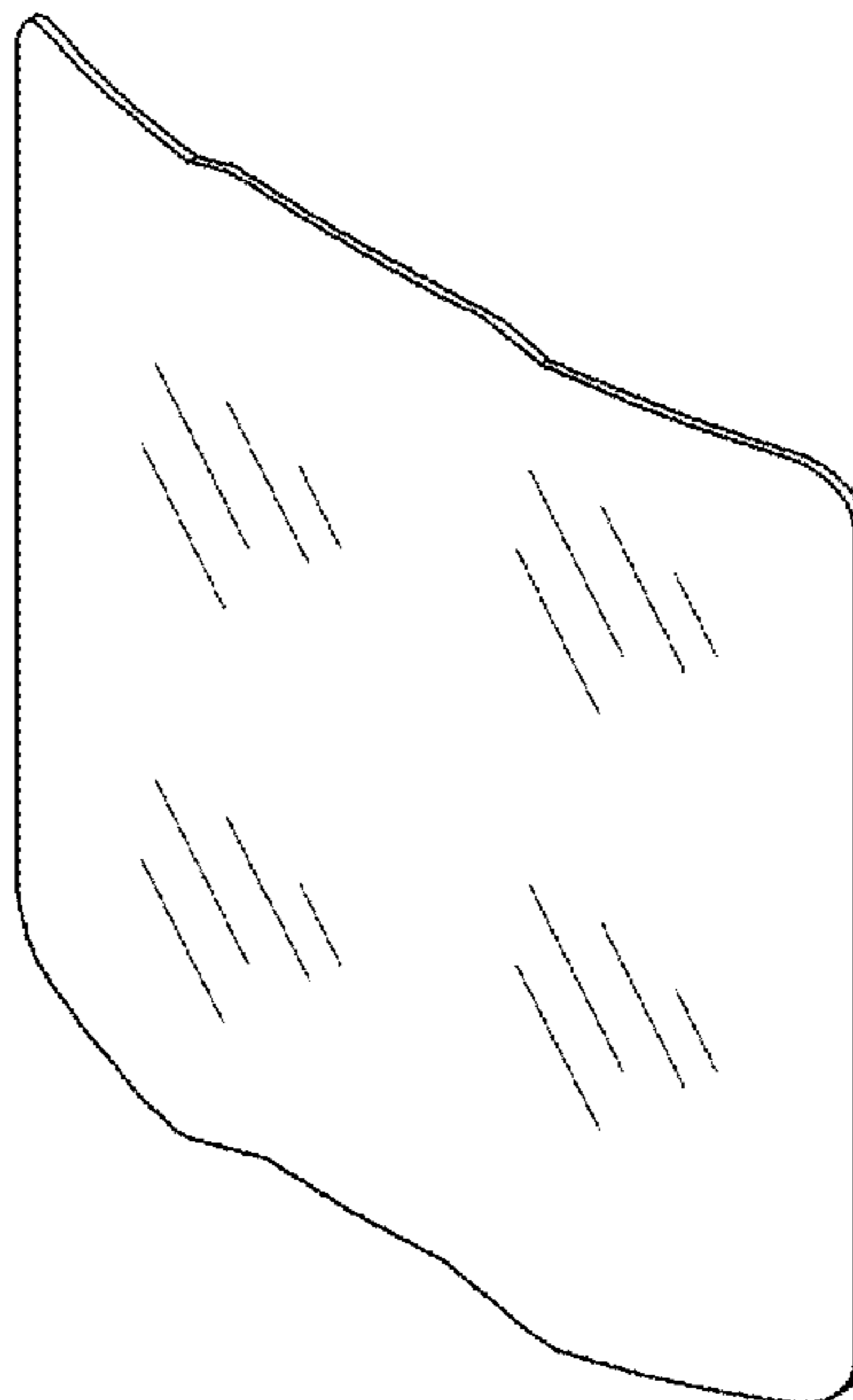

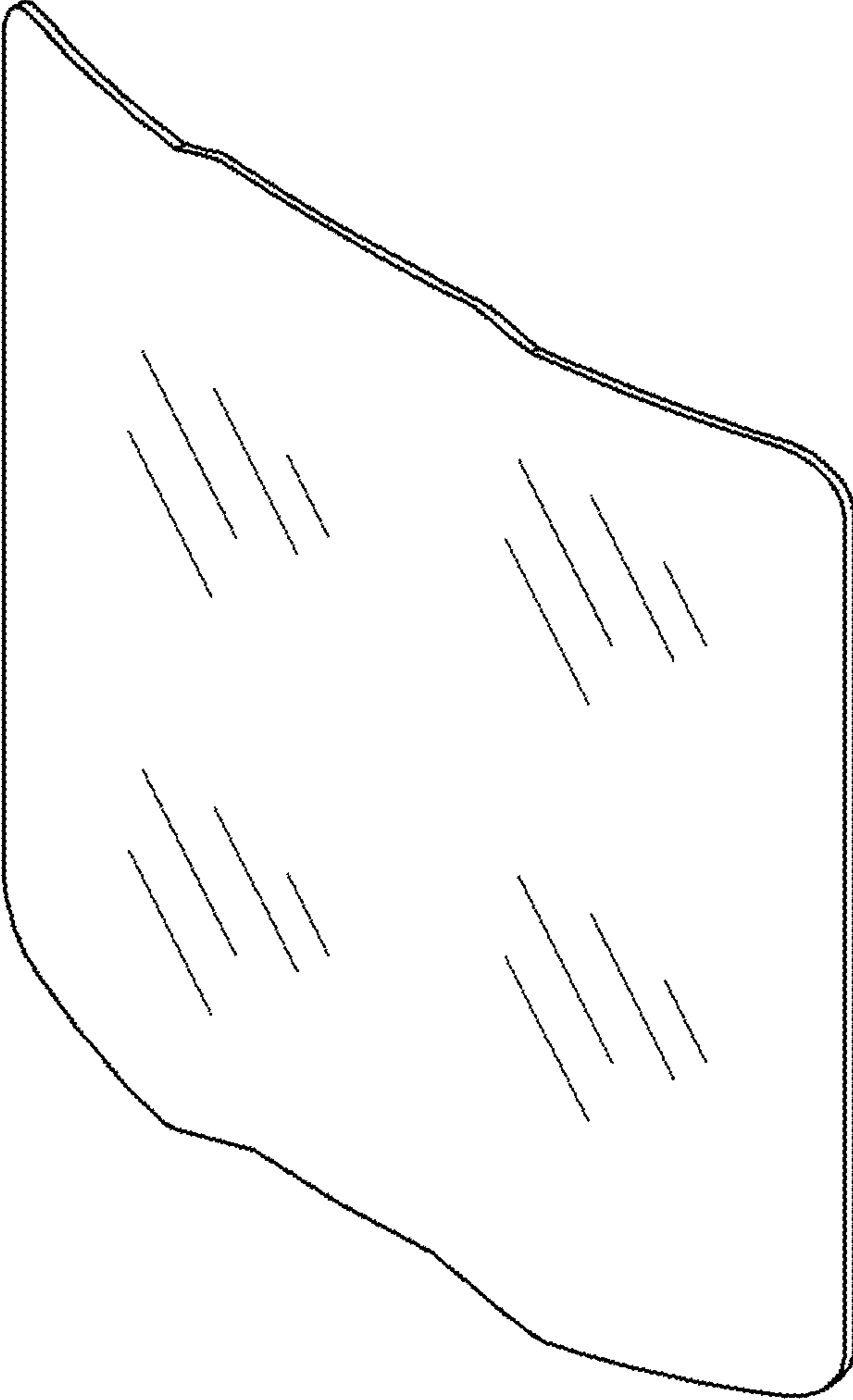

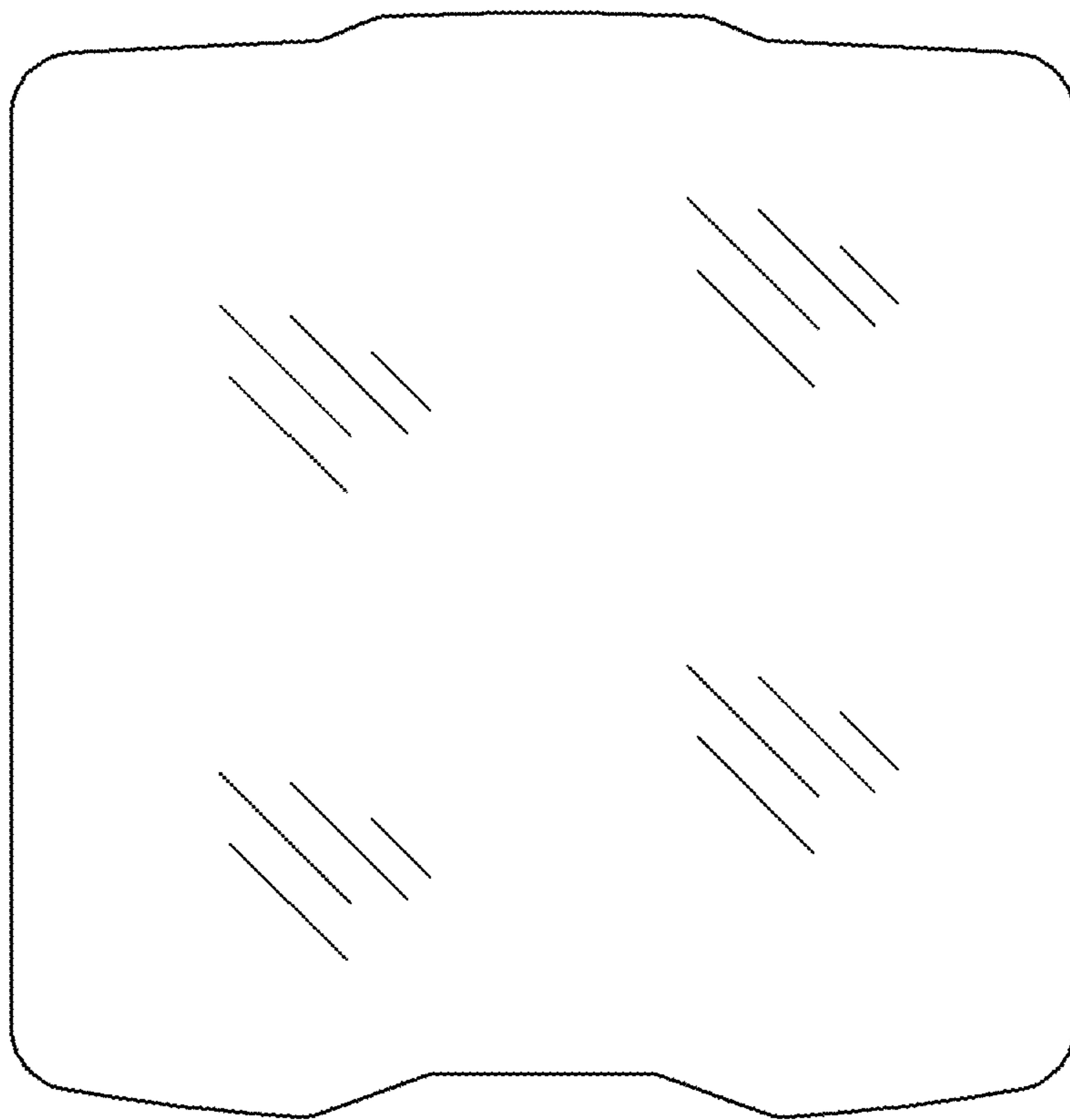

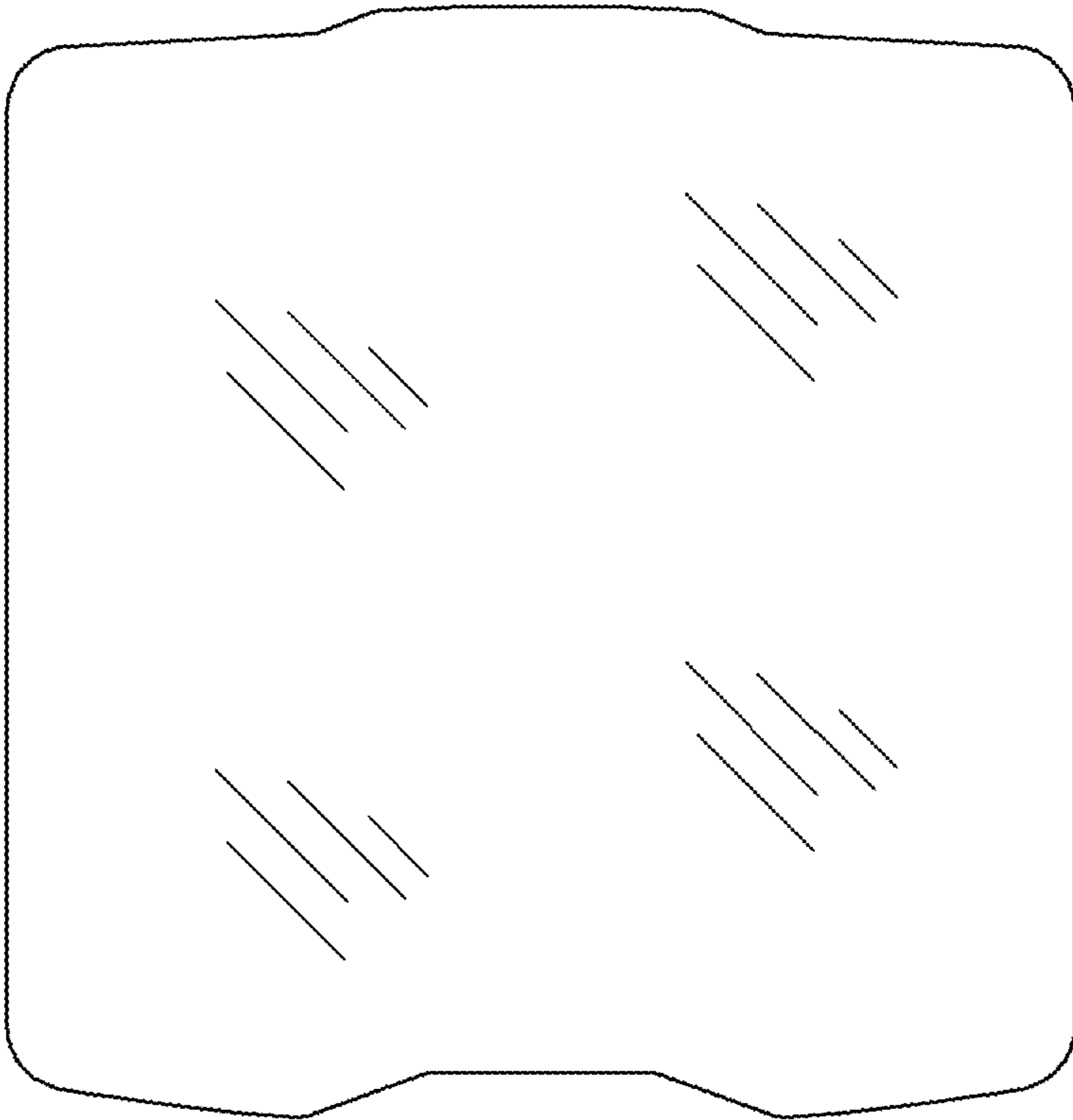

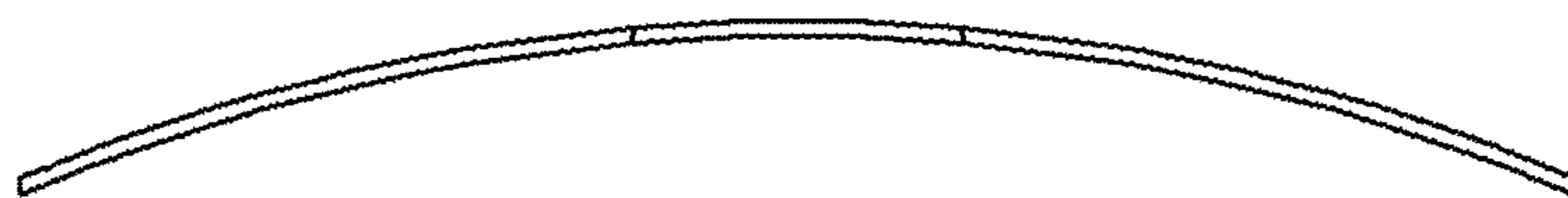
