FIG. 3 is a front perspective view thereof; in a closed position.

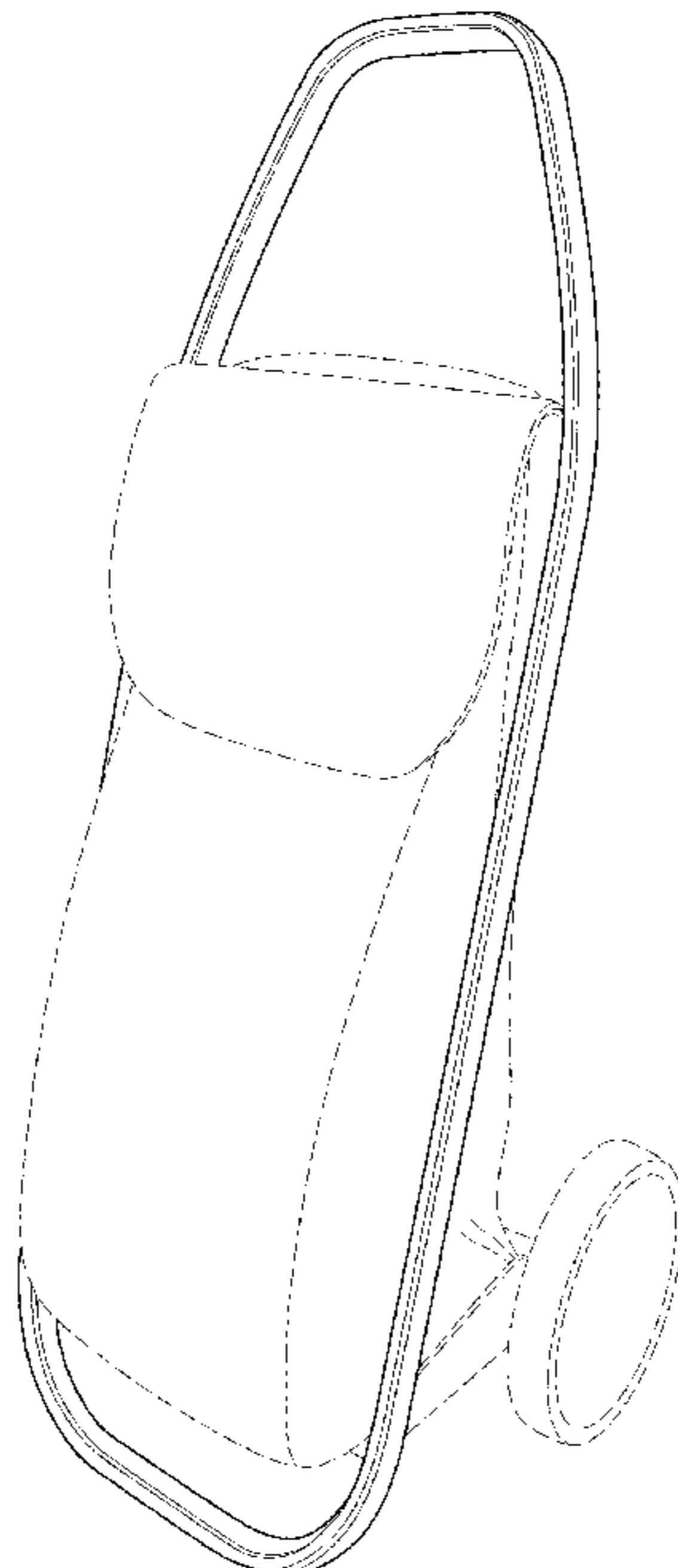
The broken lines shown in the figures are included for the purpose of illustrating portions of the shopping trolley and form no part of the claimed design.

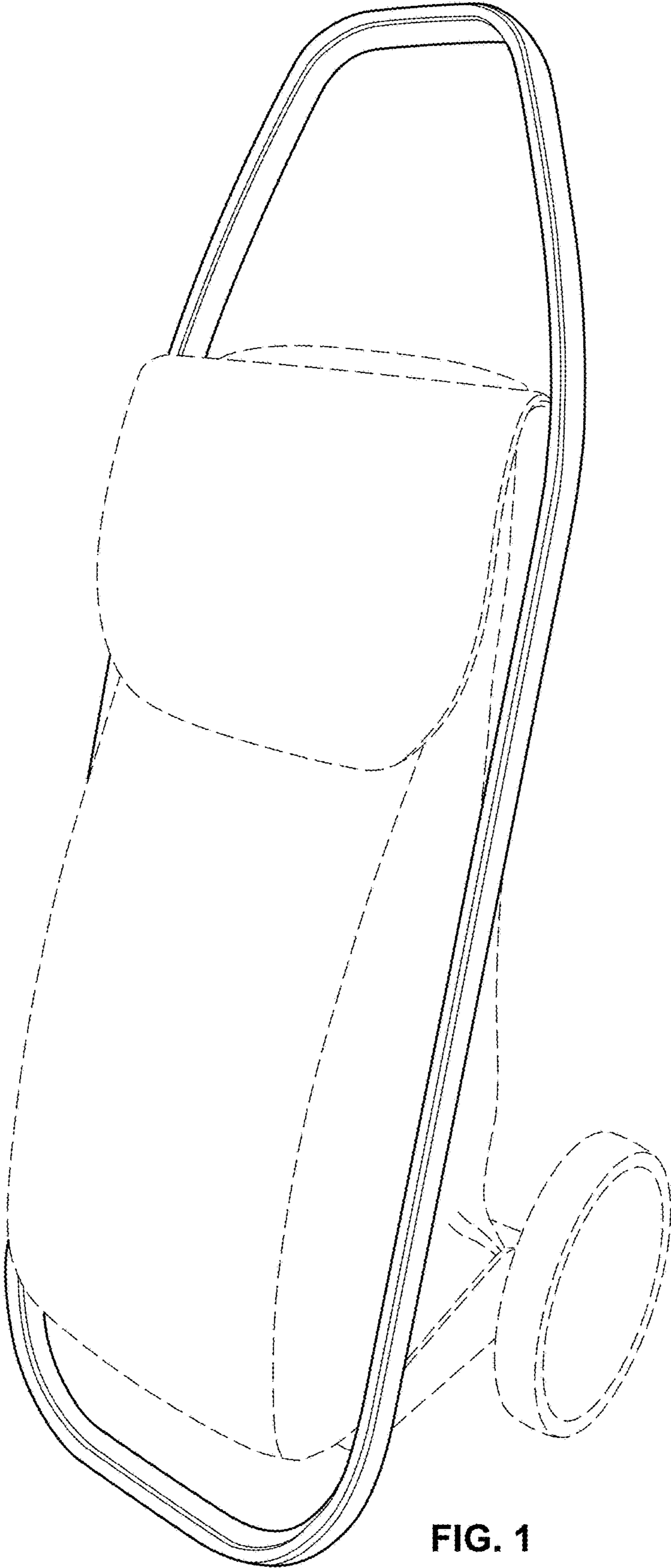

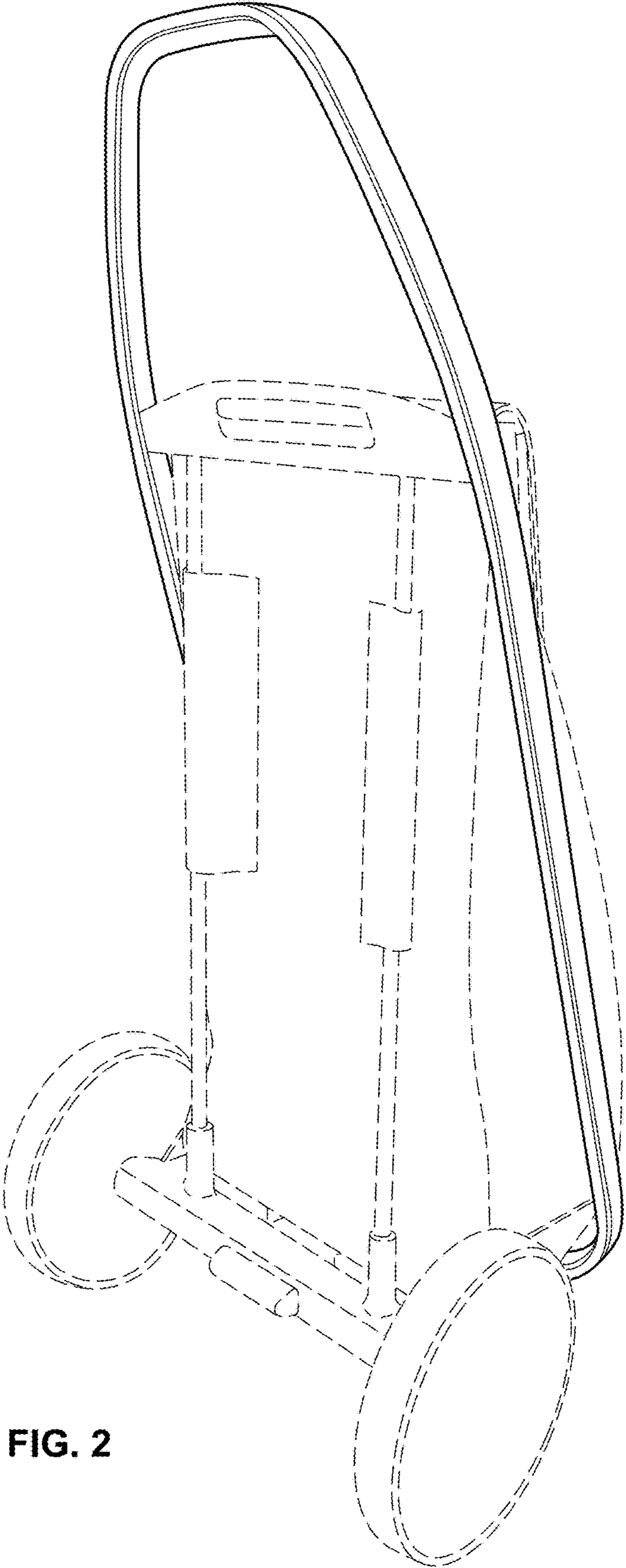

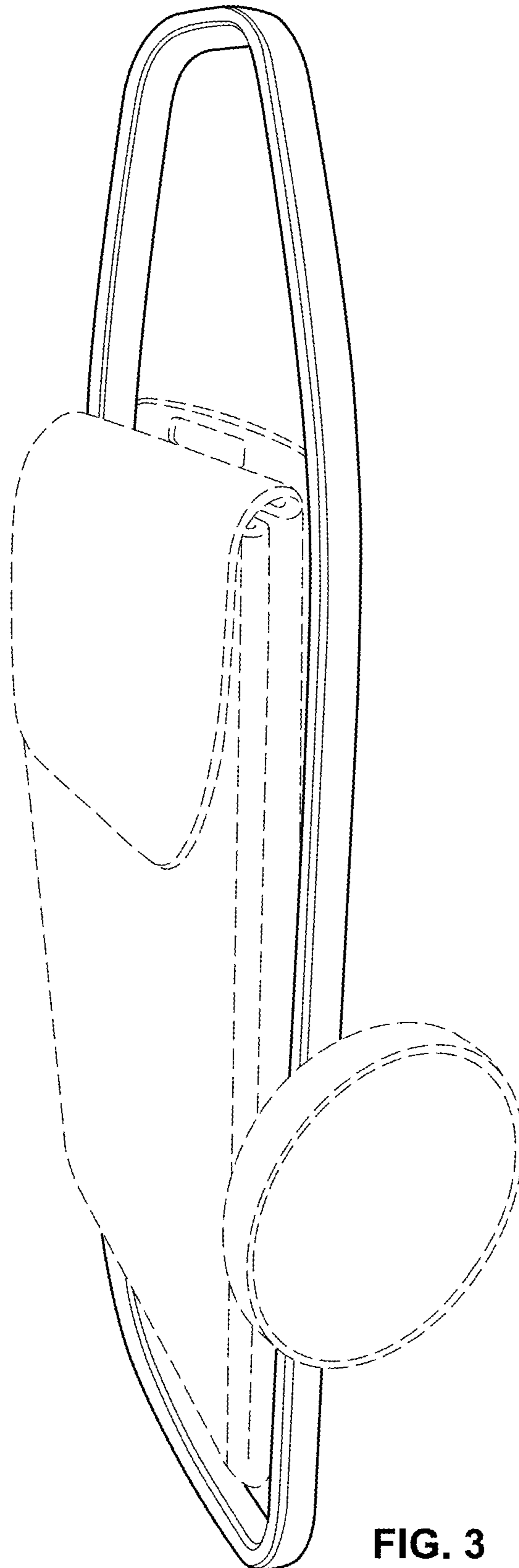
