FIG. 4 is a side view of the cleaning brush.

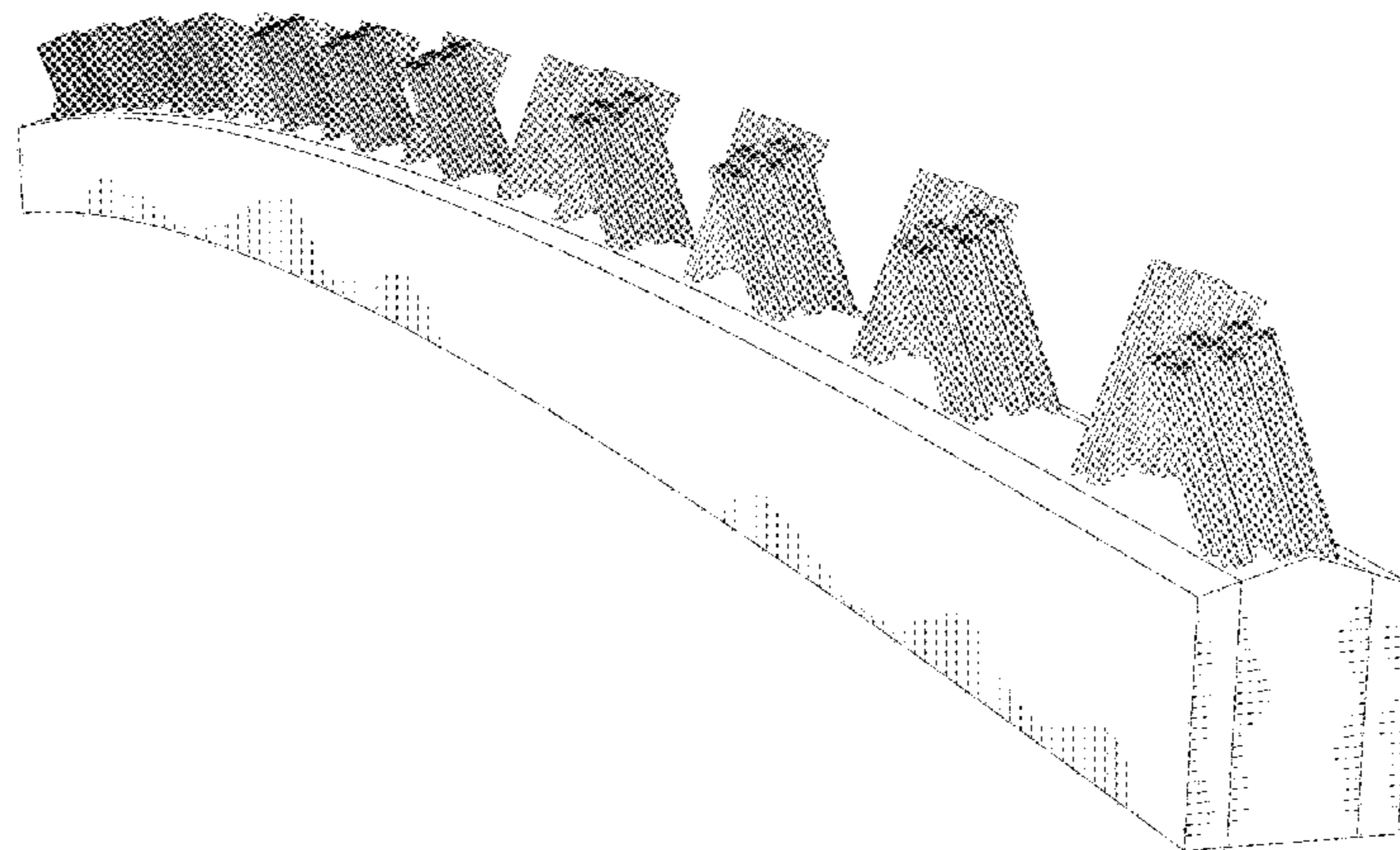
FIG. 5 is a front view of the cleaning brush.

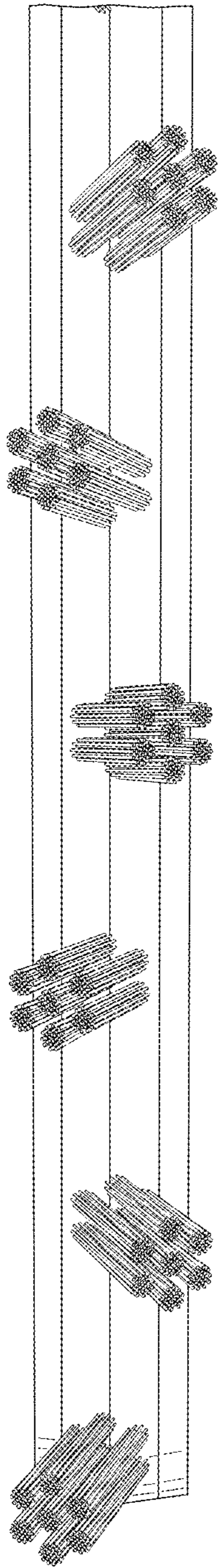

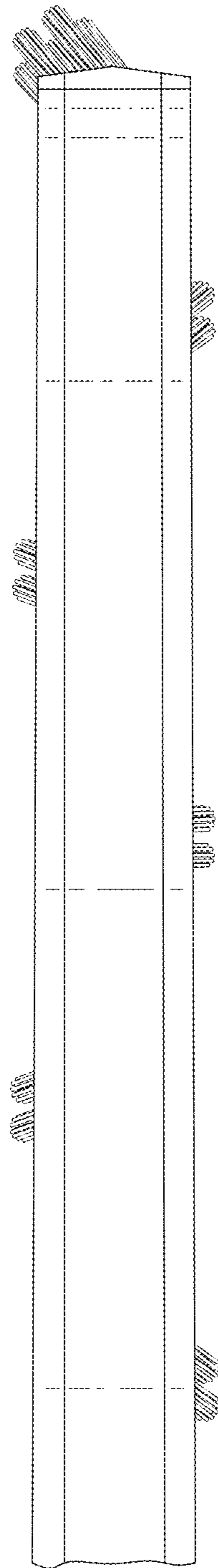

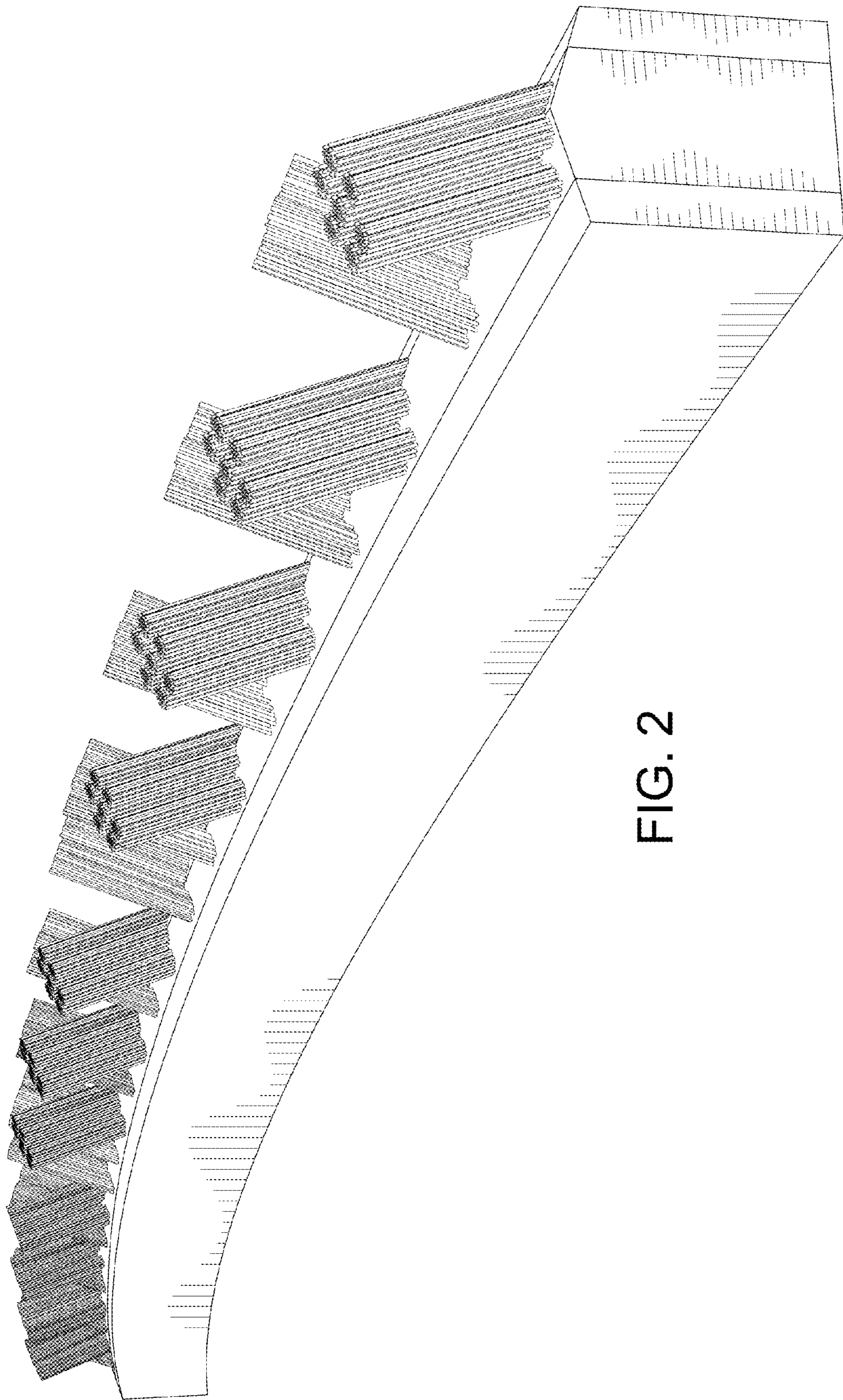

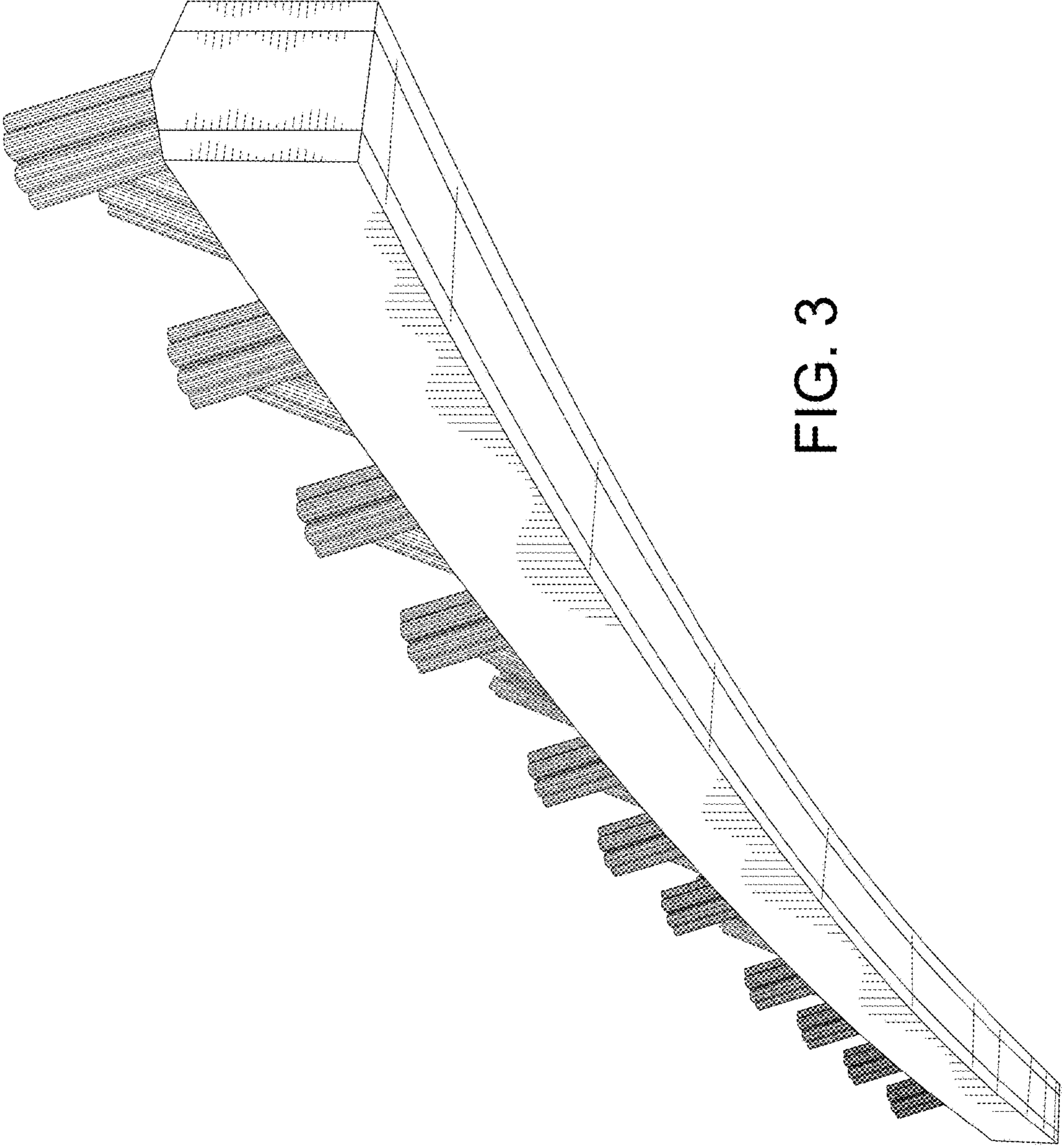

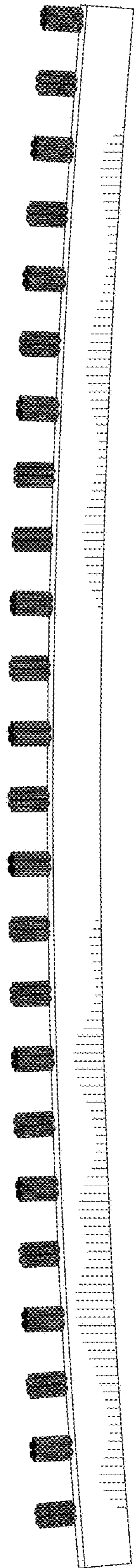

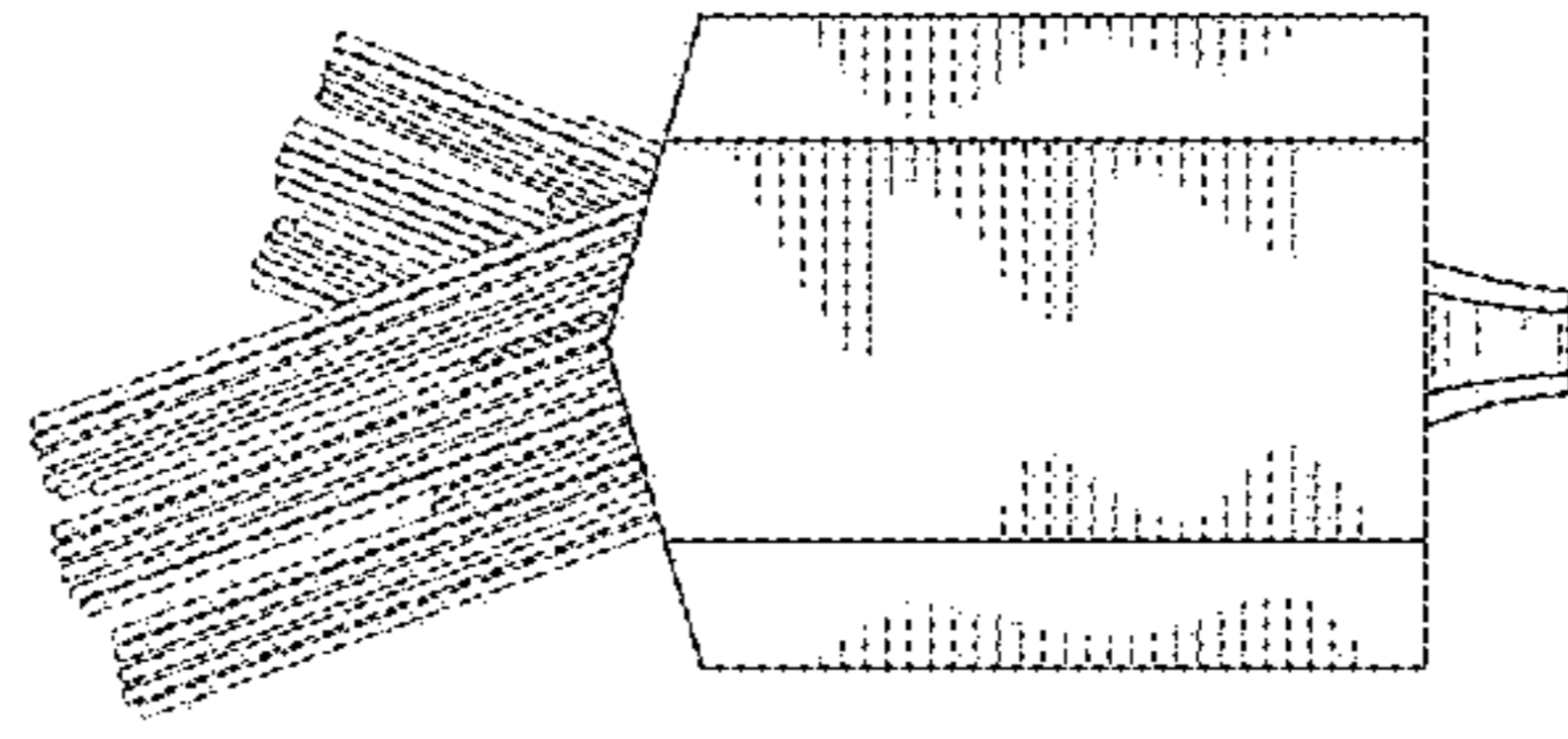
