**DESCRIPTION**

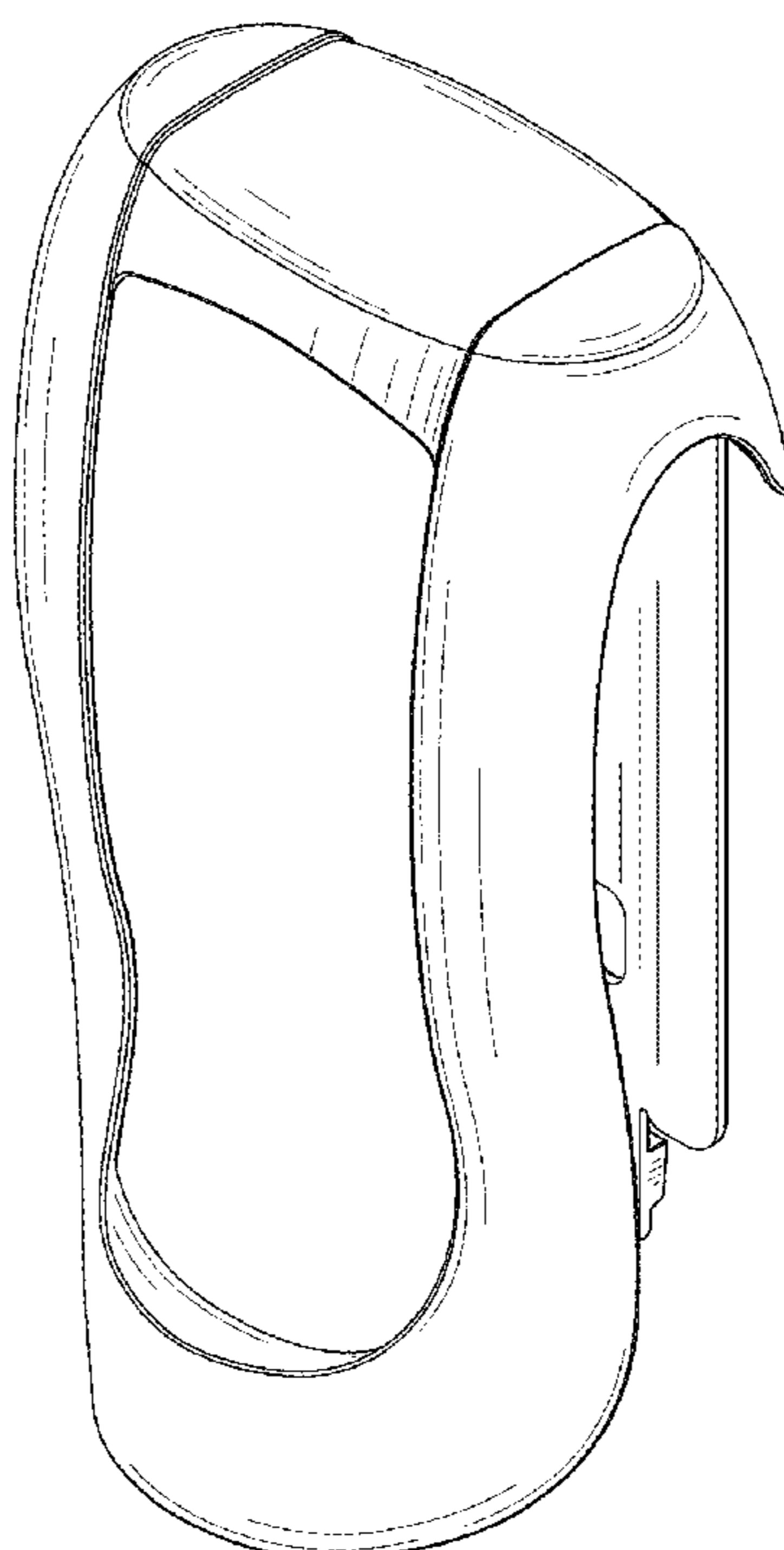
FIG. 1 is a front perspective view of a dispenser handle showing our new design;

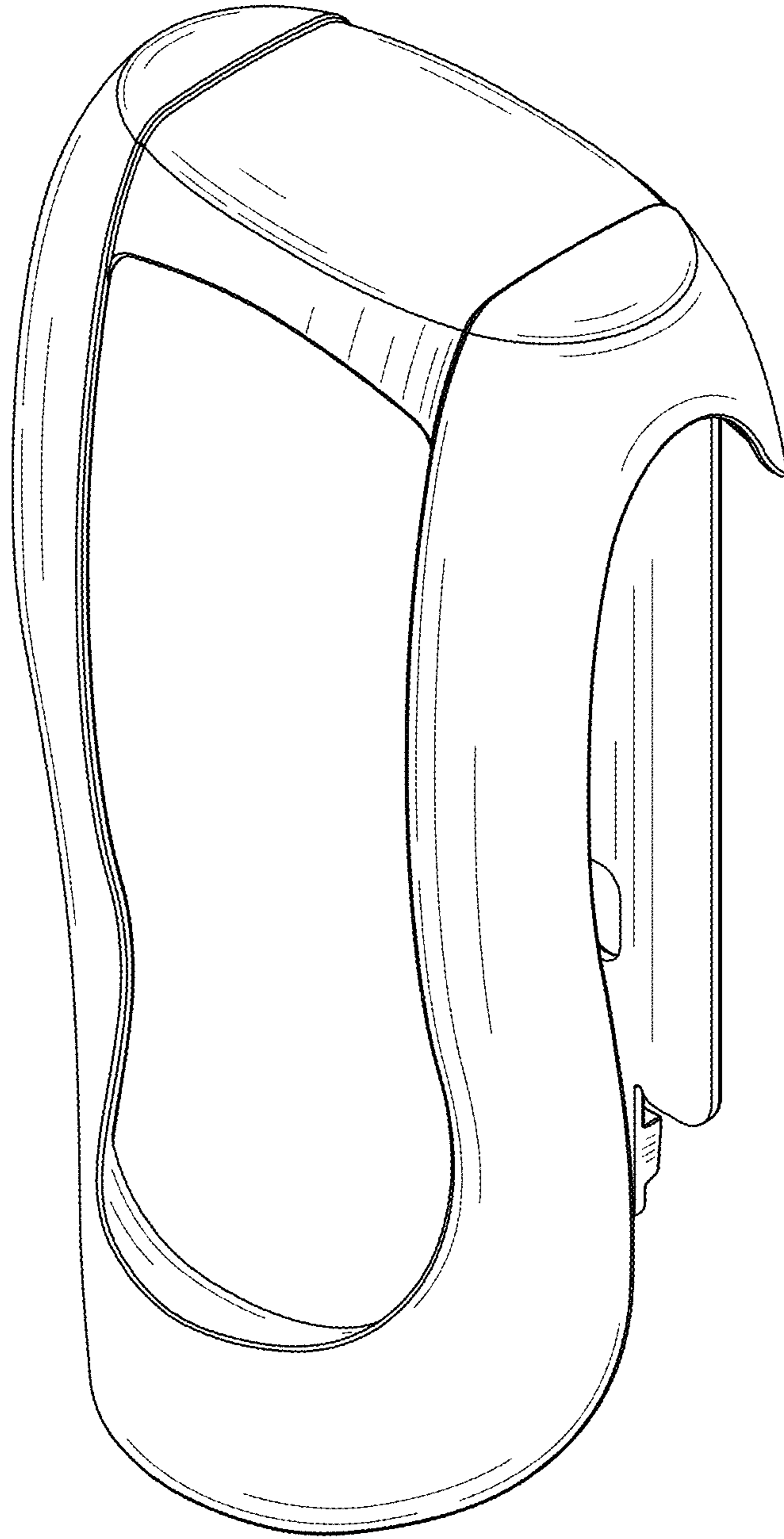

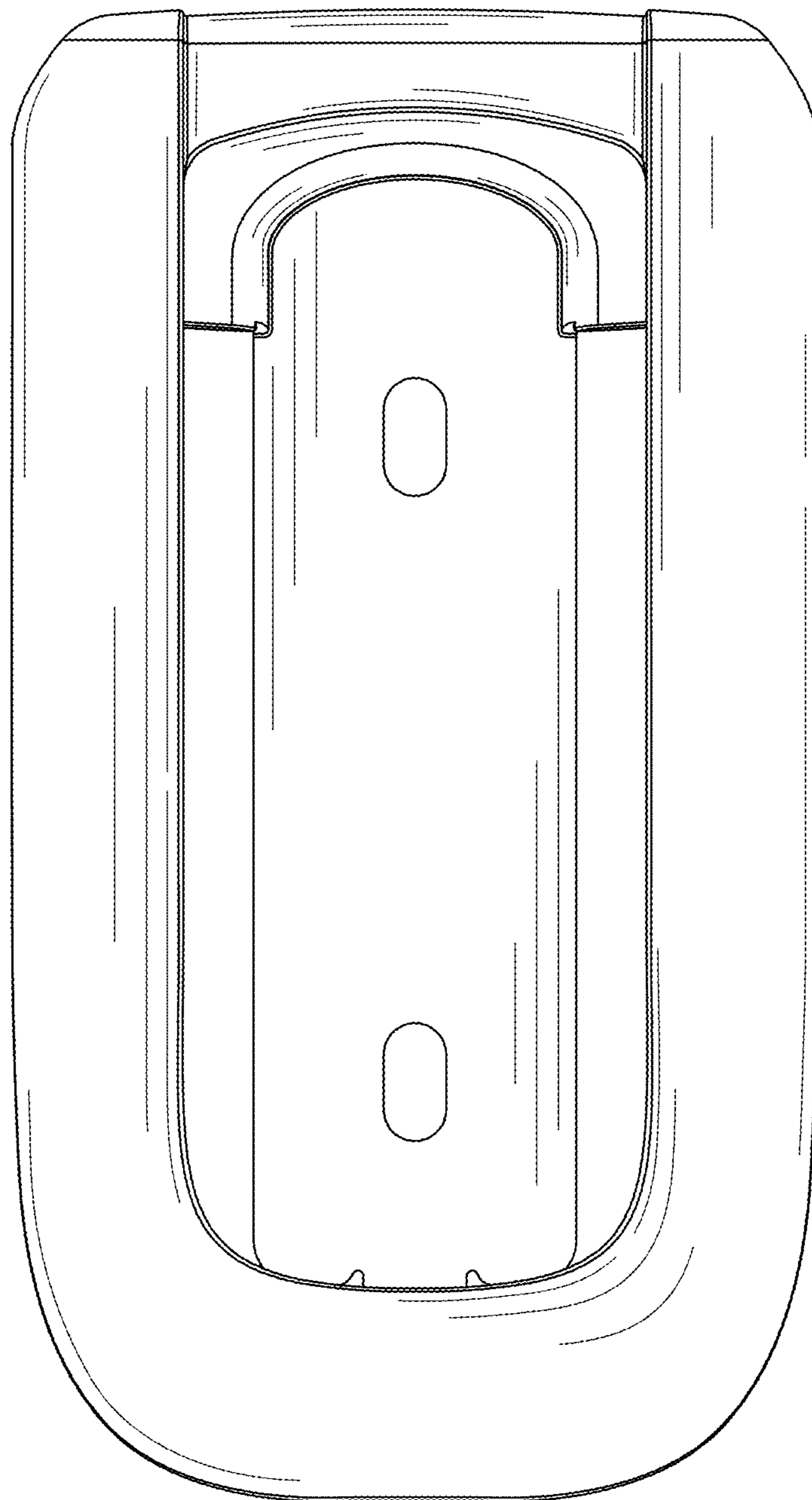

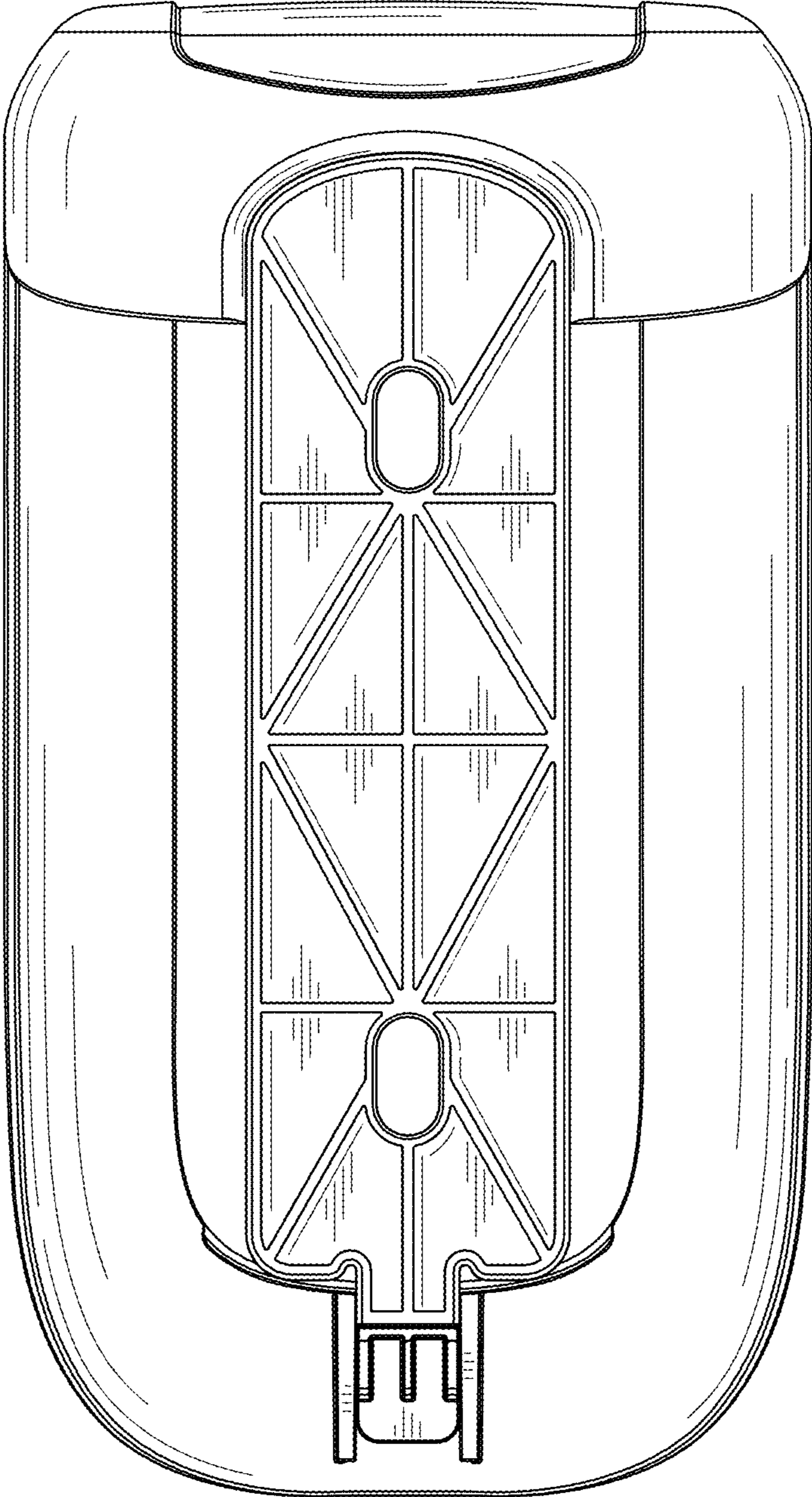

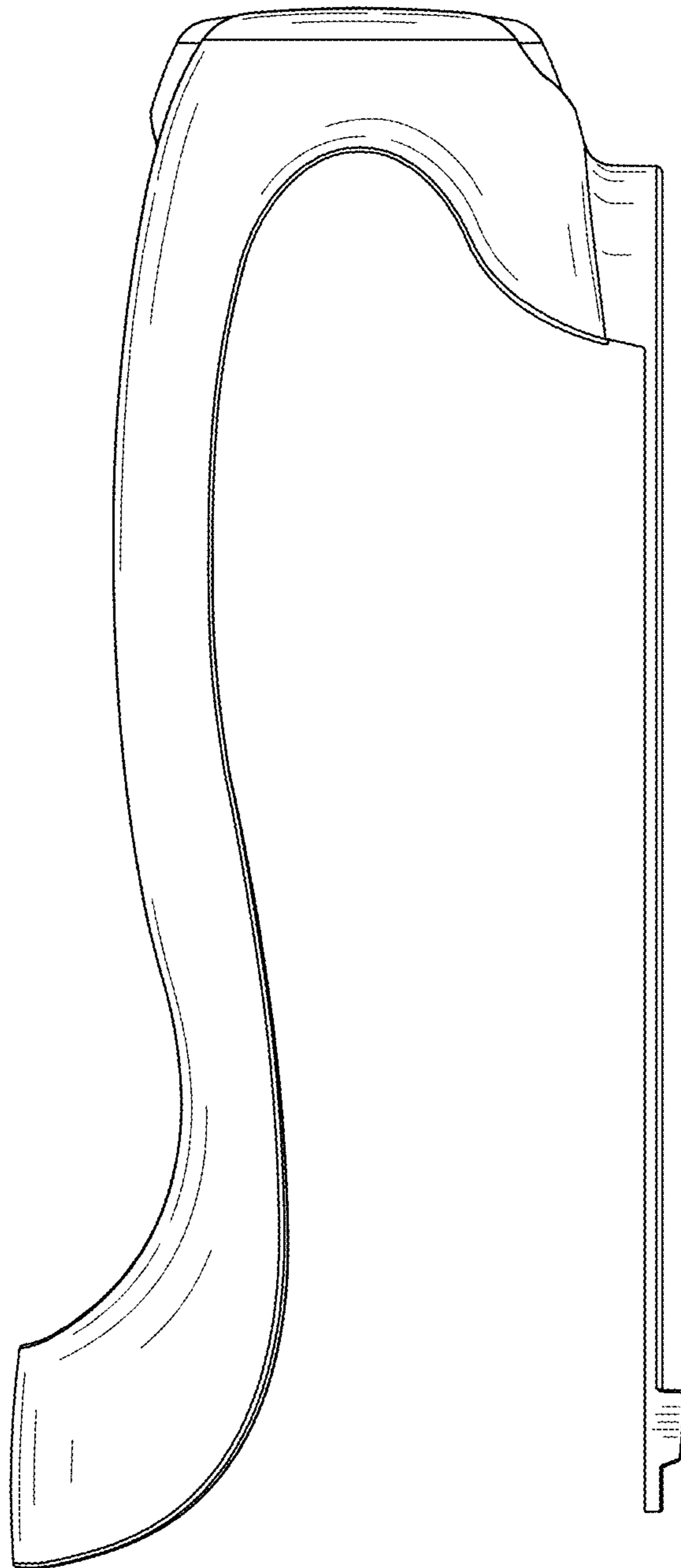

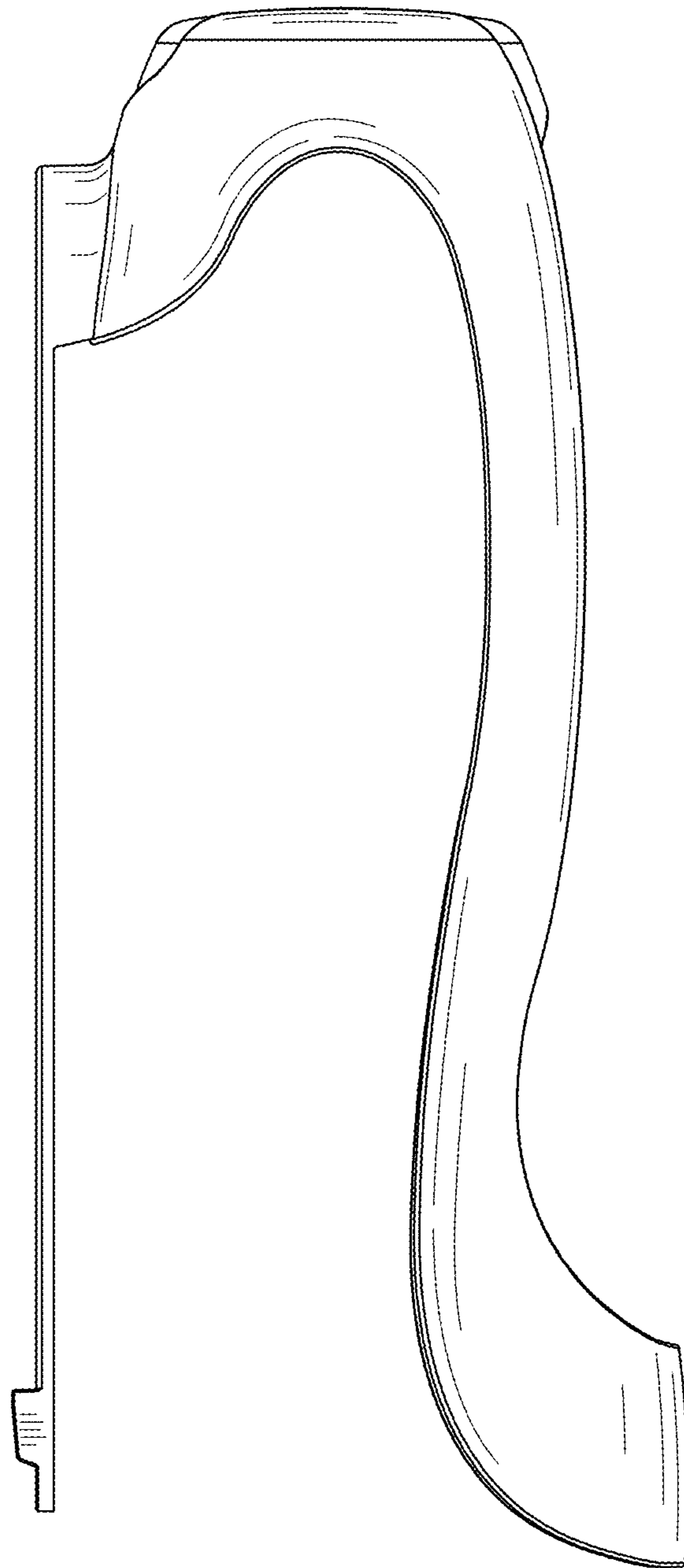

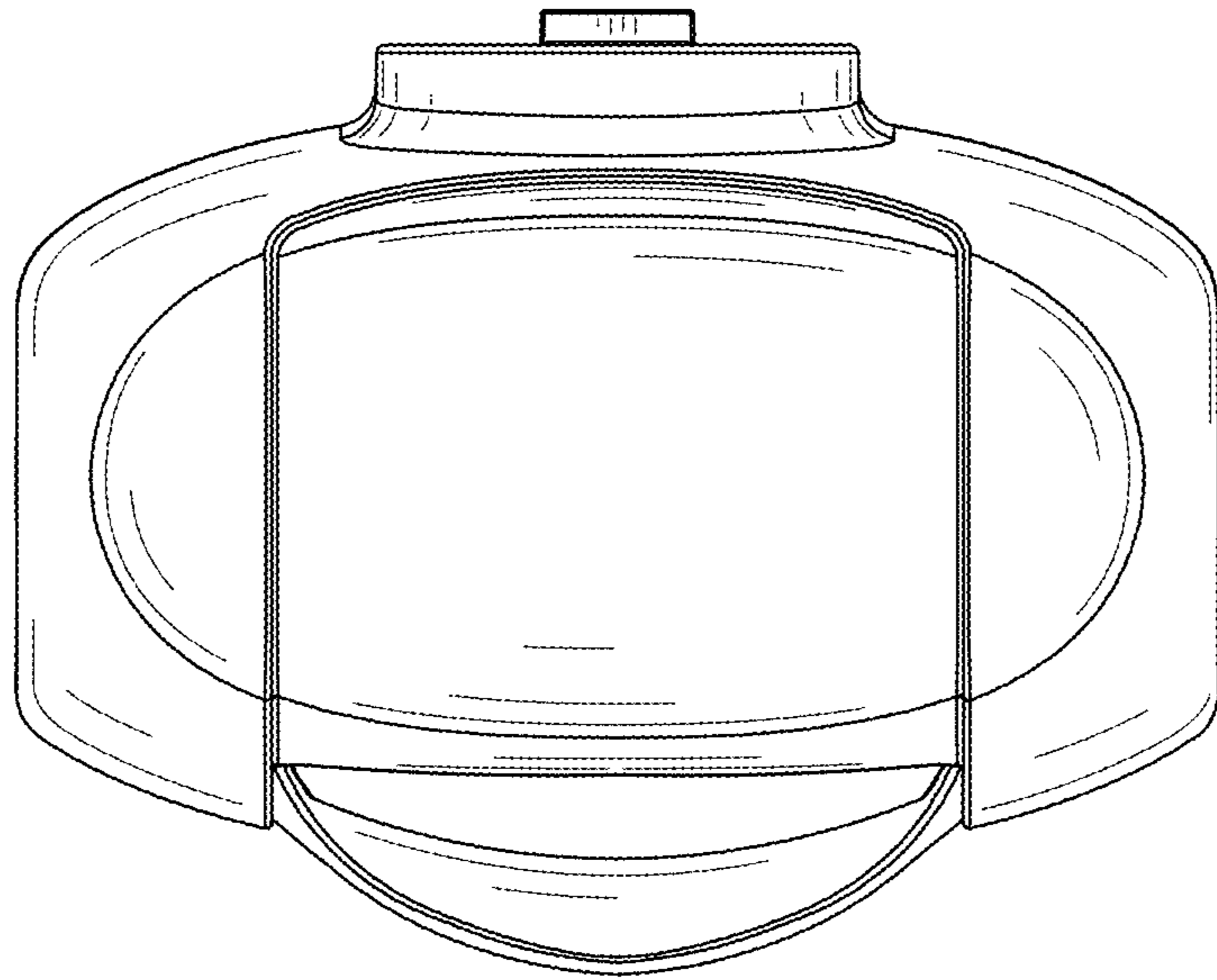

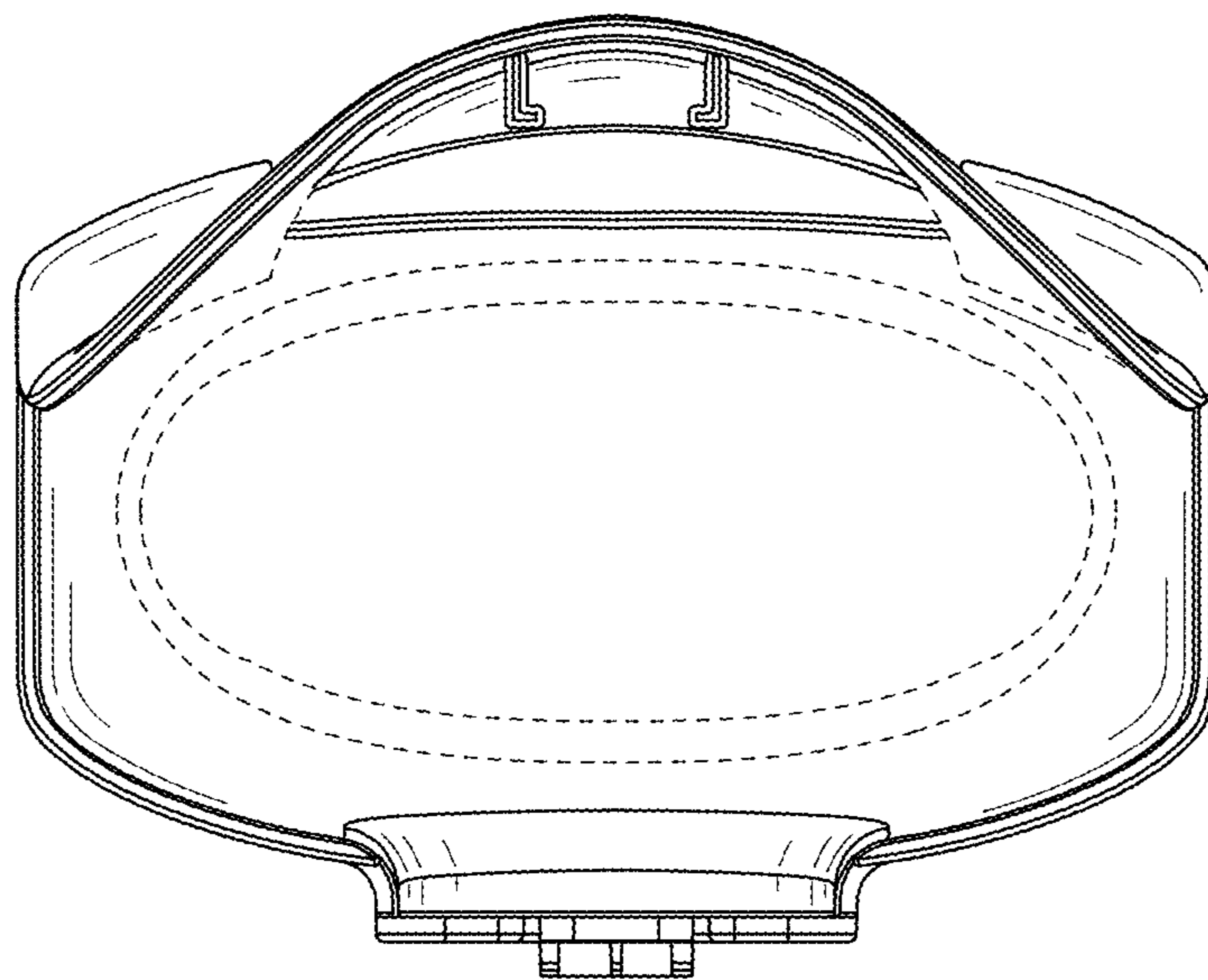

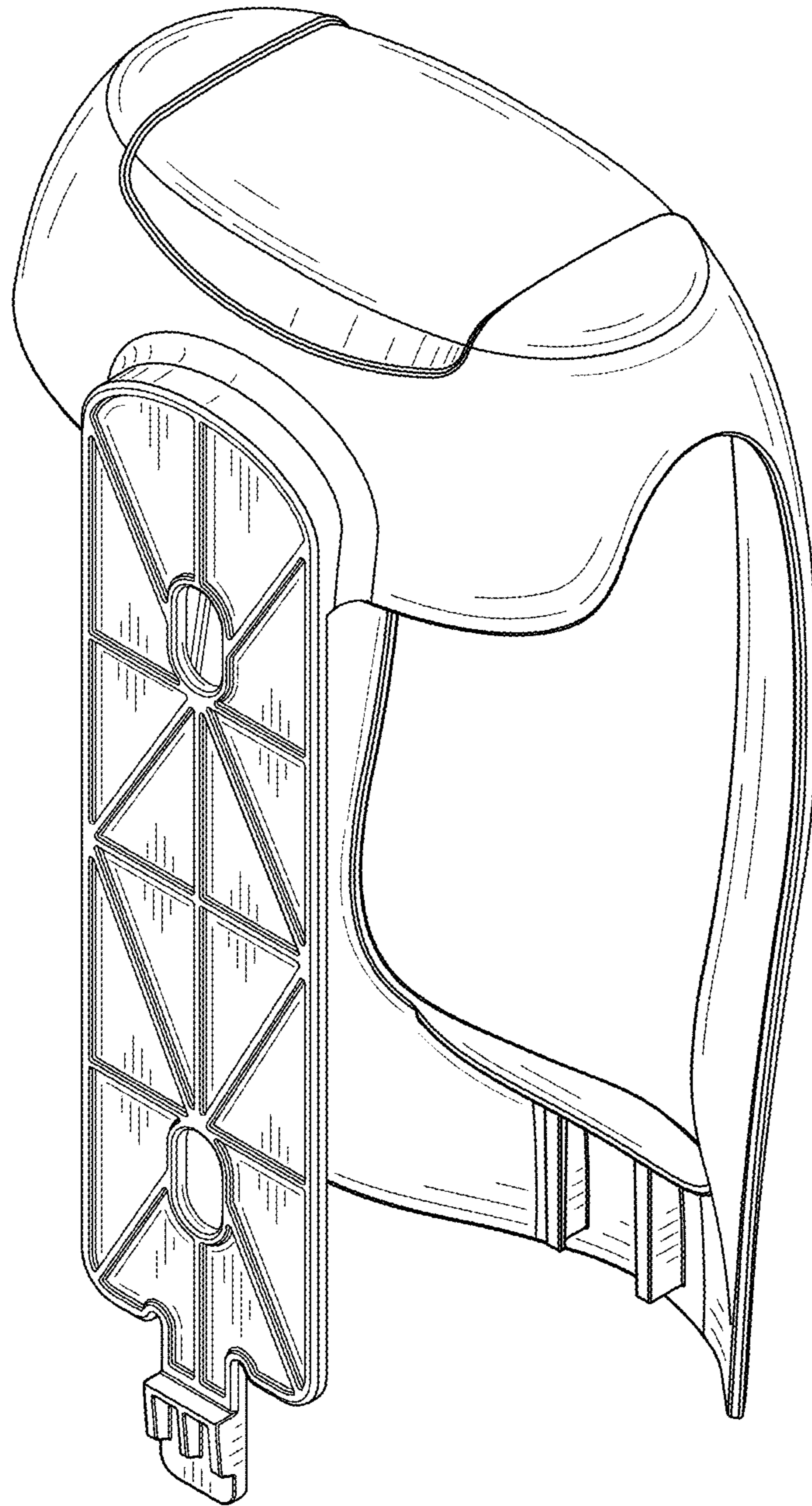
