(57) **CLAIM**


We claim the ornamental design for an aircraft credenza, as shown and described.

DESCRIPTION

FIG. 1 is front tridimensional view of the aircraft credenza in accordance with our new design;
 FIG. 2 is a top plan view of the embodiment of FIG. 1;
 FIG. 3 is a front elevational view of the embodiment of FIG. 1;
 FIG. 4 is a left side elevational view of the embodiment of FIG. 1;














