**DESCRIPTION**

FIG. 1 is a perspective view of a carpet sample holder according to our invention with sample materials illustrated in broken lines;

FIG. 5 is a right side view thereof;

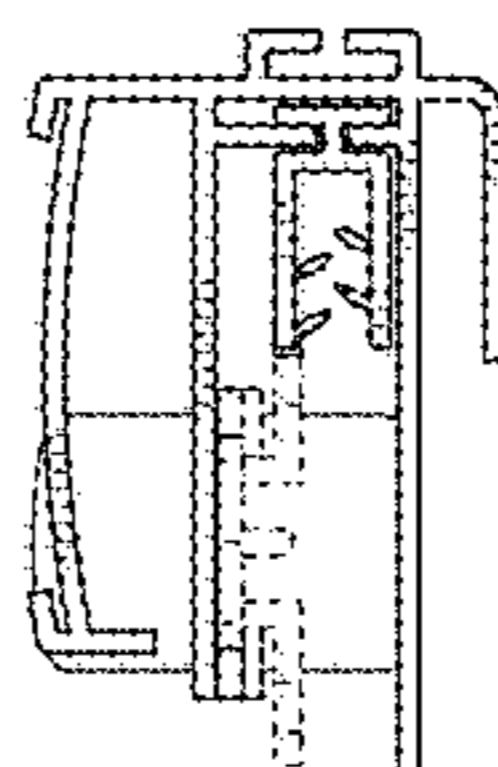
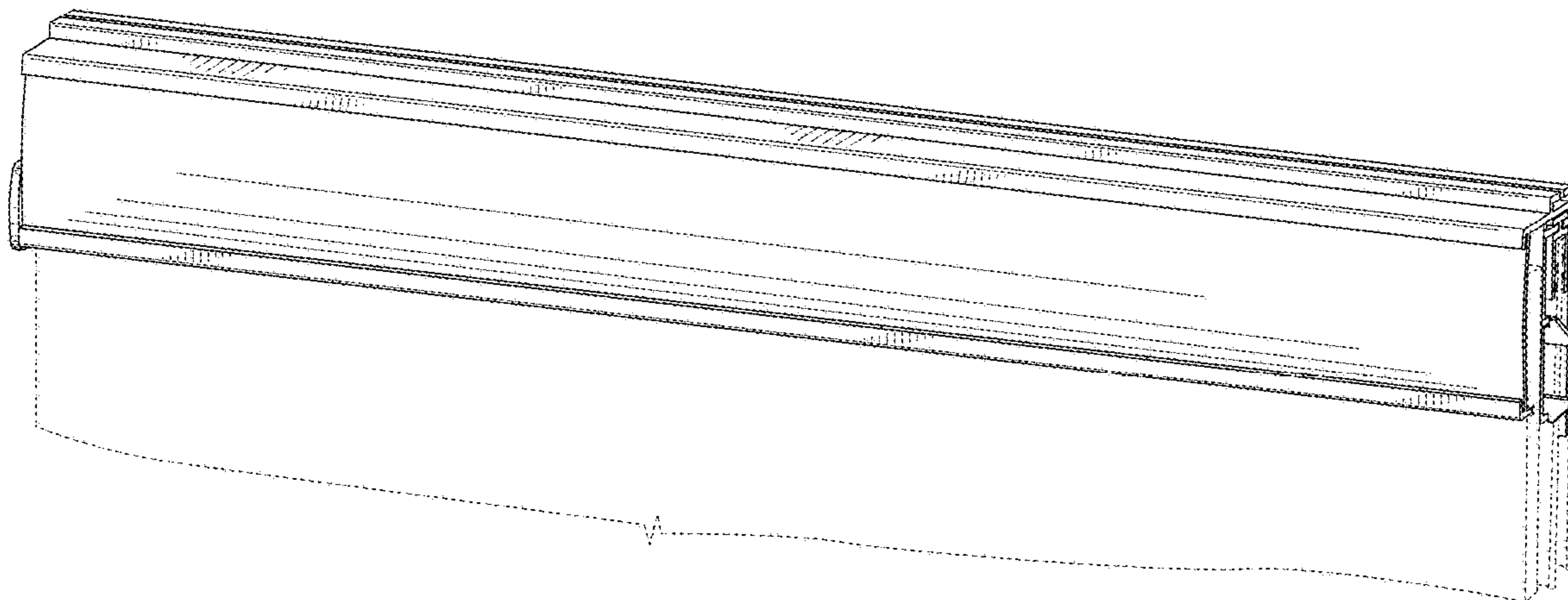
FIG. 6 is a left side view thereof;

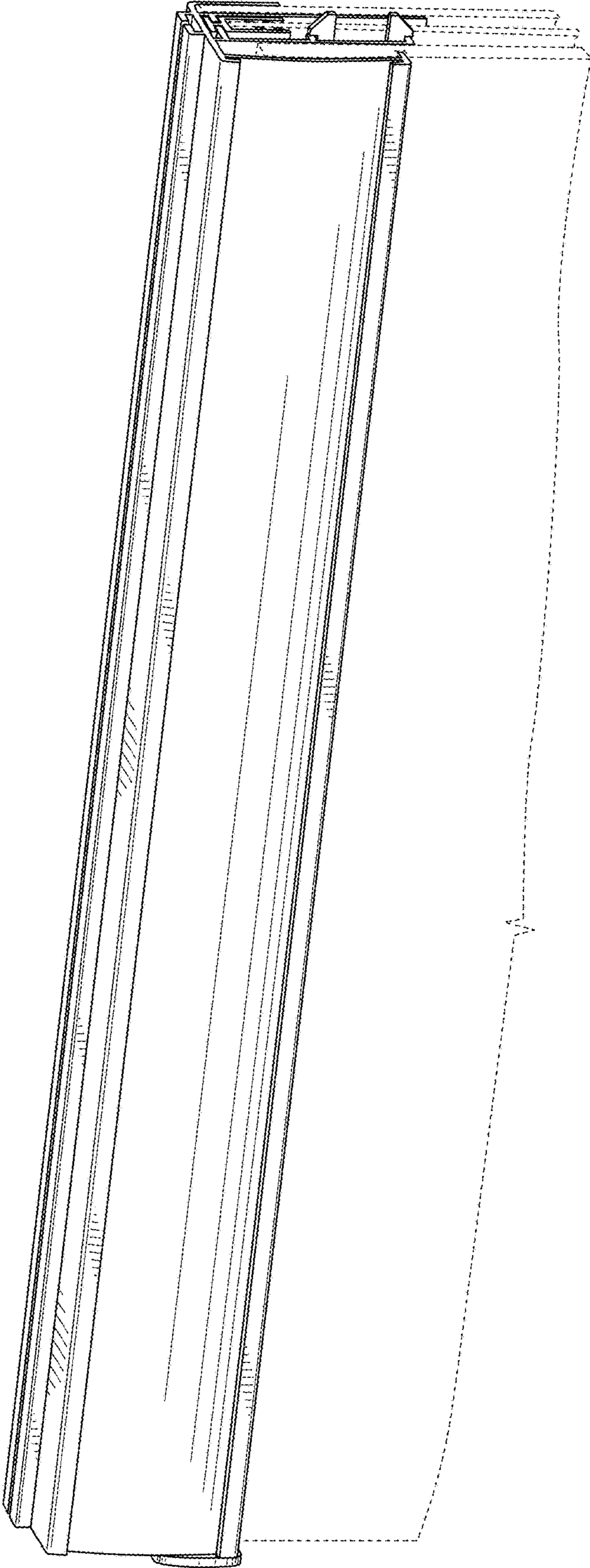

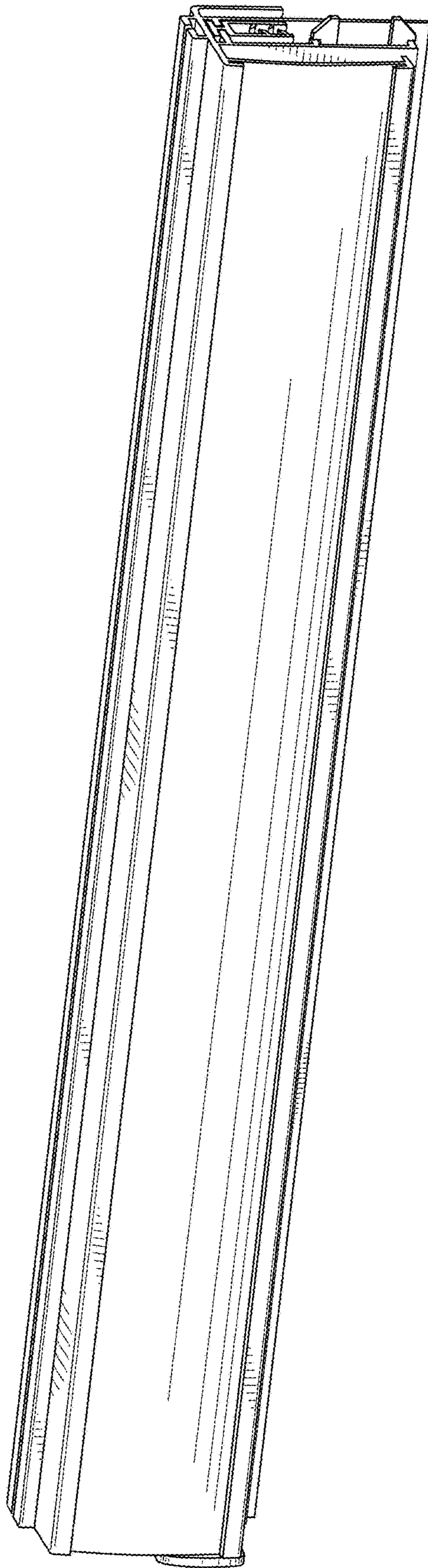

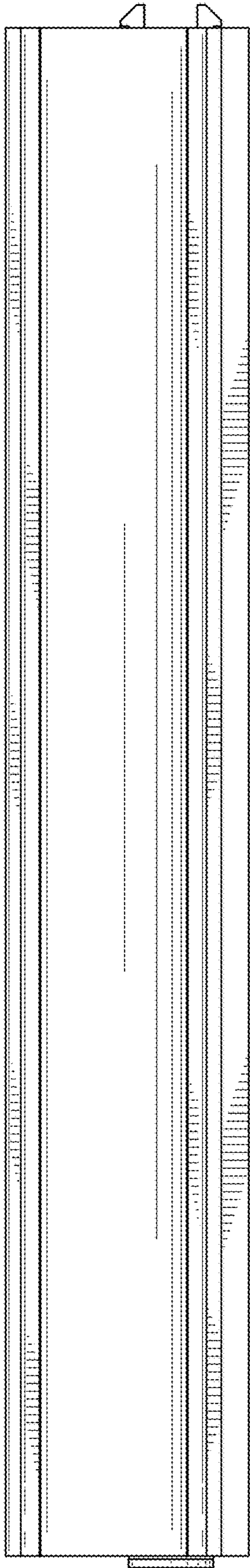

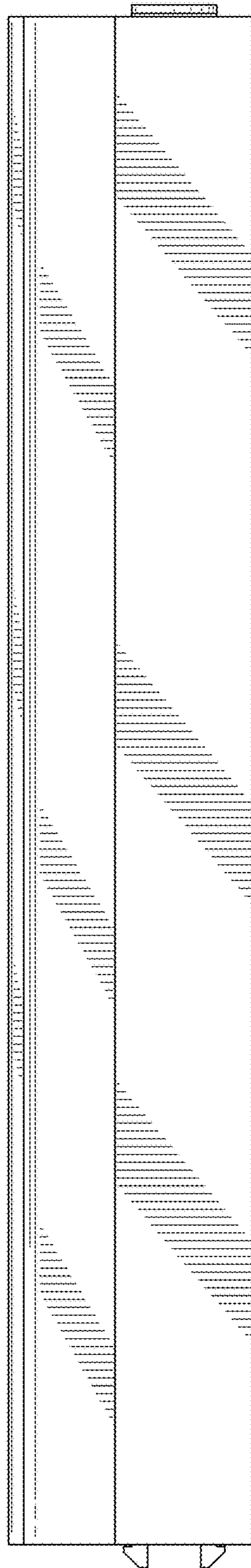
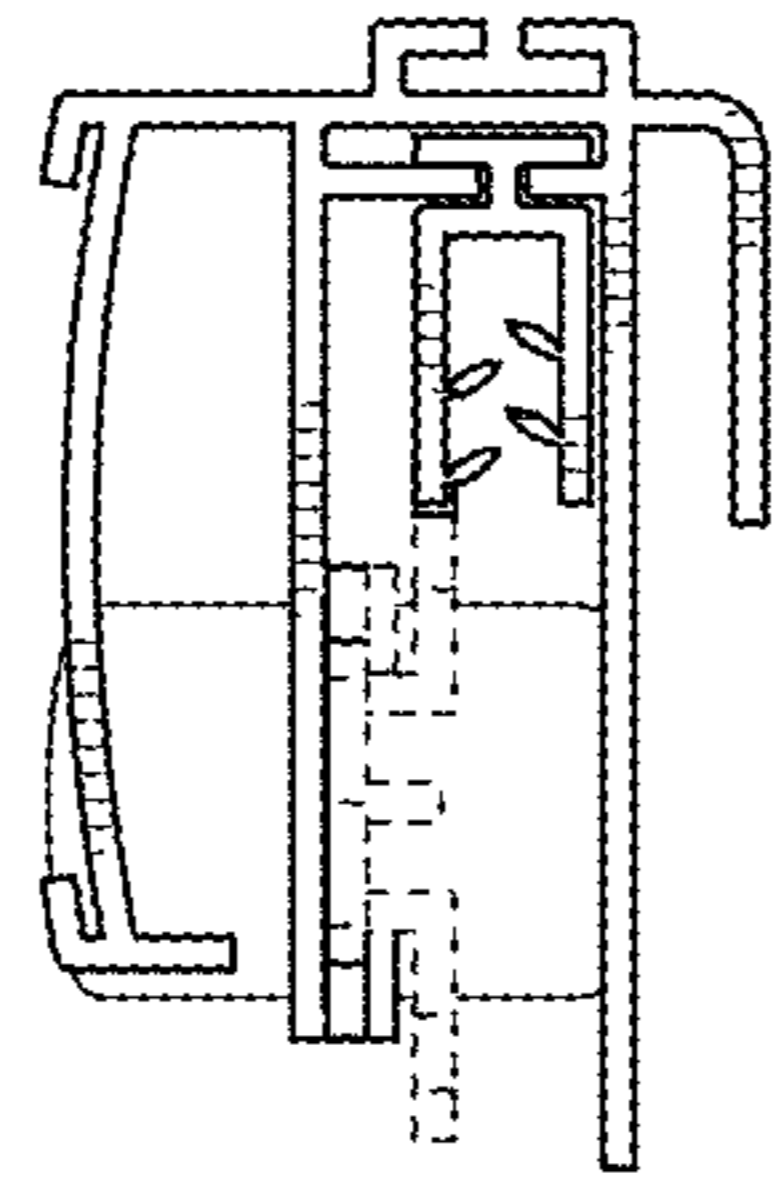
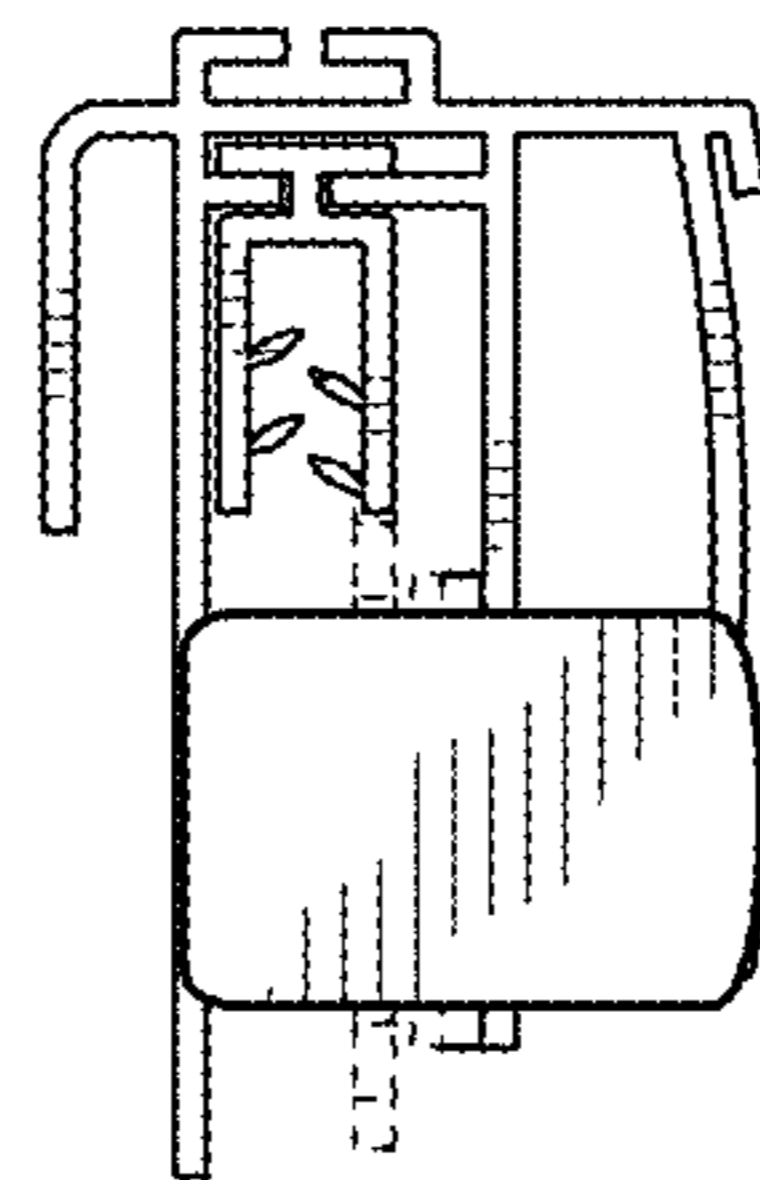

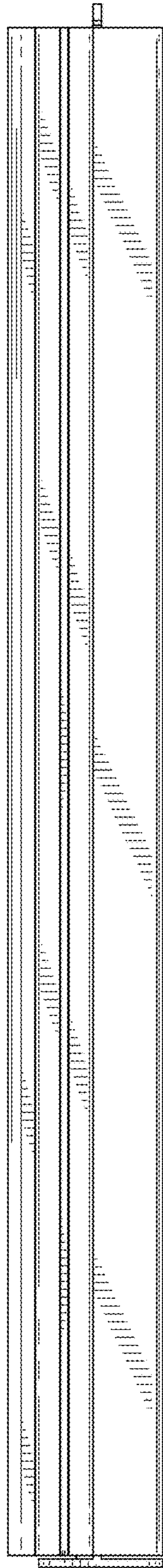

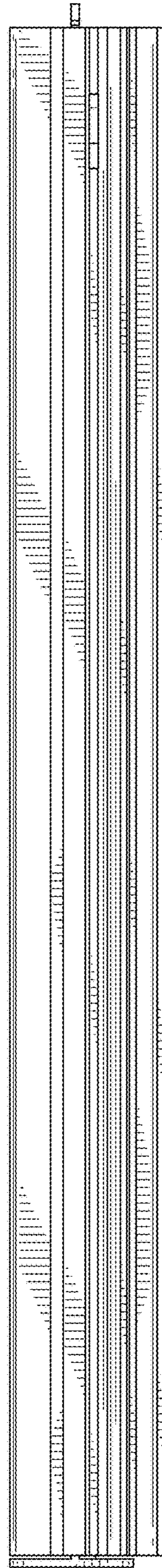
