DESCRIPTION

FIG. 1 is an upper perspective view of a first embodiment of a bottle showing our new design;

FIG. 11 is a right side view thereof, the left side view being identical;

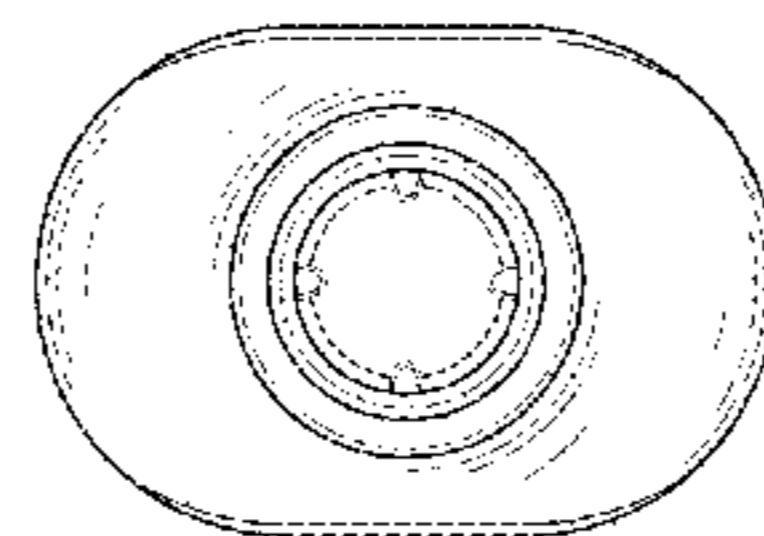
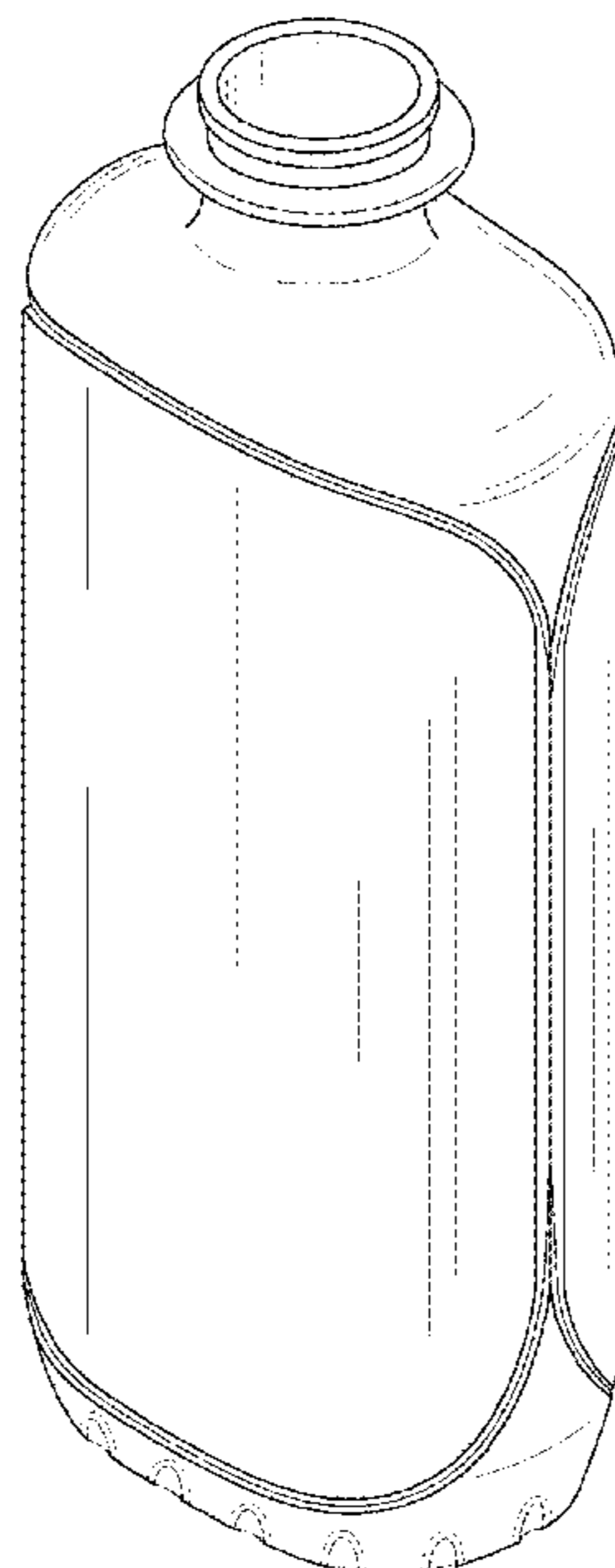
FIG. 12 is a top view thereof;

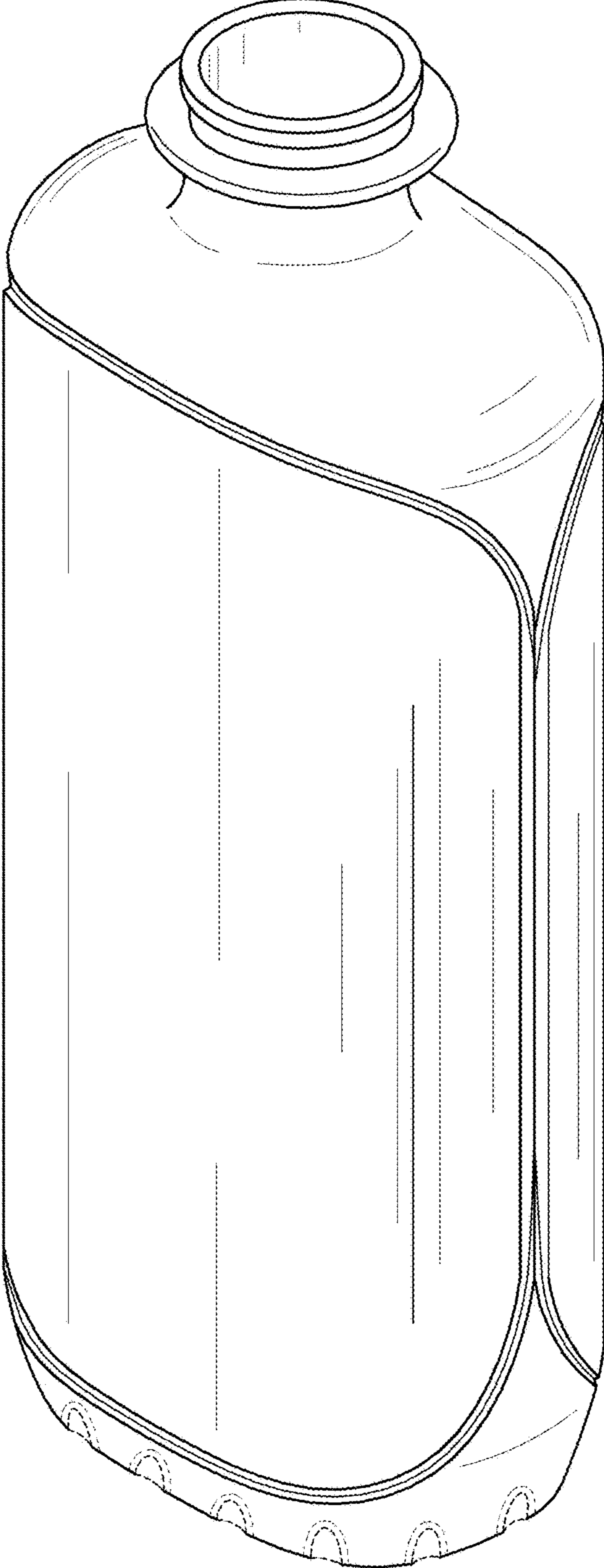

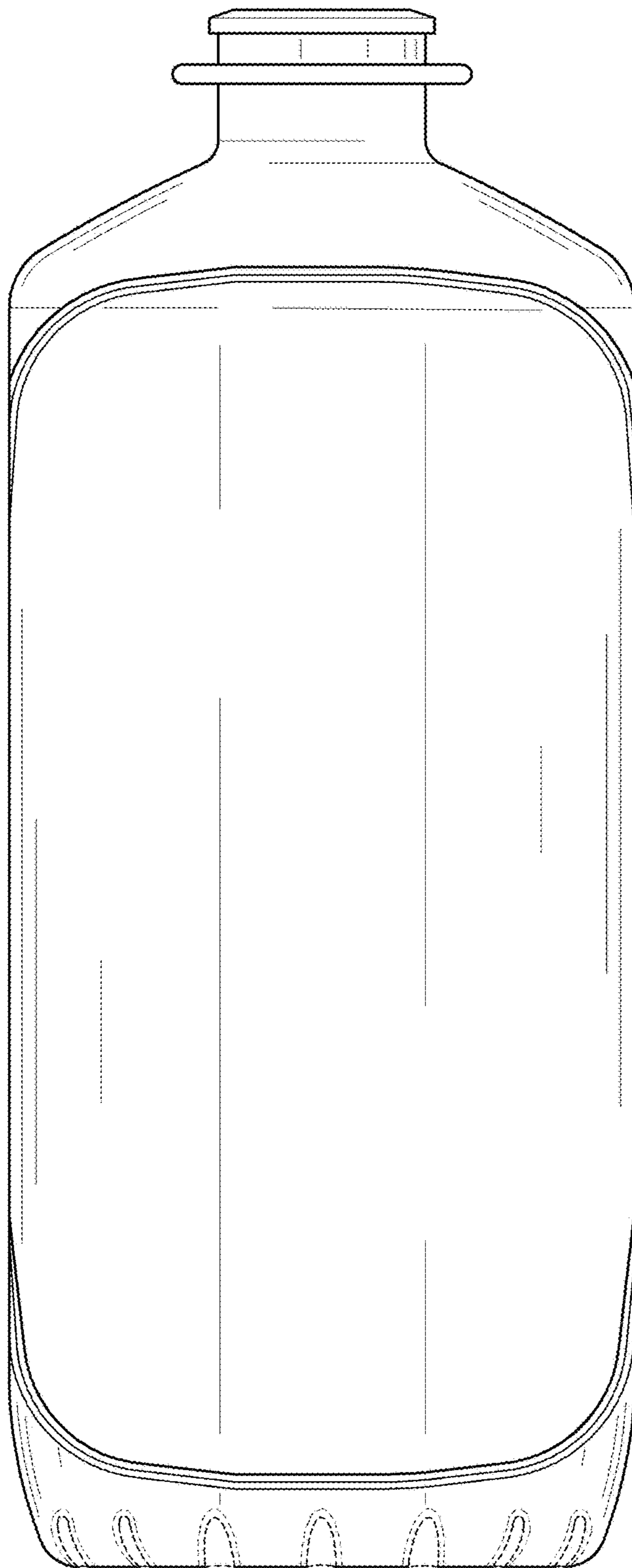

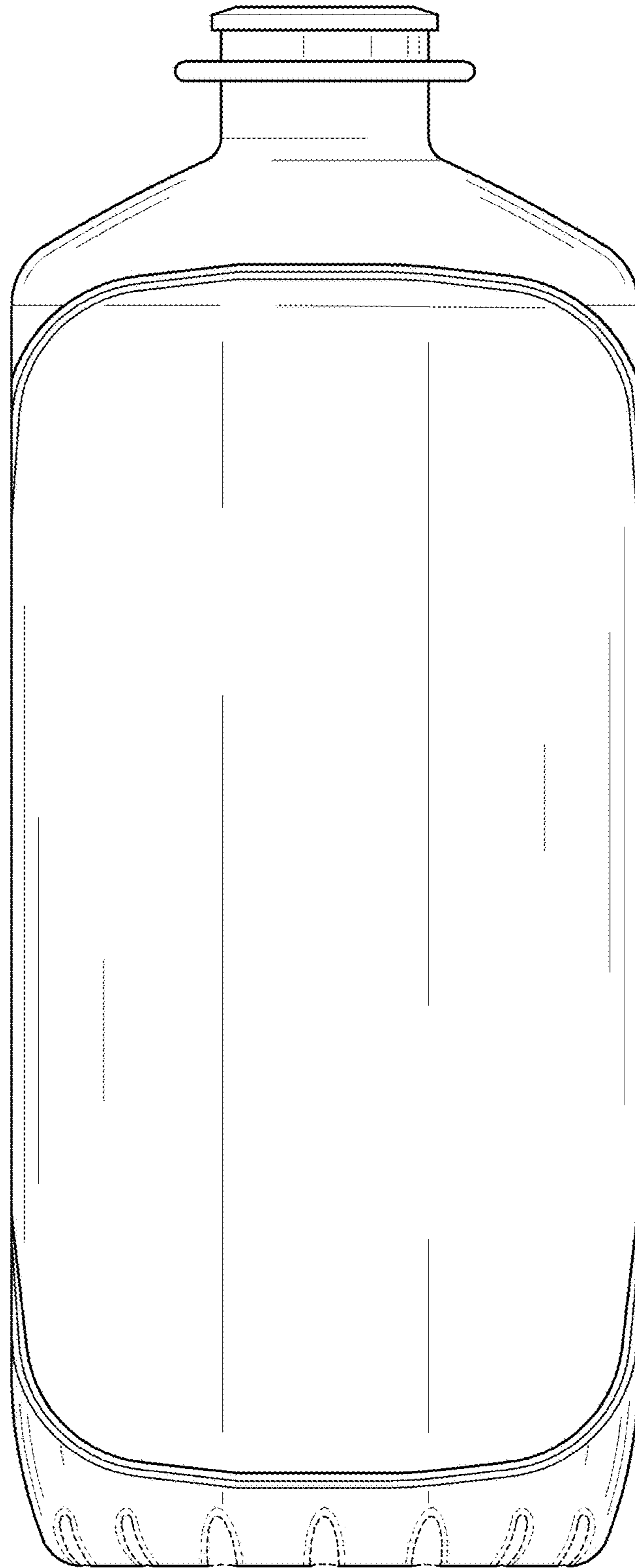

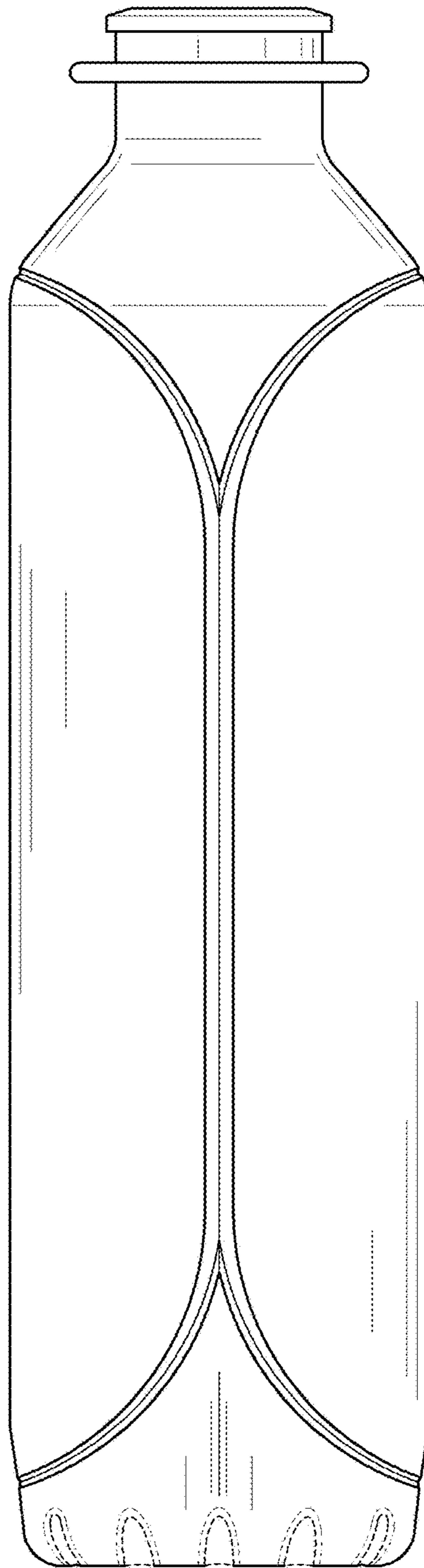

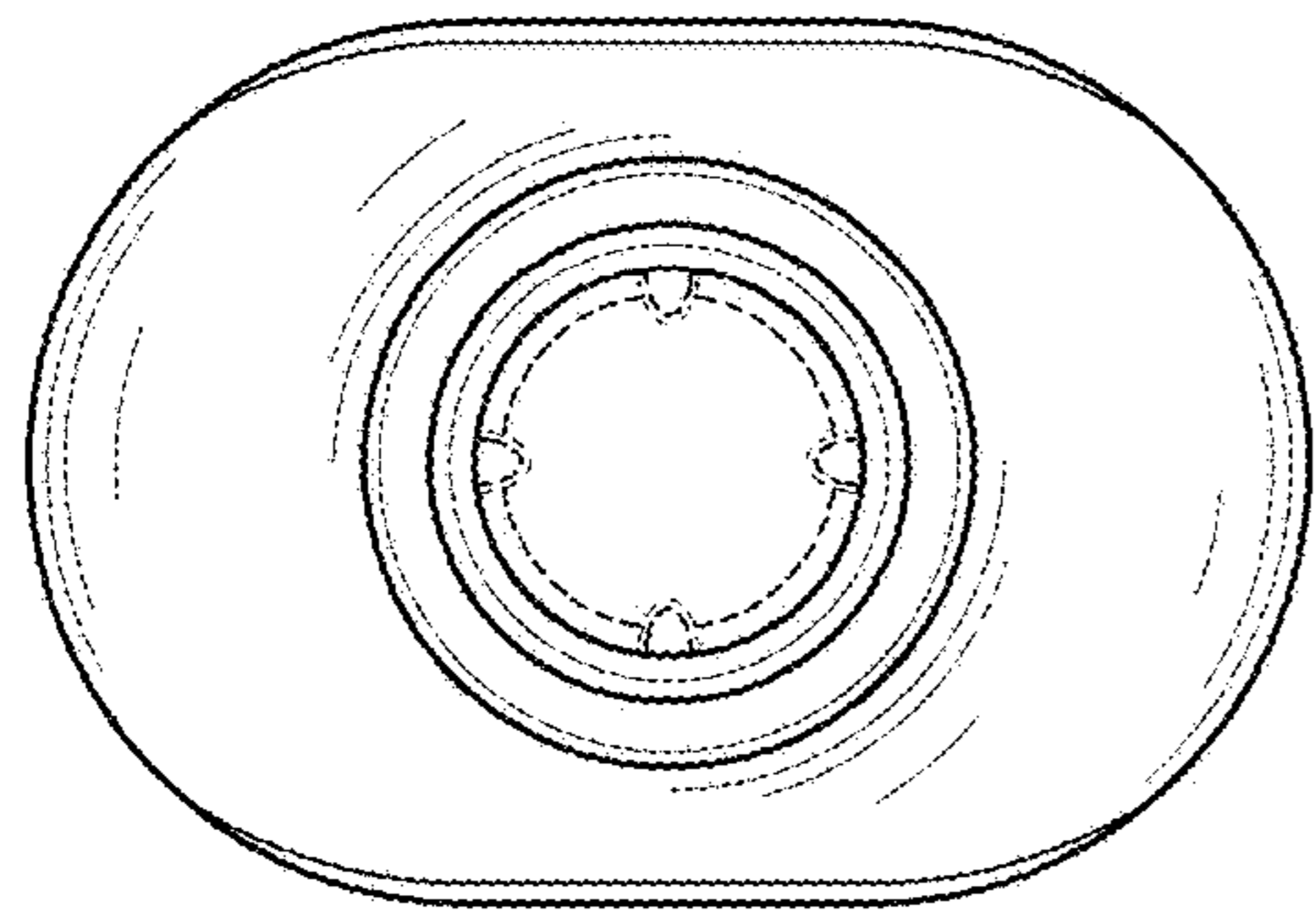

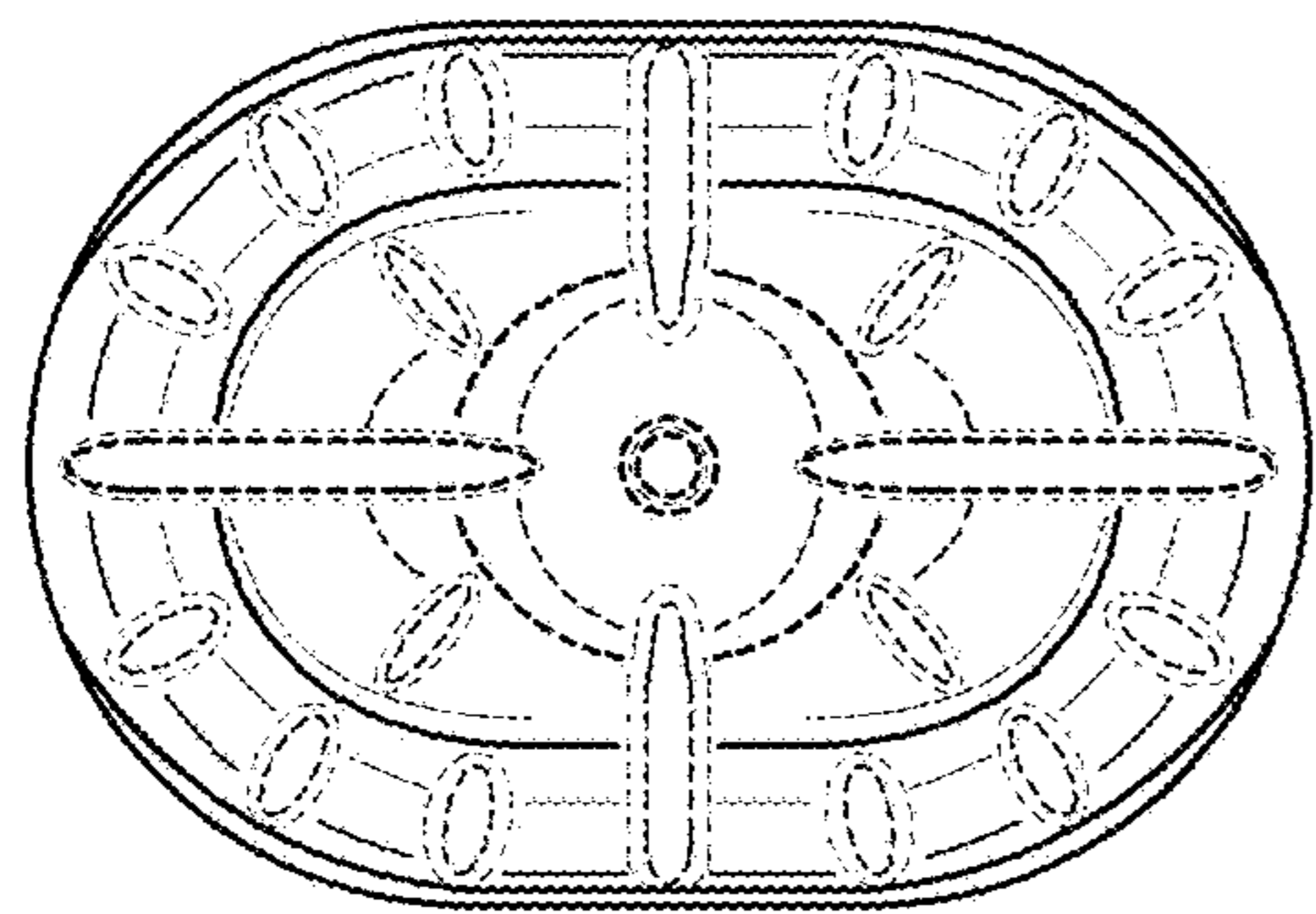

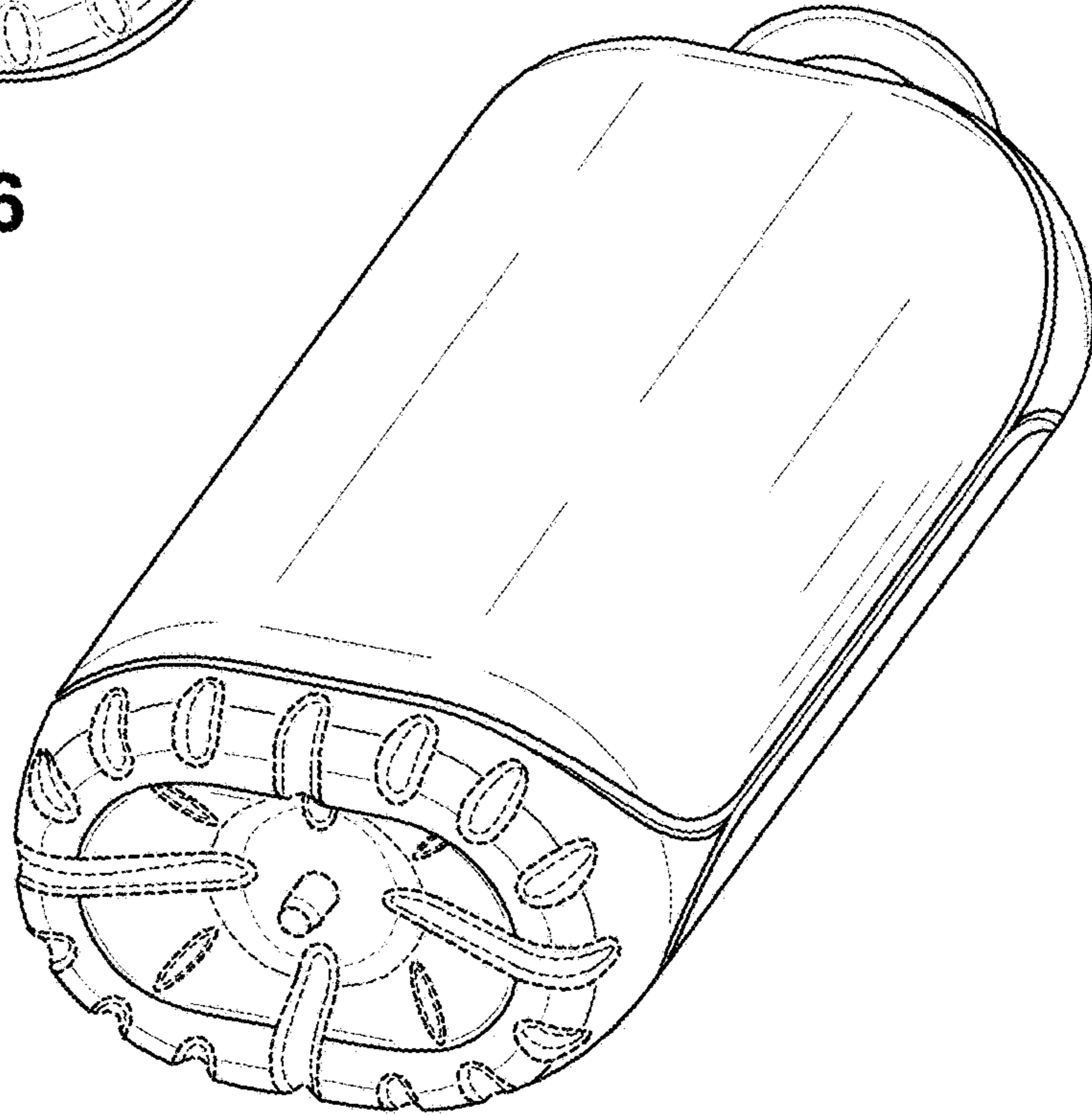

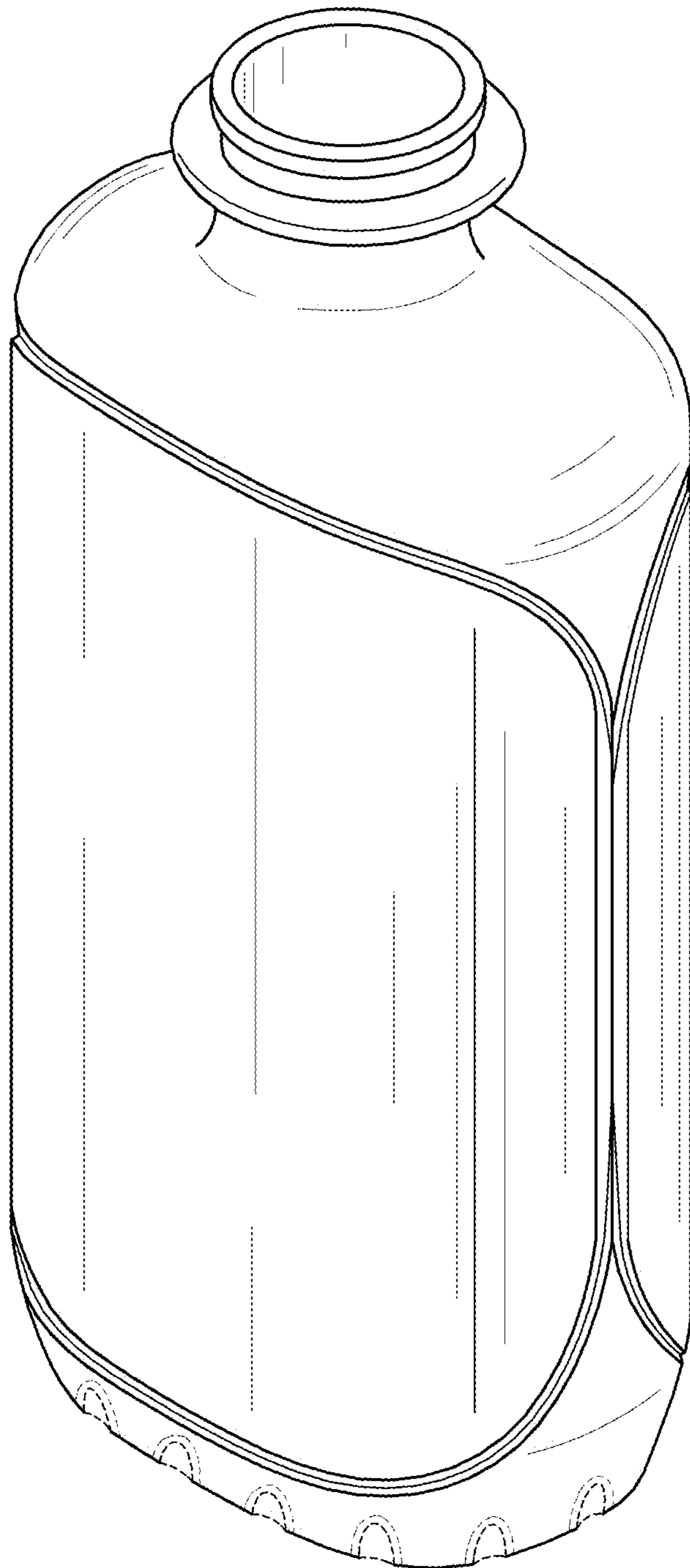

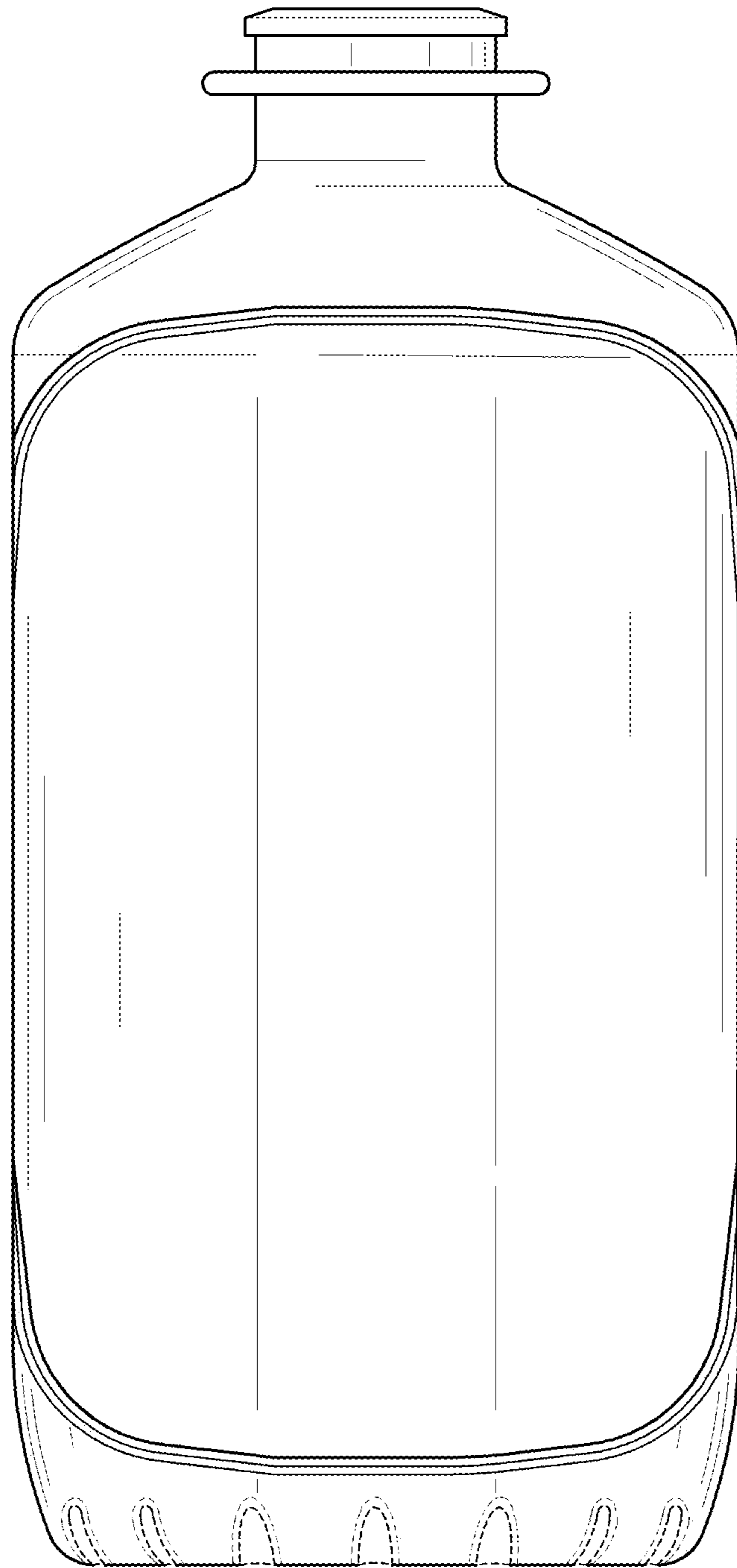

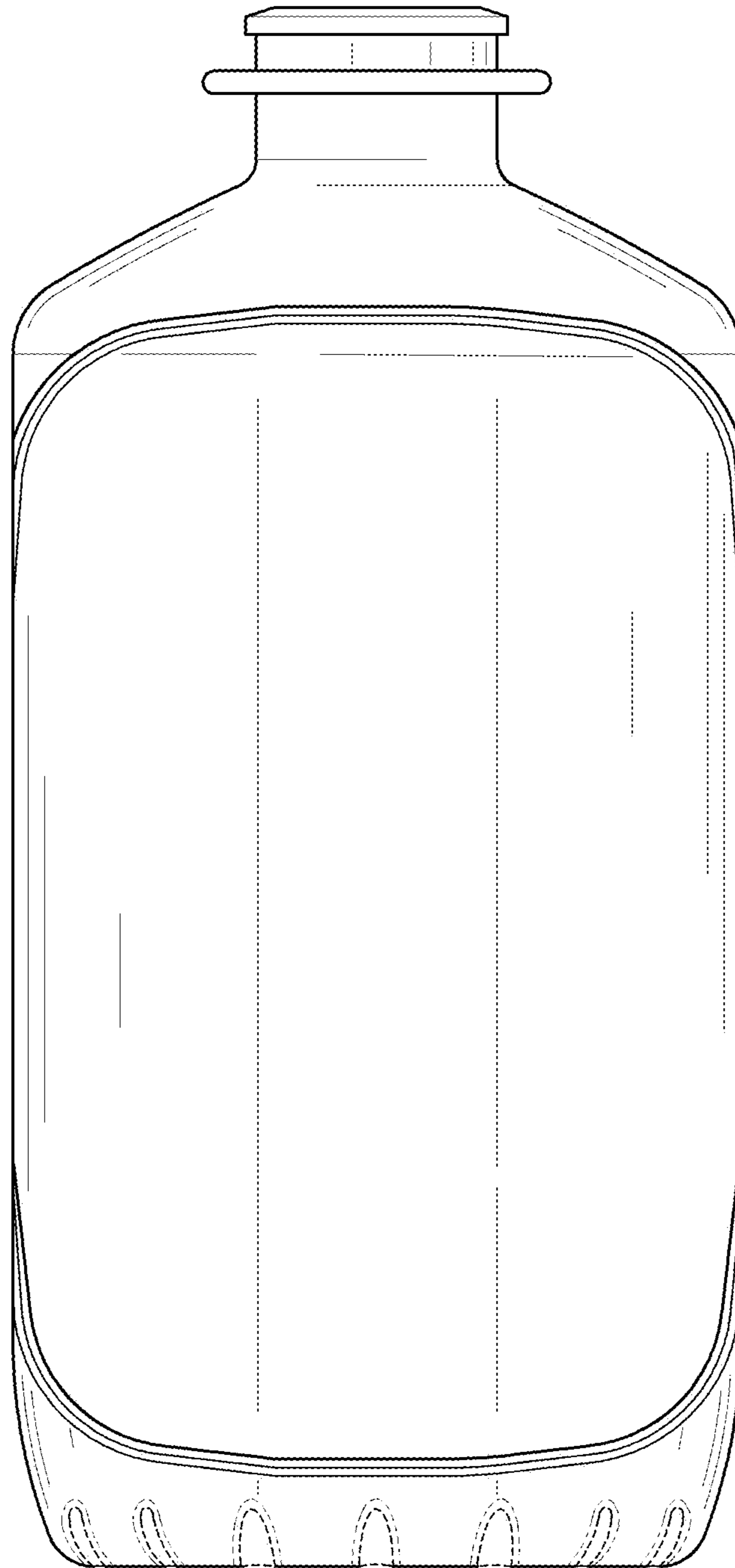

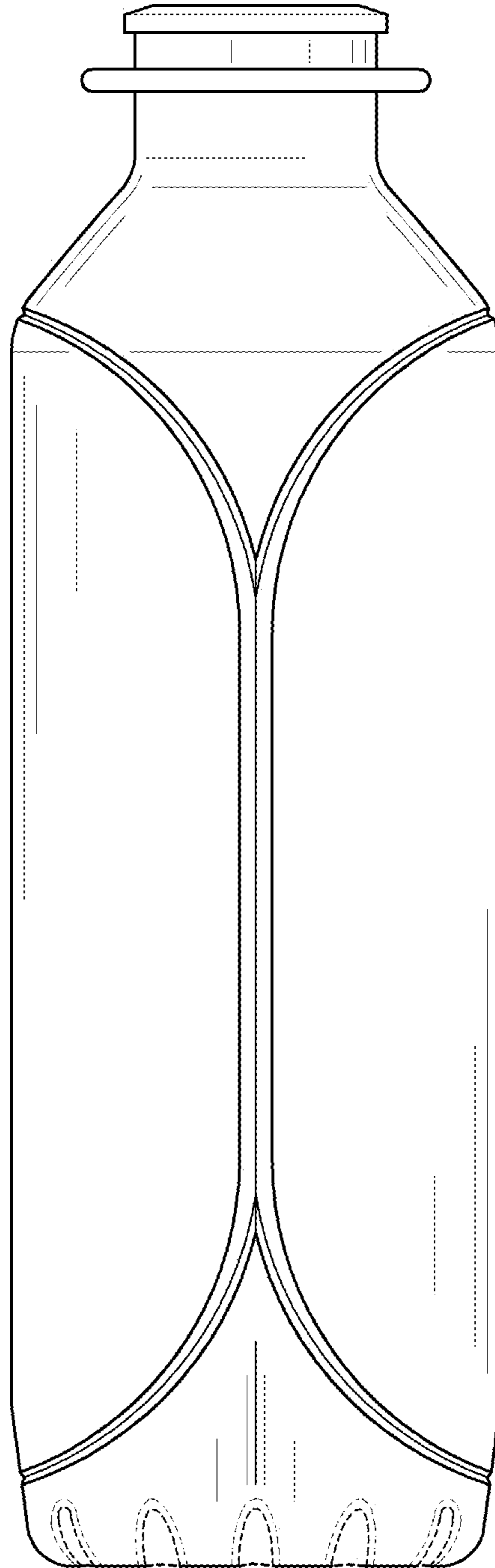

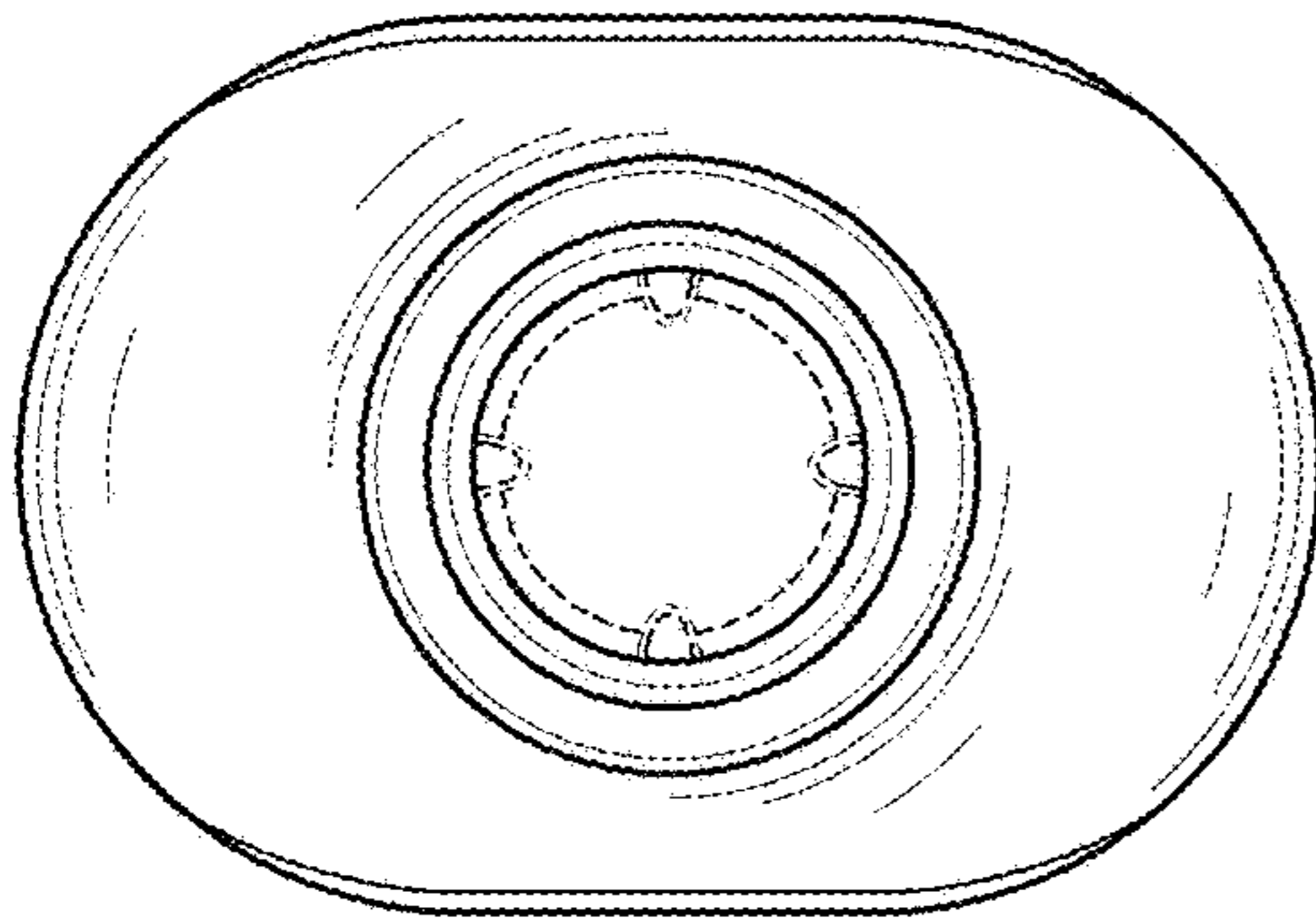

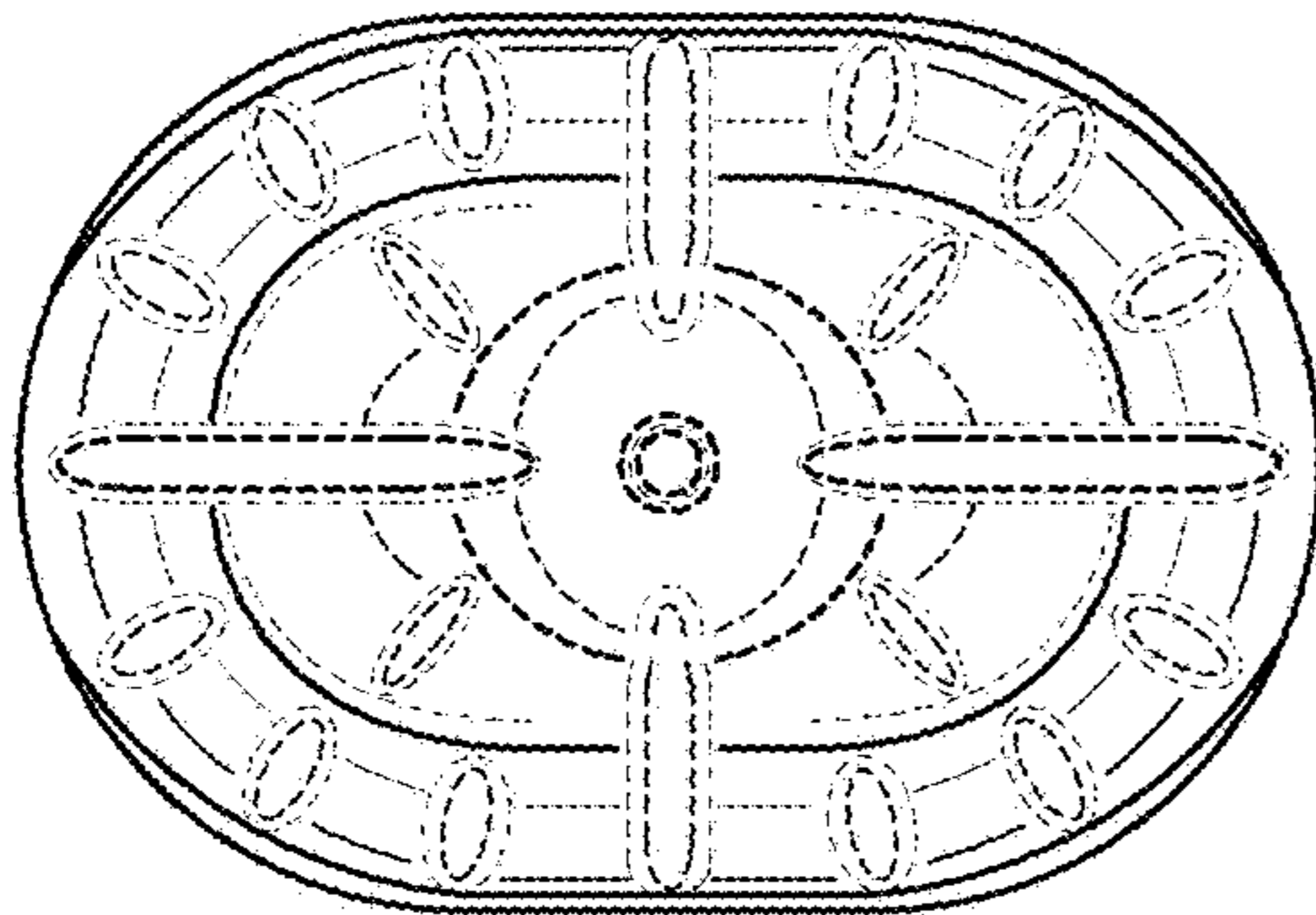

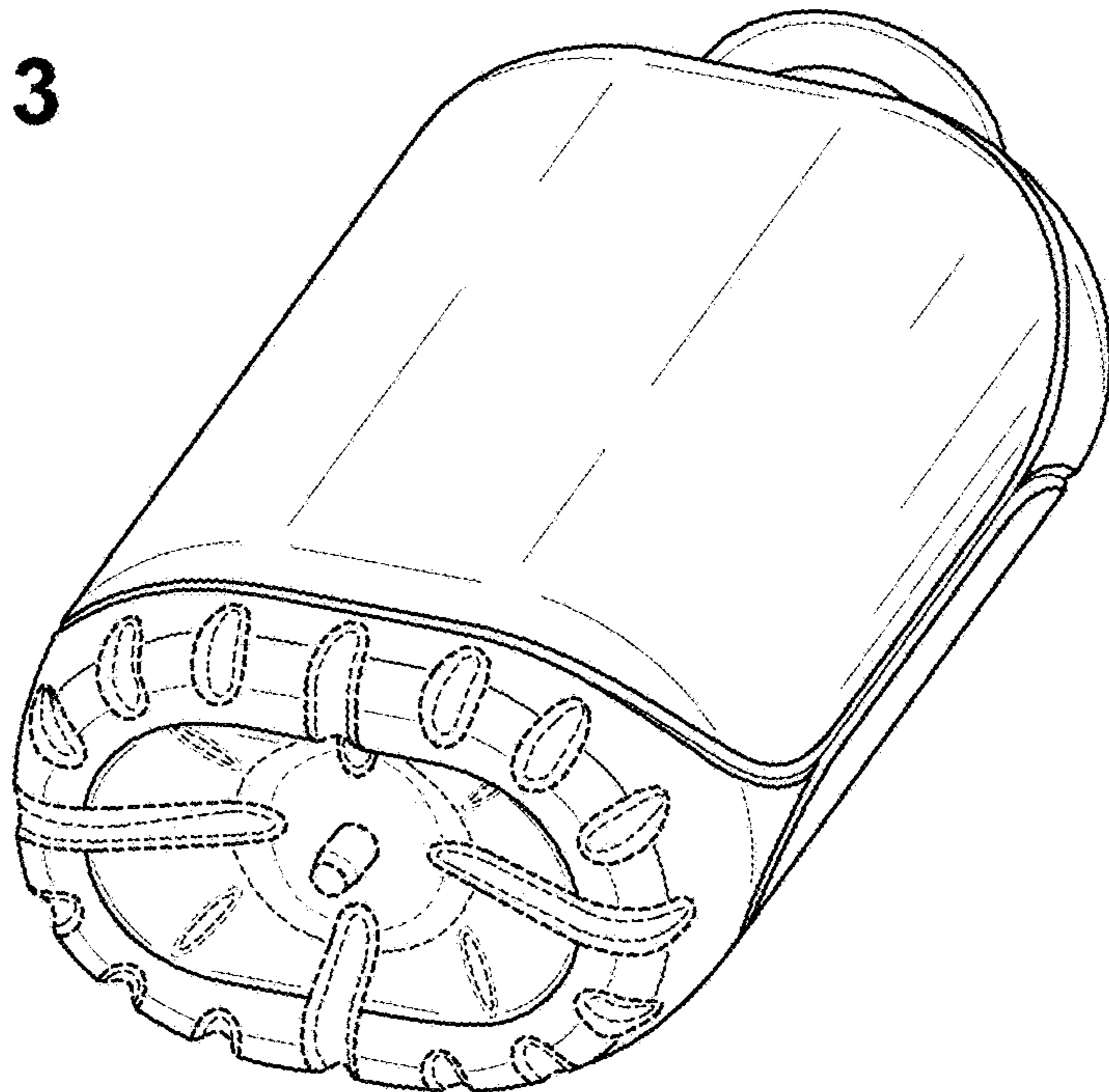
