(57) **CLAIM**

We claim the ornamental design for a spare tire carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a spare tire carrier according to our new design.

FIG. 2 is a rear perspective view thereof.

FIG. 3 is a right-side elevation view thereof. The left-side elevation view thereof is a mirror image of the right-side elevation view thereof.

FIG. 4 is a top plan view thereof.

FIG. 5 is a front elevation view thereof.

FIG. 6 is a rear elevation view thereof.

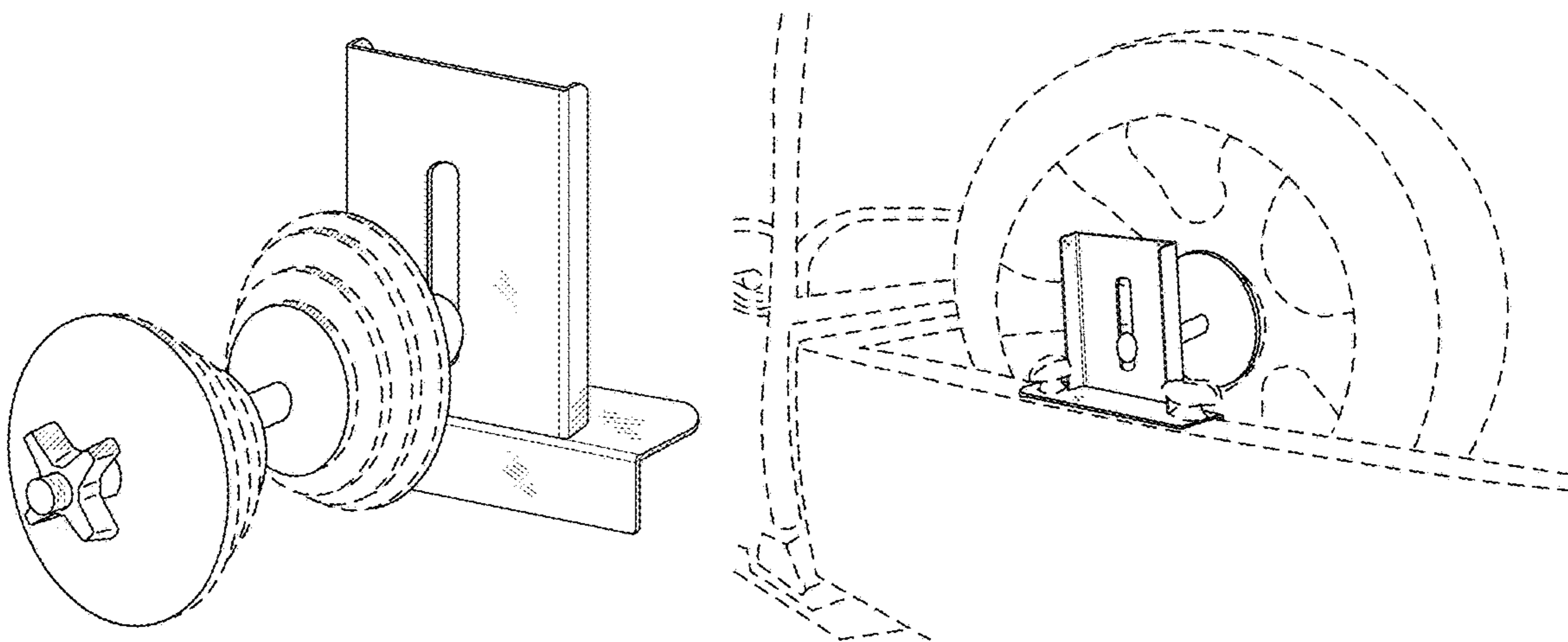
FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a reduced rear perspective view thereof, shown in a position of use attached to a utility task vehicle, a spare wheel, and a spare tire.

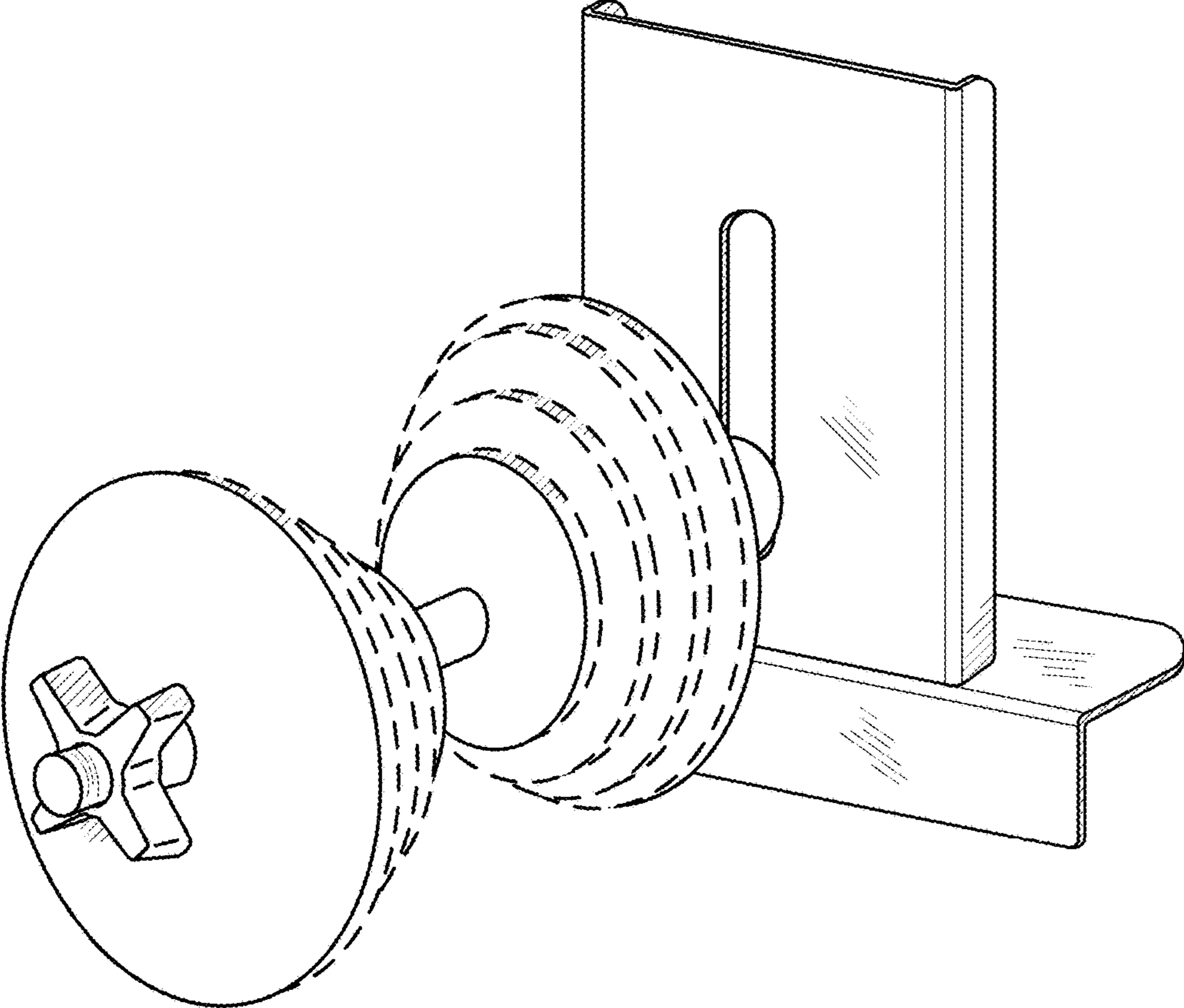

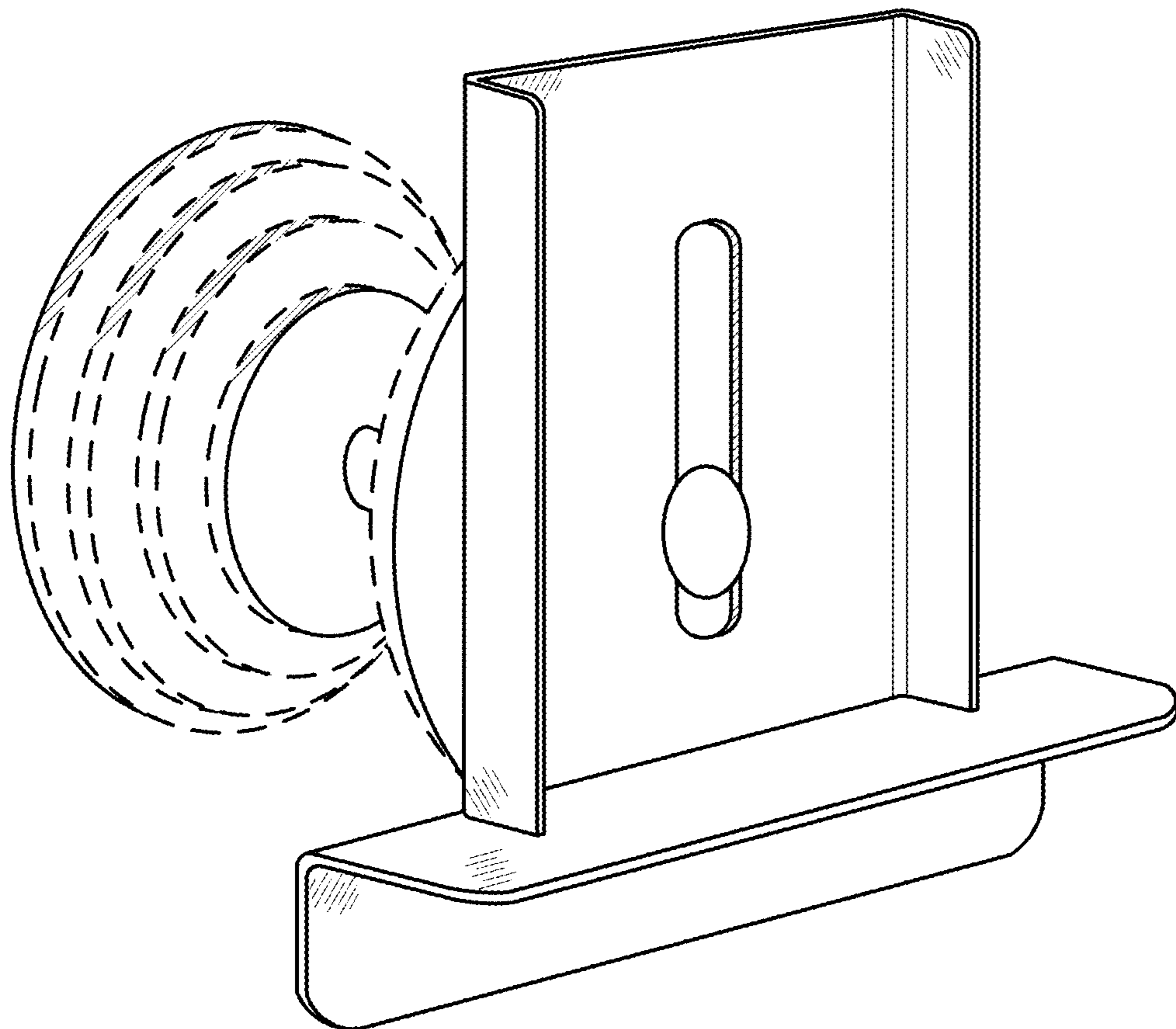

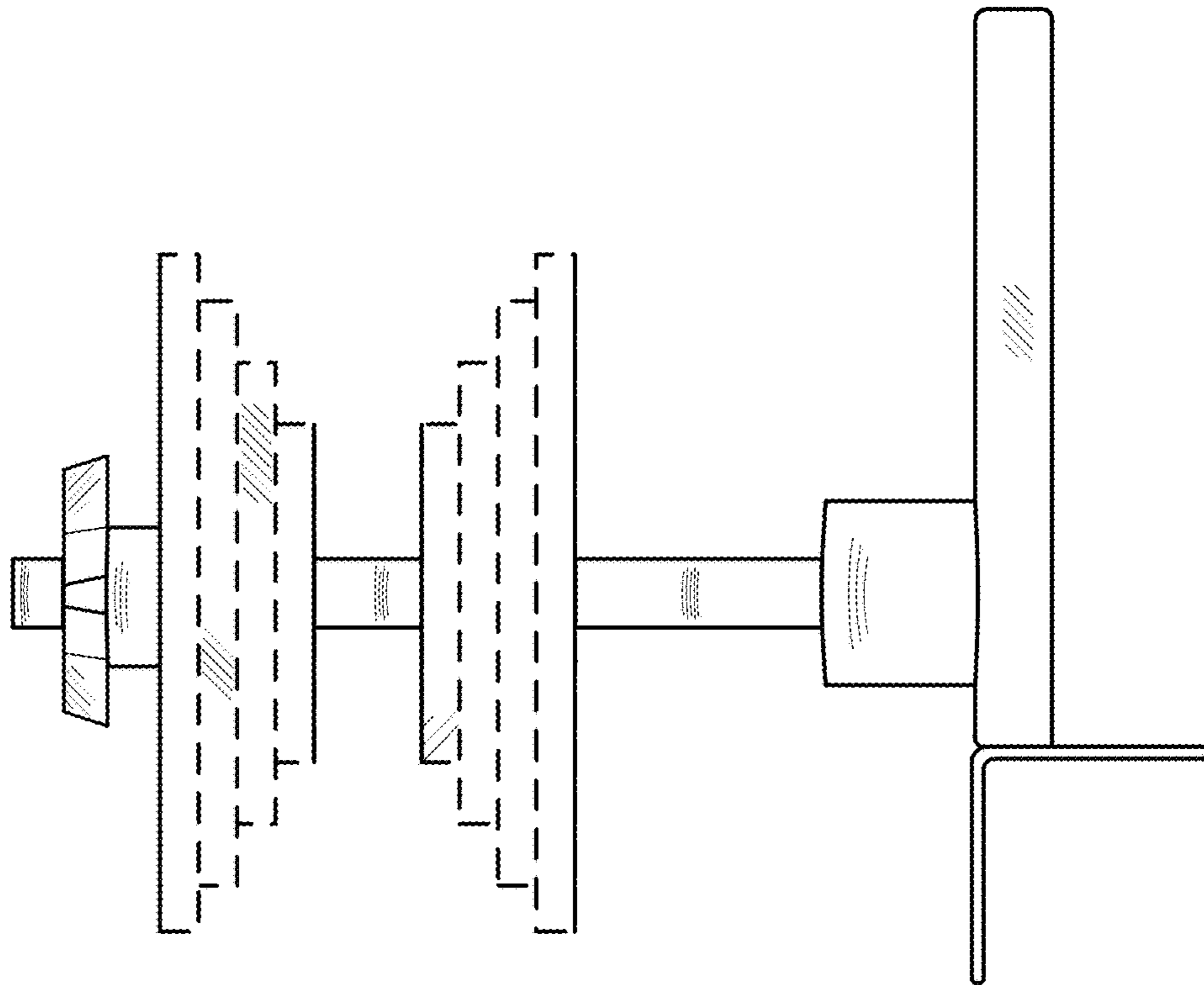

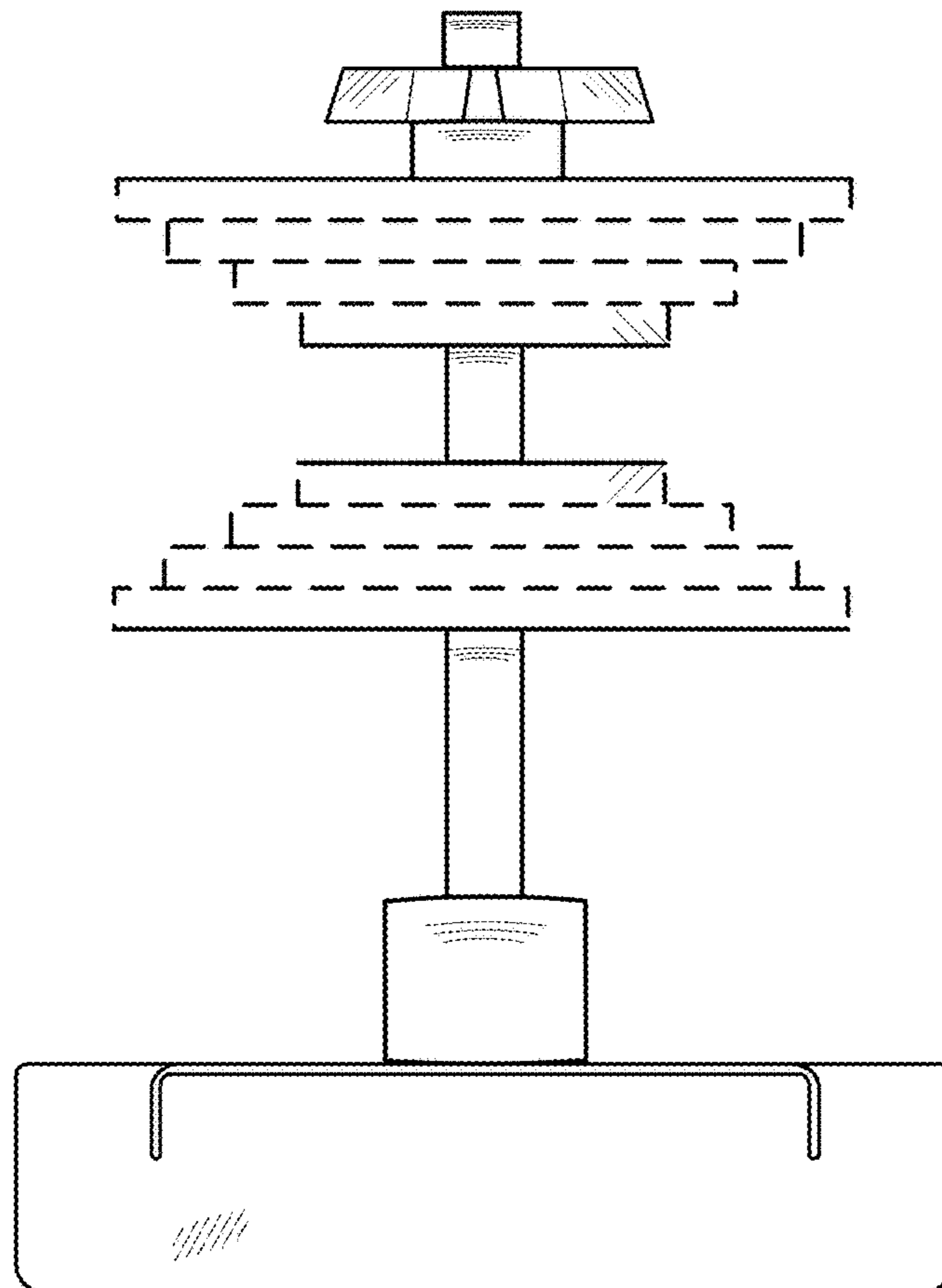

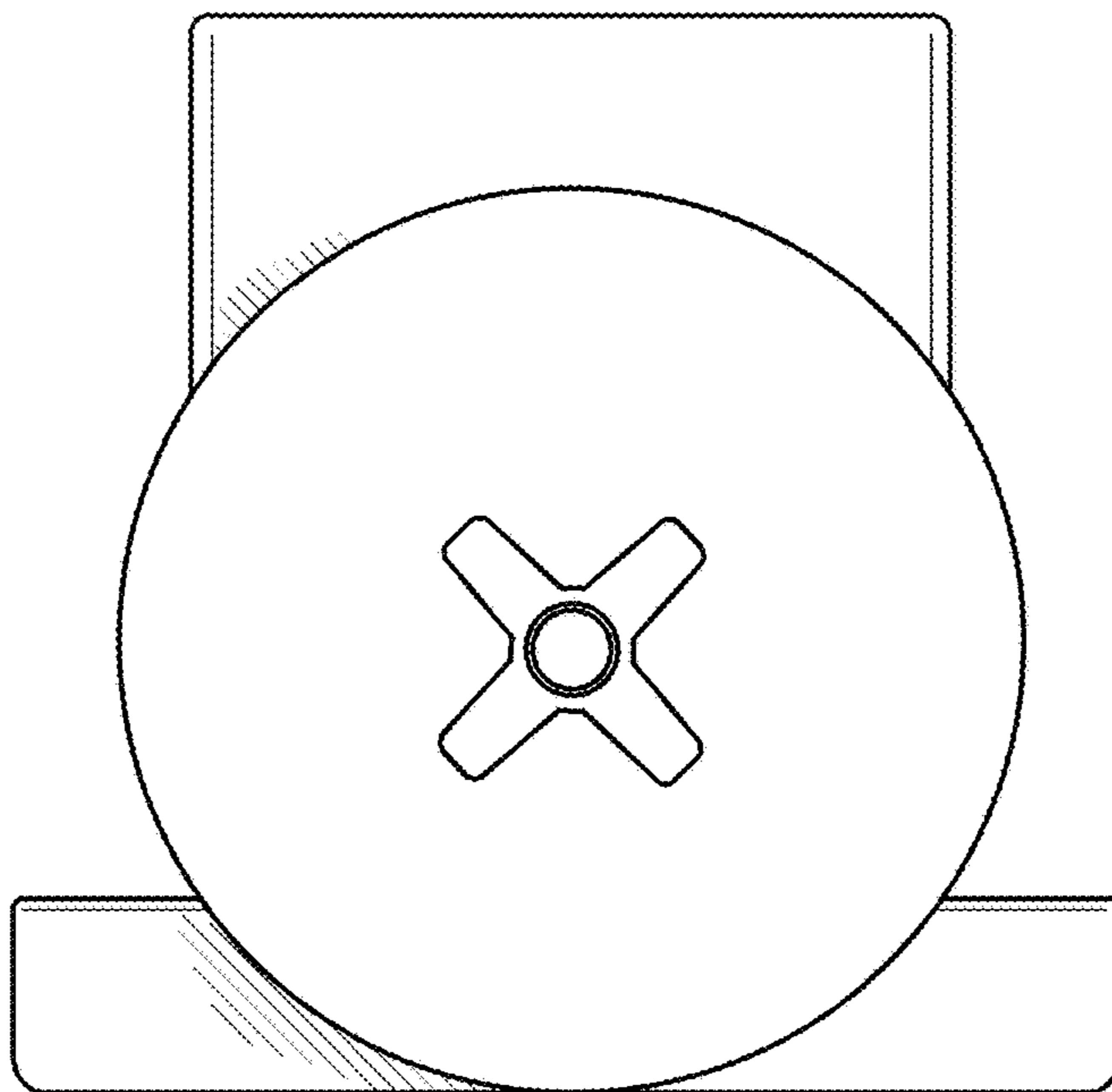

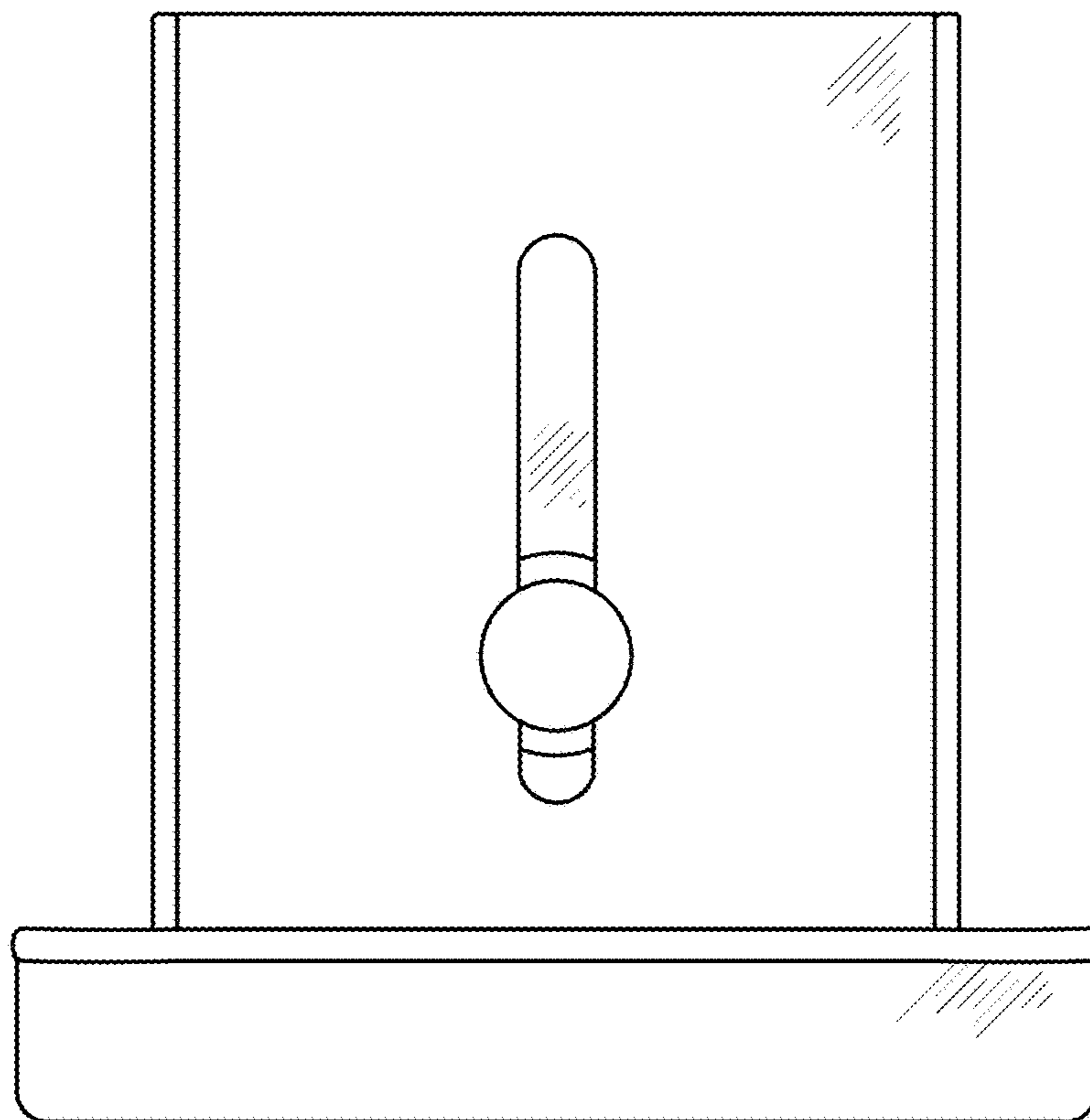

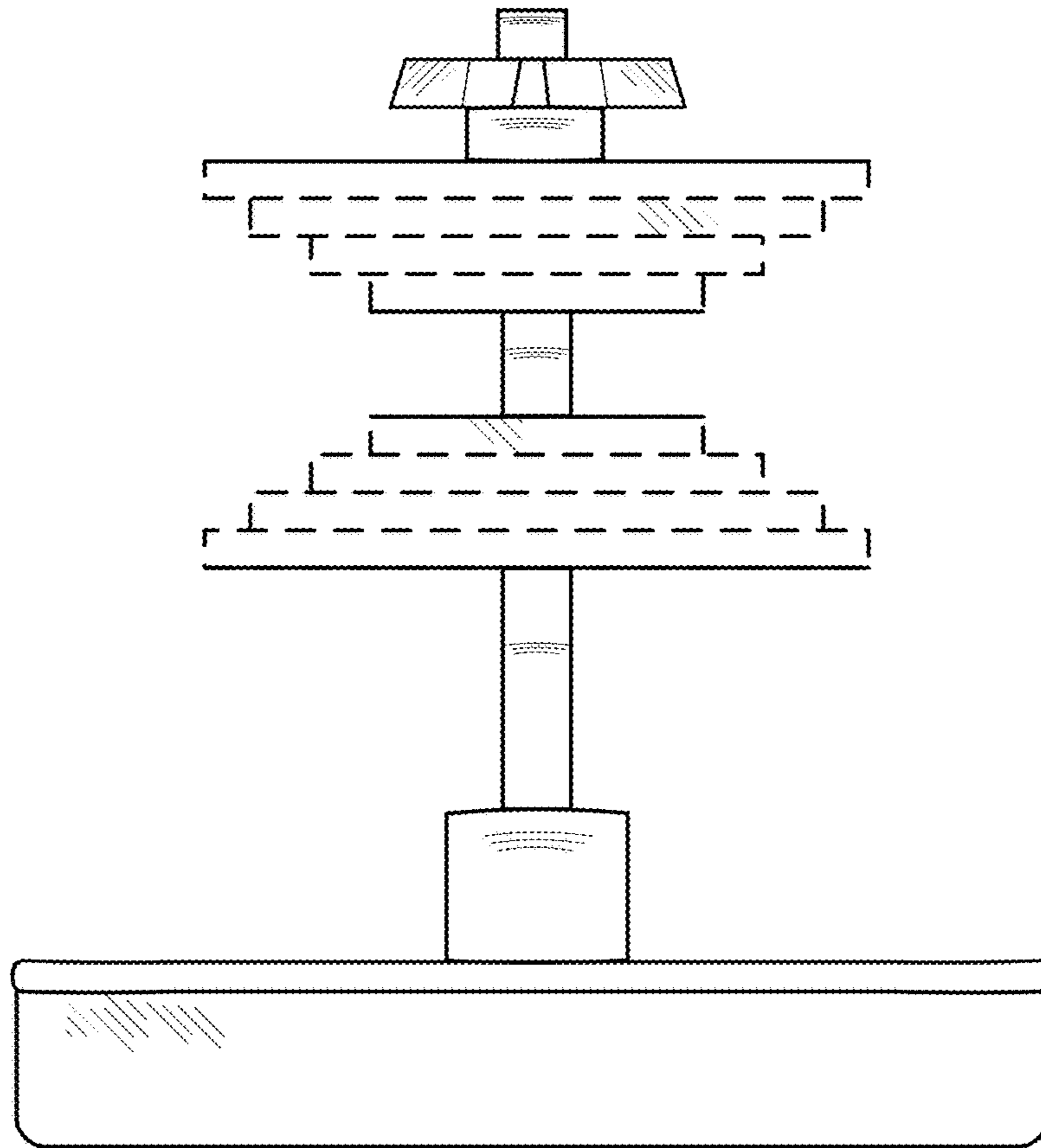

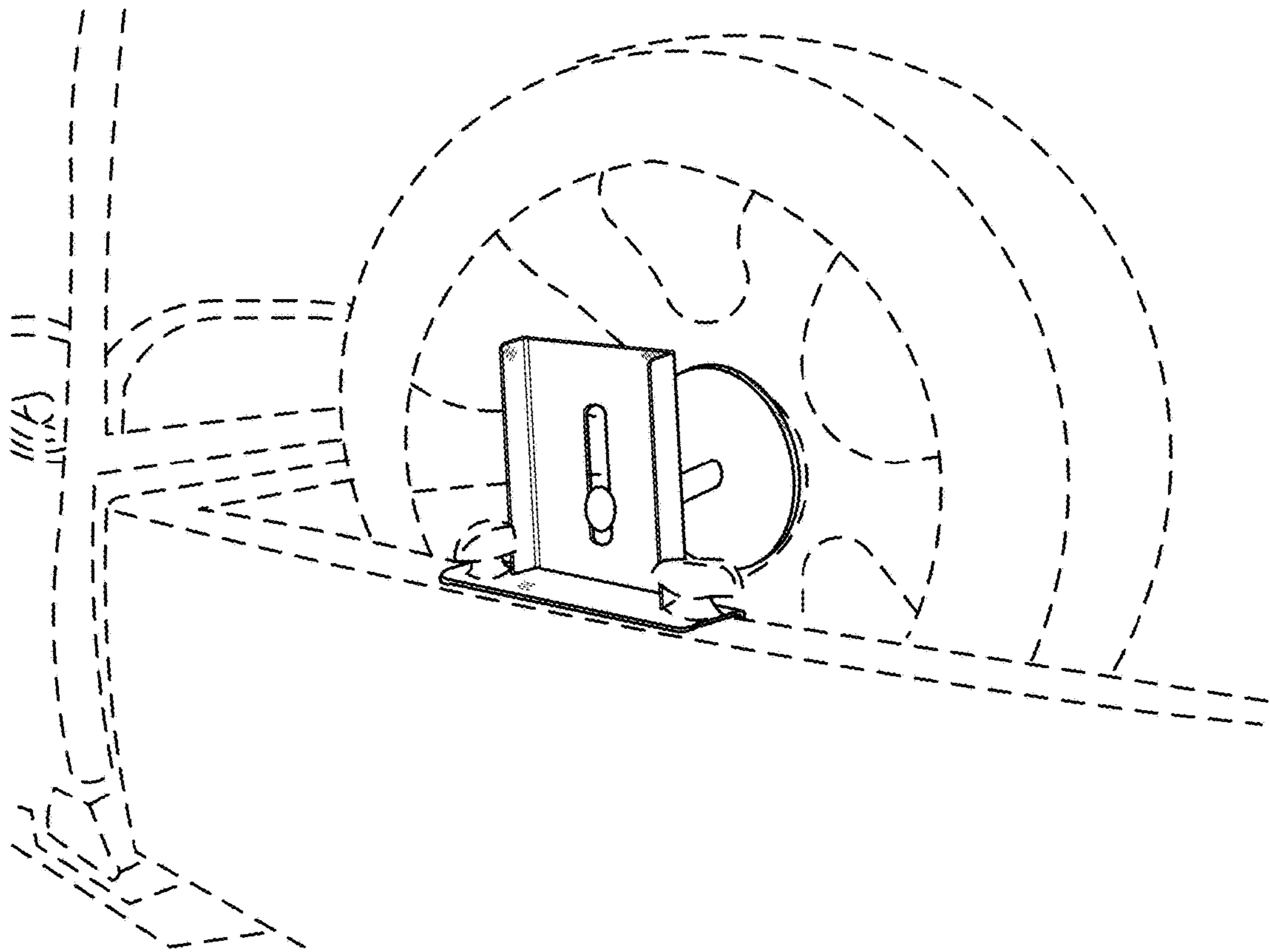
