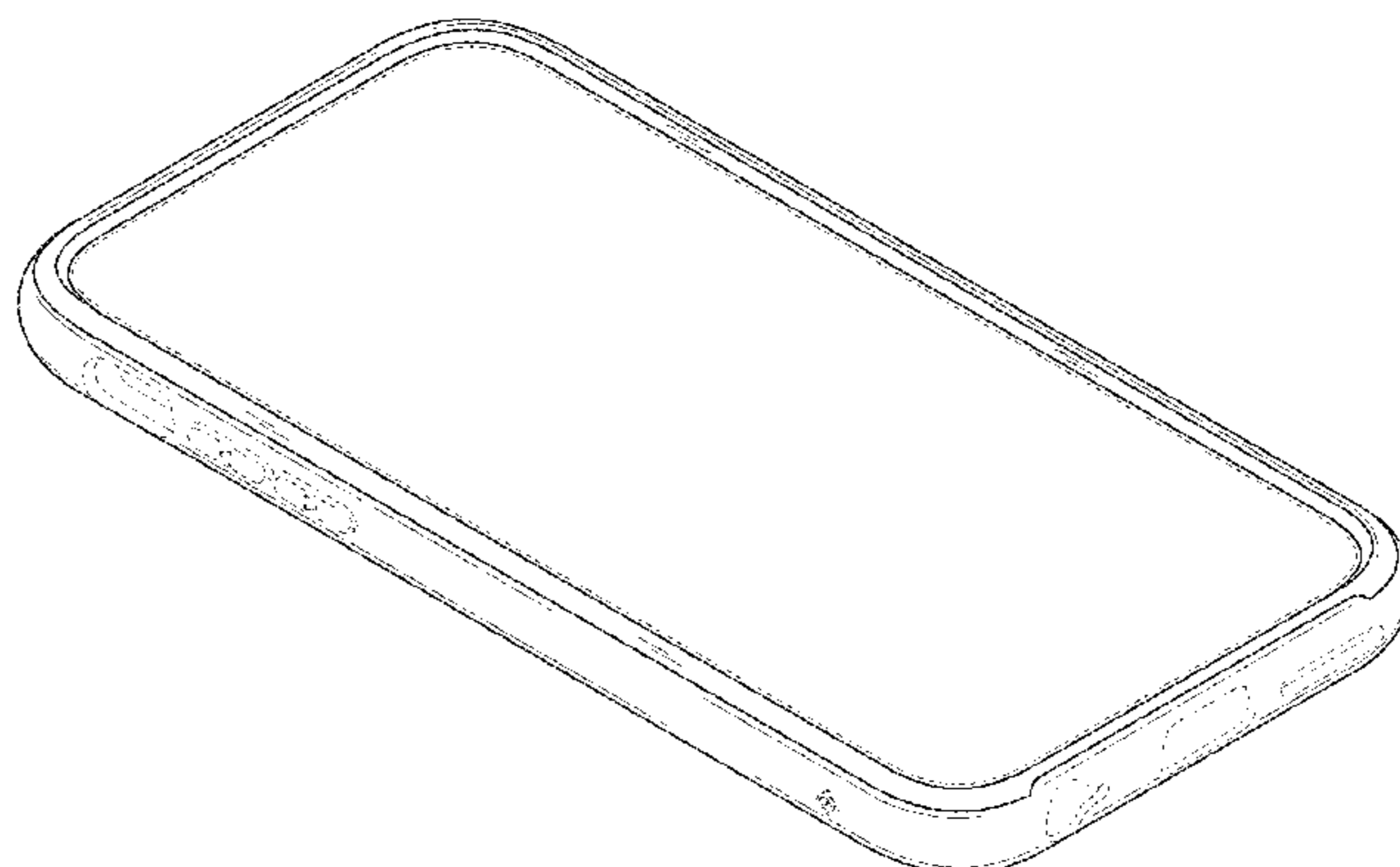
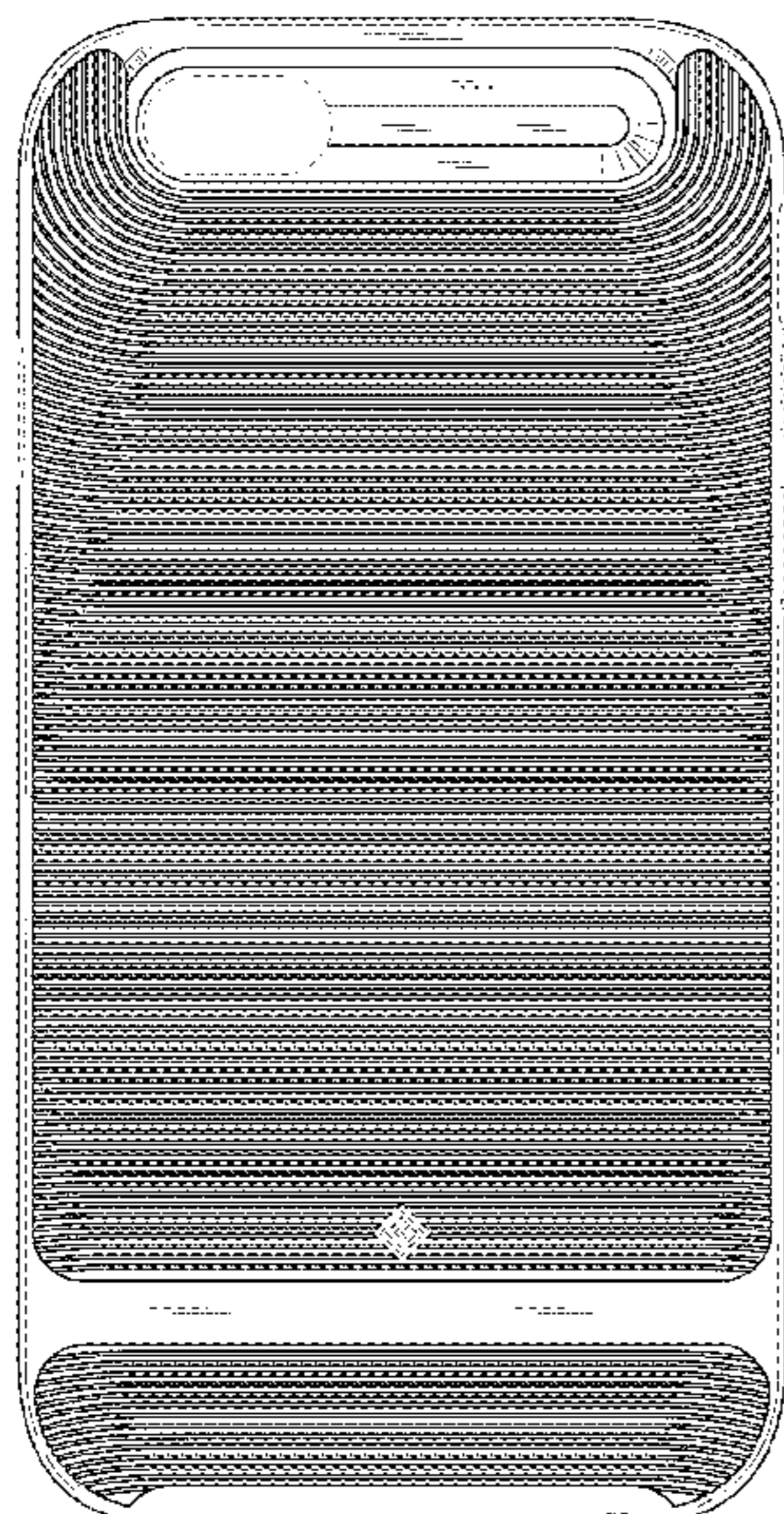
(57) **CLAIM**

The ornamental design for a phone case, as shown and described.

DESCRIPTION

FIG. 1 is an illustration of a front view of a phone case showing our new design;
FIG. 2 is an illustration of a back view of the phone case;
FIG. 3 is an illustration of a left side view of the phone case;
FIG. 4 is an illustration of a right side view of the phone case;
FIG. 5 is an illustration of a top view of the phone case;
FIG. 6 is an illustration of a bottom view of the phone case;
FIG. 7 is an illustration of an isometric view of the back of the phone case; and,
FIG. 8 is an illustration of an isometric view of the front of the phone case.
The broken lines immediately adjacent the shaded surfaces represent the bounds of the claimed design. 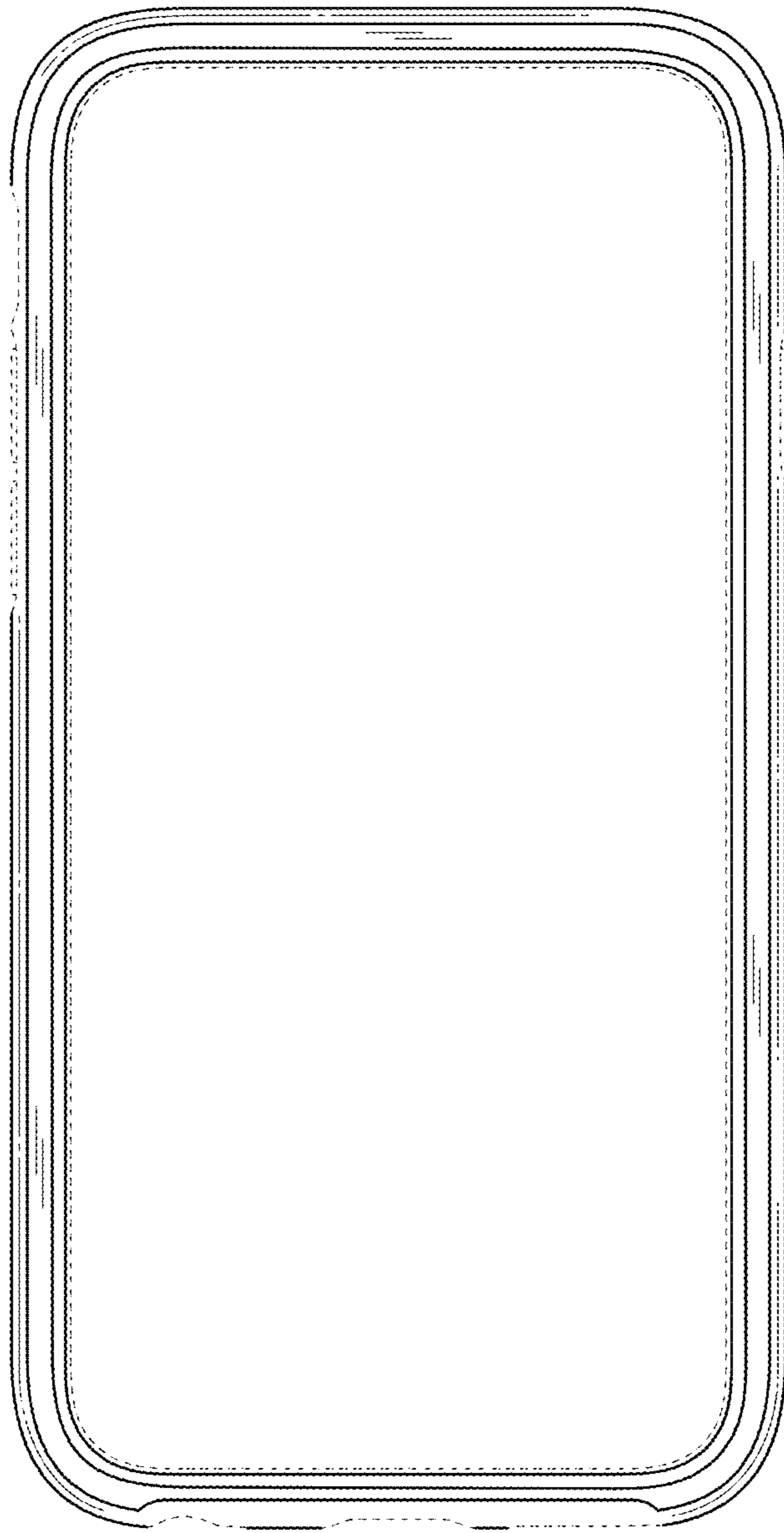

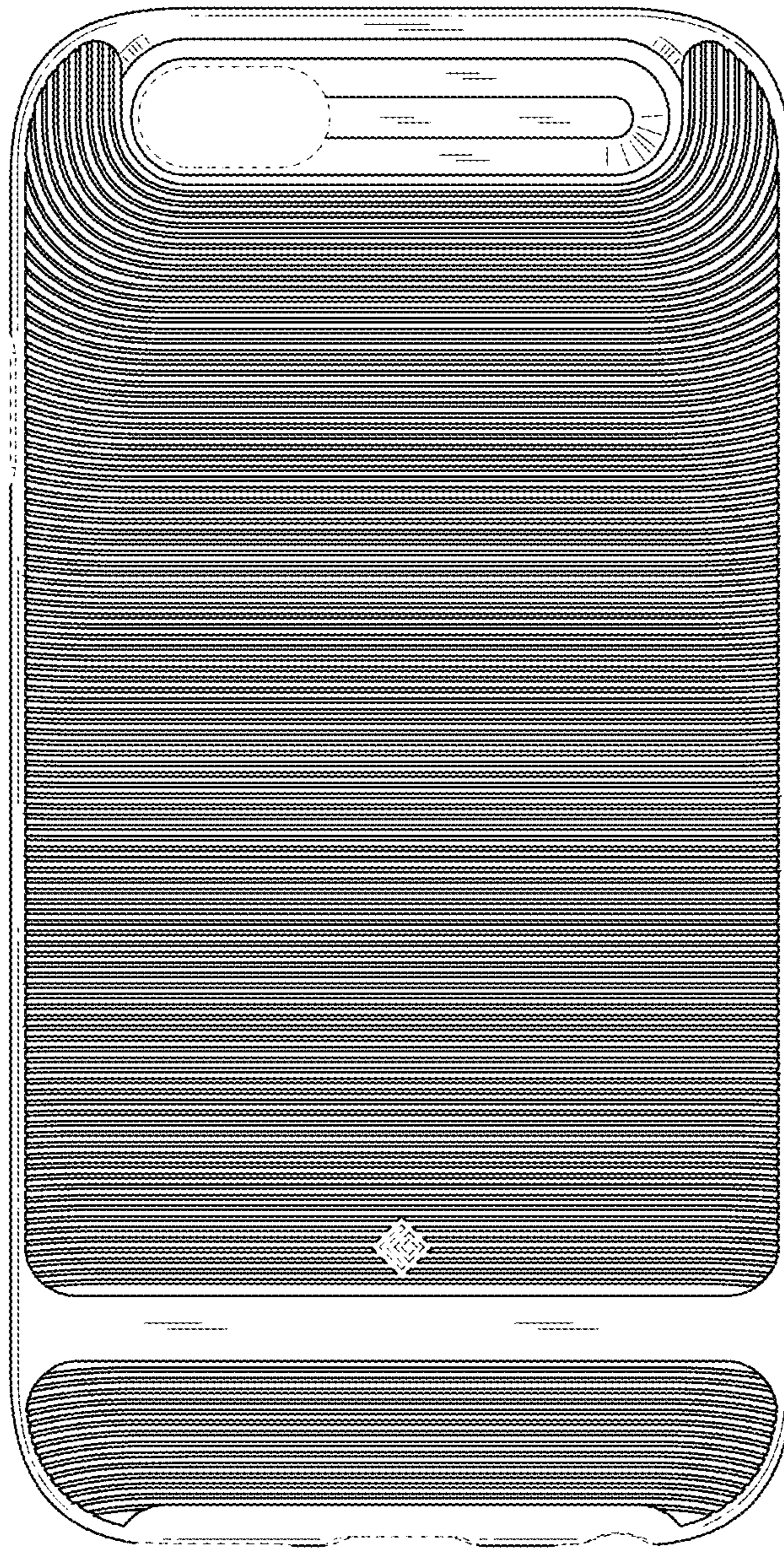

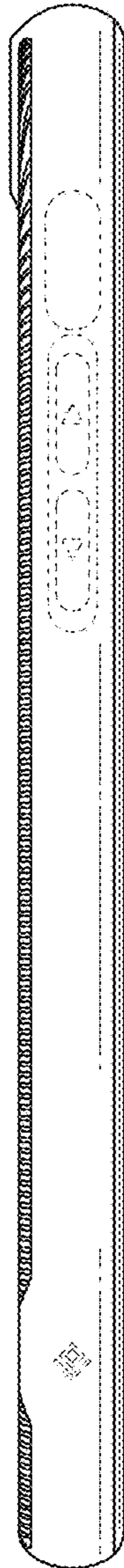

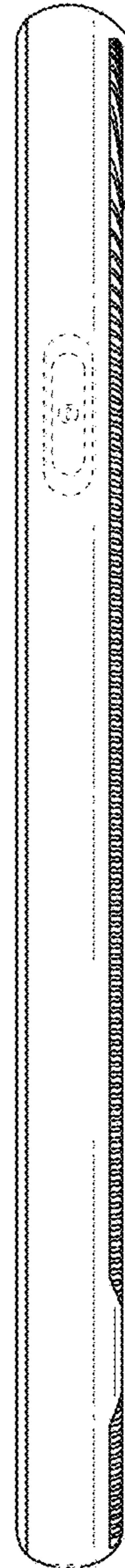

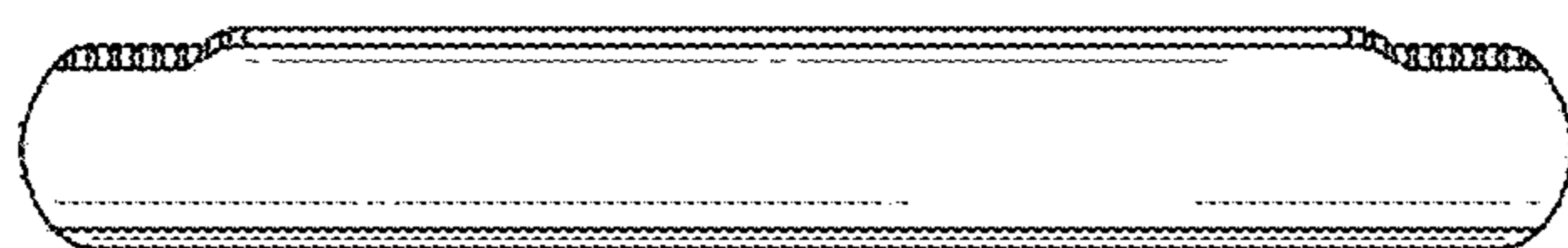

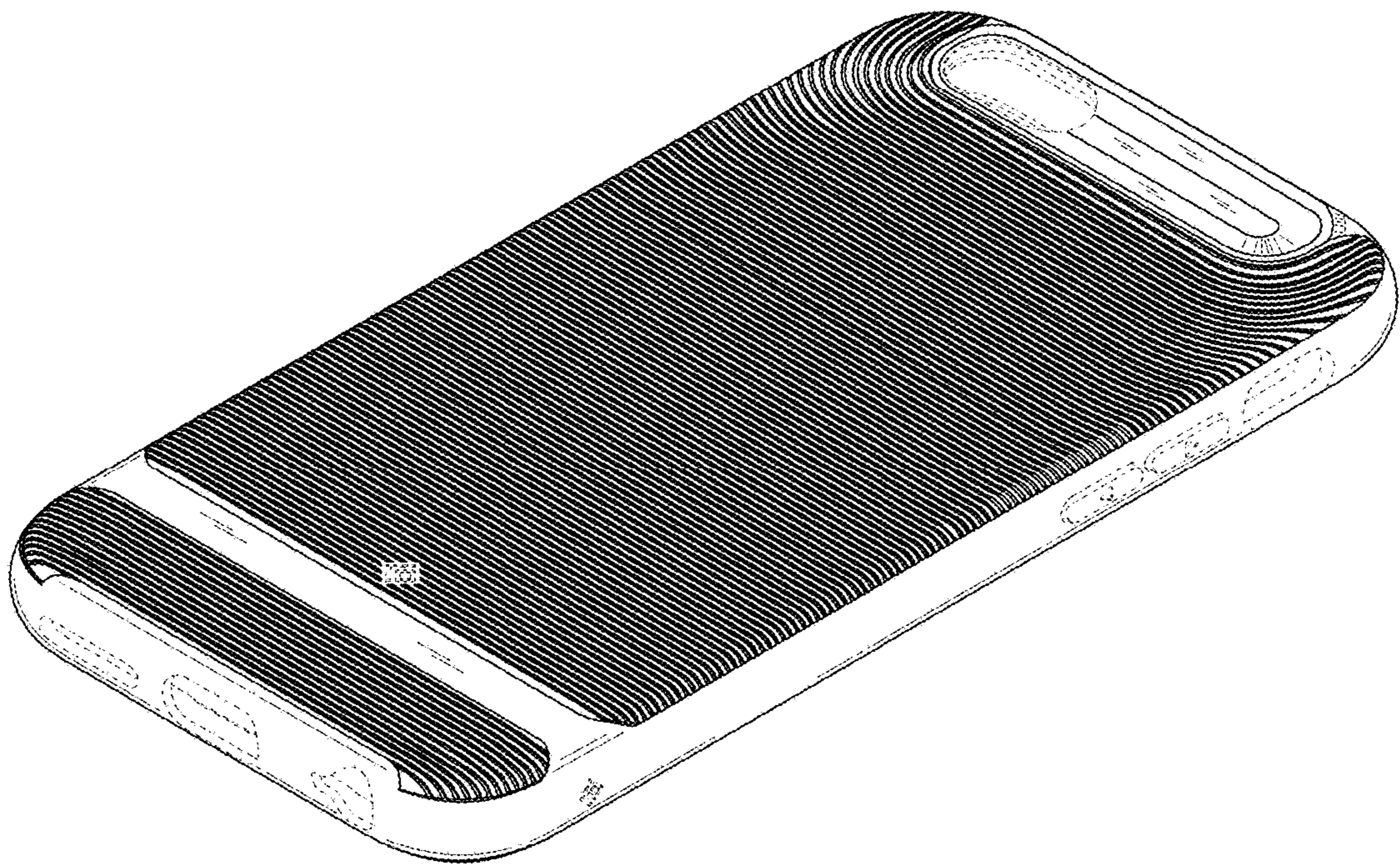

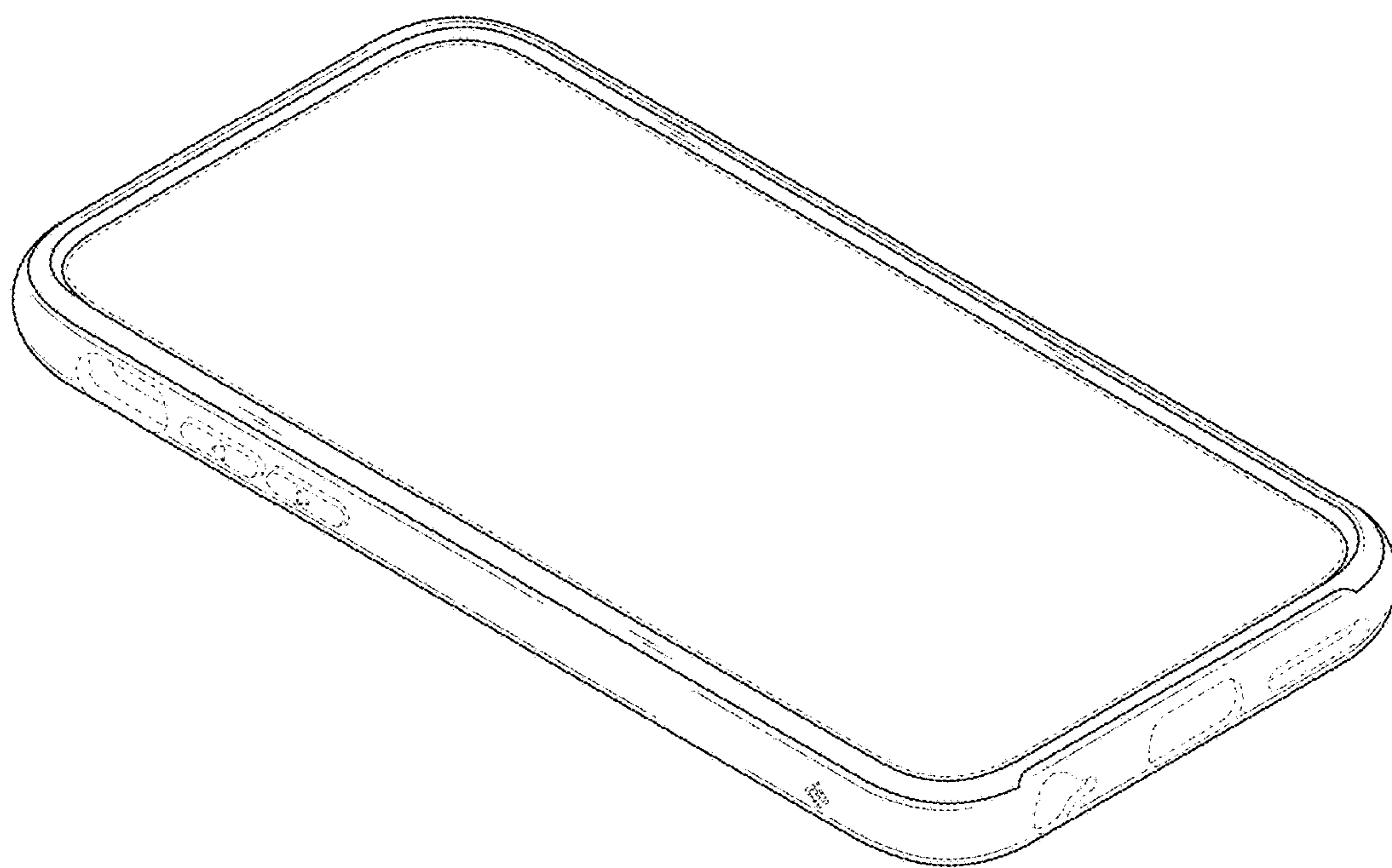
