(57) **CLAIM**

We claim the ornamental design for a display screen with an animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image in a sequence for a display screen with an animated graphical user interface showing our new design;

FIG. 4 is a fourth image thereof;

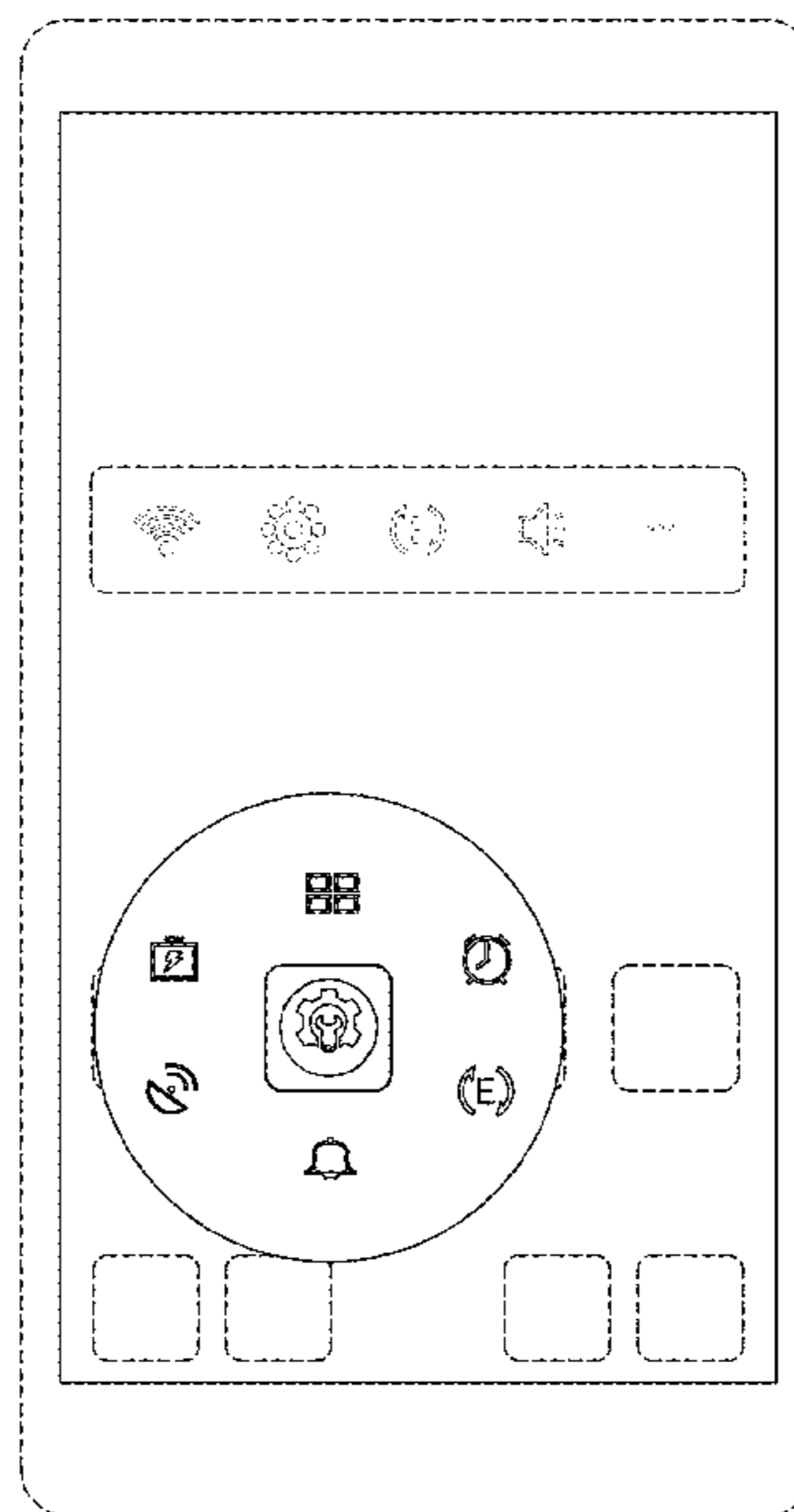
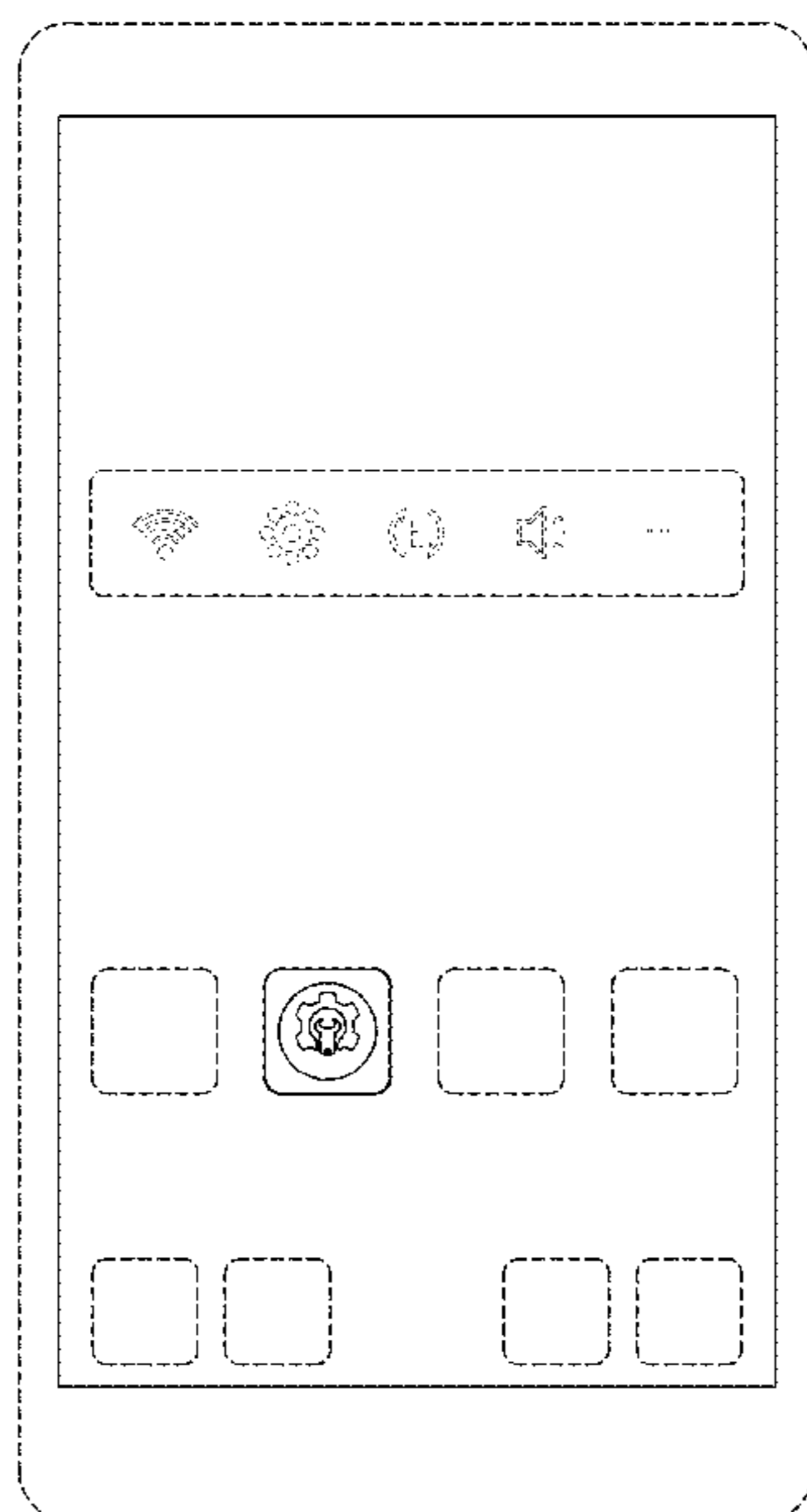
FIG. 5 is a fifth image thereof; and,

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-6. The process or period in which one image transitions to another forms no part of the claimed design.

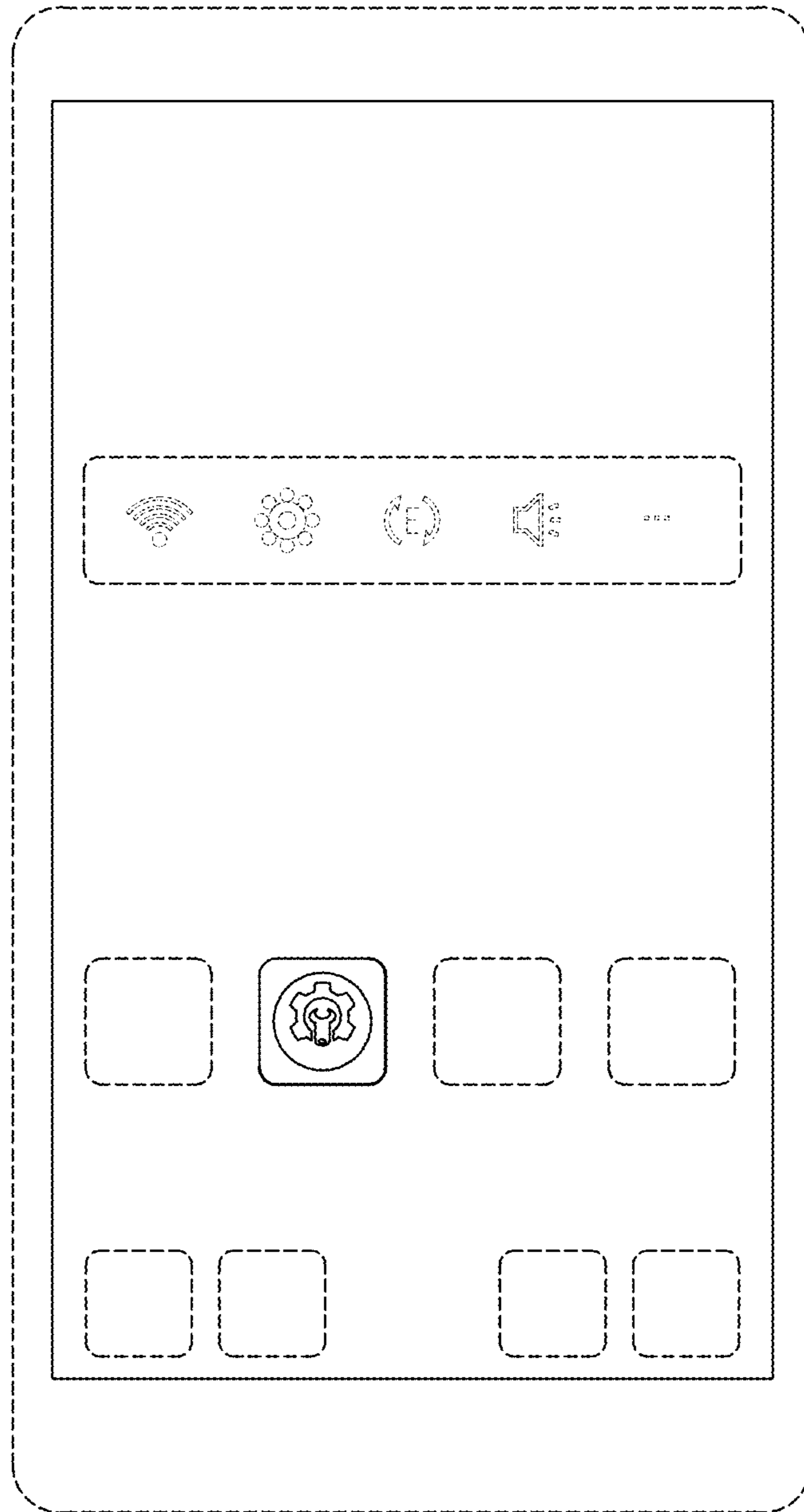

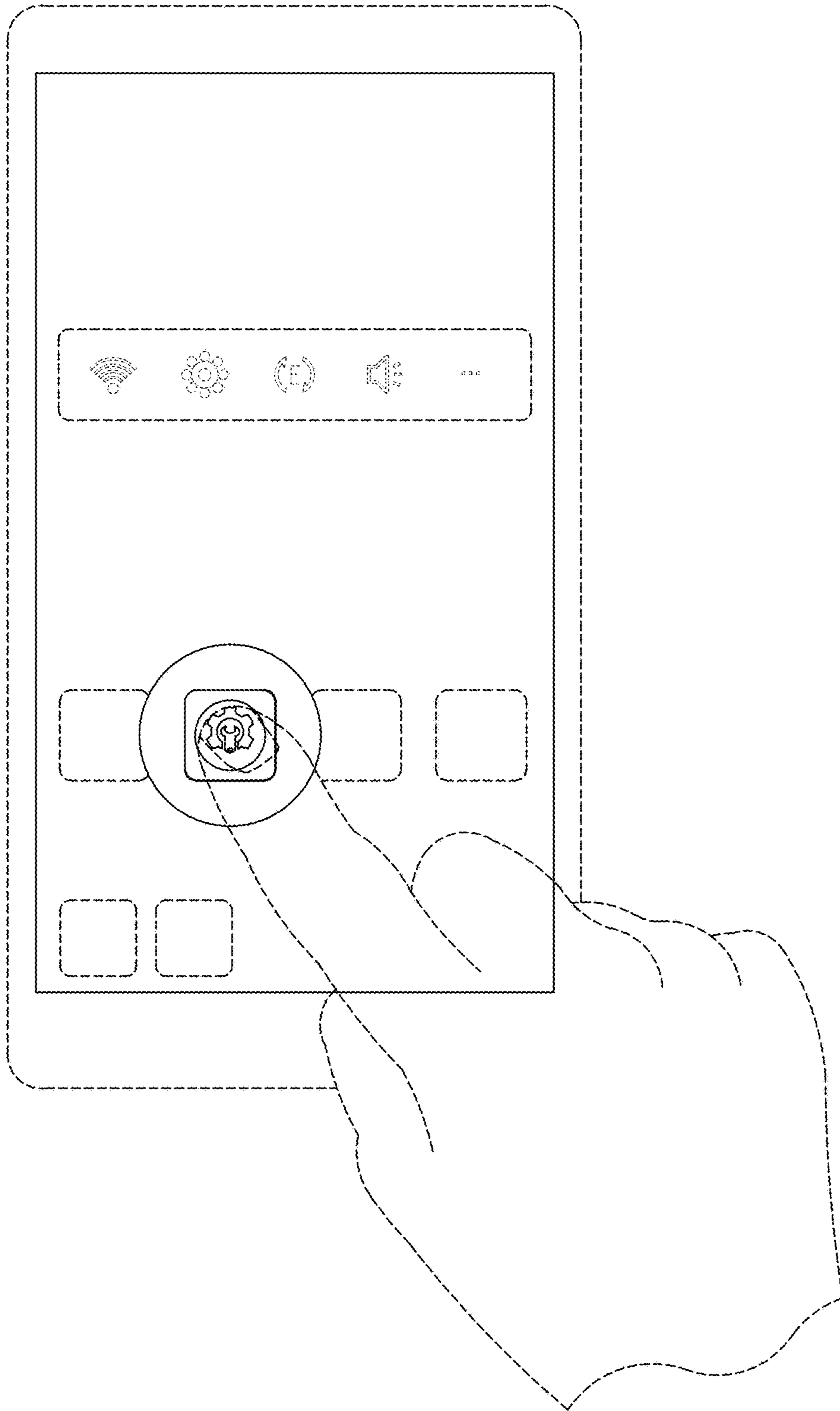

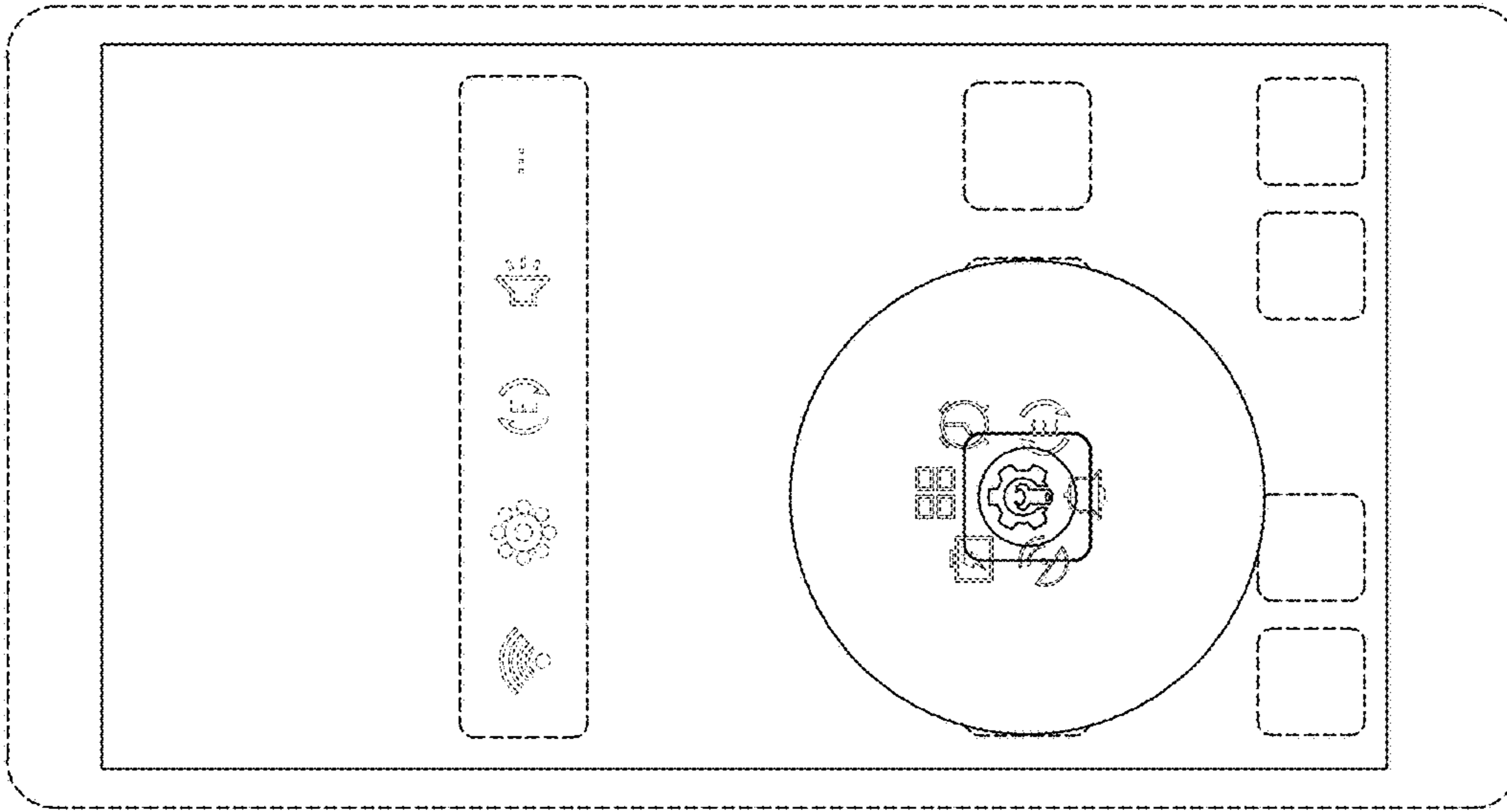

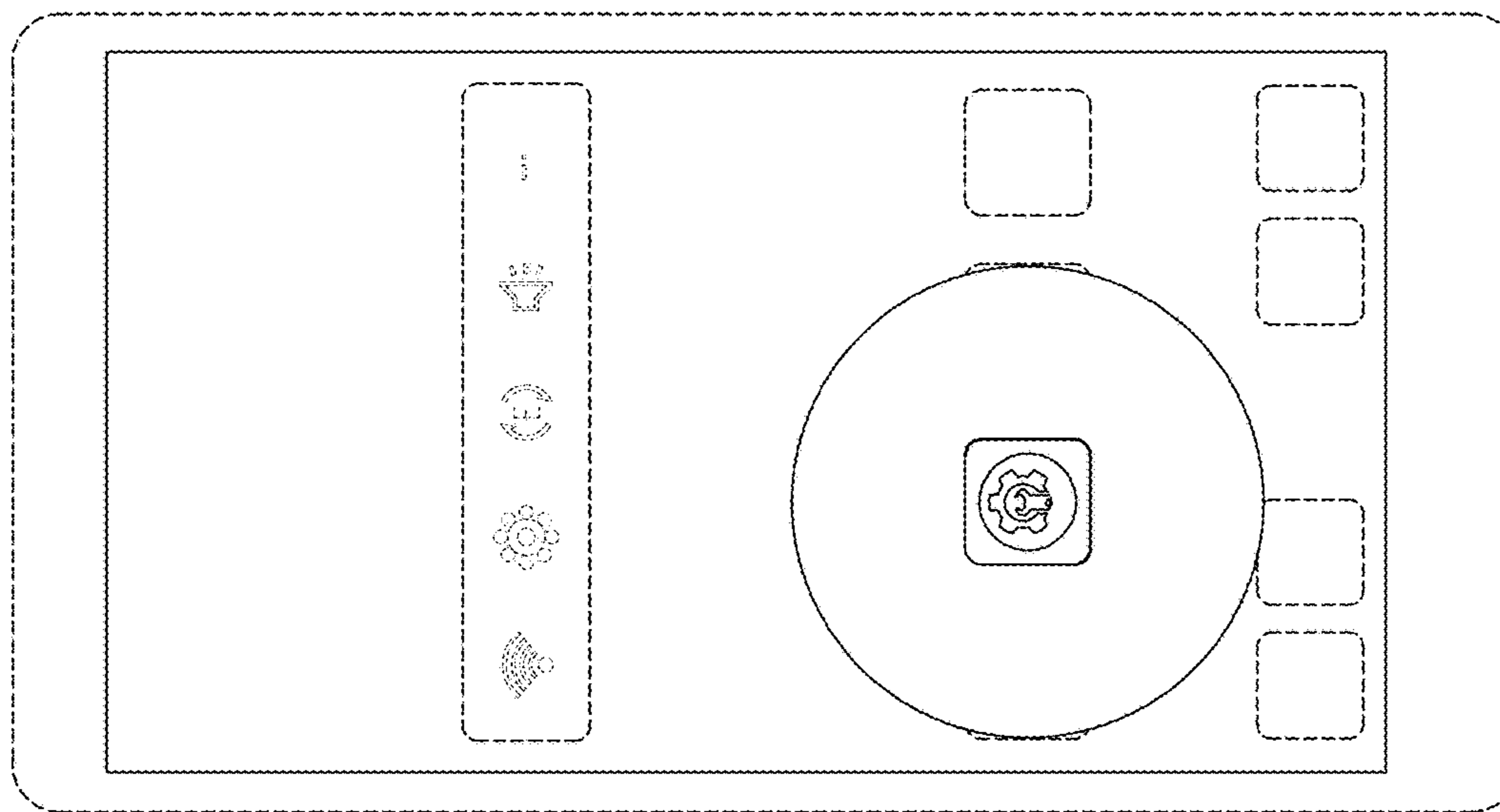

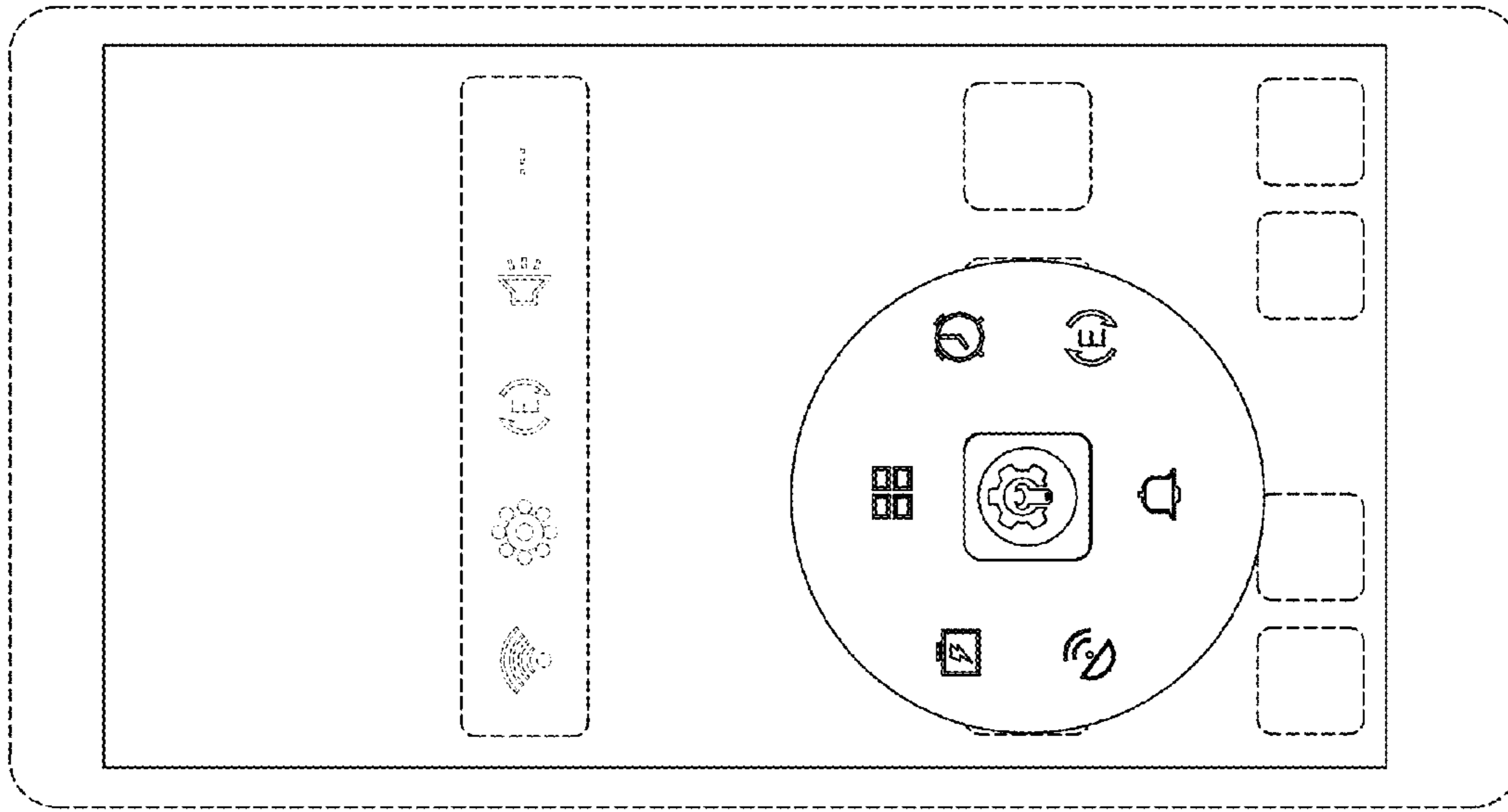

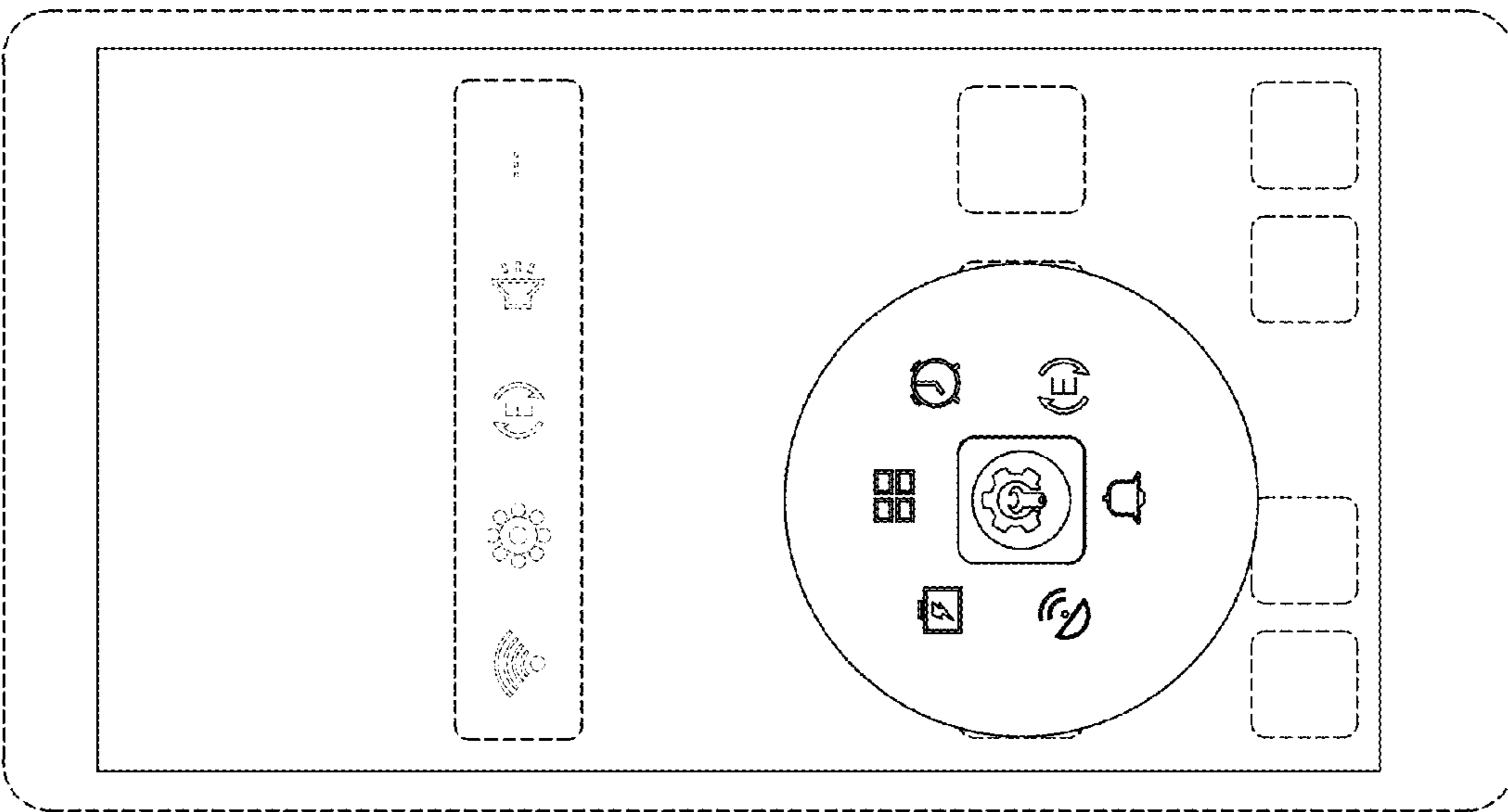
