We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

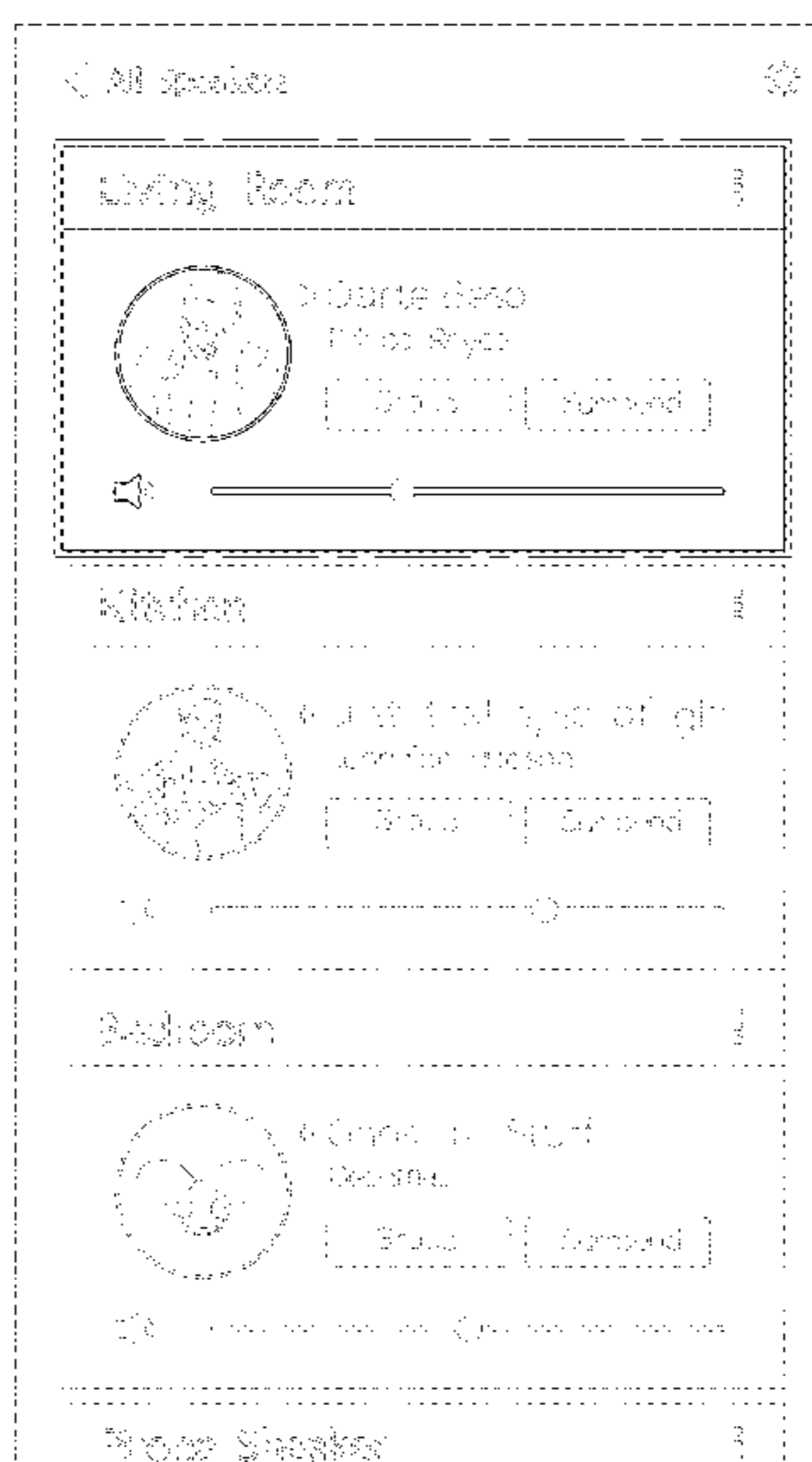
DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; and, FIG. 2 is another front view thereof in which a display screen in broken lines is provided to illustrate an example environment.
