FIG. 10 is a second image thereof;

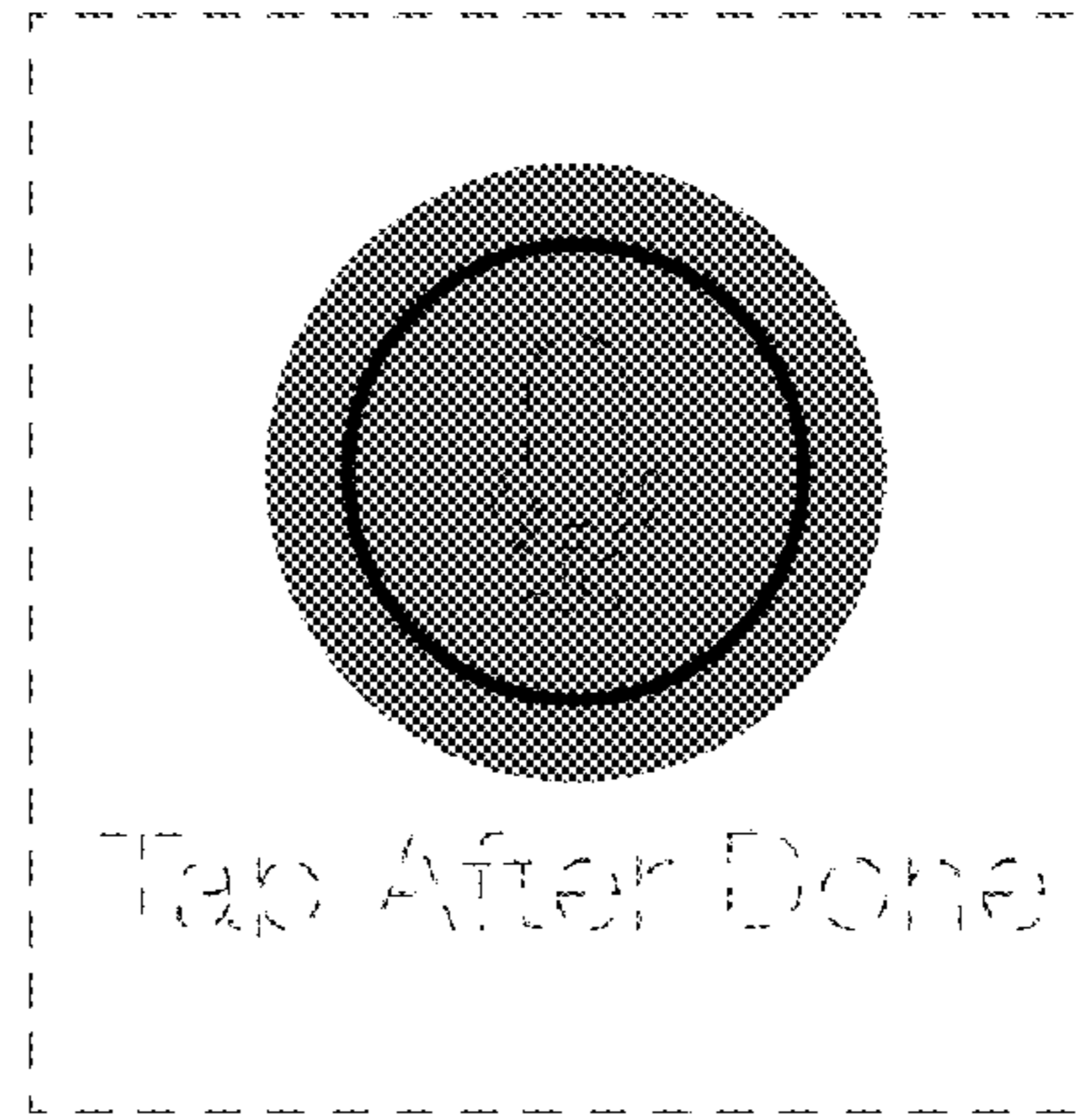

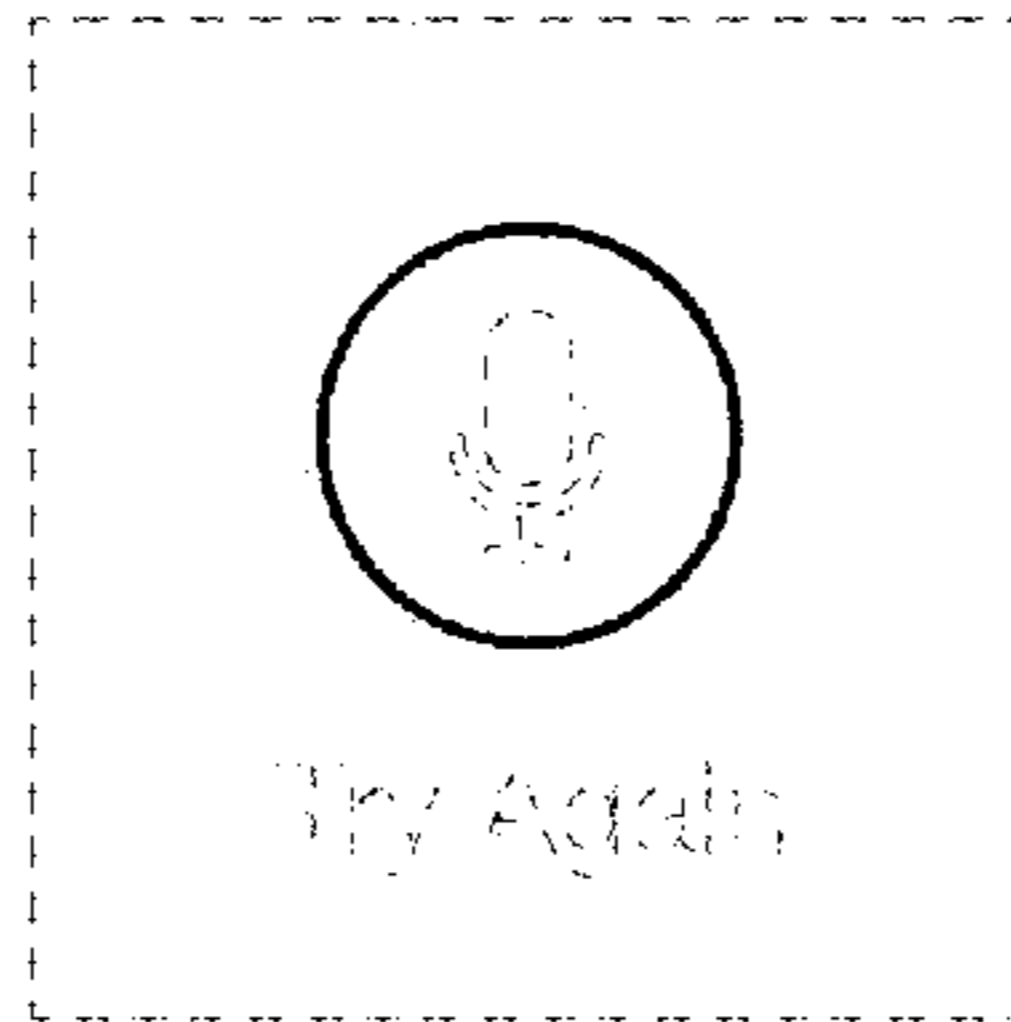

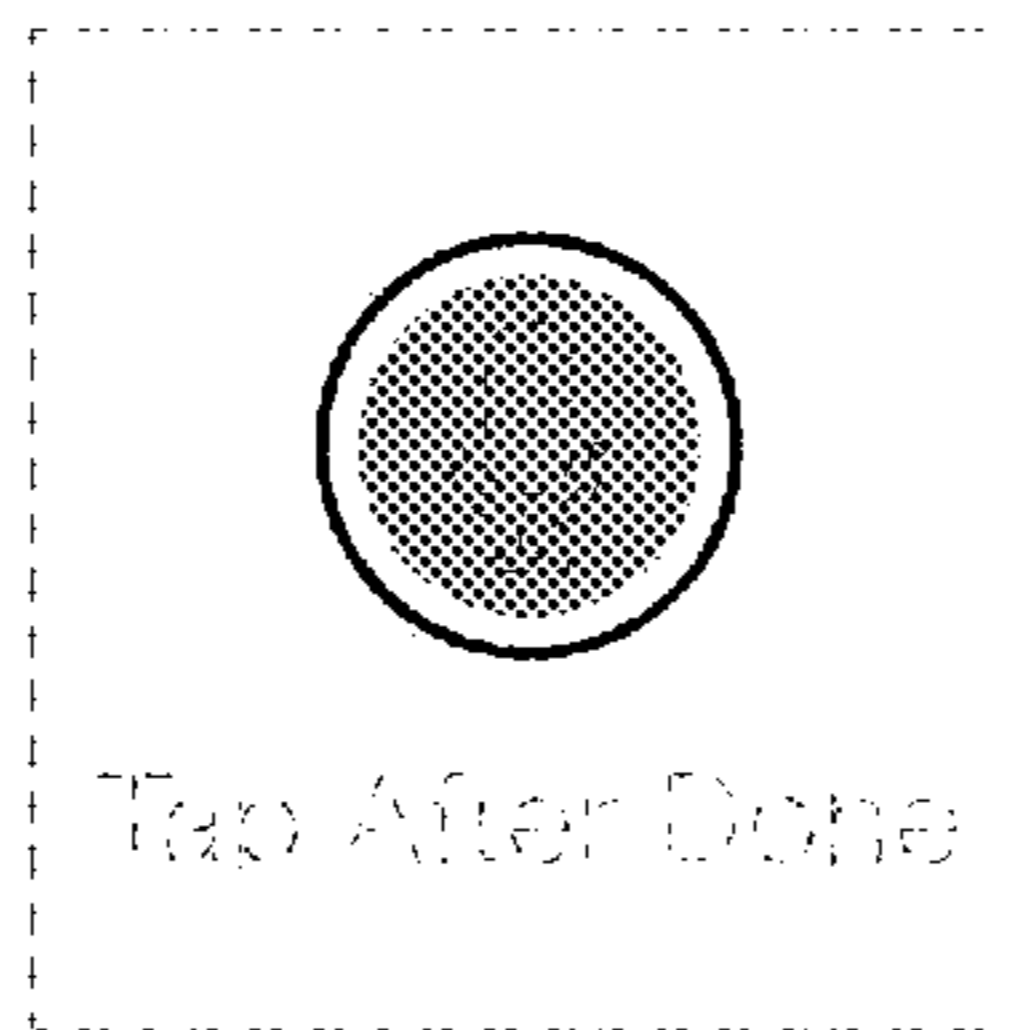

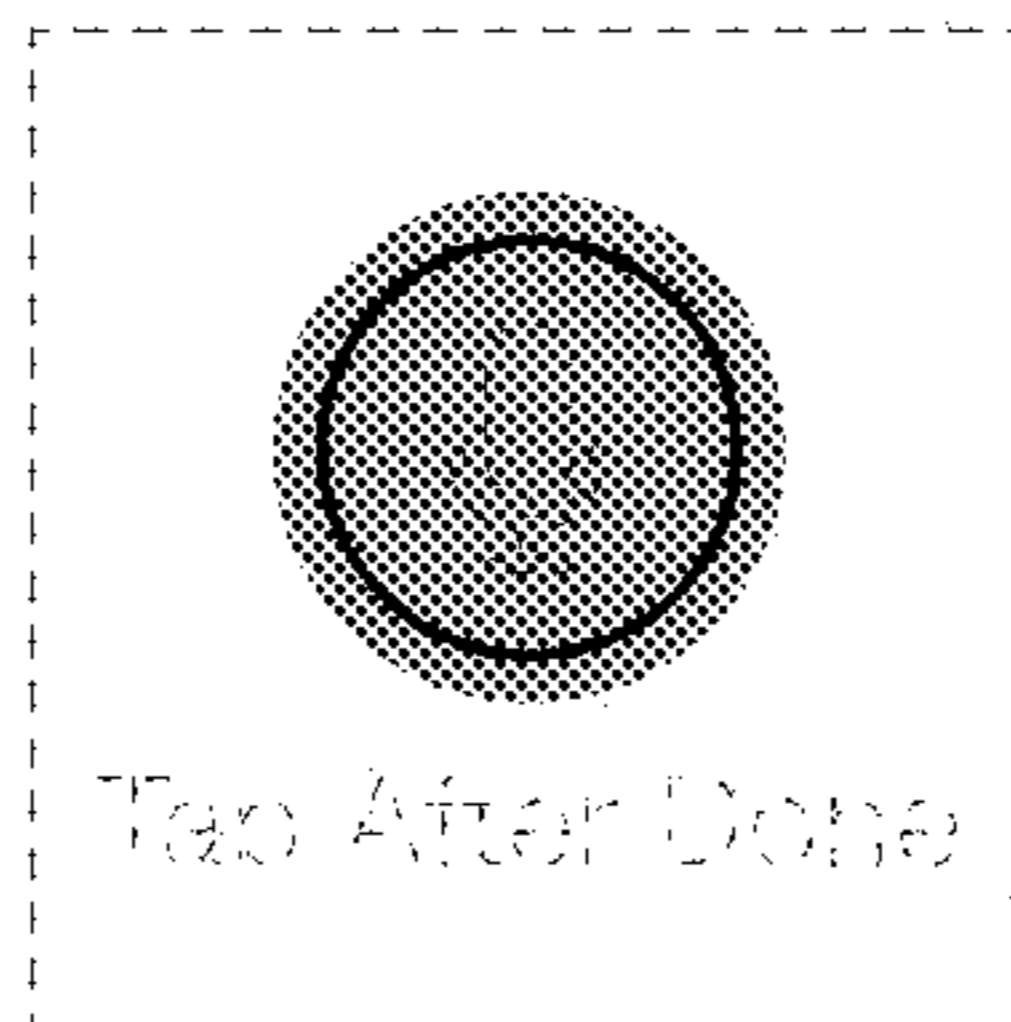

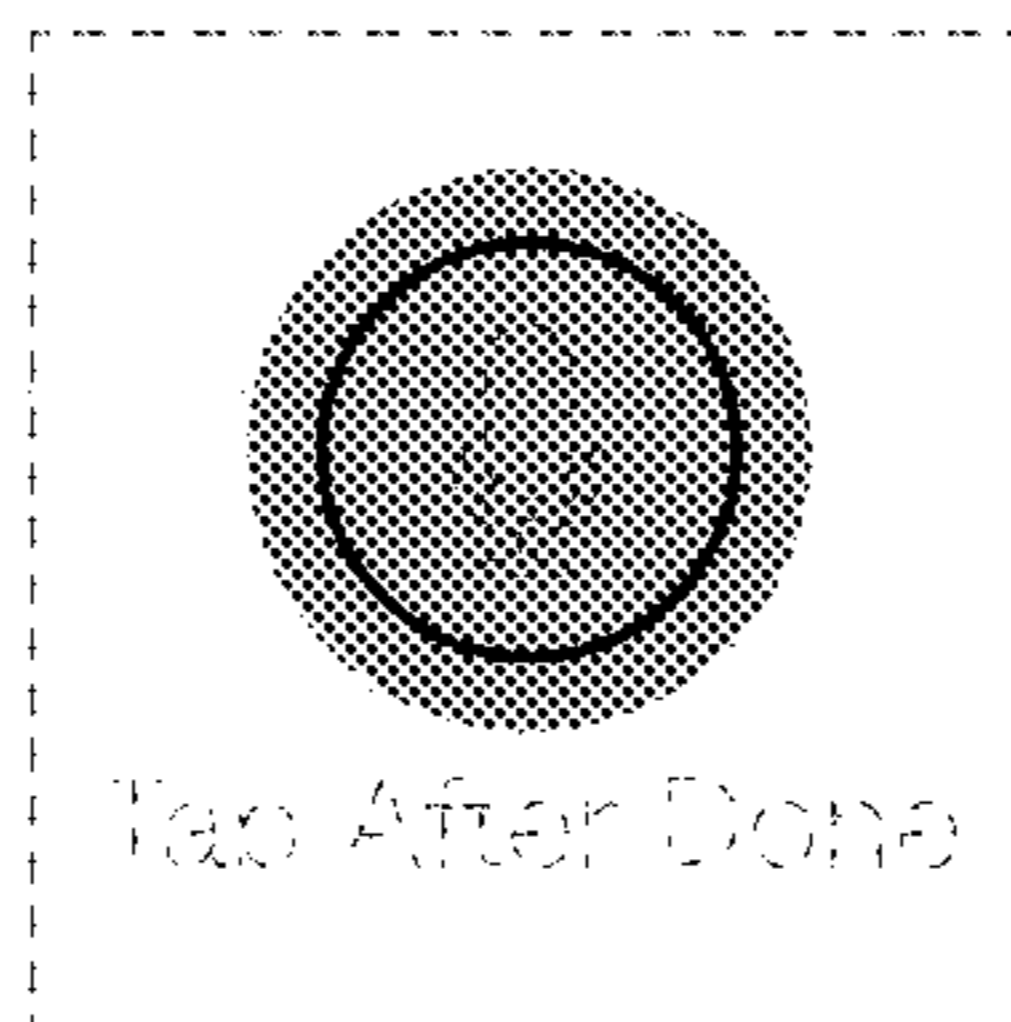

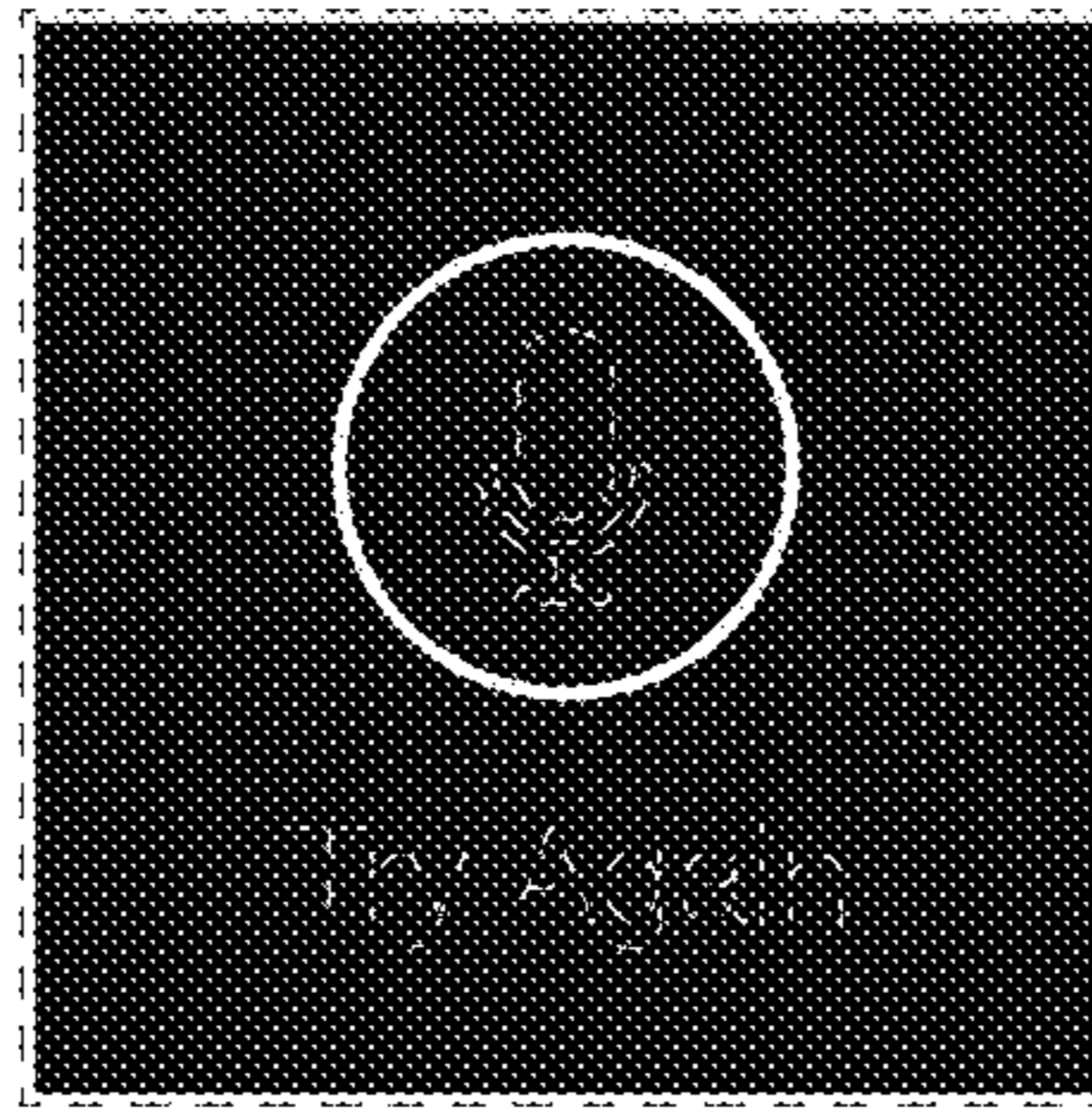

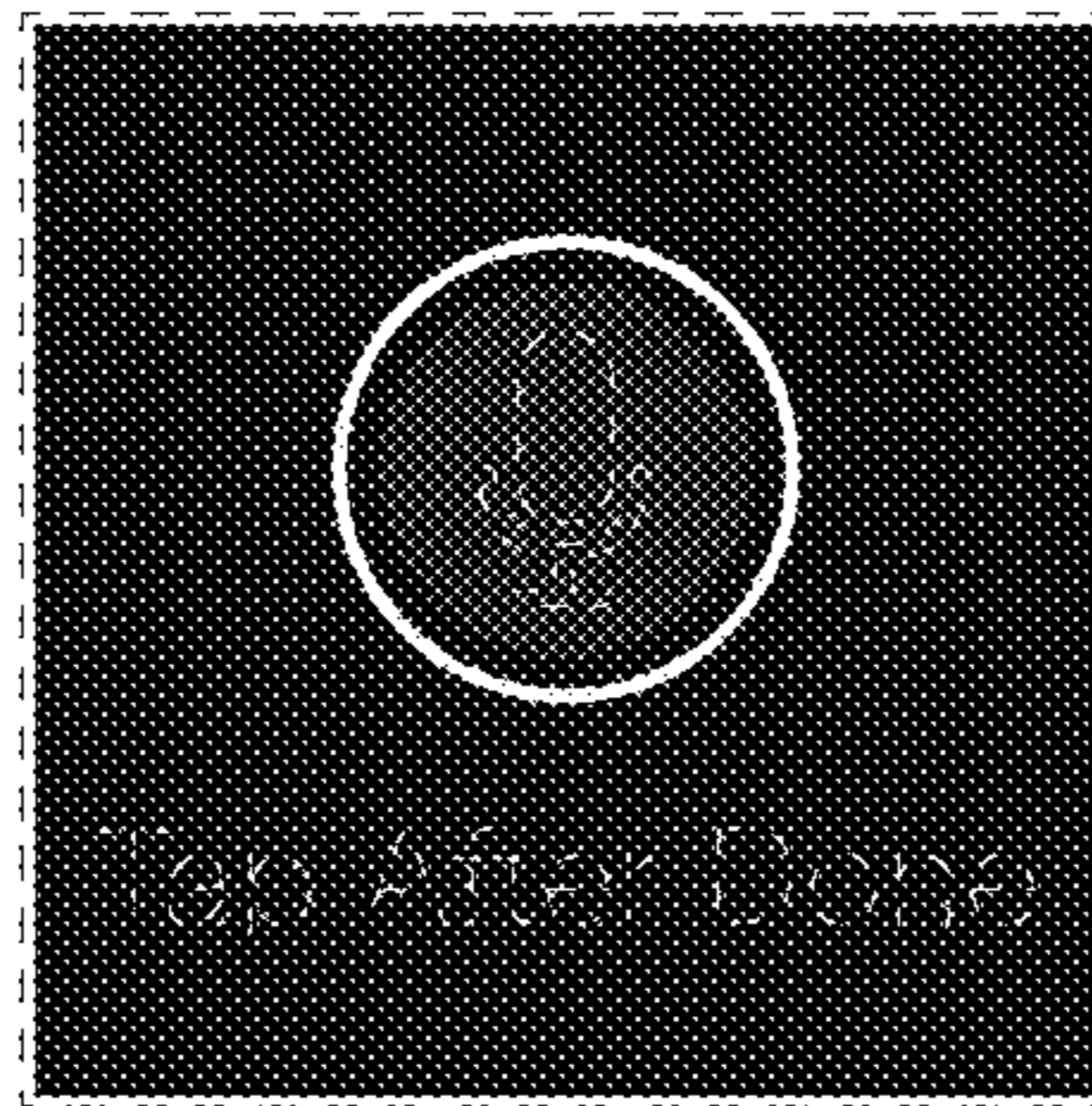

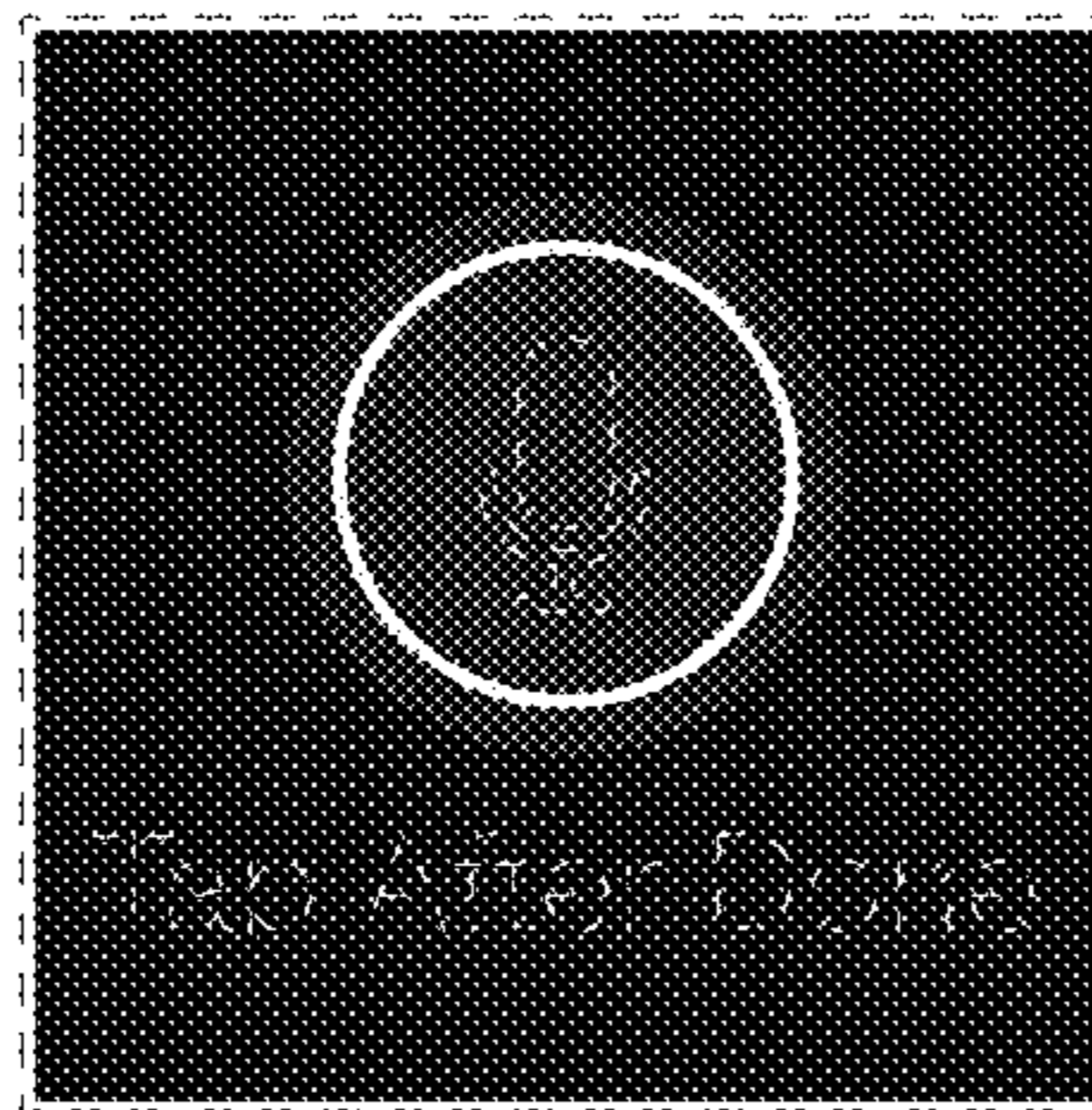

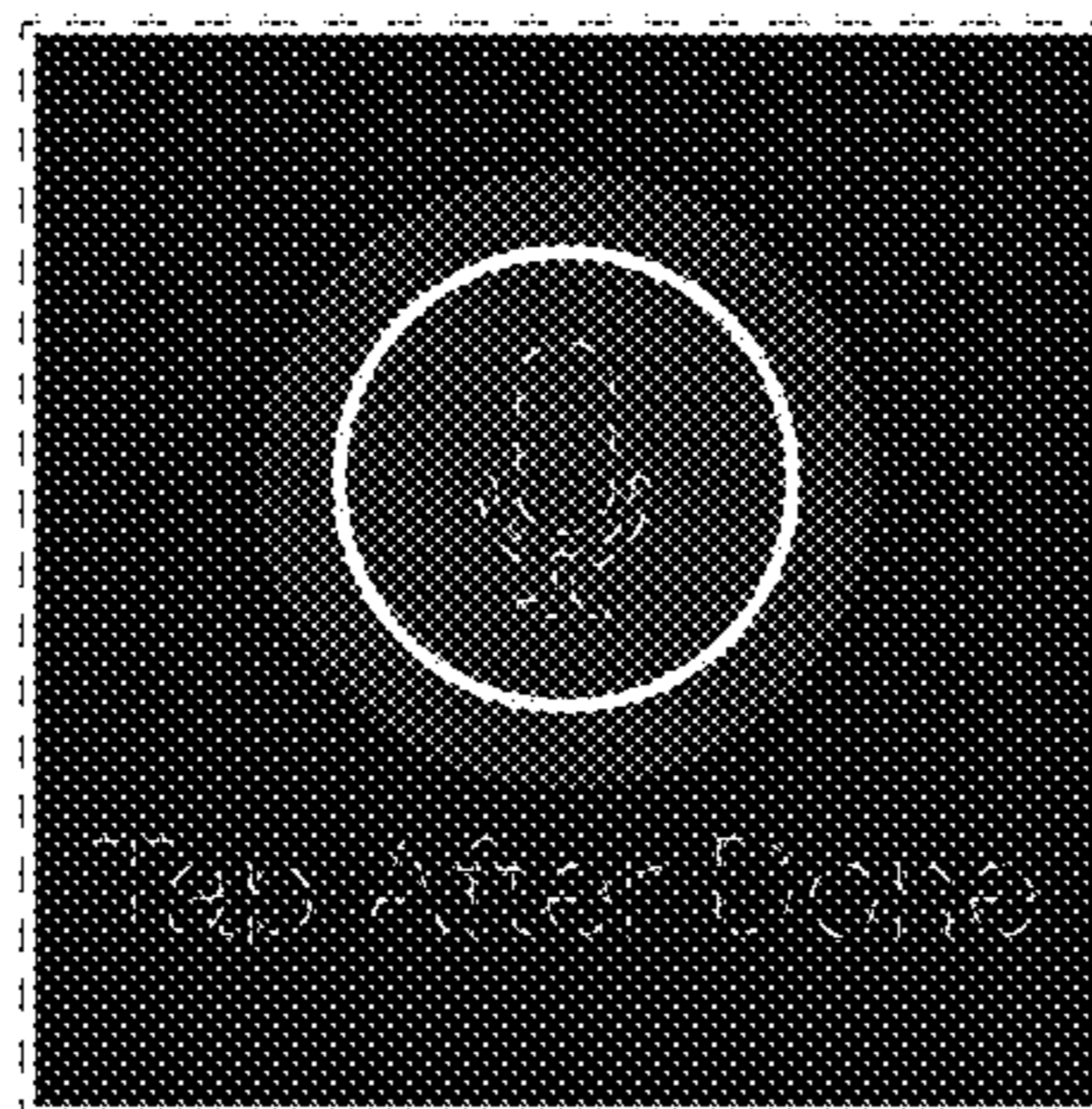

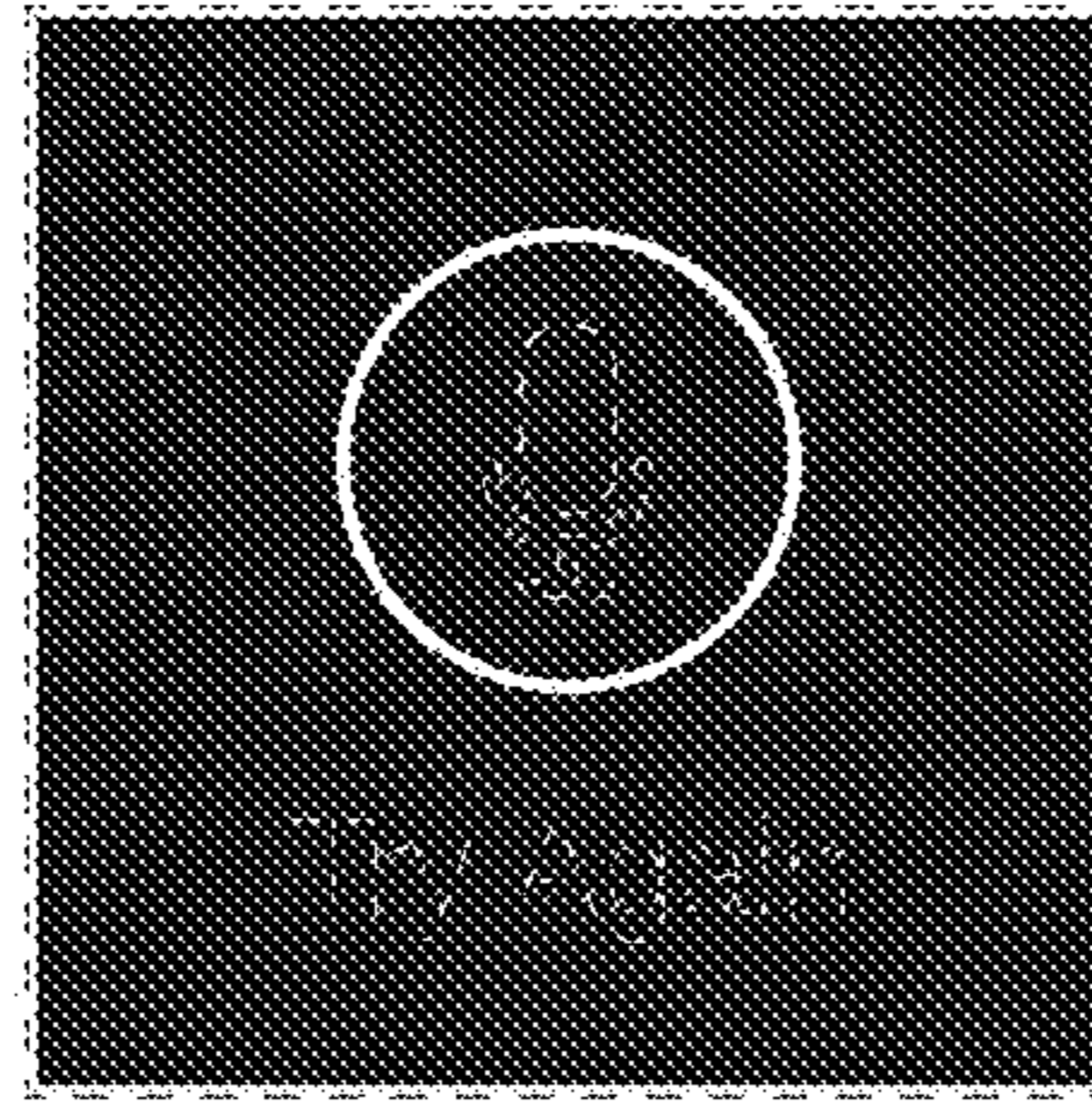

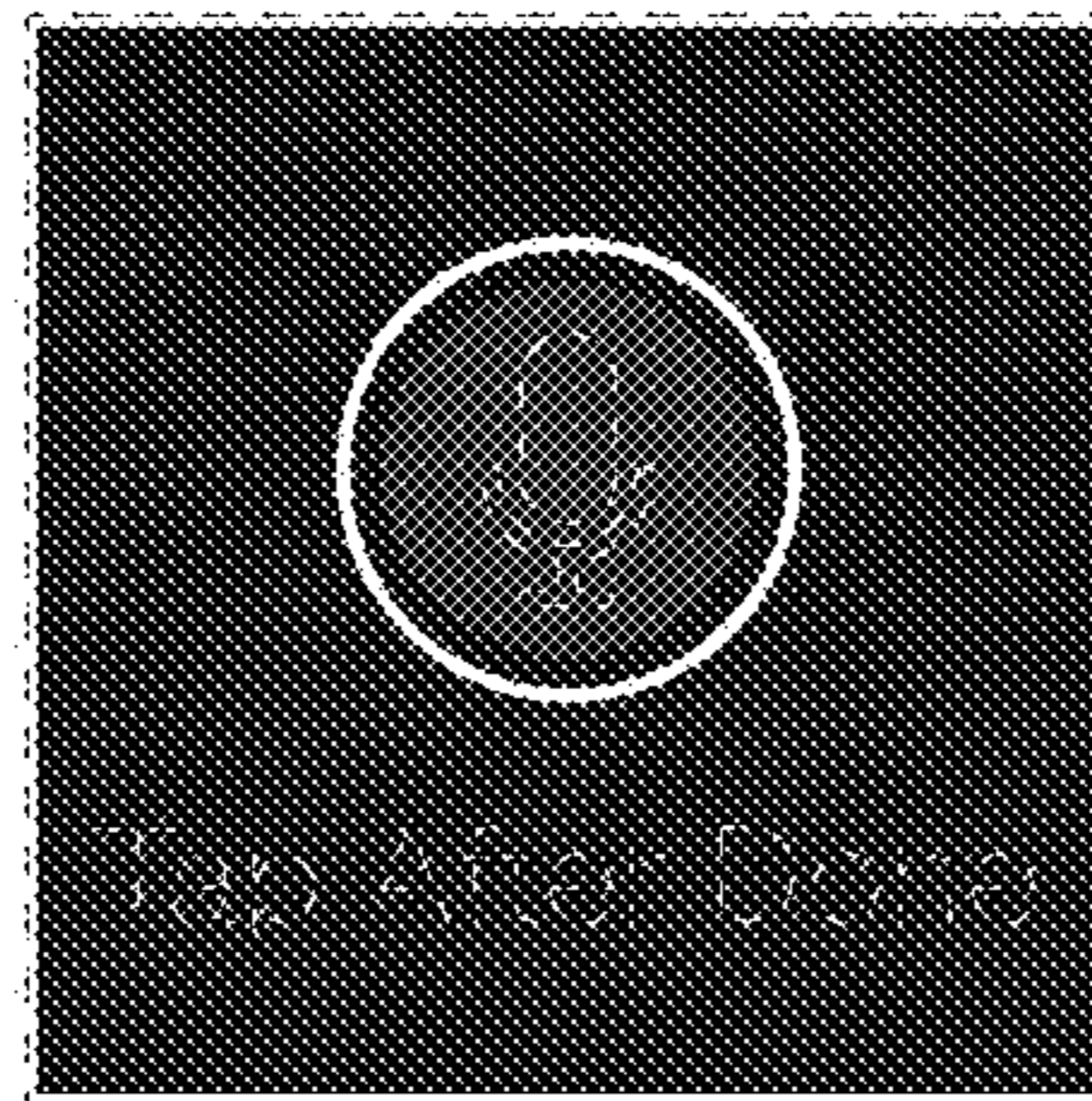

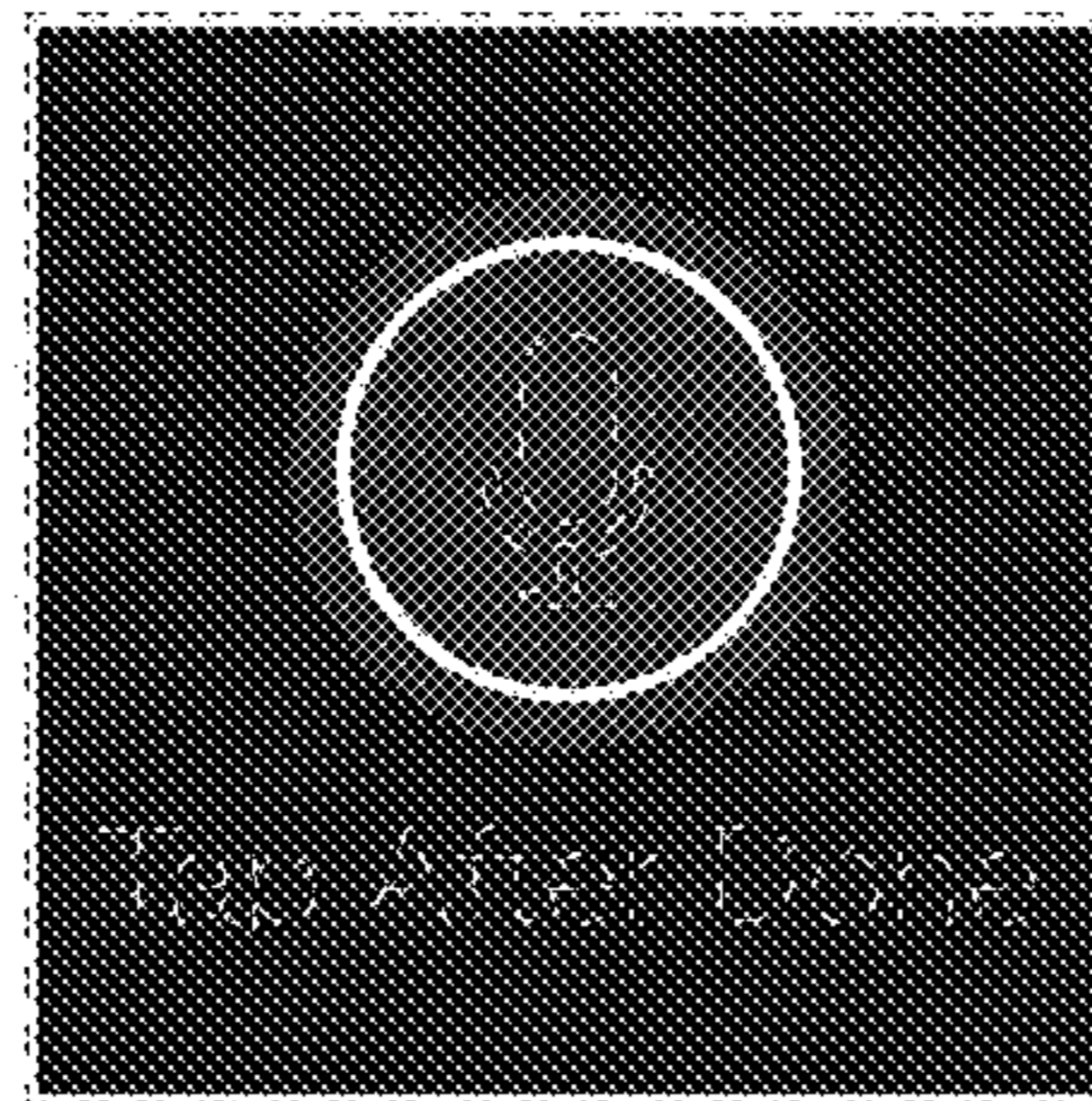

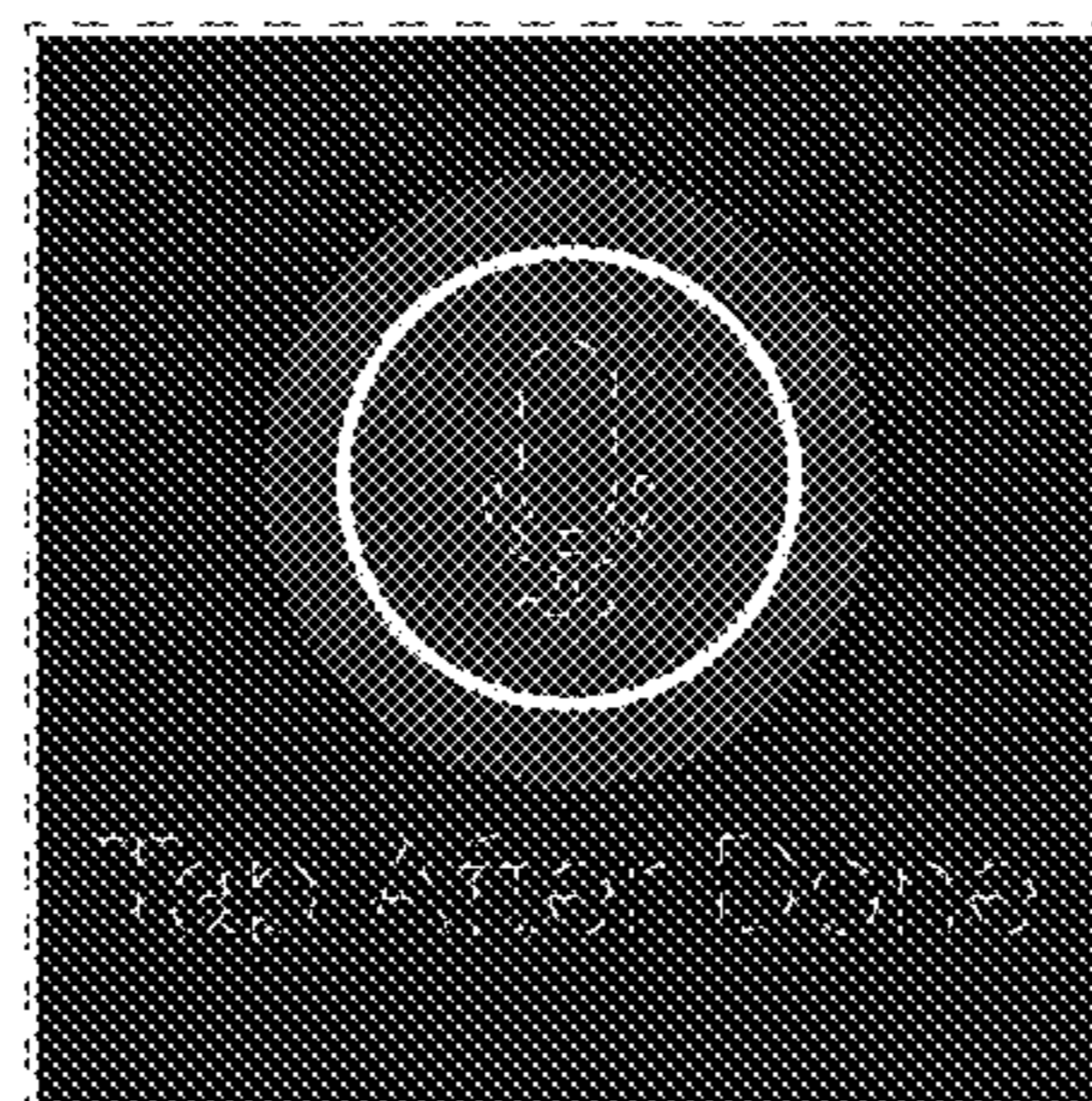
