DESCRIPTION

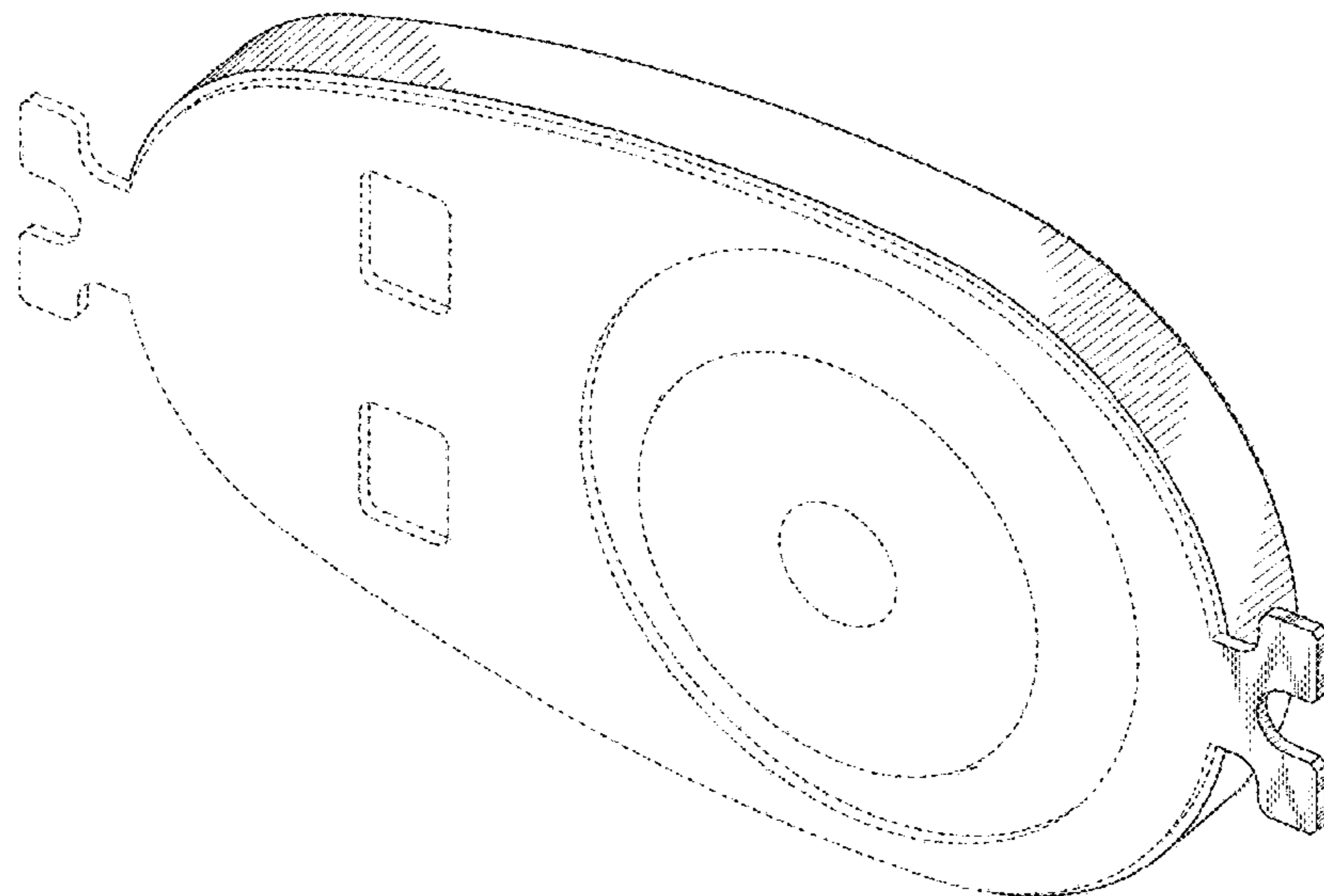
FIG. 1 is a front view of a sliding nozzle plate of the present invention.

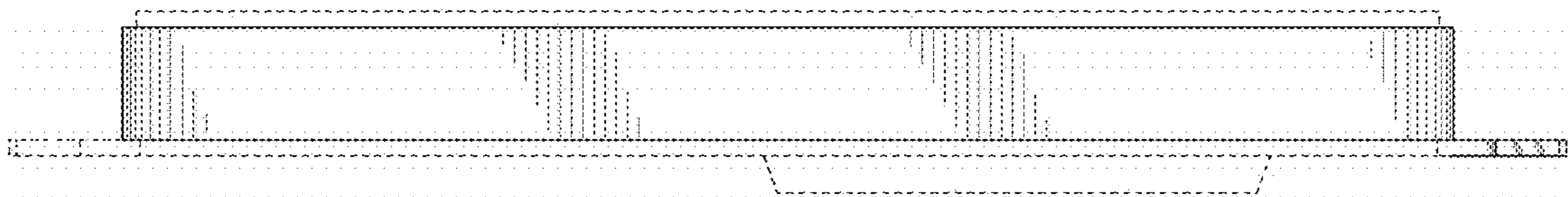

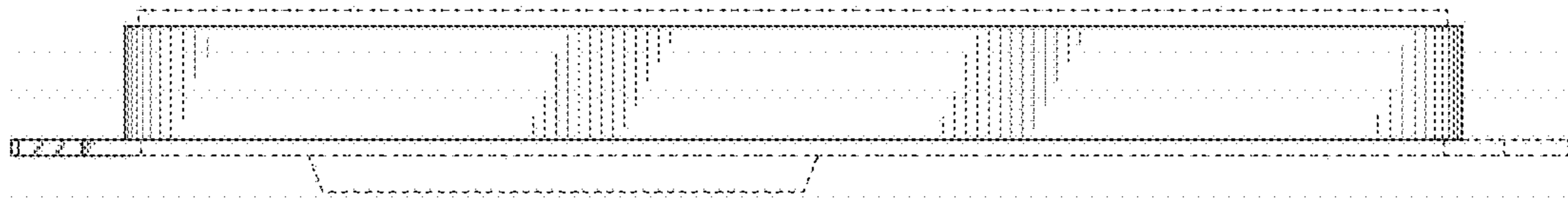

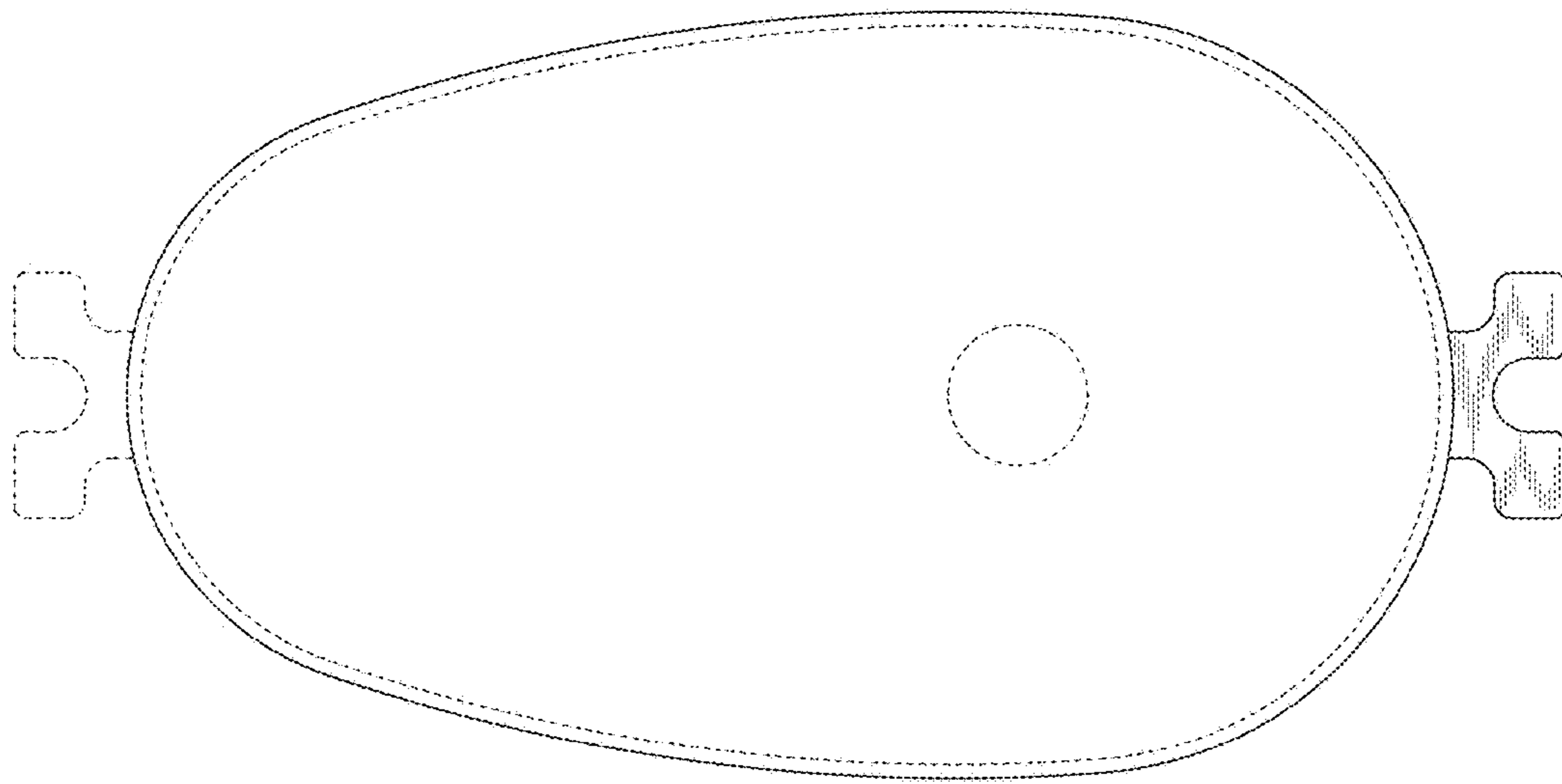
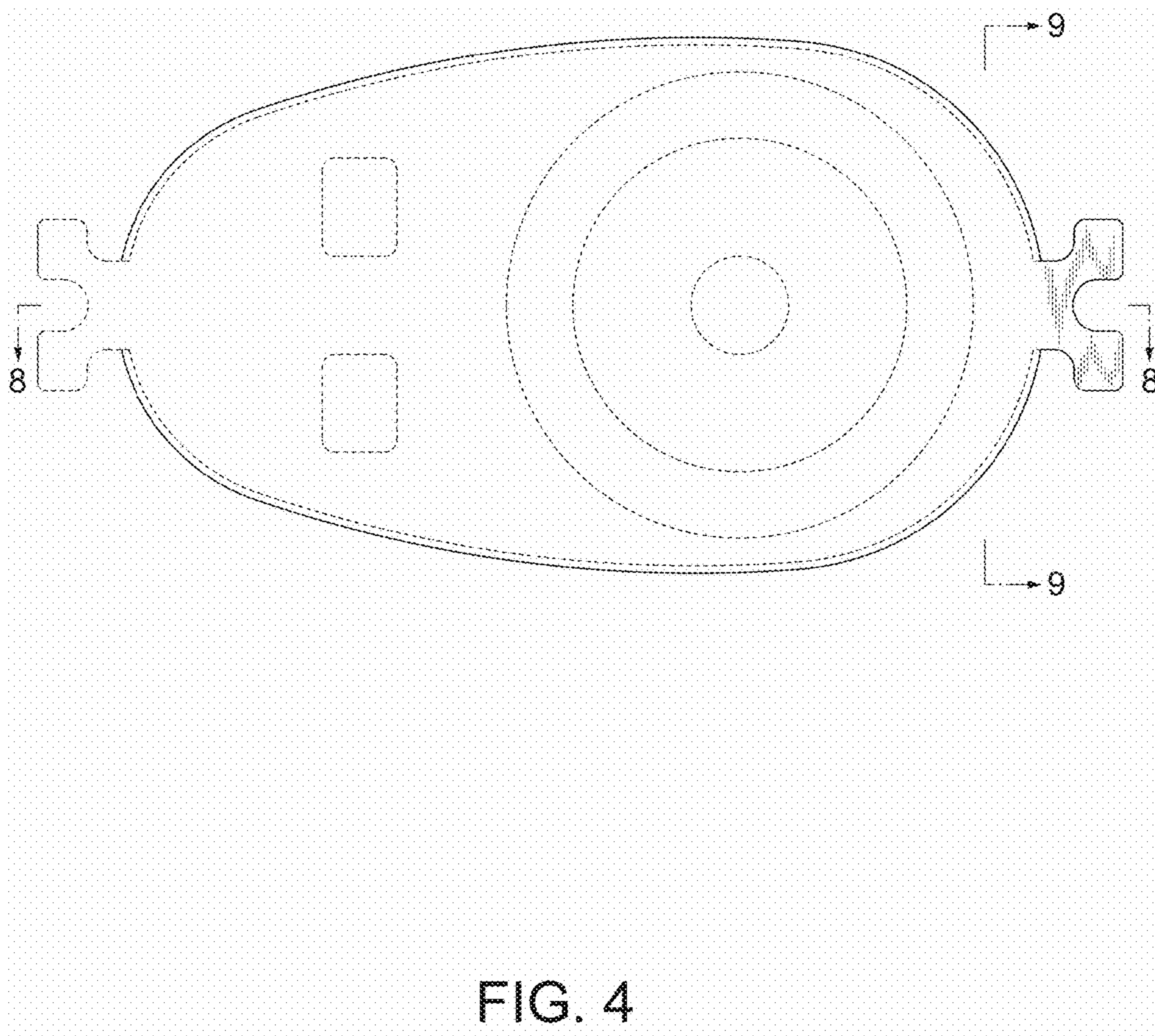

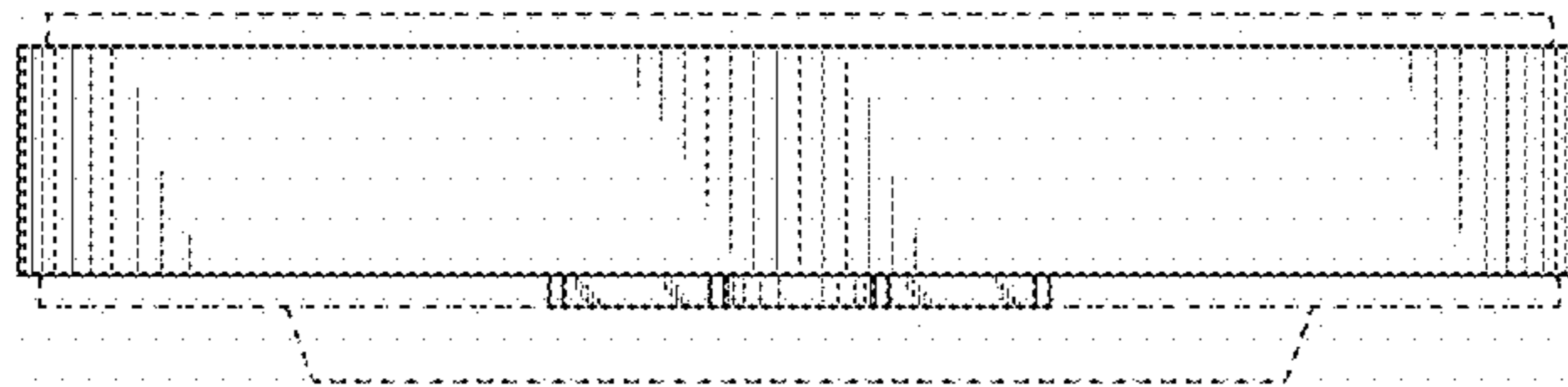
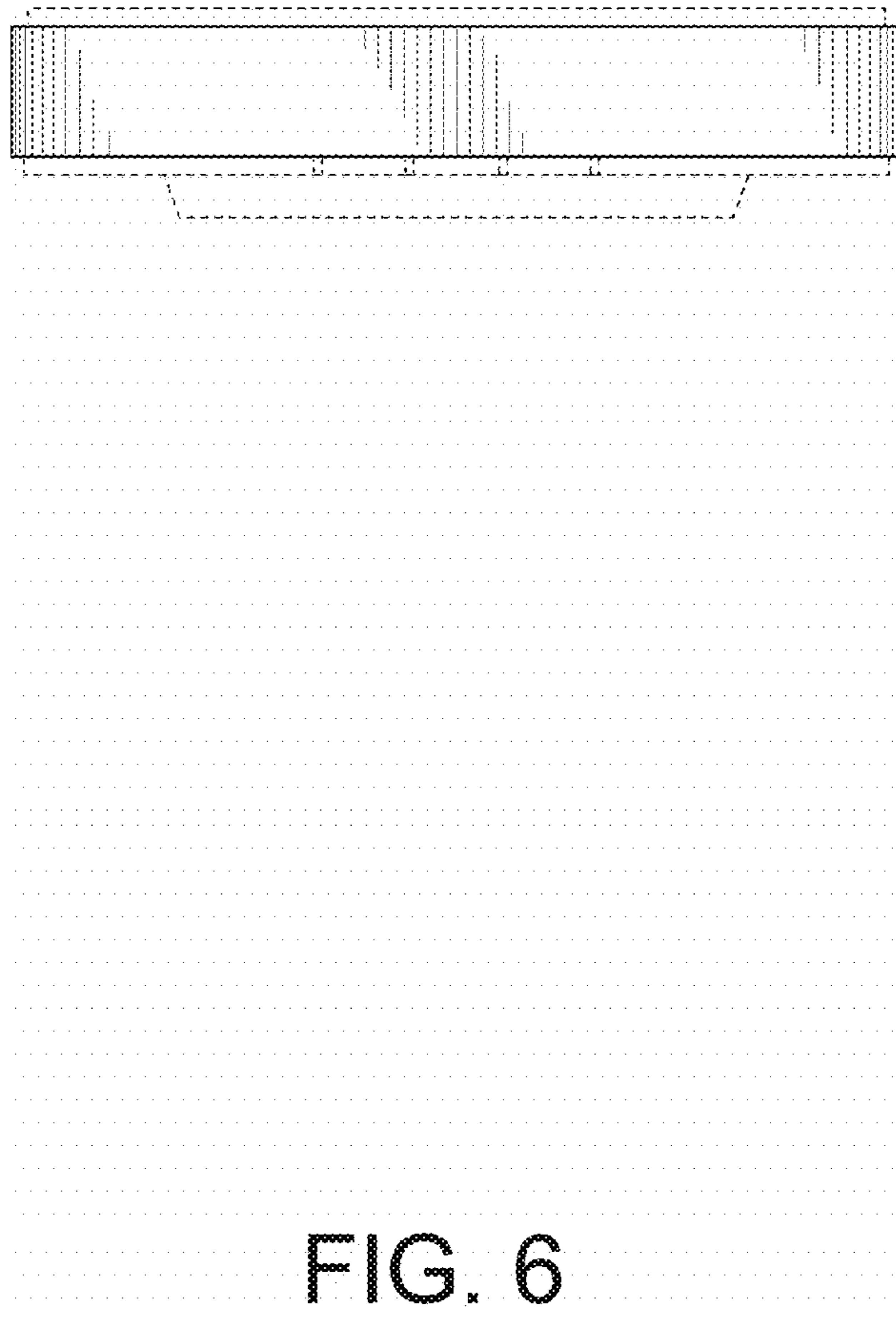

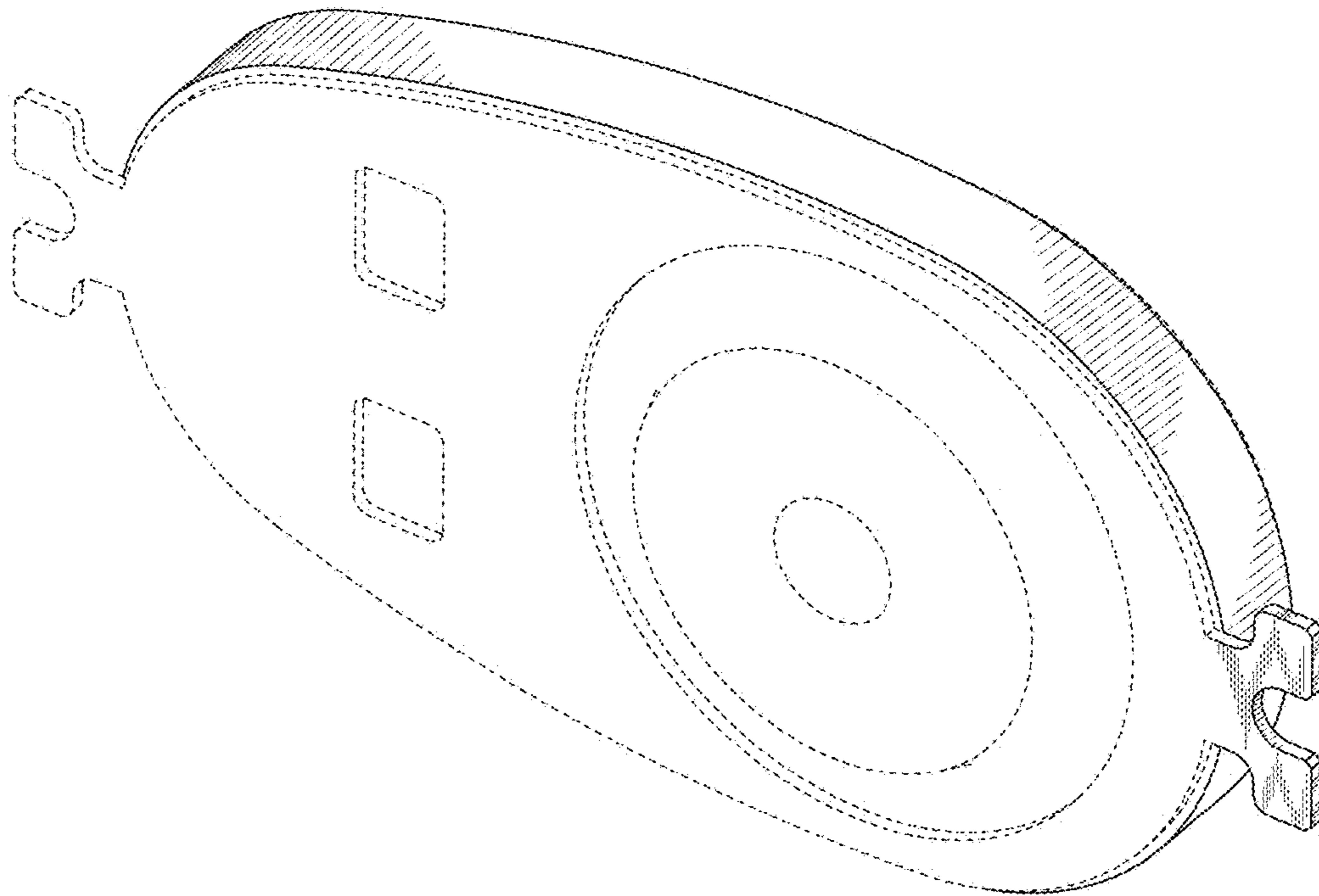

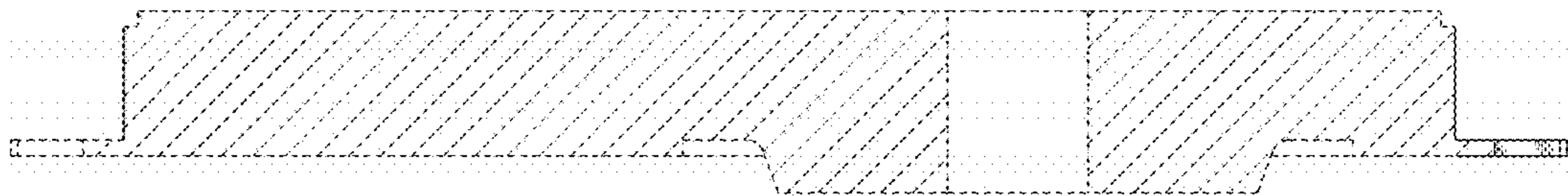

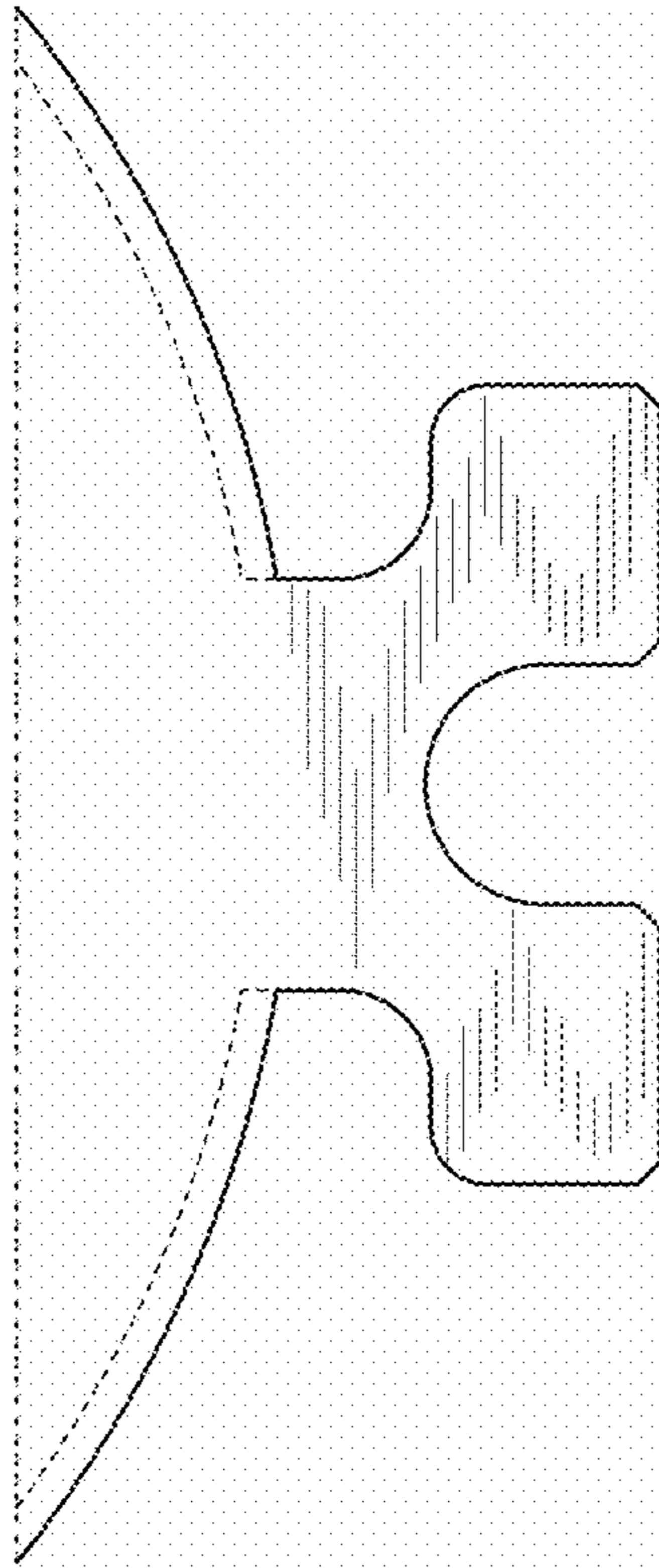
