FIG. 11 is a right end view thereof.

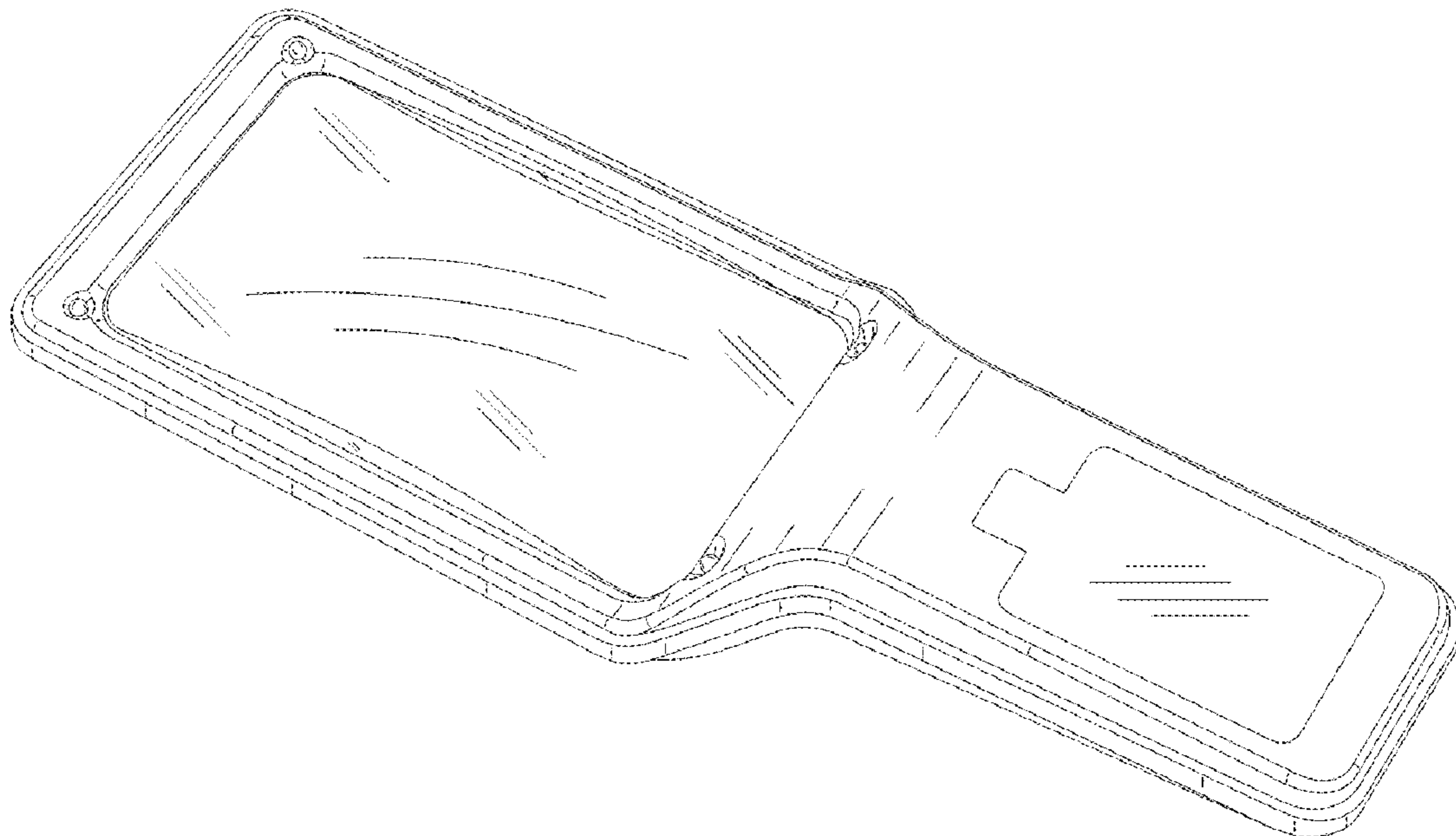
FIG. 12 is a left end view thereof.

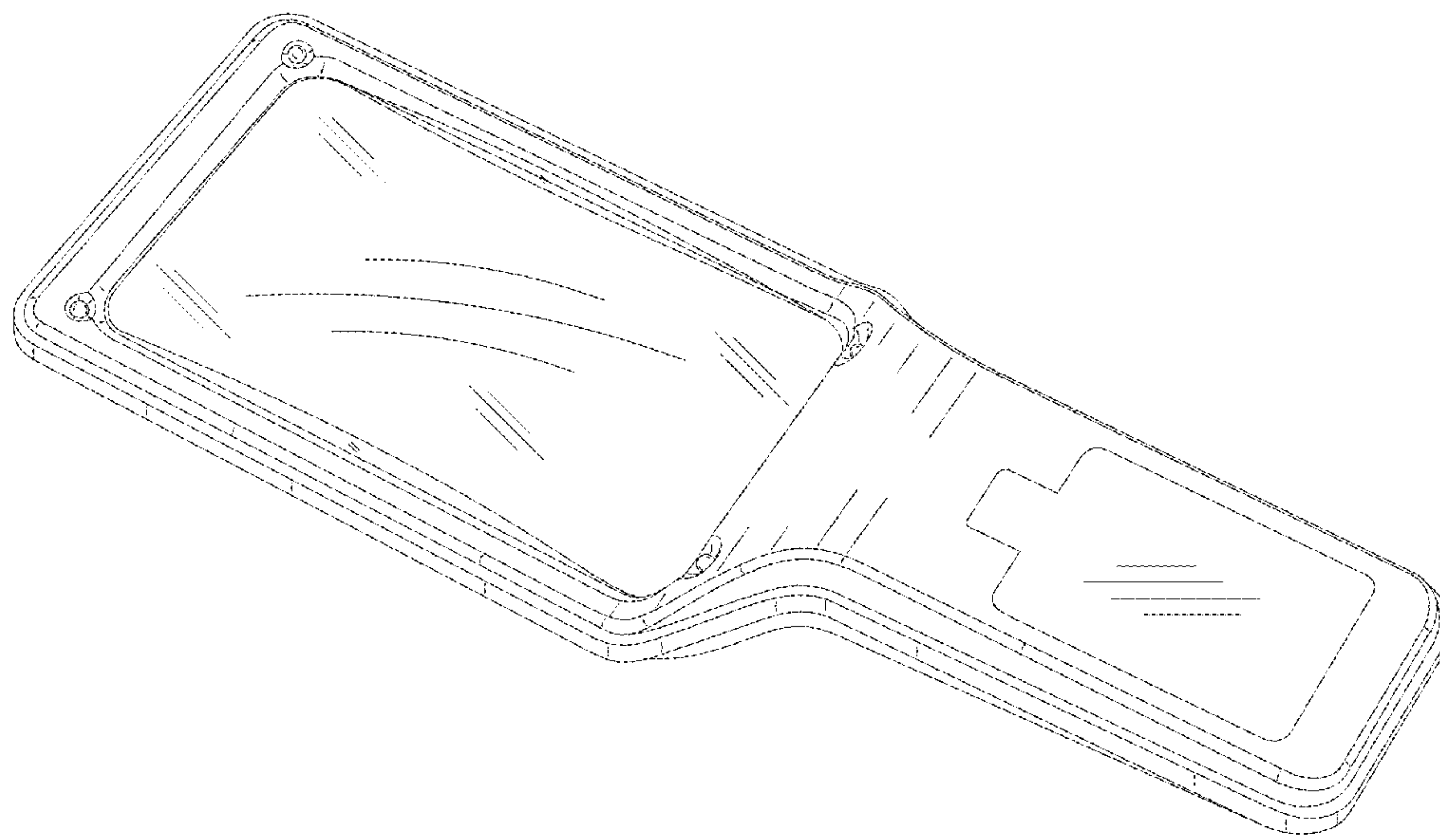

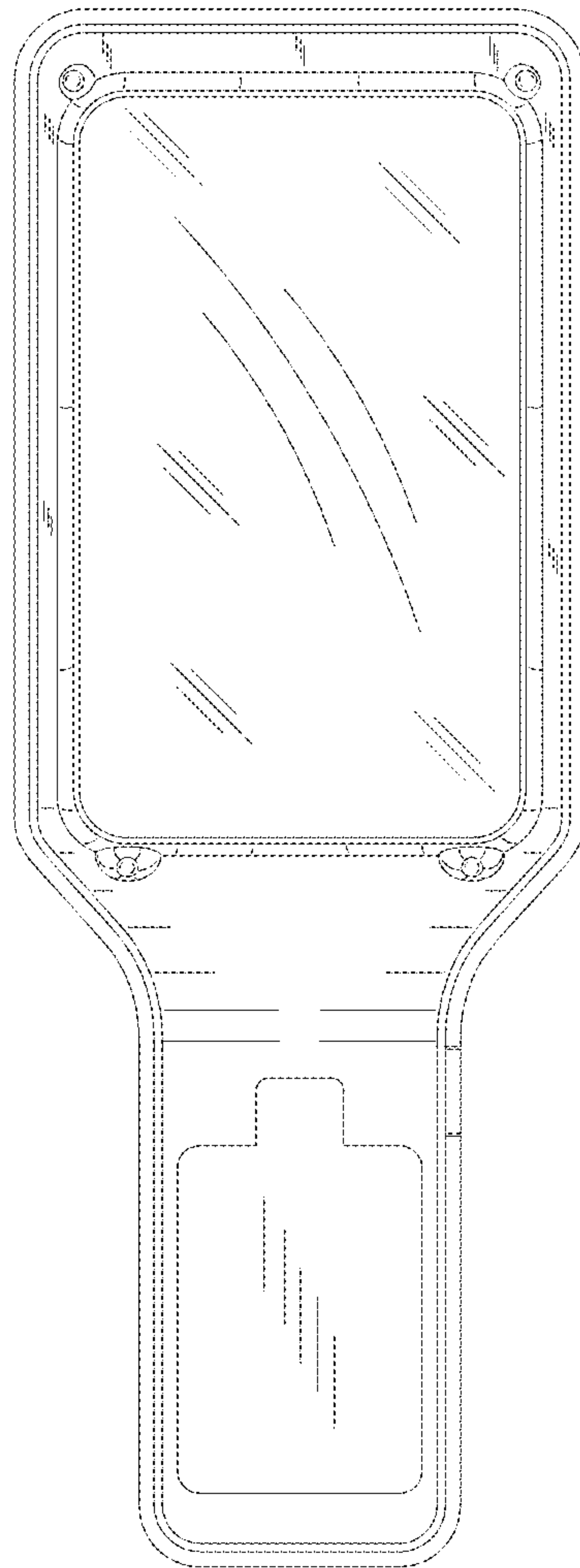

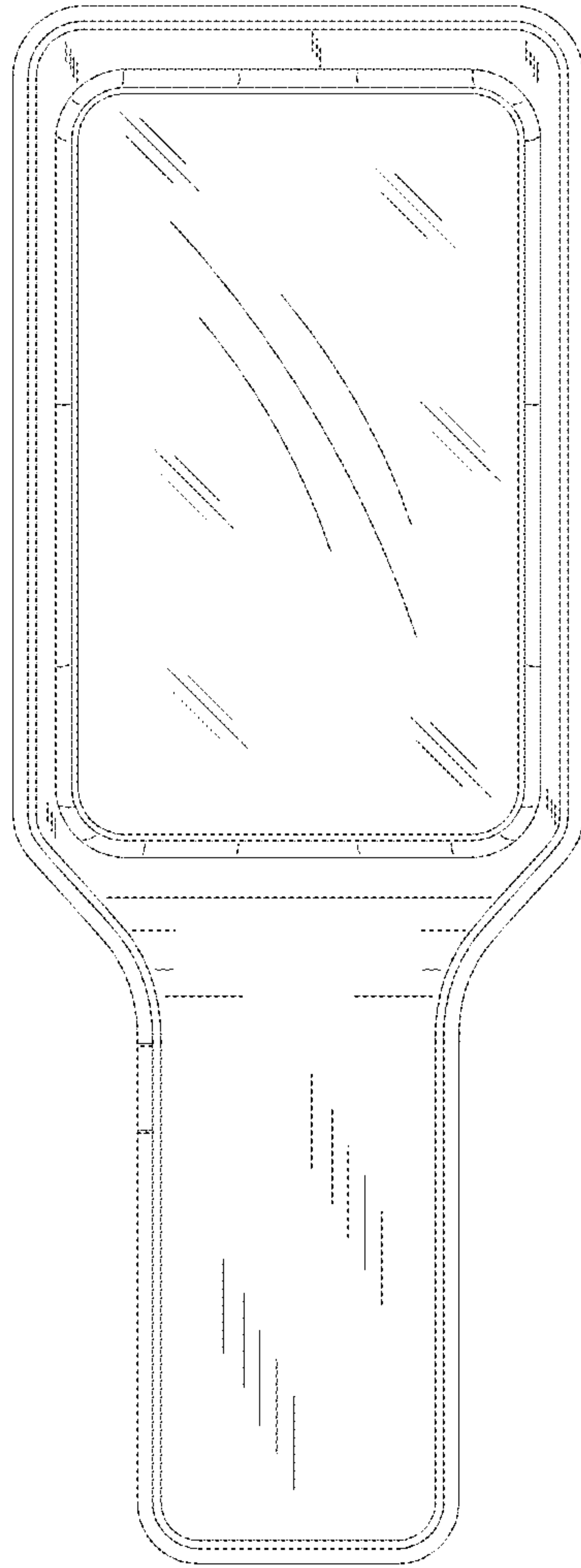

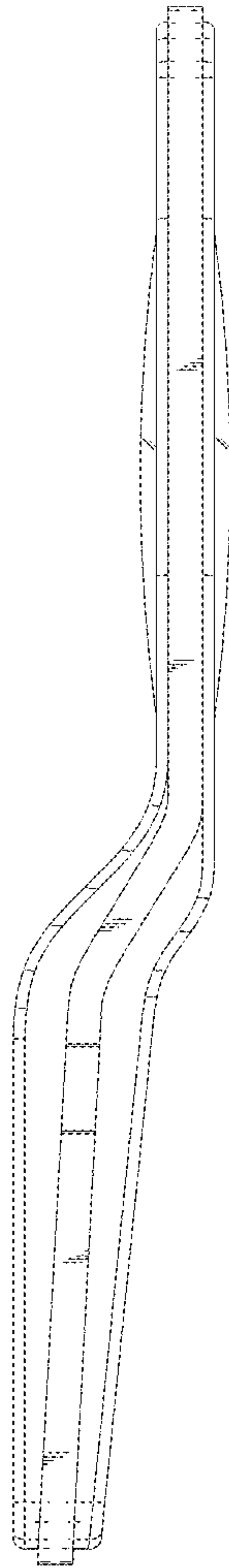

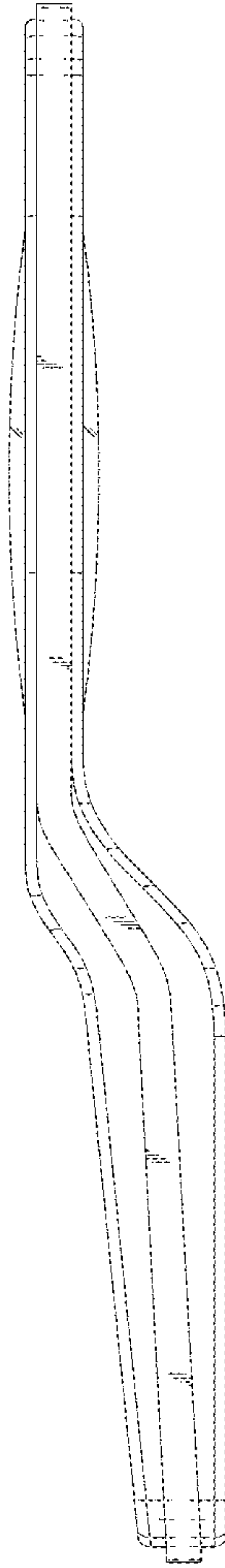

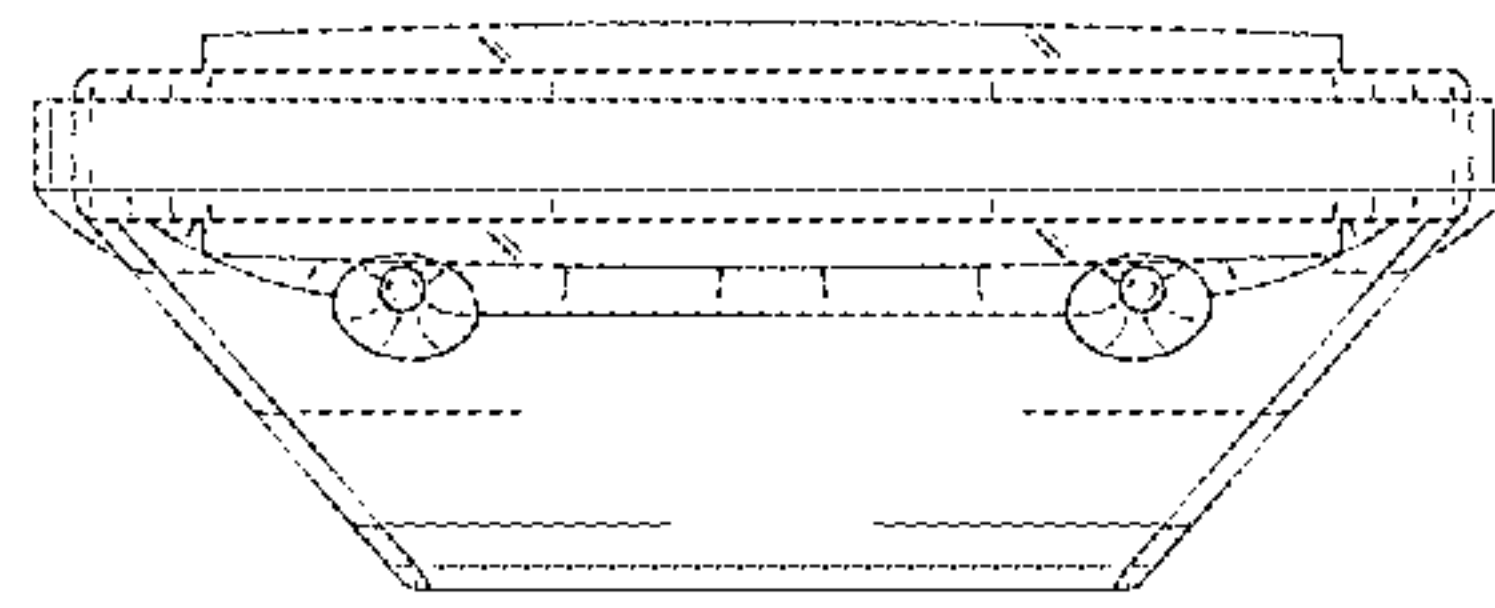

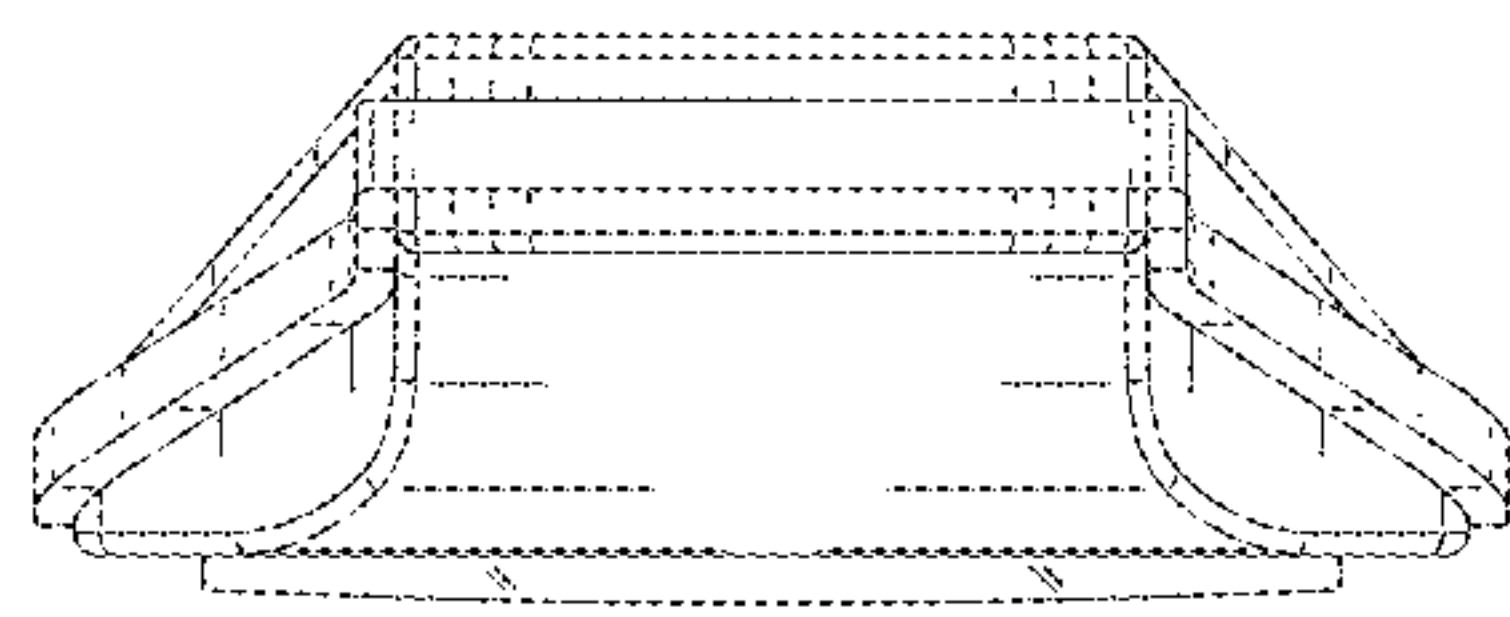

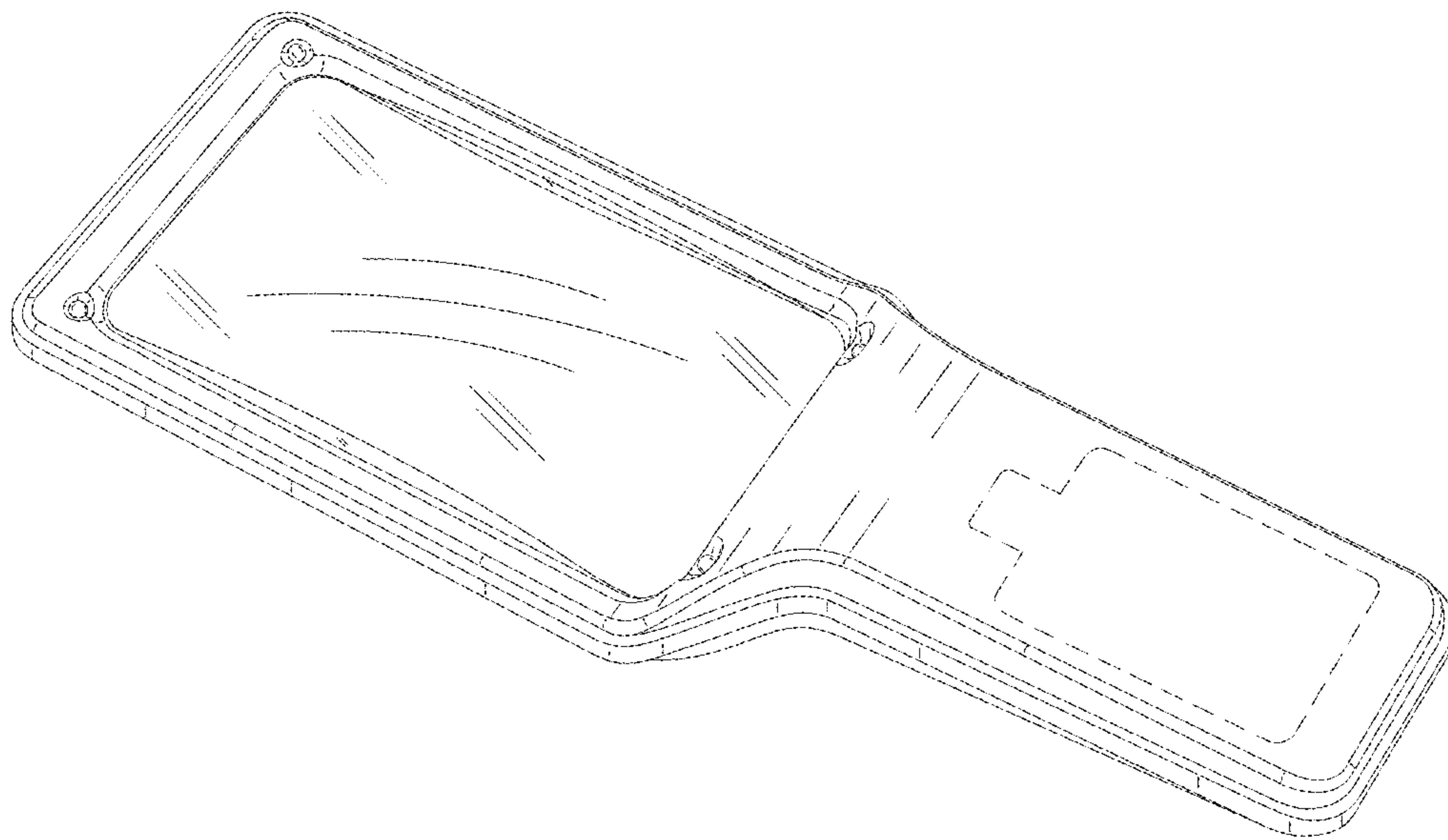

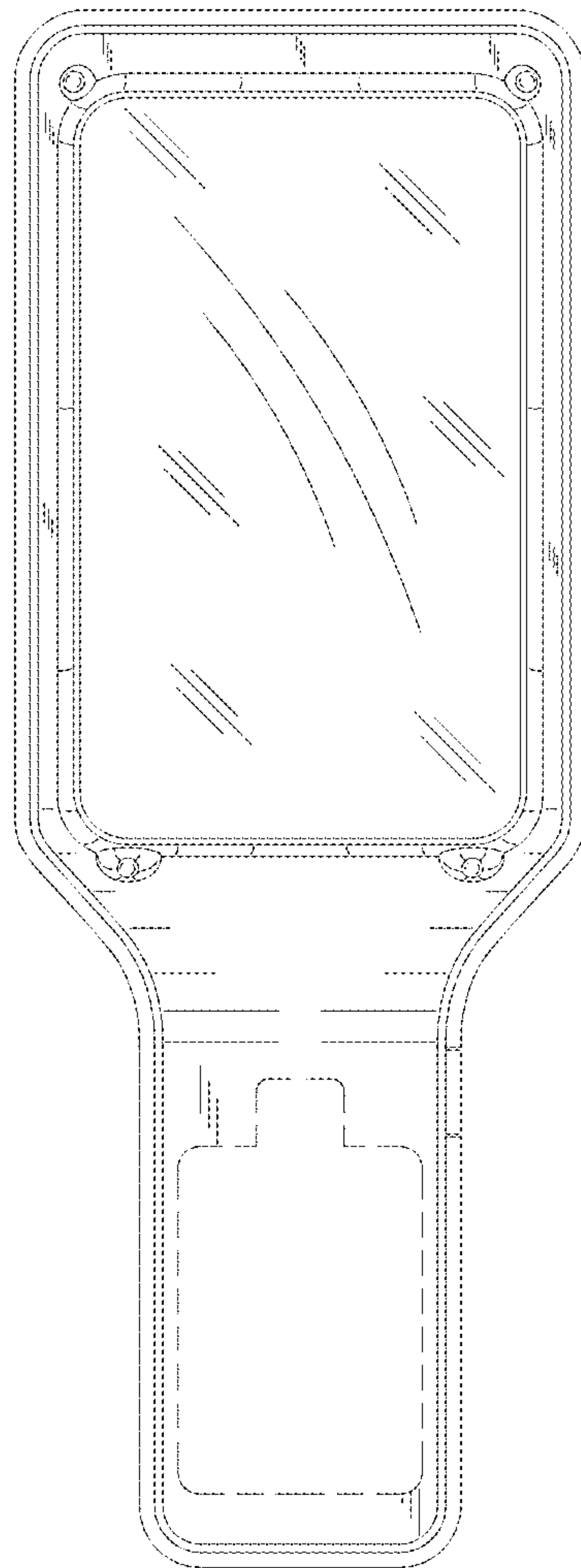

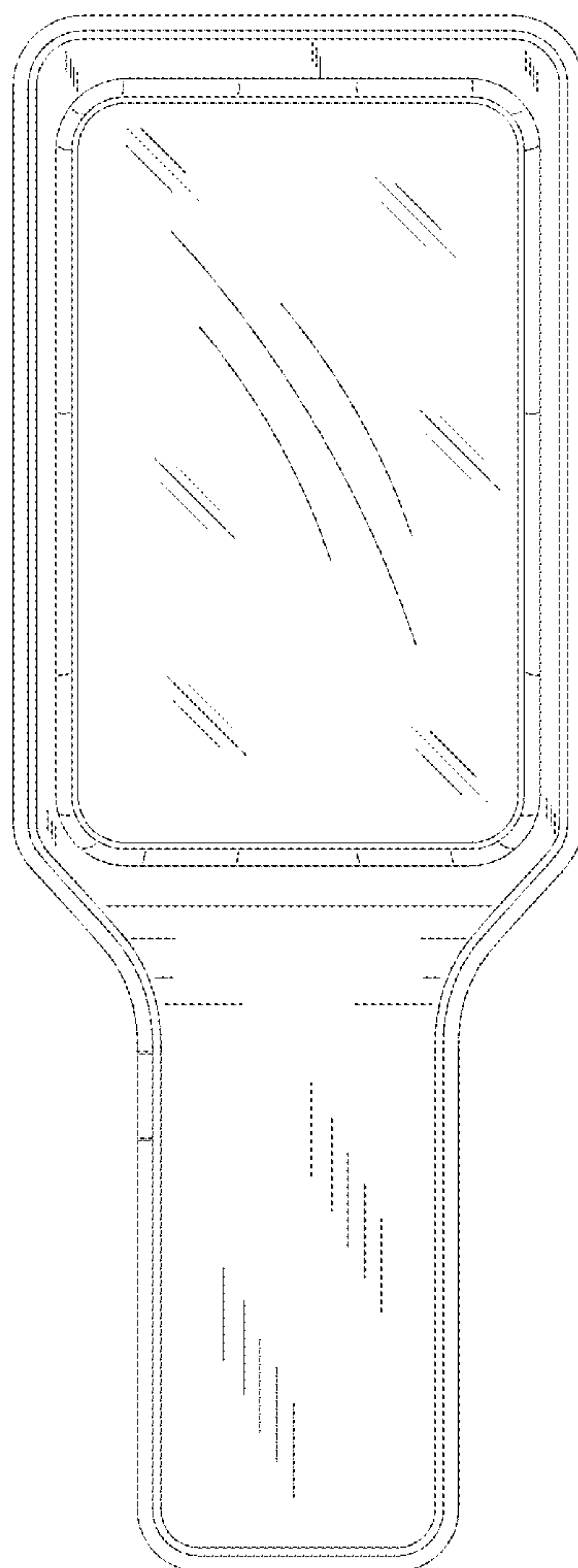

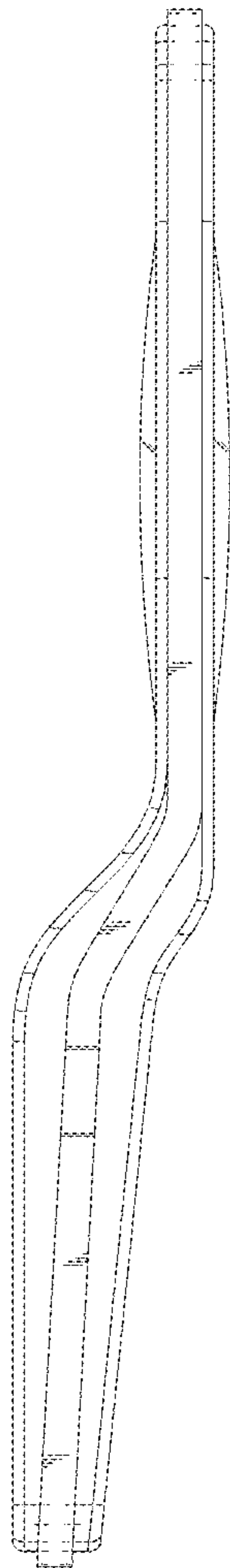

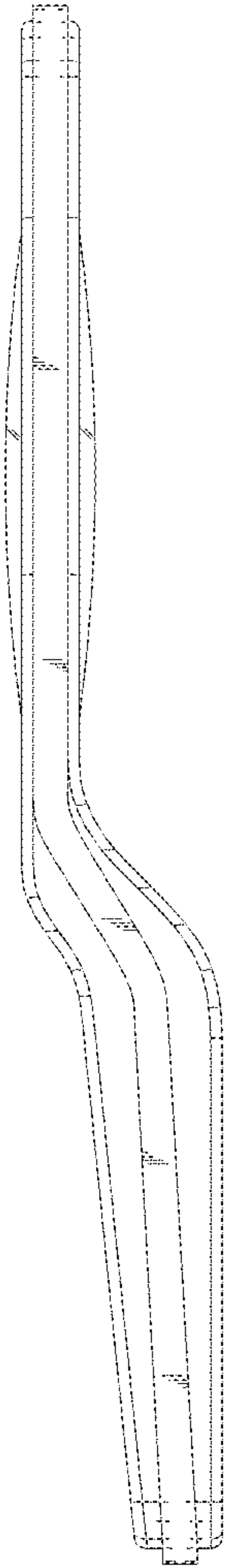

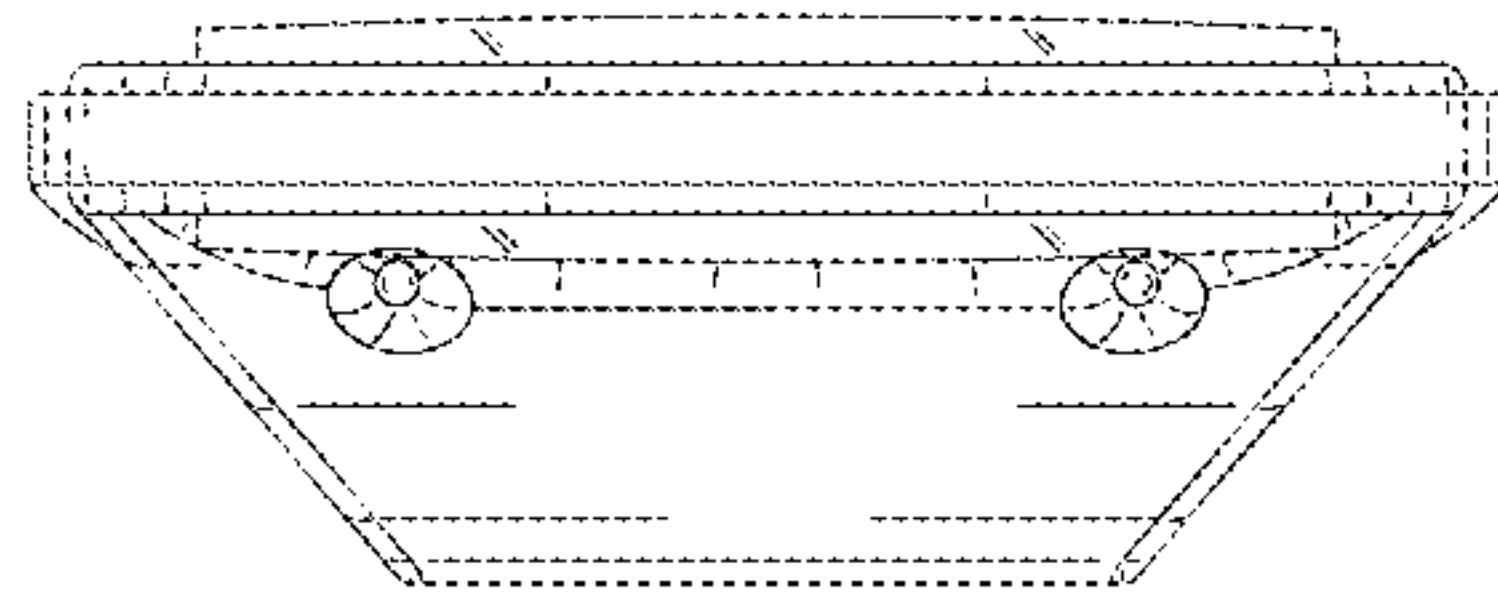

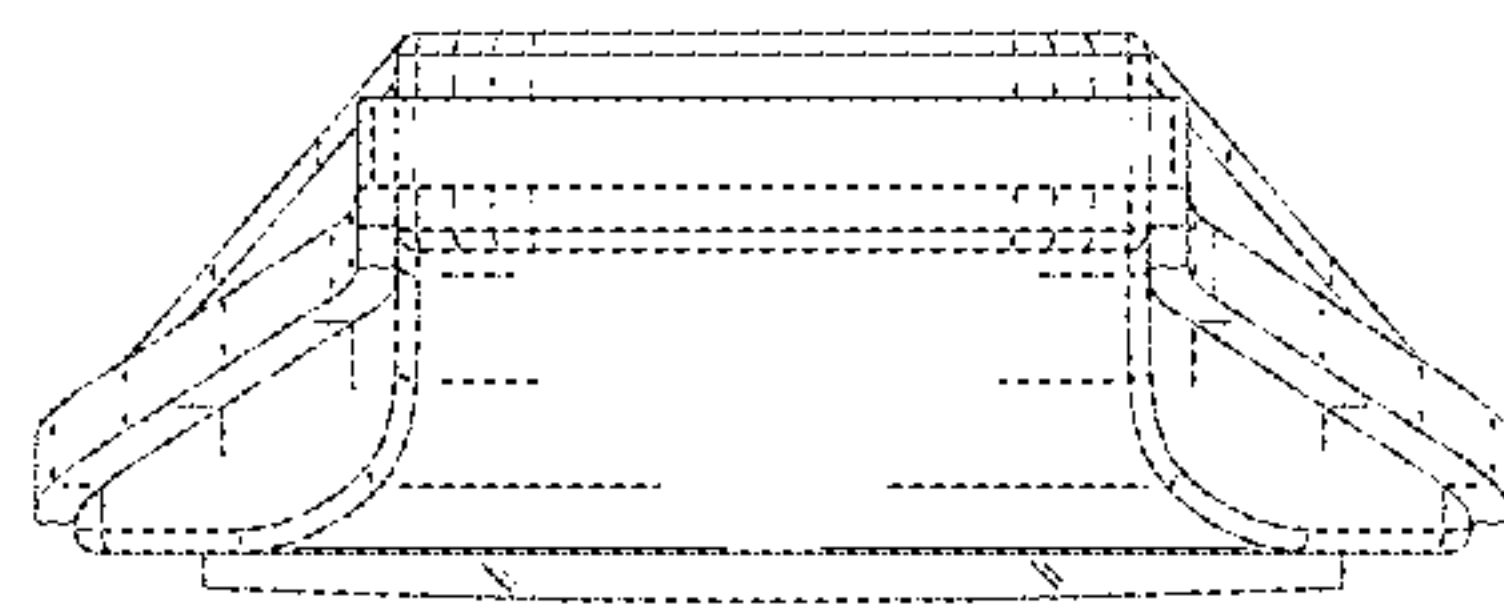
