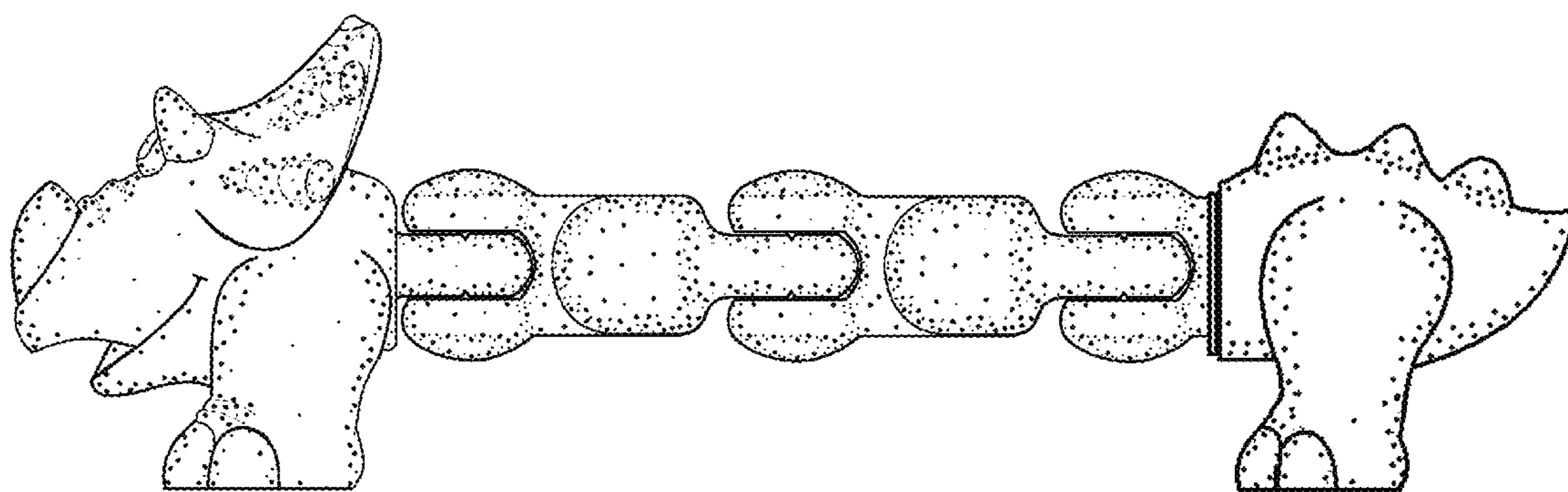
(57) **CLAIM**

The ornamental design for a toy triceratops with linked body, as shown and described.

DESCRIPTION

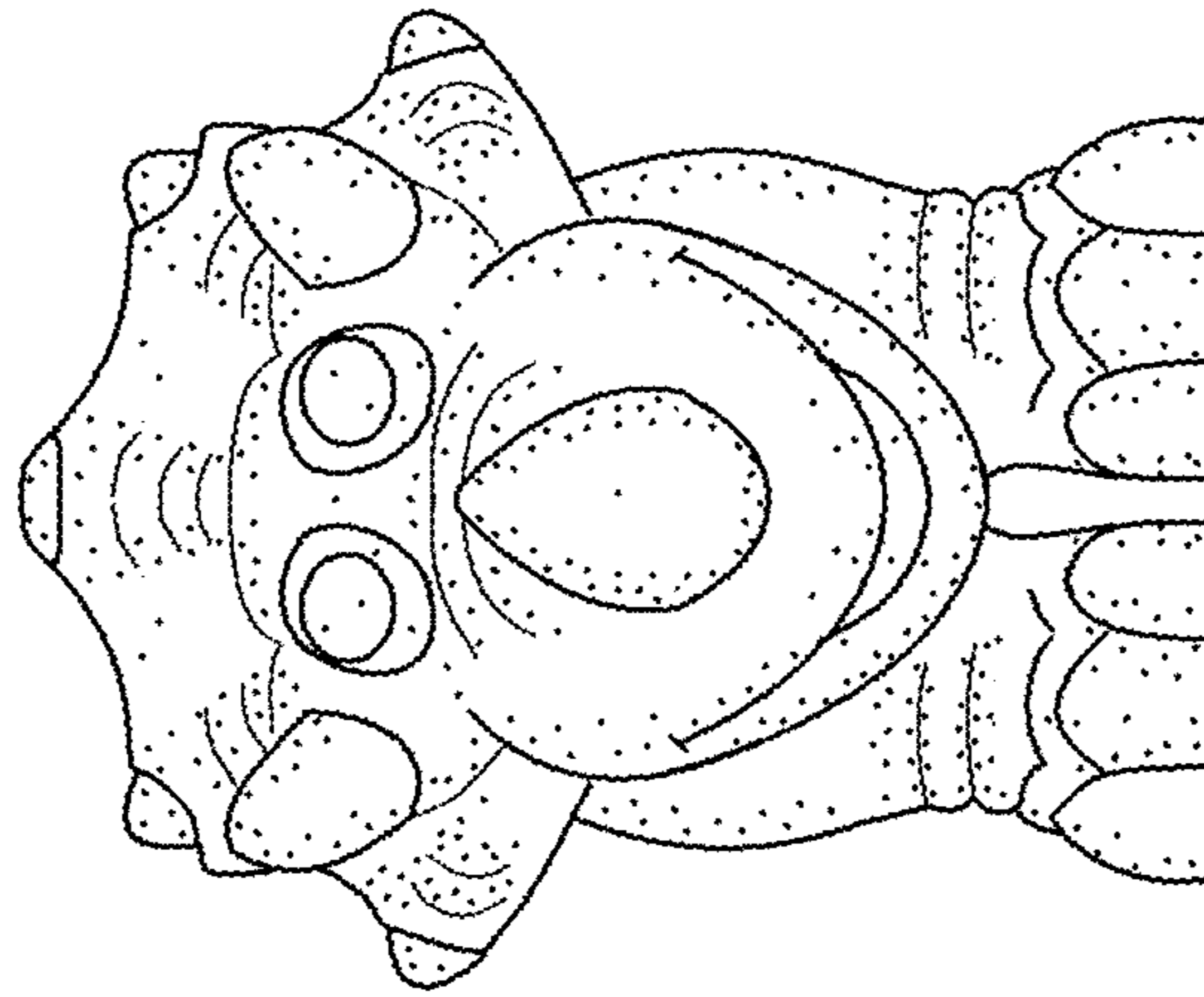

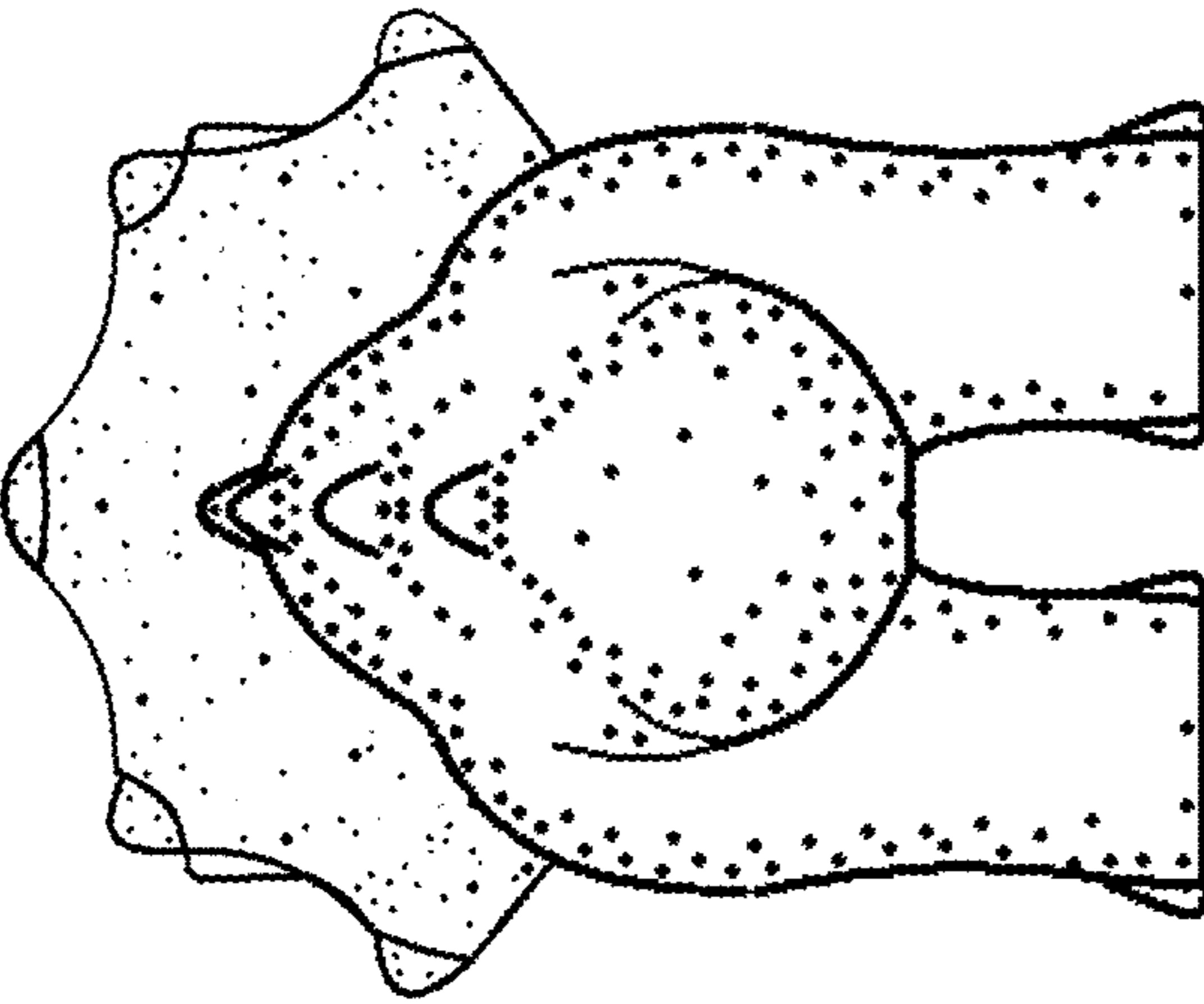

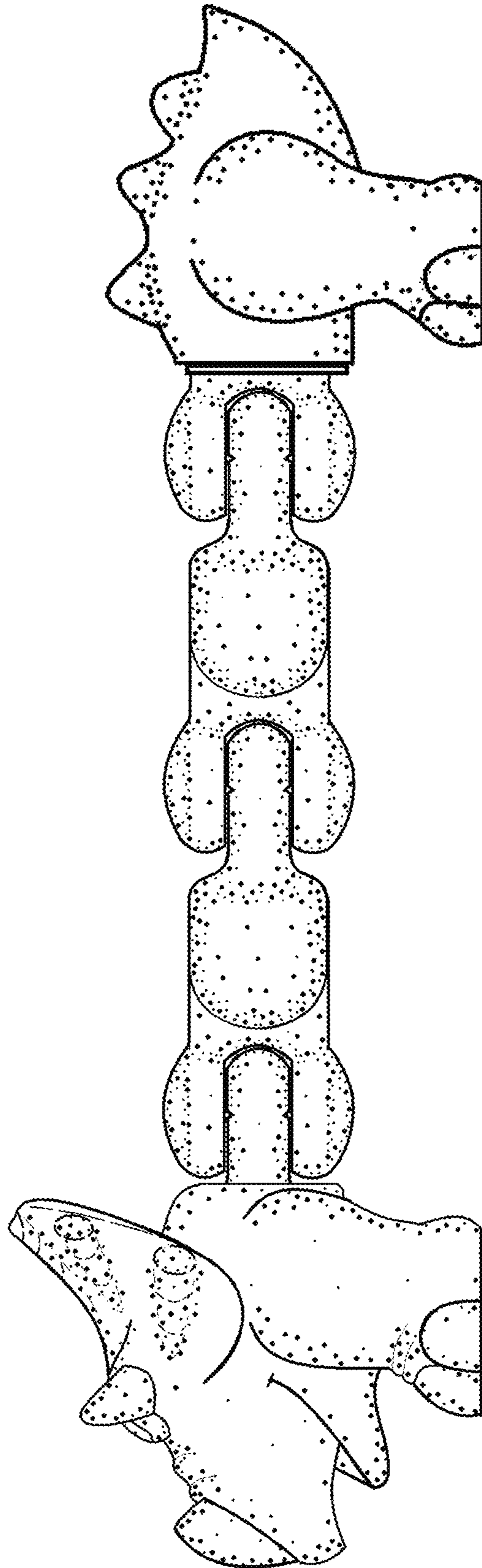

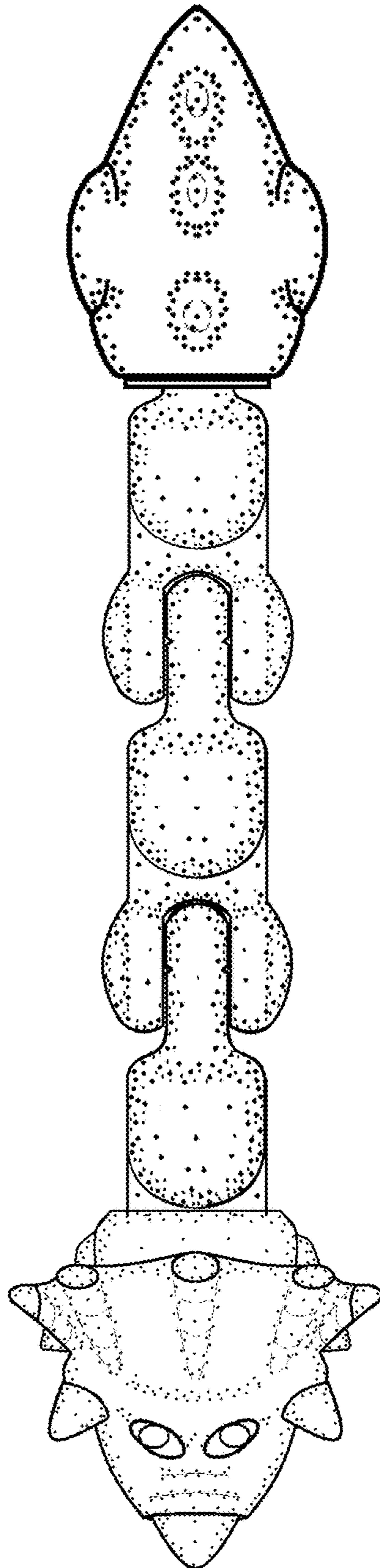

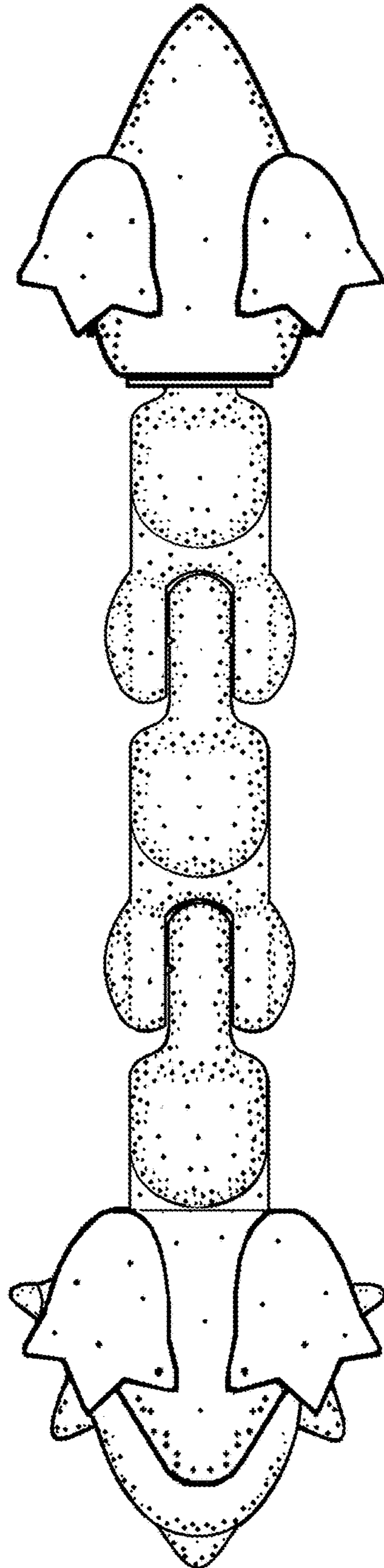
