extrusion of FIG. 1.

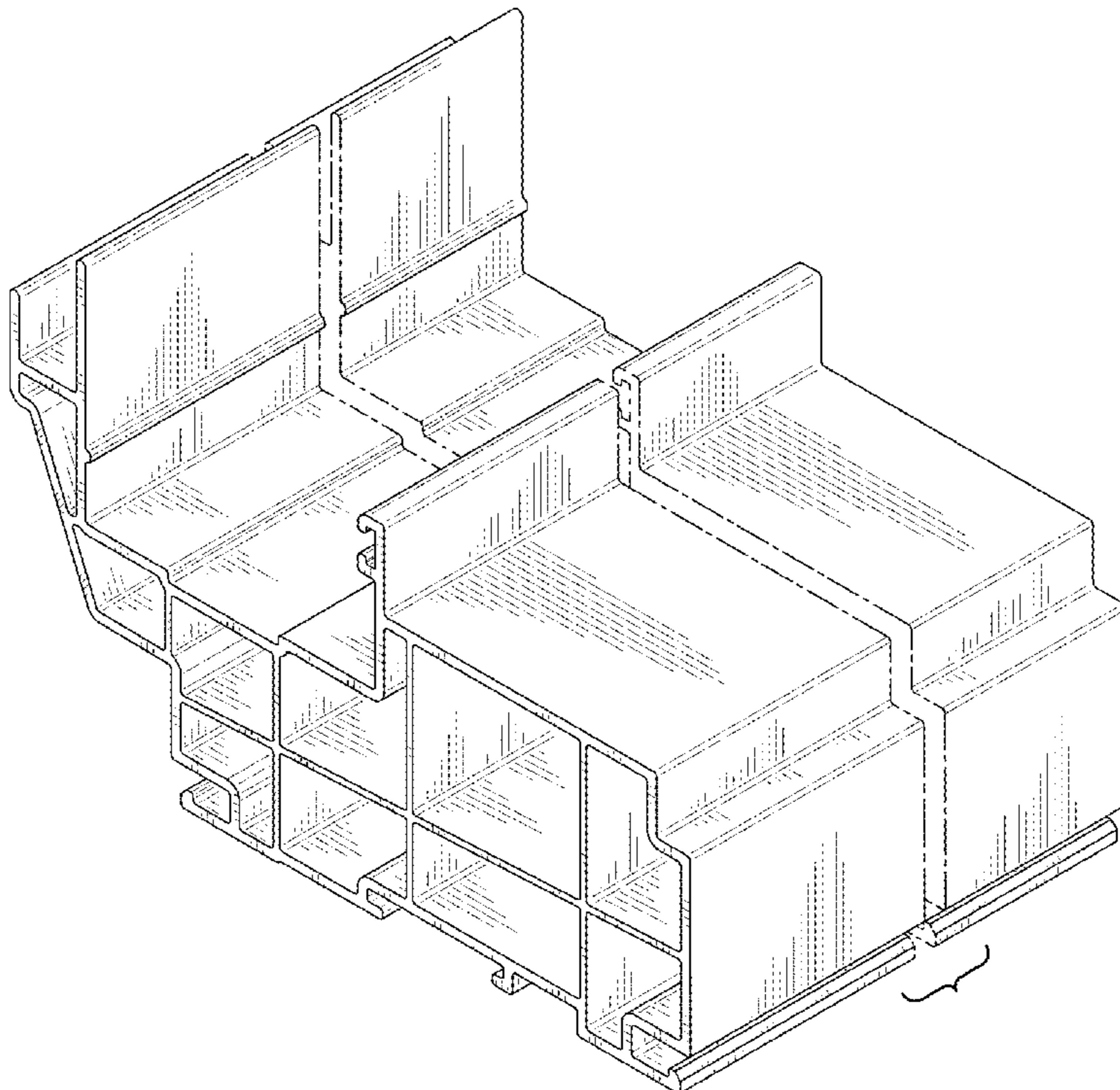
The window component extrusion is shown with two parallel

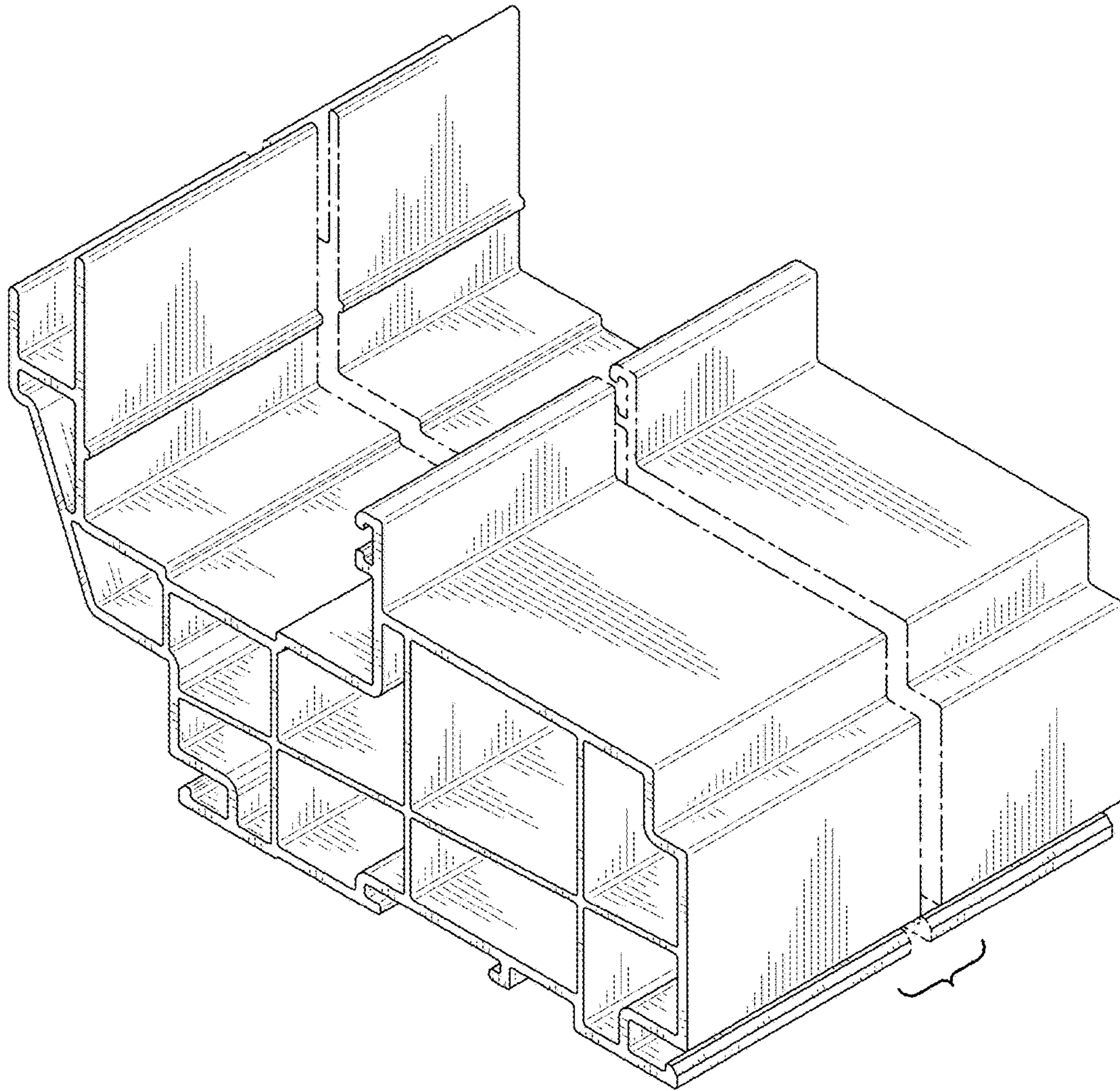

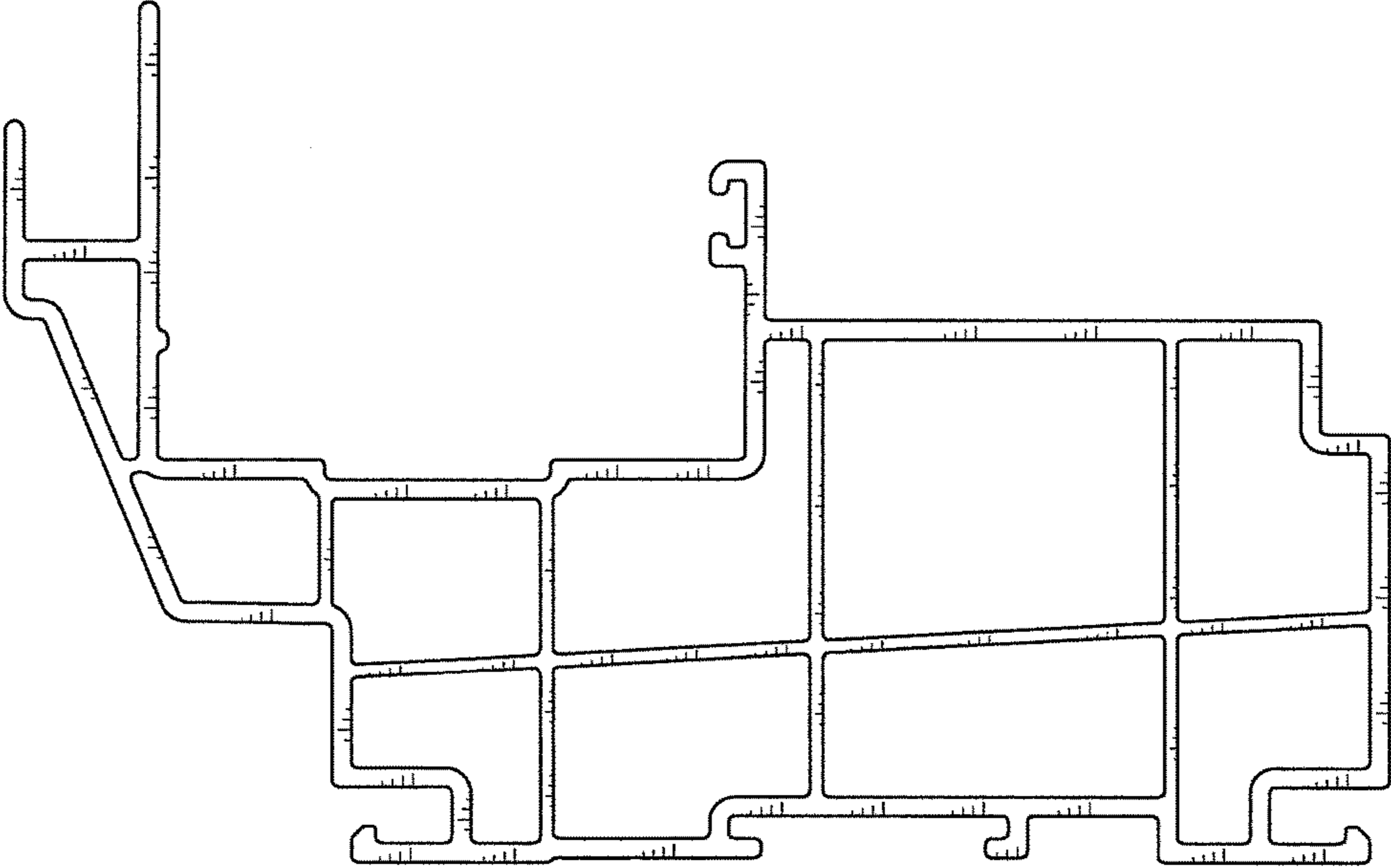

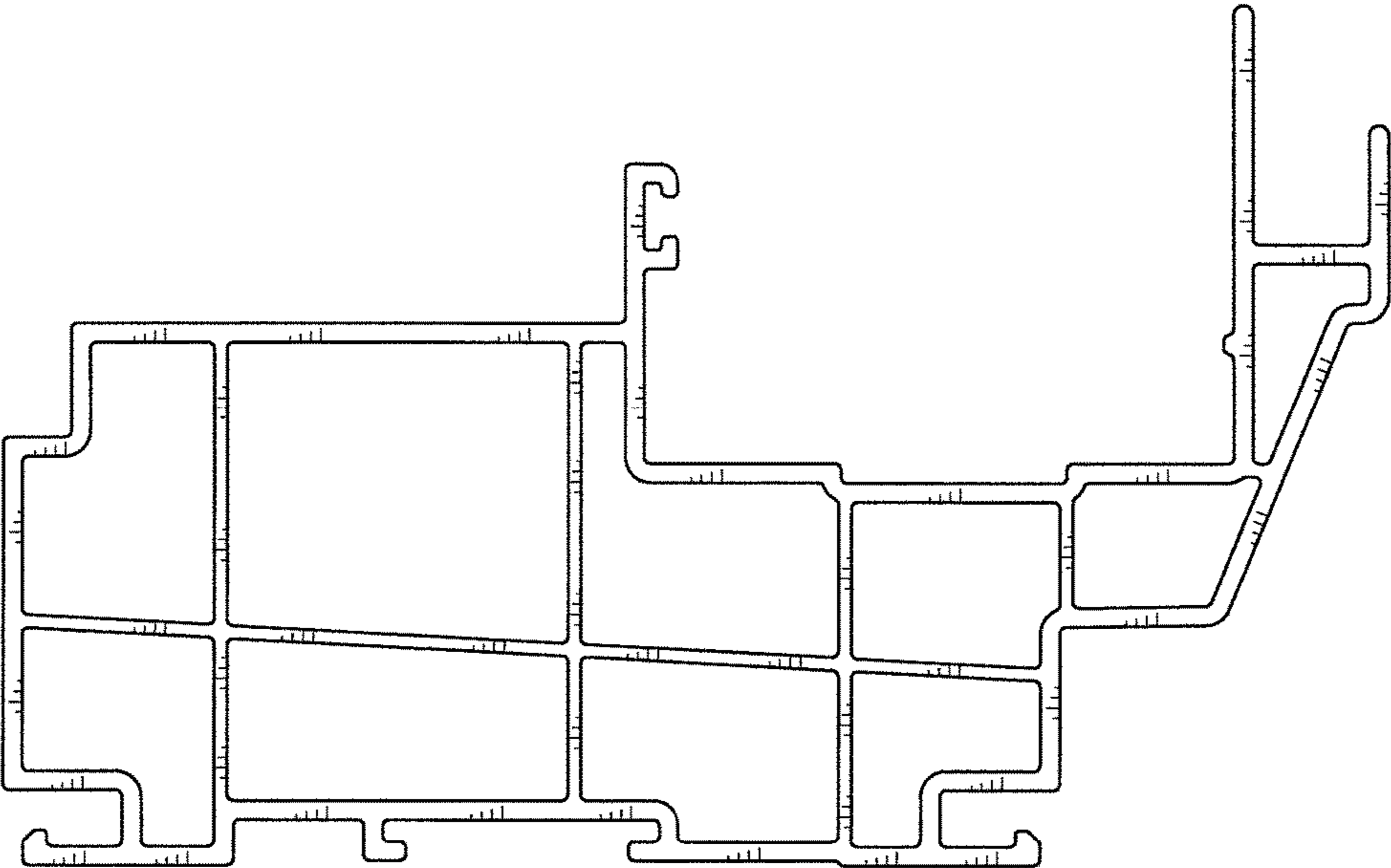

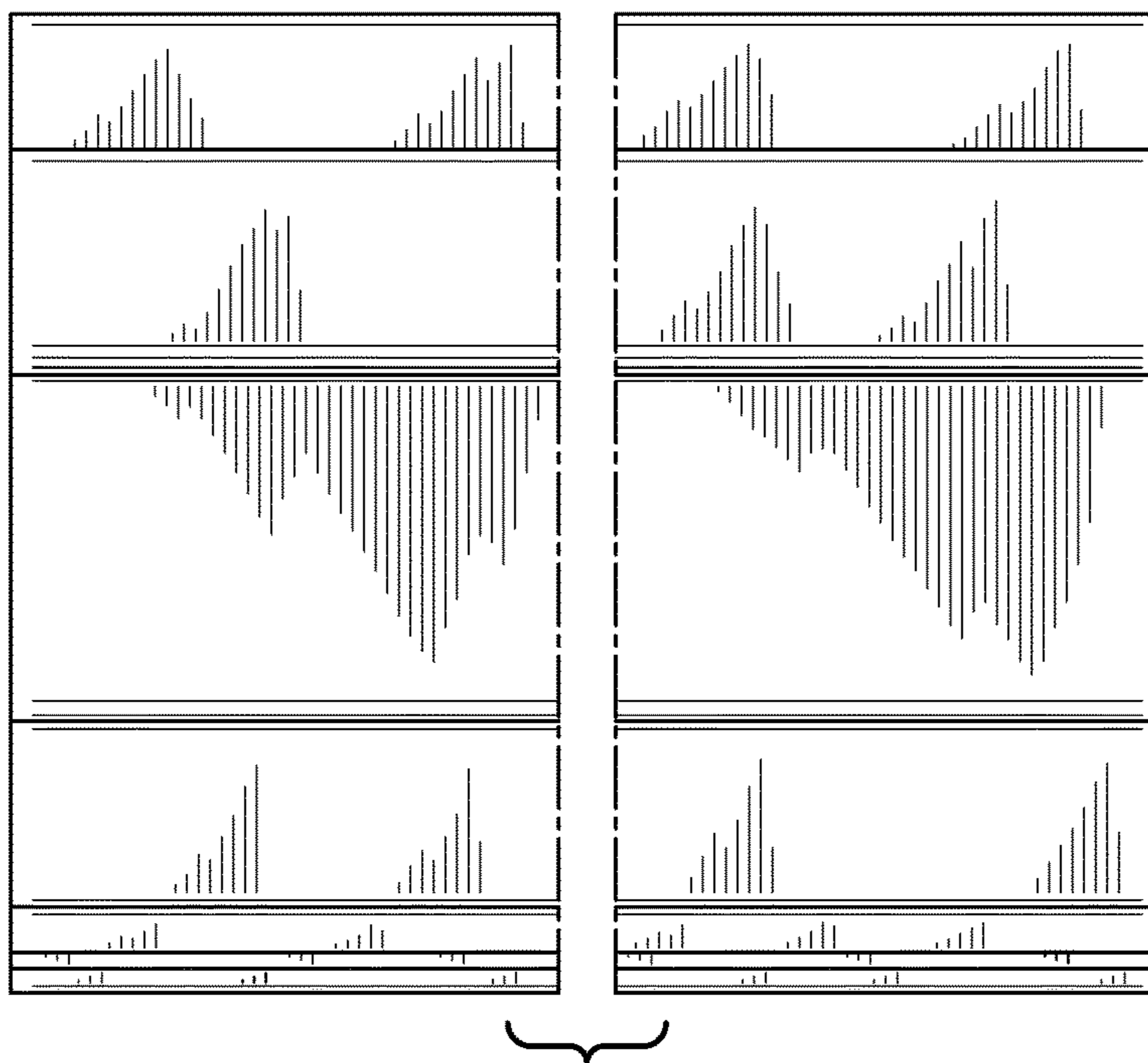

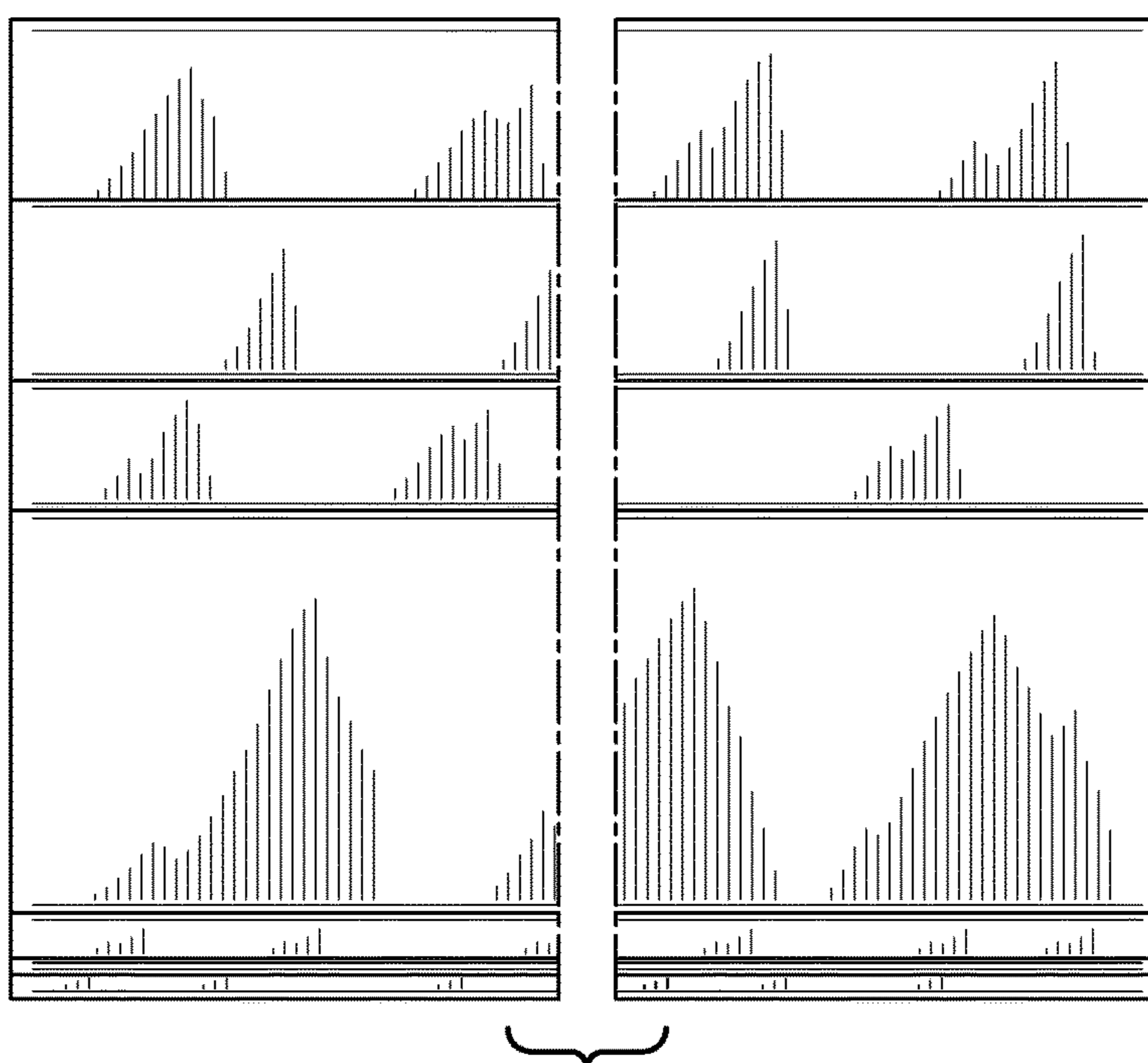

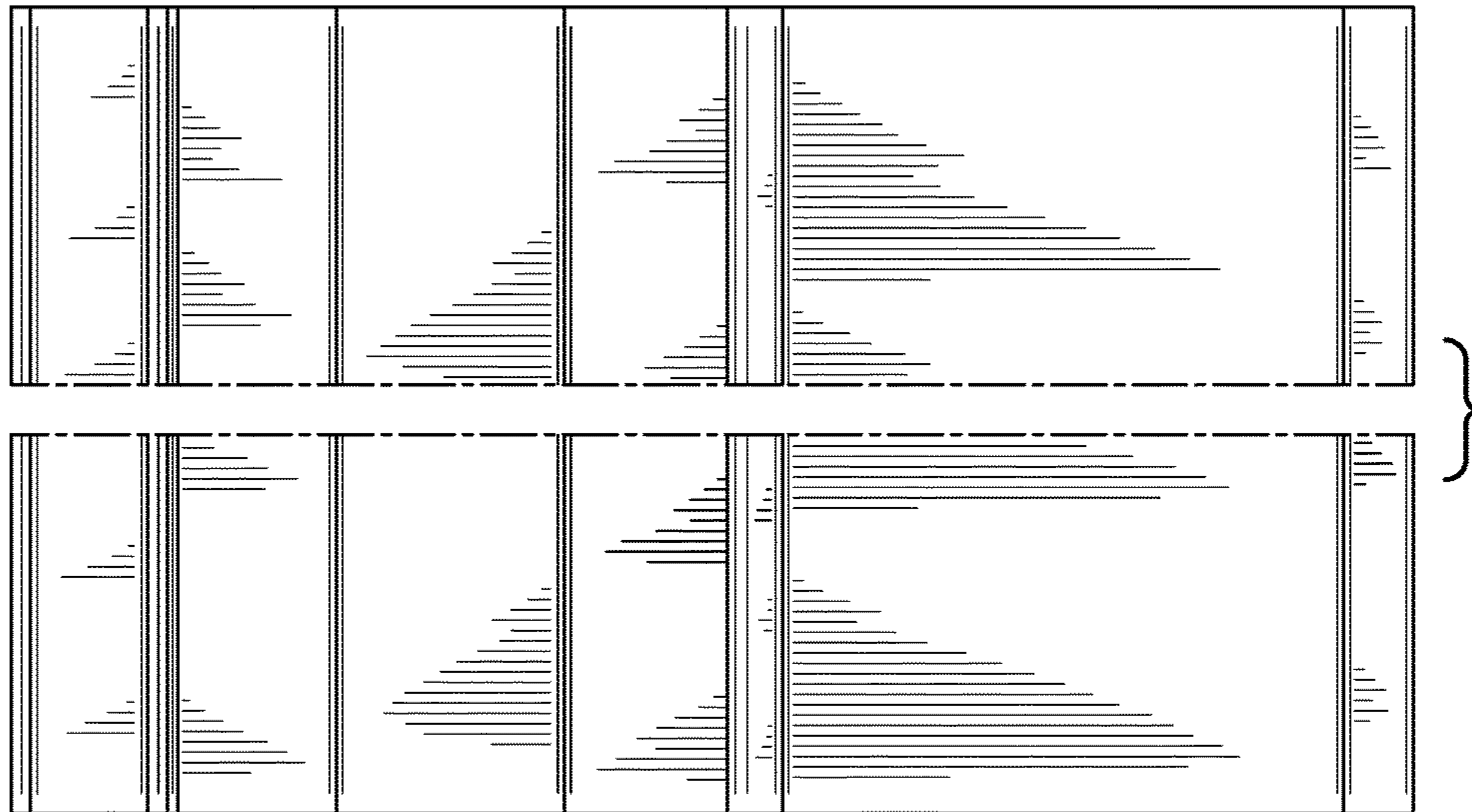

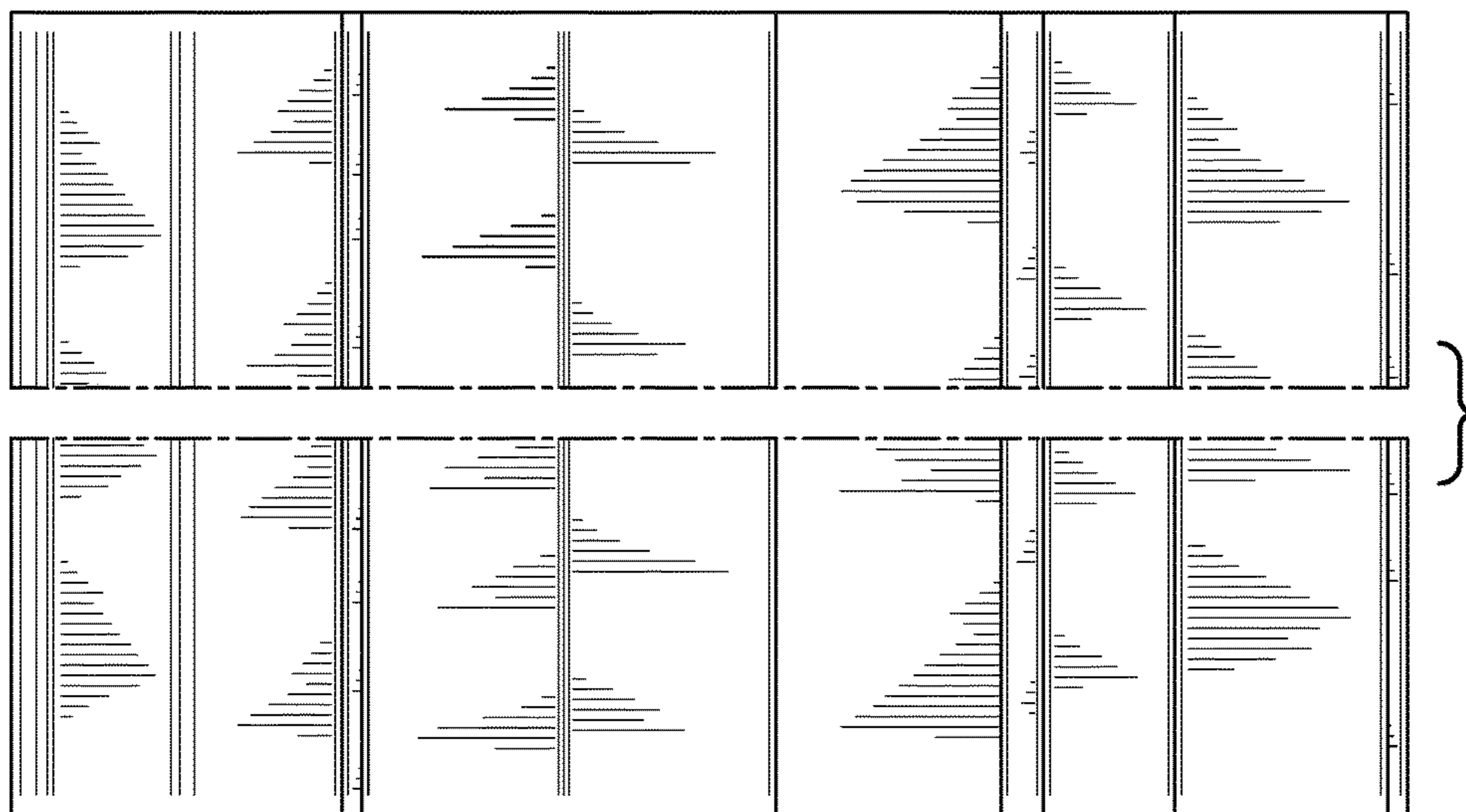
