FIG. 3 is a back side elevational view of the light fixture illustrated in FIG. 1.

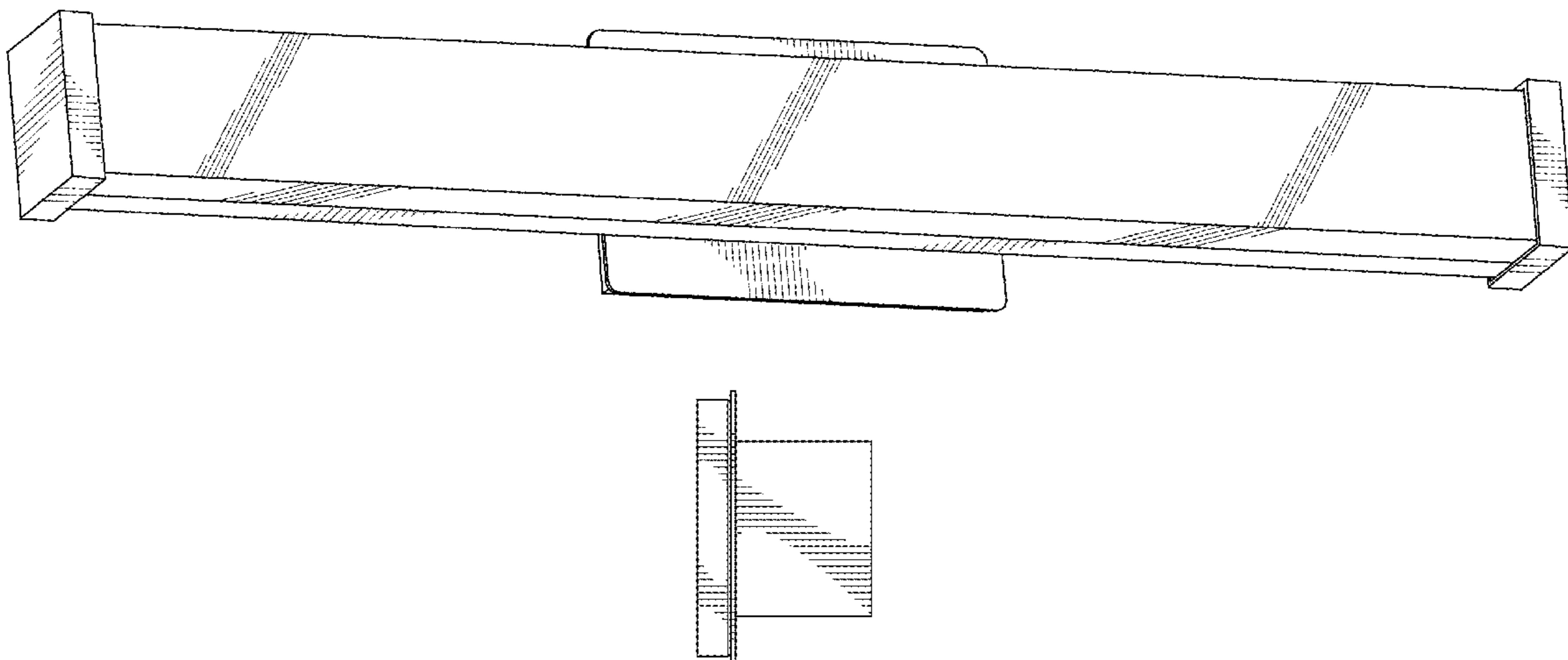

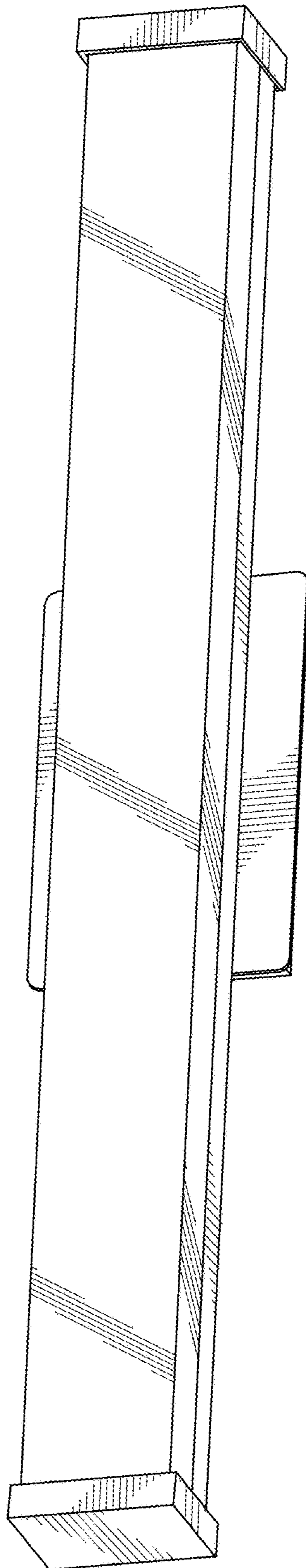

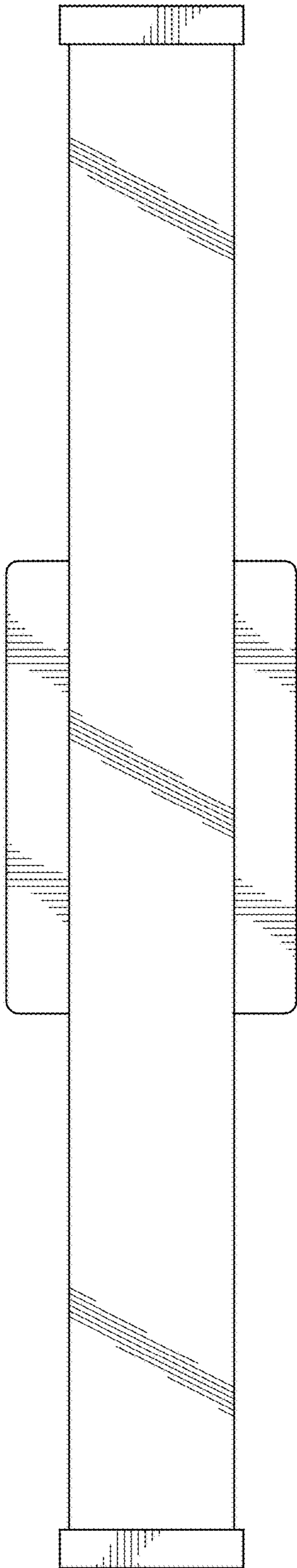

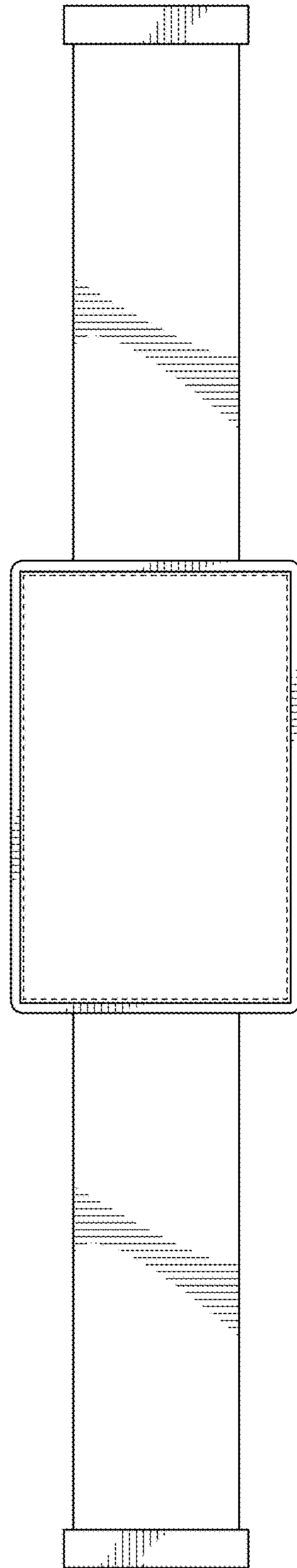

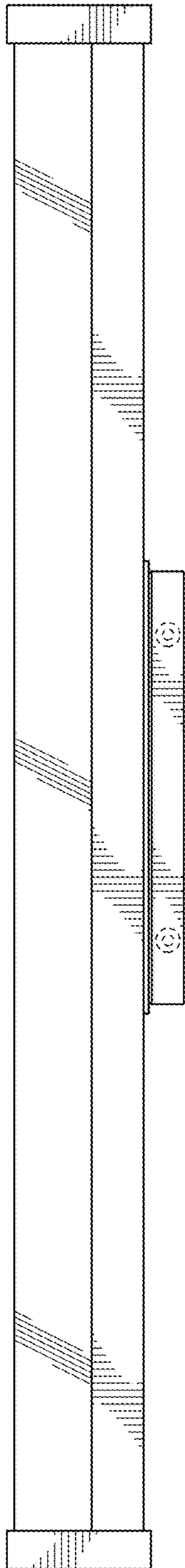

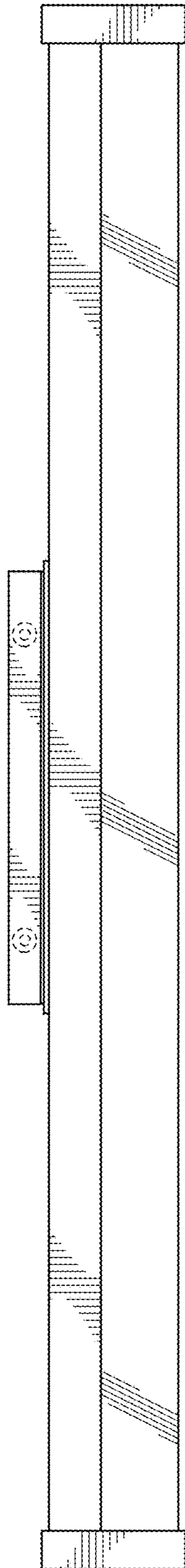

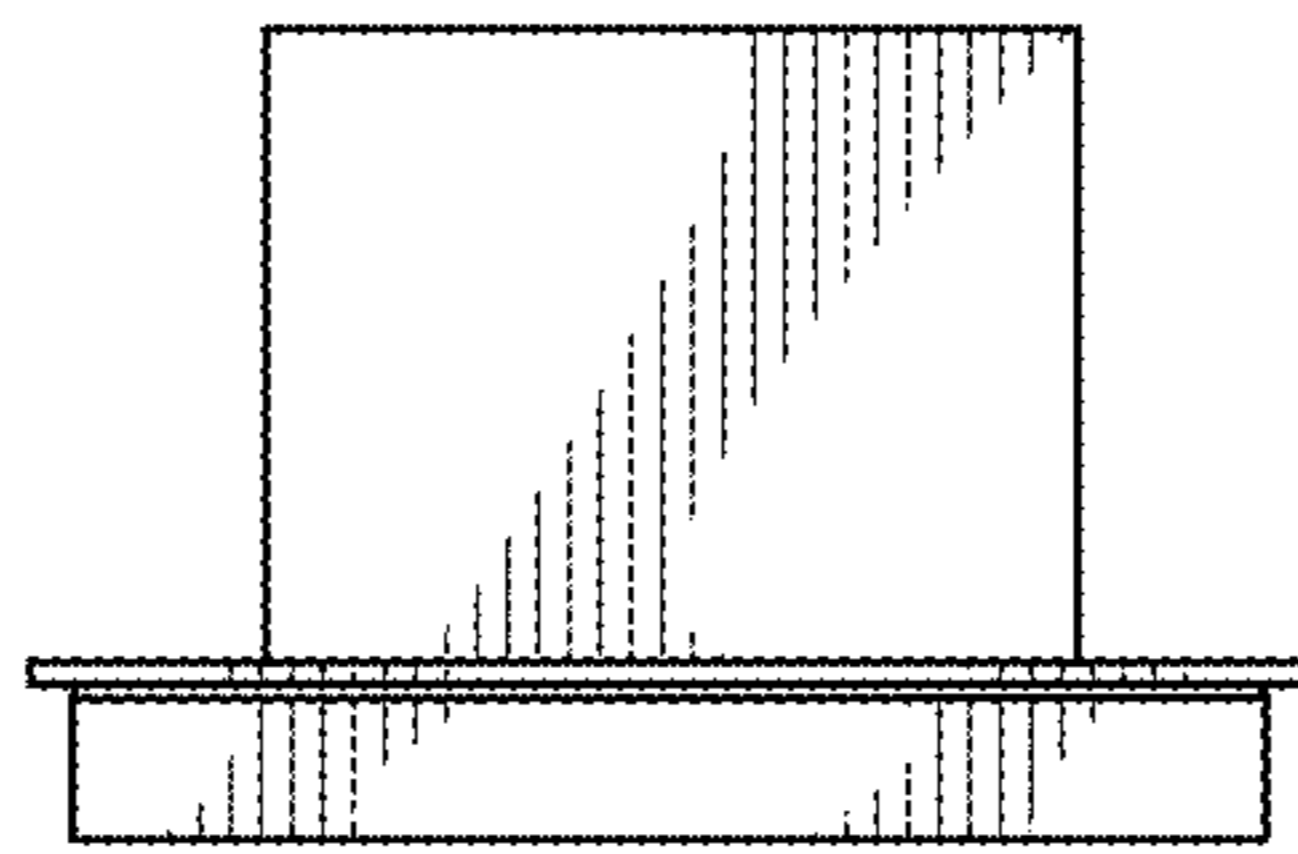

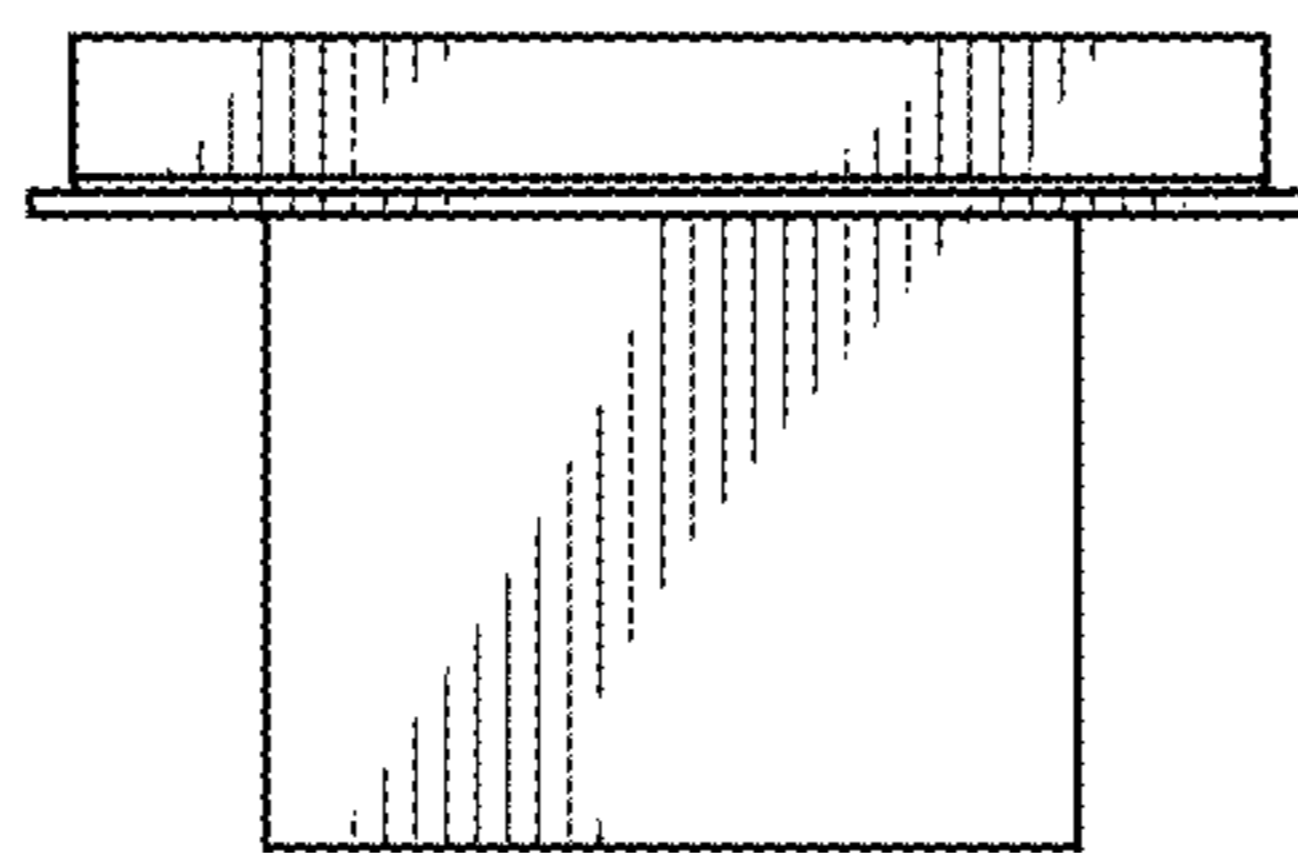
