The ornamental design for a pet scarf, as shown.

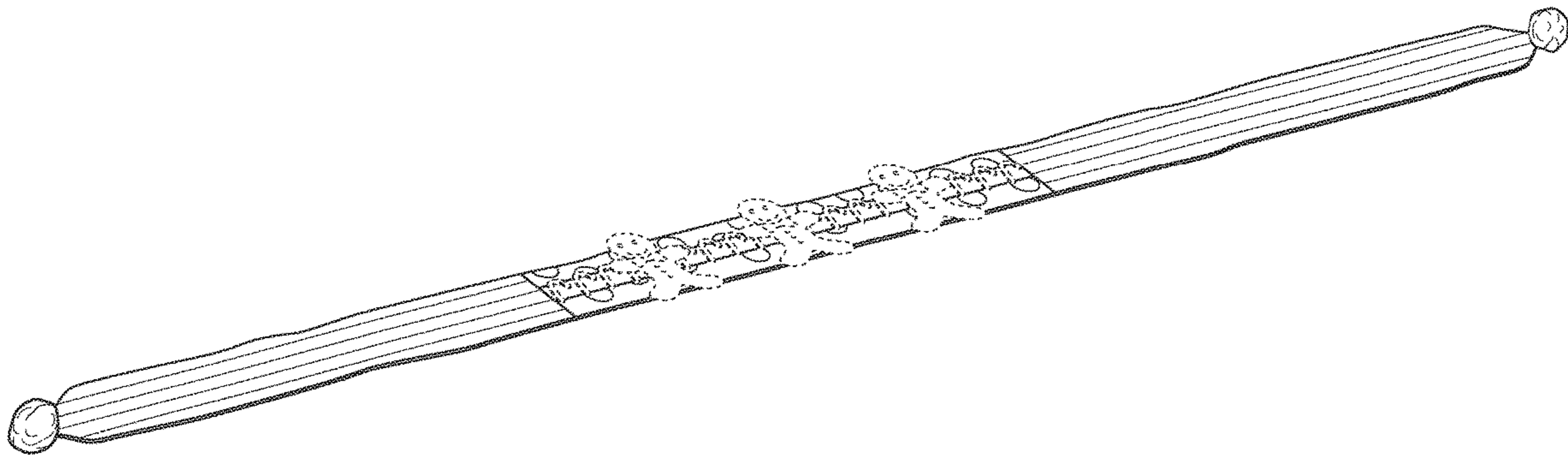
DESCRIPTION

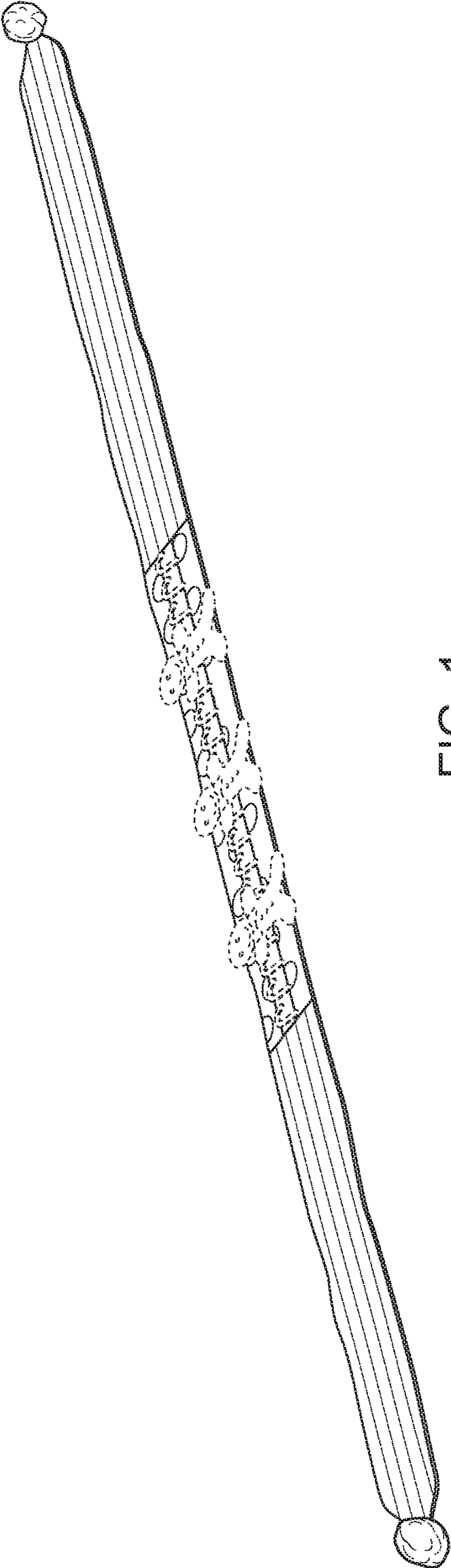
