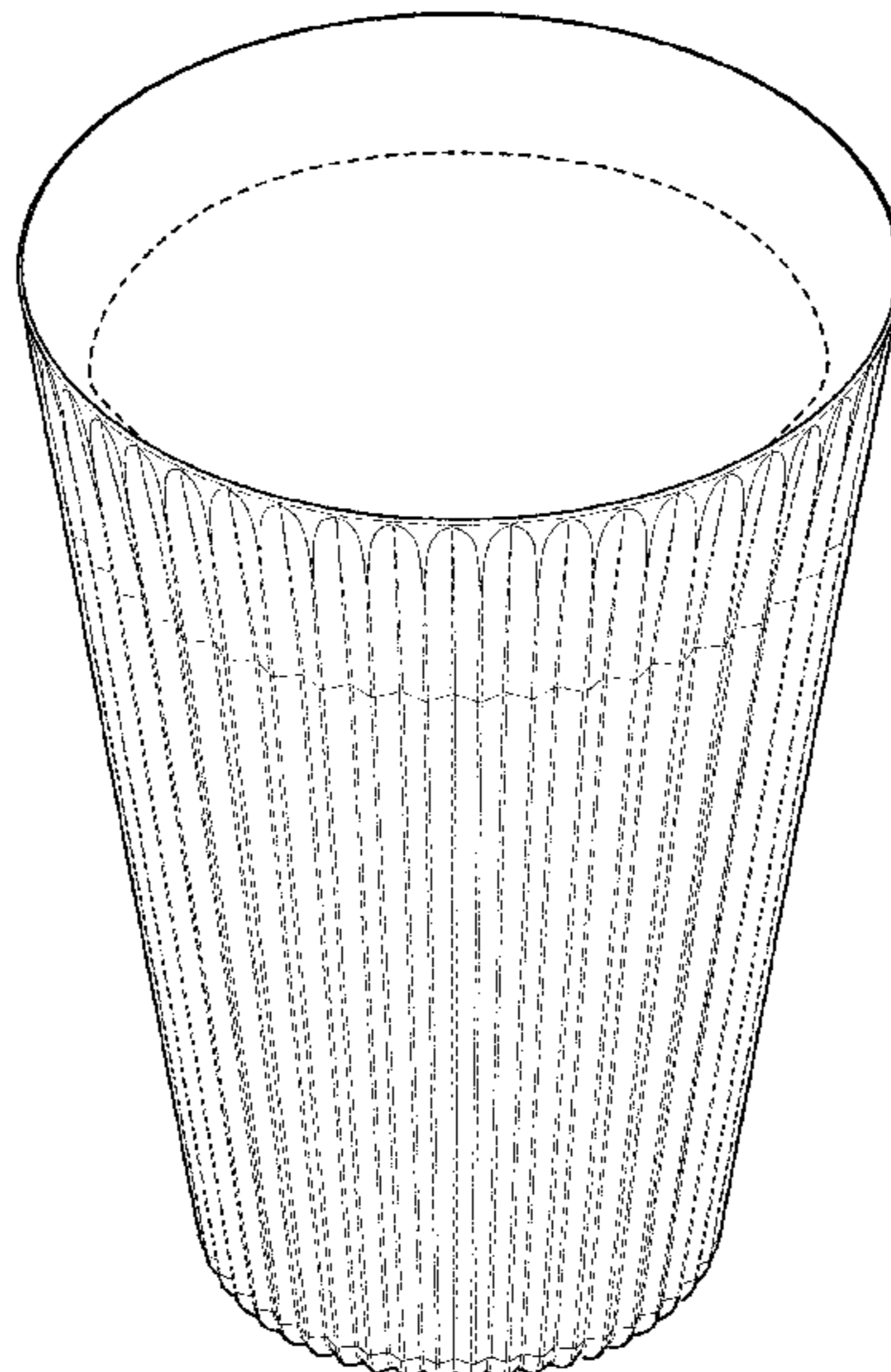
(57) **CLAIM**

We claim the ornamental design for an edible cup, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the edible cup.
FIG. 2 is a side view thereof.
FIG. 3 is a bottom view thereof; and,

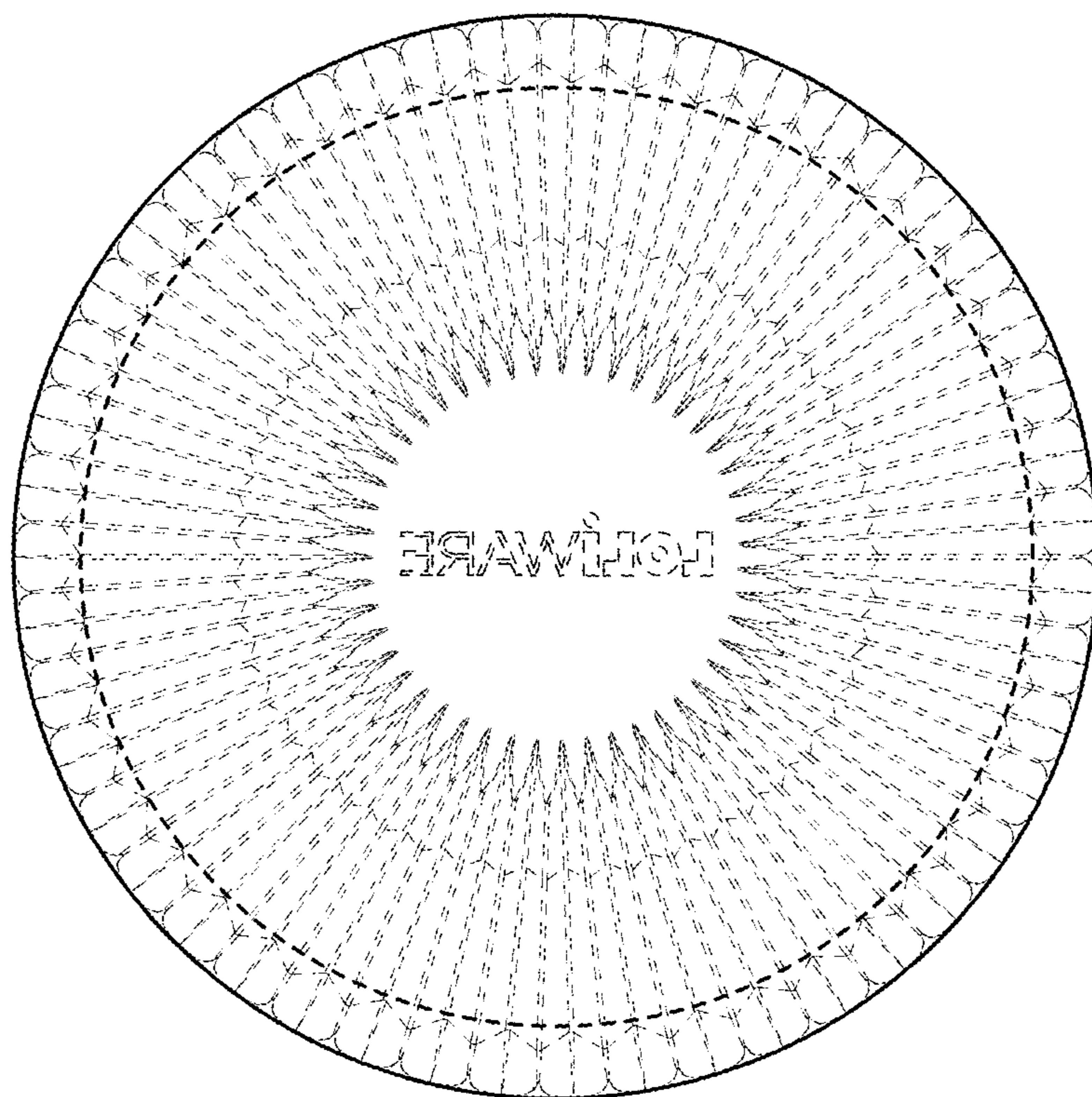

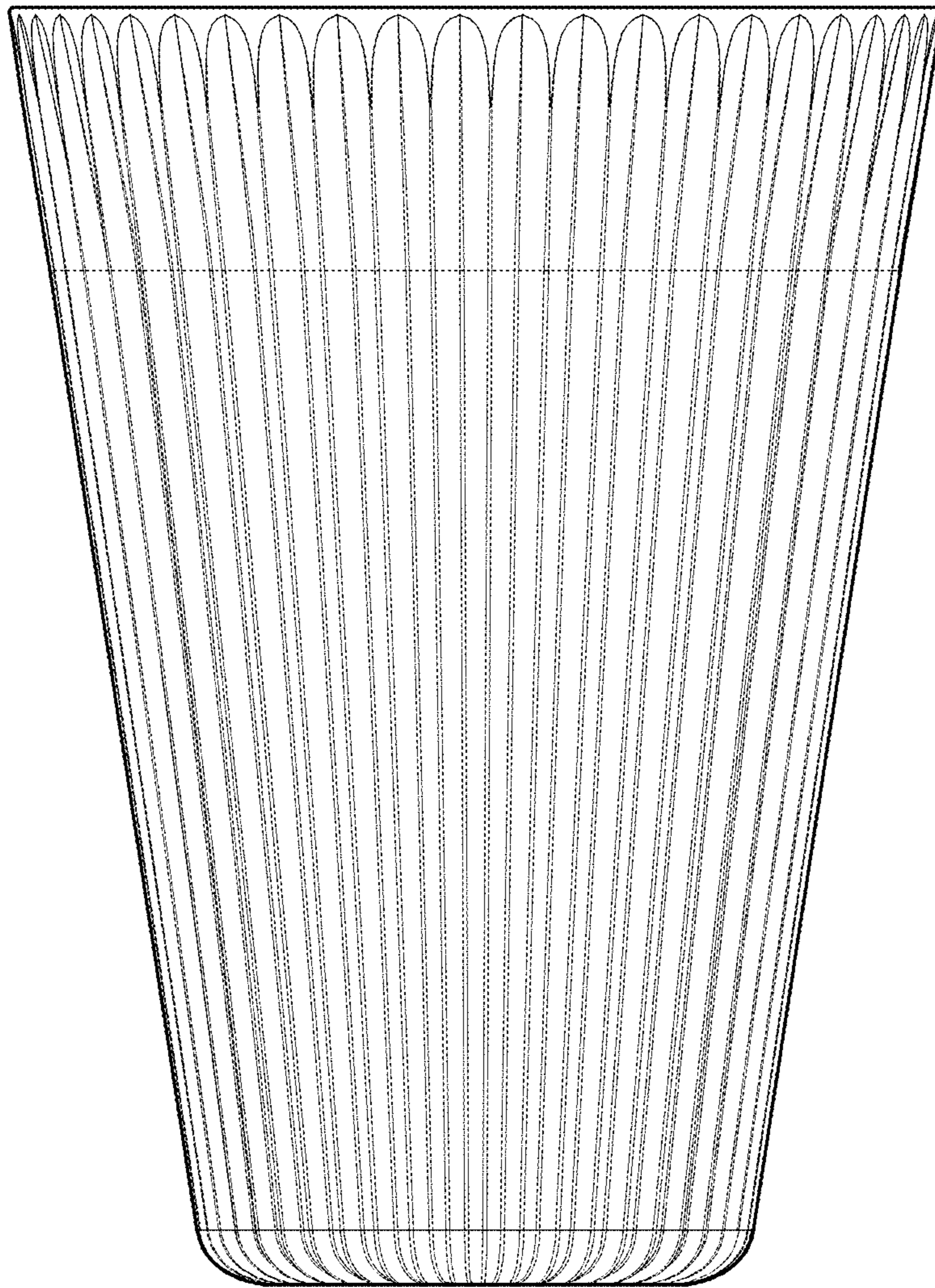

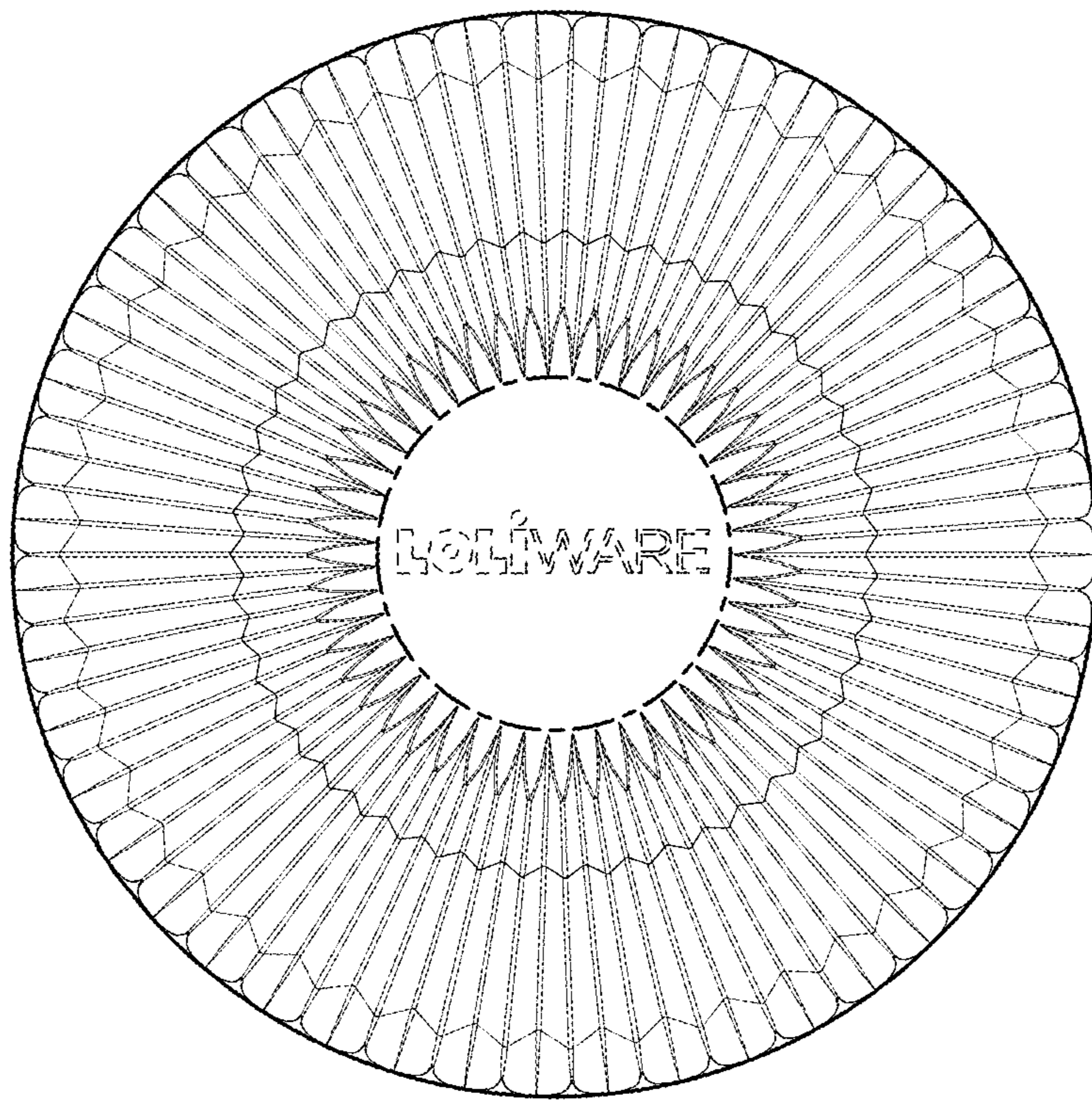

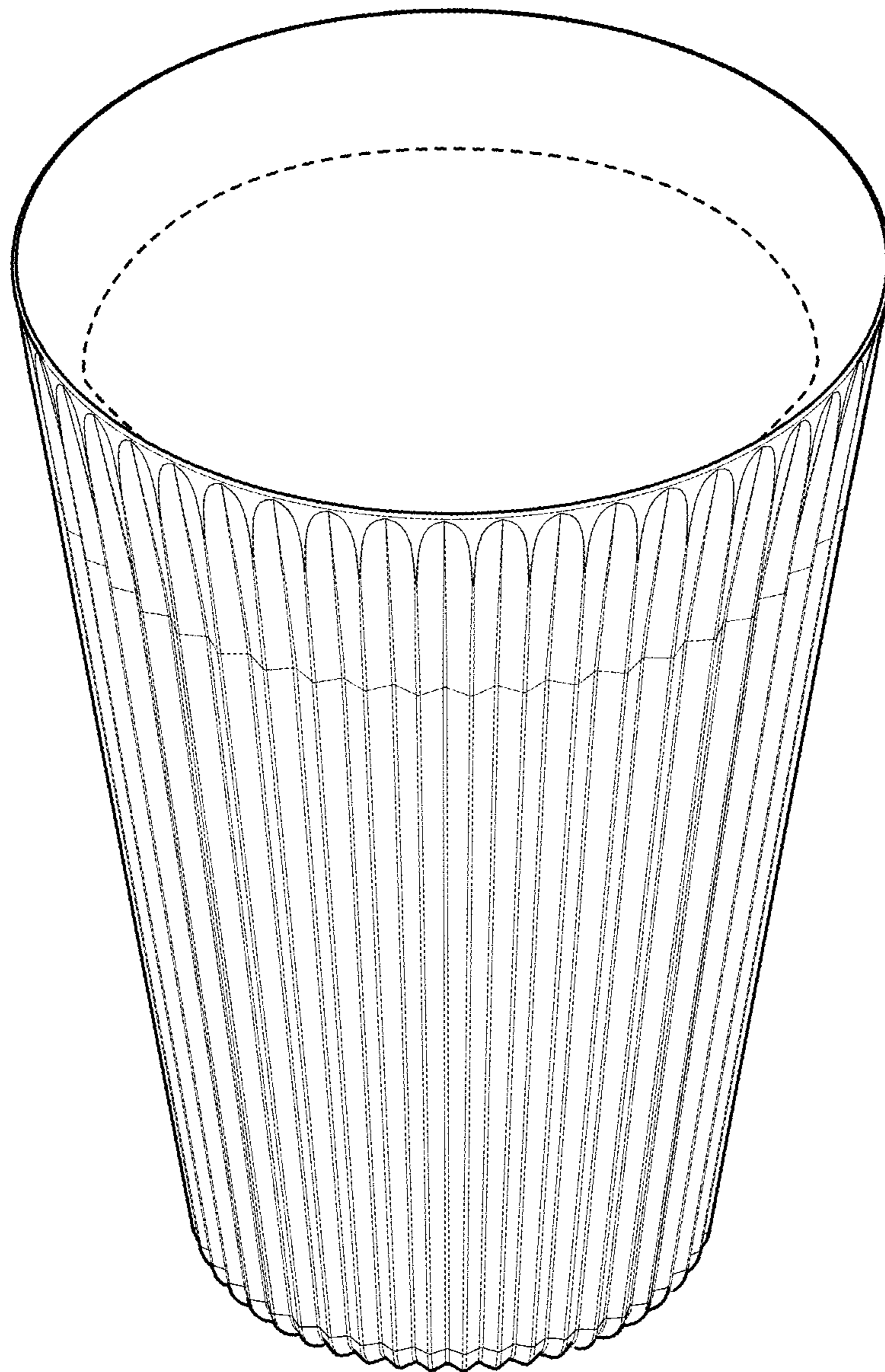
