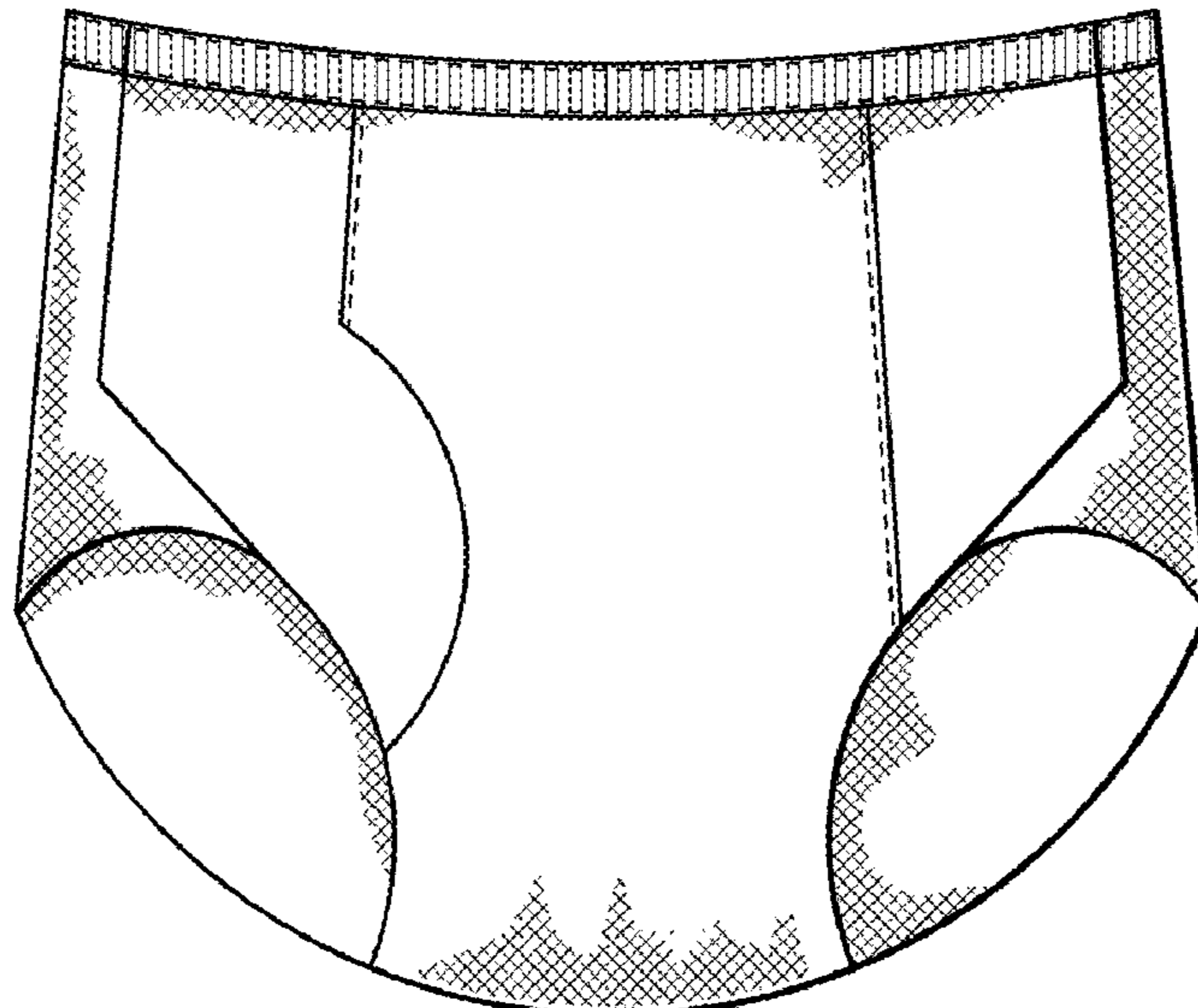
(57) **CLAIM**

The ornamental design for a men's brief garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view;  
FIG. 2 is a back elevation view thereof;  
FIG. 3 is a side elevation view thereof;  
FIG. 4 is an open inside elevation view thereof wherein the front panel and flaps are disengaged; and,  
FIG. 5 is a partially closed inside elevation view thereof wherein the flaps are engaged.  
The broken lines indicate potential locations for stitching and form no part of the claimed design.

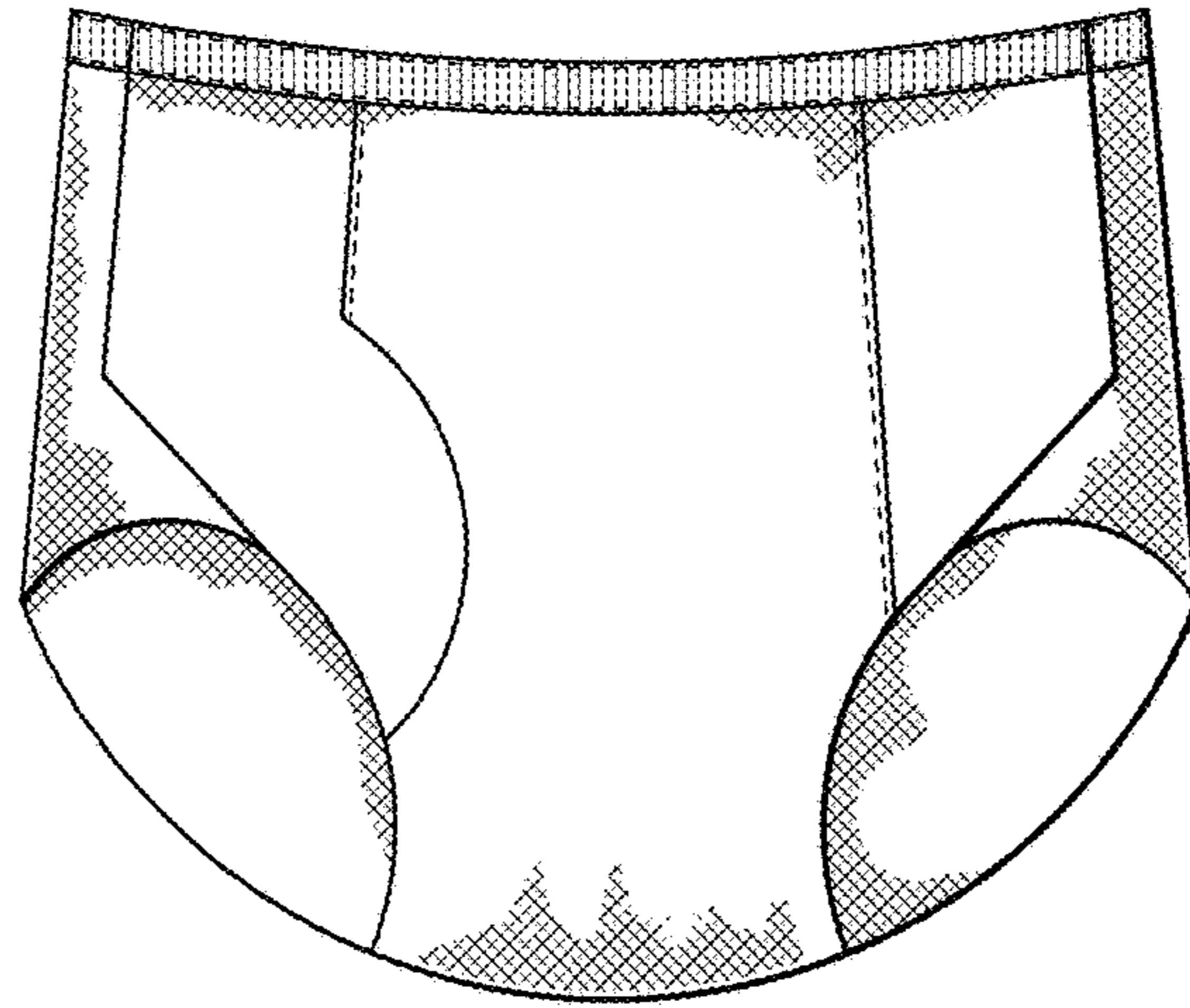

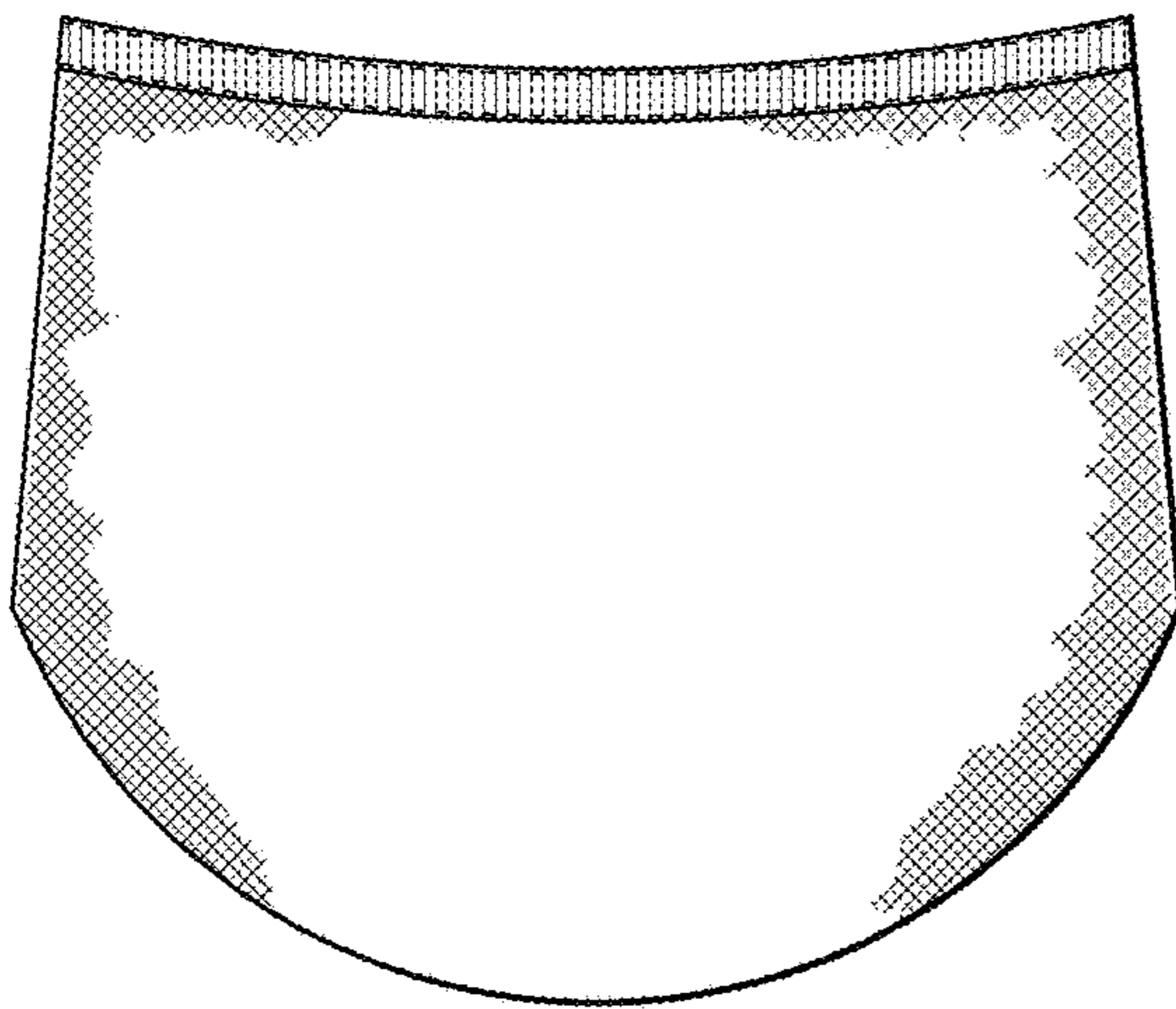

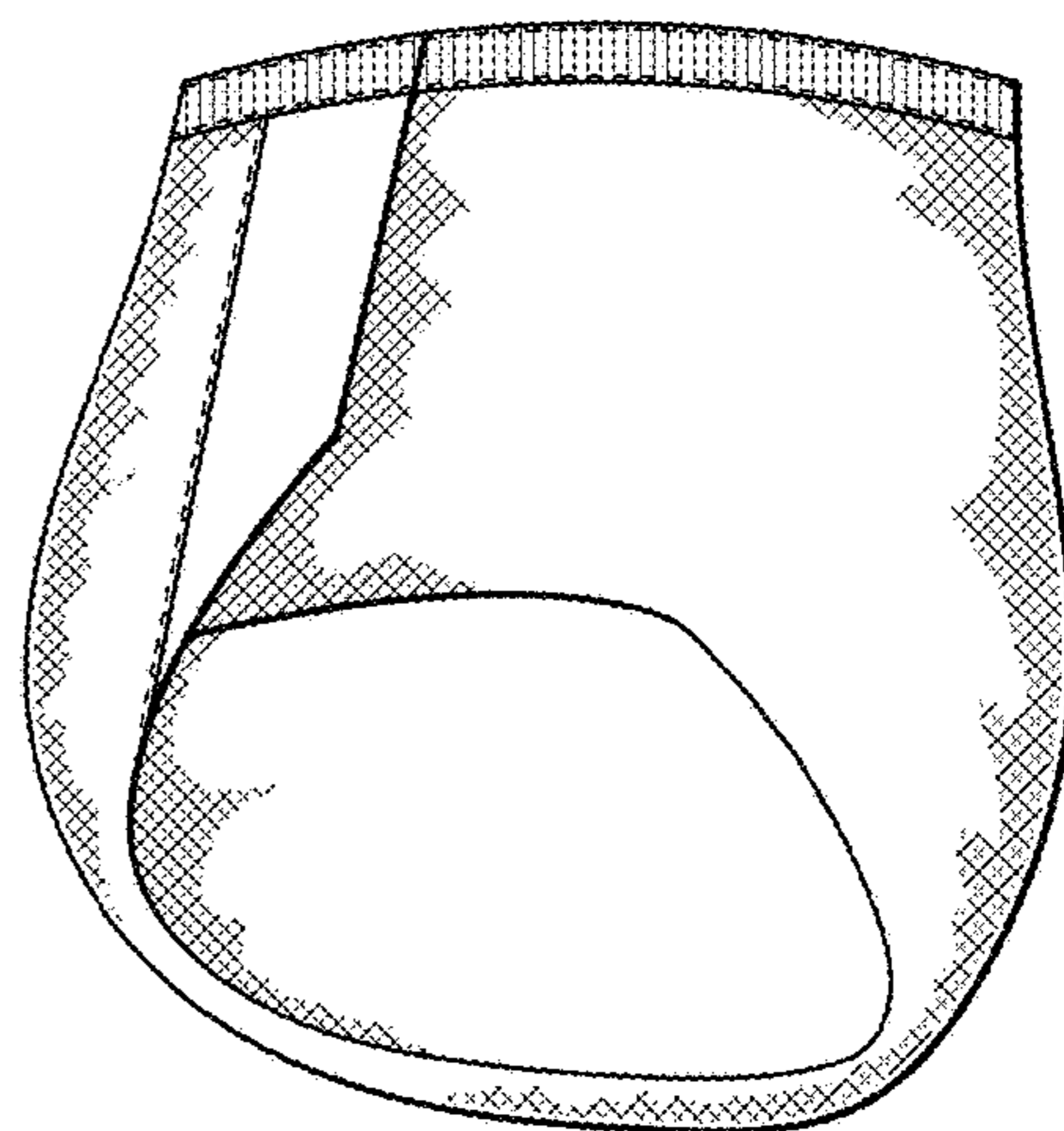

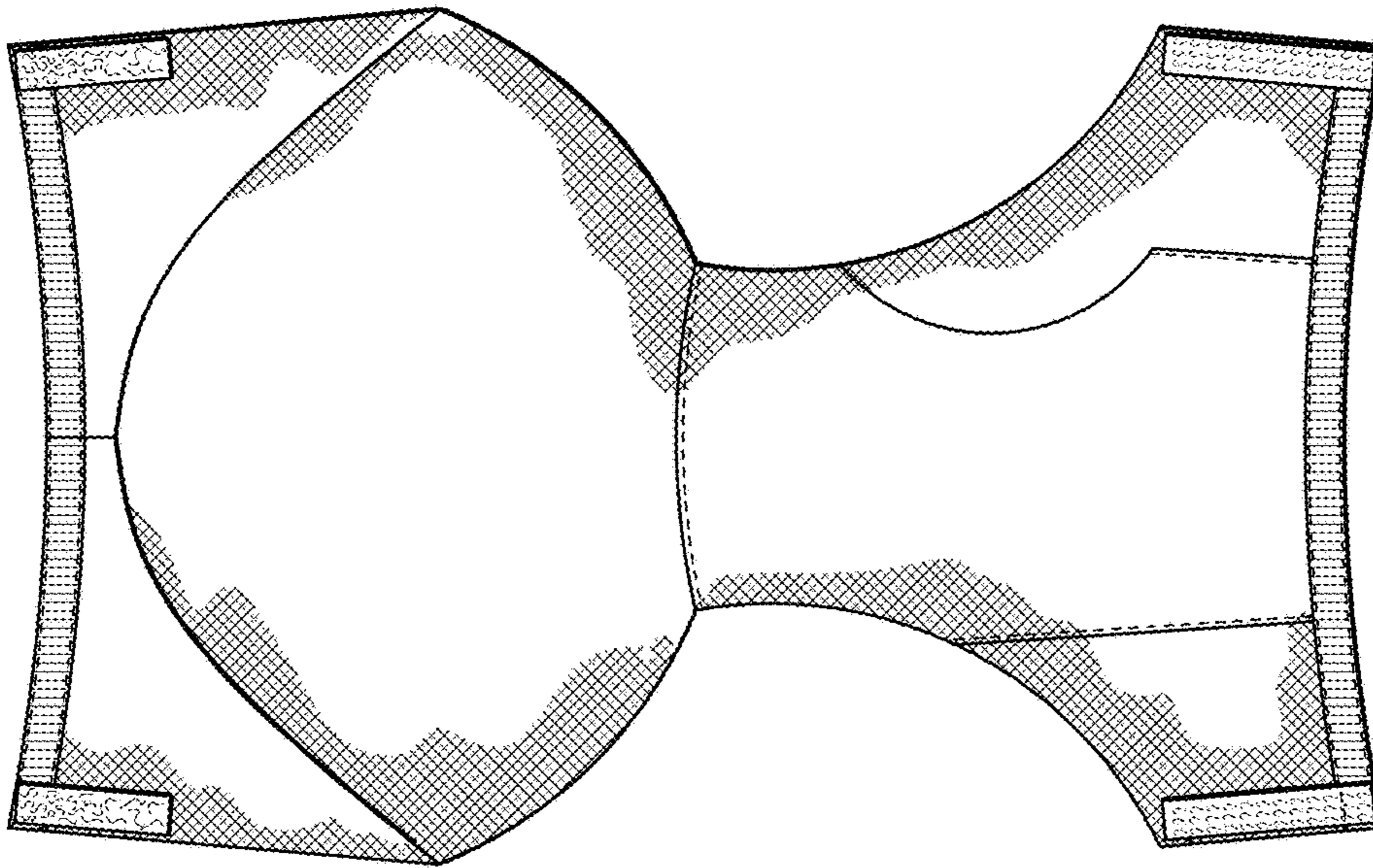

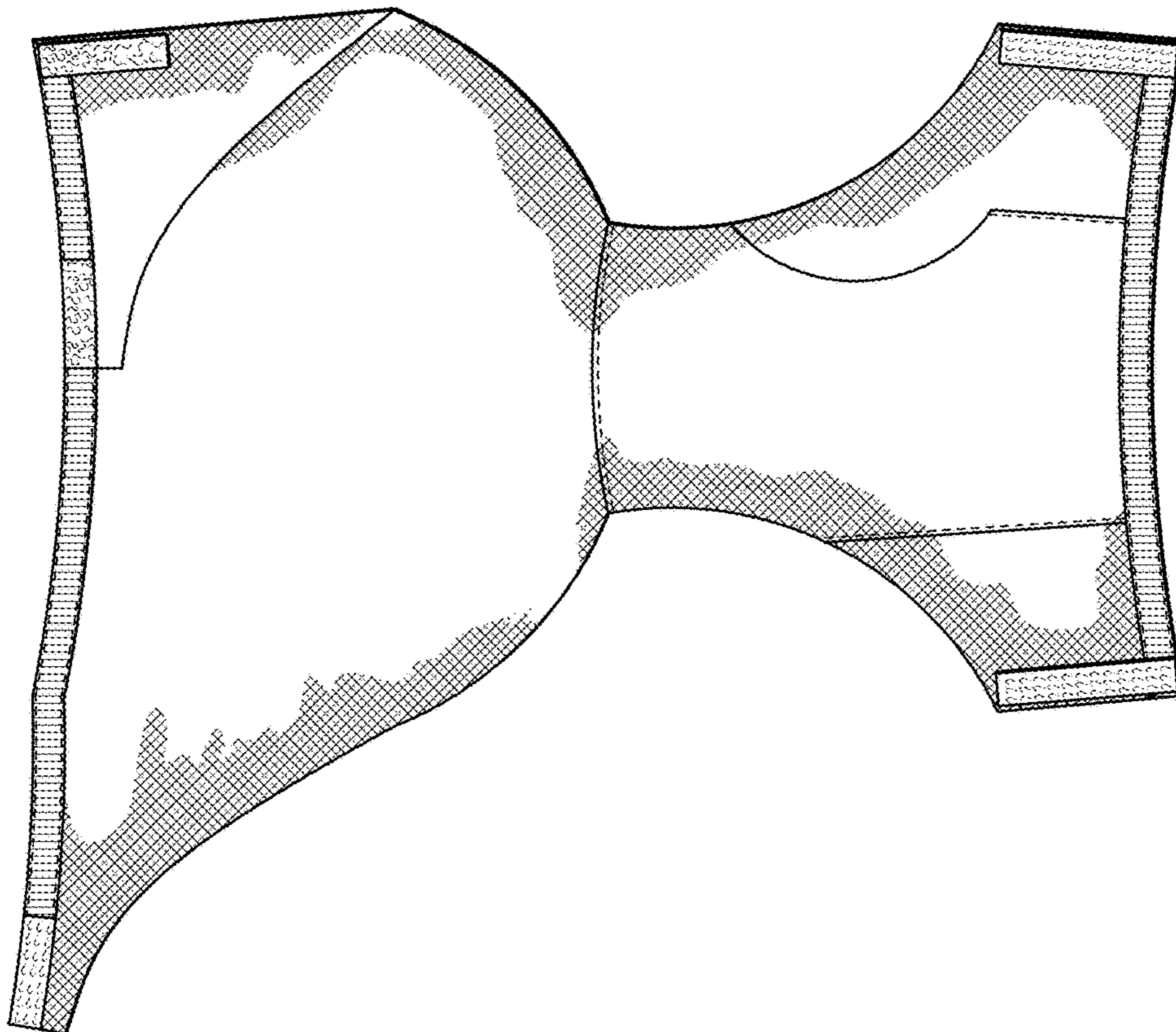
