(57) **CLAIM**

The ornamental design for a dual molded mascara brush head, as shown.

DESCRIPTION

FIG. 1 is an elevation view of our new design for a dual molded mascara brush head;

FIG. 2 is a perspective view of the dual molded mascara brush head shown in FIG. 1;

FIG. 3 is a second perspective view of the dual molded mascara brush head shown in FIG. 1;

FIG. 4 is a front elevation view of the dual molded mascara brush head shown in FIG. 1;

FIG. 5 is a back elevation view of the dual molded mascara brush head shown in FIG. 1;

FIG. 6 is a right side elevation view of the dual molded mascara brush head shown in FIG. 1, the left side elevation view being a mirror image thereof.

FIG. 7 is a top plan view of the dual molded mascara brush head, shown in FIG. 1; and,

FIG. 8 is a bottom plan view of the dual molded mascara brush head, shown in FIG. 1.

The broken lines showing the stem and handle in FIG. 1 are for illustrative purposes only and form no part of the claimed design. FIGS. 2-8 omit the stem and handle so that the mascara brush head may be enlarged.

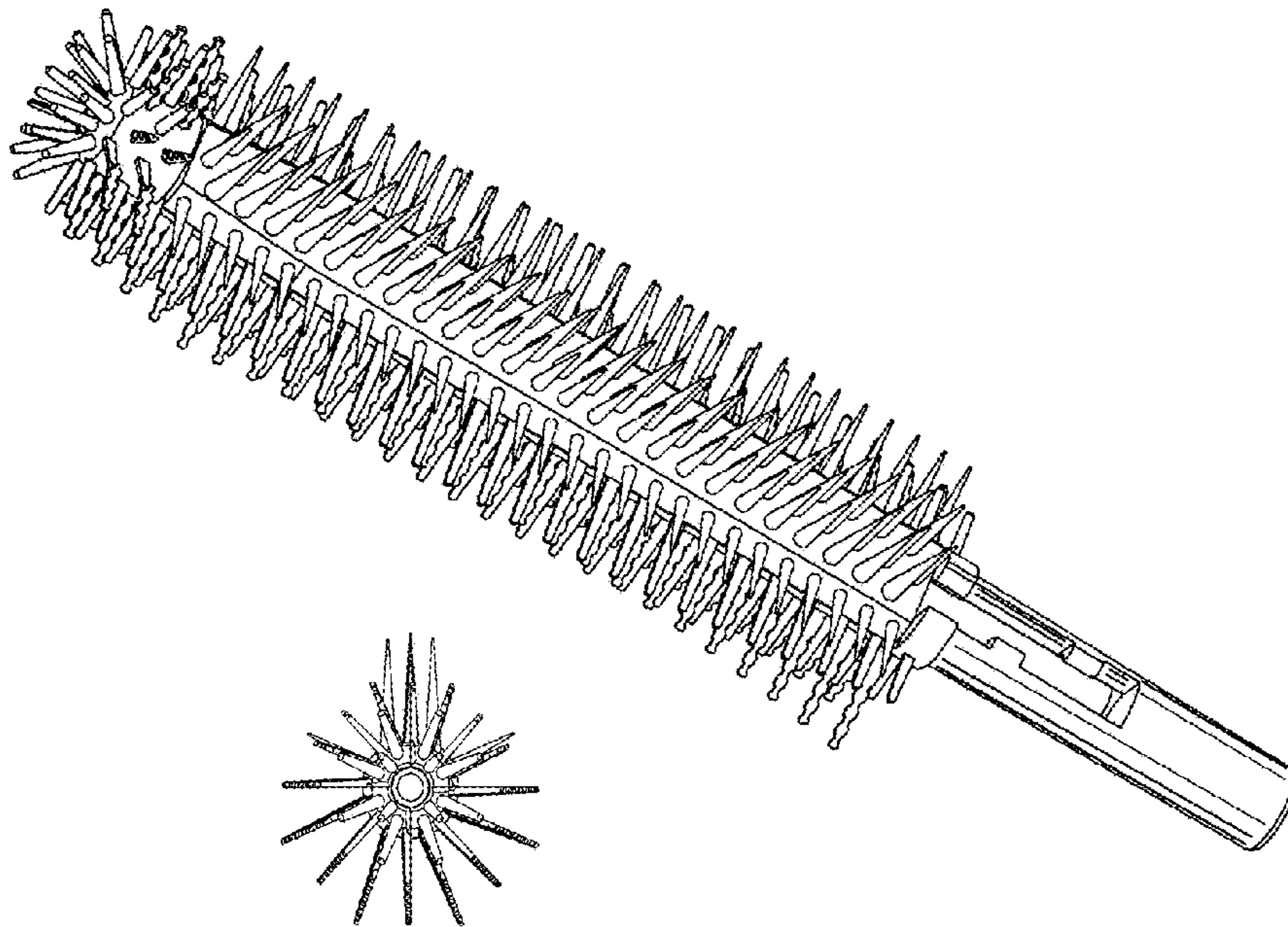

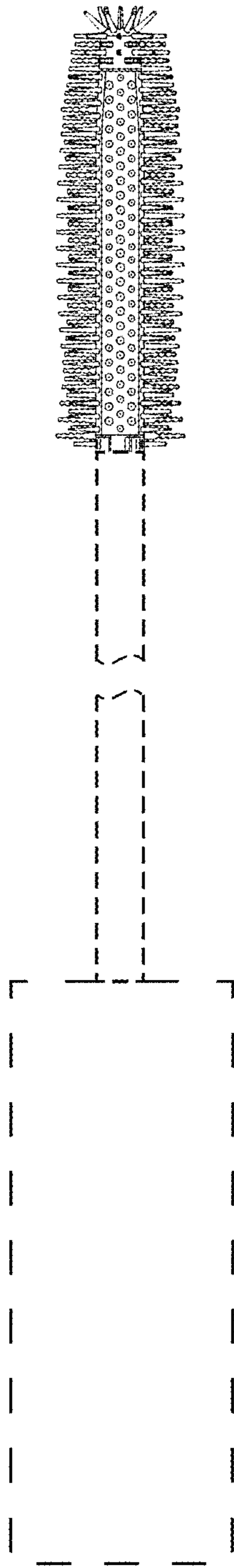

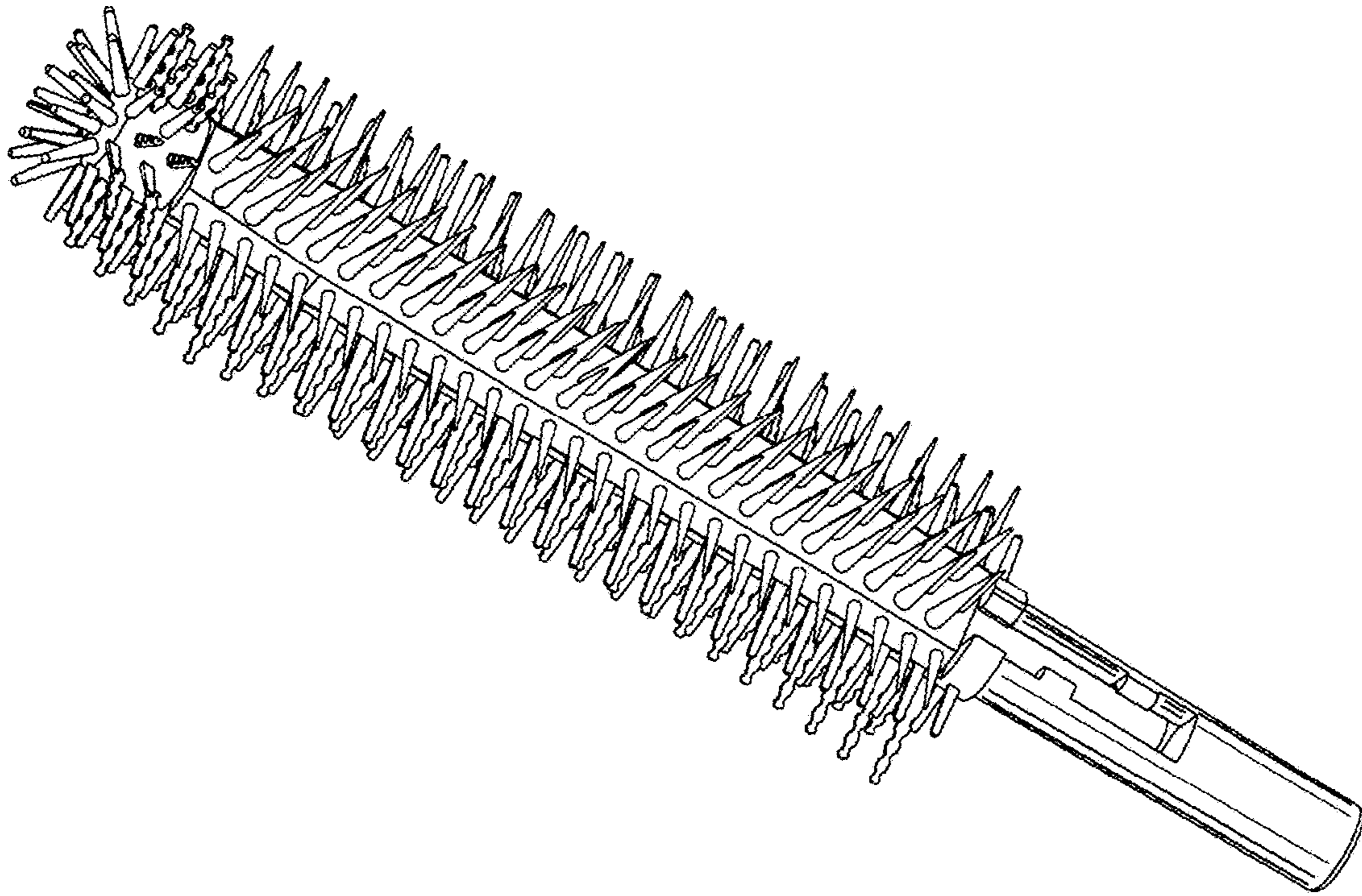

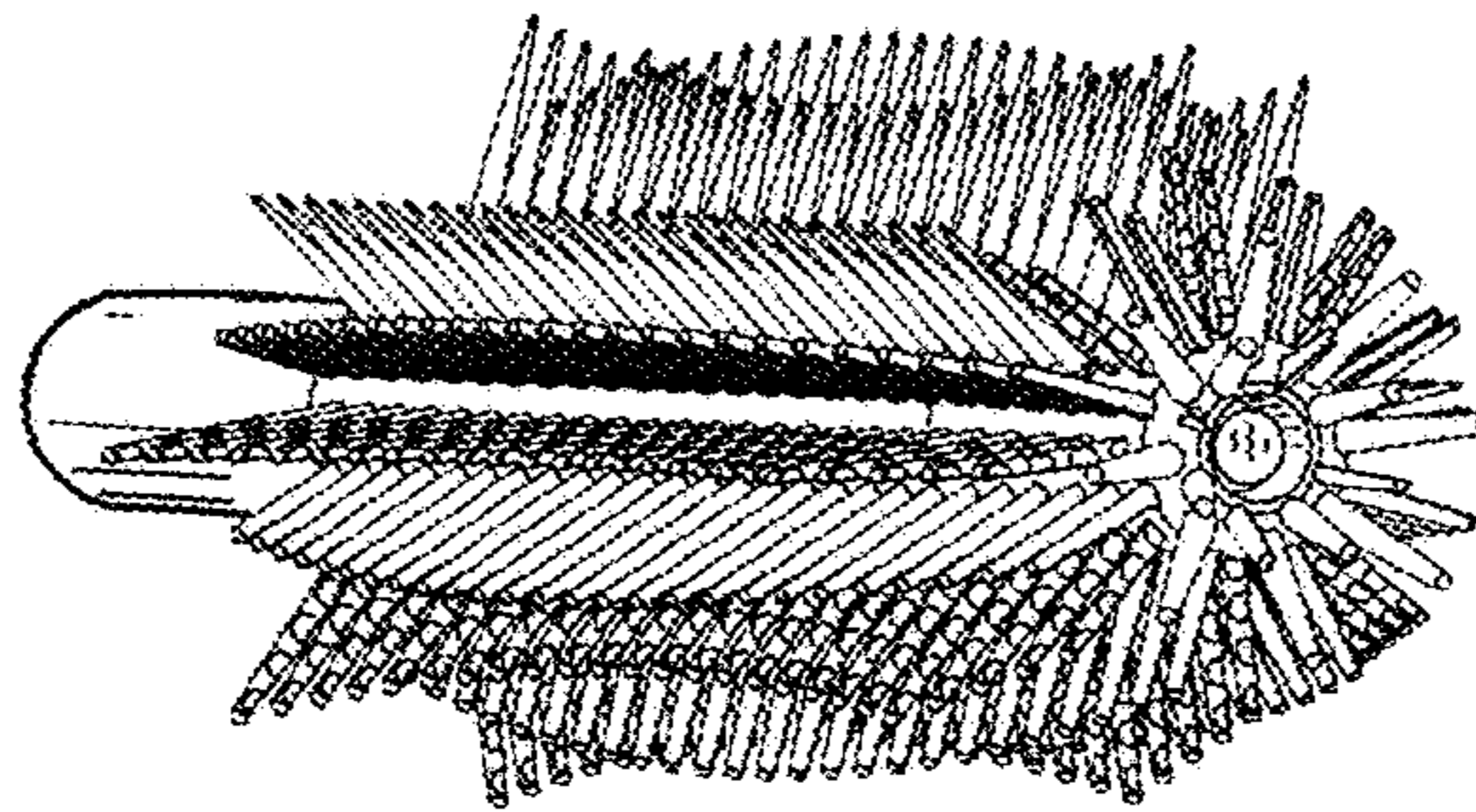

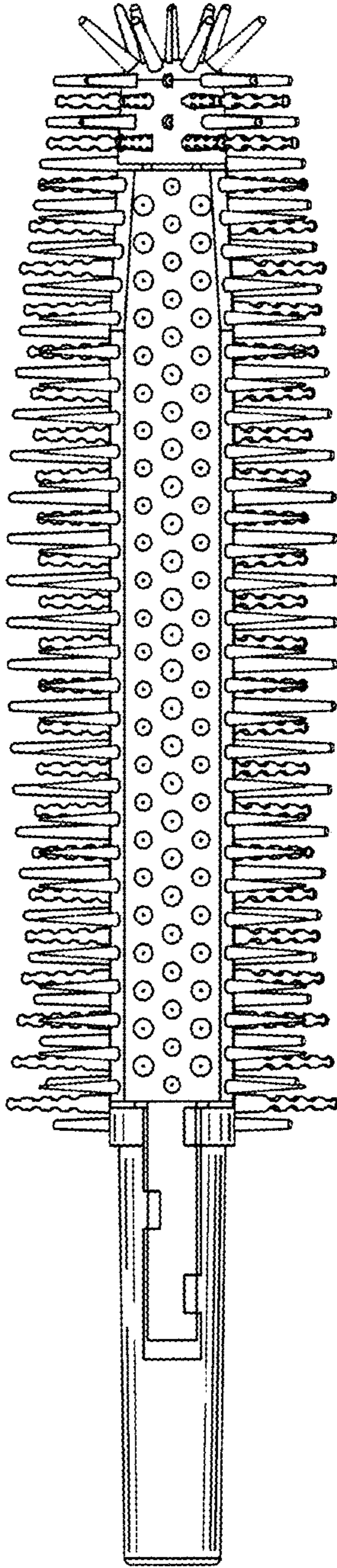

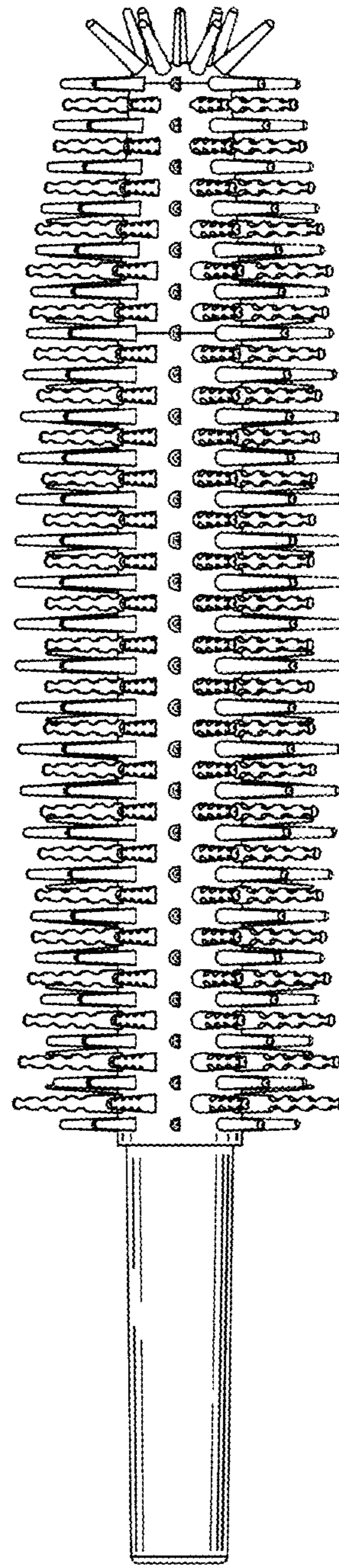

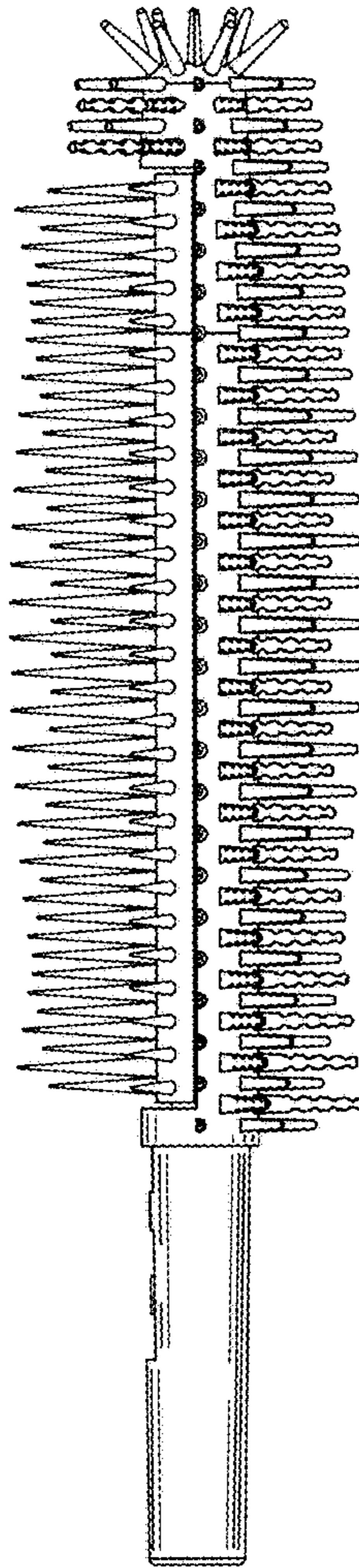

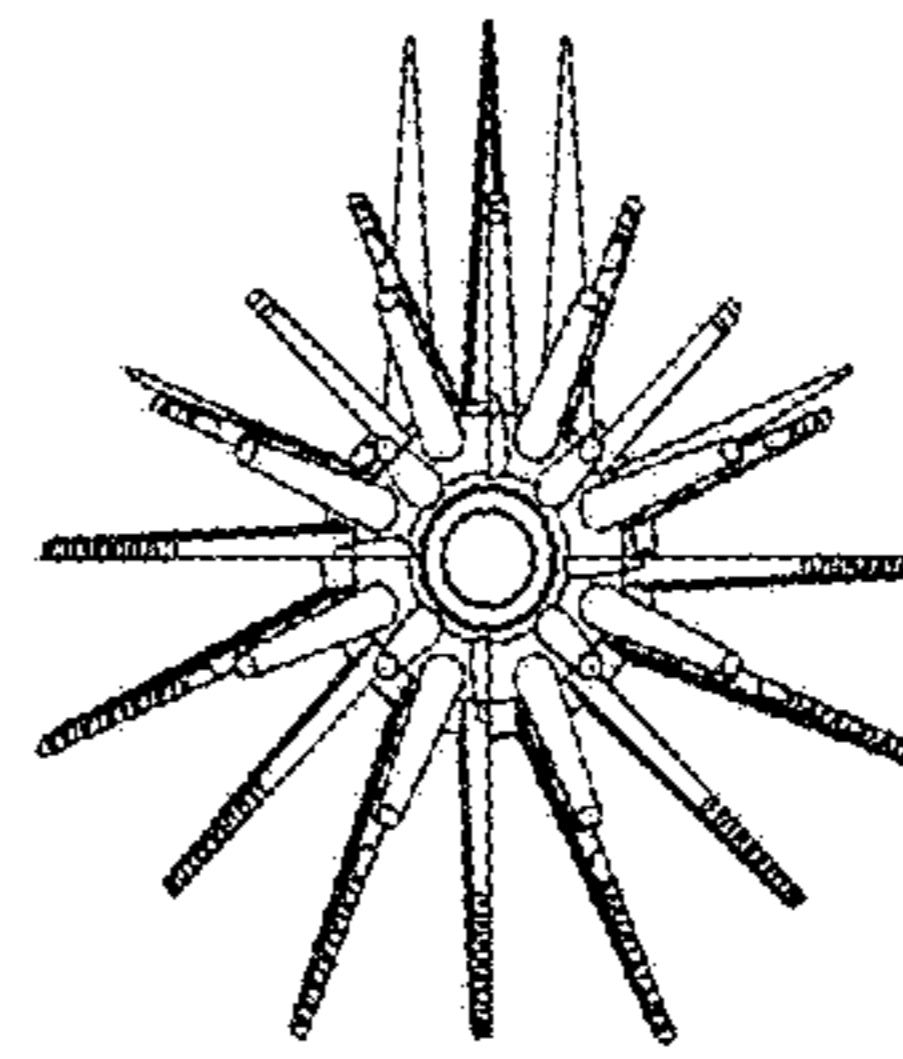
