DESCRIPTION

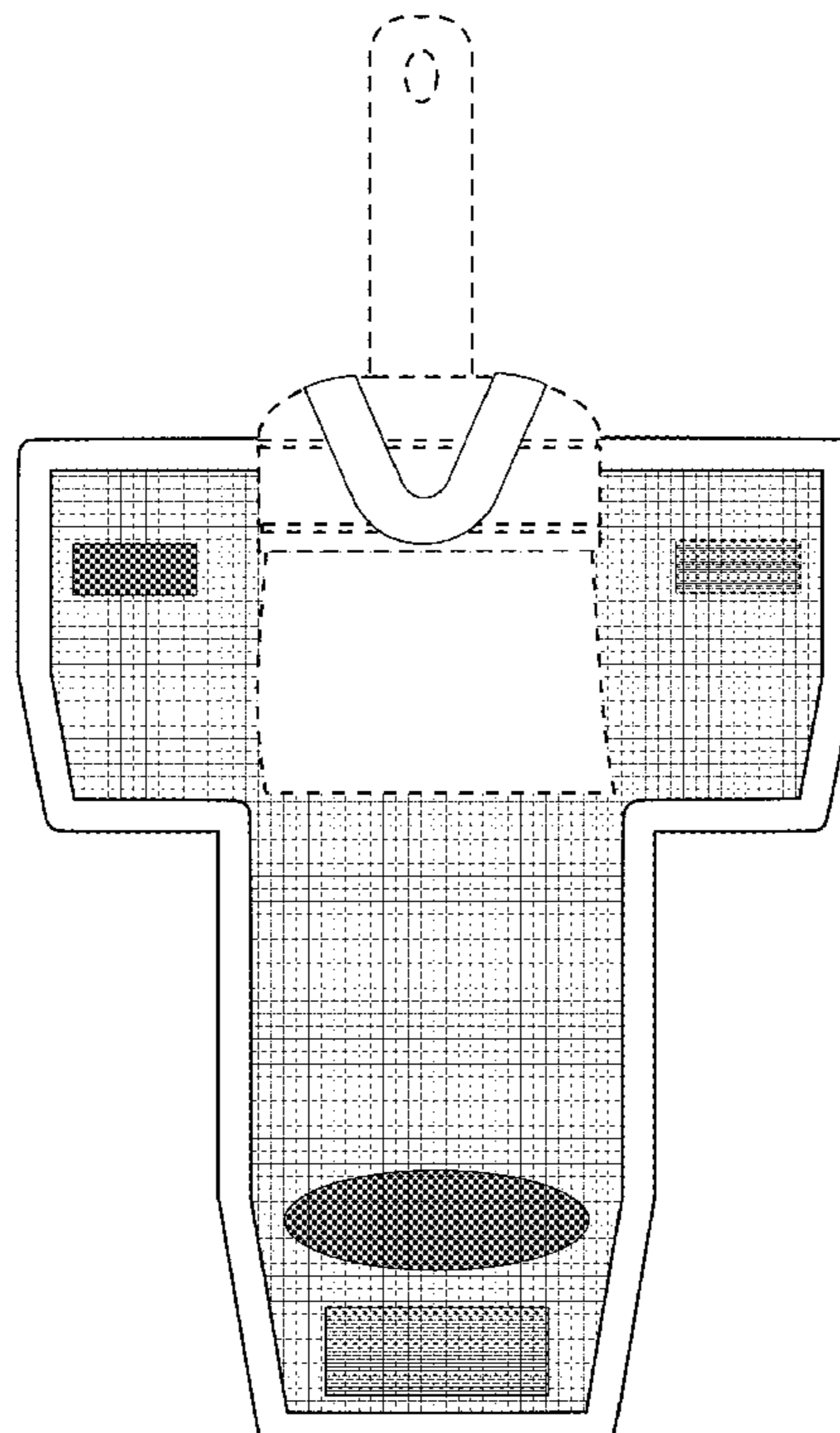
FIG. 1 is a front side elevation of the paint brush protector

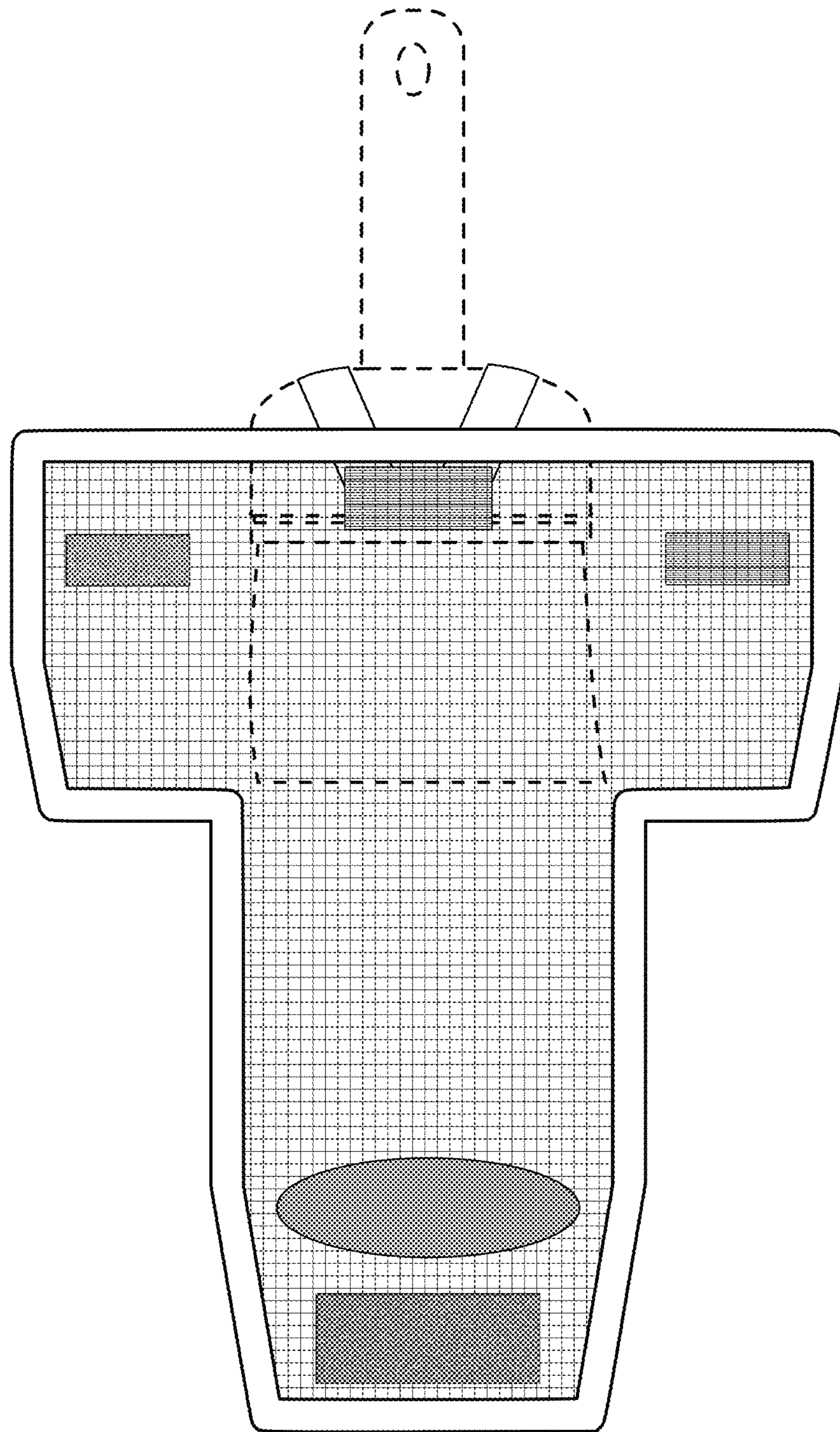

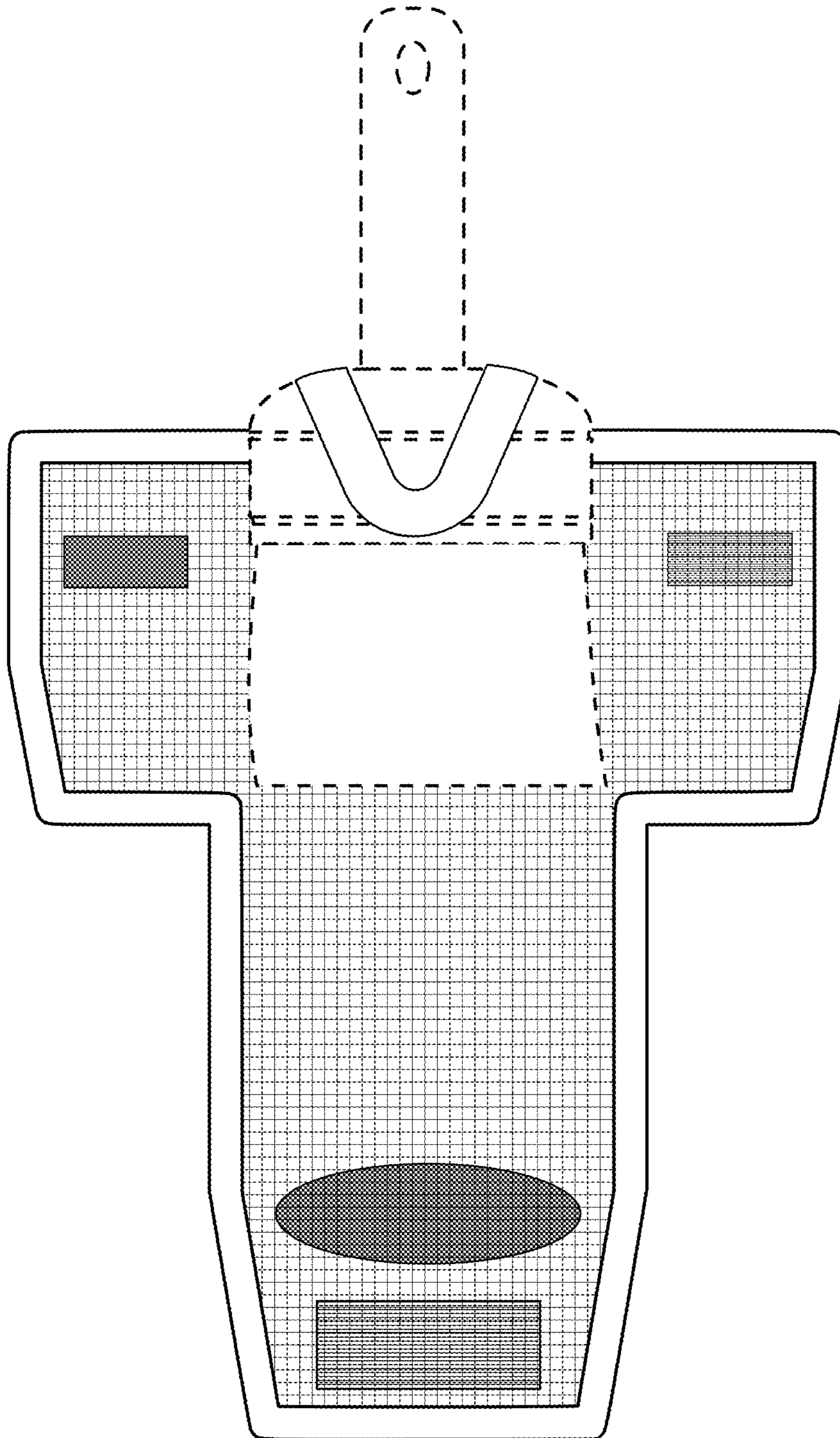

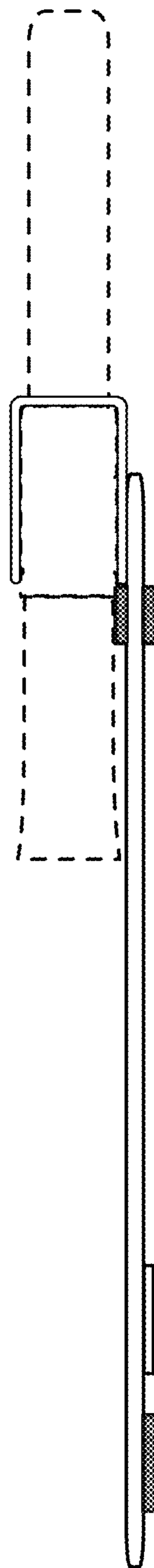

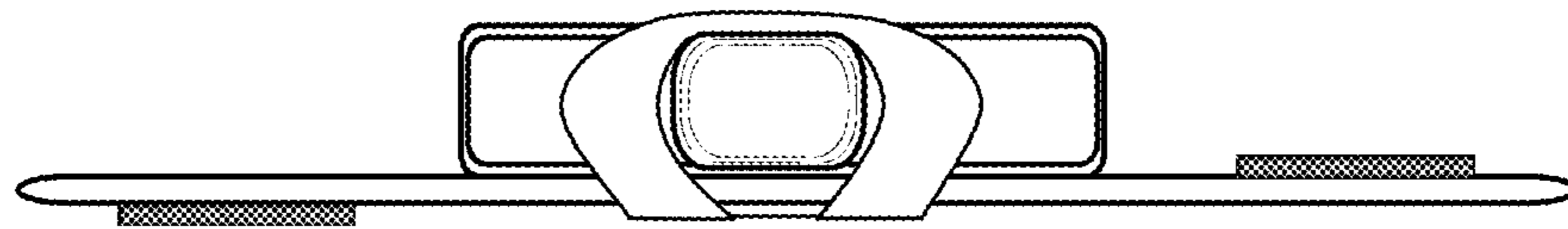

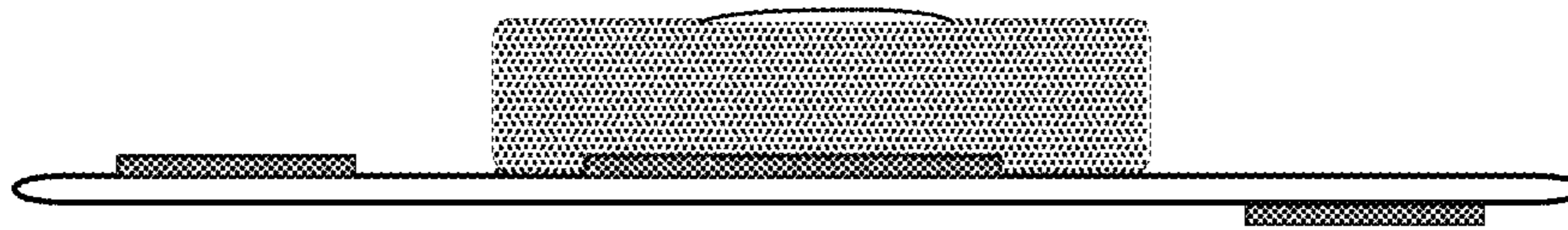
