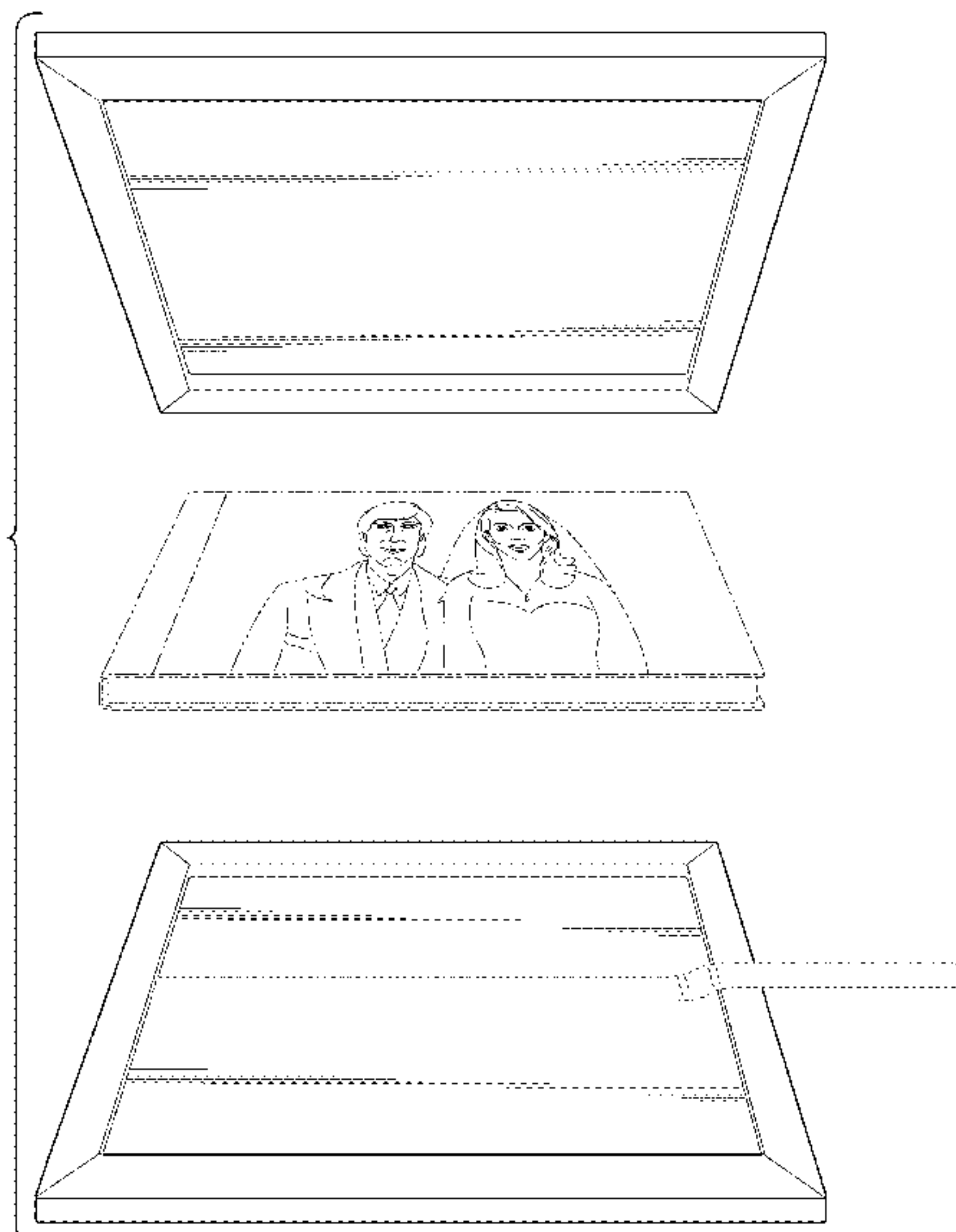
(57) **CLAIM**

The ornamental design for a container for a photographic collection, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of the container for a photographic collection showing my new design; FIG. 2 is a top view of the container; FIG. 3 is a front elevation of the container; FIG. 4 is a right side view of the container; FIG. 5 is a bottom view of the container; FIG. 6 is a rear view of the container; and, FIG. 7 is a left side view of the container. 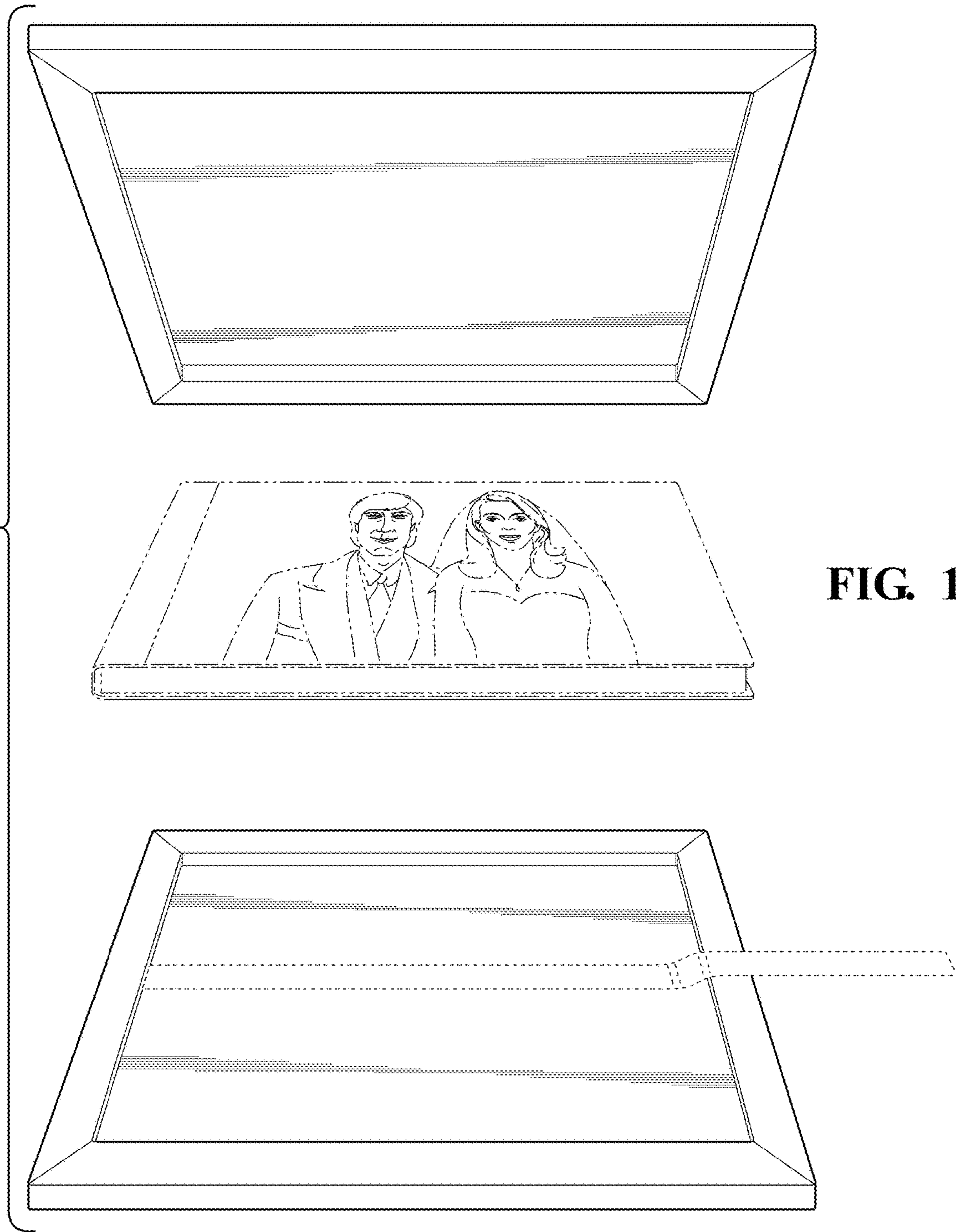

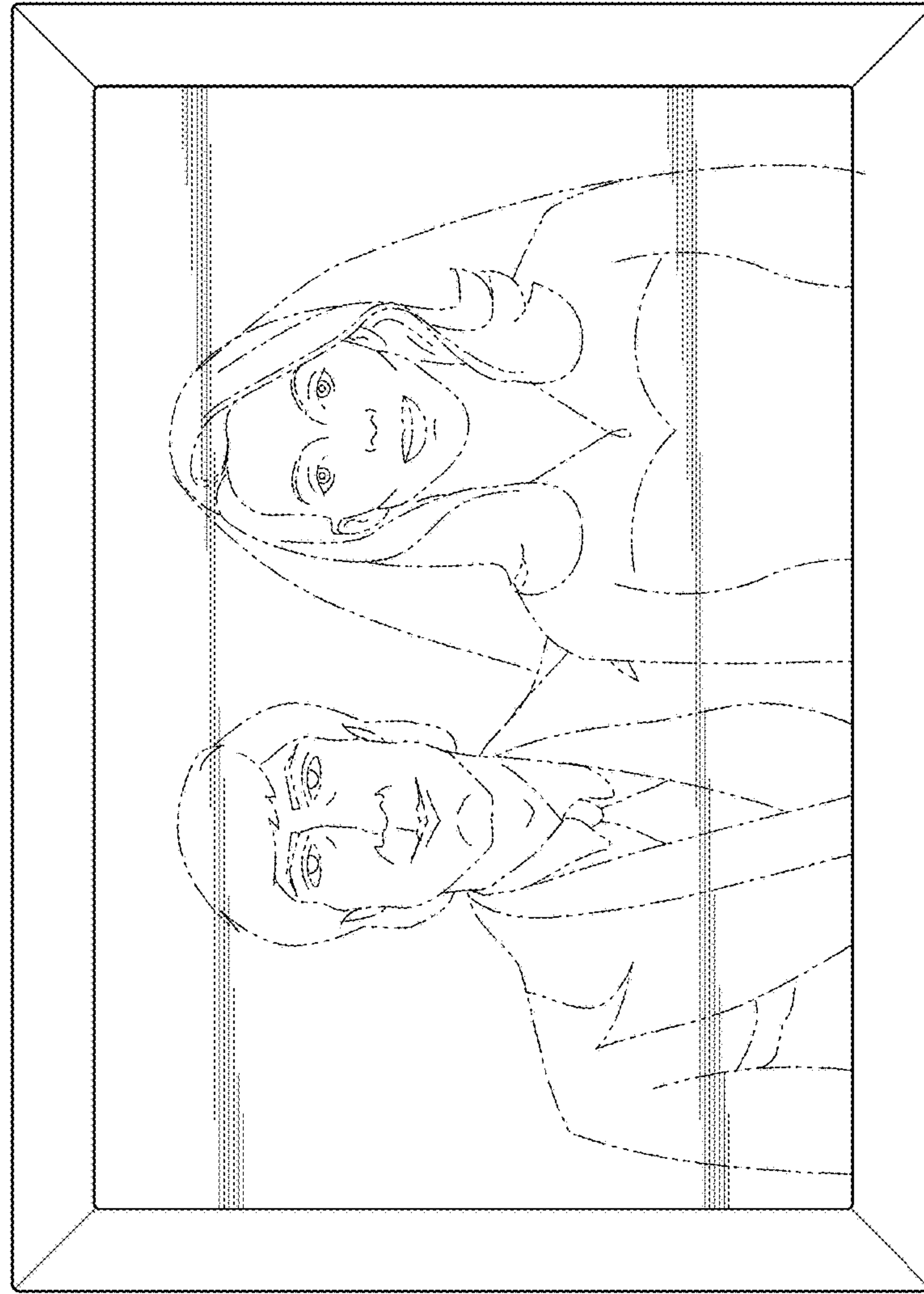

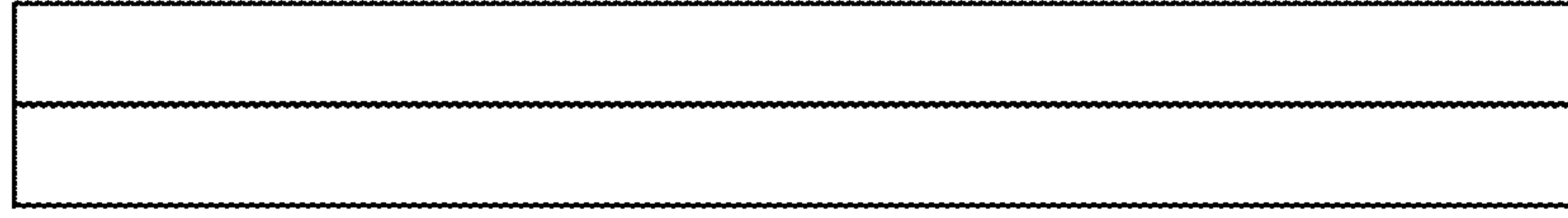
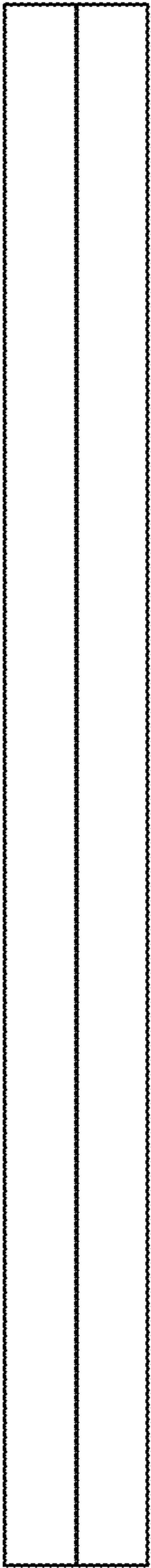

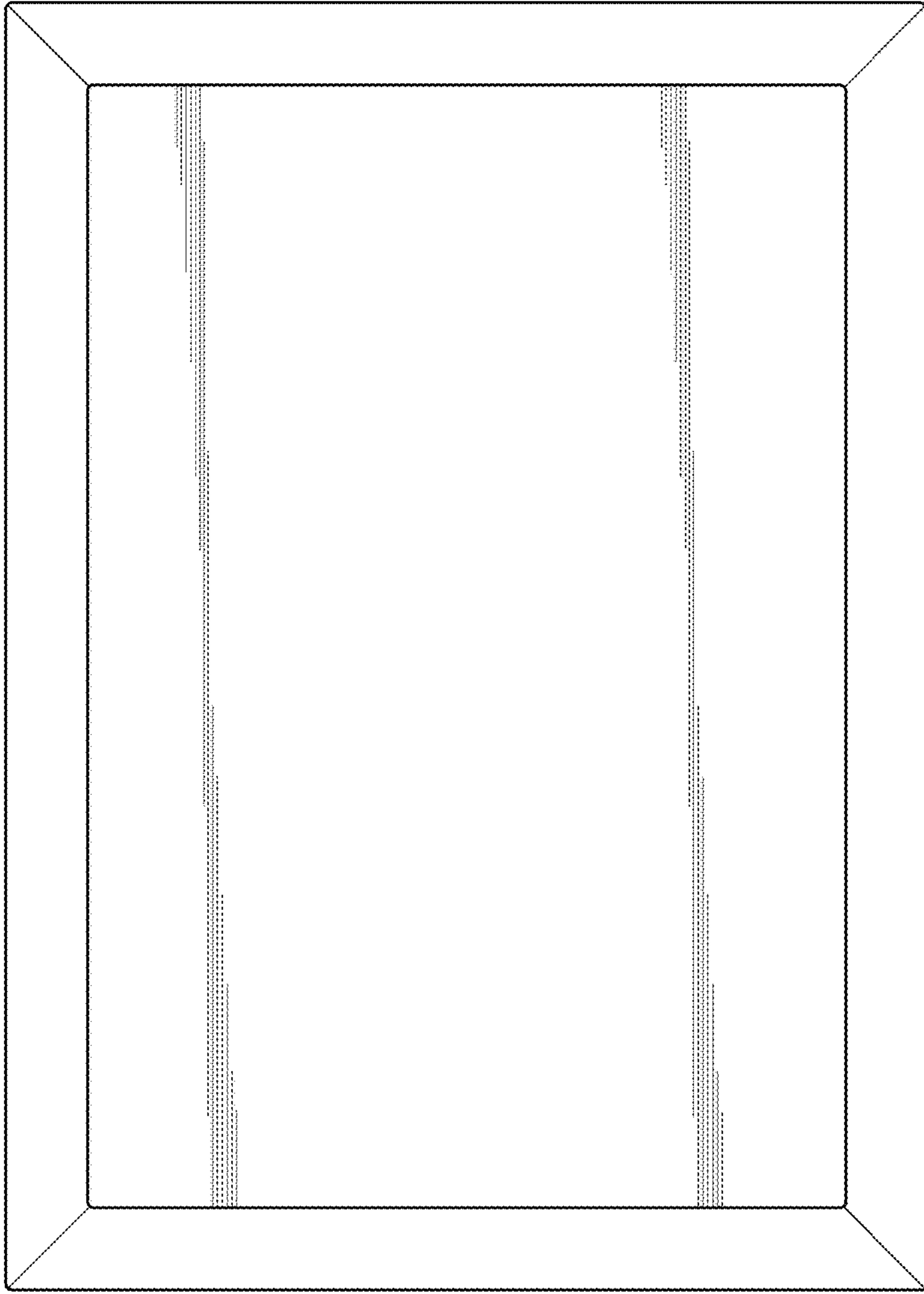
