The ornamental design for a stork picture frame, as shown and described.

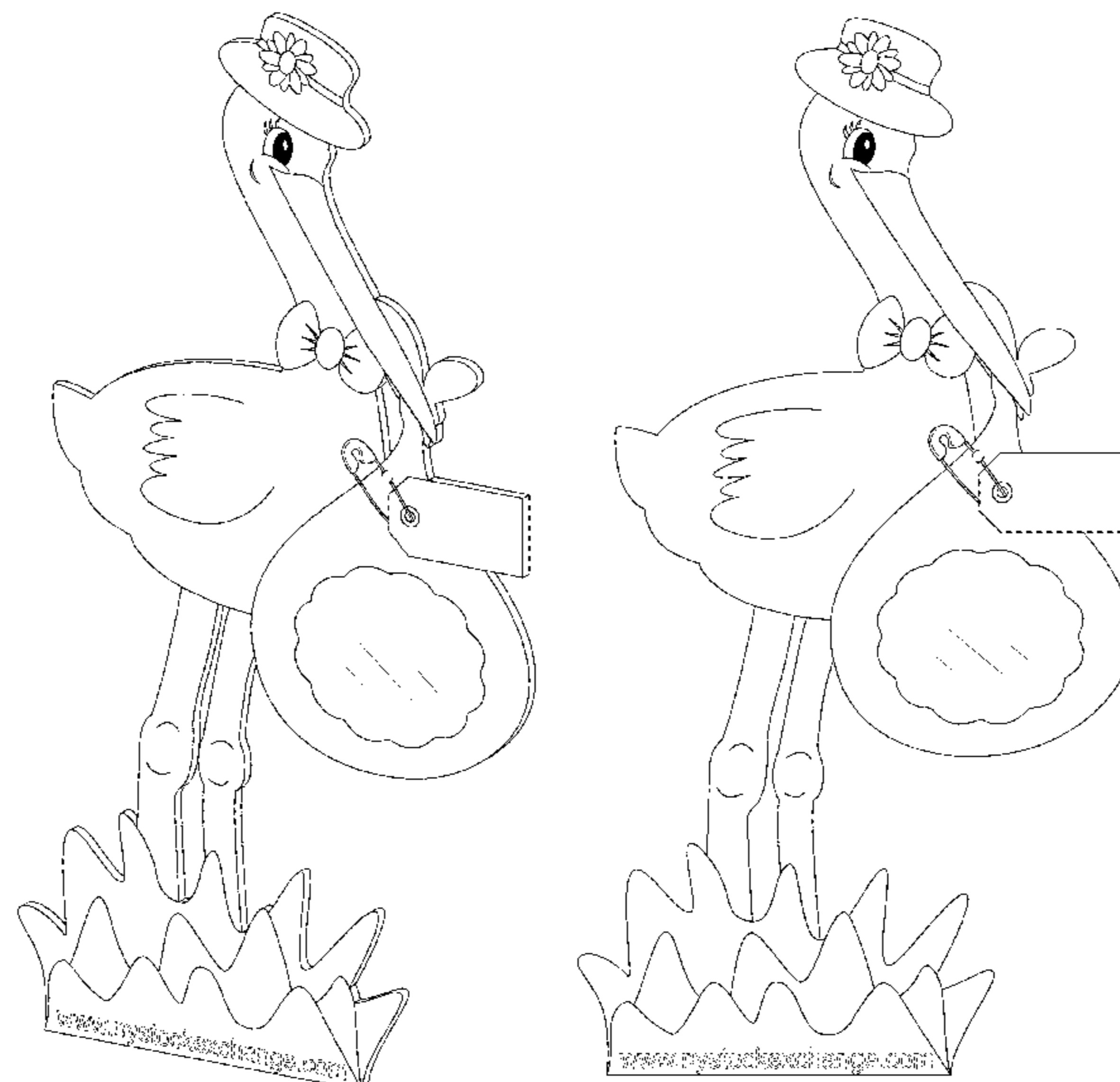
**DESCRIPTION**

FIG. 1 is a perspective view of a stork picture frame in accordance with the present design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.

The solid black surface appearance of the eye features depicts the color black included in the claimed design.

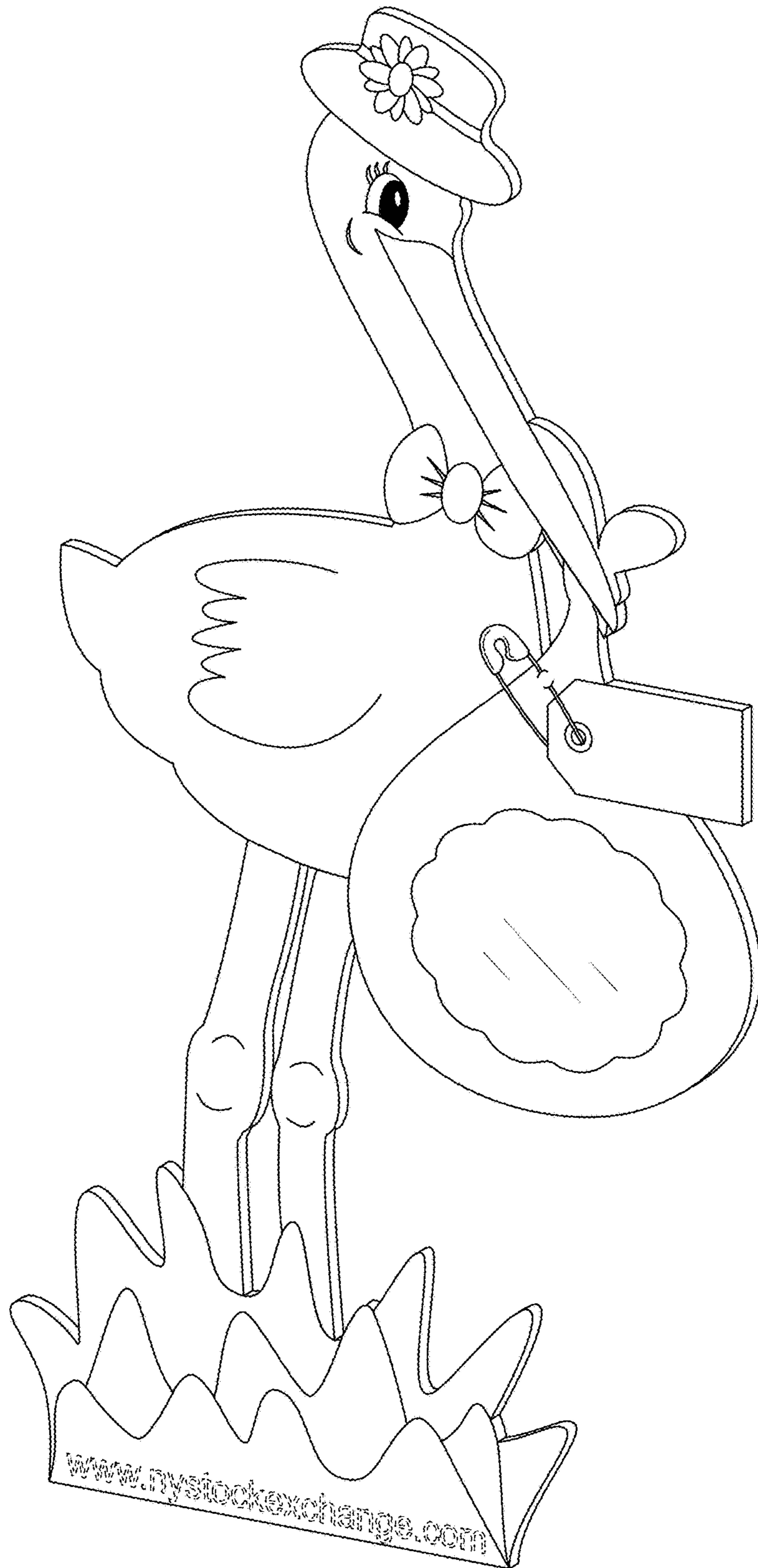

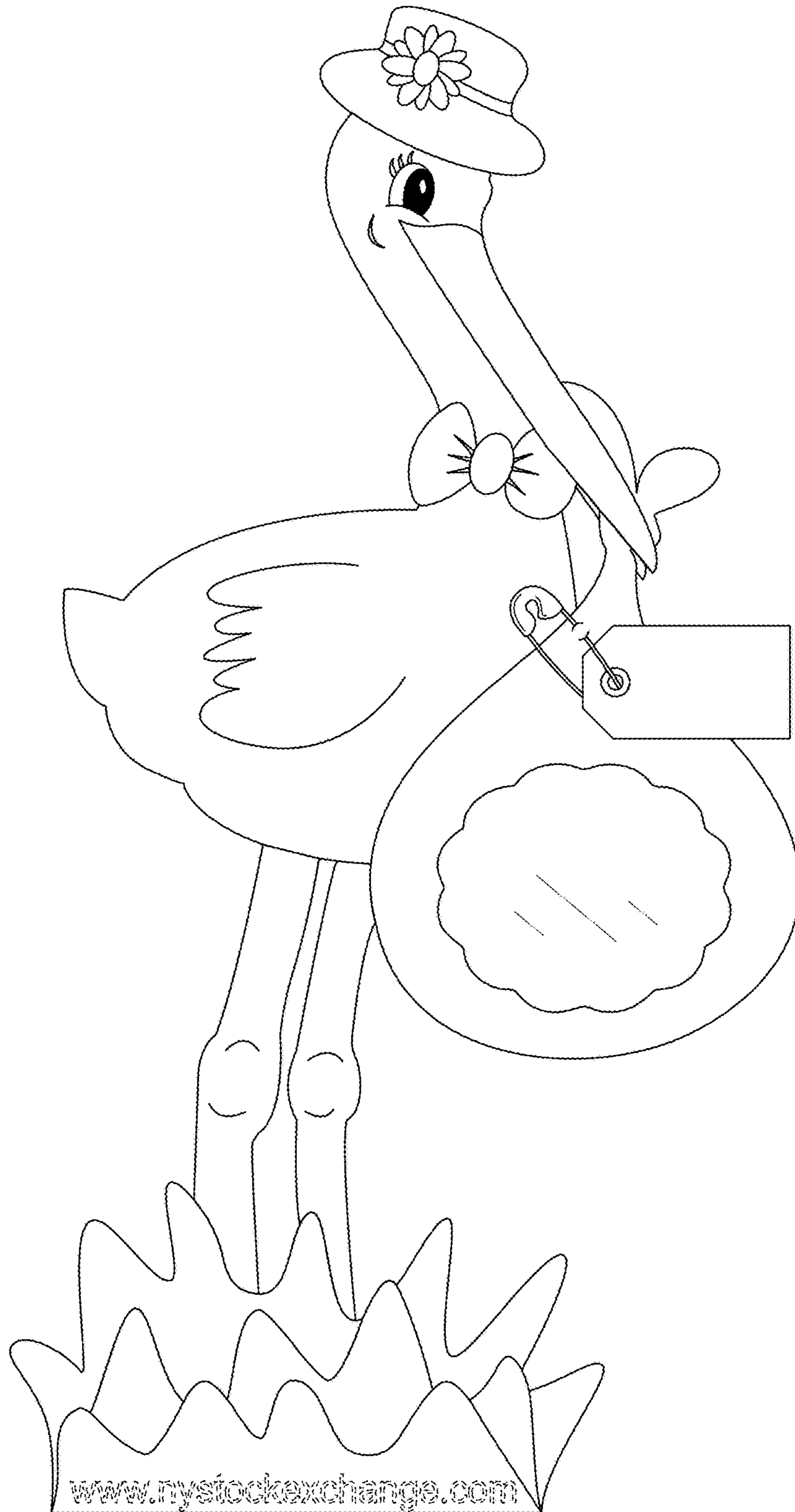

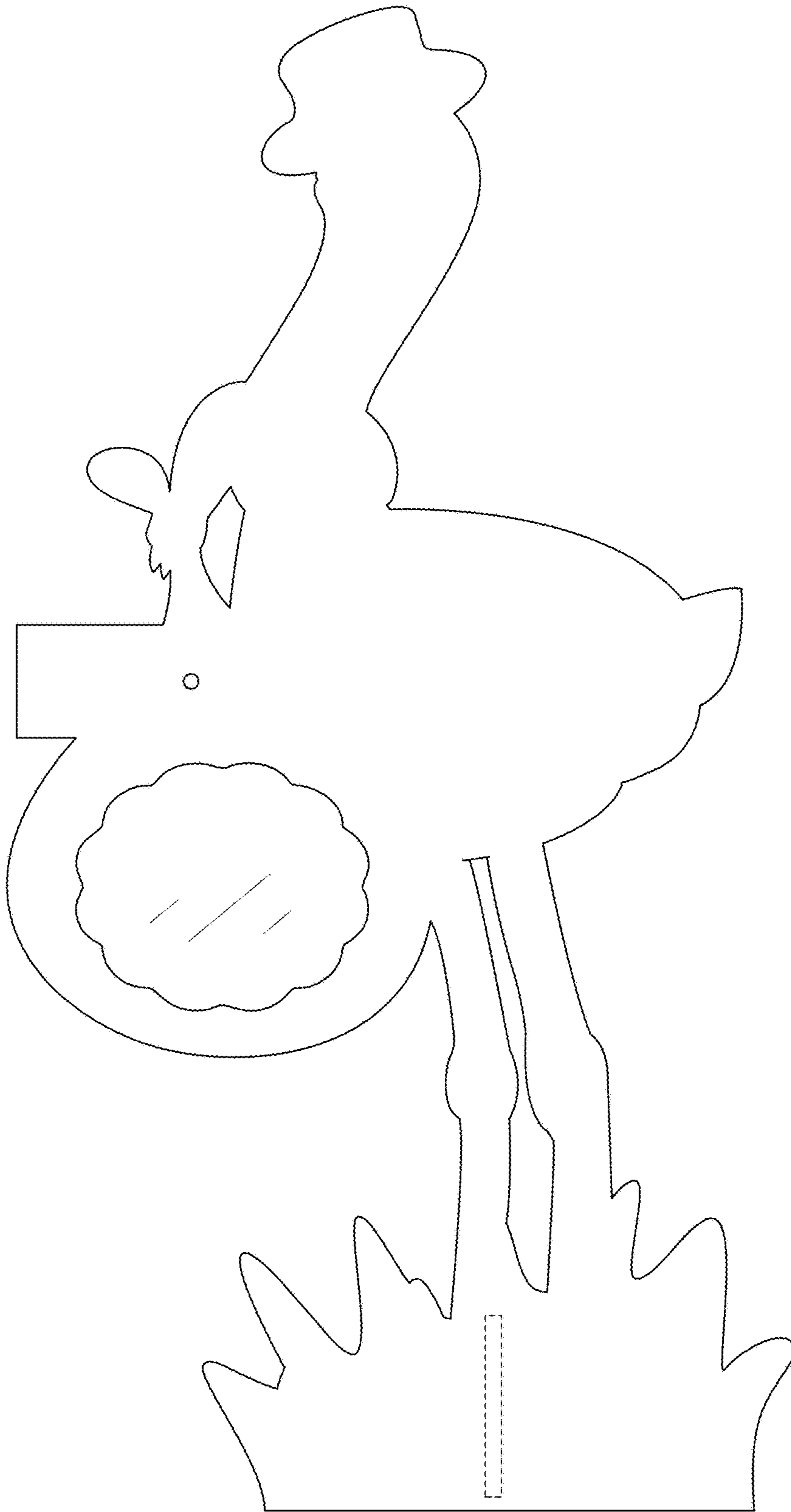

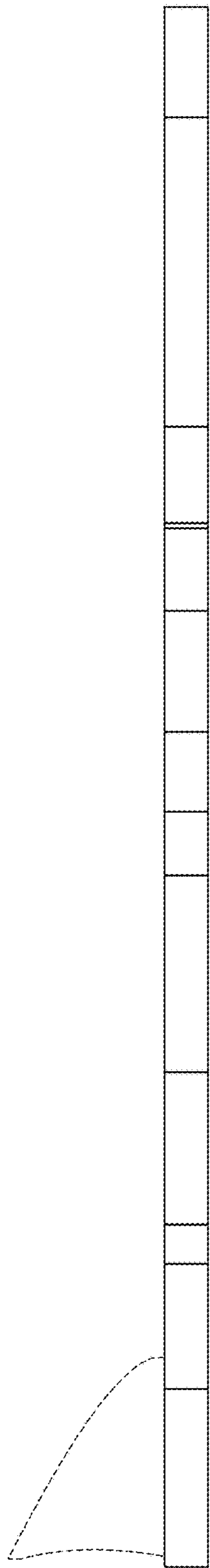

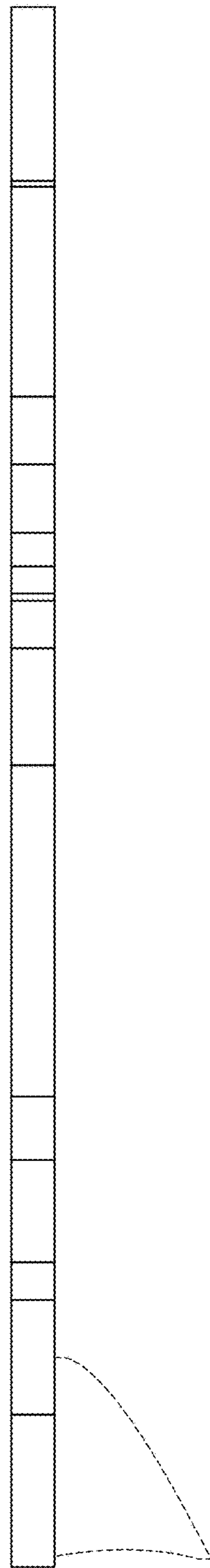
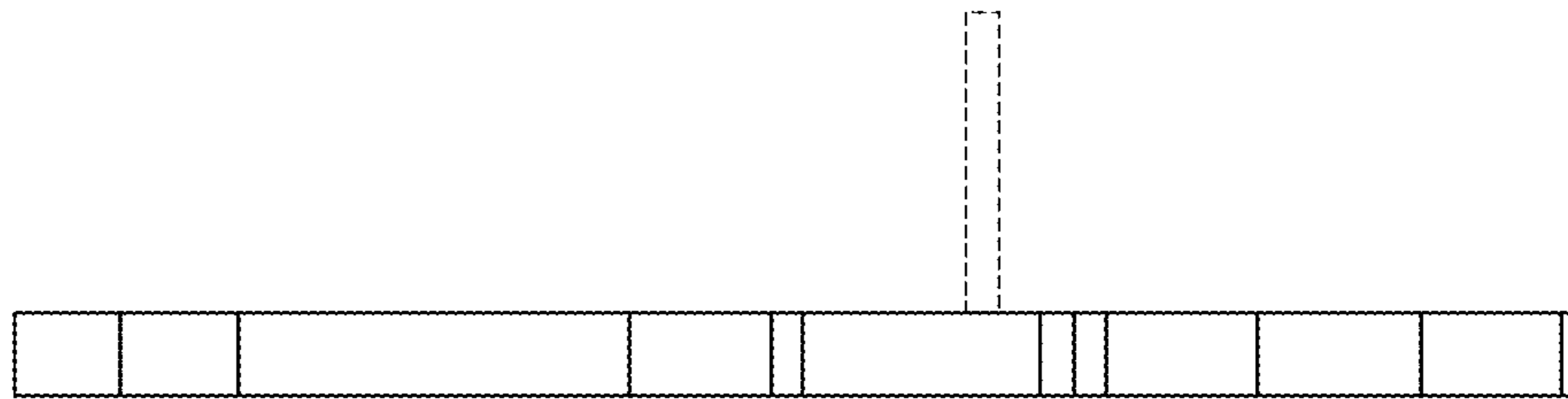
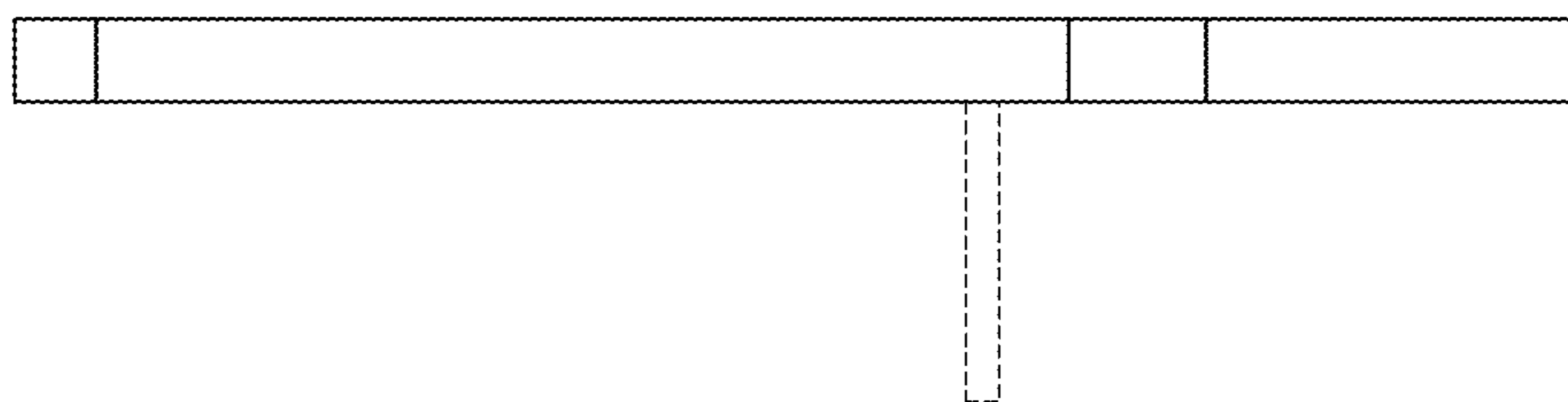
