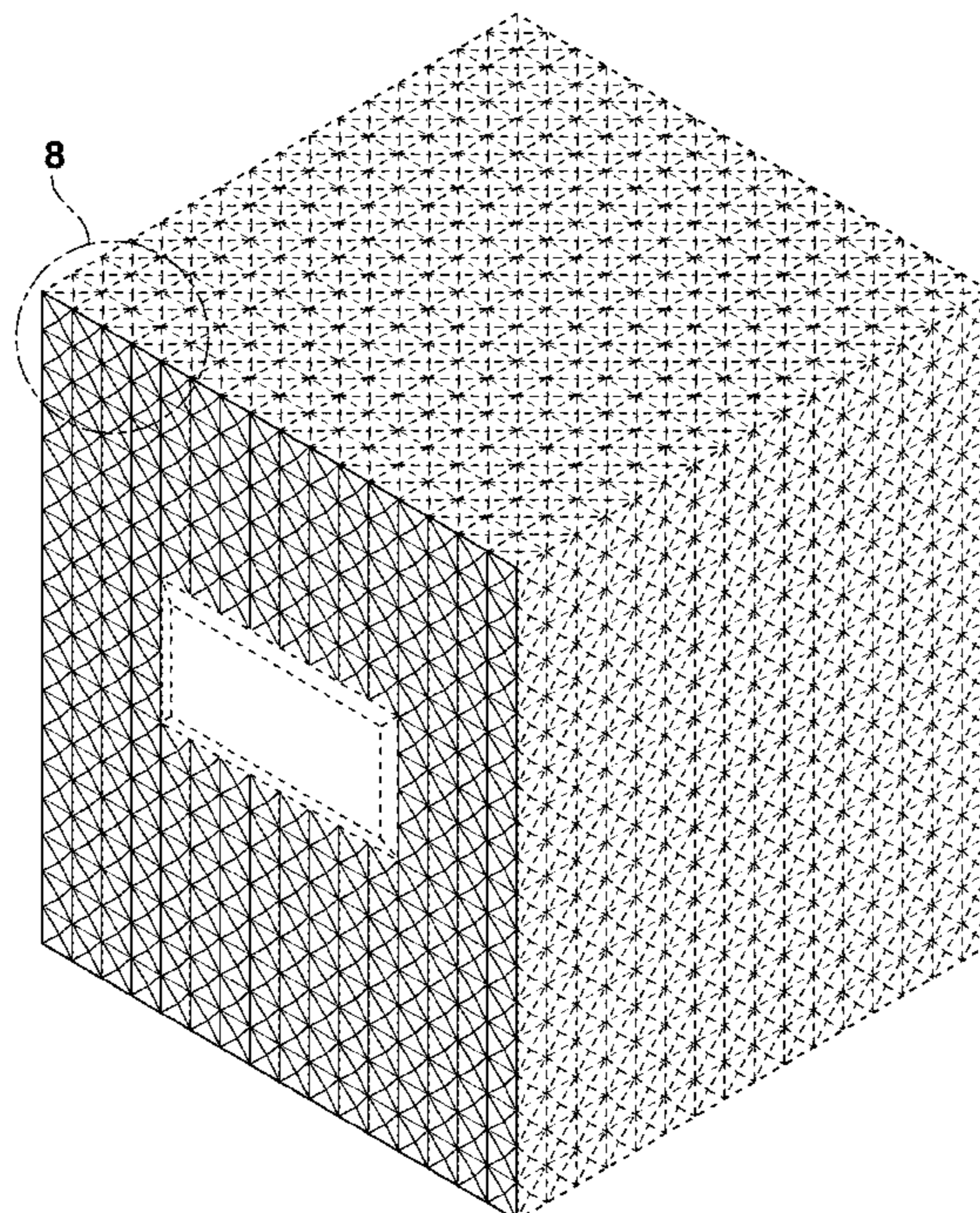
(57) **CLAIM**

The ornamental design for packaging for perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a packaging design showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a cut-away view of the portion of the packaging indicated in FIG. 1, shown with surface shading, which is understood to extend across the entire surface of the packaging in FIGS. 1-7, except for the rectangular label element as shown in FIGS. 1-2.
The broken line showing of portions of the packaging in the relevant drawings shows unclaimed subject matter for the design in those drawings.

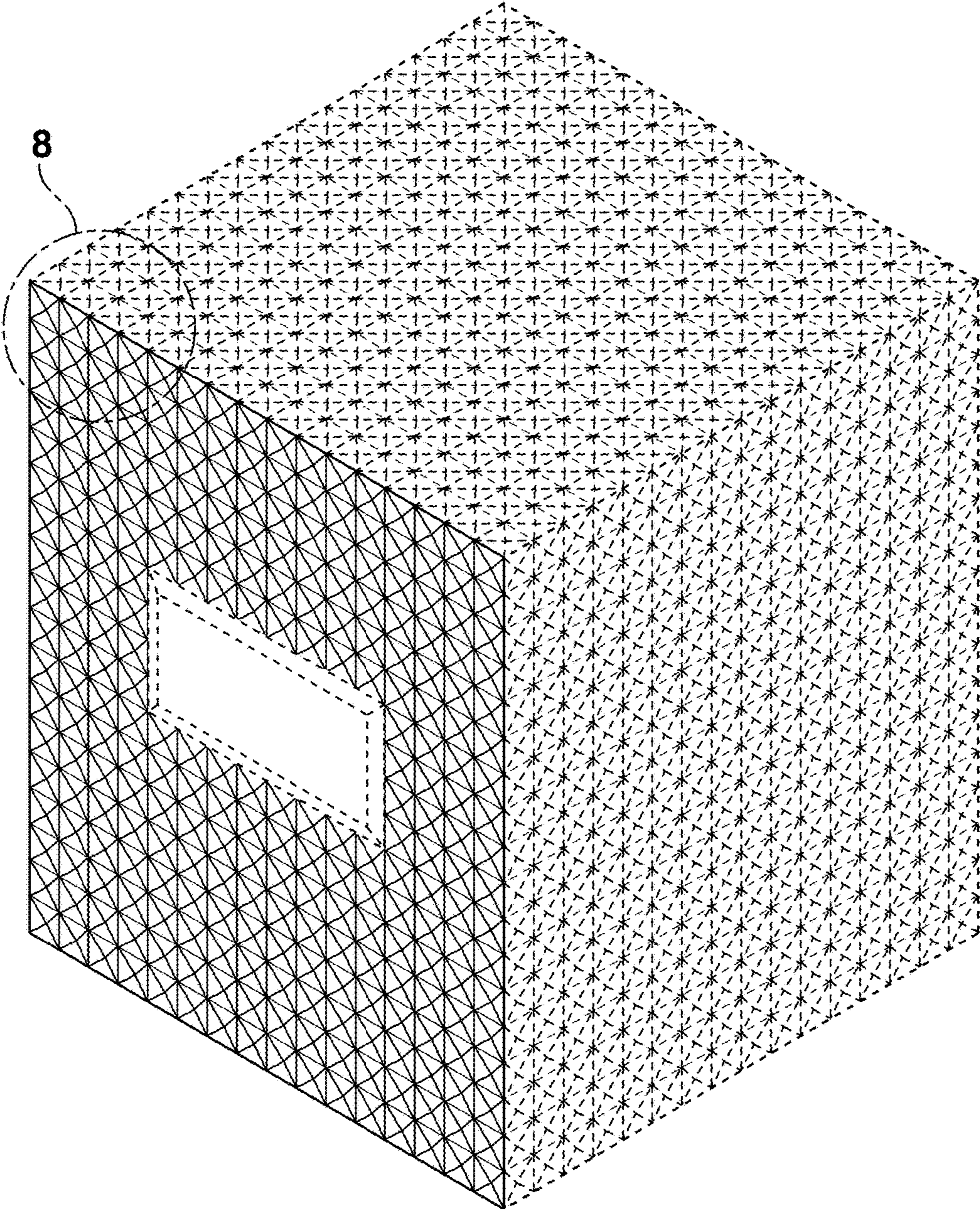

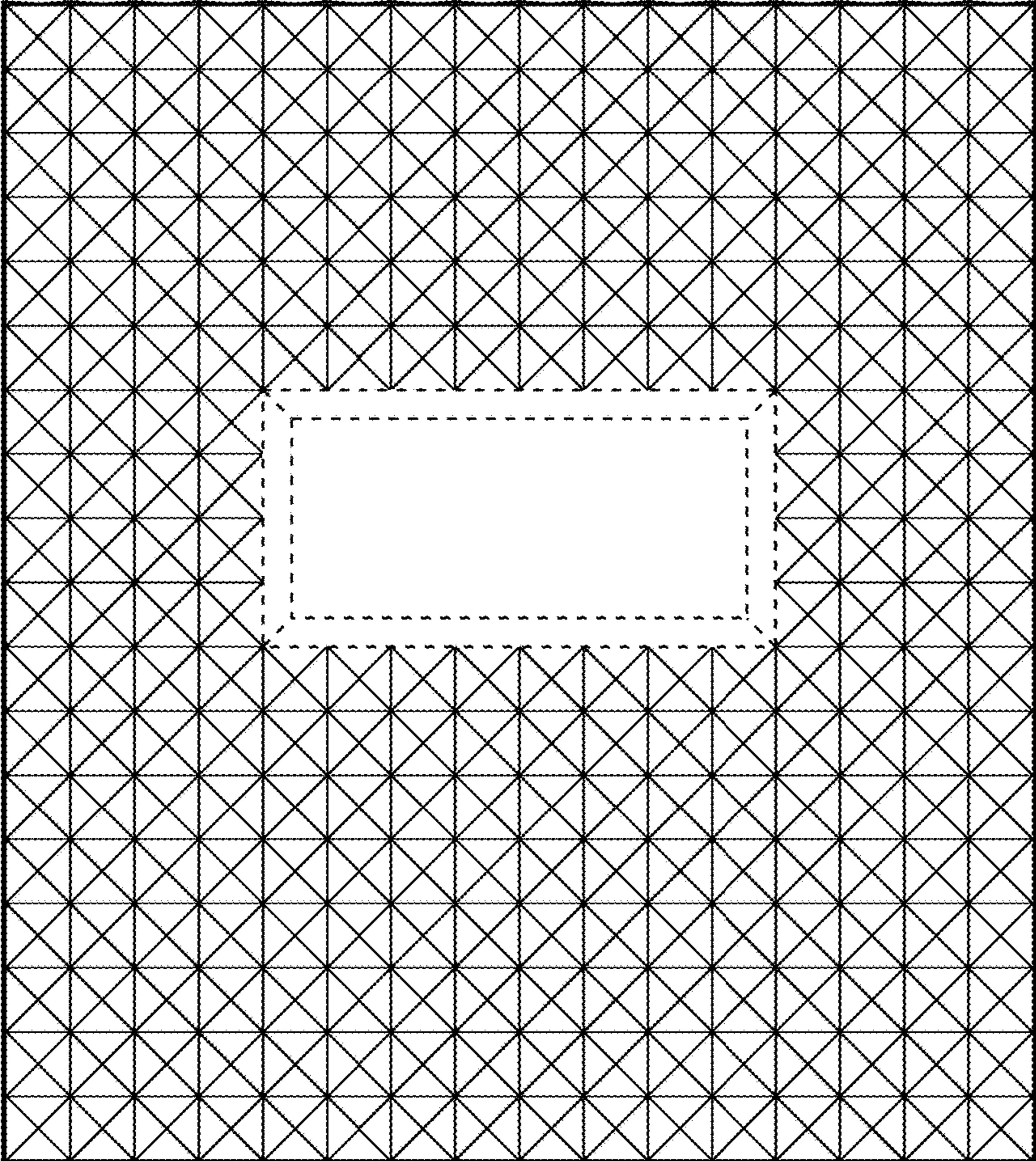

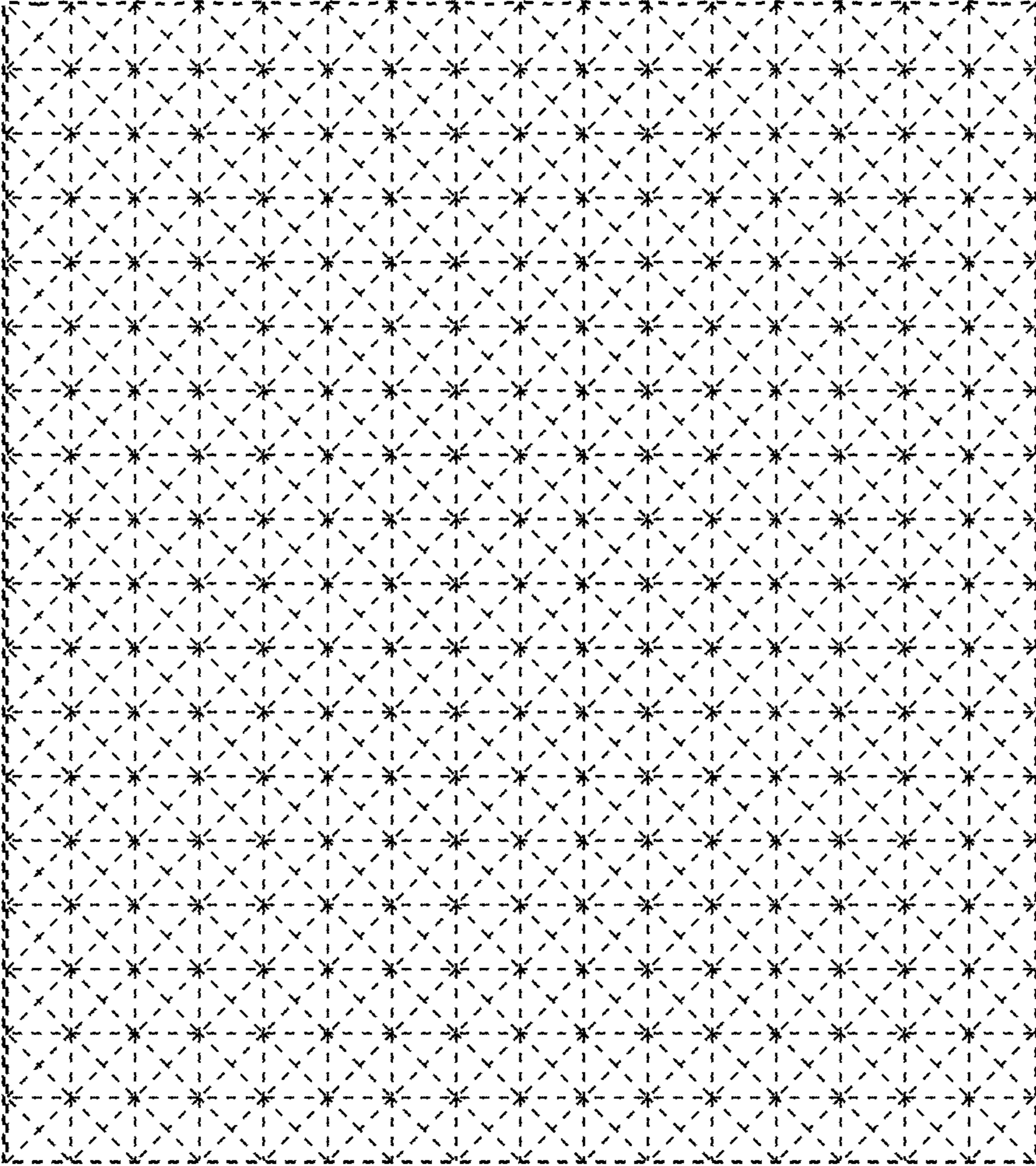

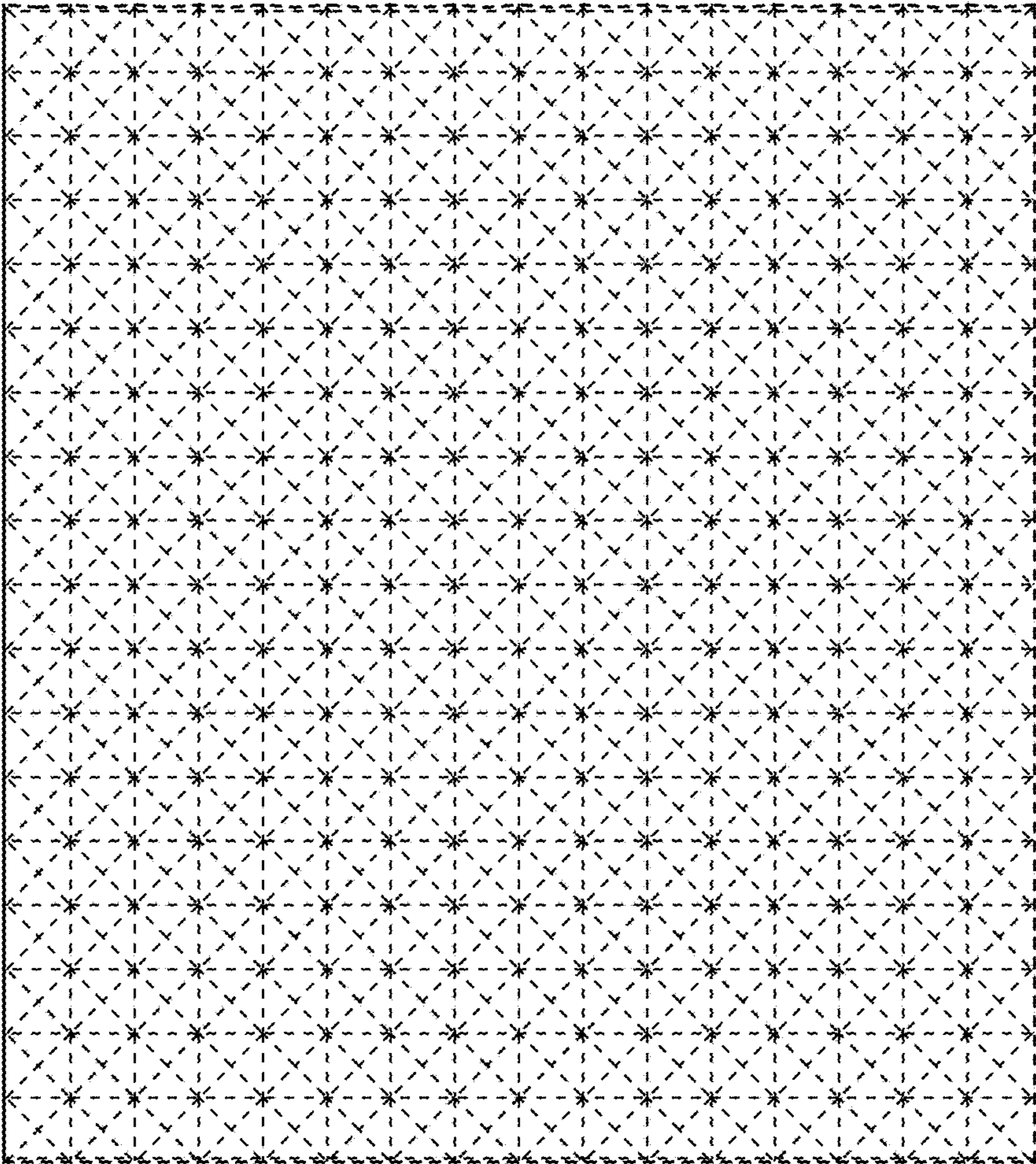

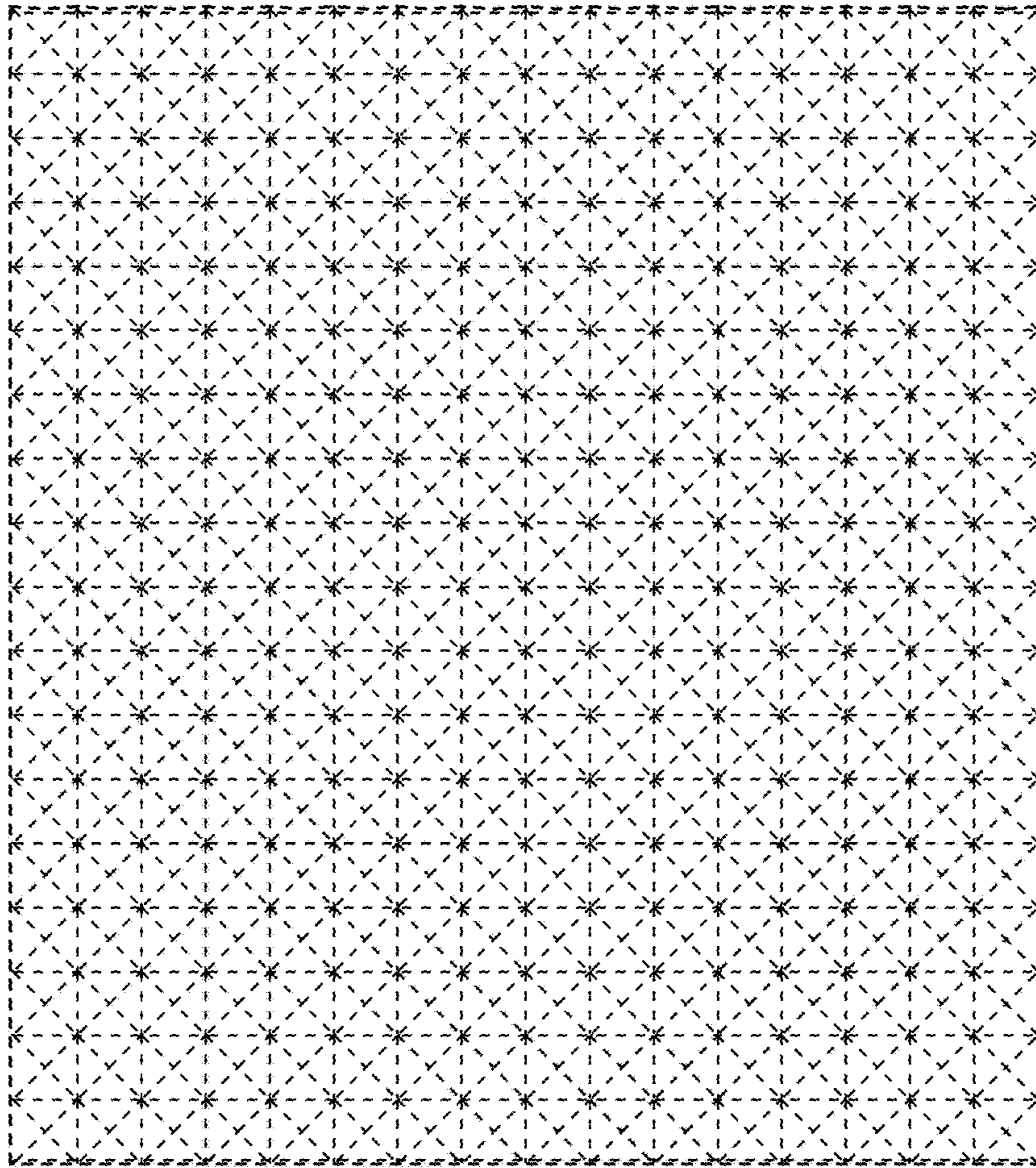

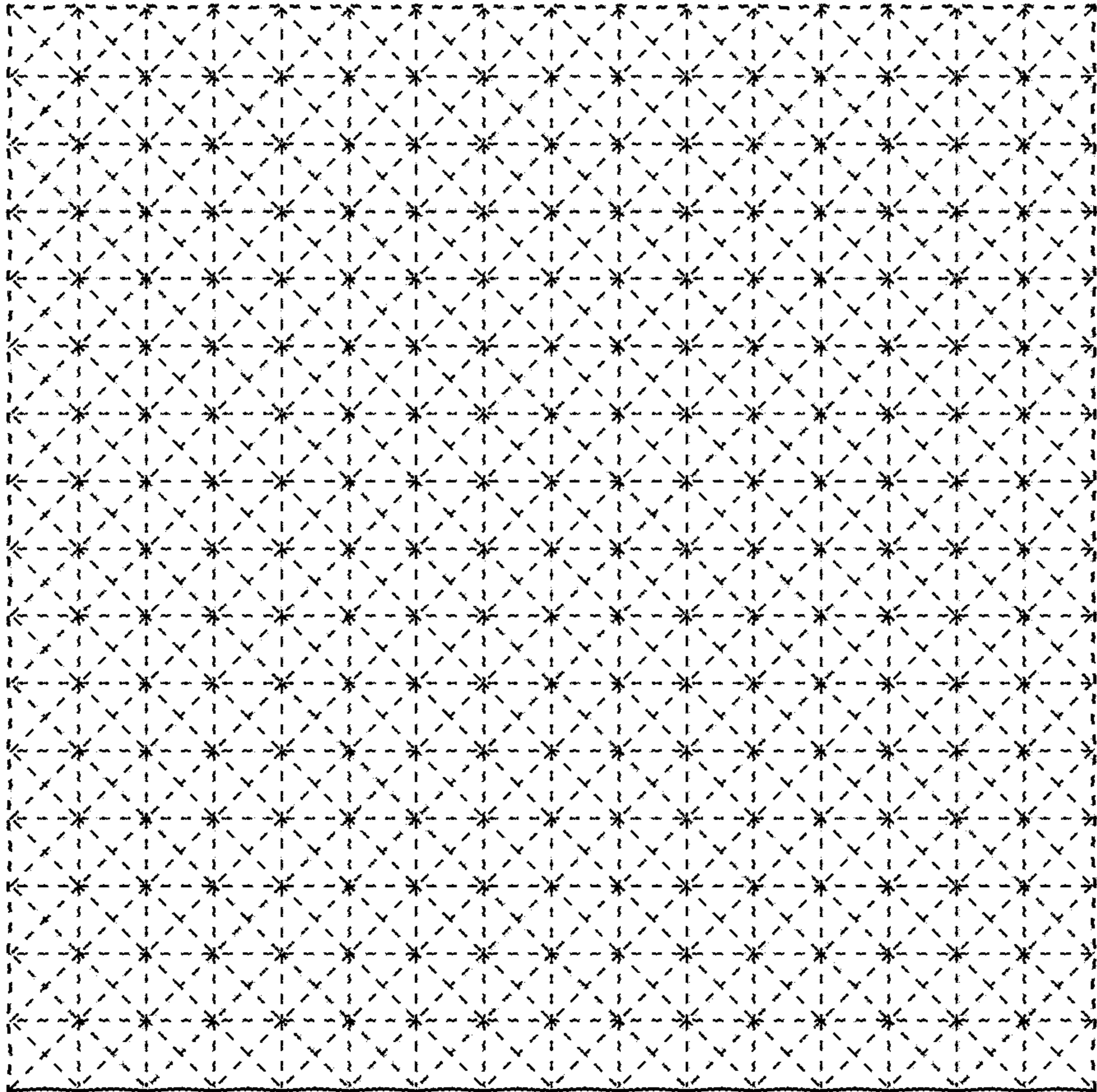

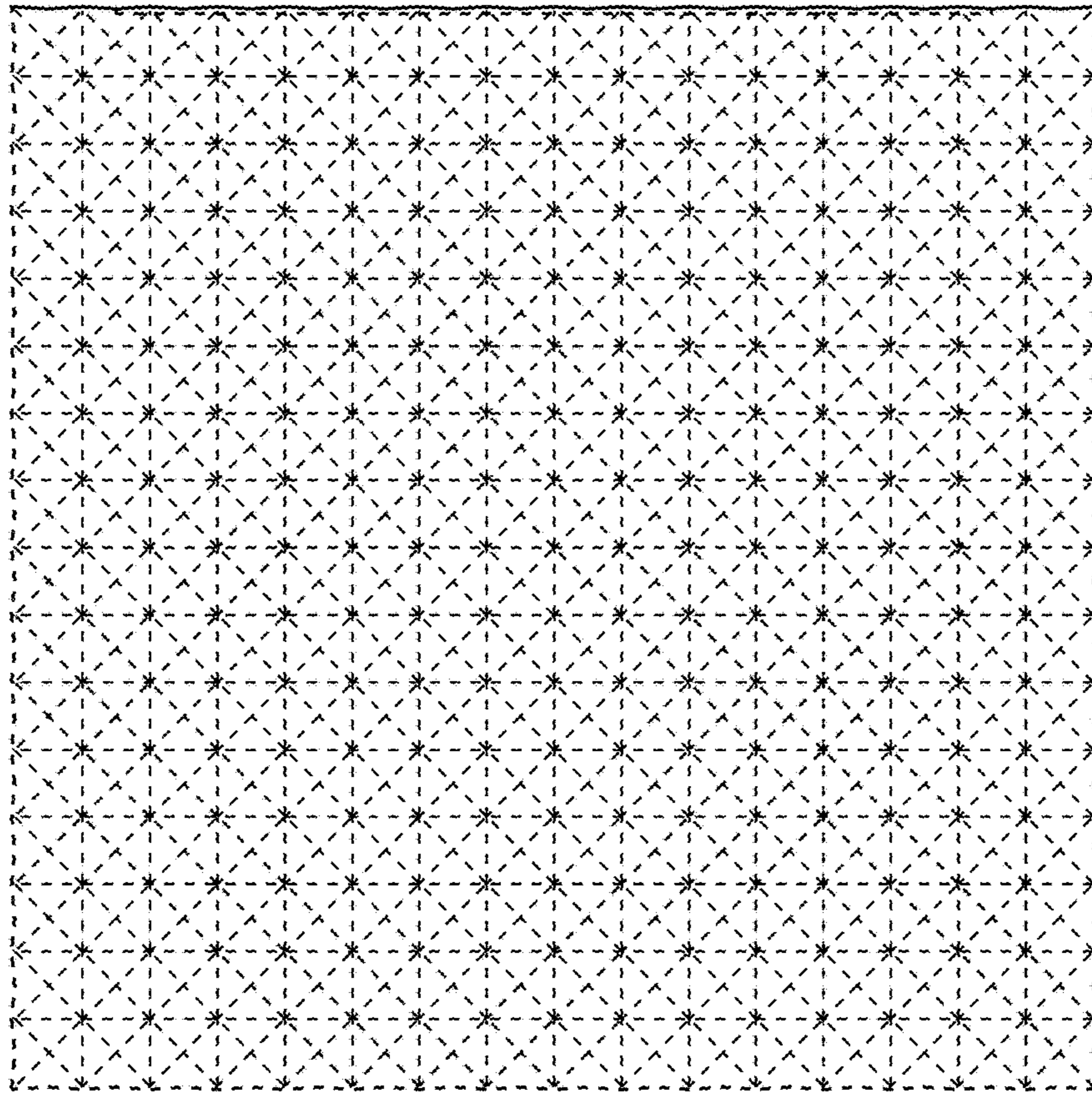

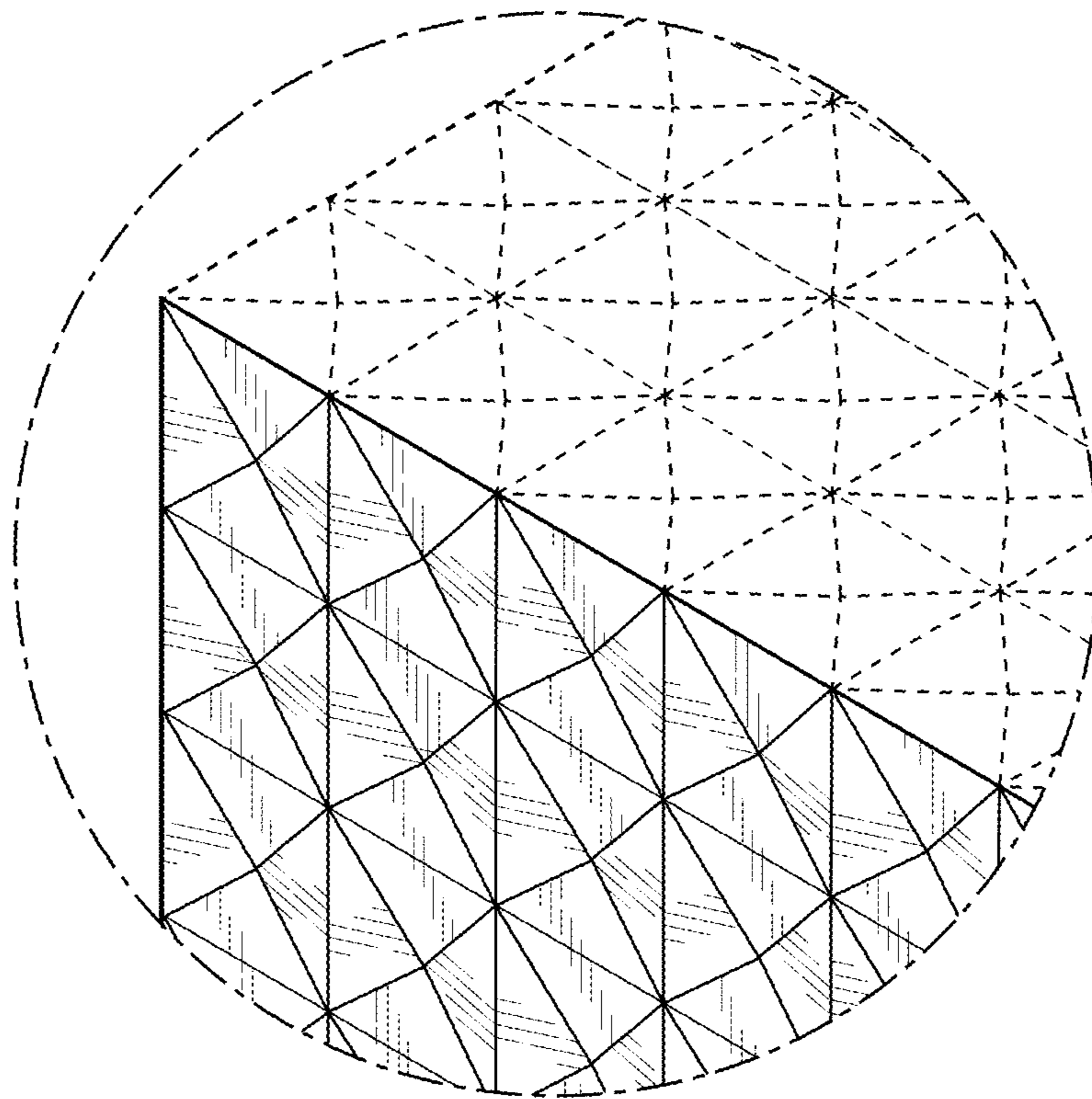
