FIG. 1 is a perspective view of a neck band for bottle according to my new design;

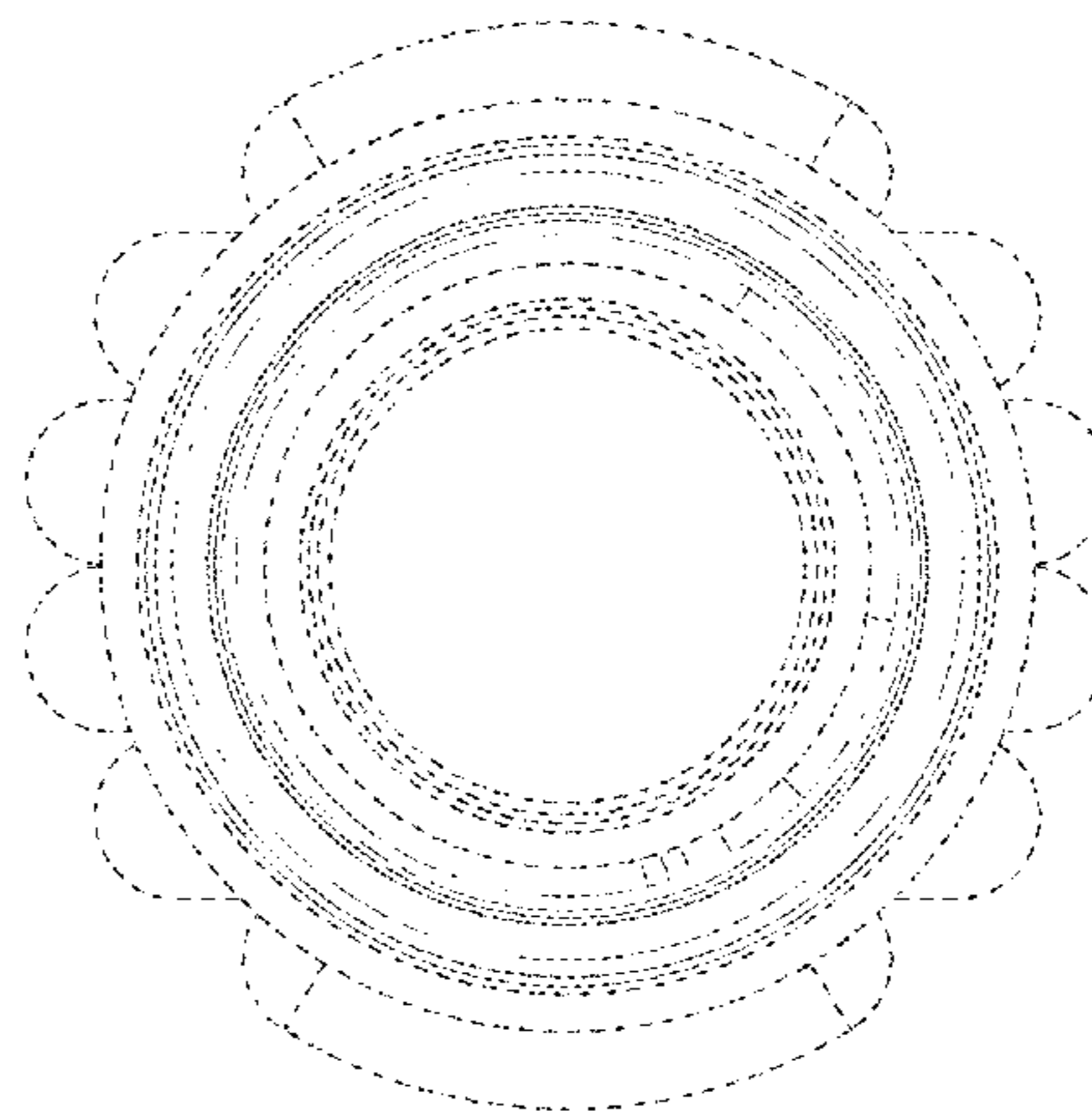
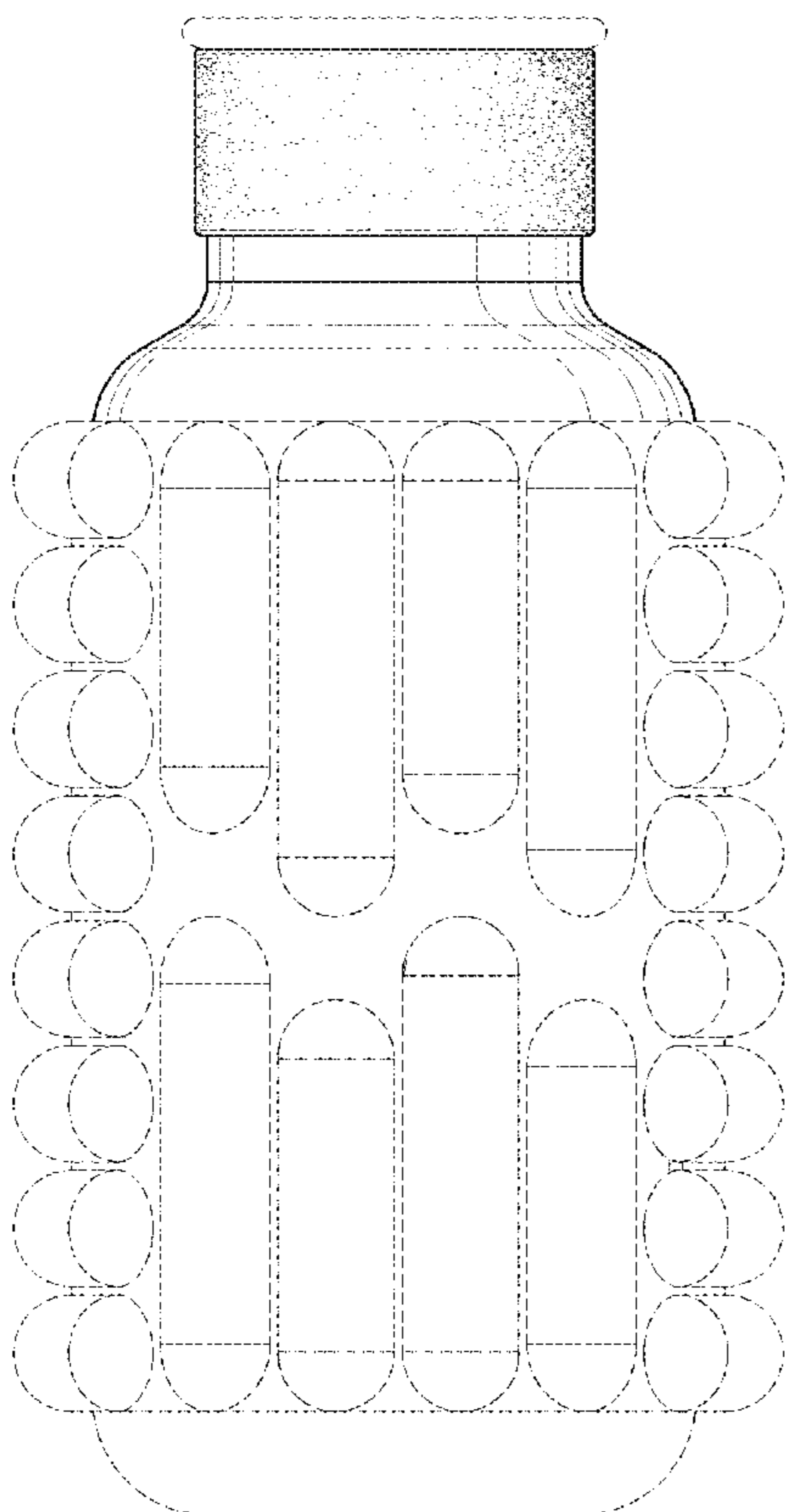
FIG. 2 is a front elevation view thereof, the sides and rear elevation views being identical;

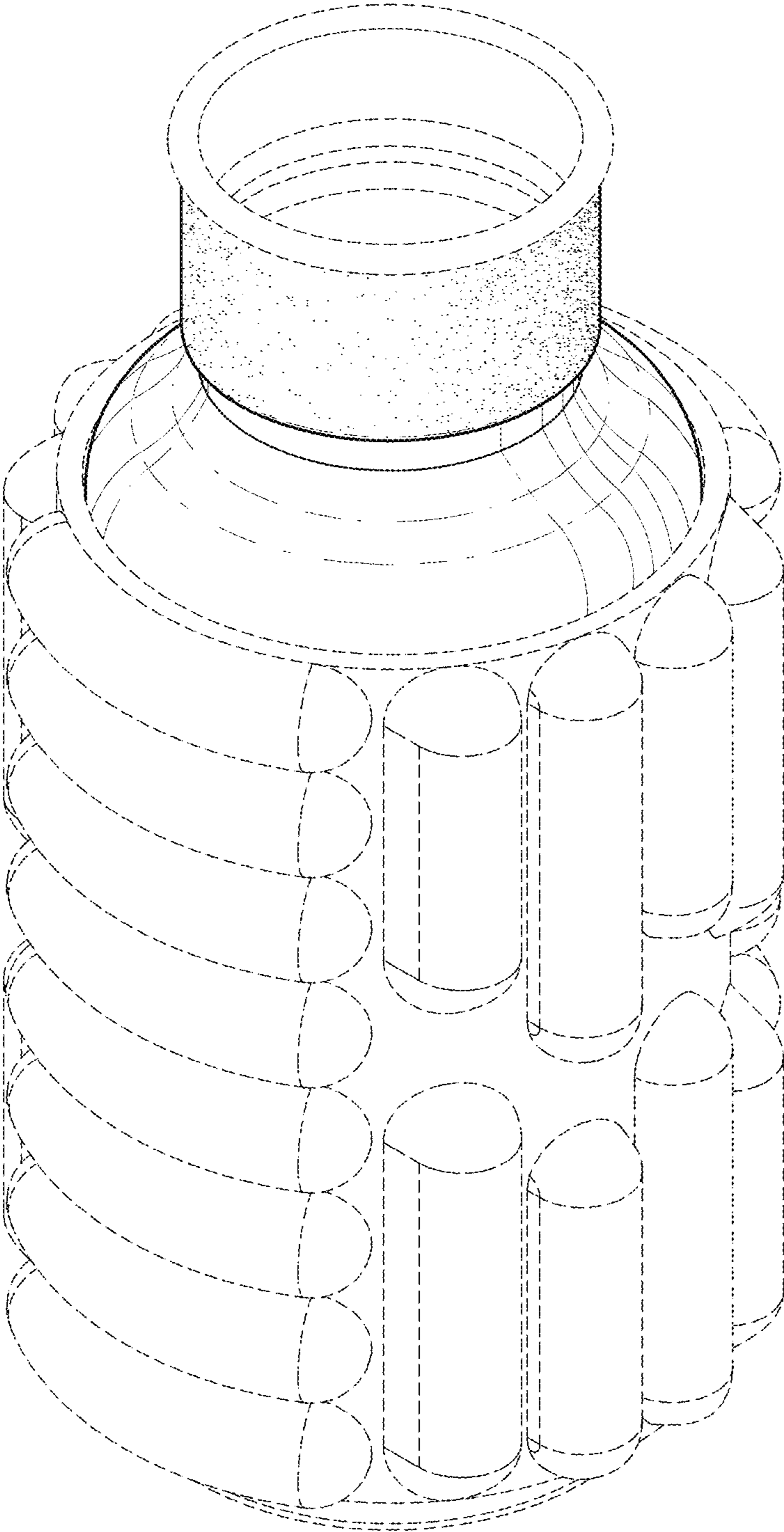

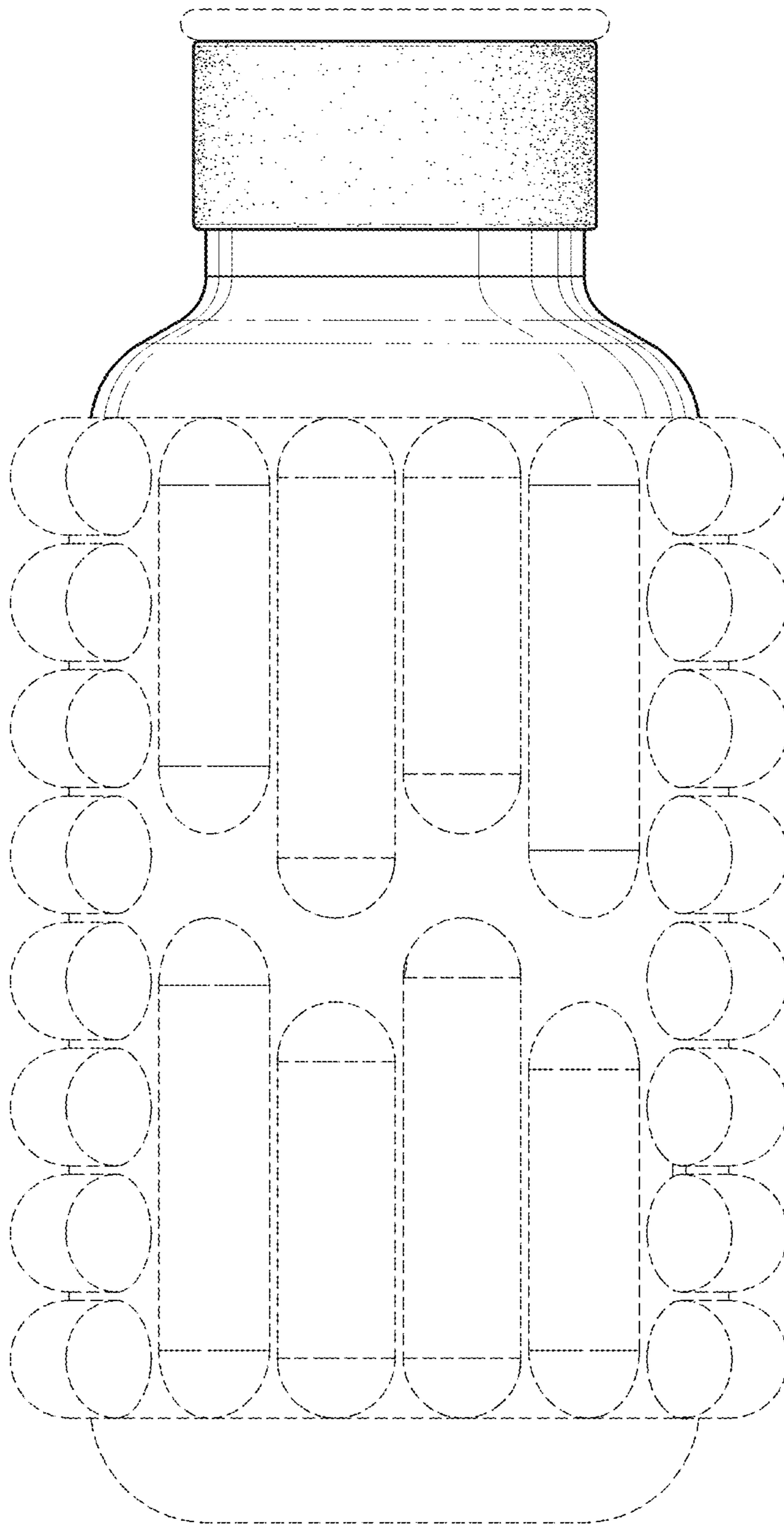

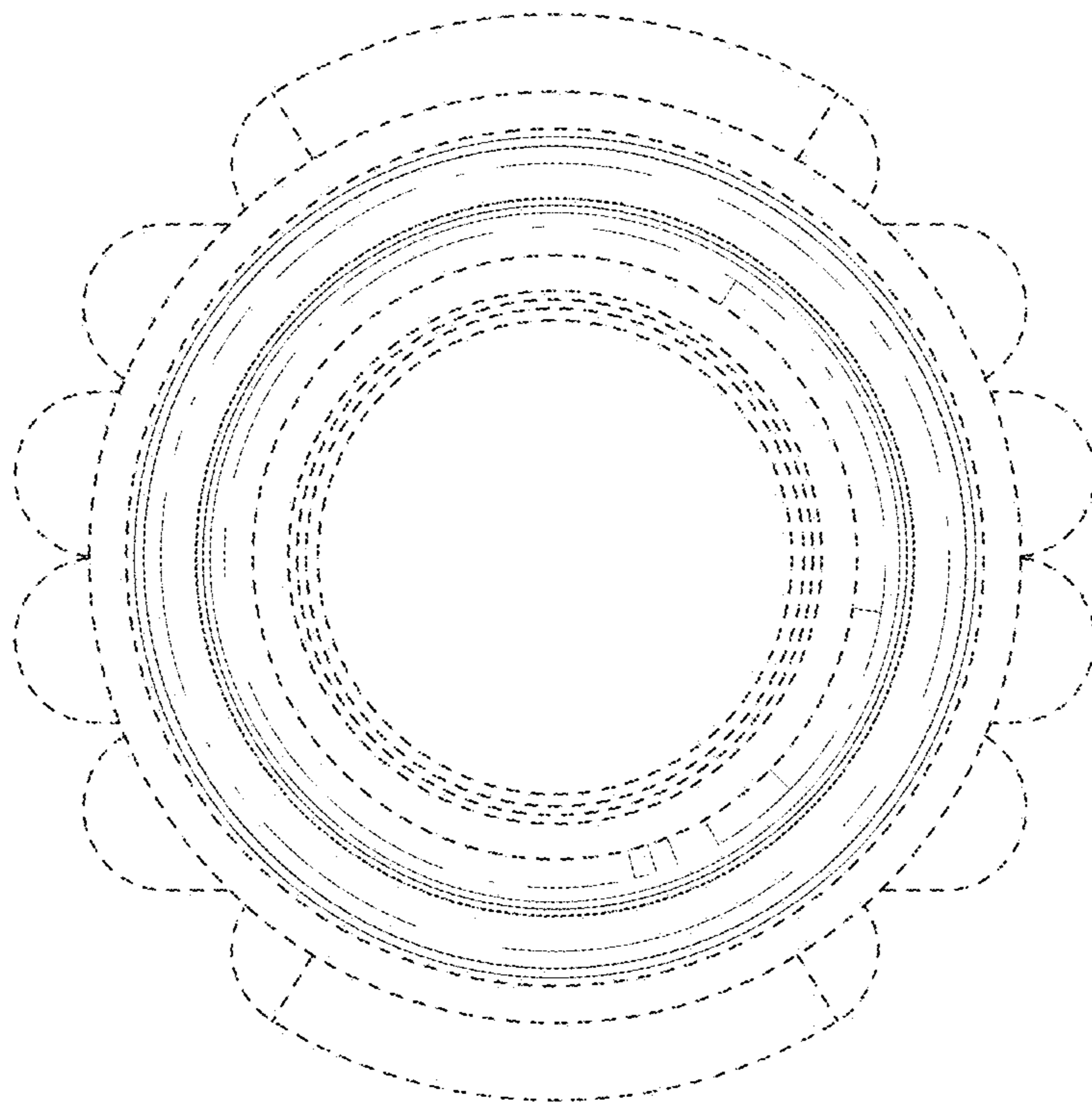

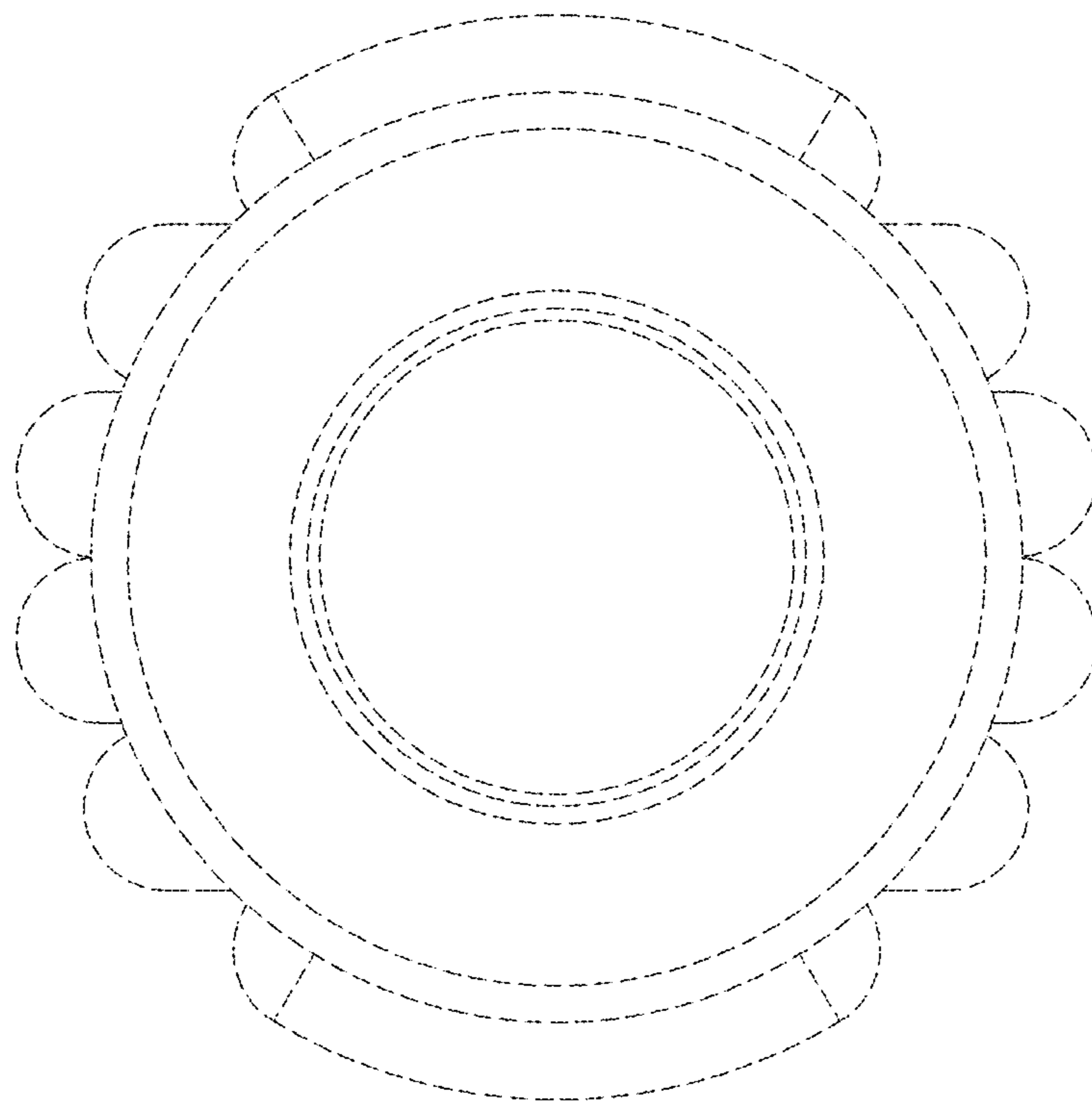
