(57) **CLAIM**

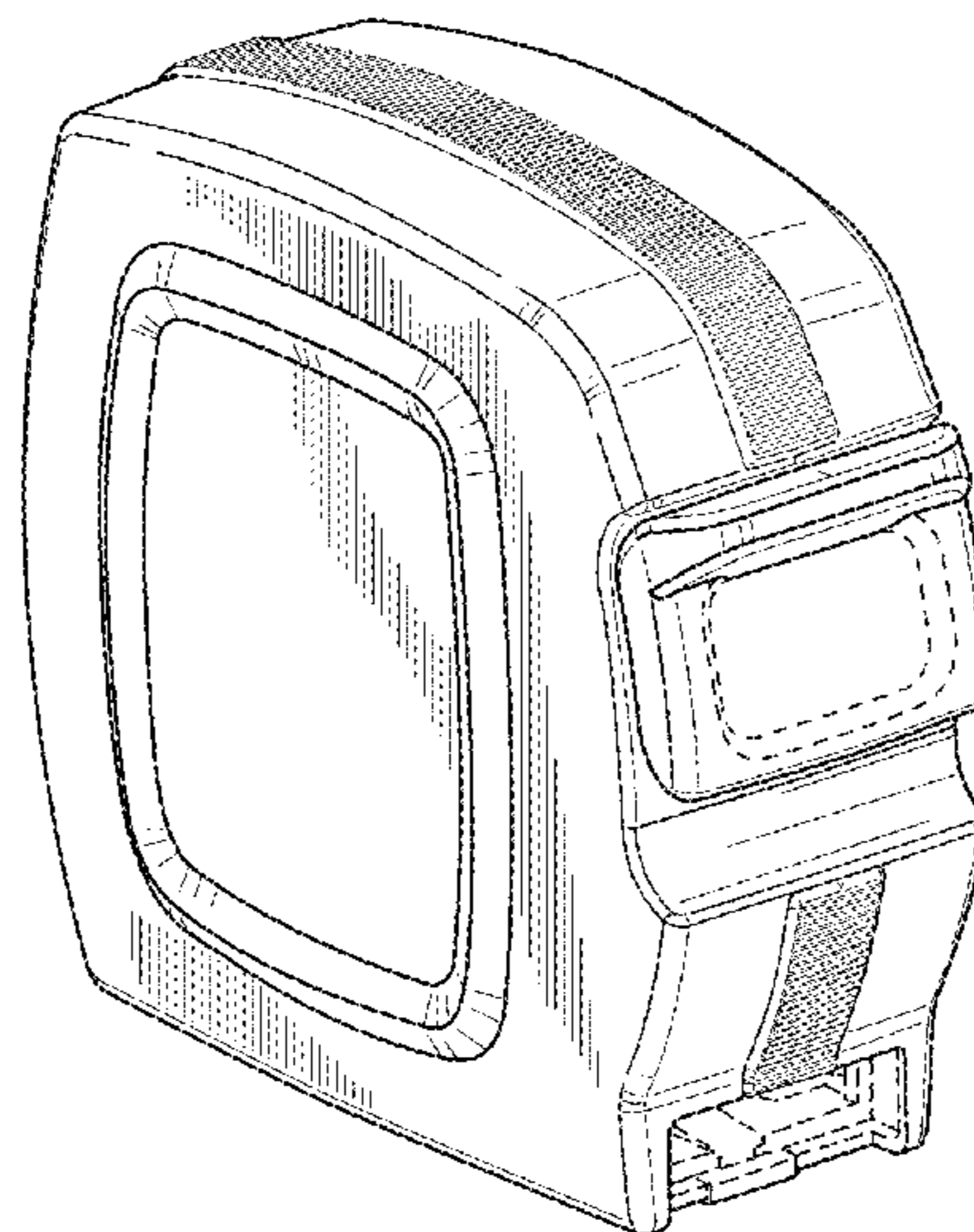
The ornamental design for a tape measure housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tape measure housing according to an embodiment of the invention.
FIG. 2 is a left side view of the tape measure housing of FIG. 1.
FIG. 3 is a front view of the tape measure housing of FIG. 1.
FIG. 4 is a right side view of the tape measure housing of FIG. 1.
FIG. 5 is a back view of the tape measure housing of FIG. 1.
FIG. 6 is a top view of the tape measure housing of FIG. 1; and,
FIG. 7 is a bottom view of the tape measure housing of FIG. 1.

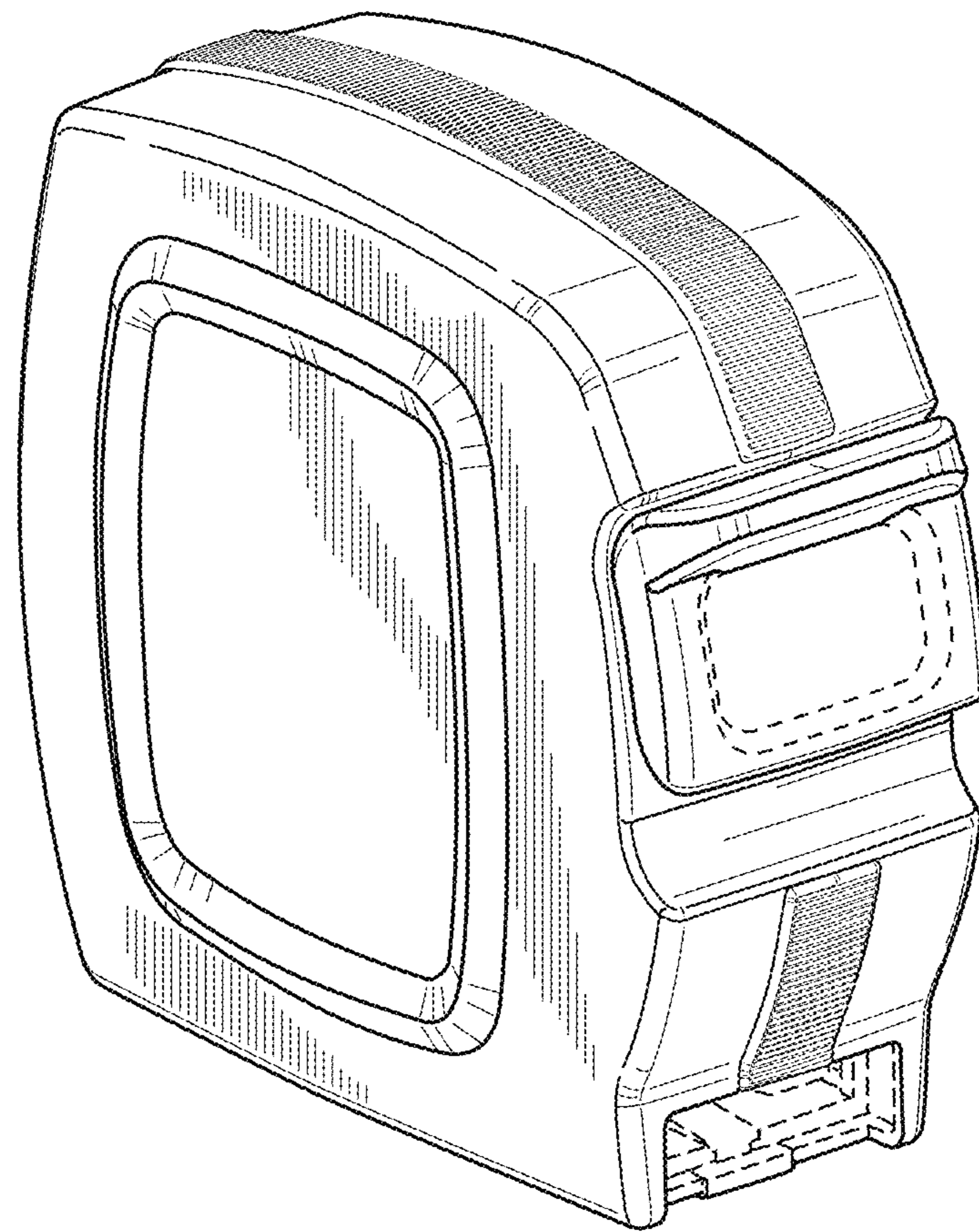

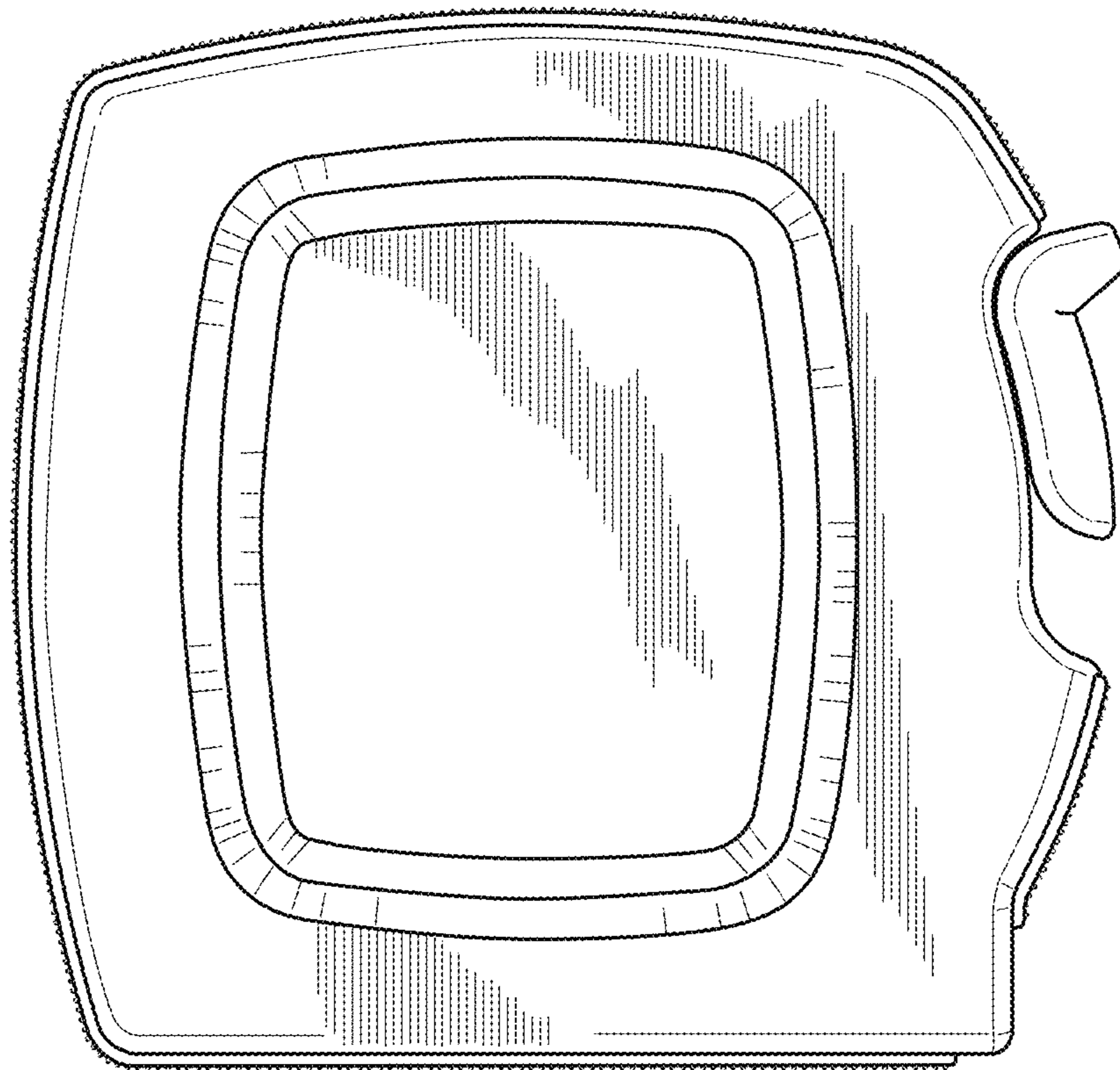

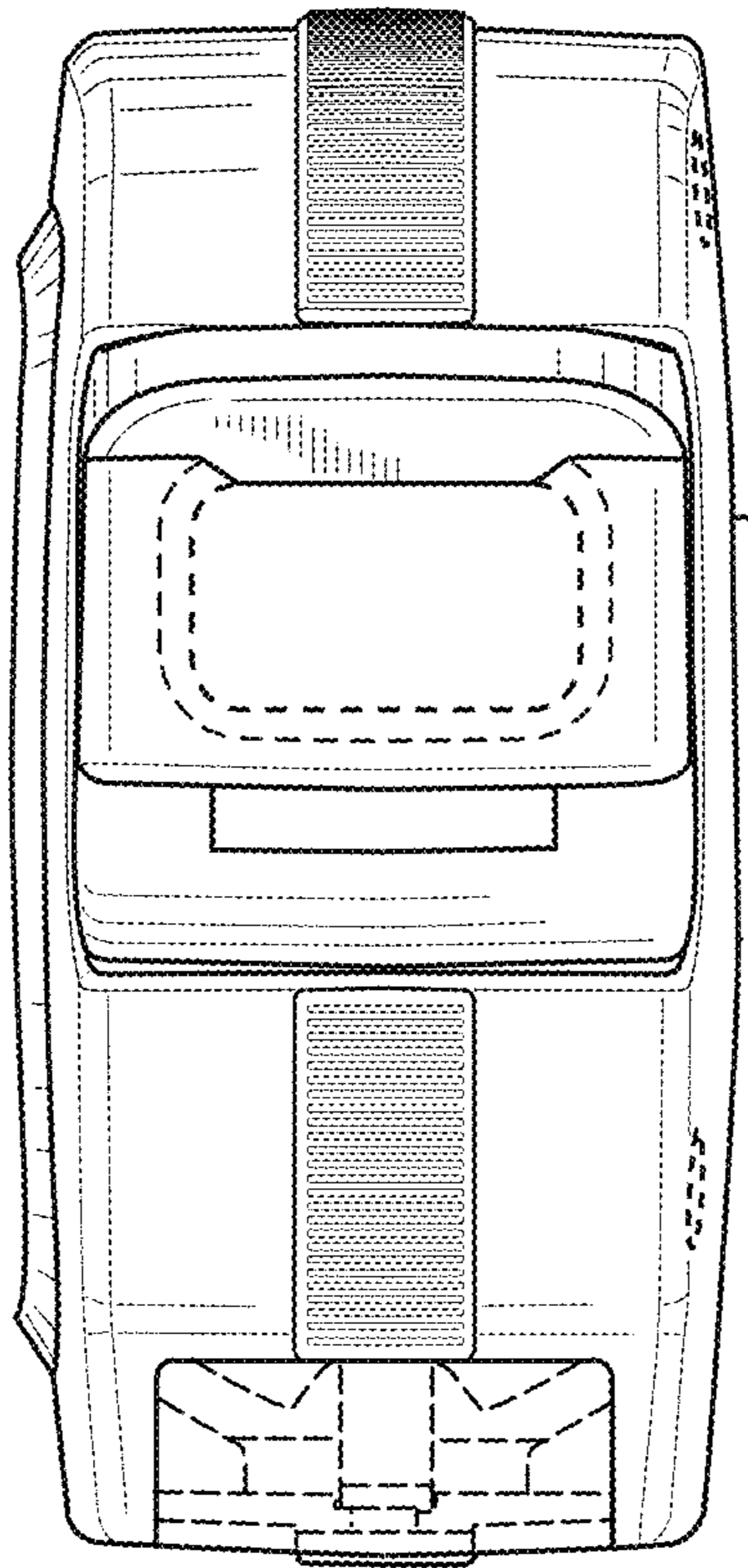

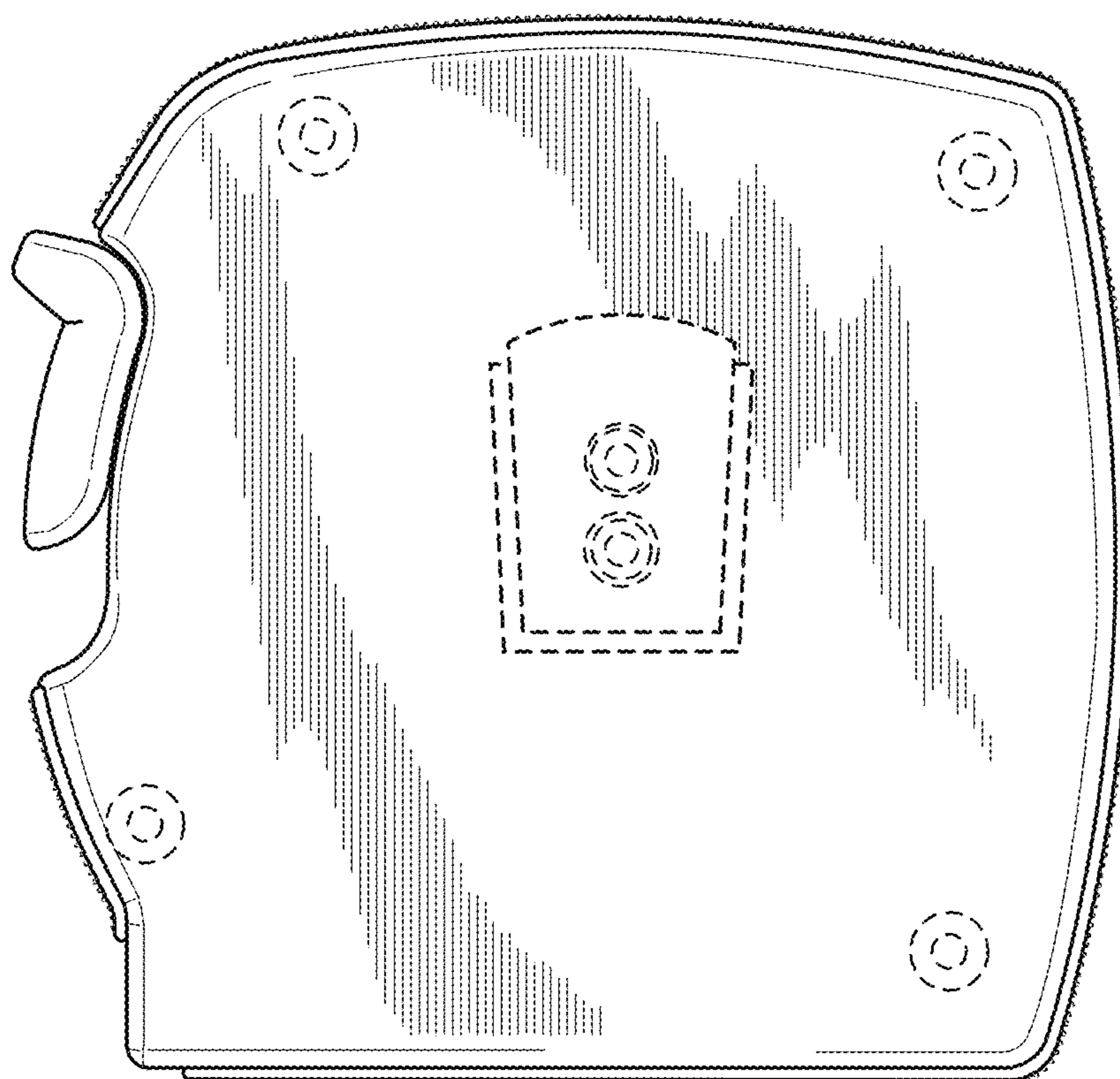

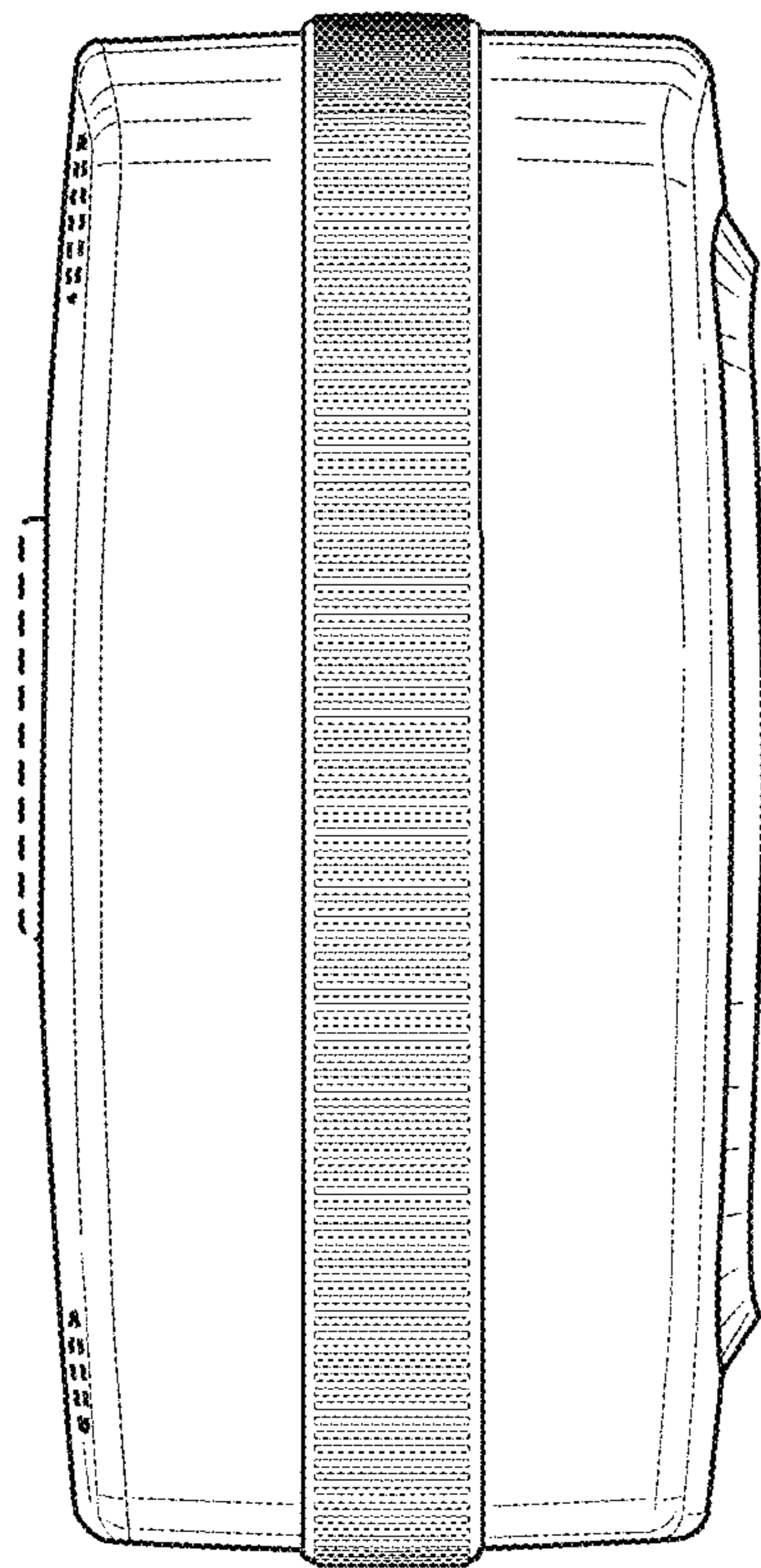

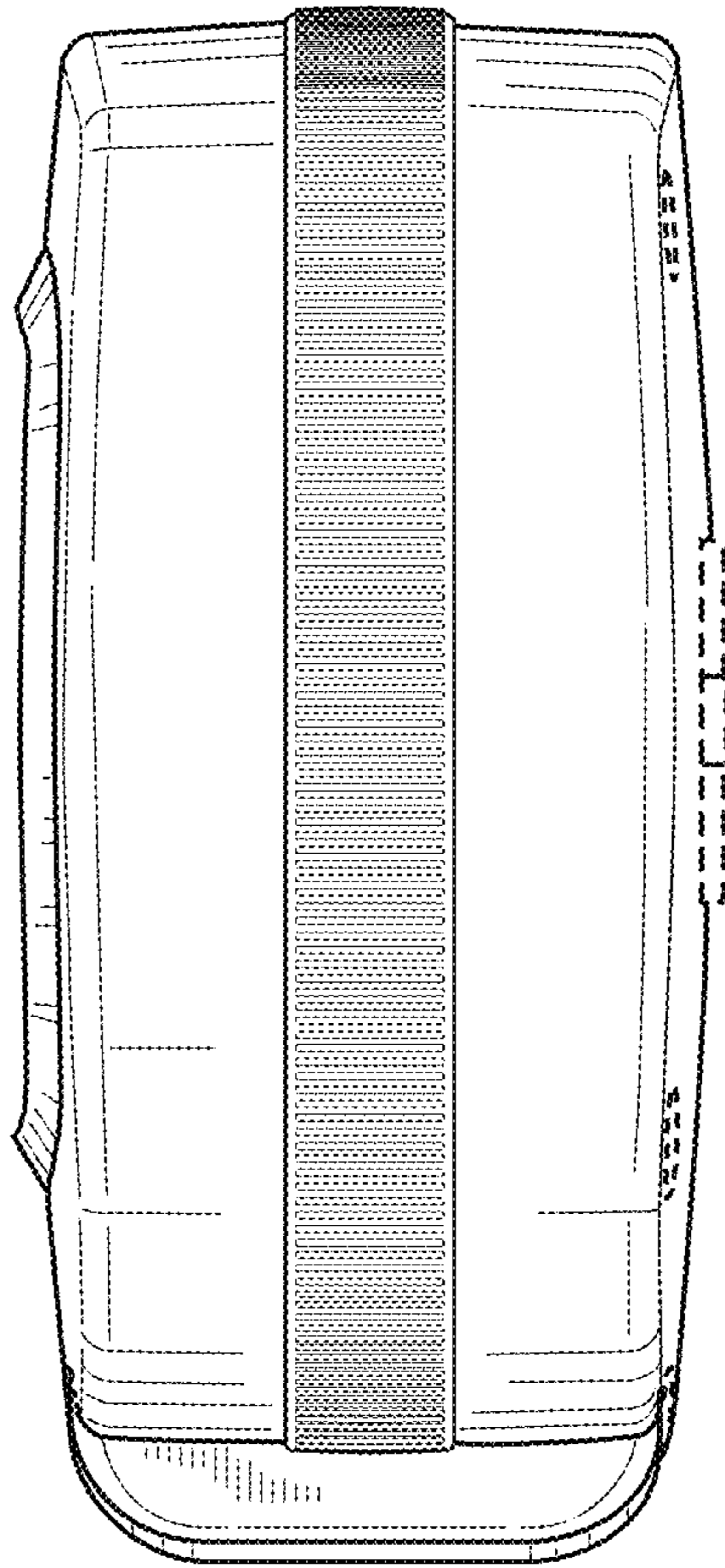

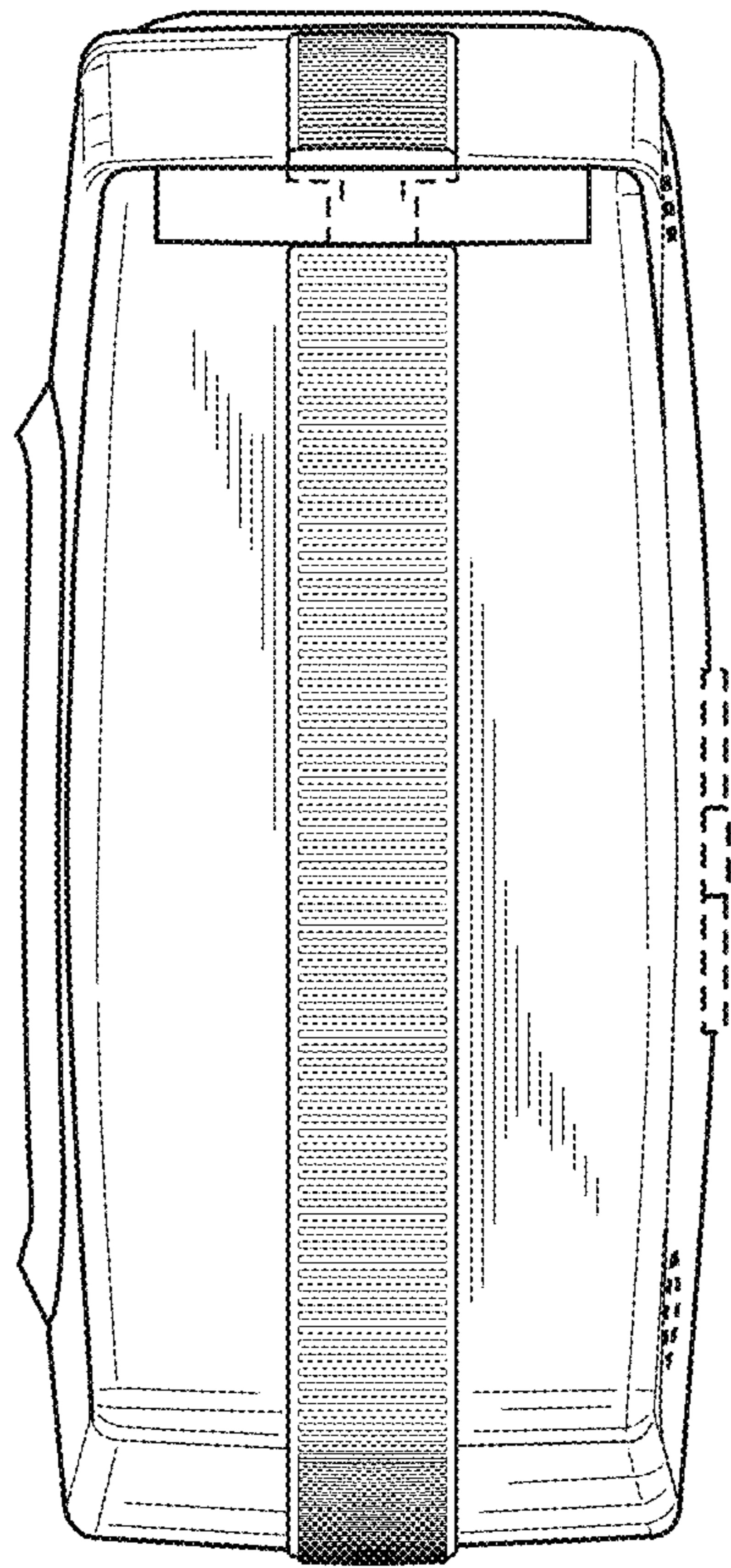
