FIG. 5 is a first side view of the toy aircraft of FIG. 1;

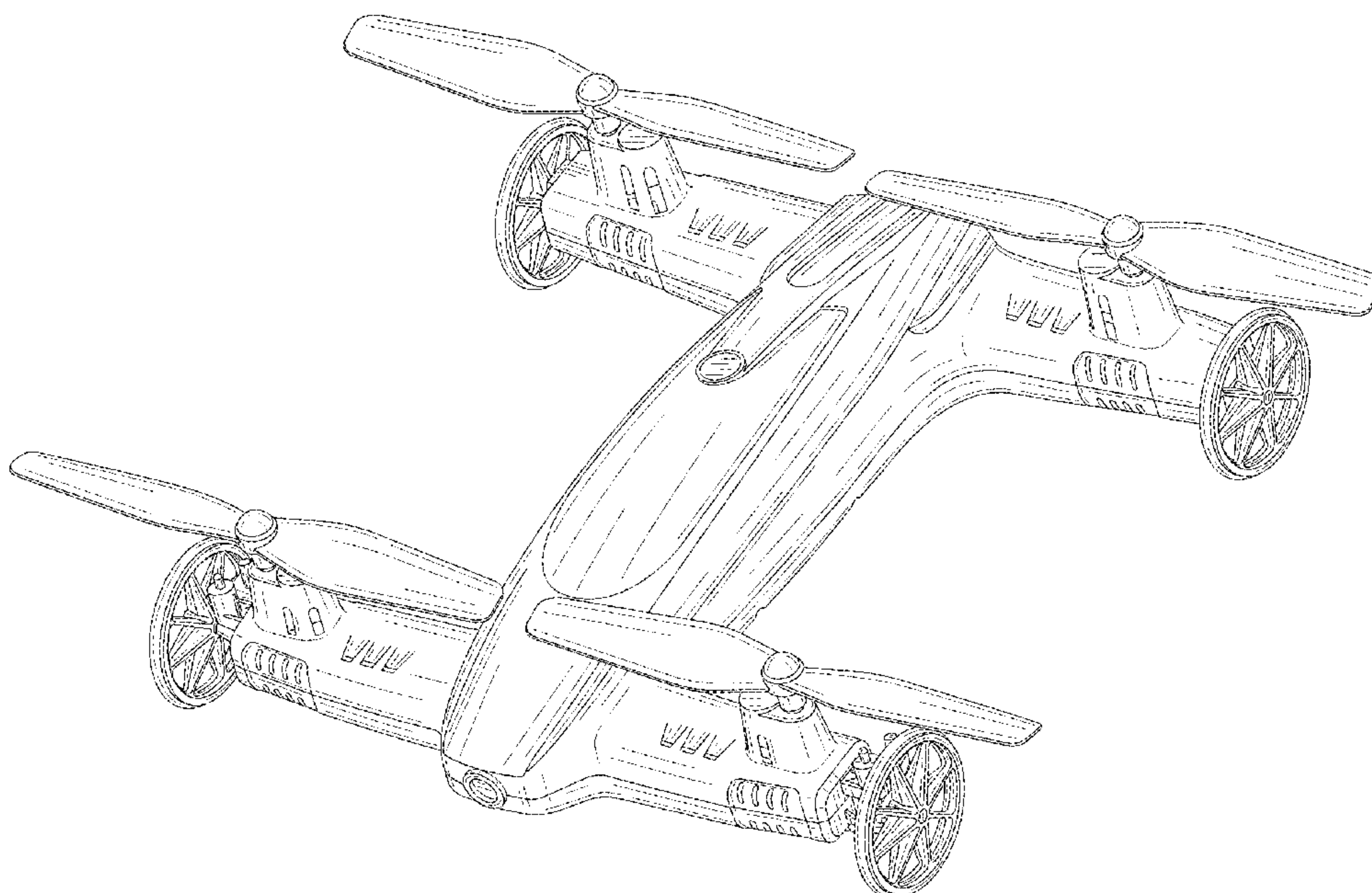
FIG. 6 is a second side view of the toy aircraft of FIG. 1;

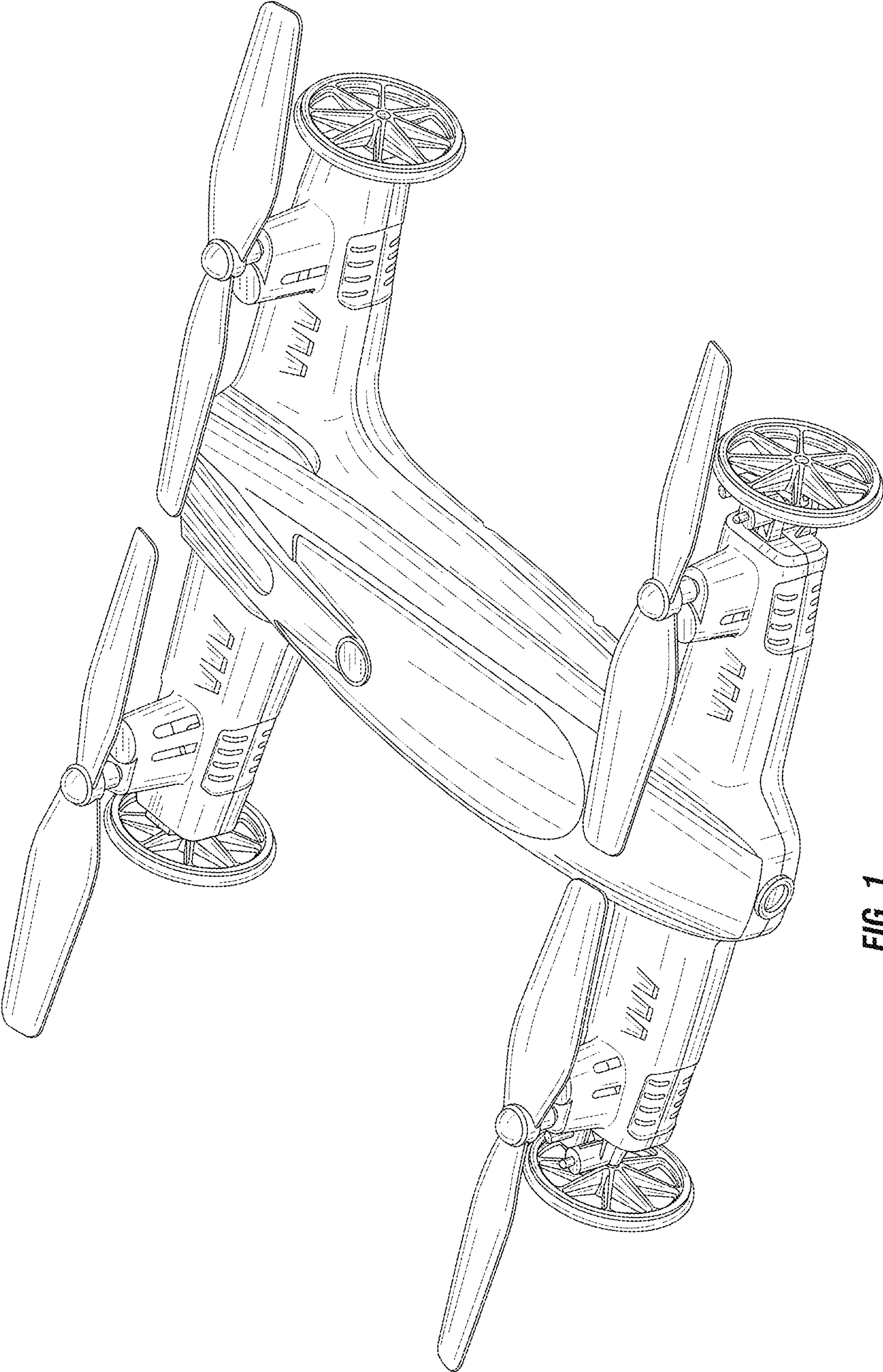

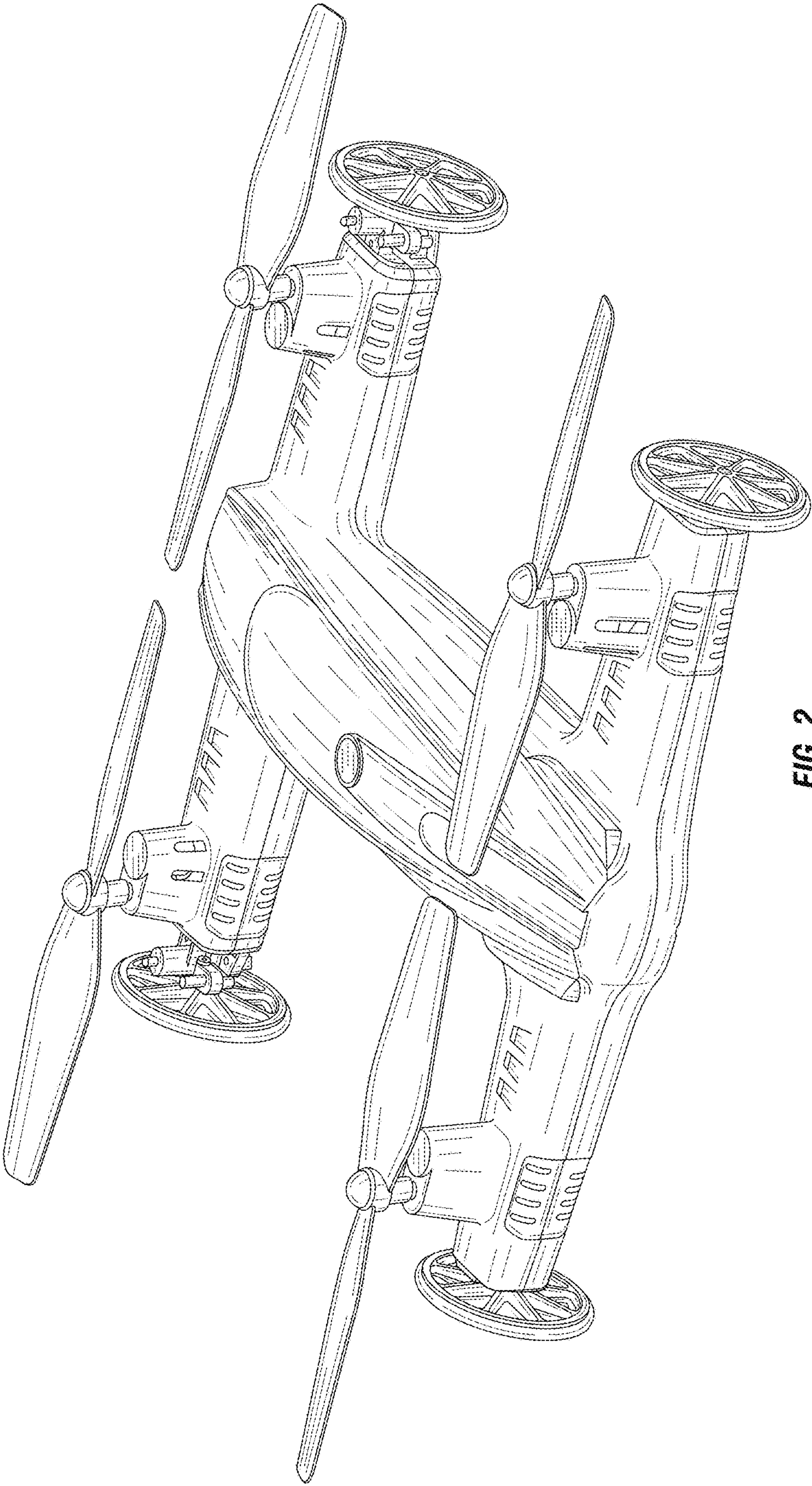

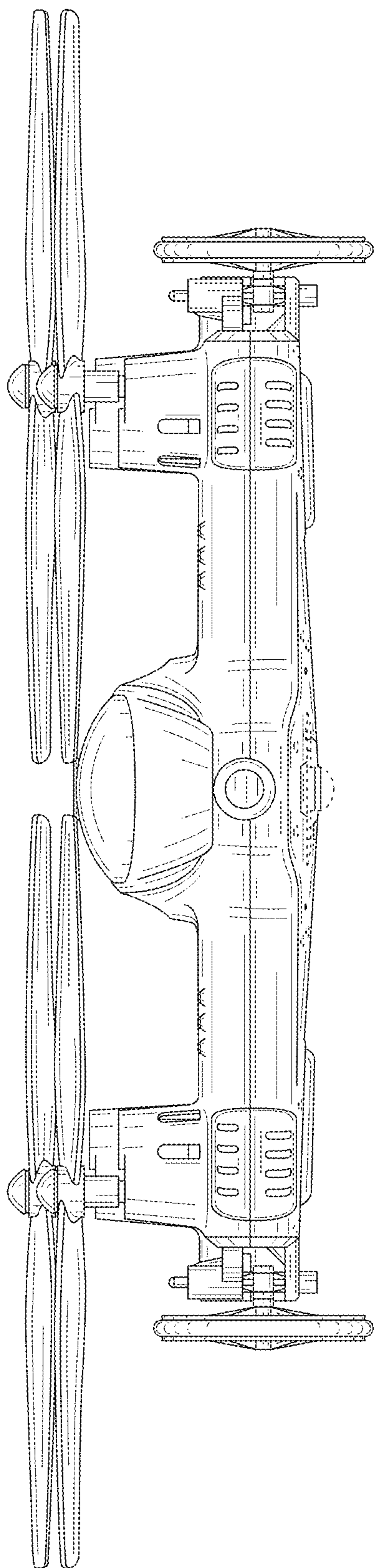

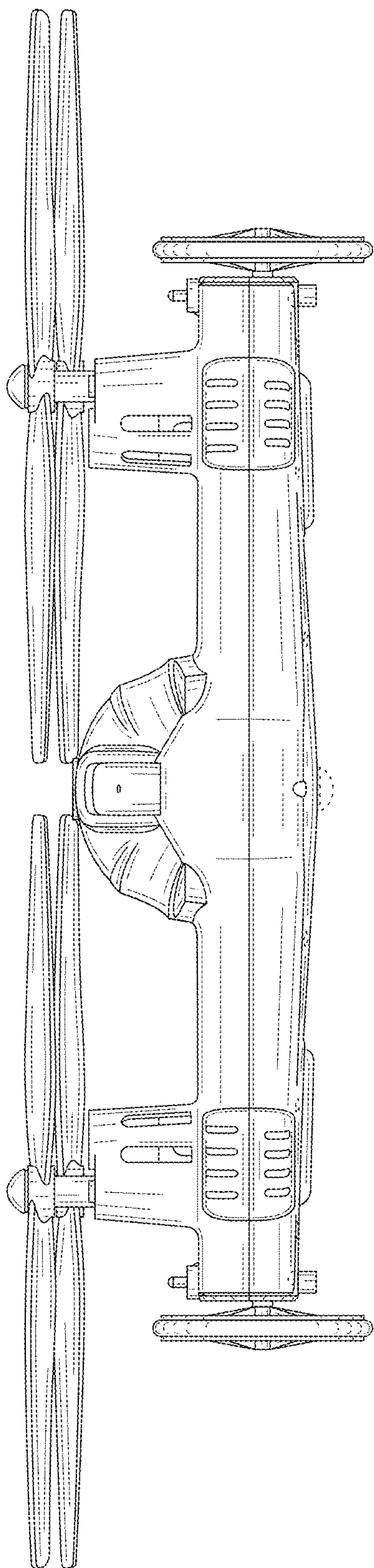

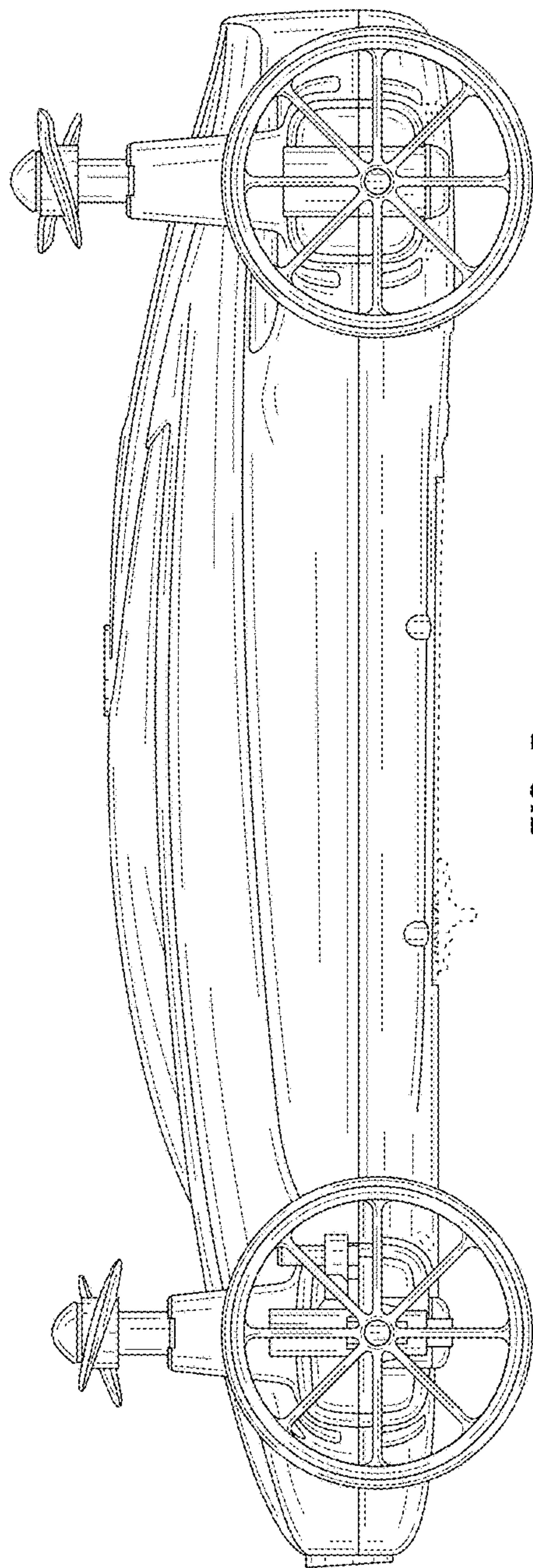

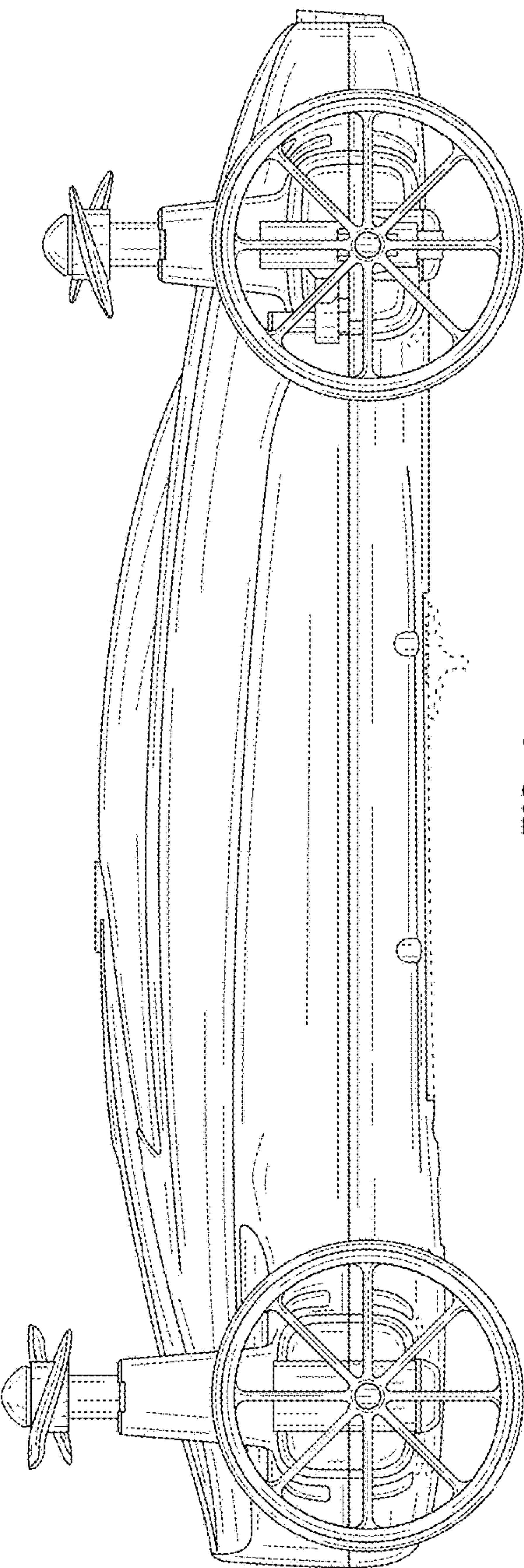

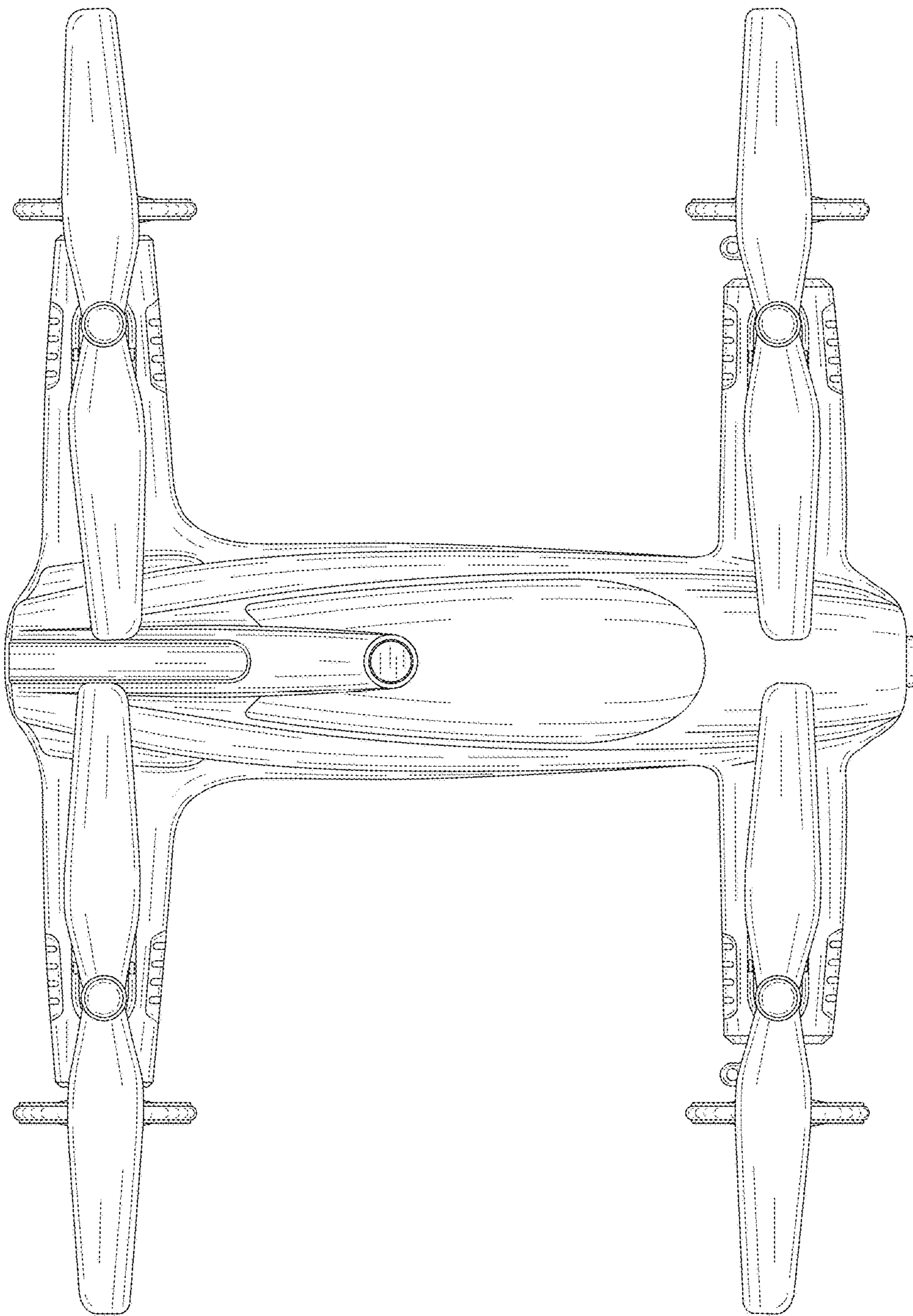

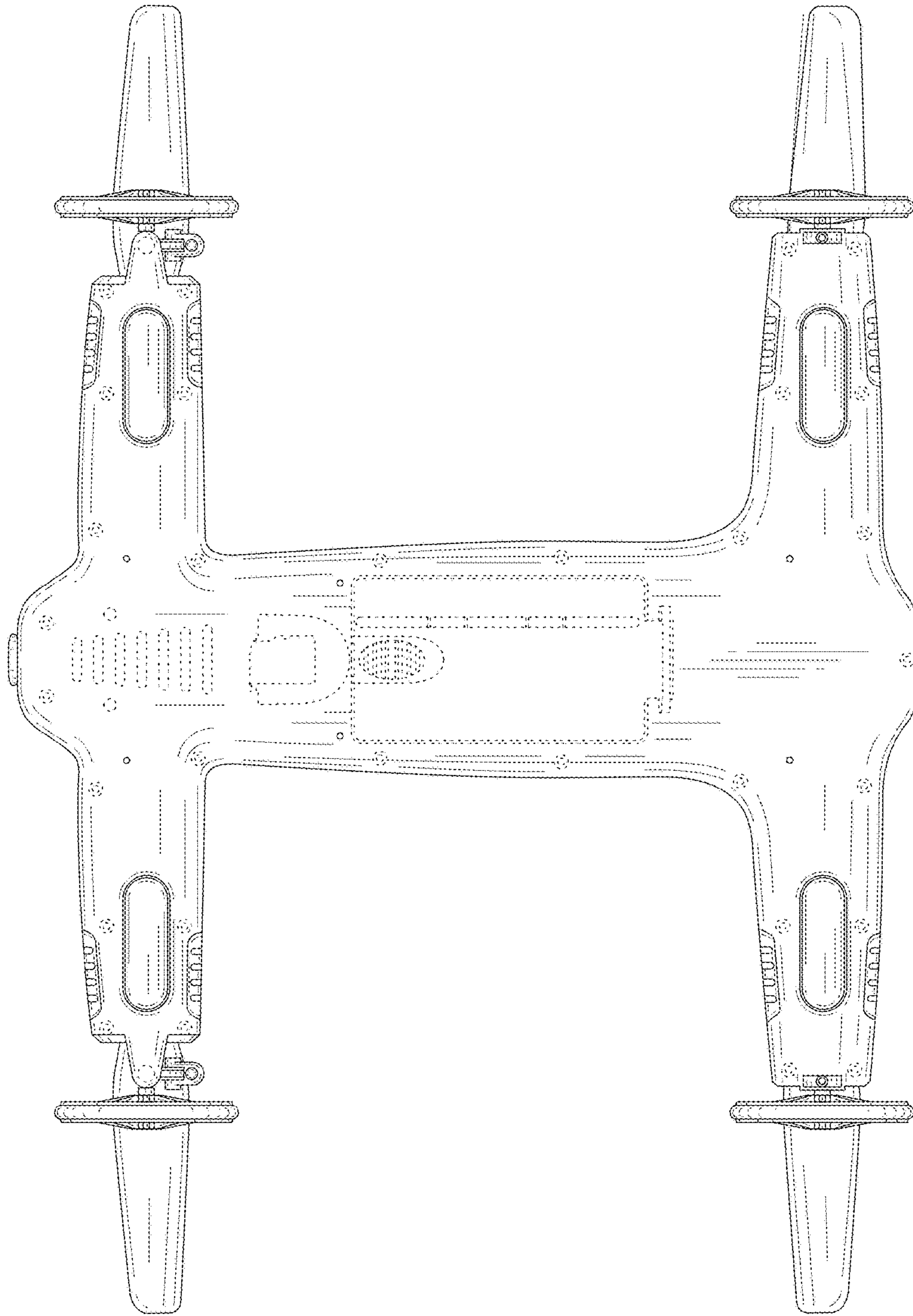
