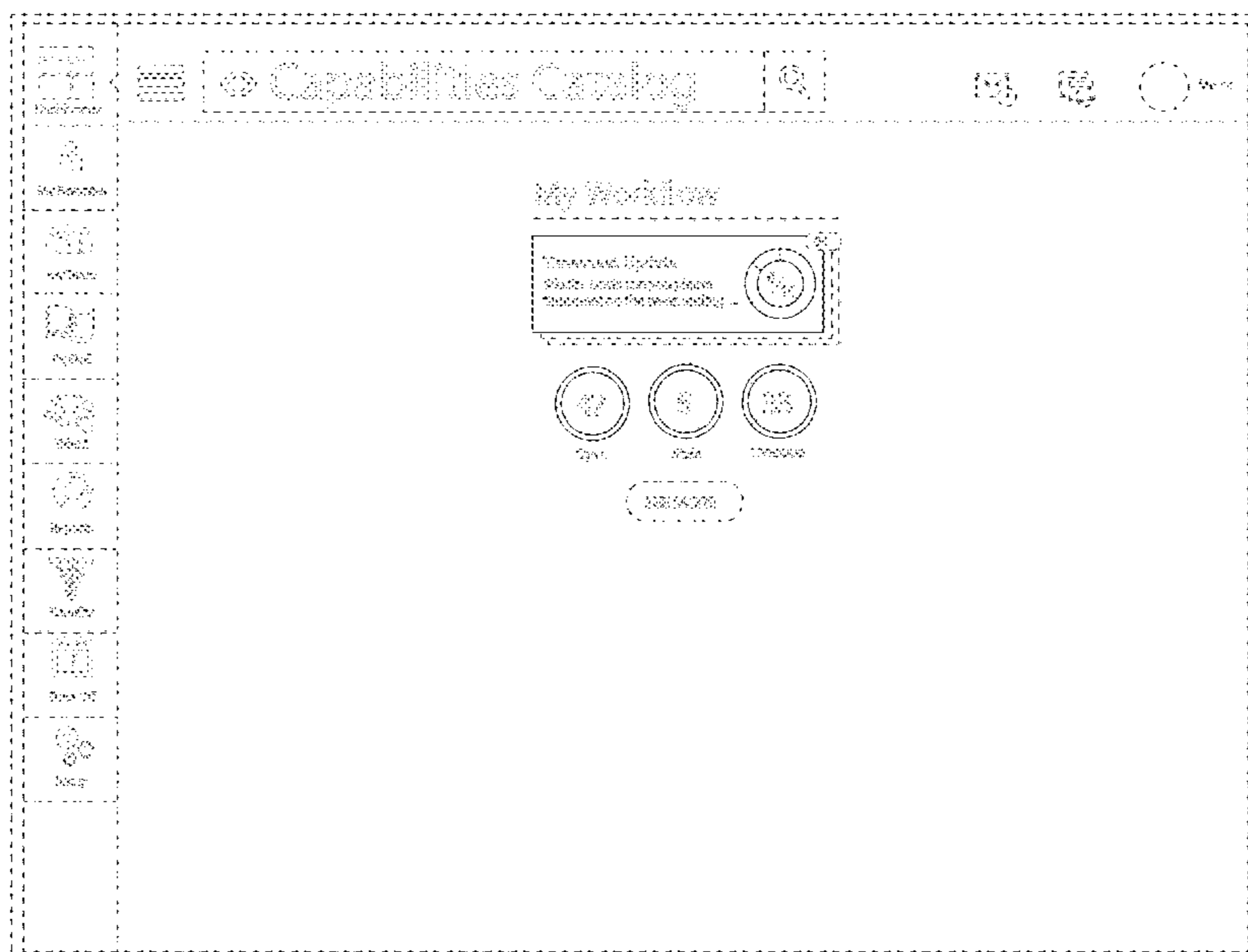
(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the display screen or portion thereof with graphical user interface showing our new design; and, FIG. 2 is a front view of a second embodiment thereof. The outermost broken lines illustrate a display screen or portion thereof. The remaining broken lines illustrate portions of a graphical user interface. 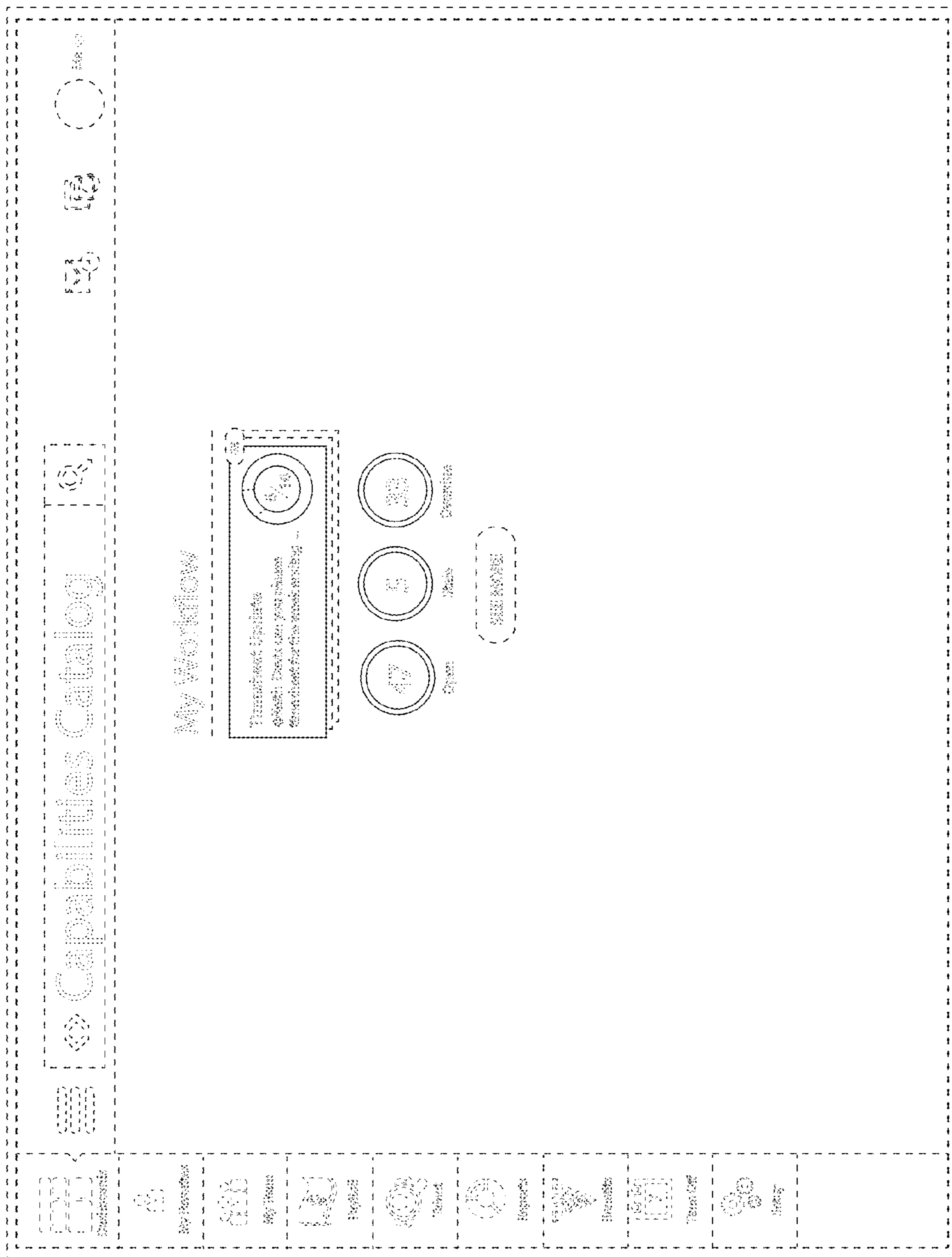

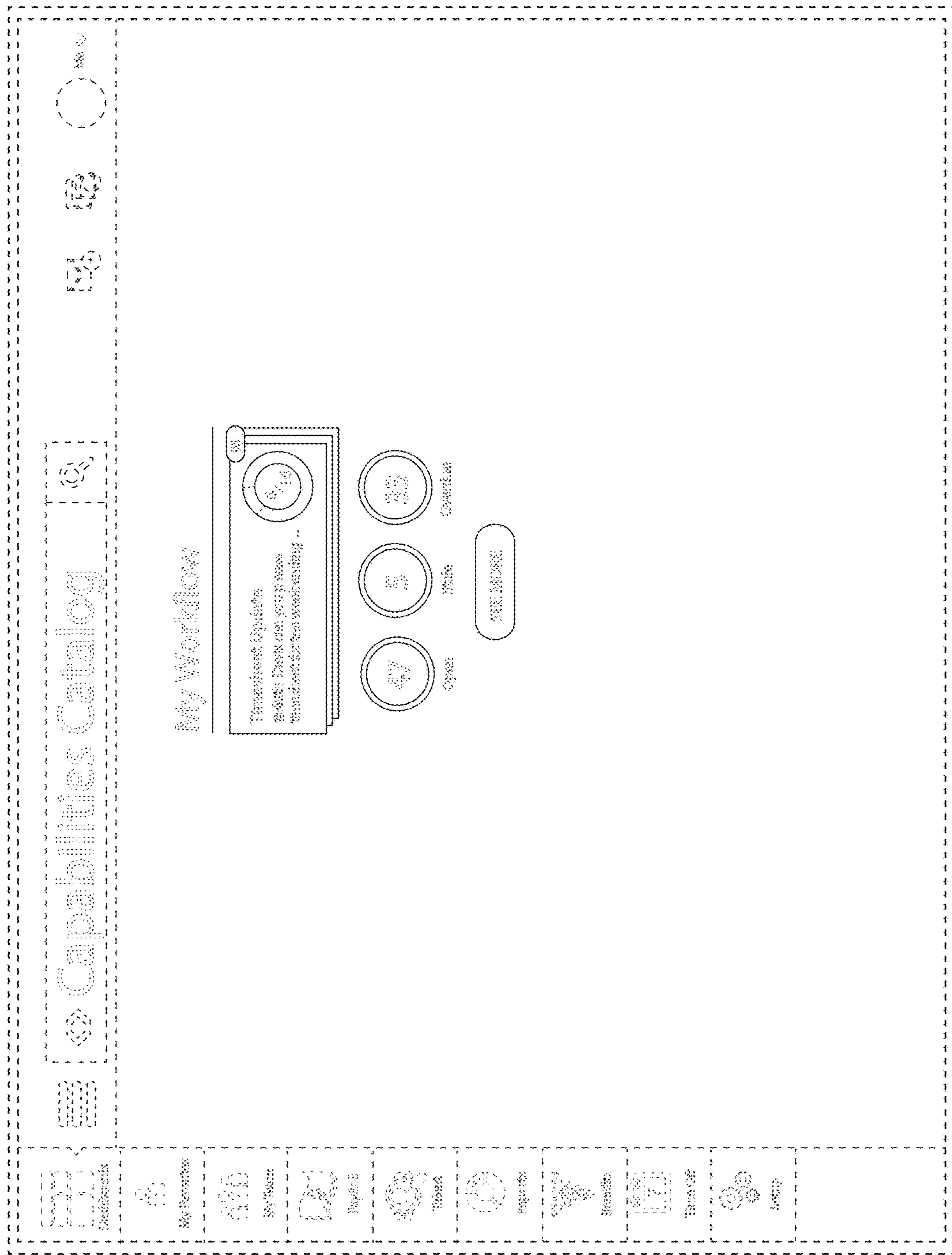
