(57) **CLAIM**

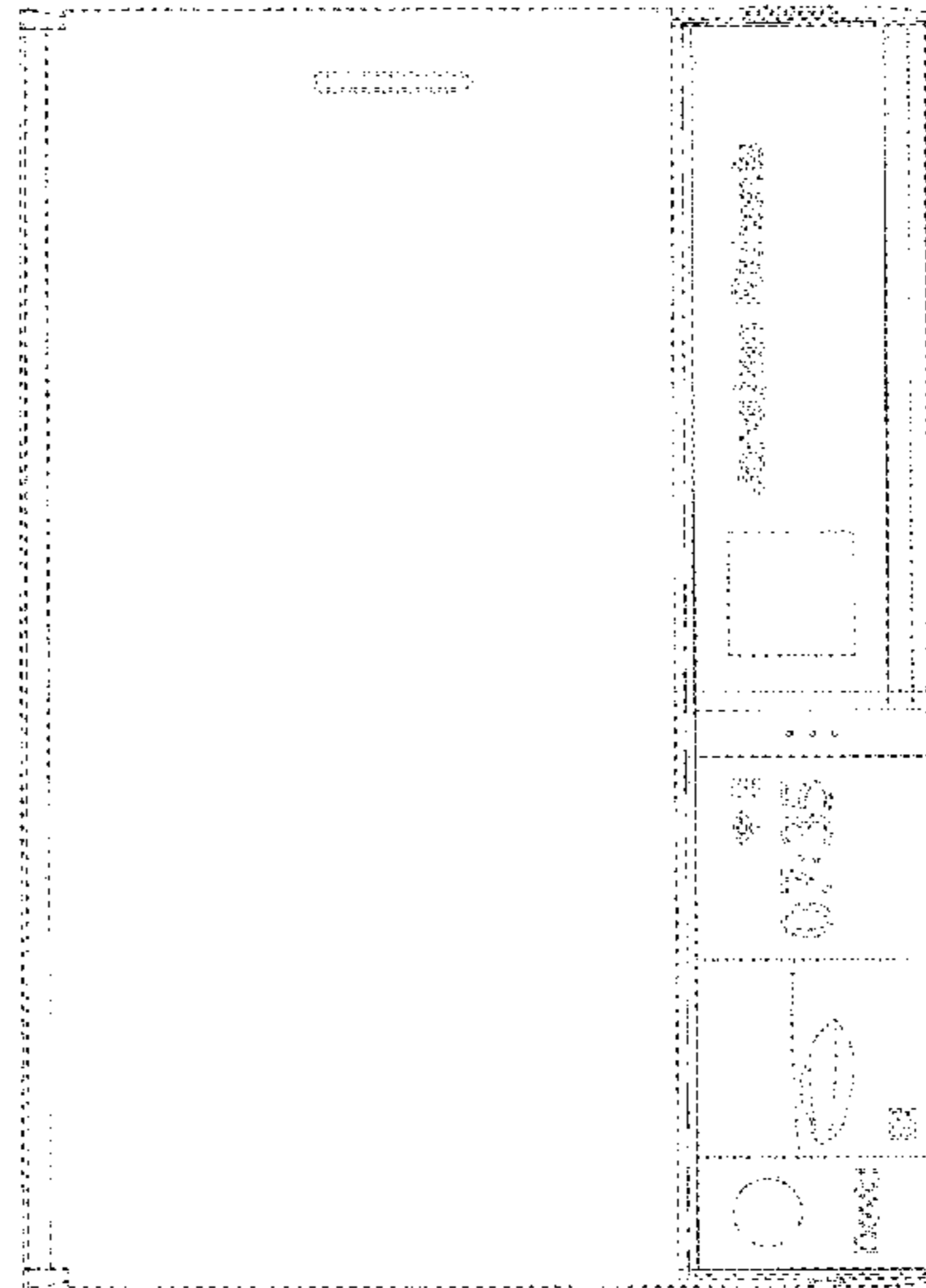
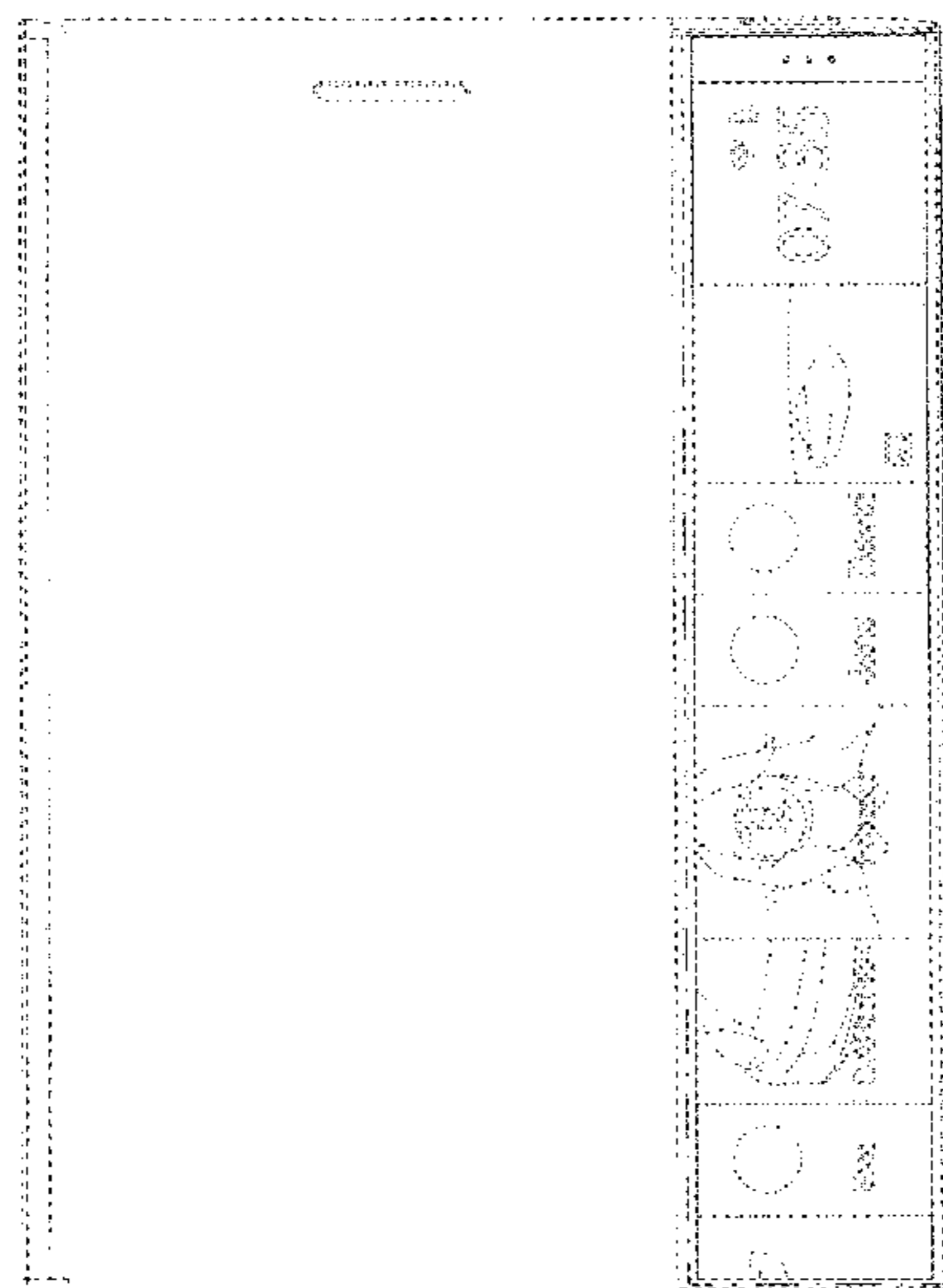
We claim the ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is display screen or portion thereof with an animated graphical user interface showing our new design showing the first image in a sequence of images included in the animated graphical user interface showing our new design; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; and, FIG. 4 is the fourth image thereof.

The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 1 to 4. The process or period in which one image transitions to another forms no part of the claimed design. The evenly-spaced broken lines illustrating portions of the display screen or portion thereof with animated graphical user interface are for illustrative purpose only and form no part of the claimed design. The dot-dash broken lines indicate the boundary of the claimed design.

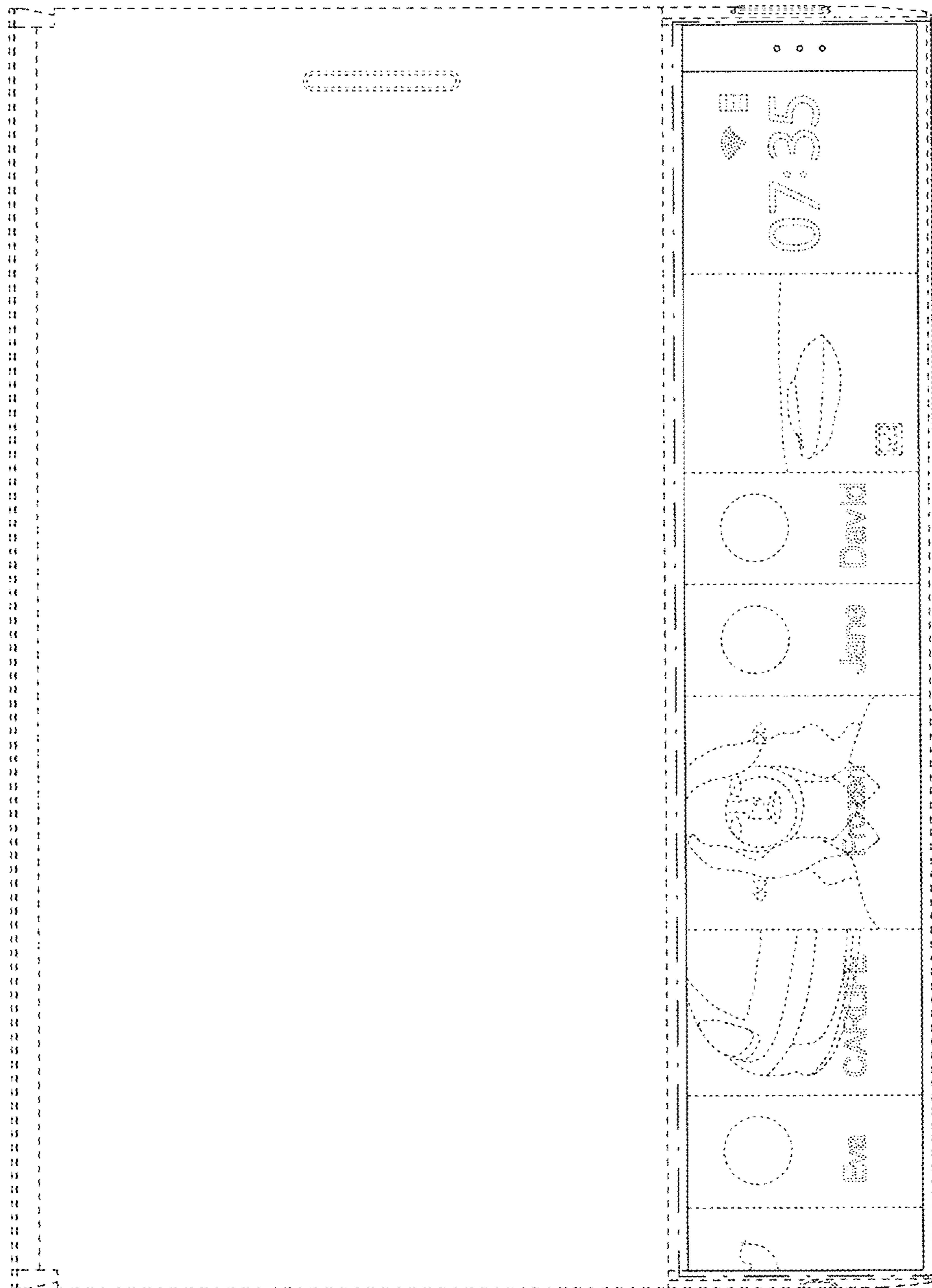

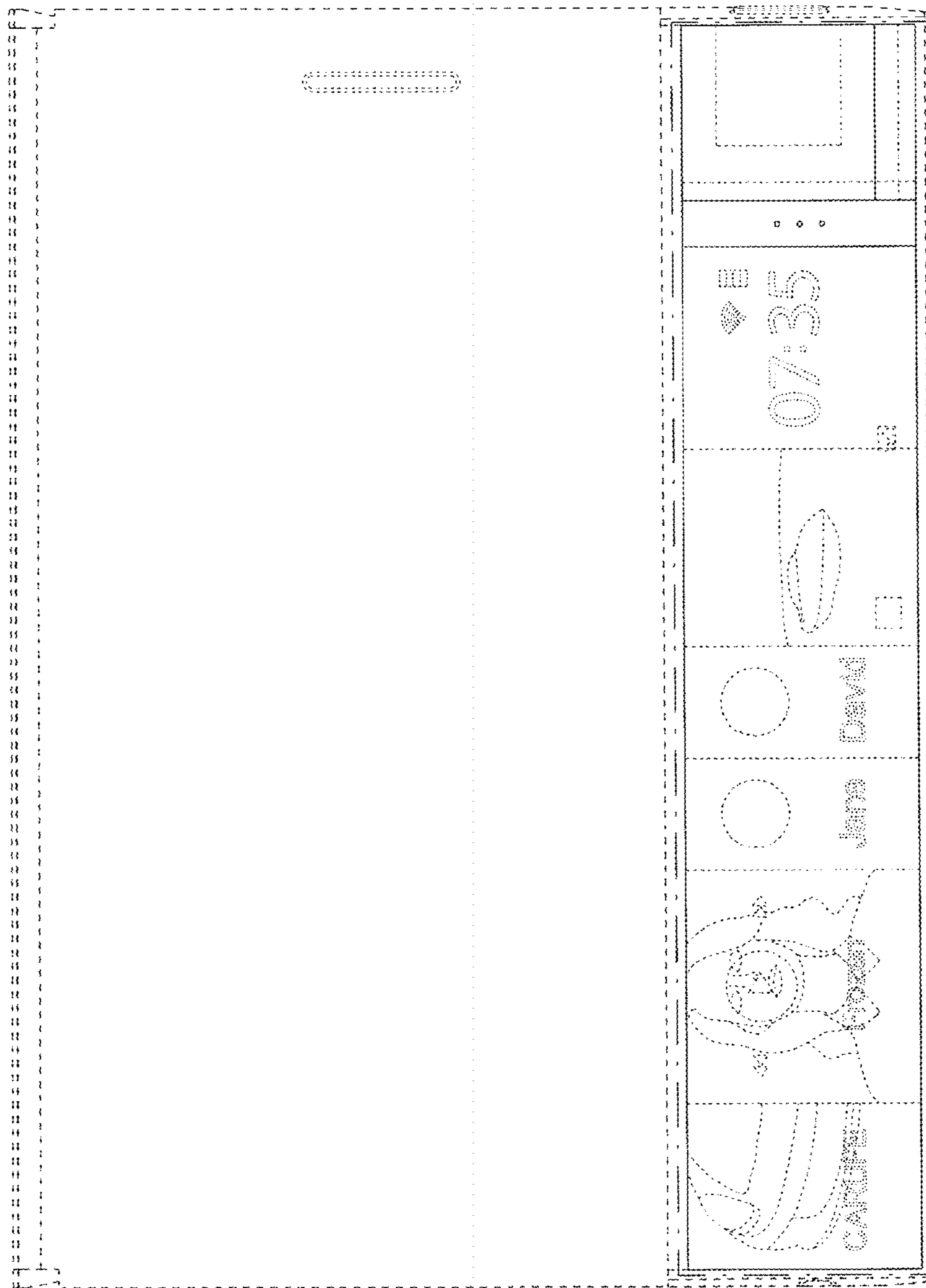

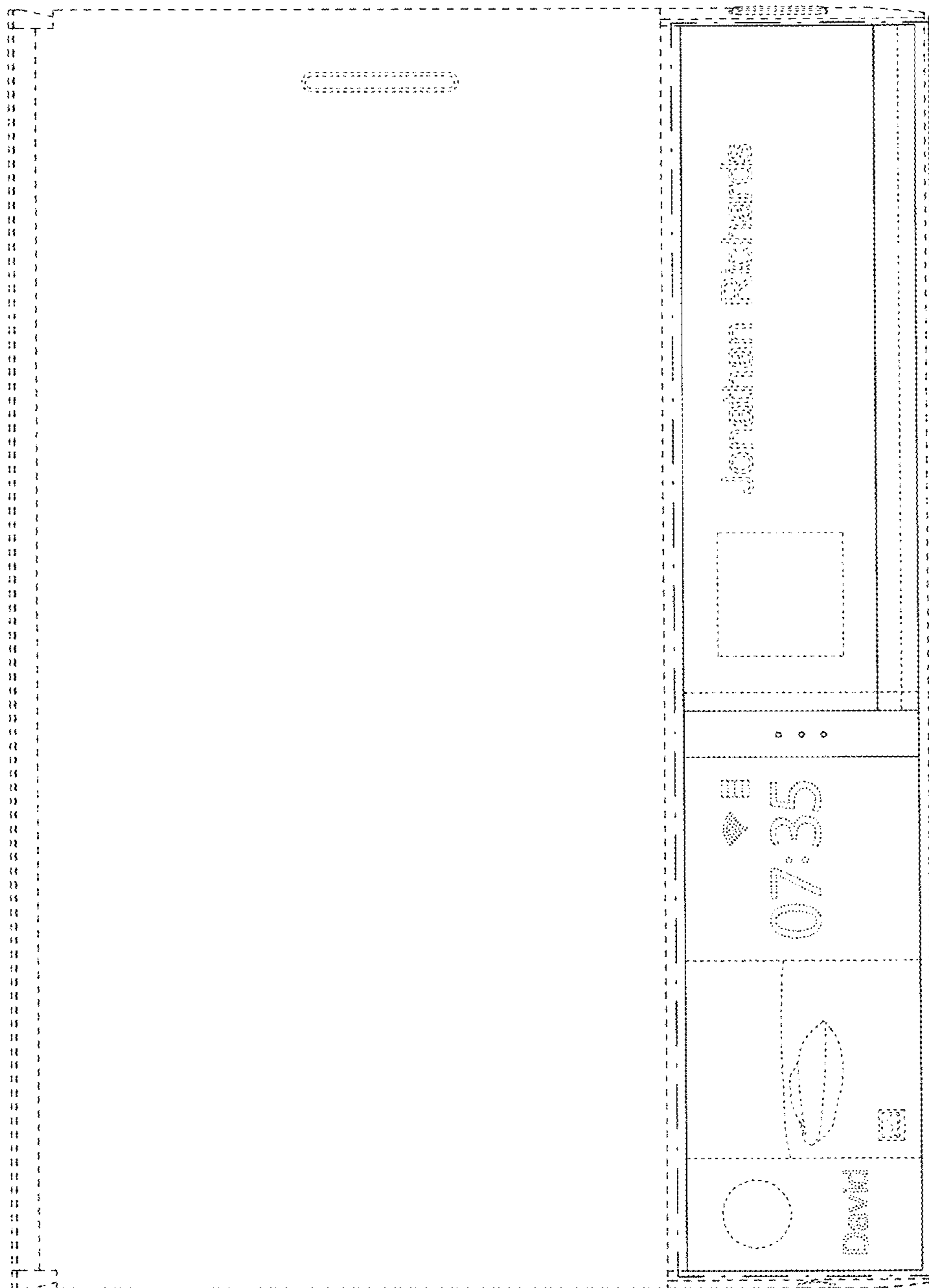
