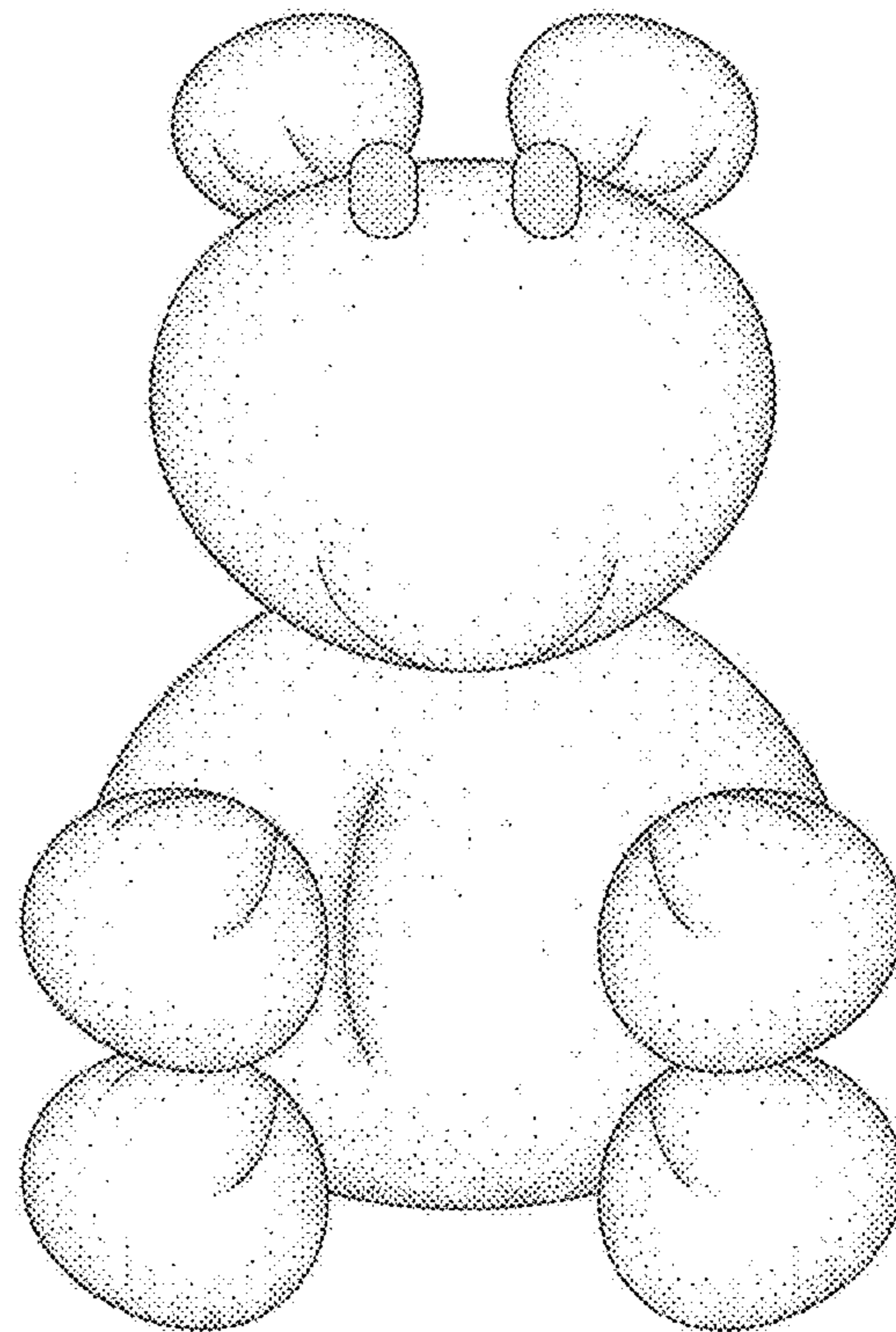
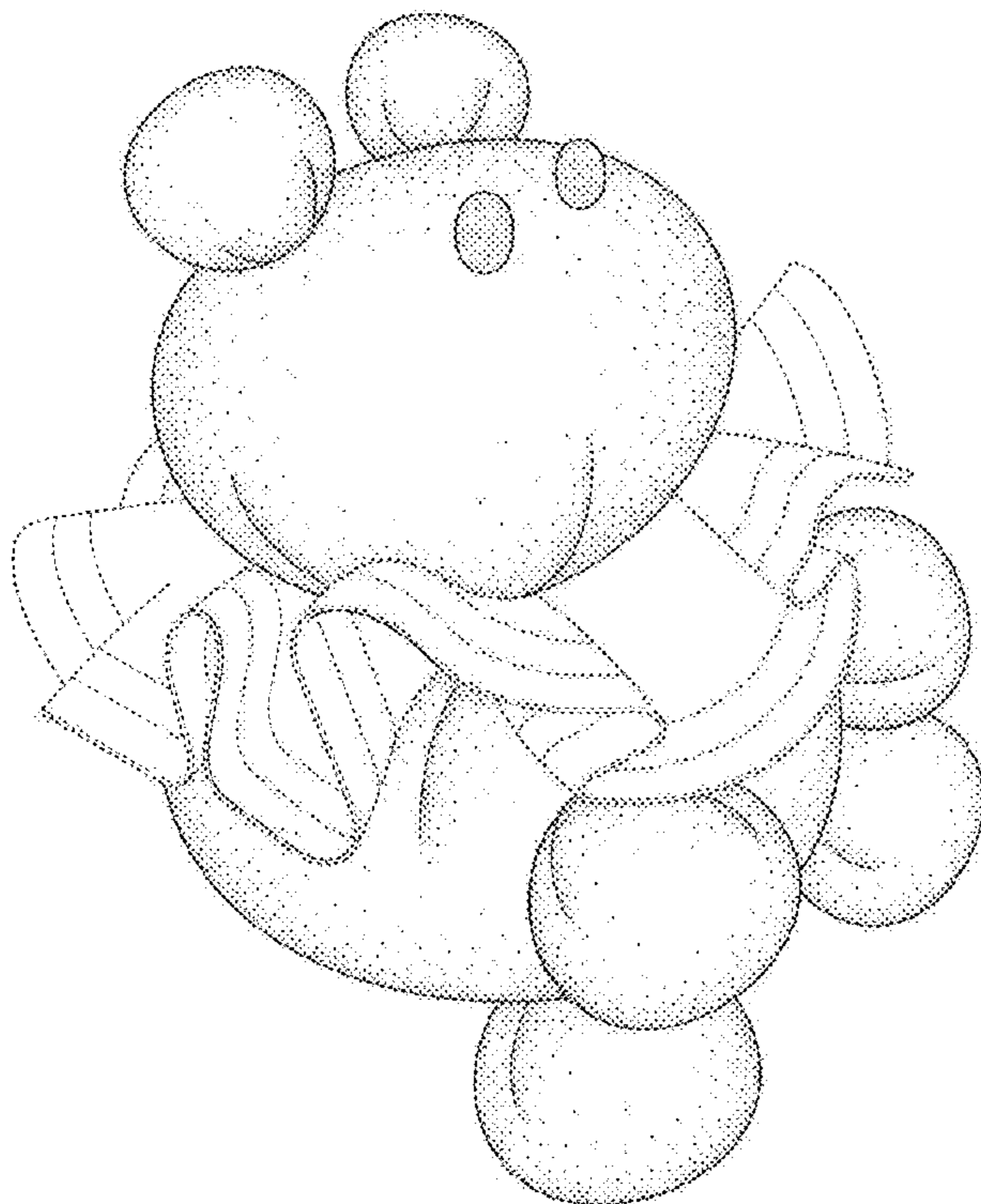
(57) **CLAIM**

The ornamental design for a stuffed bear, as shown and described.

DESCRIPTION

FIG. 1 is a front upper perspective view of the stuffed bear; FIG. 2 is a back lower perspective view of the stuffed bear; FIG. 3 is a front view of the stuffed bear; FIG. 4 is a back view of the stuffed bear; FIG. 5 is a right side view of the stuffed bear; FIG. 6 is a left side view of the stuffed bear; FIG. 7 is a top view of the stuffed bear; FIG. 8 is a bottom view of the stuffed bear; FIG. 9 is a front upper perspective view of the stuffed bear, with the broken line disclosure shown removed; FIG. 10 is a back lower perspective view of the stuffed bear; FIG. 11 is a front view of the stuffed bear; FIG. 12 is a back view of the stuffed bear; FIG. 13 is a right side view of the stuffed bear; FIG. 14 is a left side view of the stuffed bear; FIG. 15 is a top view of the stuffed bear; and, FIG. 16 is a bottom view of the stuffed bear. 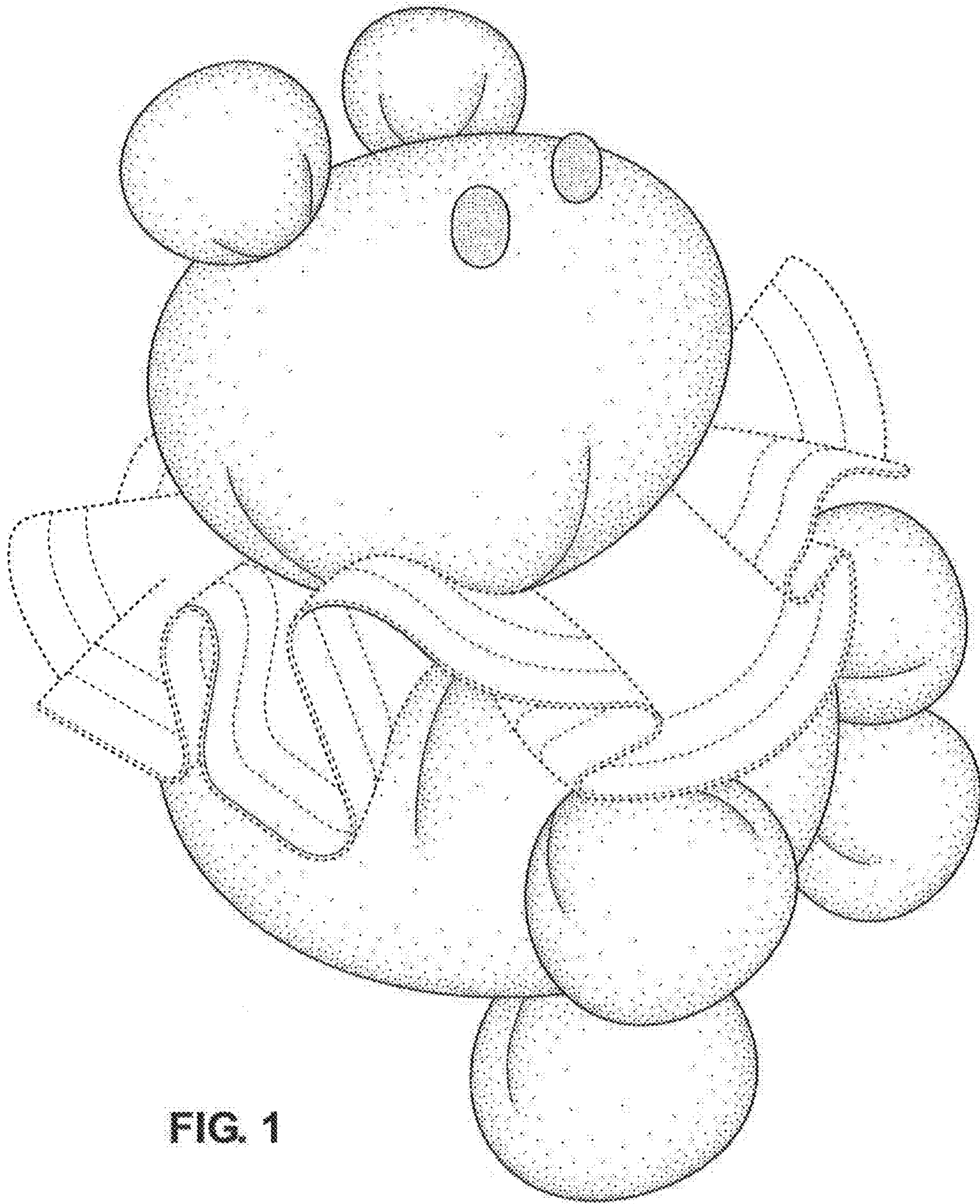

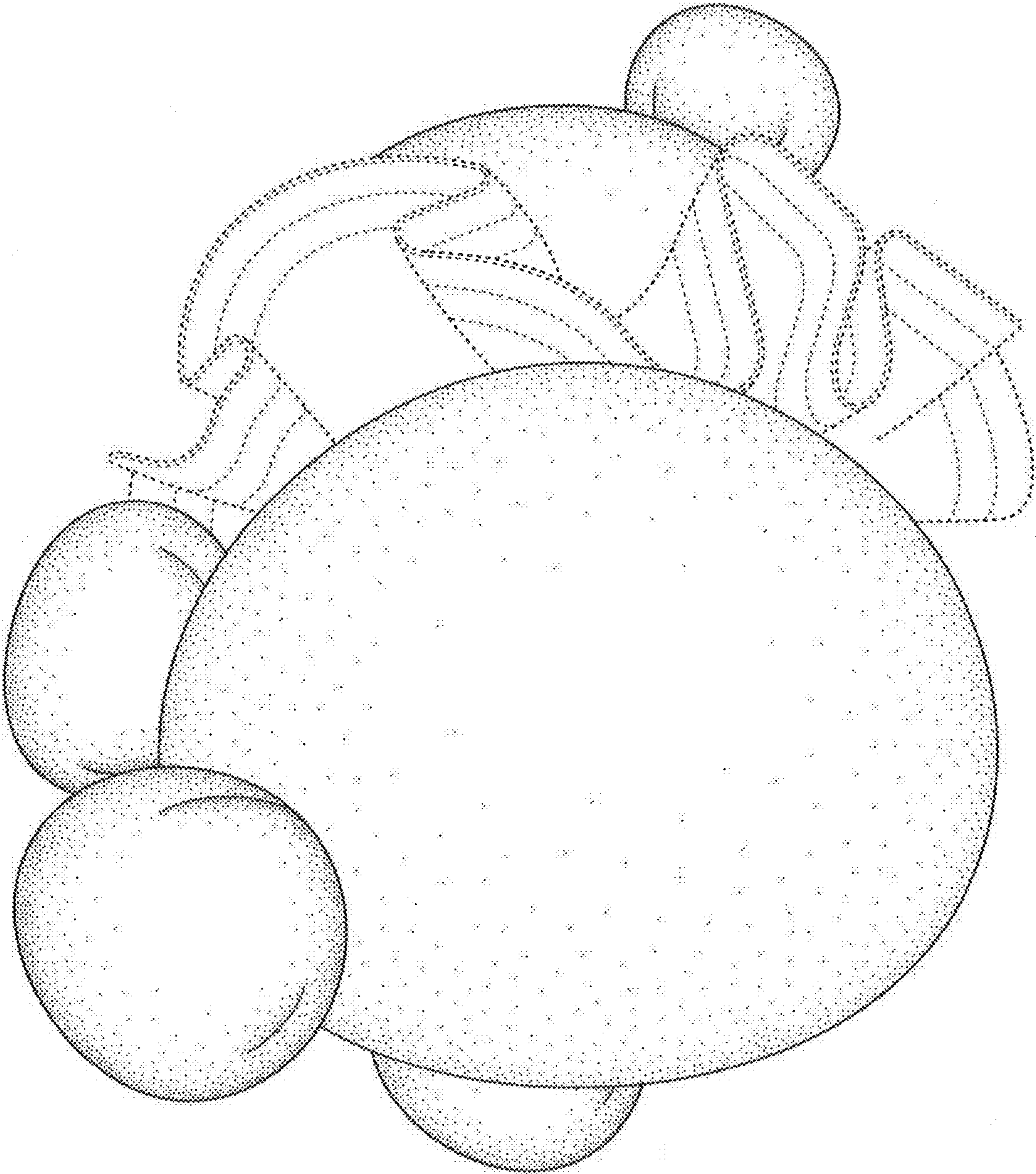

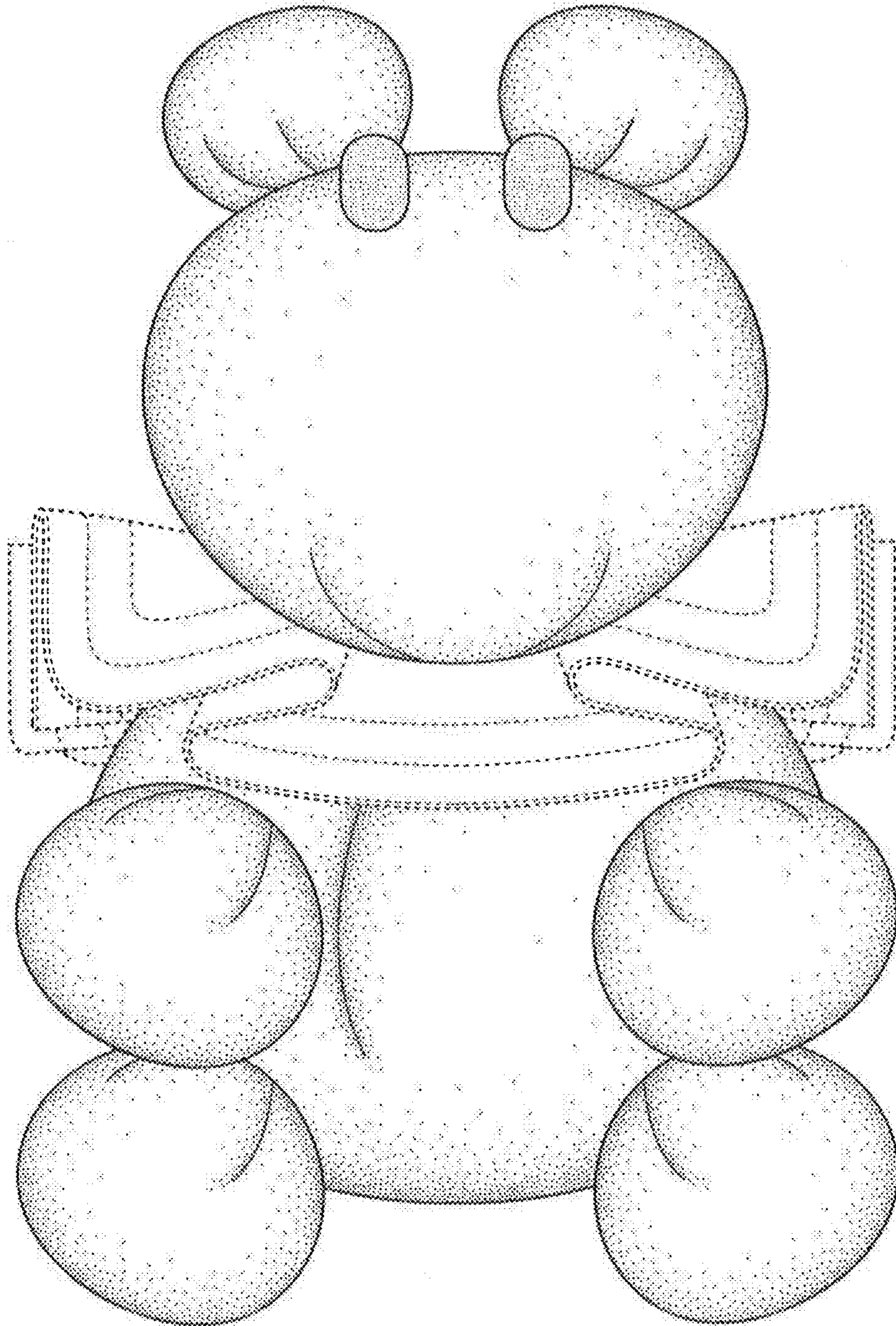

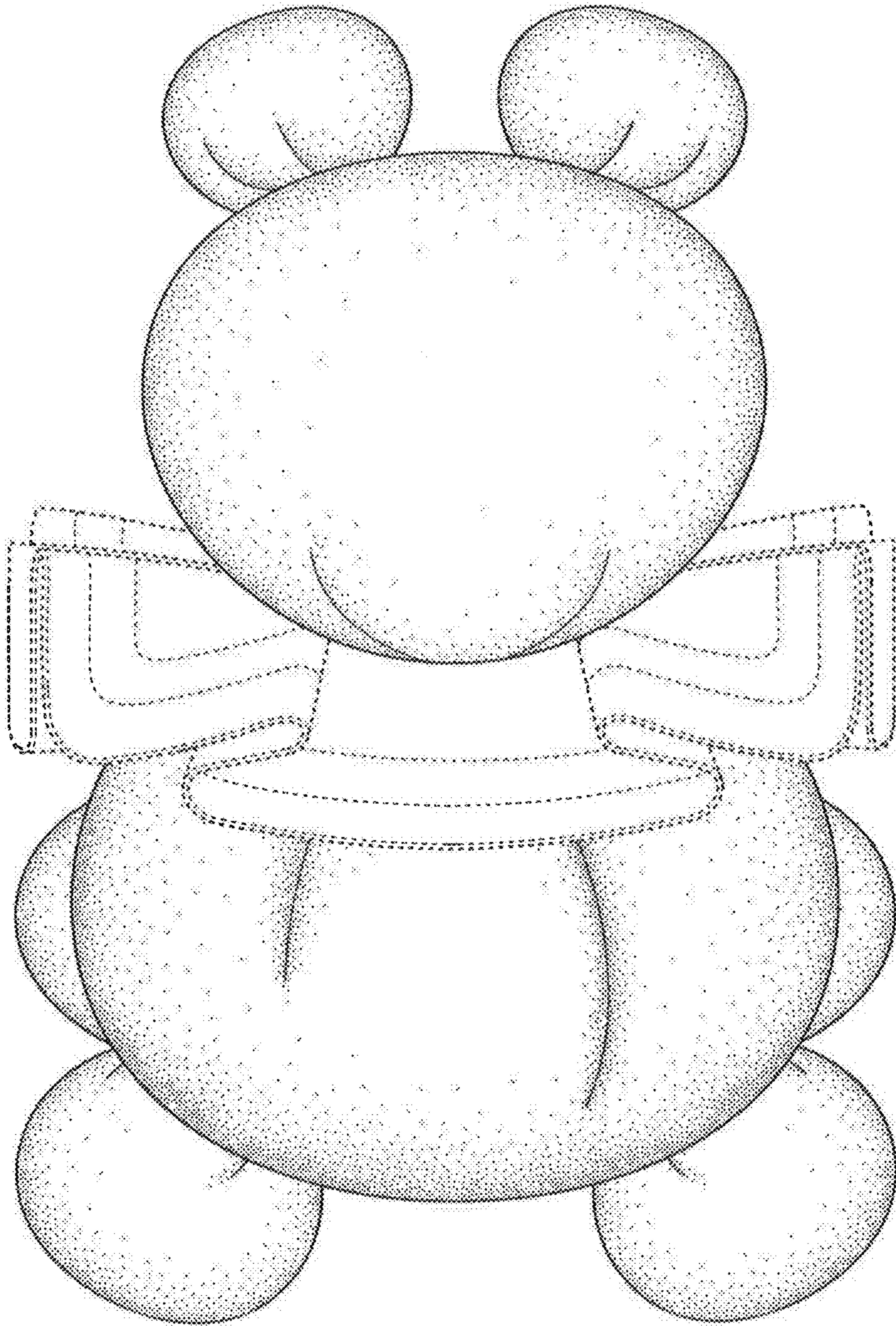

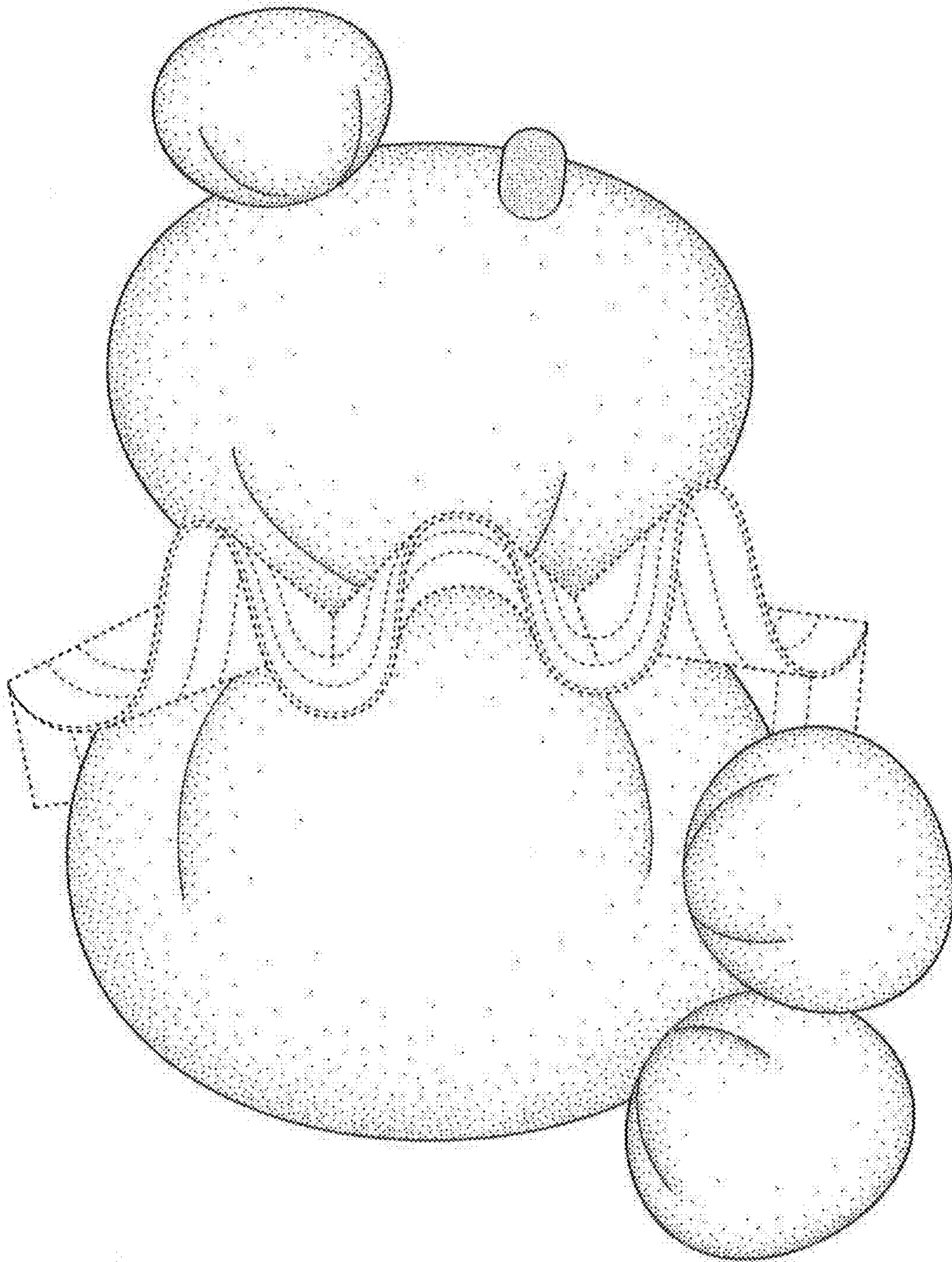

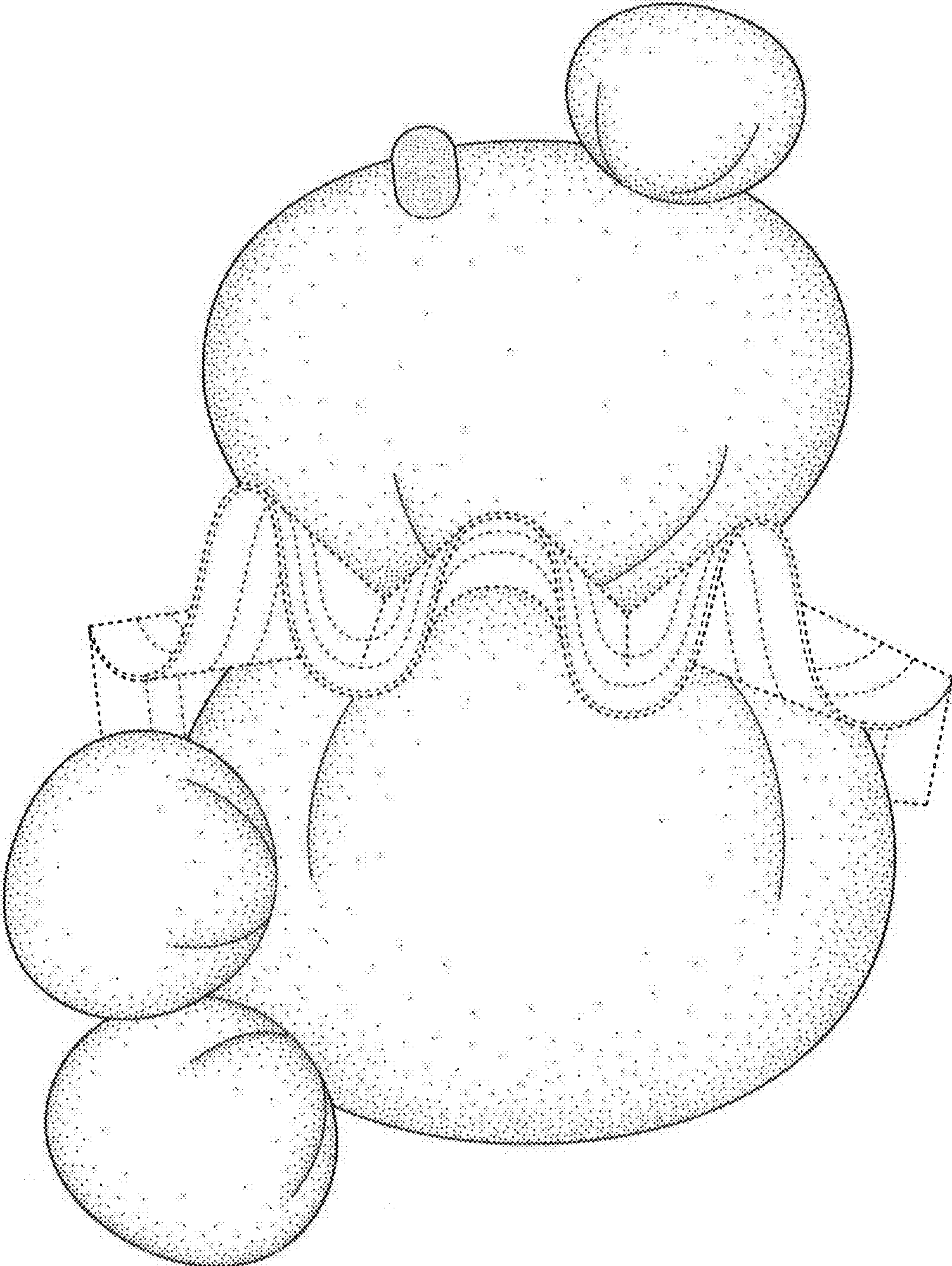

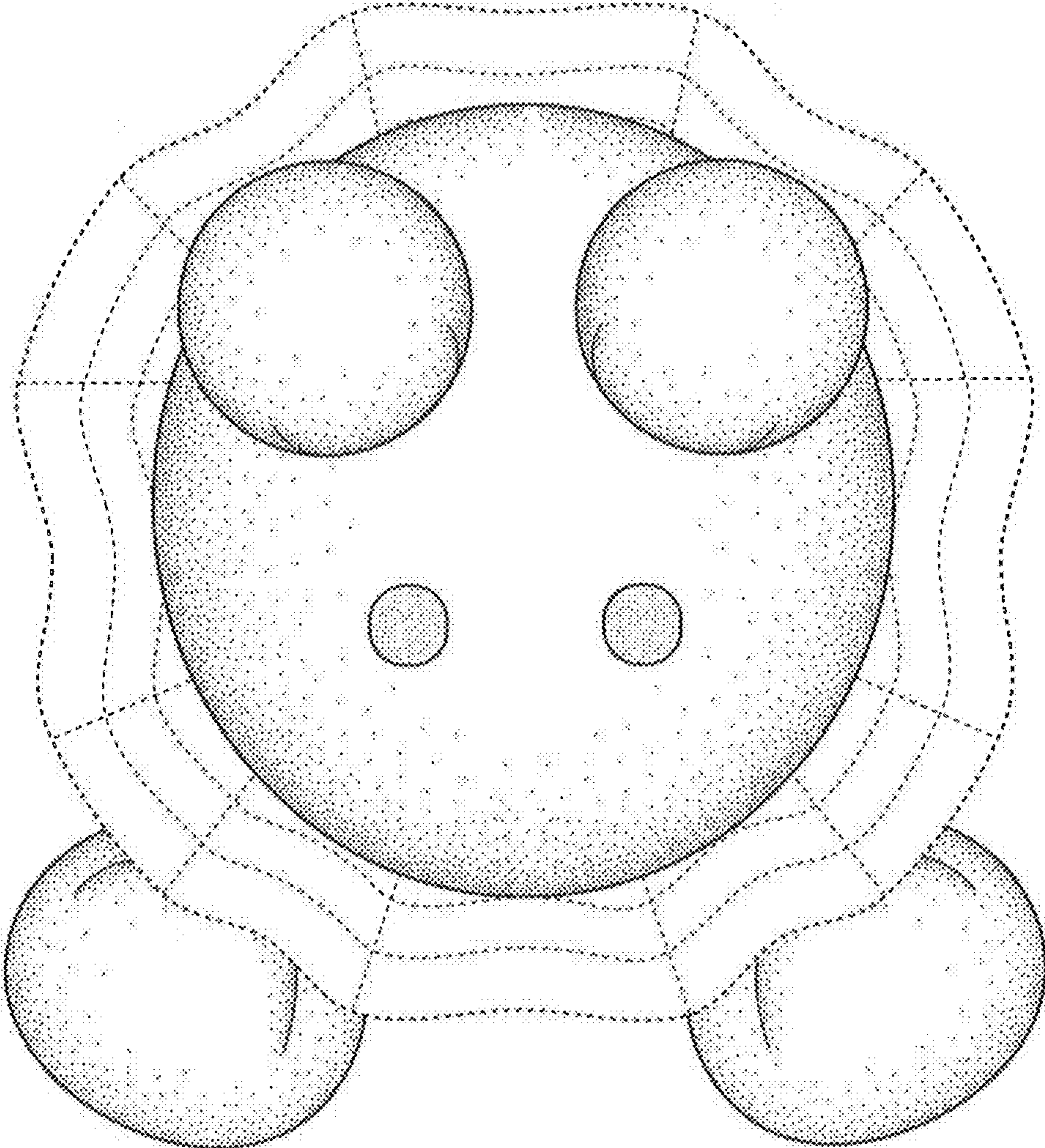

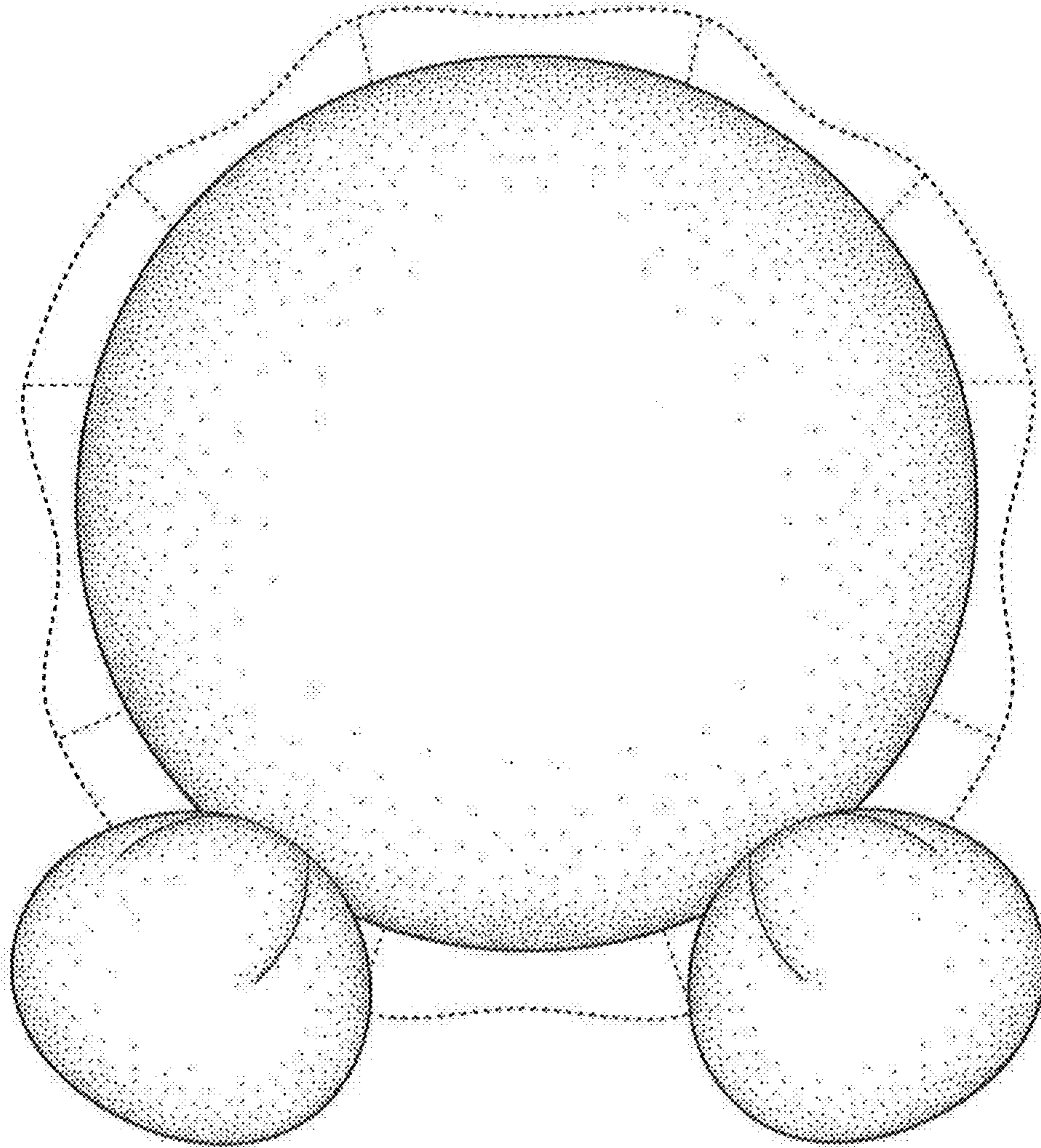

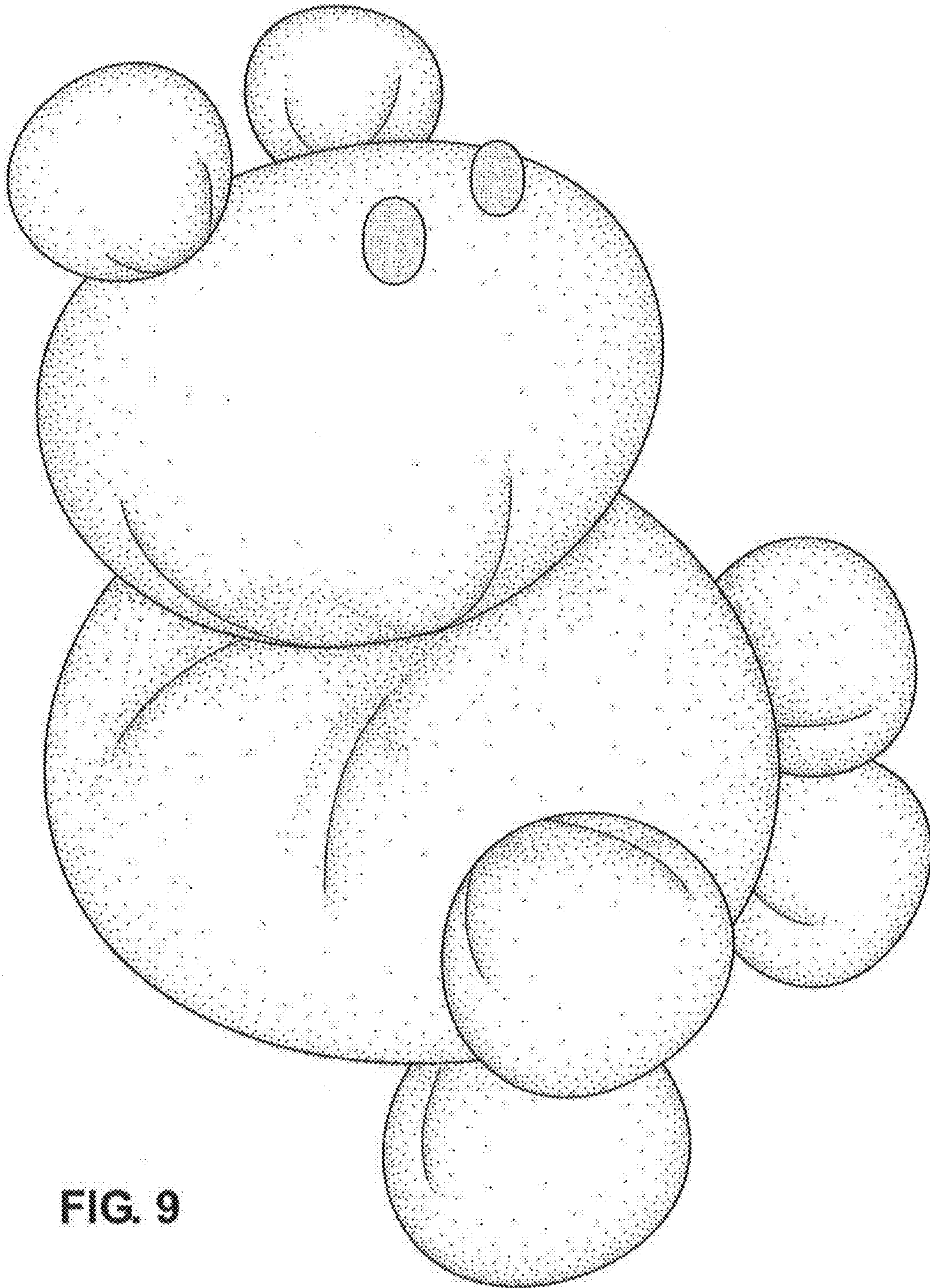

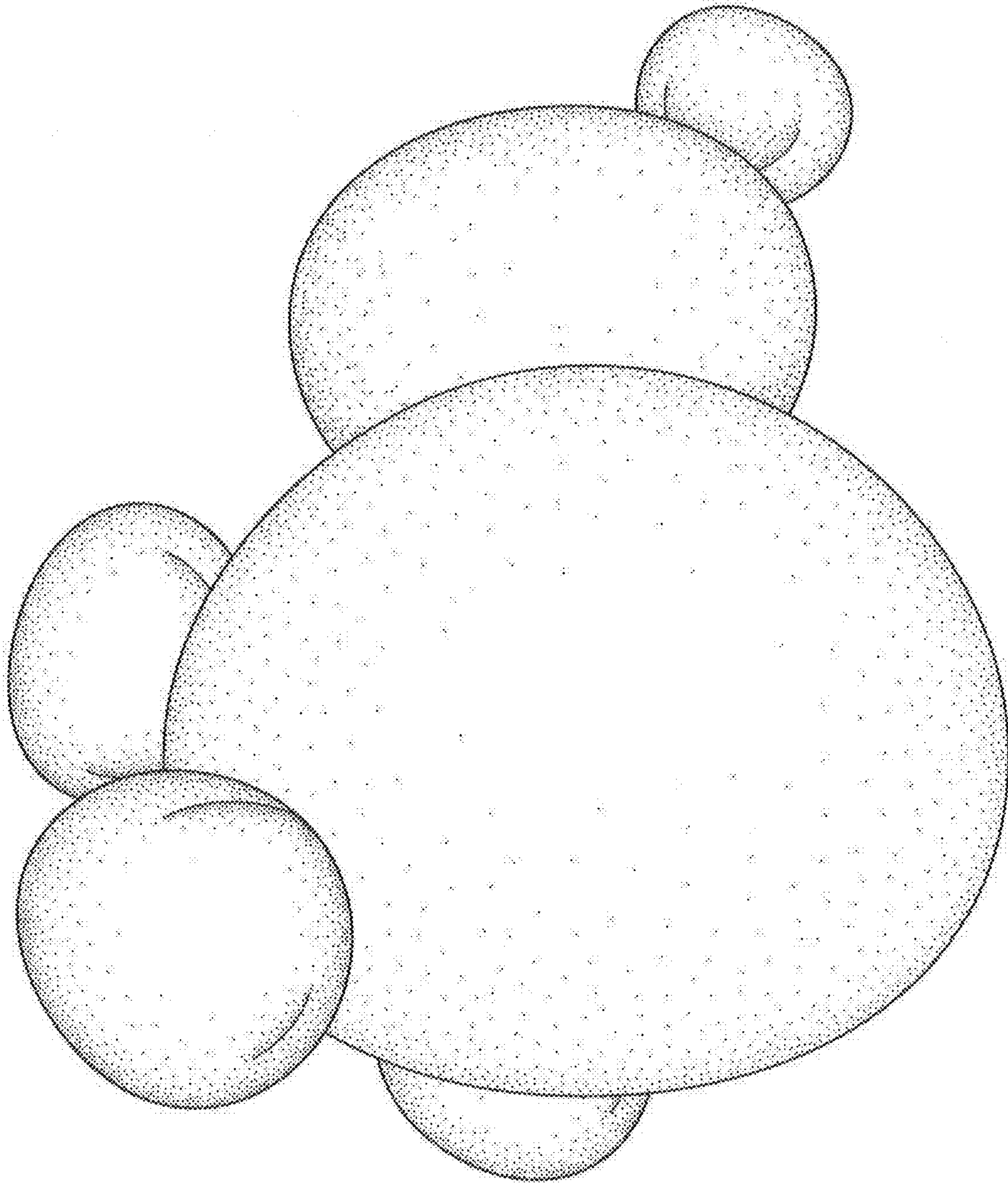

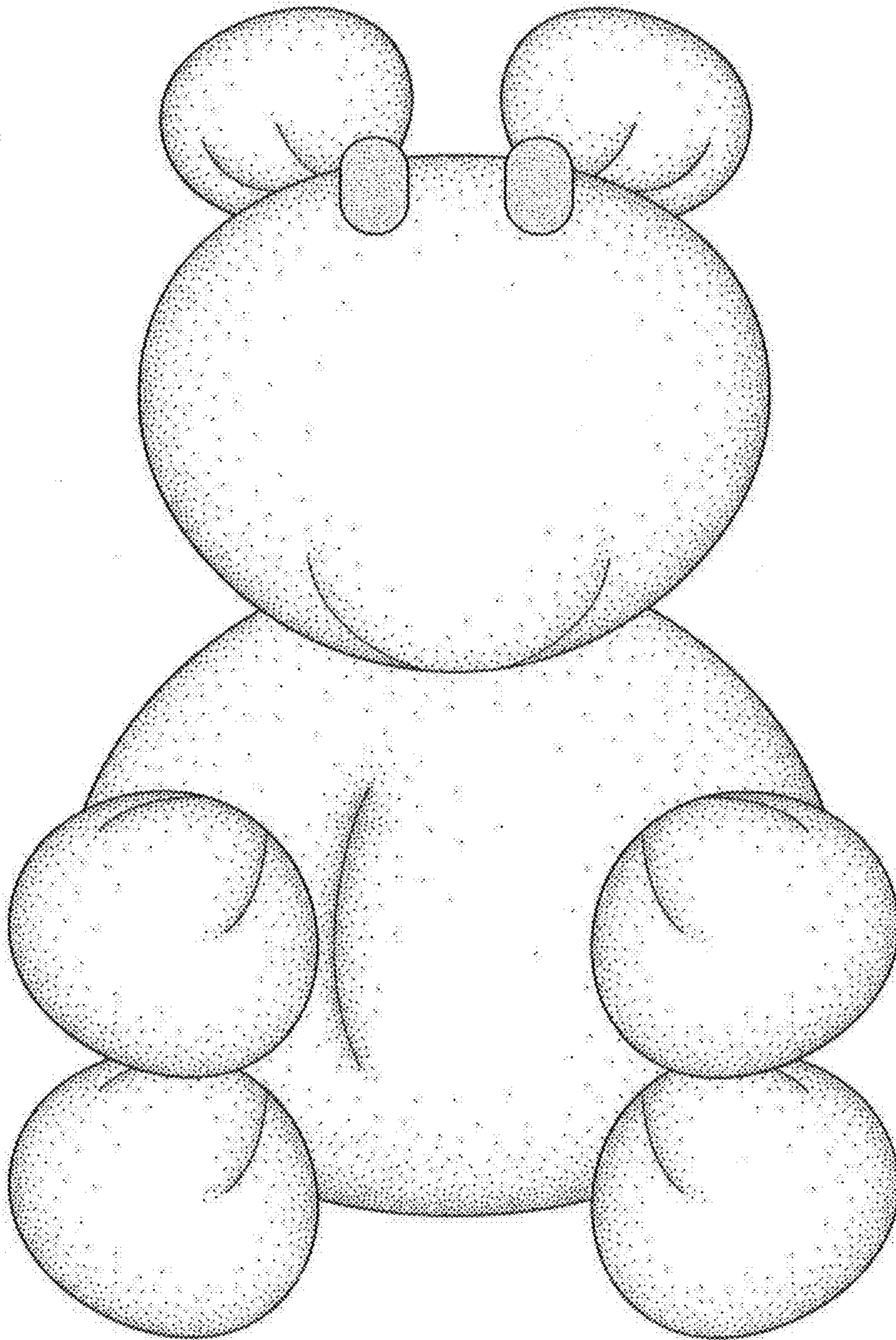

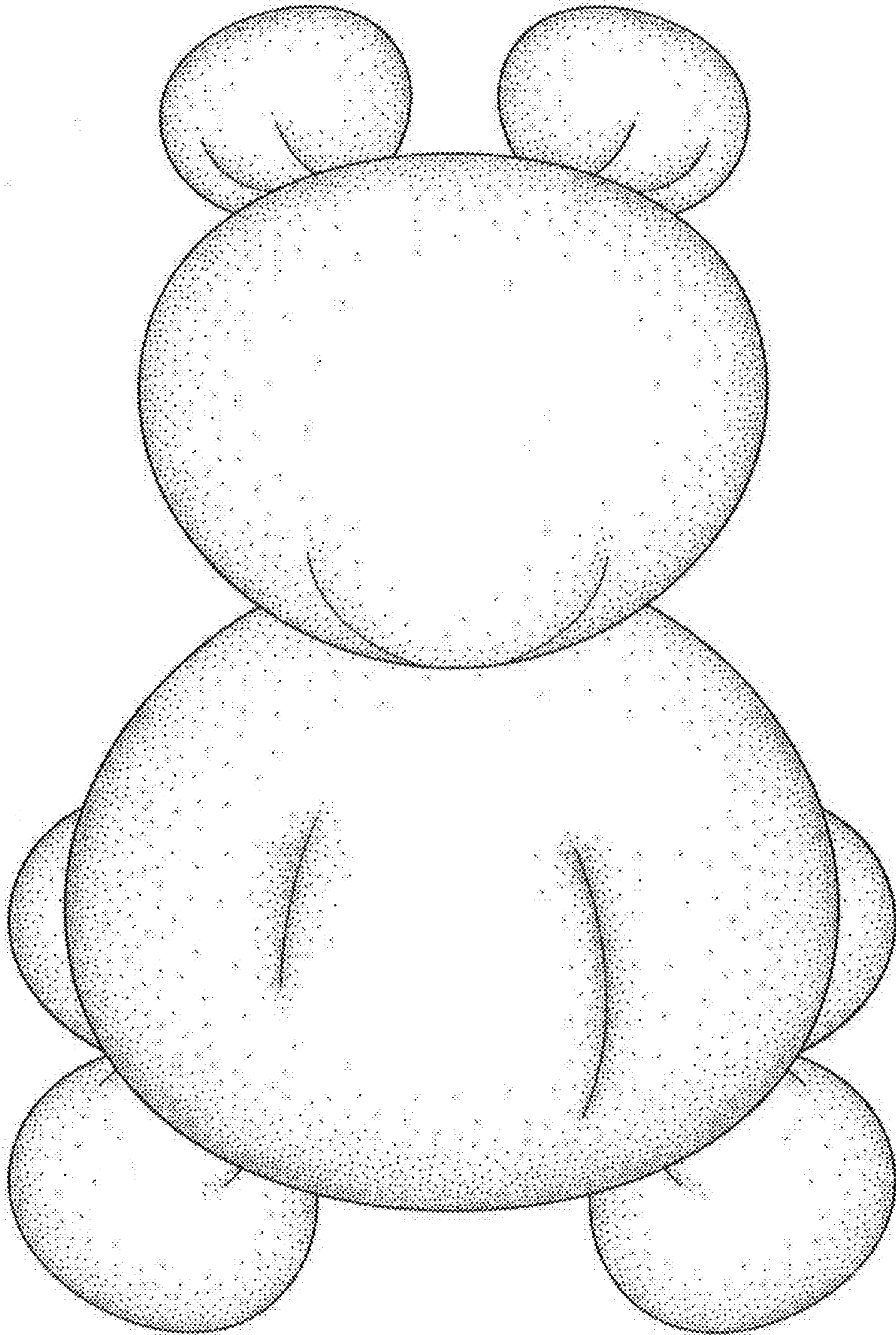

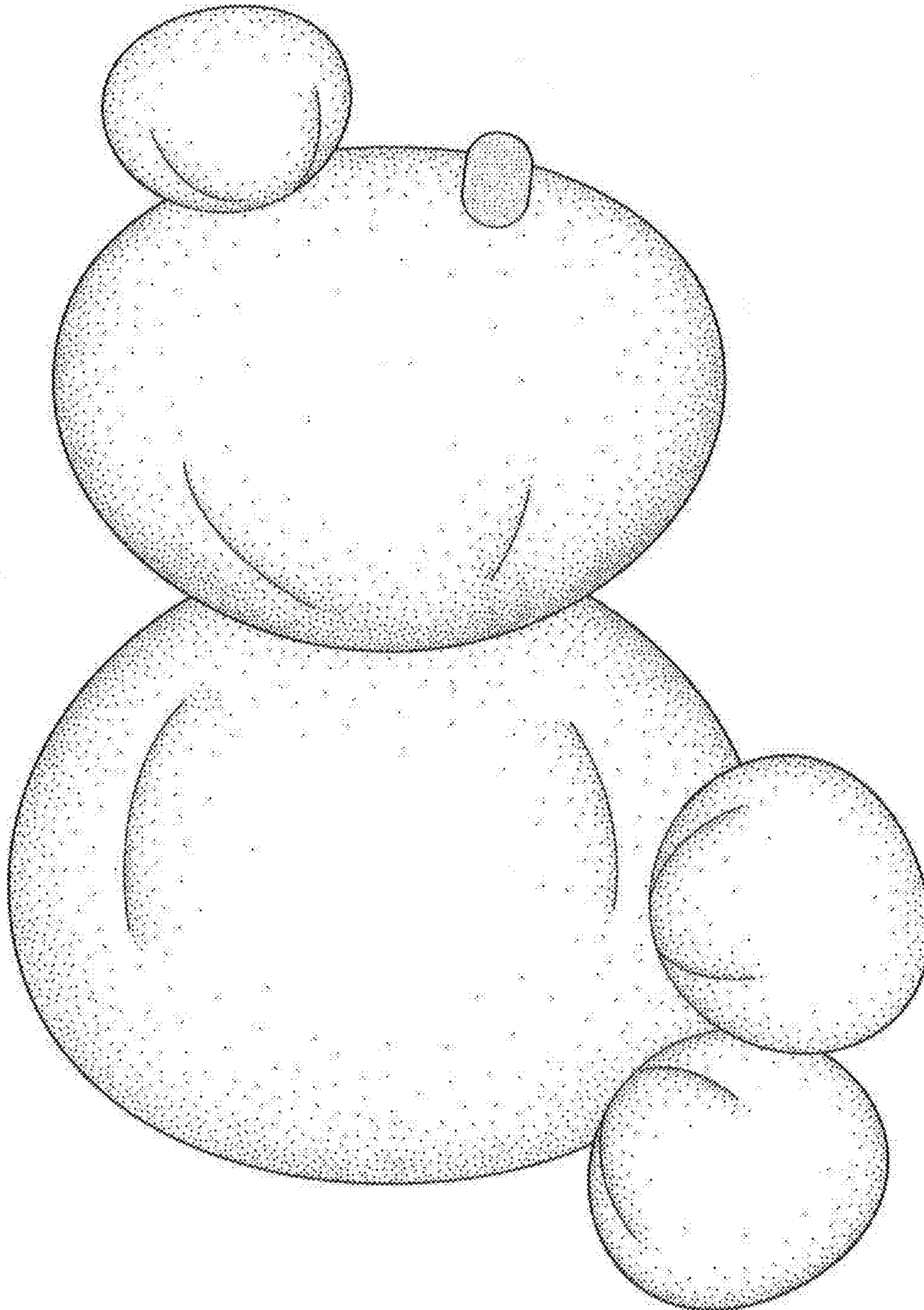

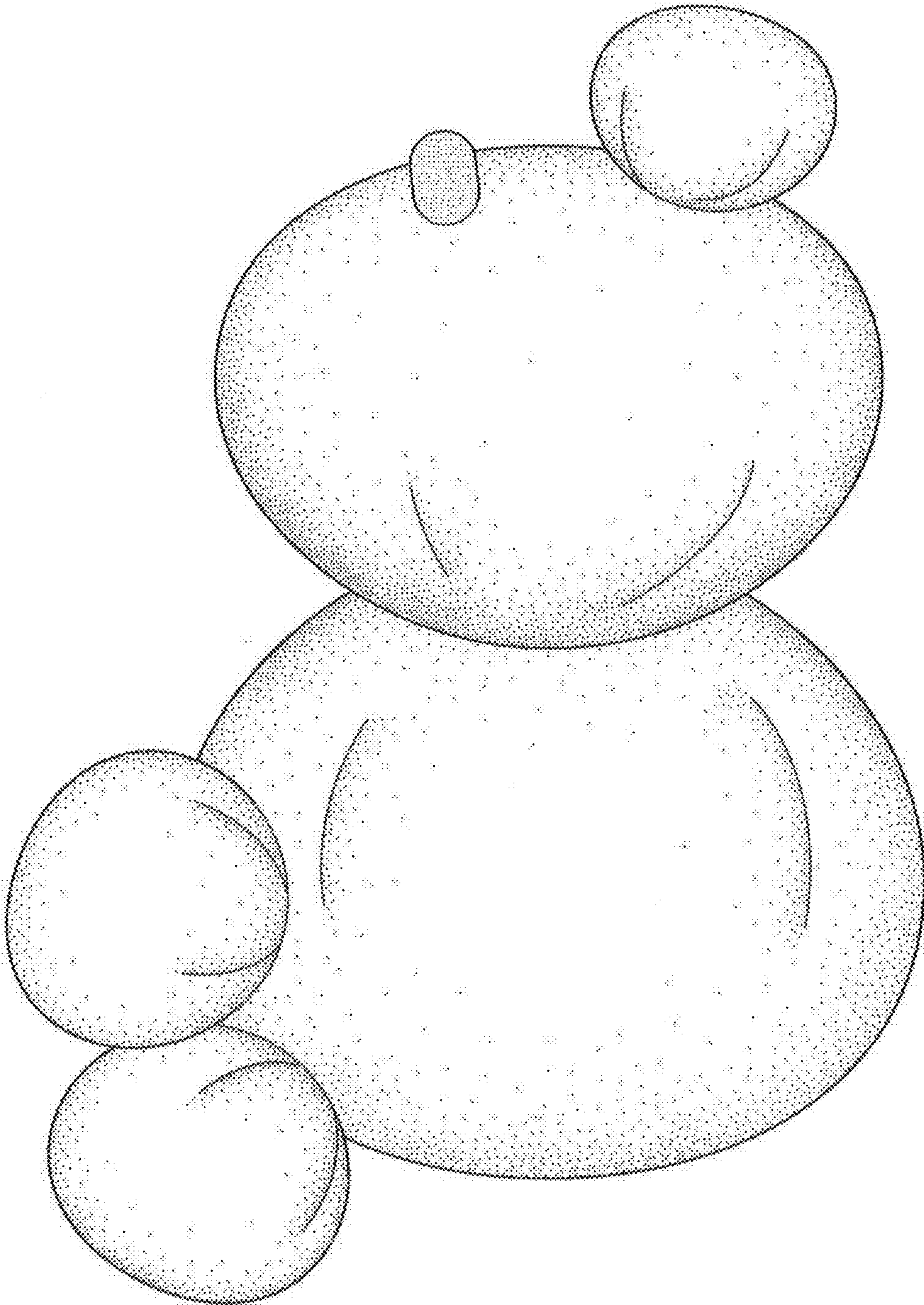

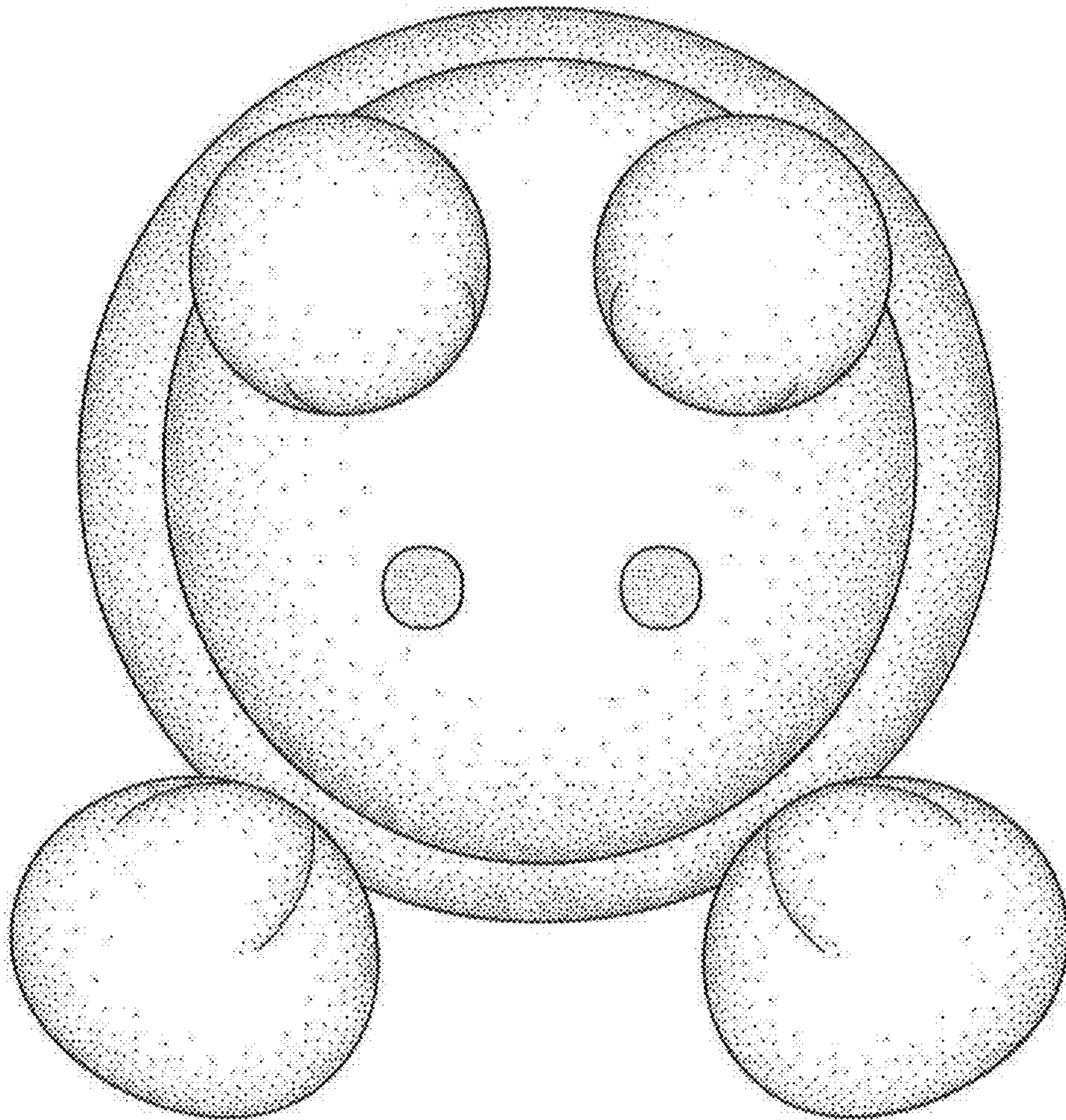

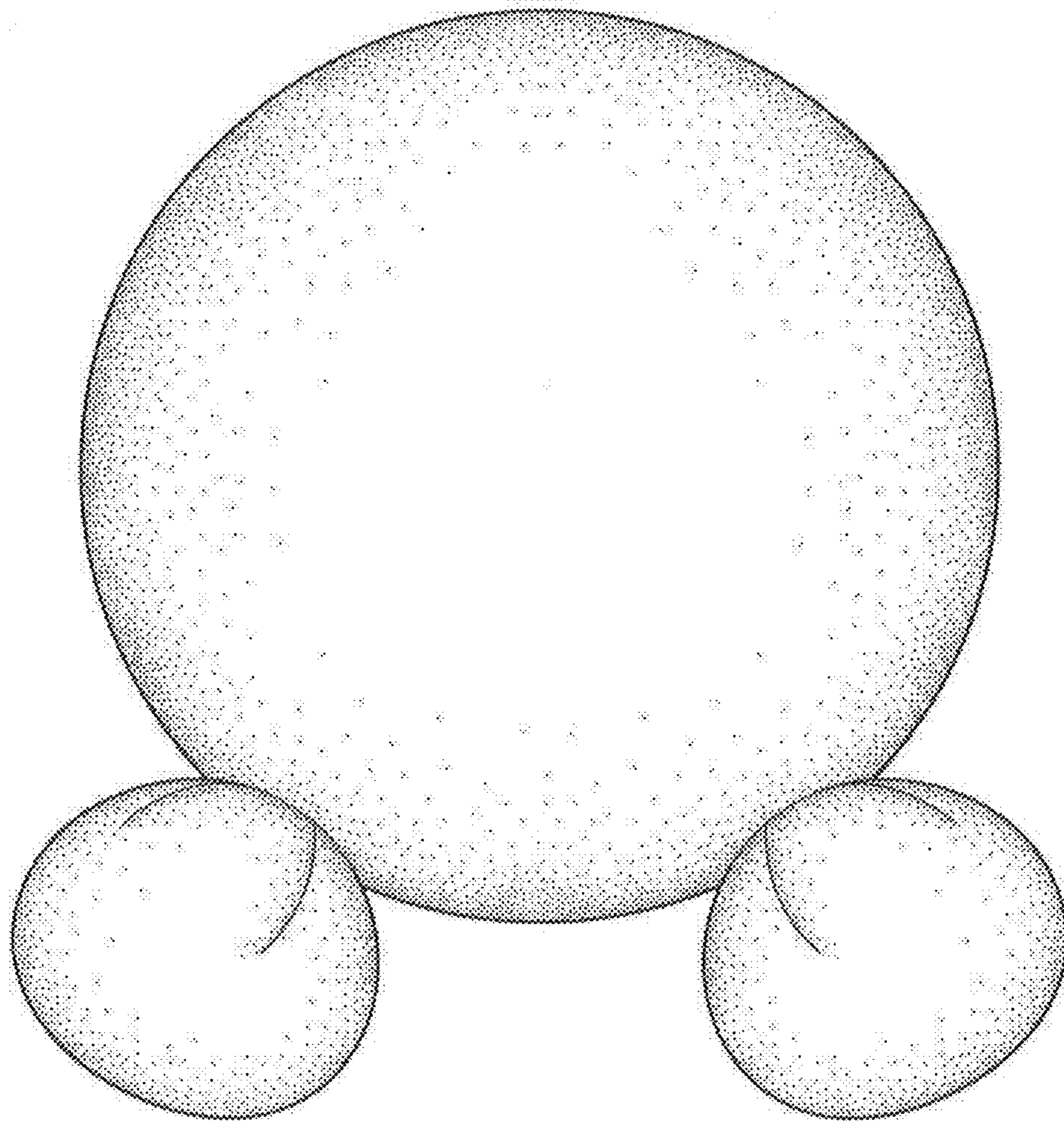
