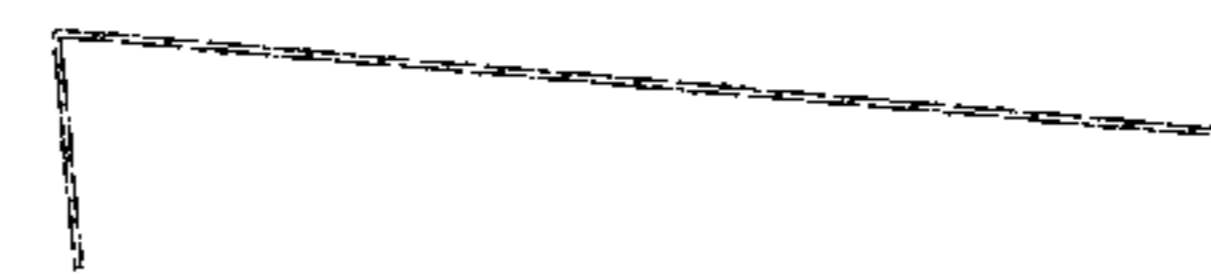
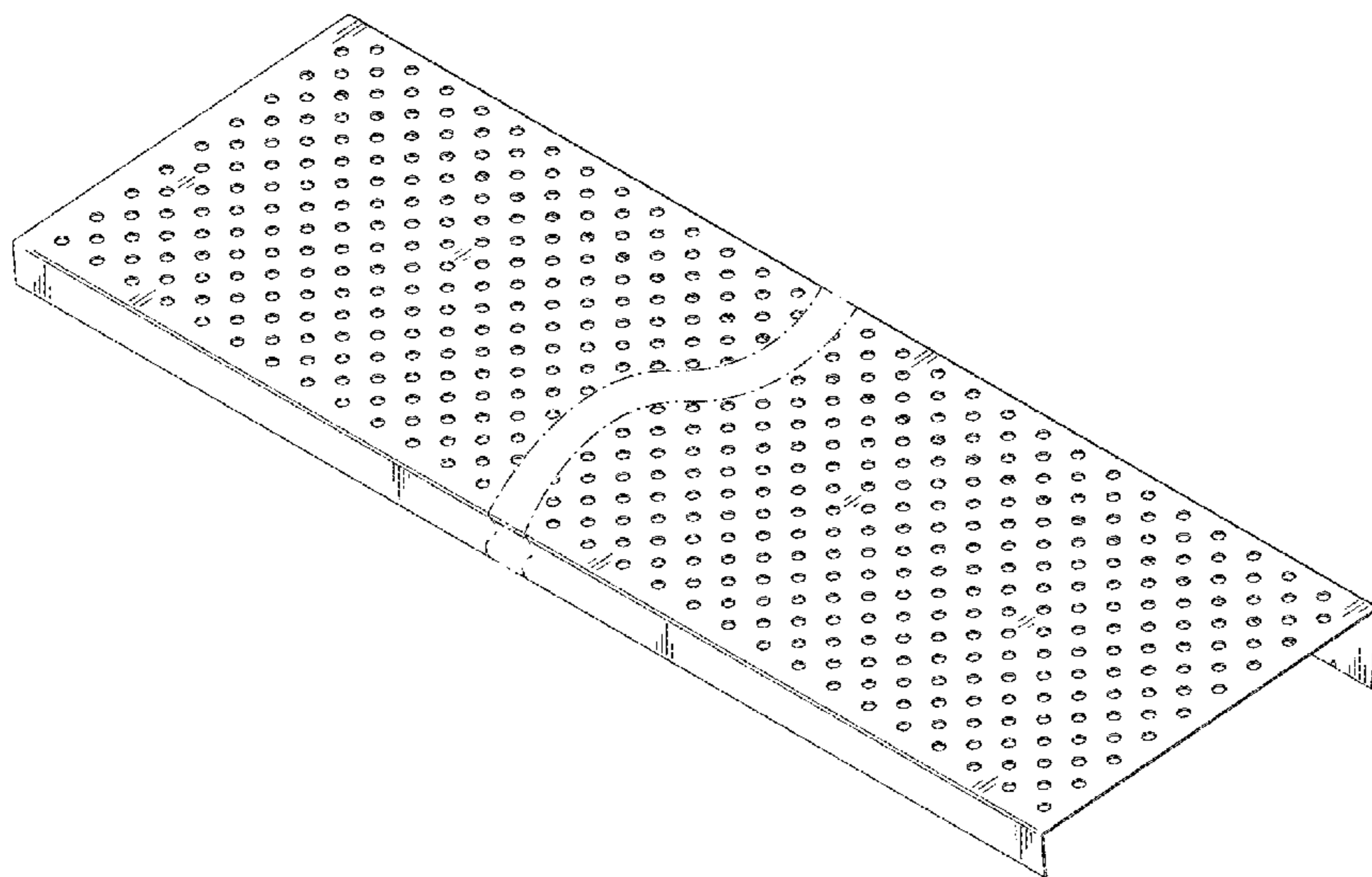
(57) **CLAIM**

The ornamental design for a gutter cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gutter cover; FIG. 2 is a front isometric view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The alternating dash-dot lines represent a symbolic break in the gutter cover's length and form no part of the claim. The appearance of any portion of the article between the break lines forms no part of the claim.

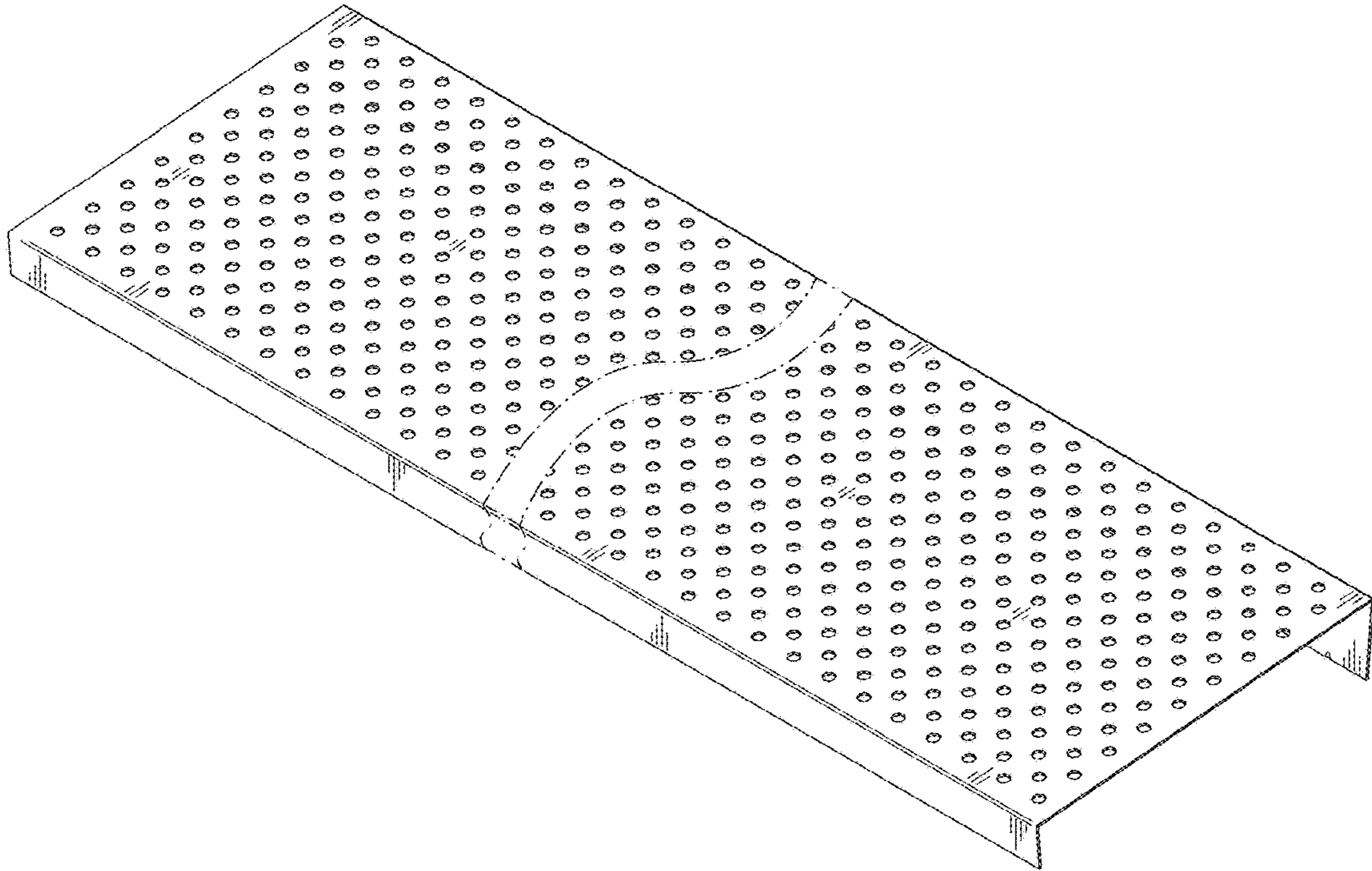

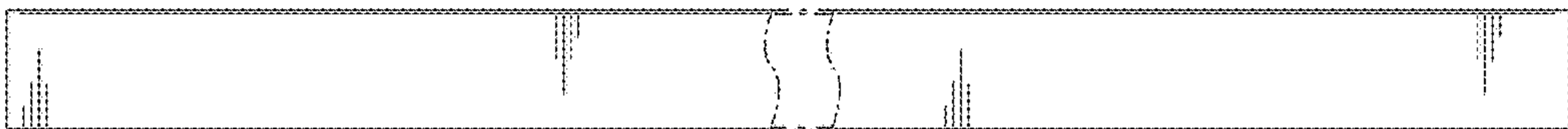

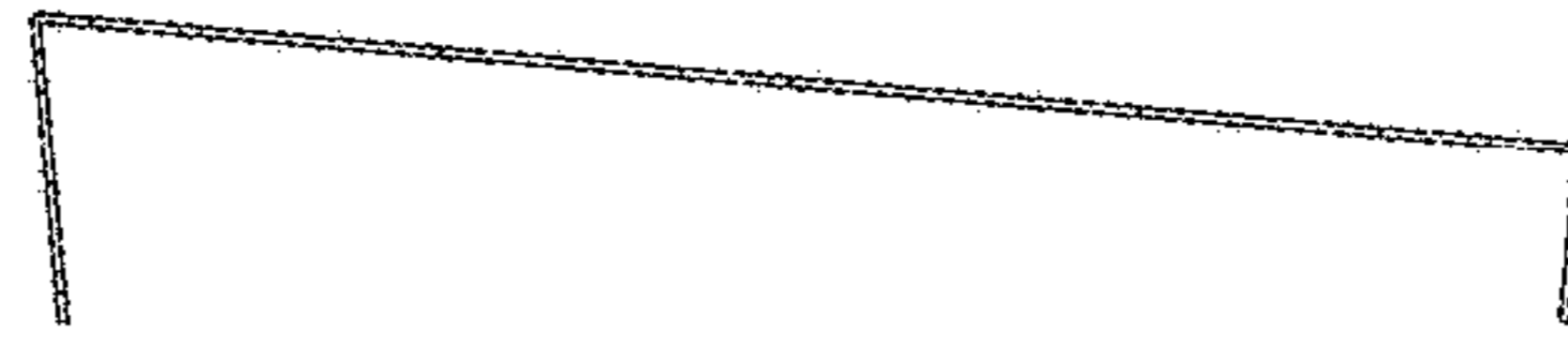

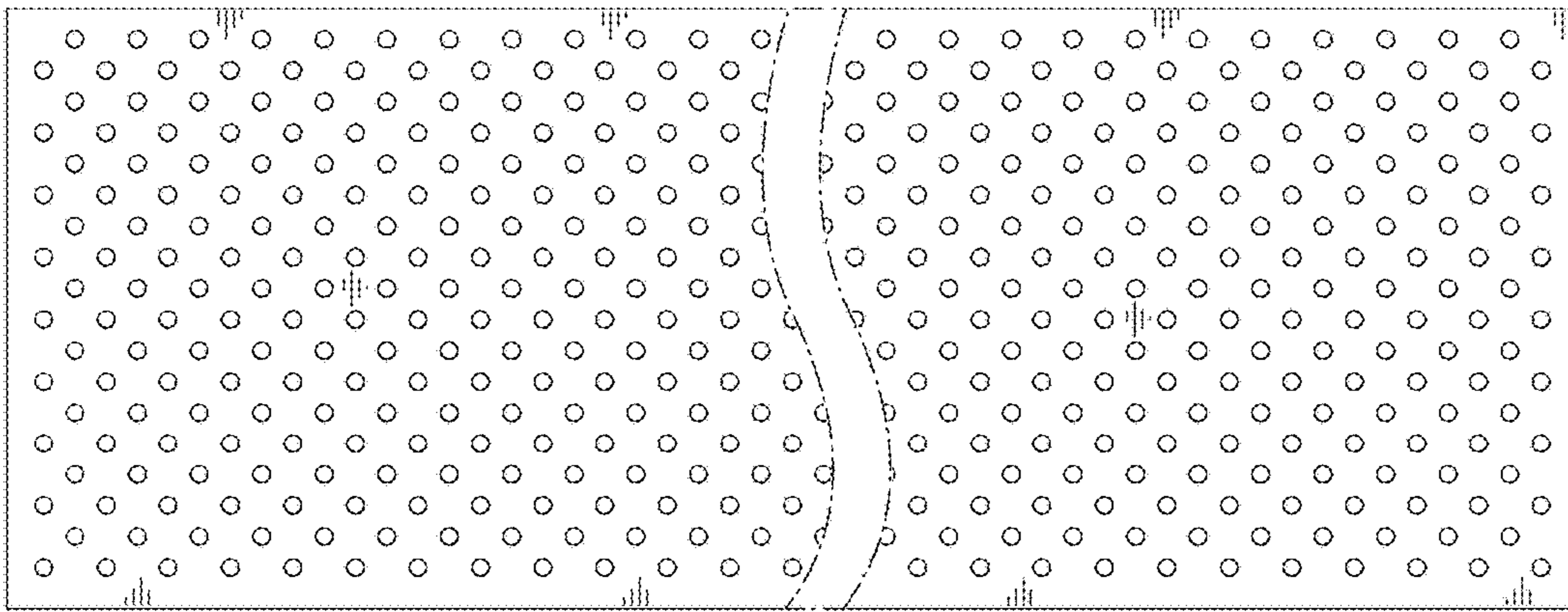

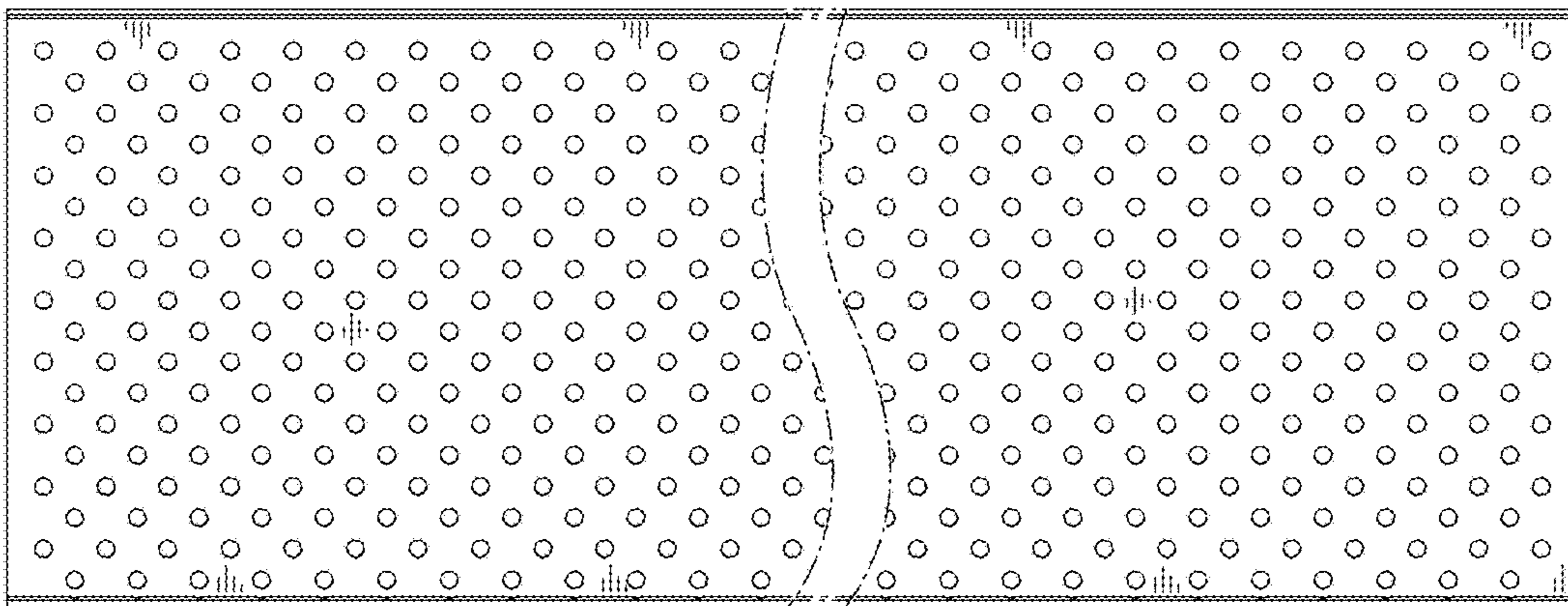
