1.

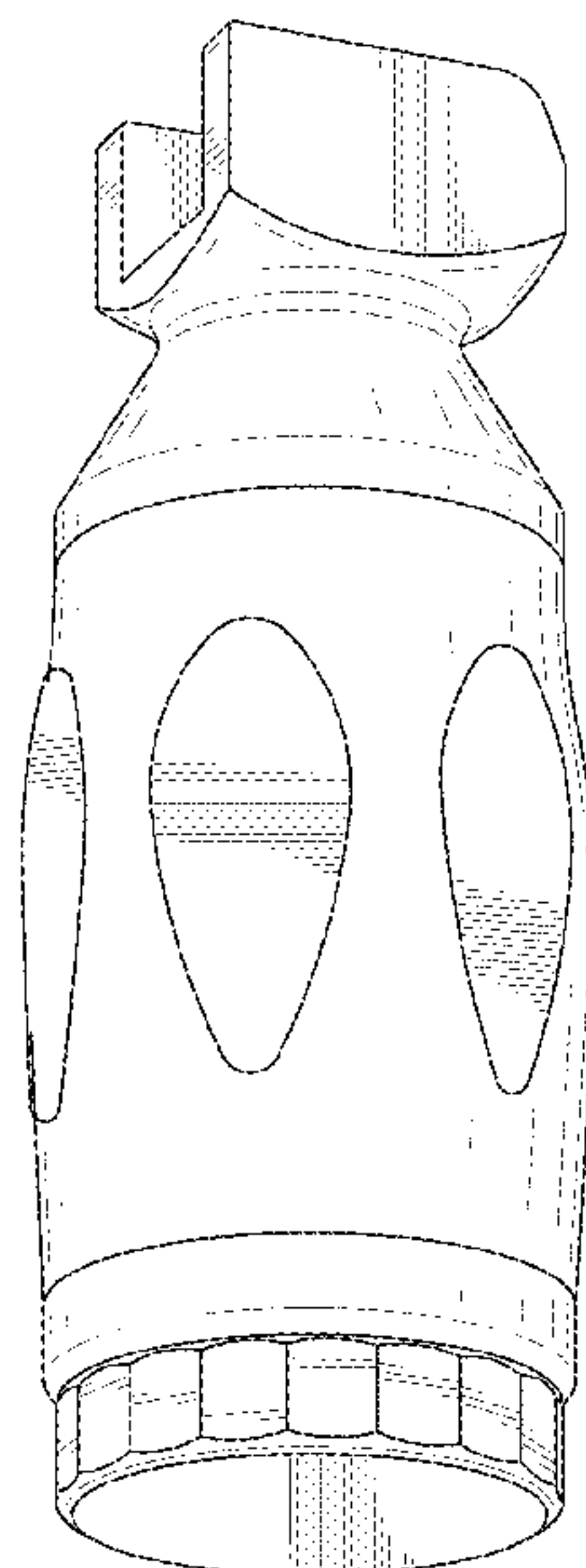

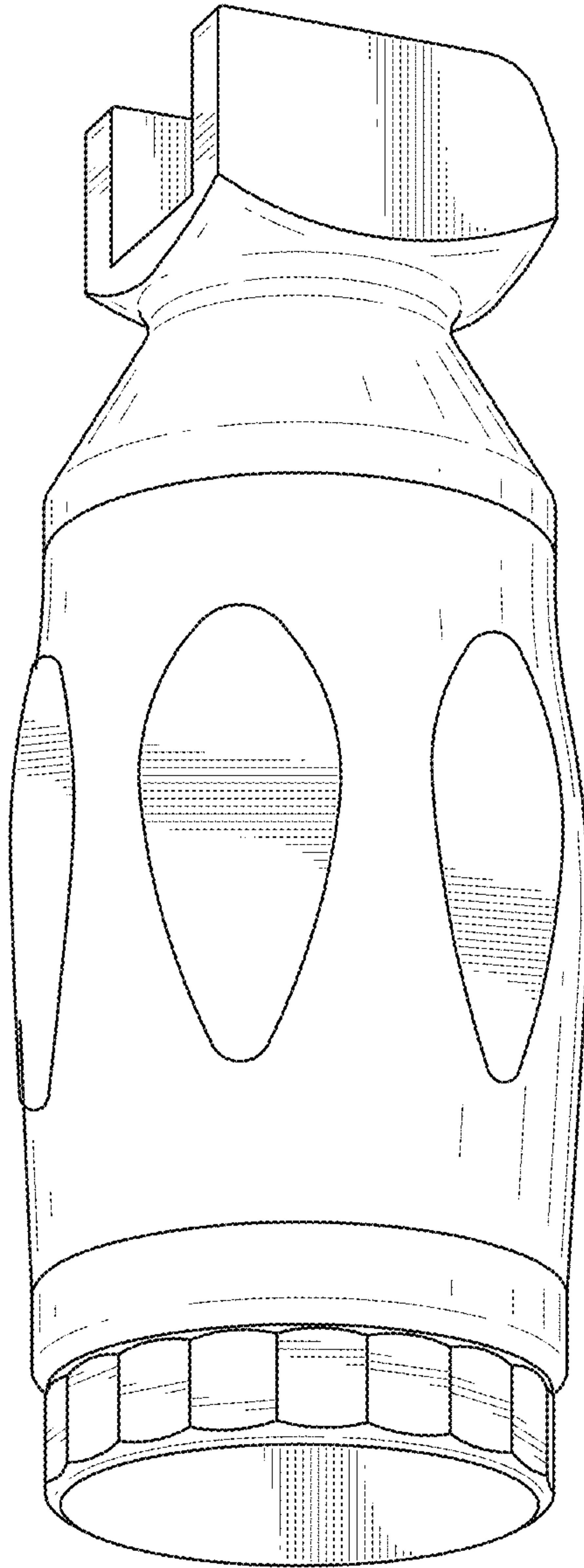

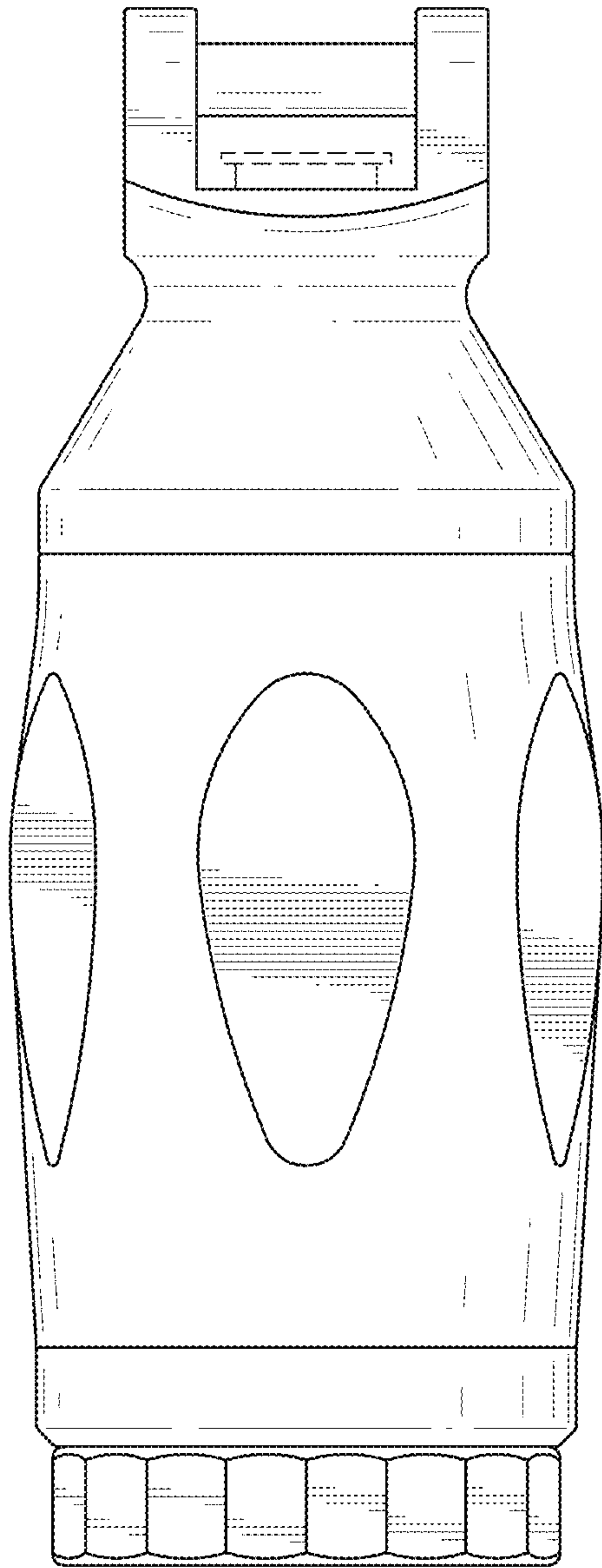

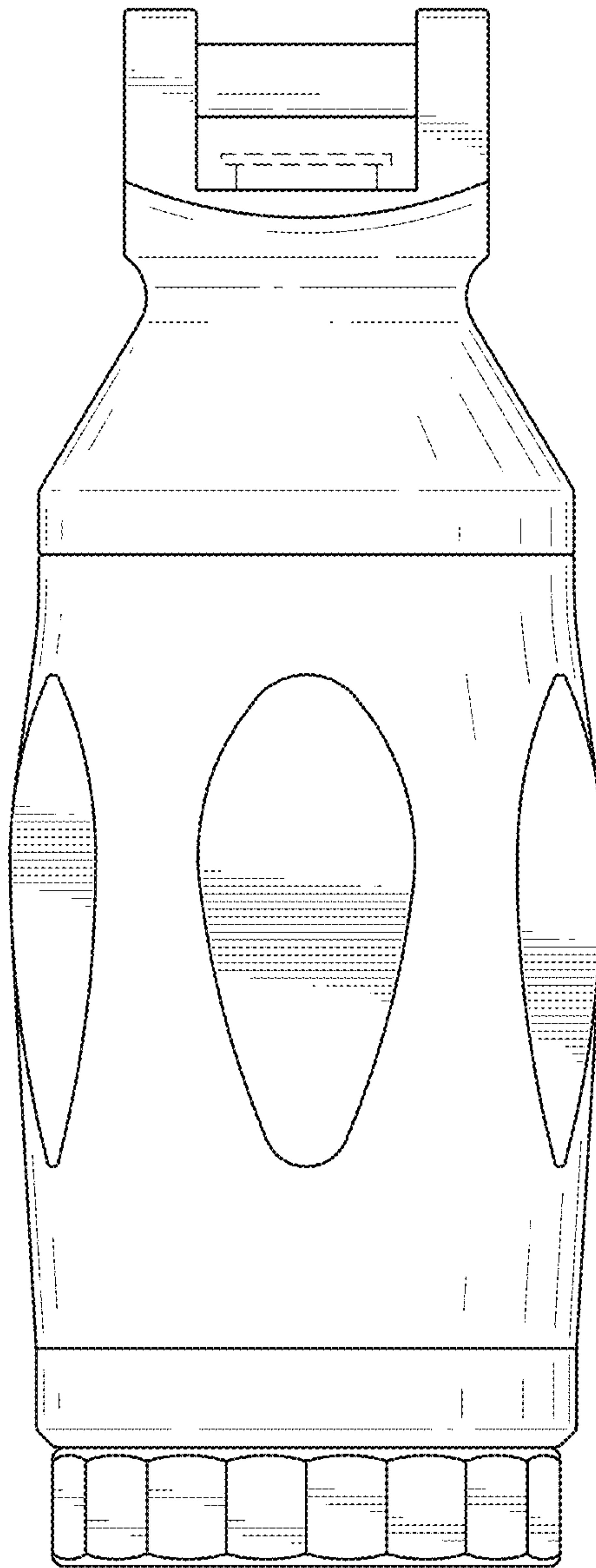

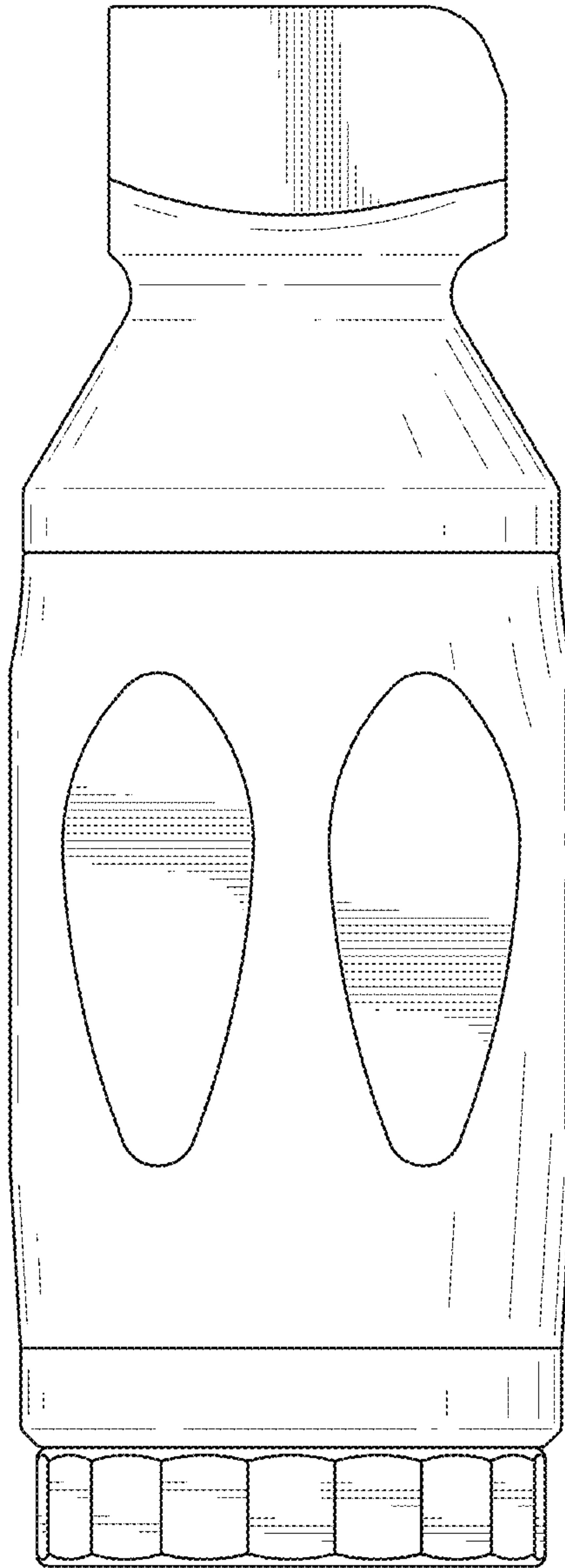

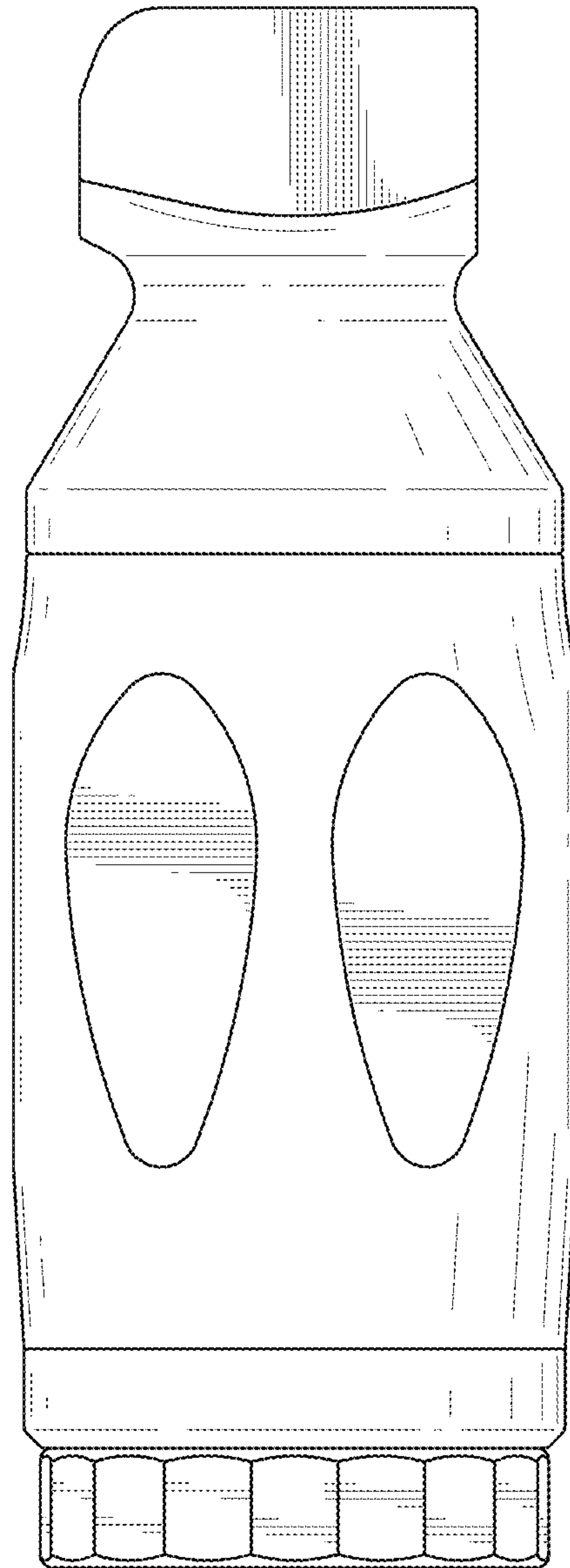

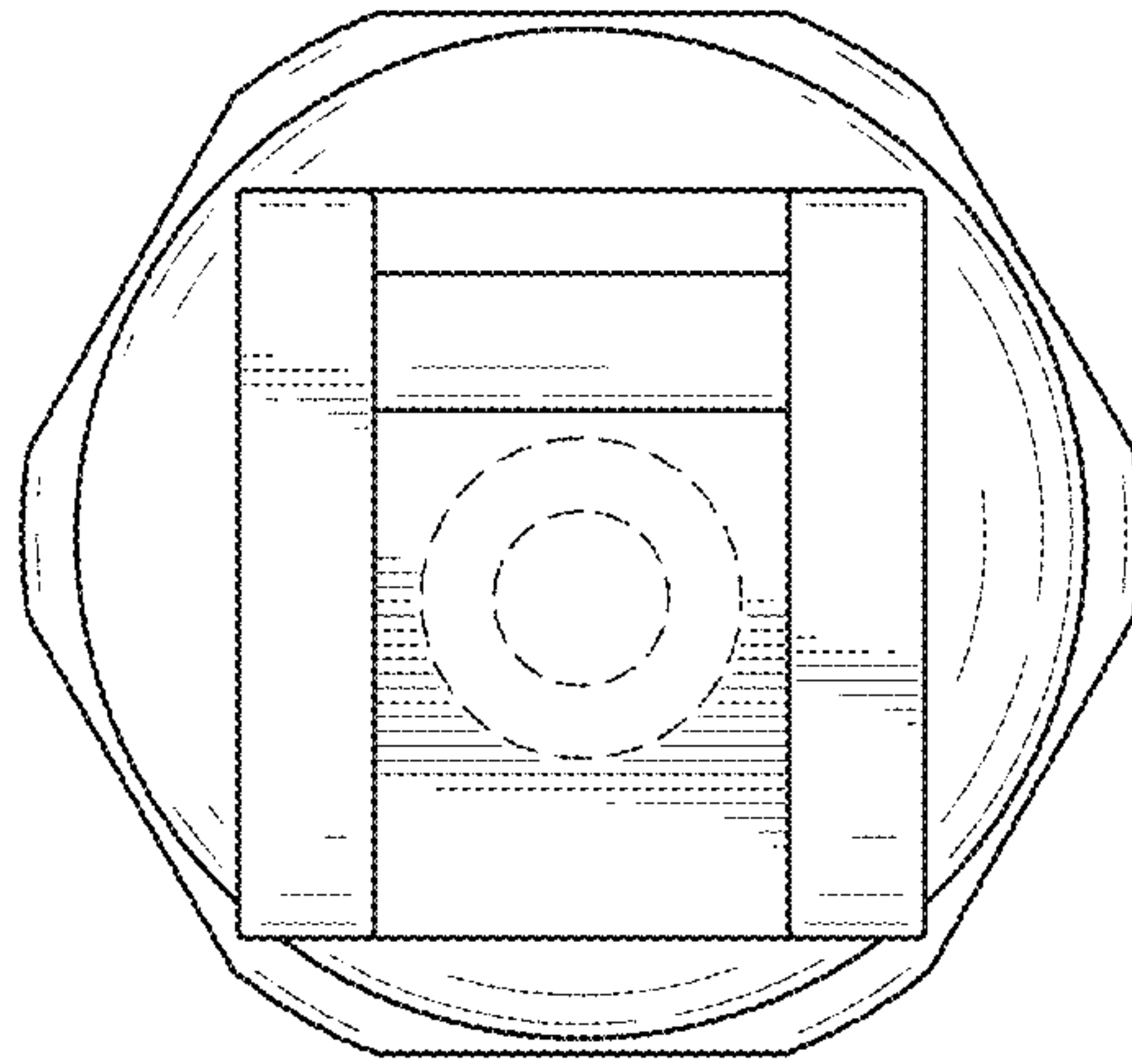

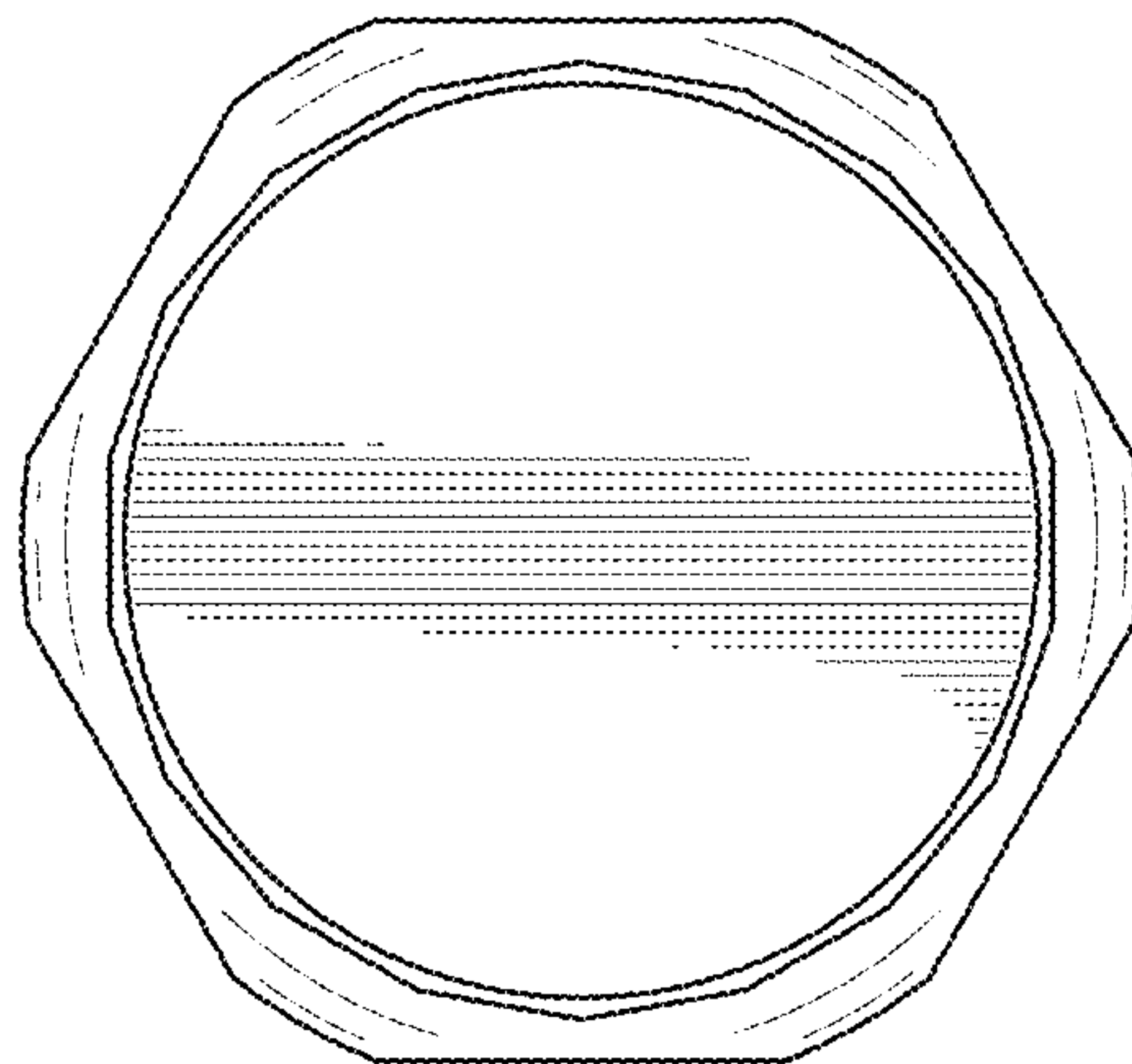
