We claim the ornamental design for a tooth cap, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a tooth cap in accordance with a first embodiment of my new design;
 FIG. 2 is a frontal view of the tooth cap of FIG. 1 showing the design;
 FIG. 3 is a left side view of the tooth cap of FIG. 1 showing the design;
 FIG. 4 is a rear view of the tooth cap of FIG. 1 showing the design;
 FIG. 5 is a right view of the tooth cap of FIG. 1 showing the design; and,
 FIG. 6 is a top plan view of the tooth cap of FIG. 1 showing the design.
 The broken lines of the tooth cap define the bounds of the claimed design and form no part thereof.

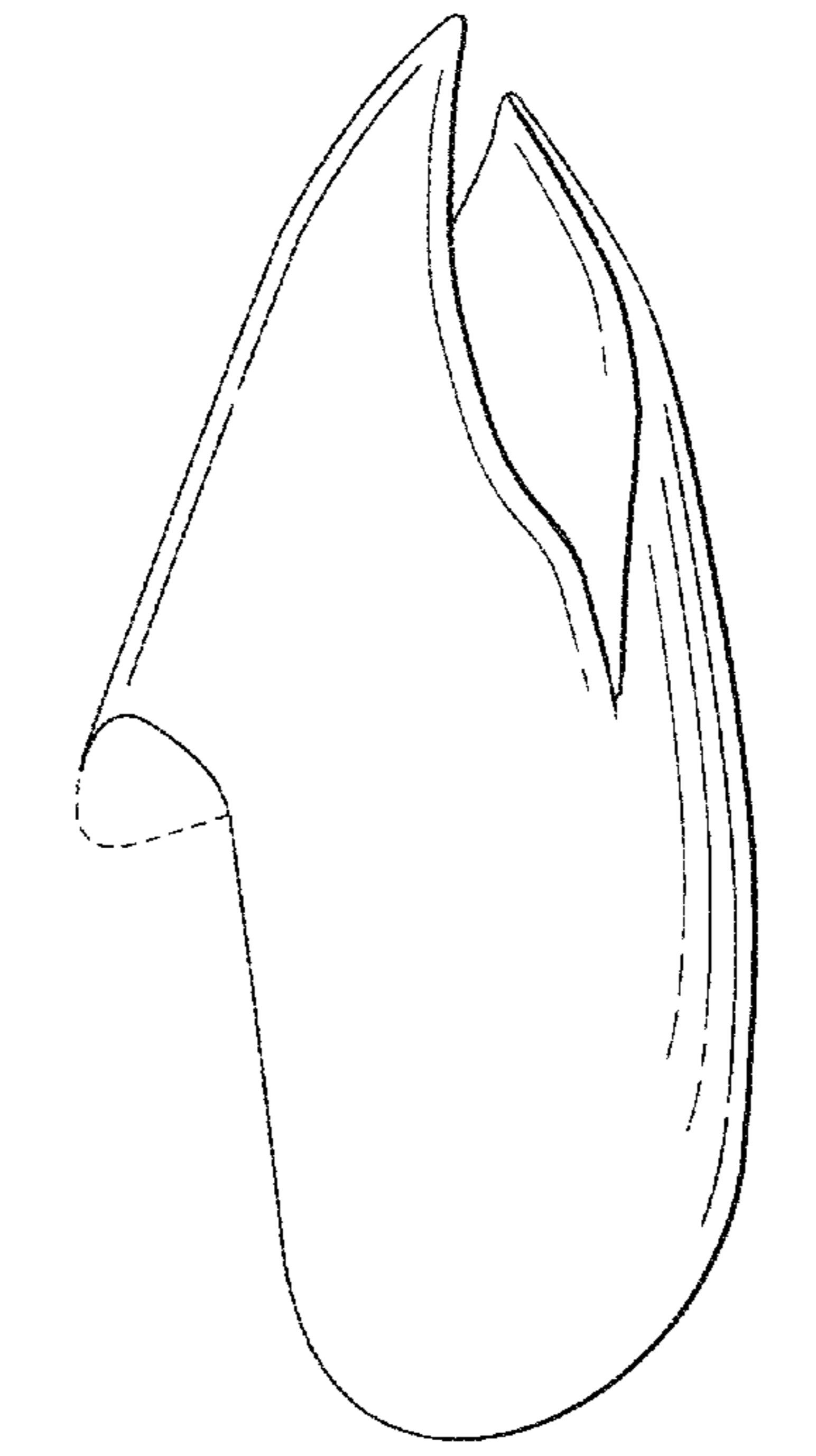

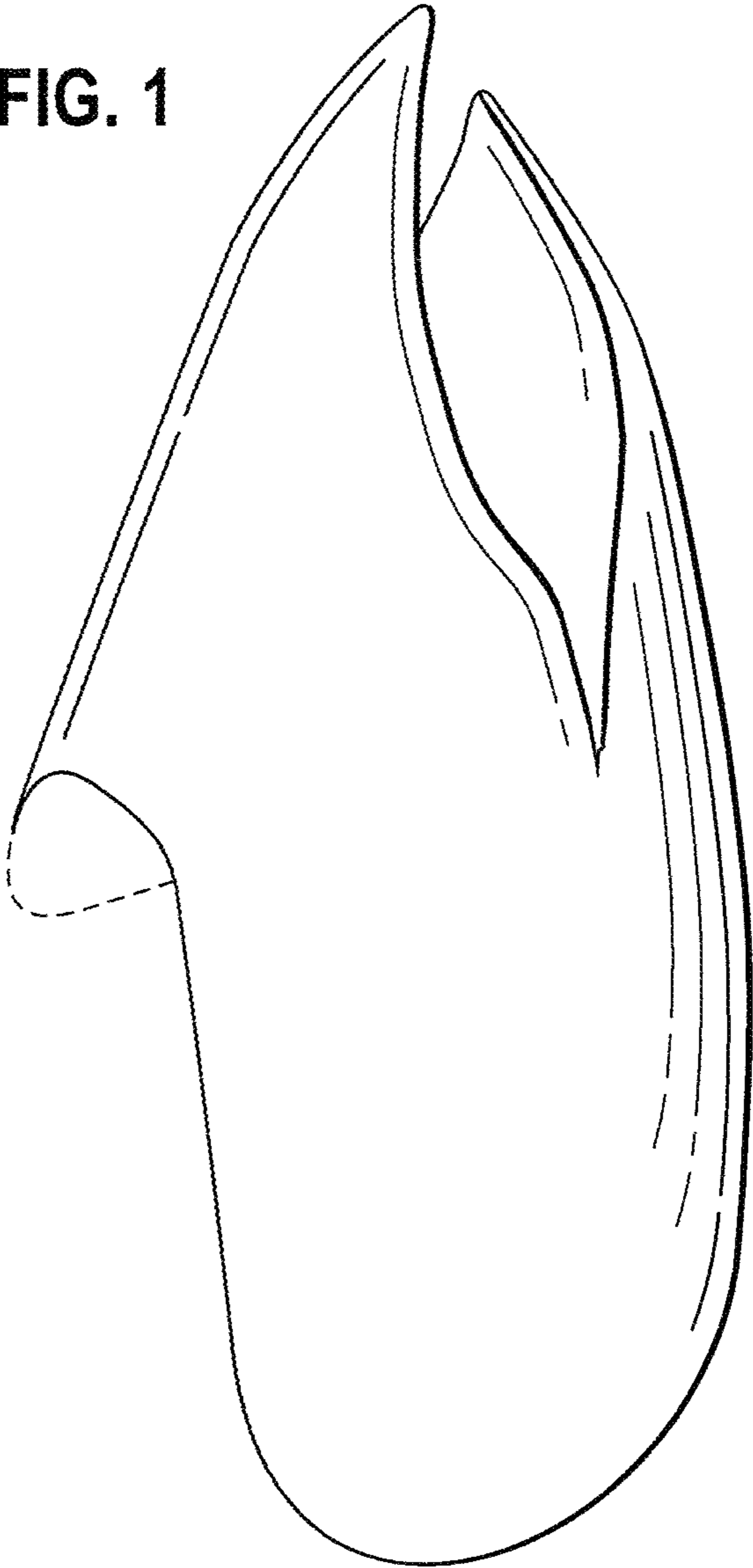

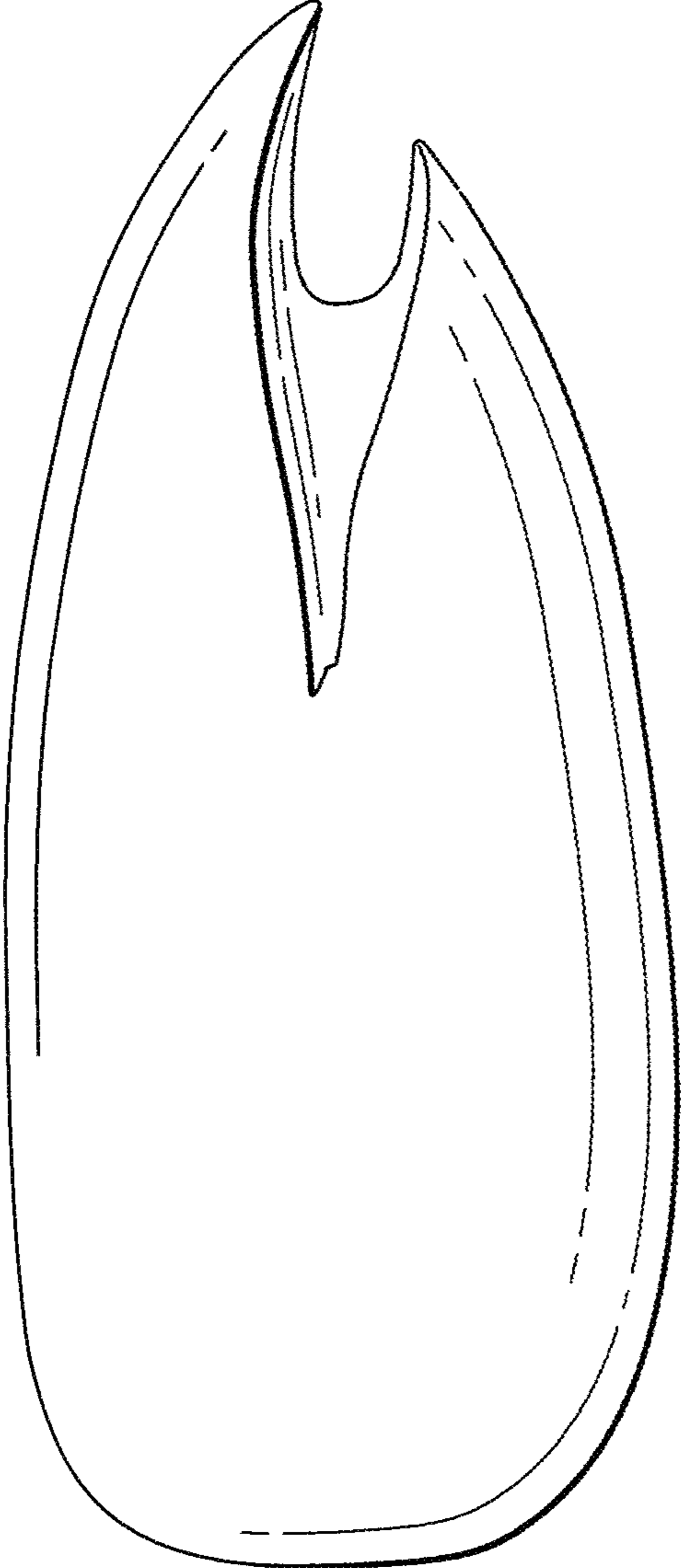

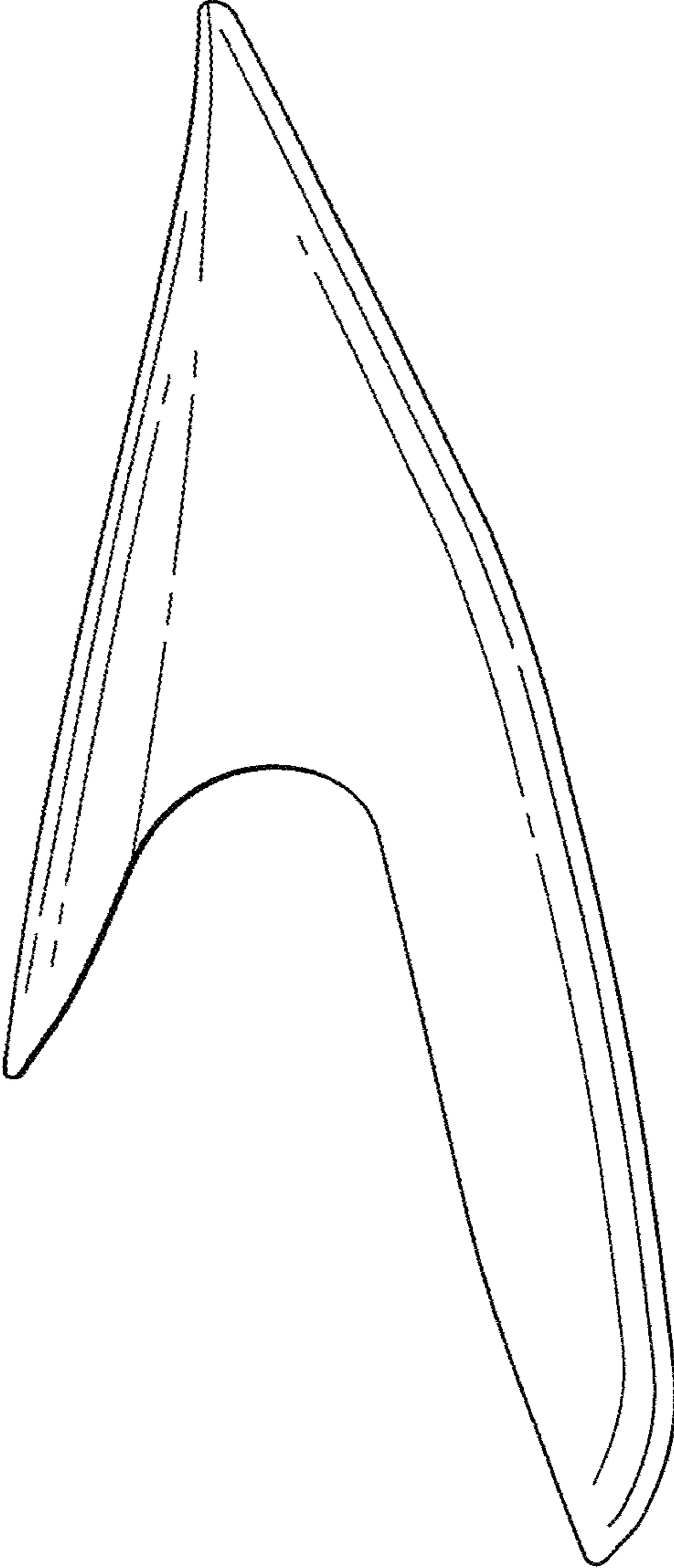

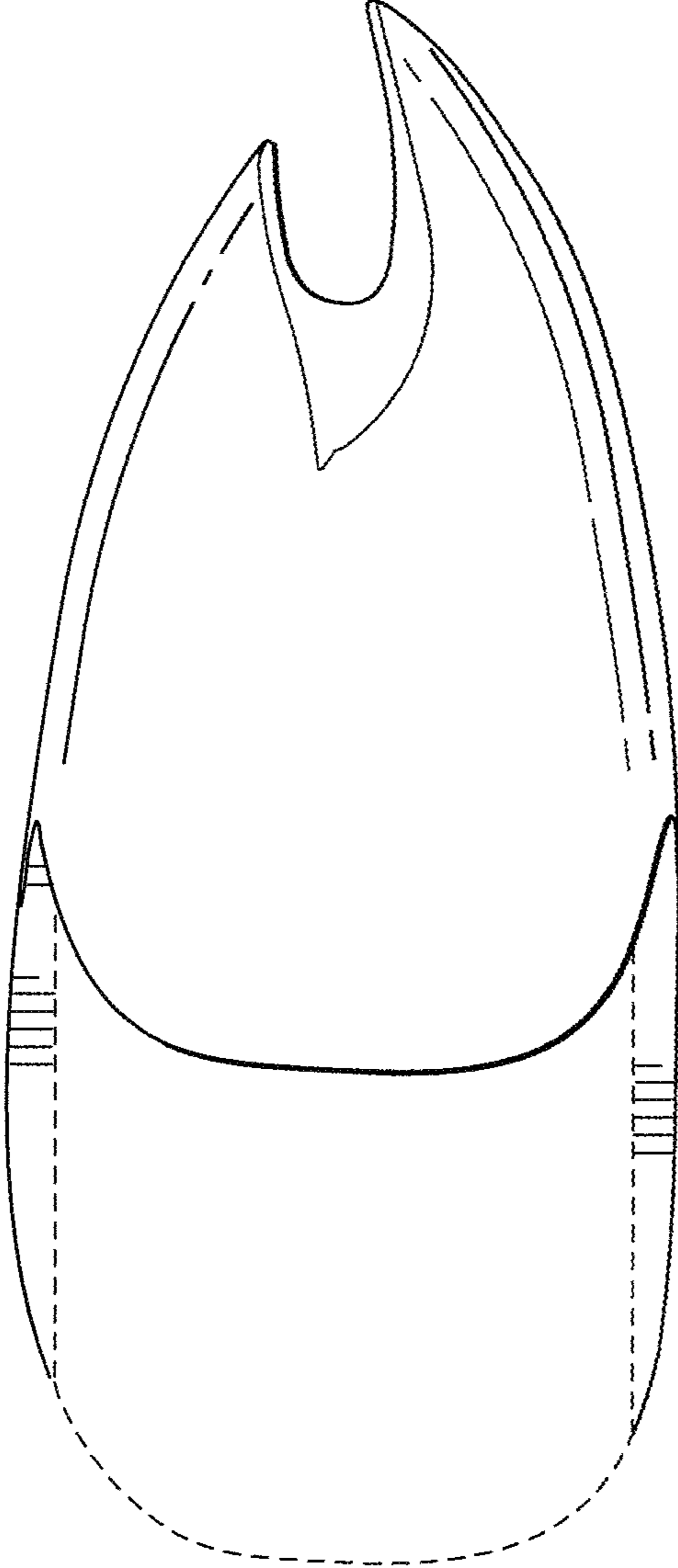

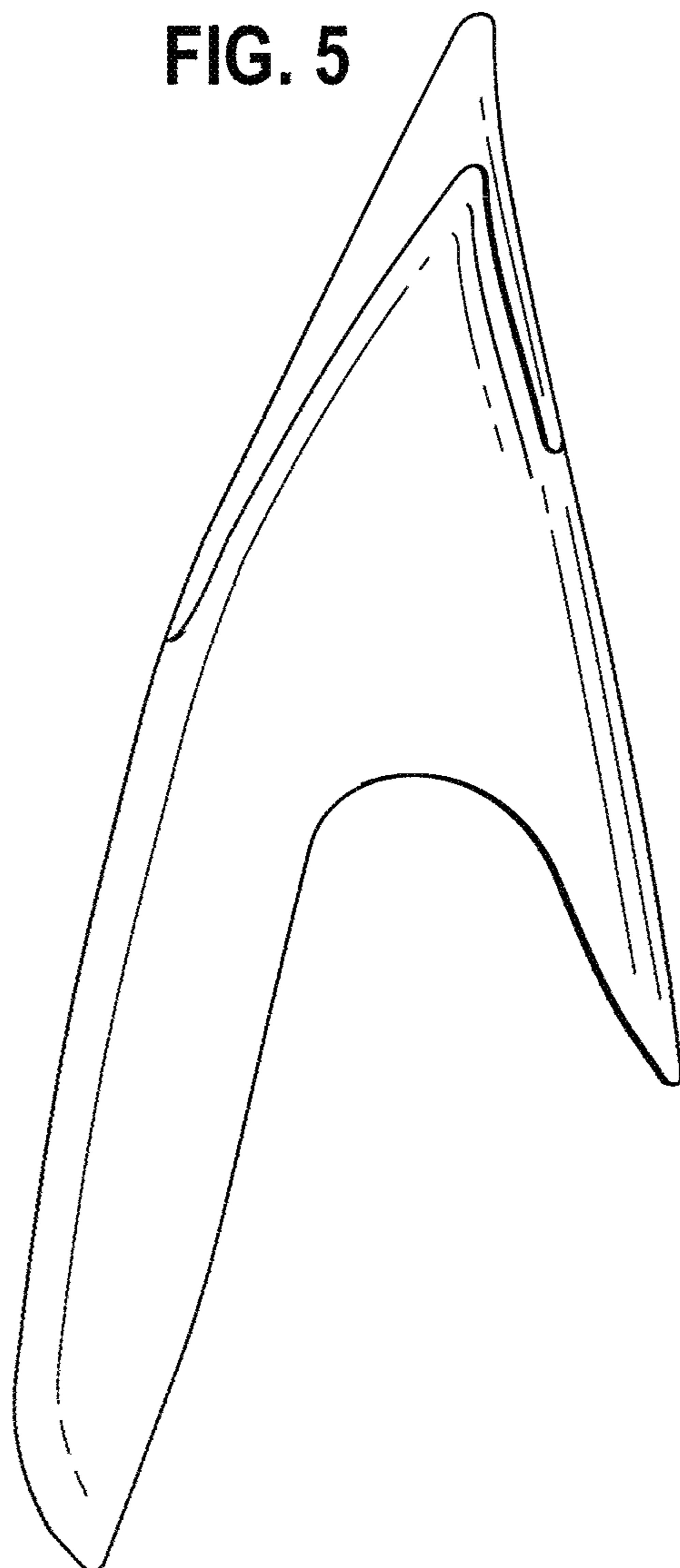
